(57) **CLAIM**

The ornamental design for a cartridge filter gasket, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a cartridge filter gasket showing my new design;

FIG. 2 is a front elevational view thereof, with all side and rear views thereof having the same appearance;

FIG. 3 is a bottom plan view thereof; and,

FIG. 4 is a sectional side view thereof to better illustrate the contours of the gasket.

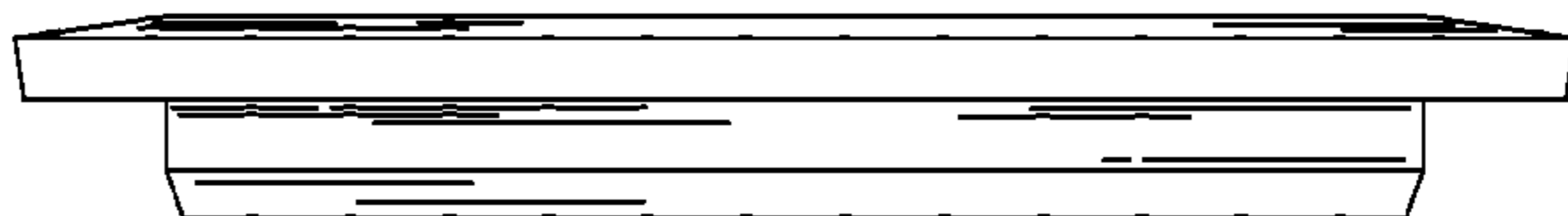
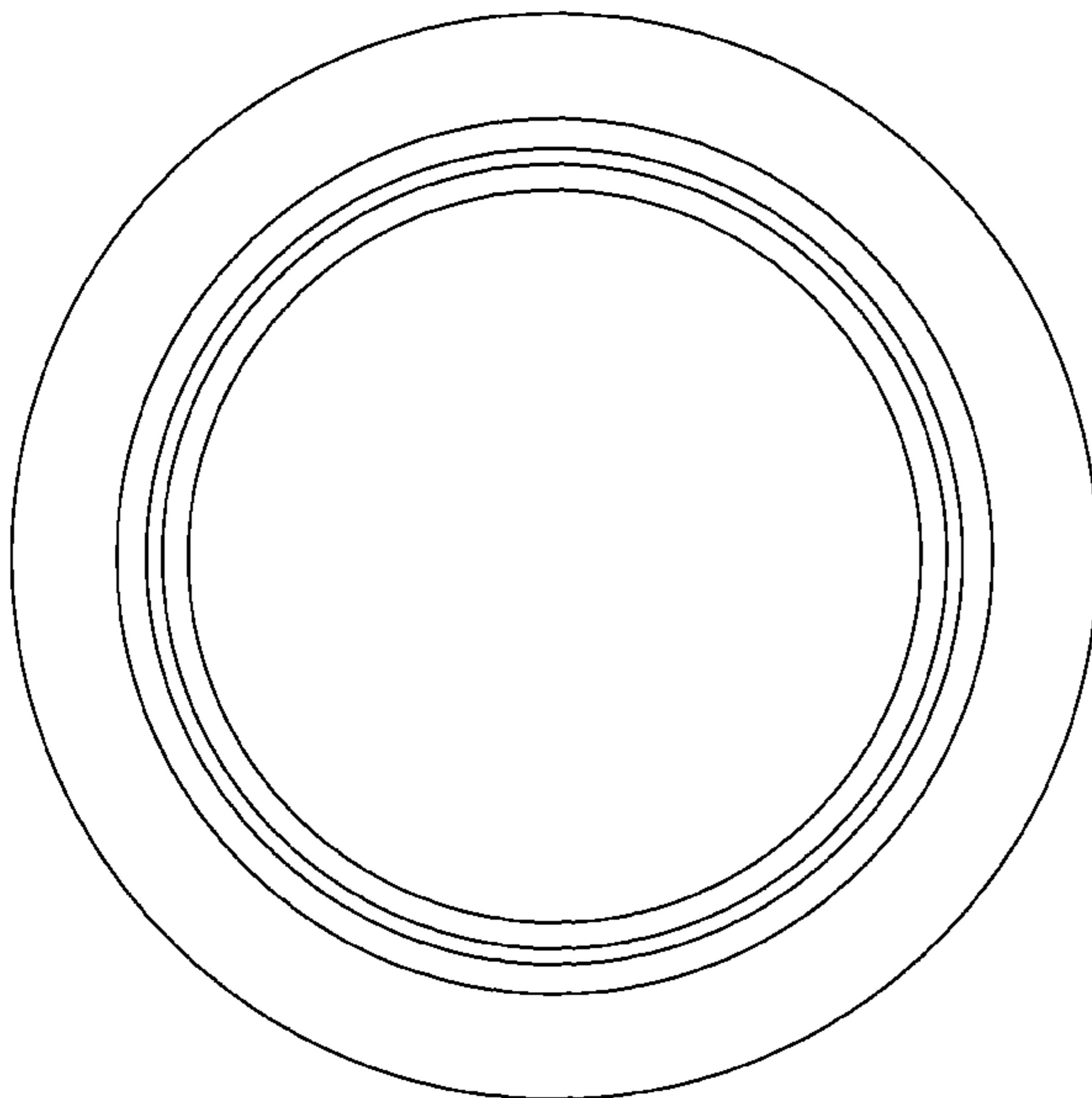

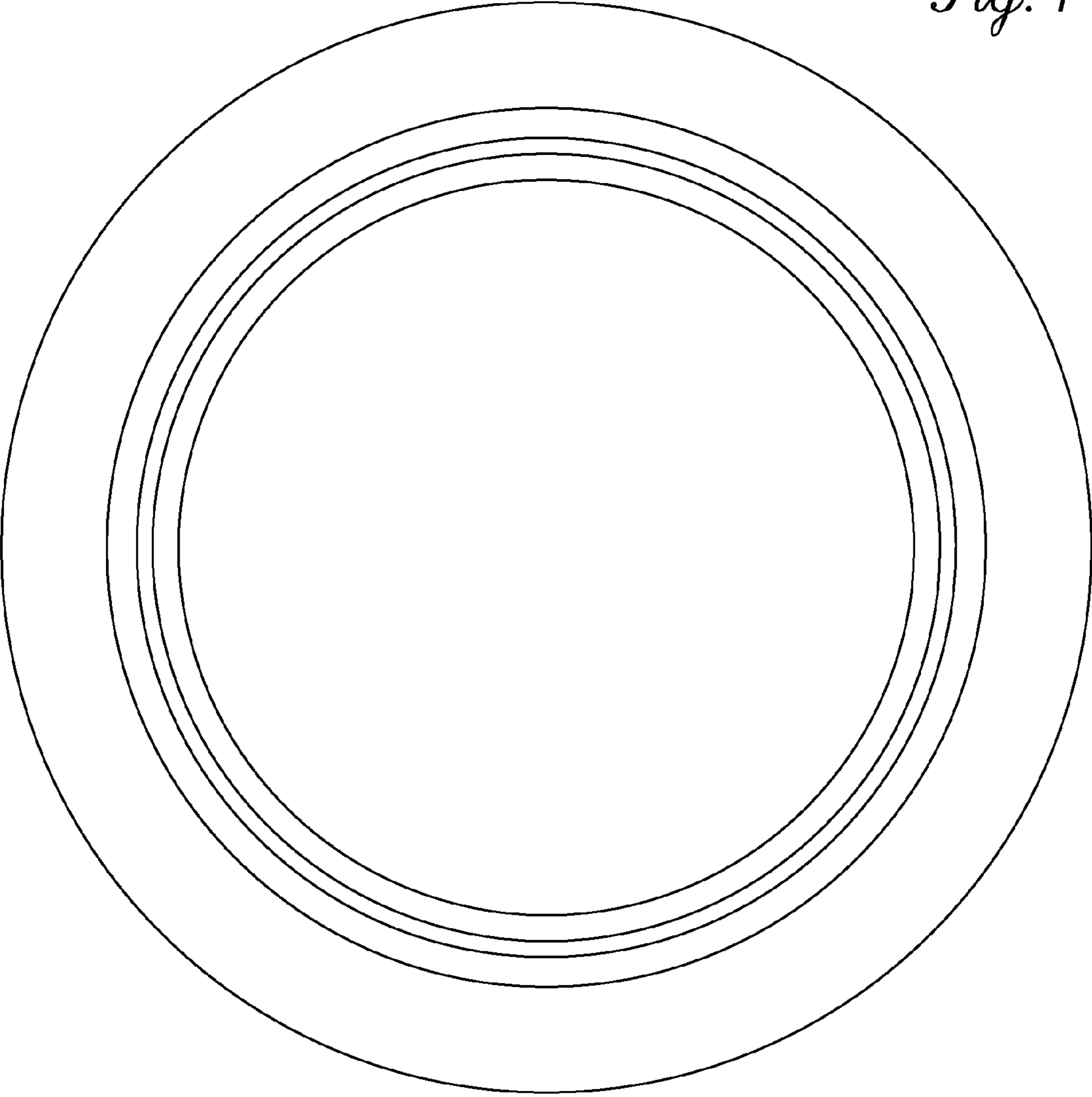

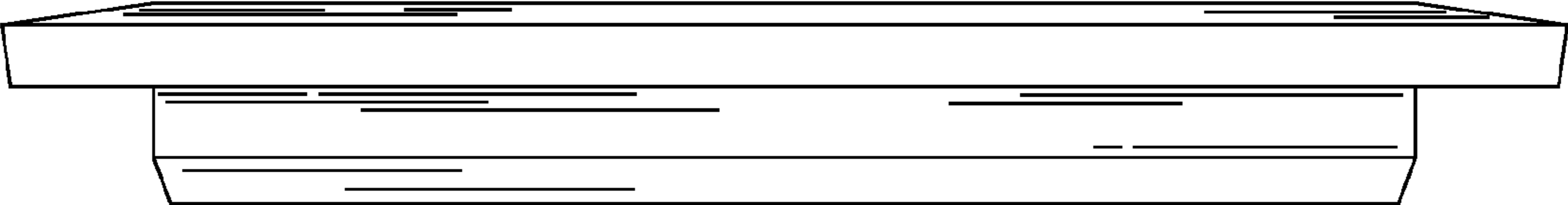

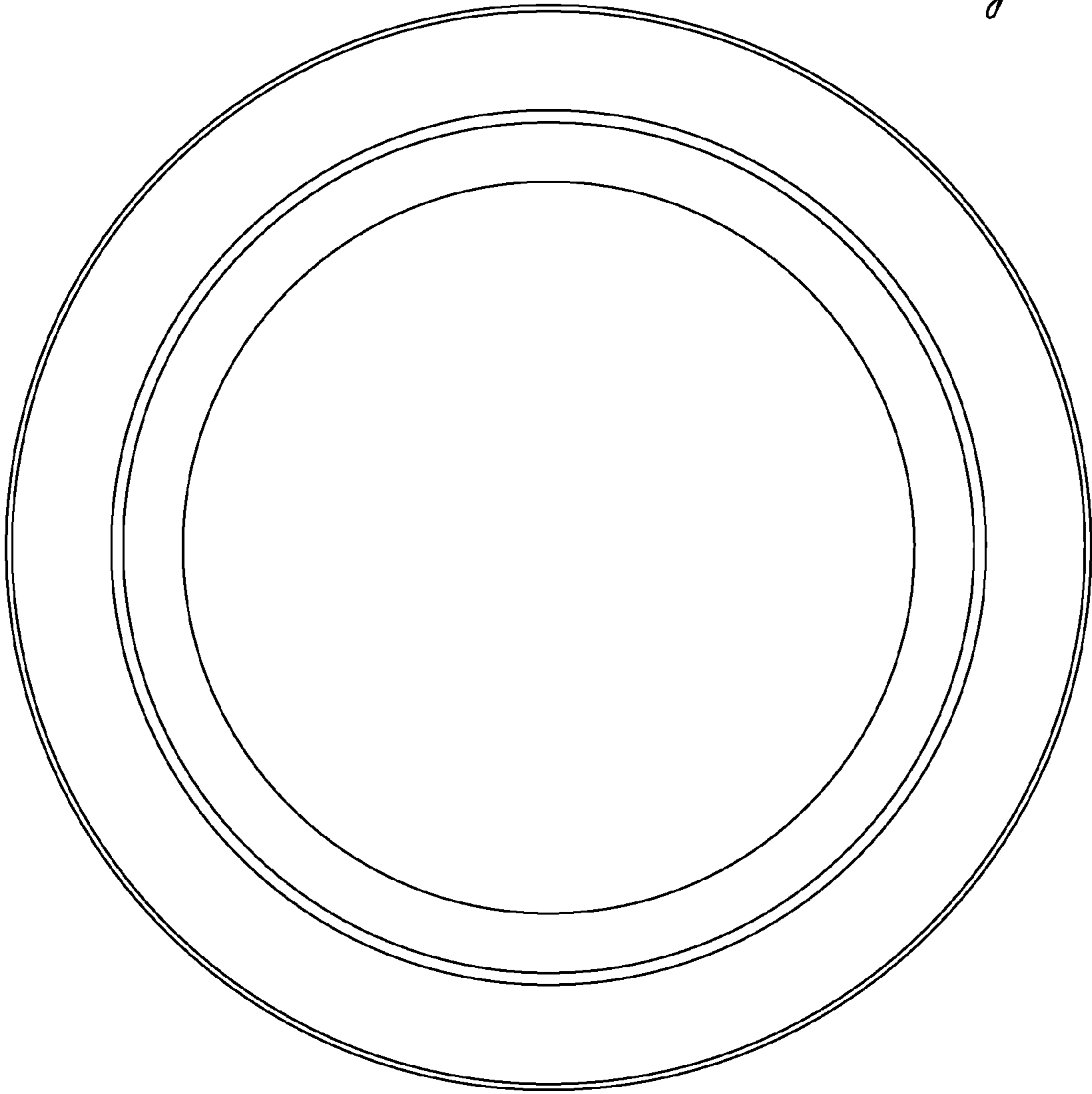
