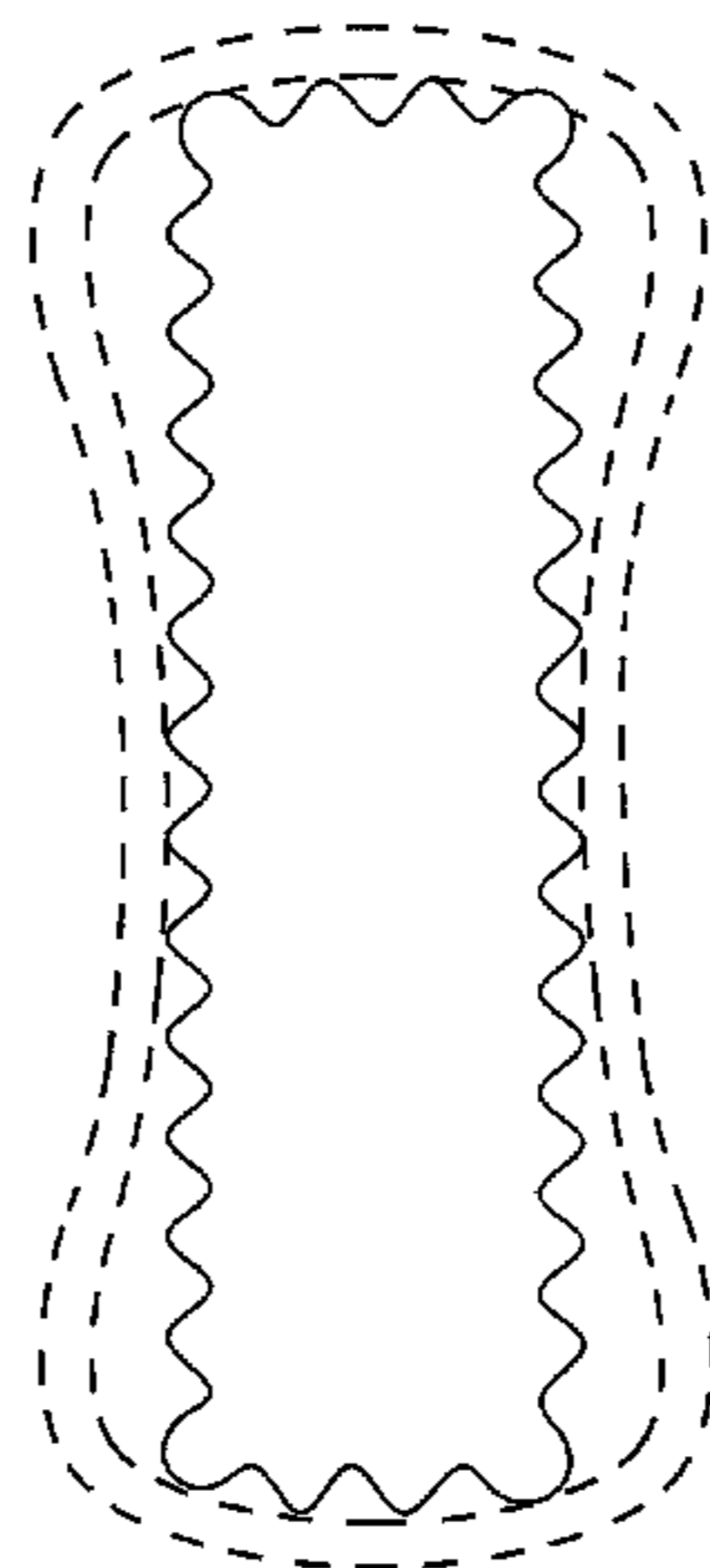
The ornamental design for an absorbent product with release sheet, as shown and described.

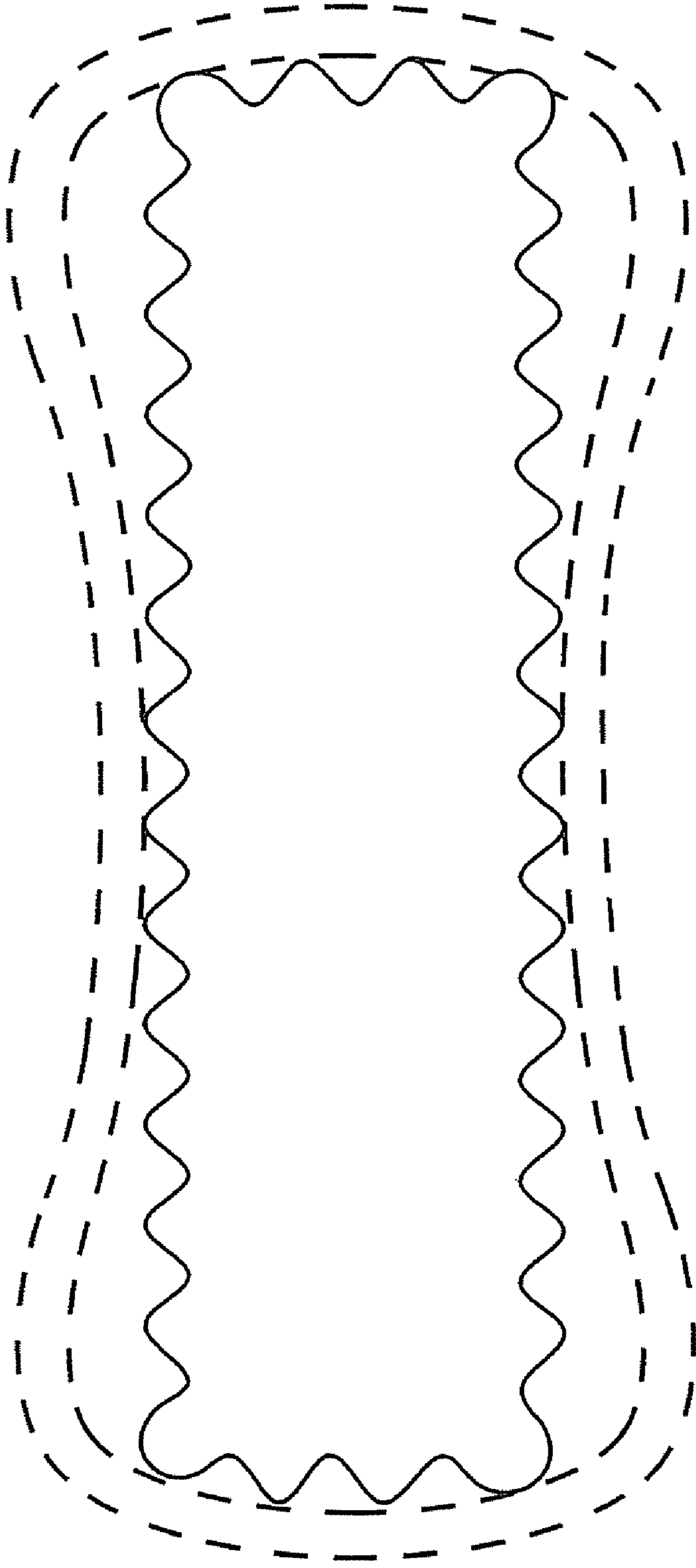
