(57) **CLAIM**

The ornamental design for a surgical instrument for use in single-access surgery, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of a surgical instrument for use in single-access surgery in accordance with the new design;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevation view thereof;

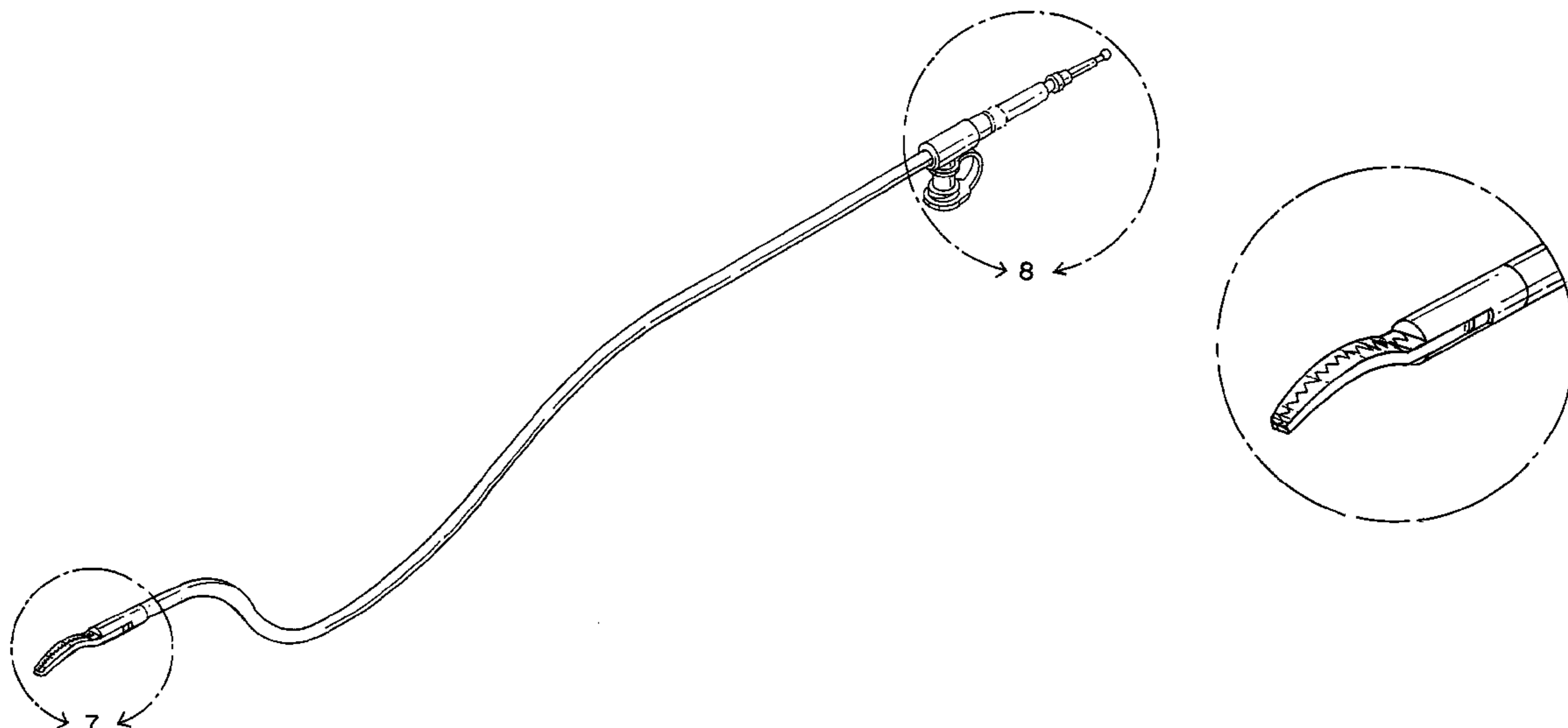
FIG. 6 is a rear elevation view thereof;

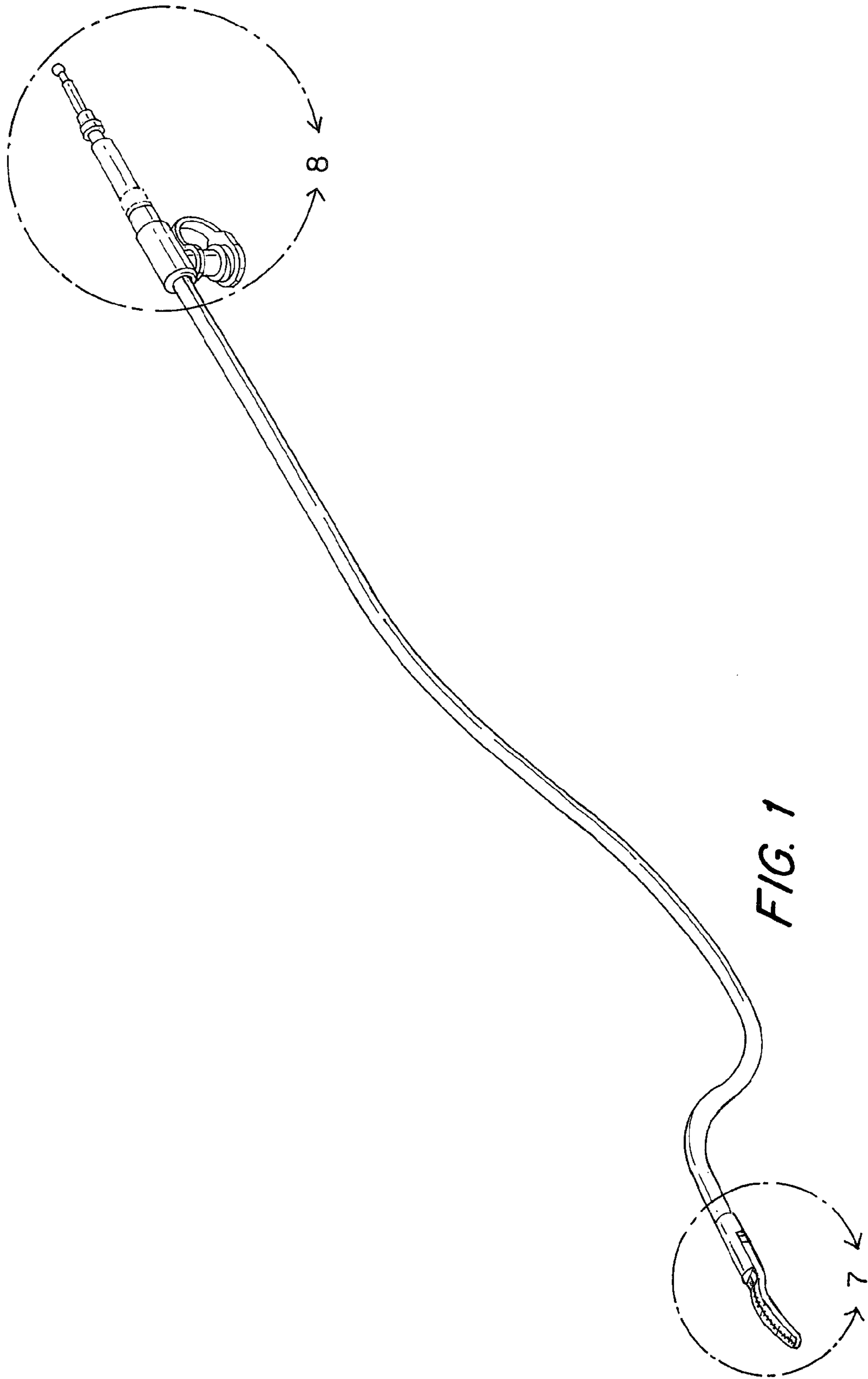
FIG. 7 is an enlarged perspective view of the area labeled “7” in FIG. 1; and,

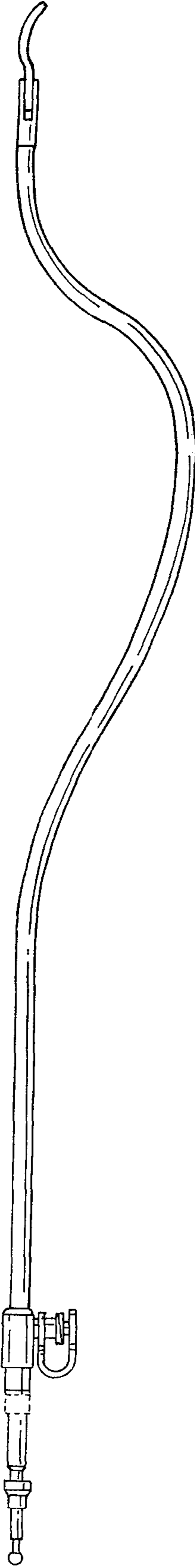
FIG. 8 is an enlarged perspective view of the area labeled “8” in FIG. 1.

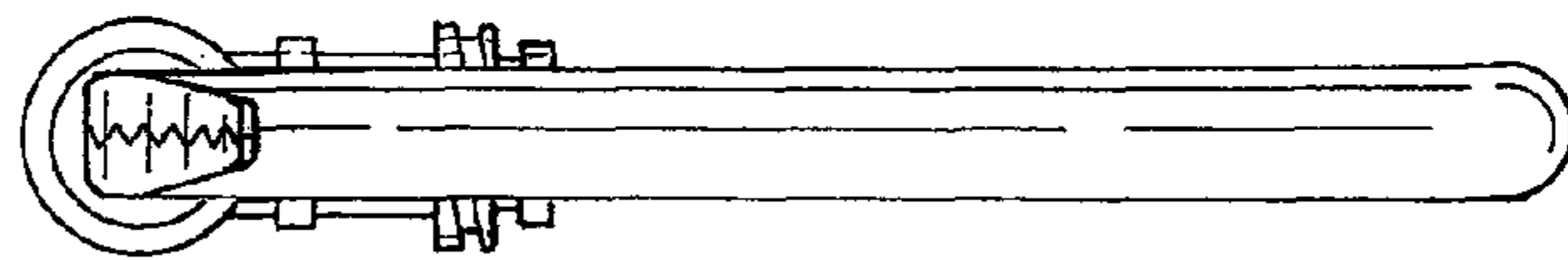

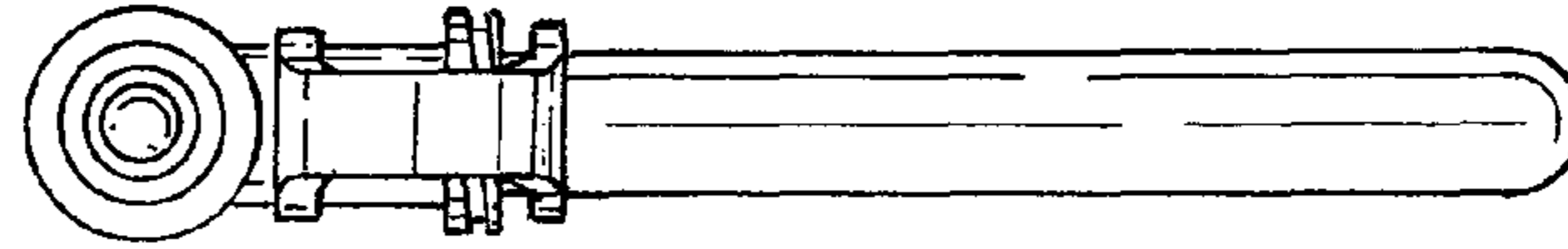
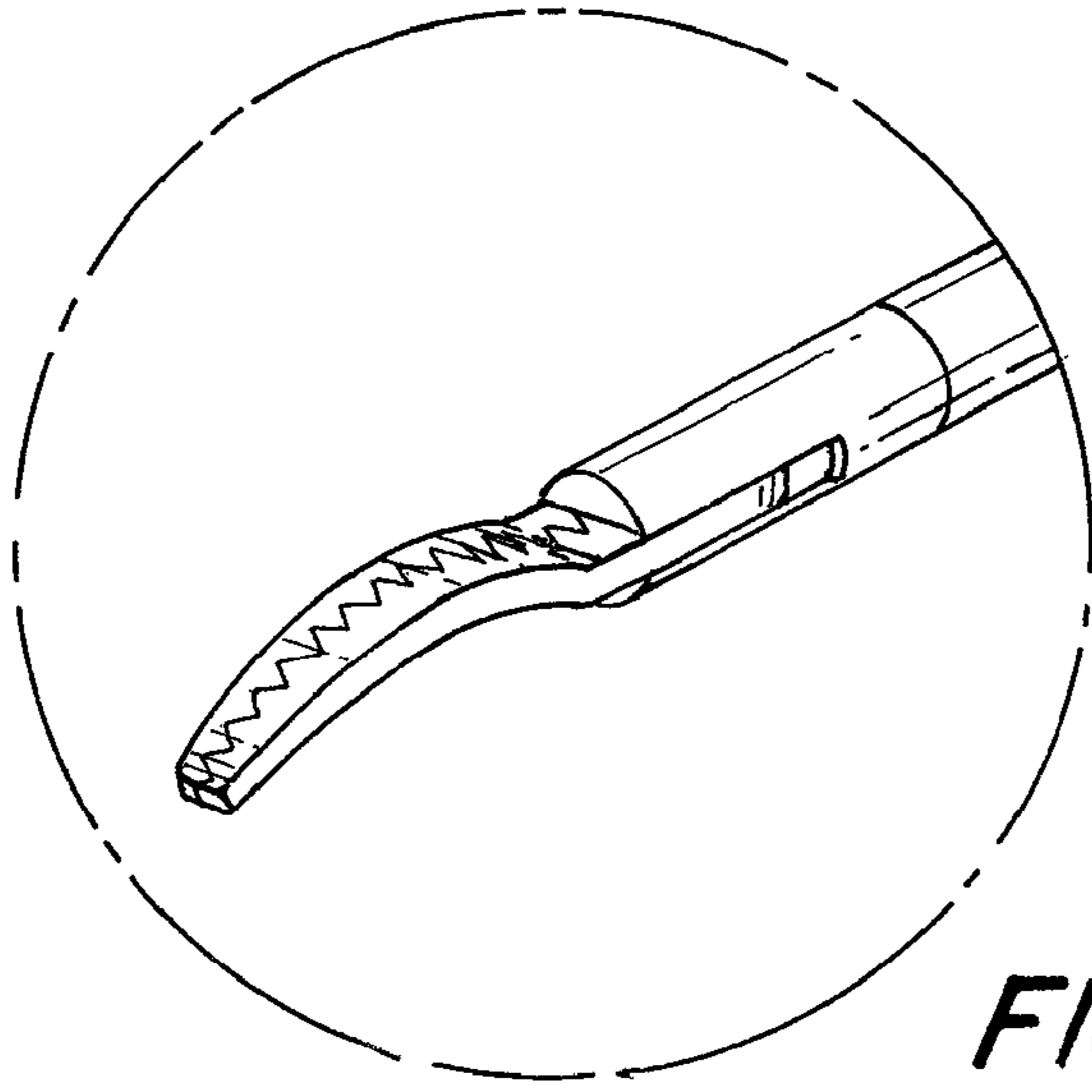
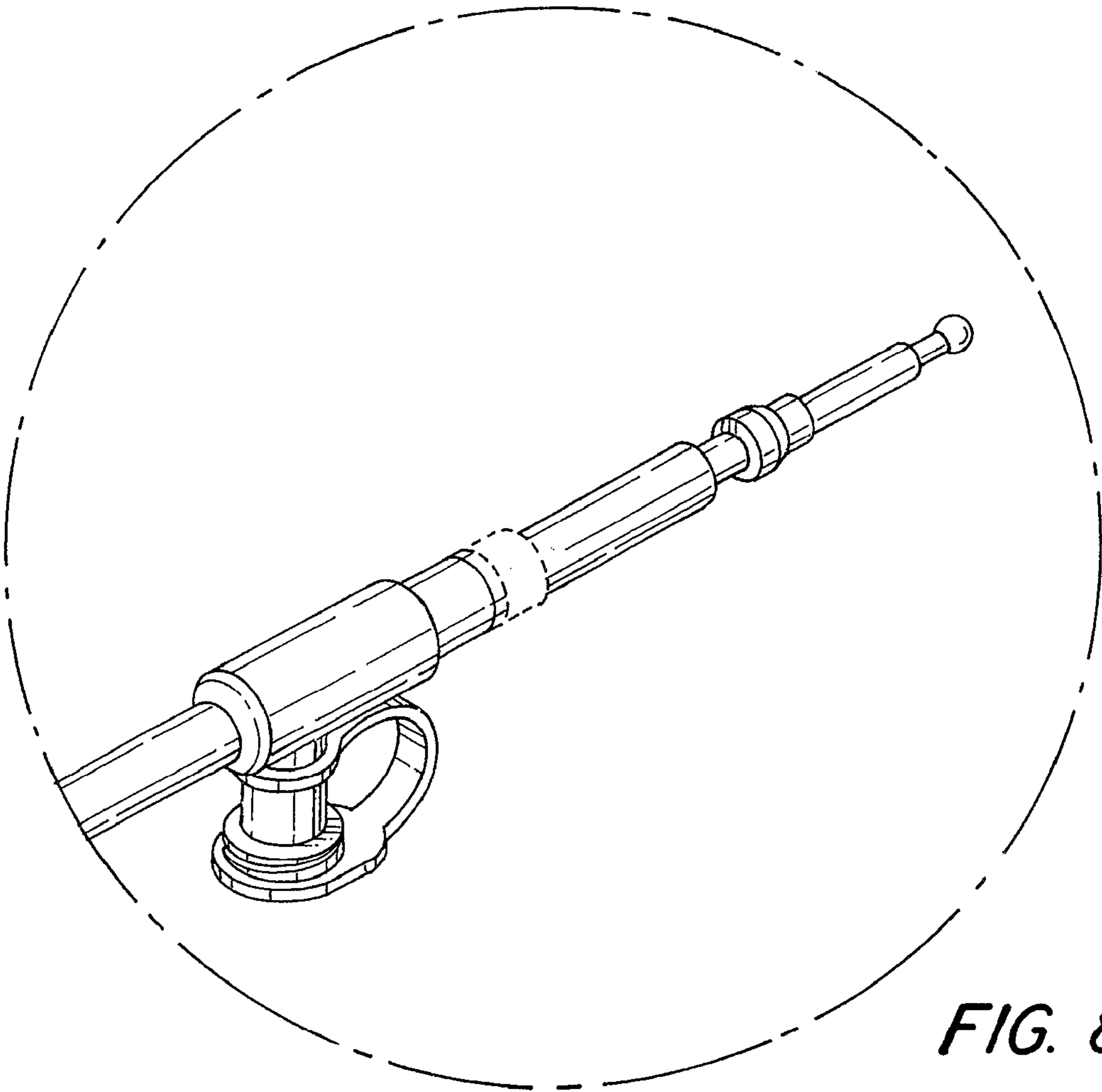
