FIG. 3 is a top view of the invention;

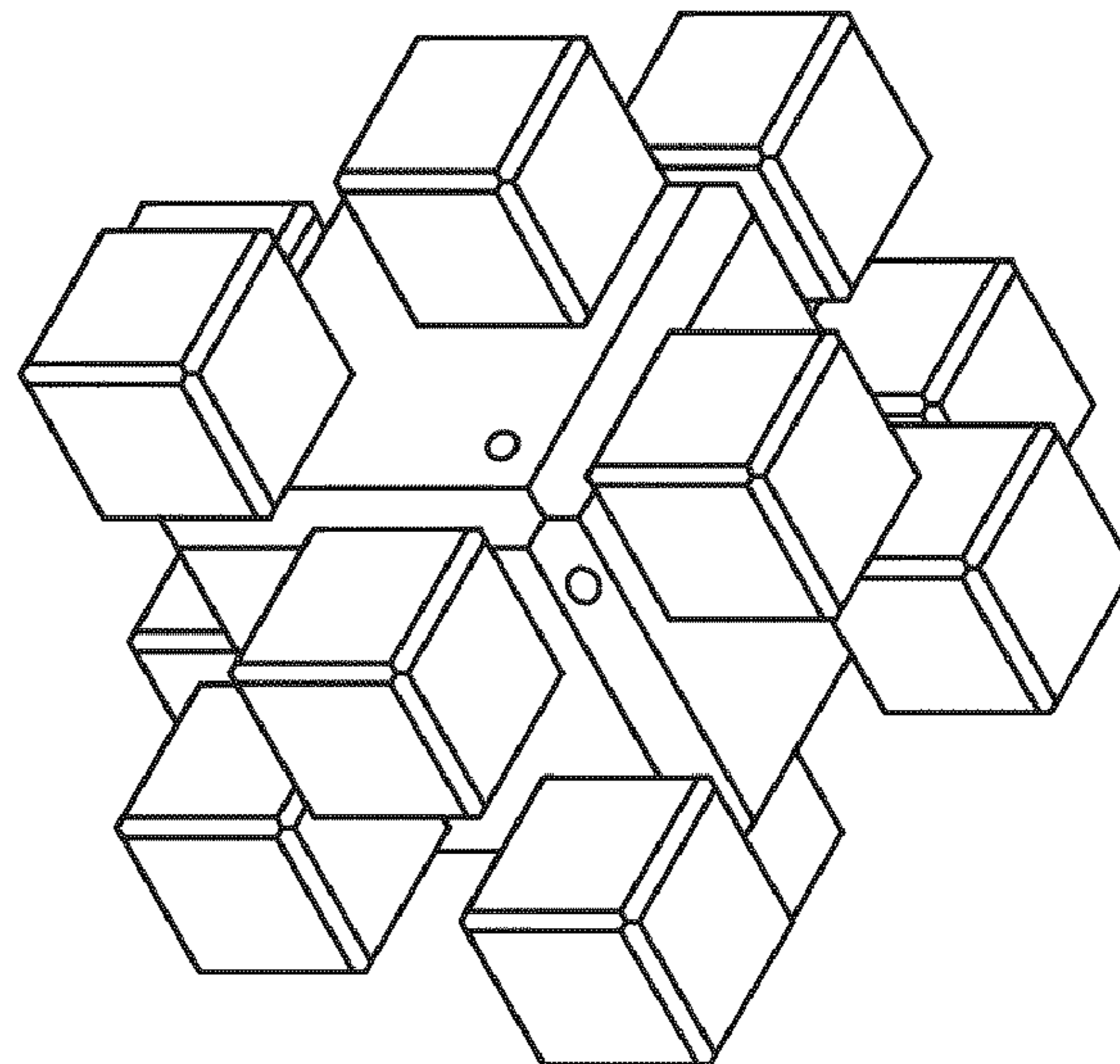
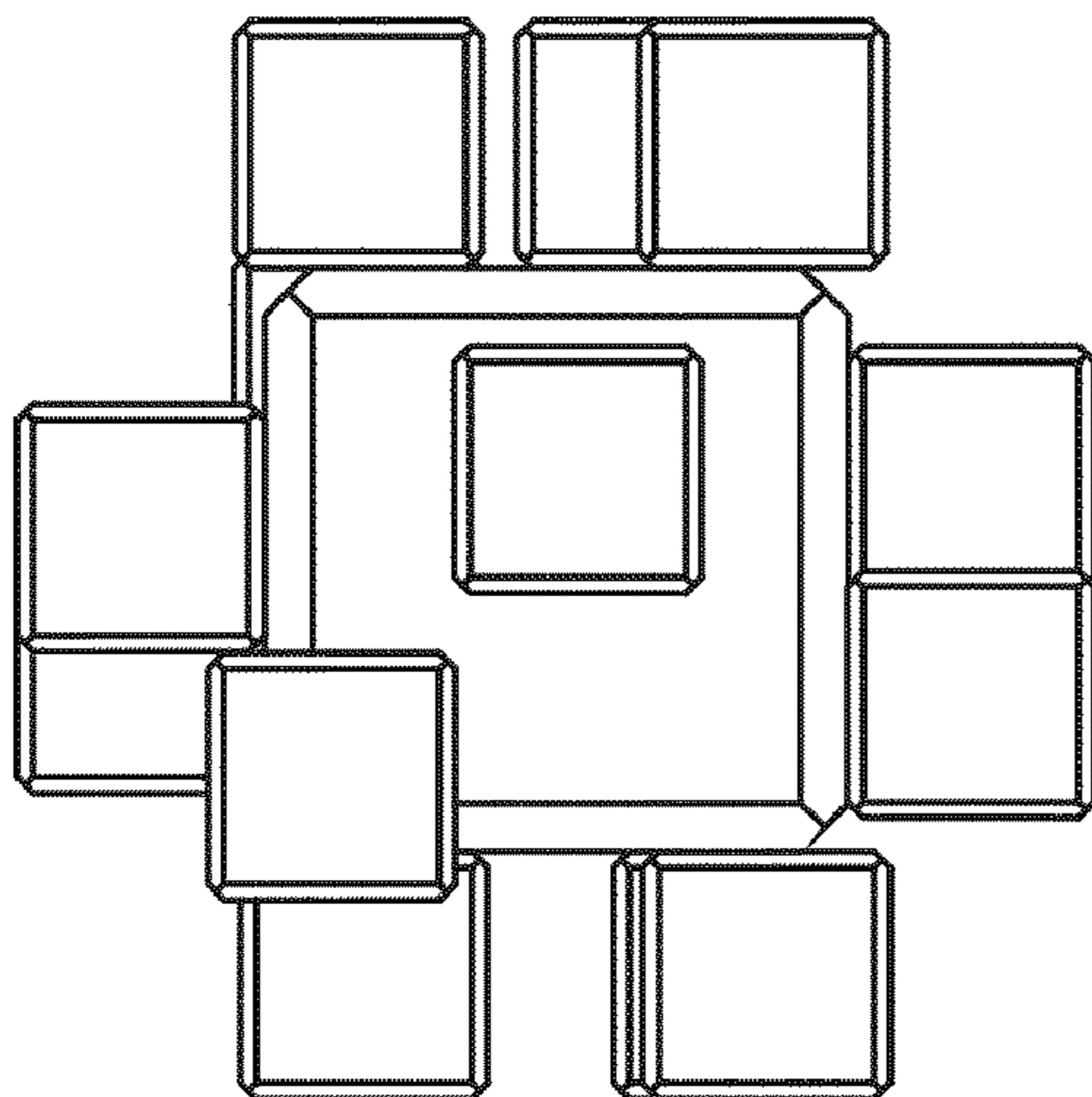
FIG. 4 is a right view of the invention;

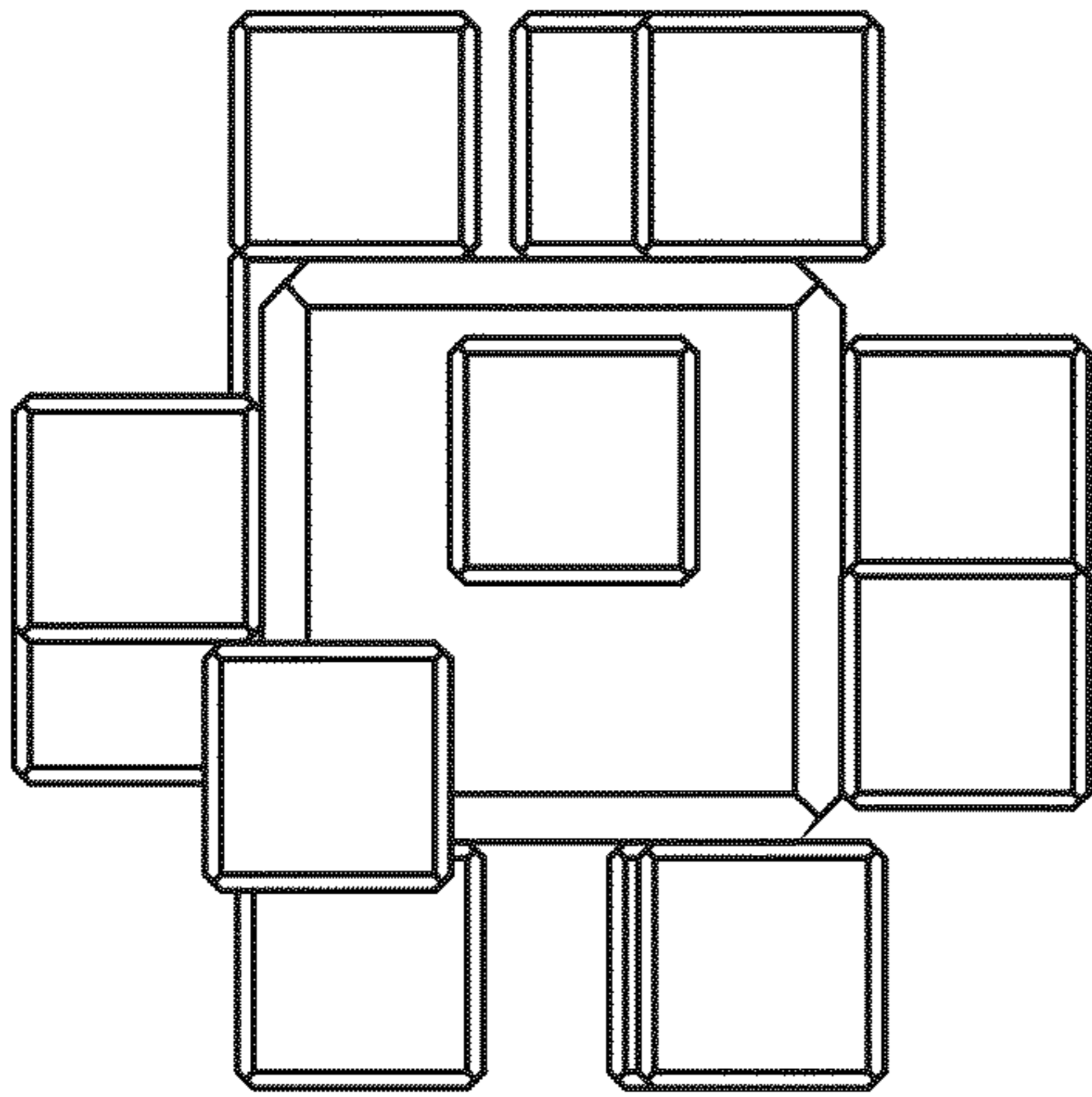

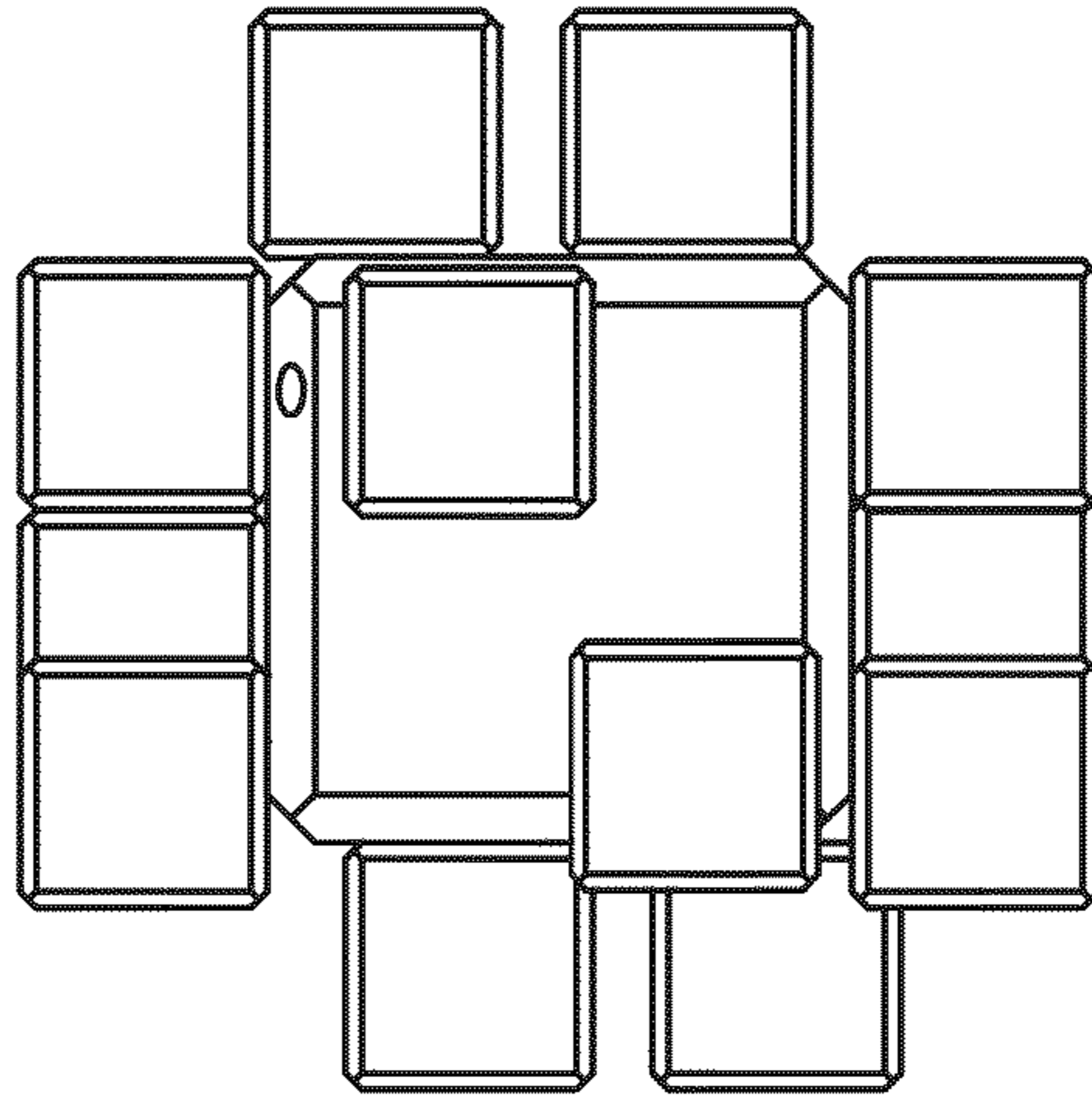

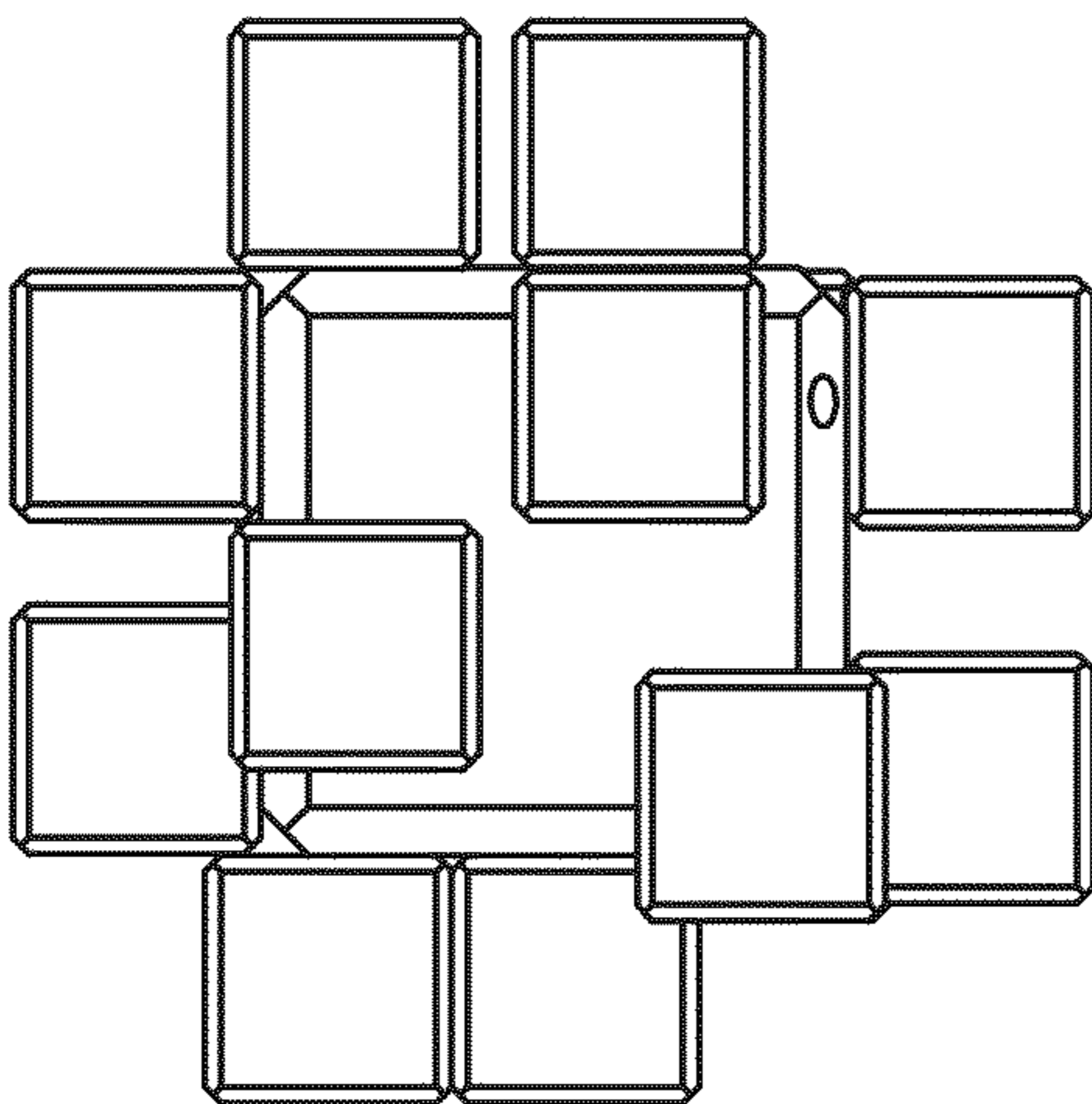

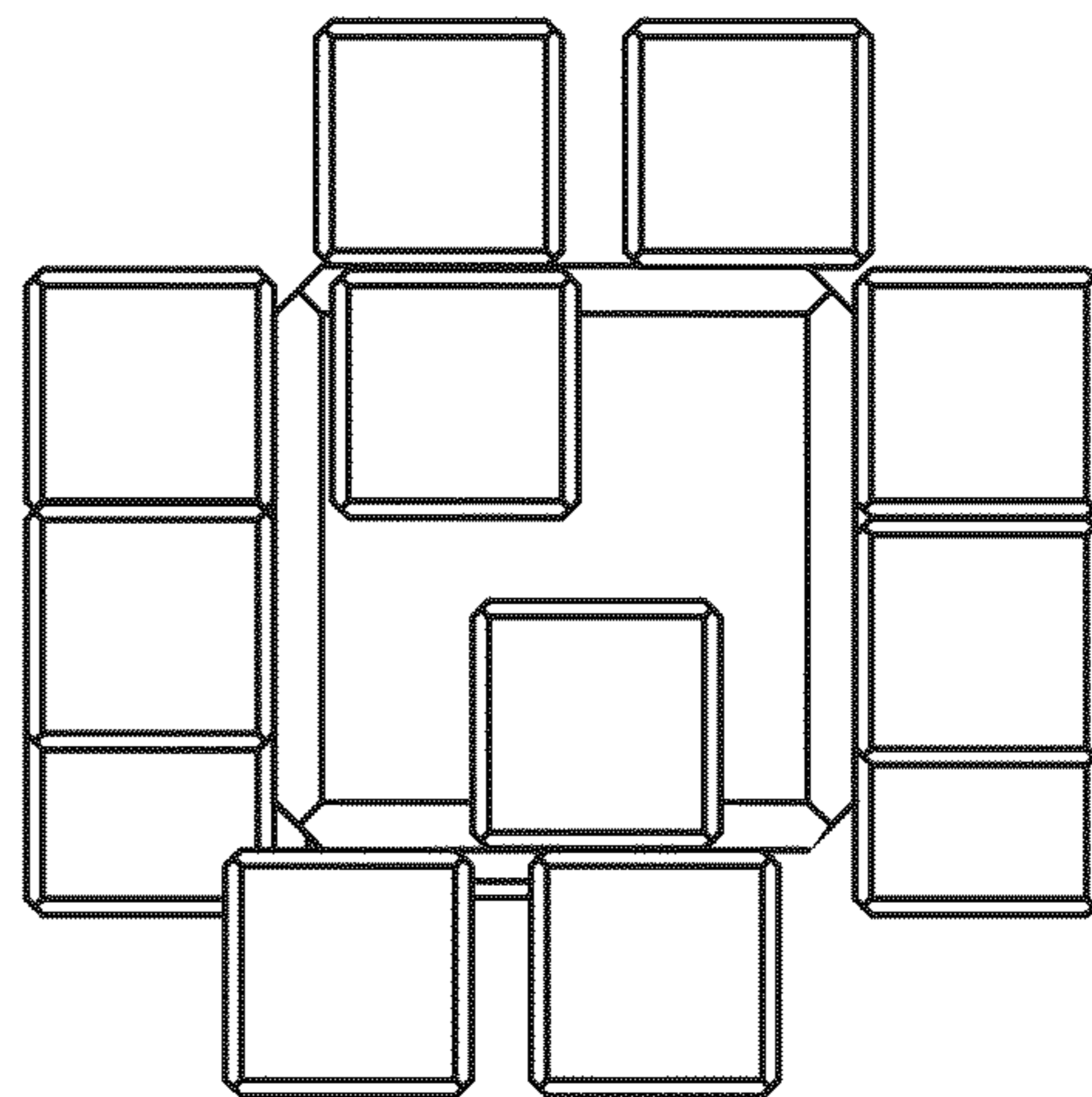

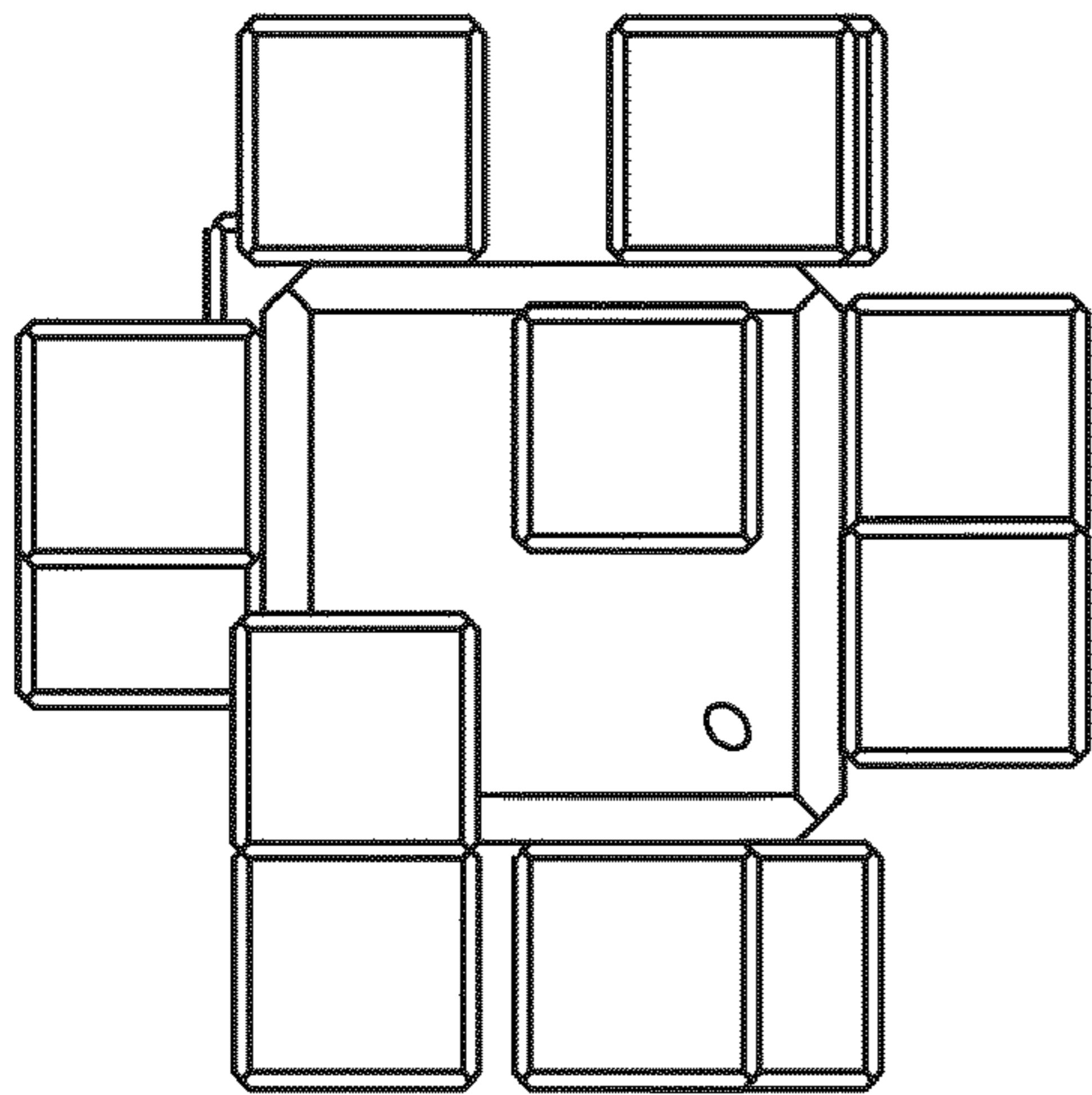

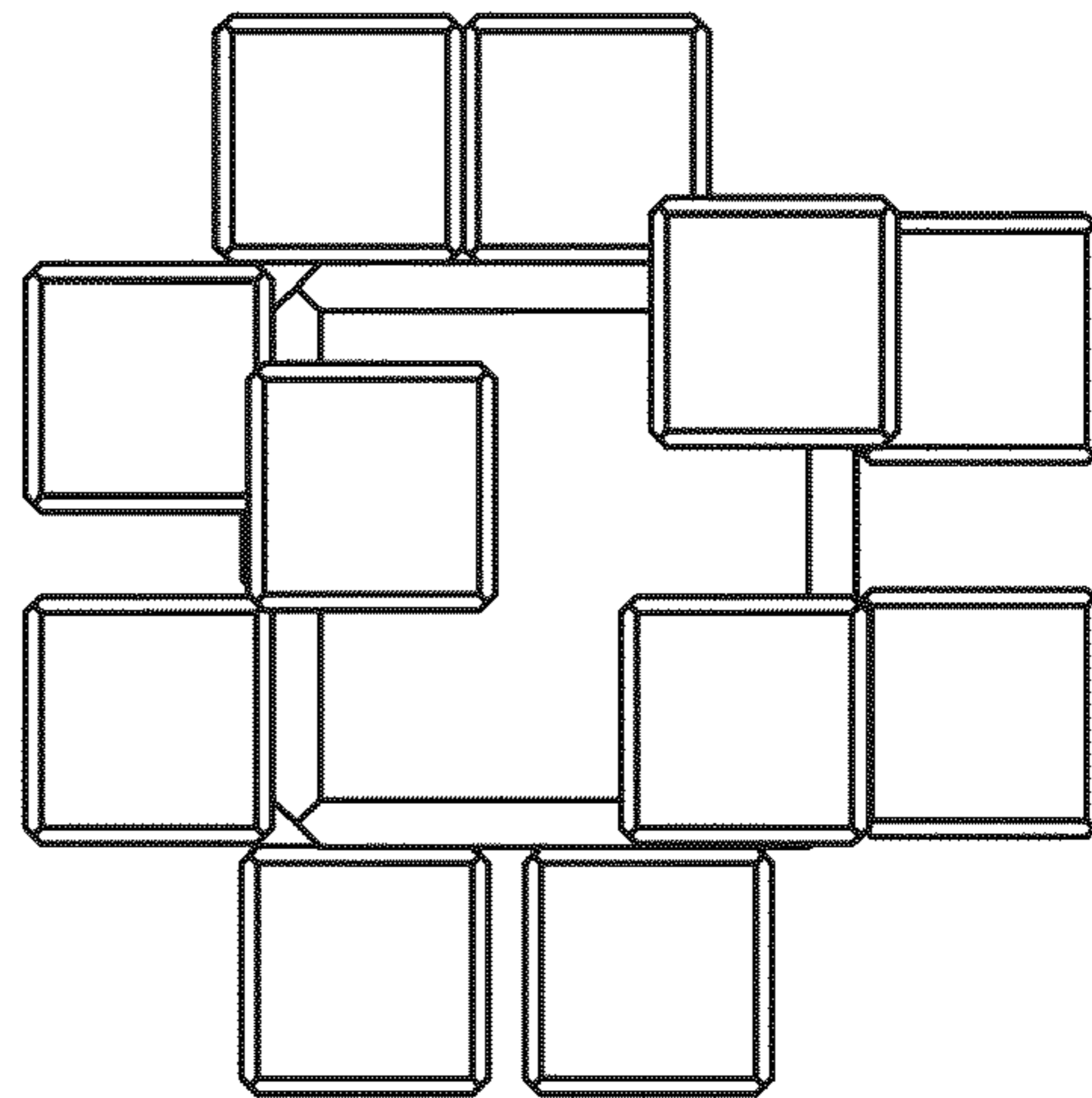

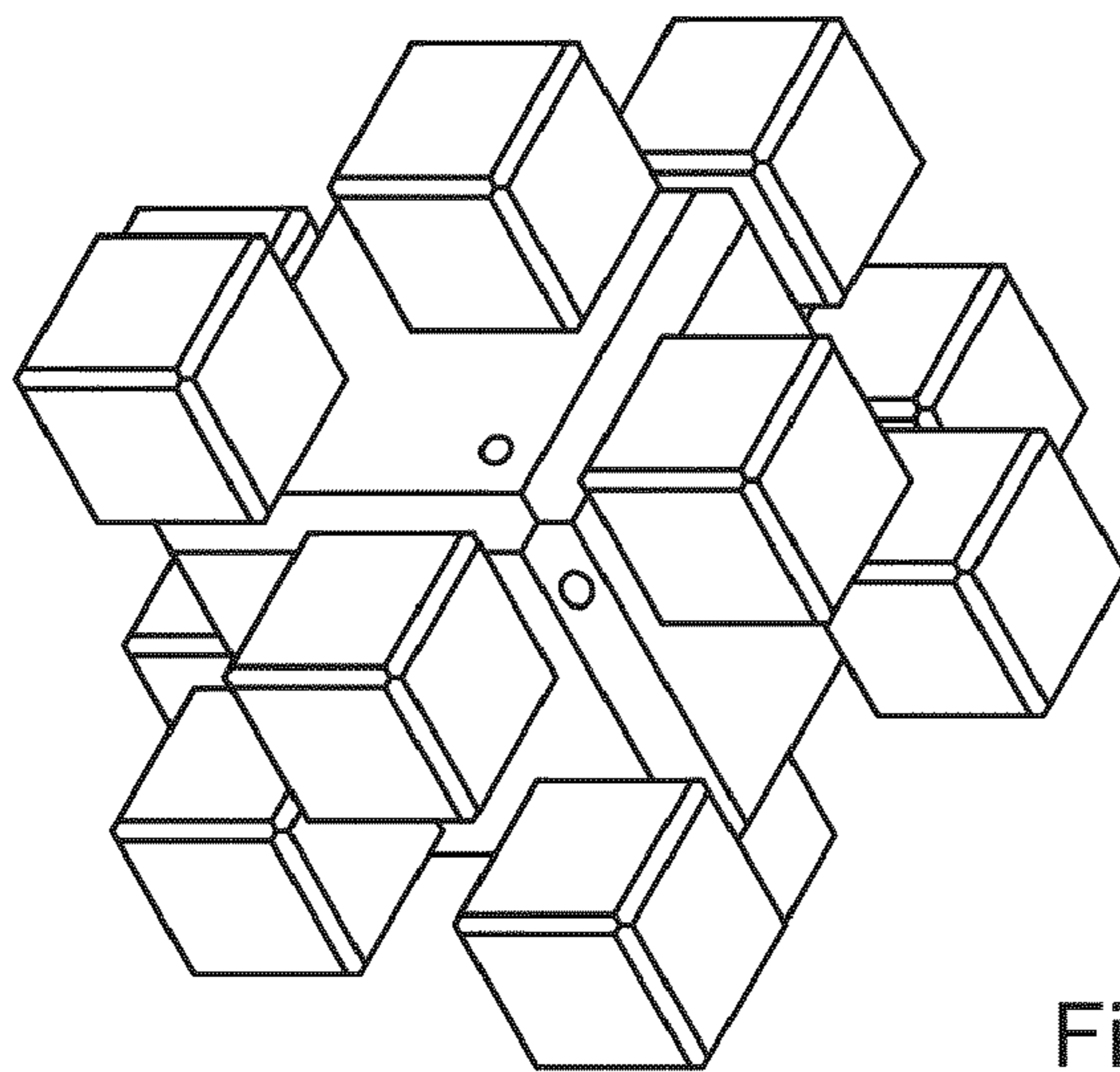
