FIG. 11 is a perspective view thereof (with detachable cap).

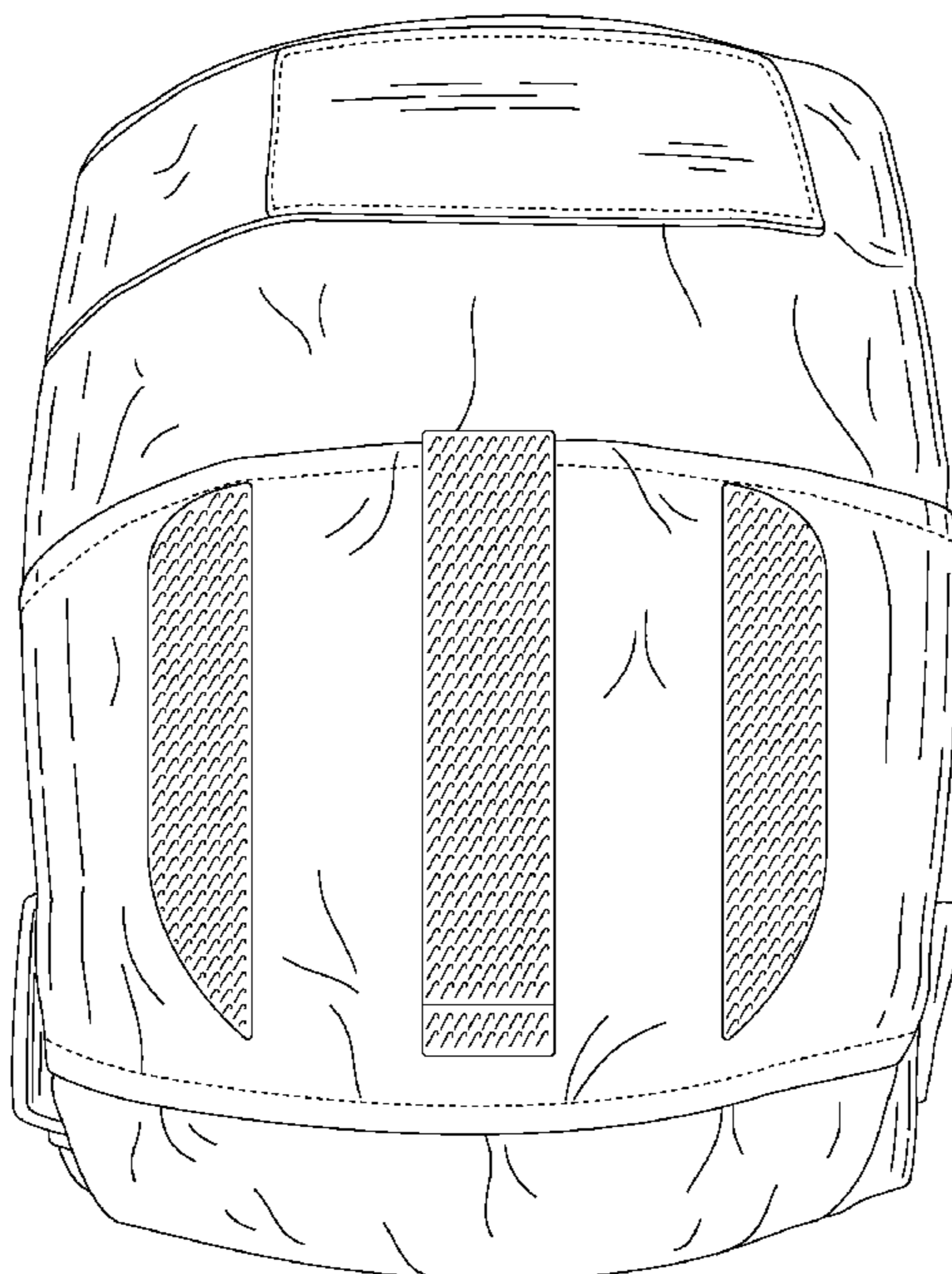

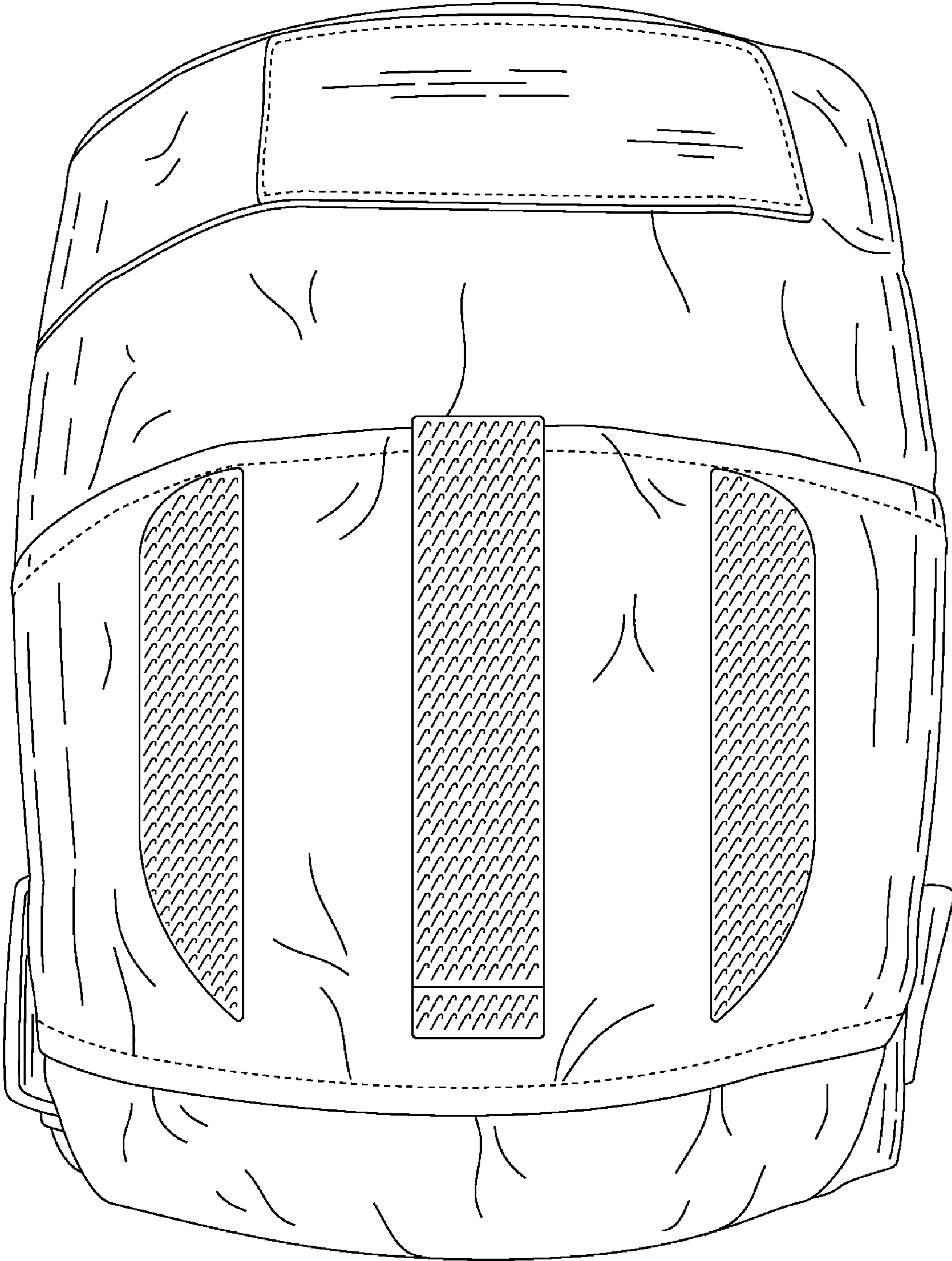

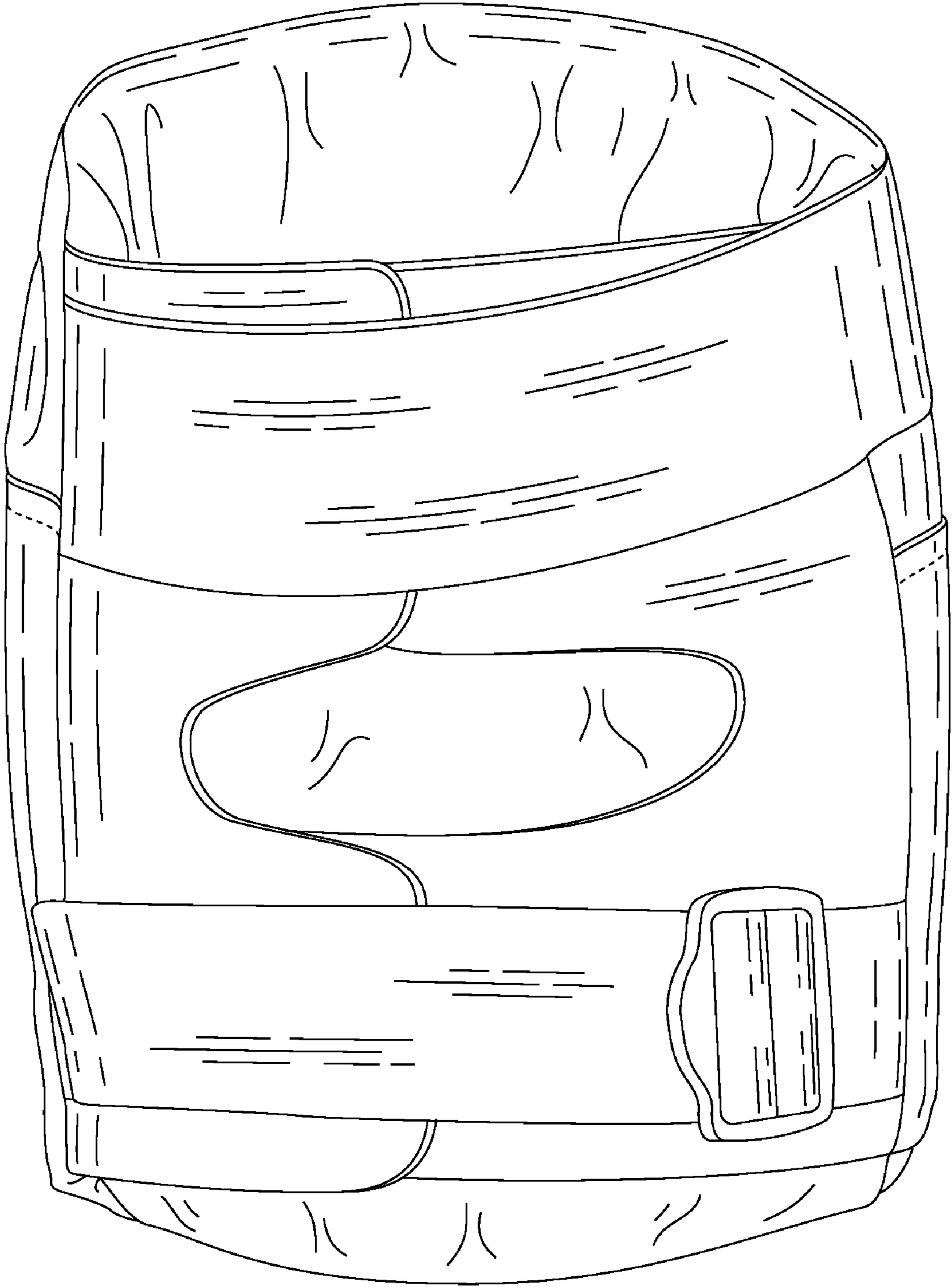

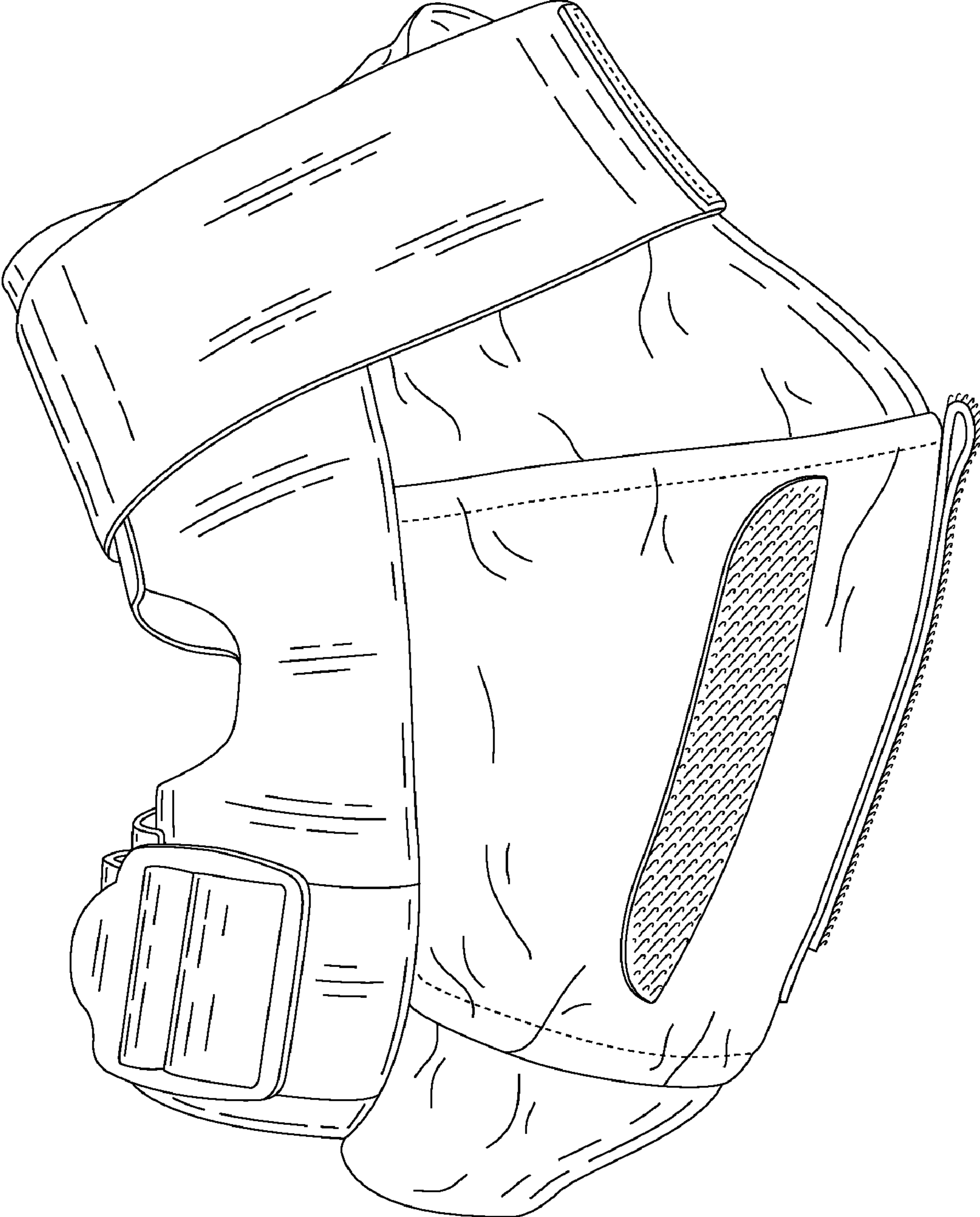

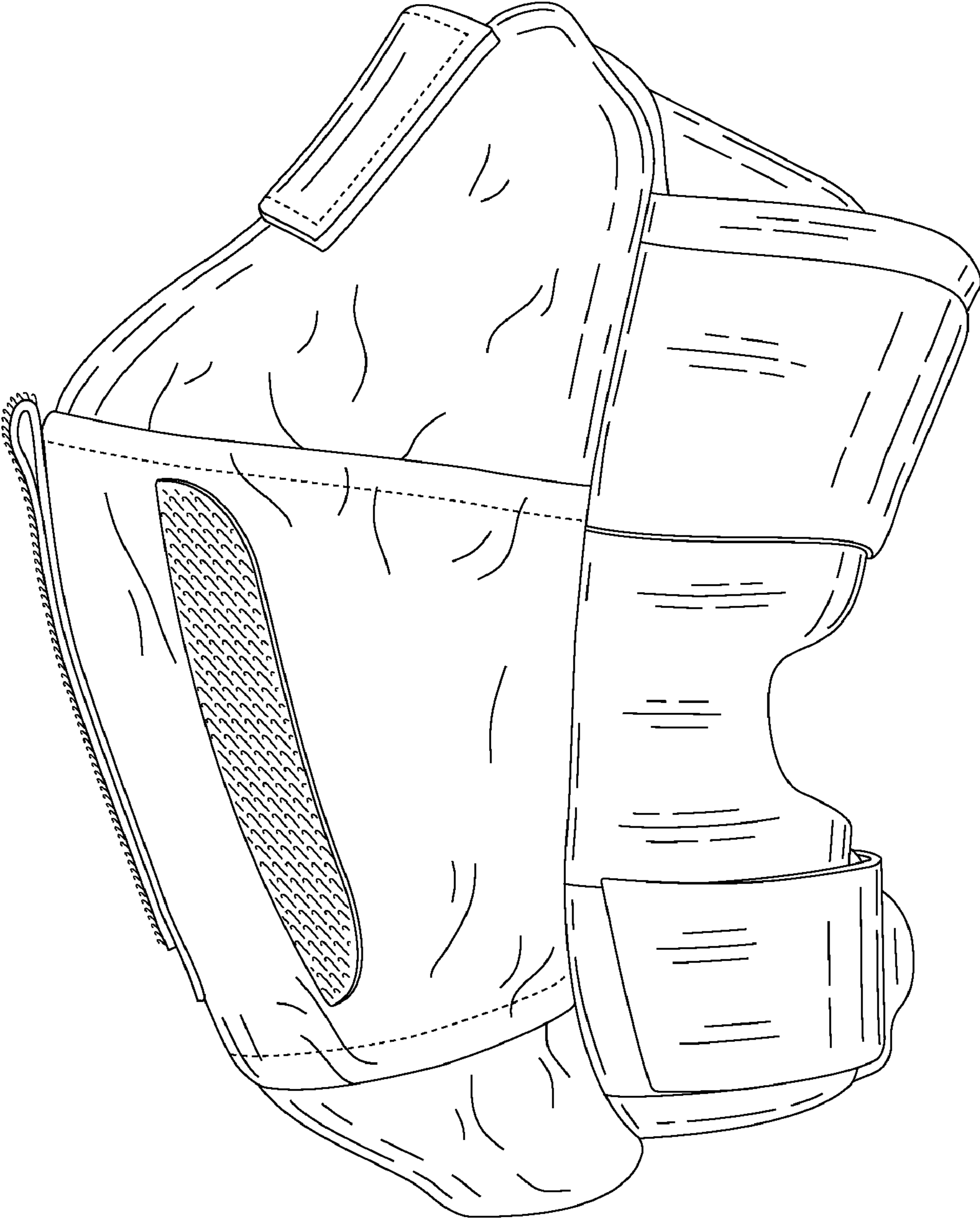

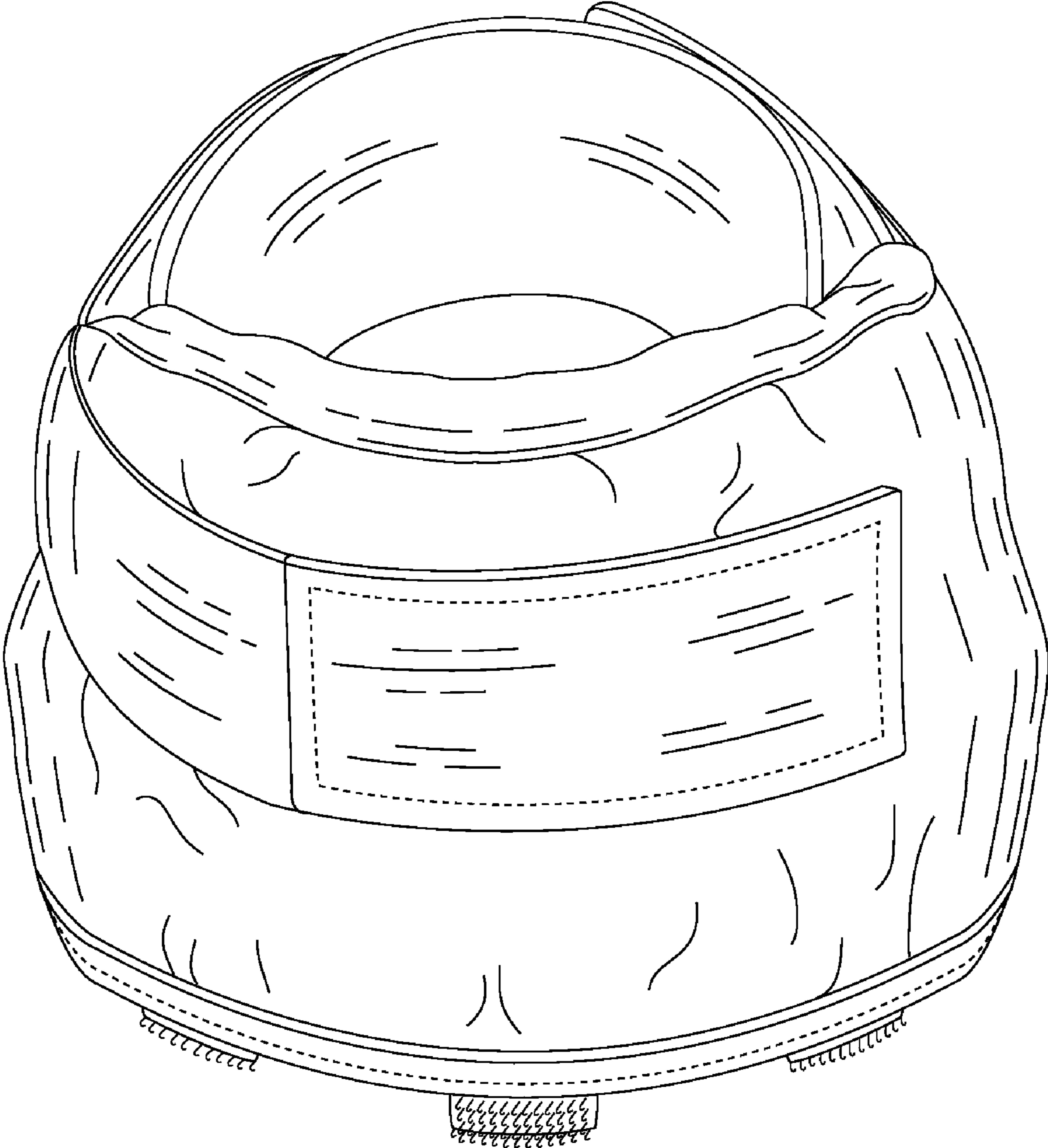

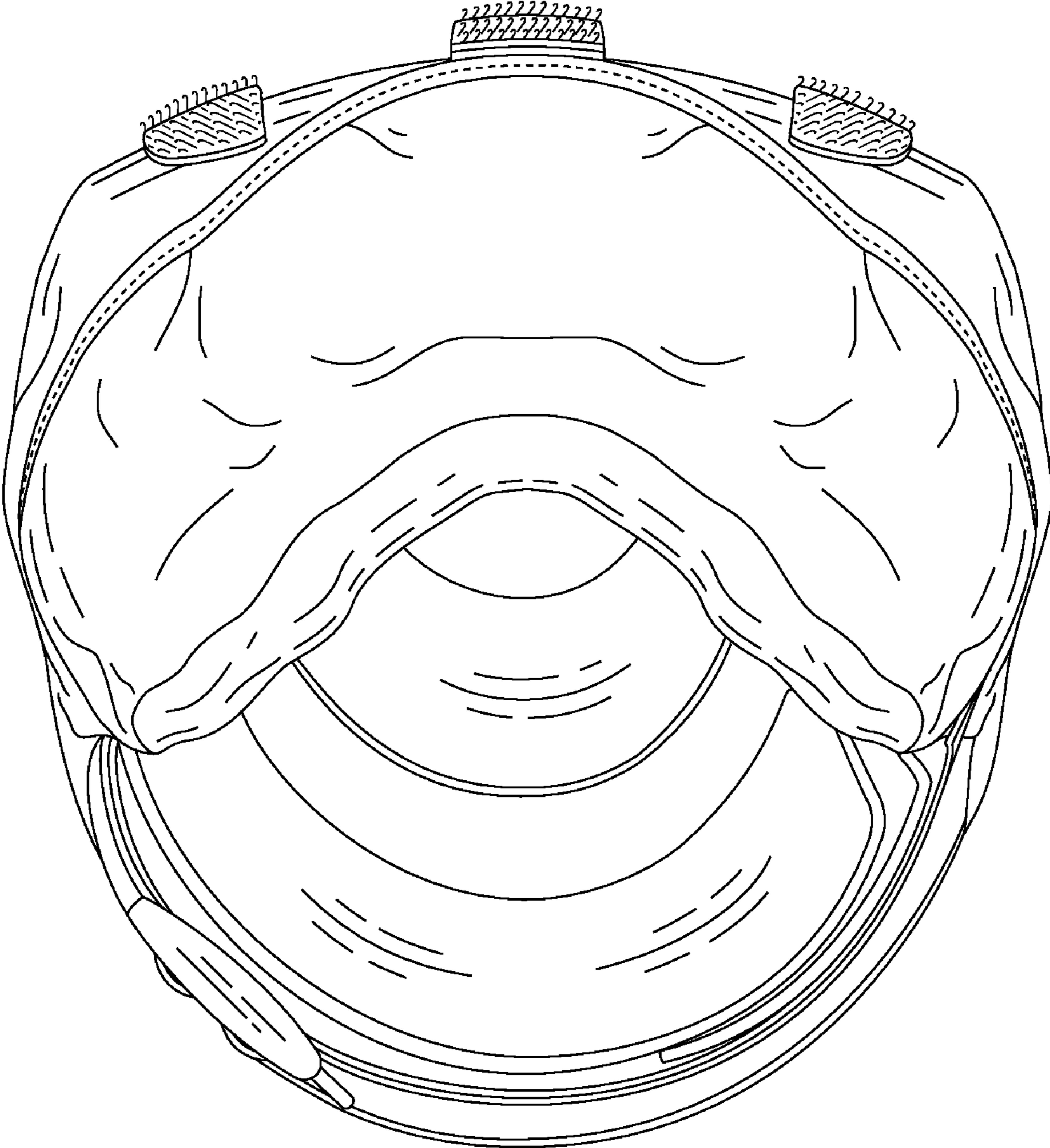

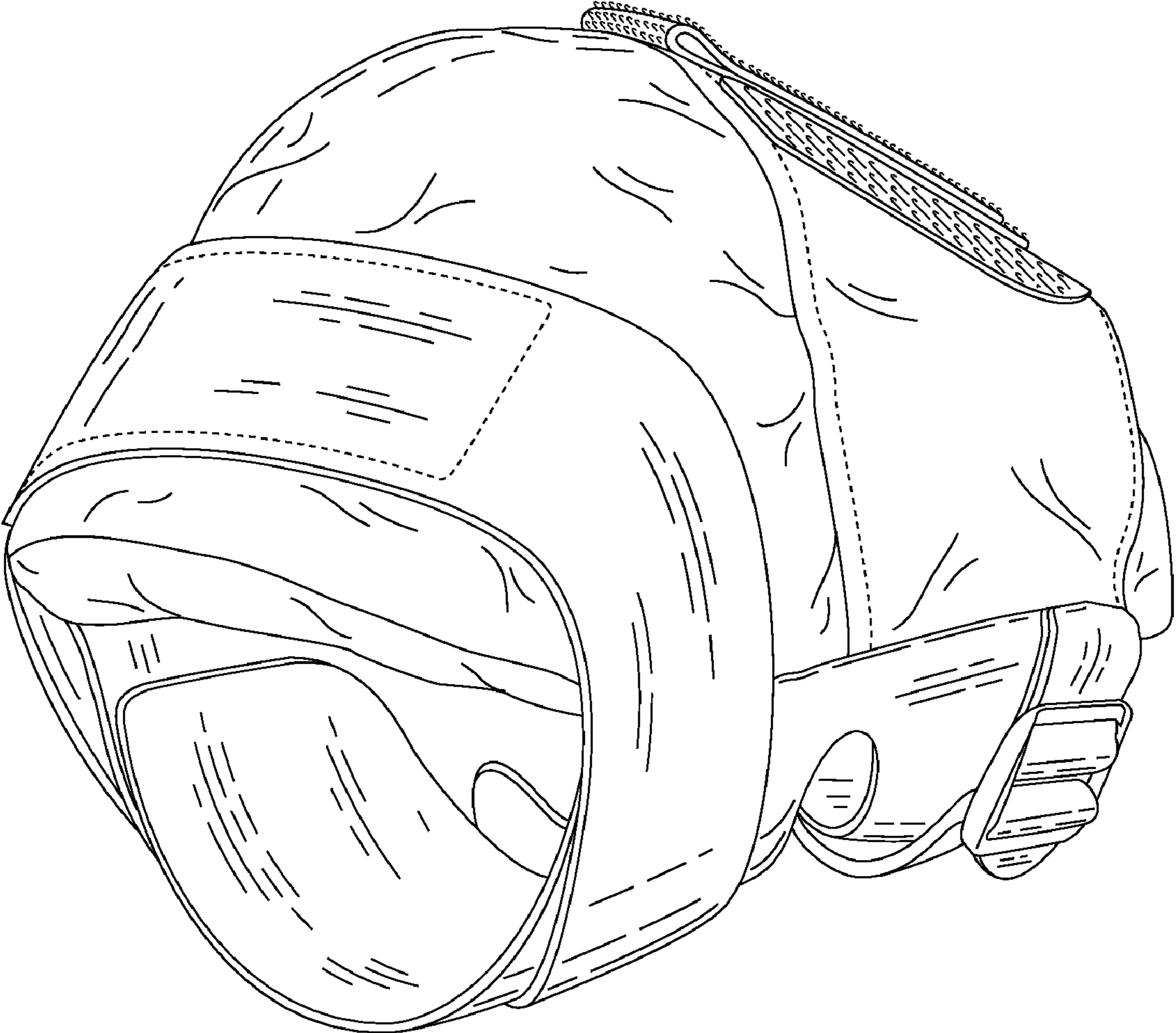

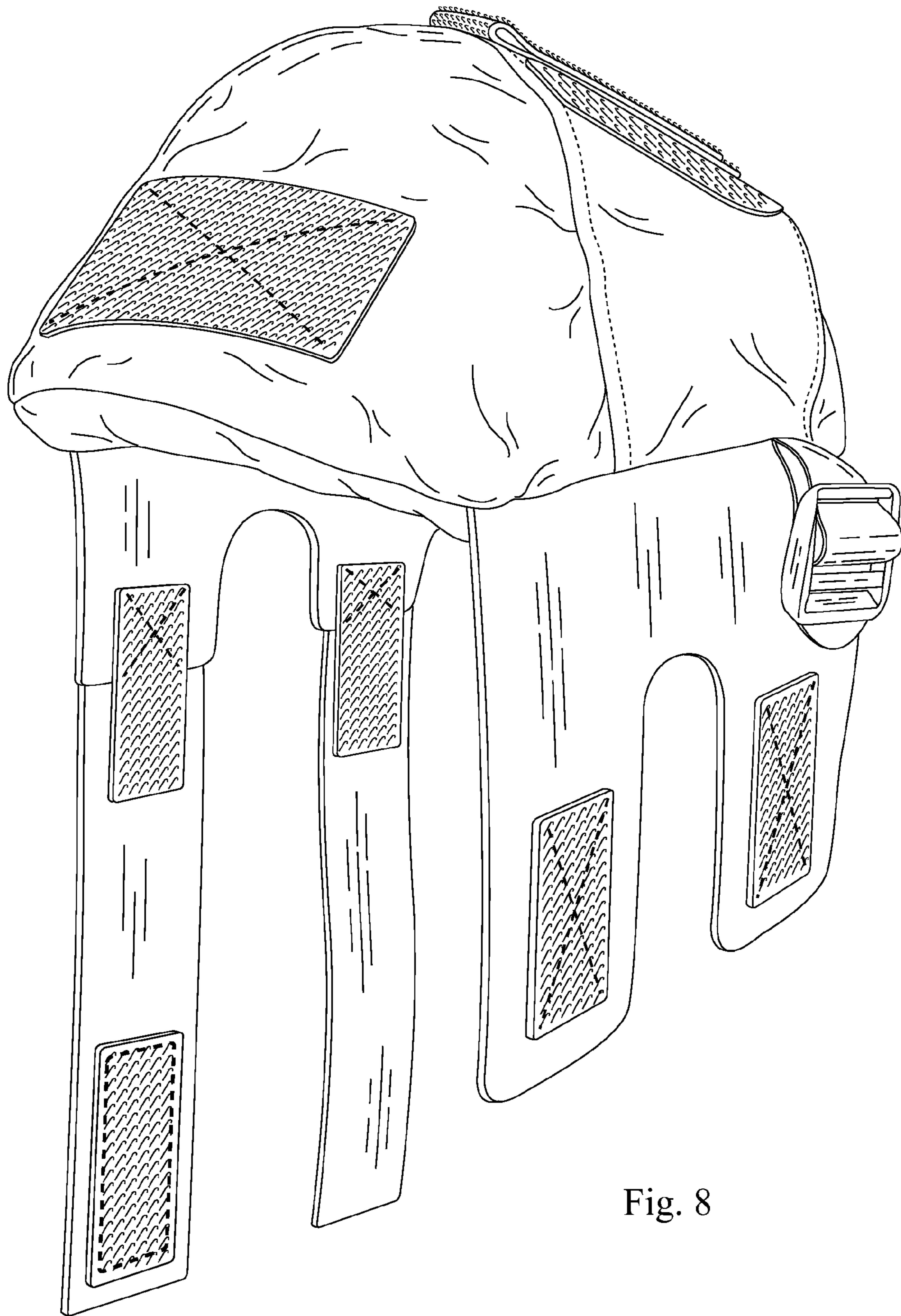

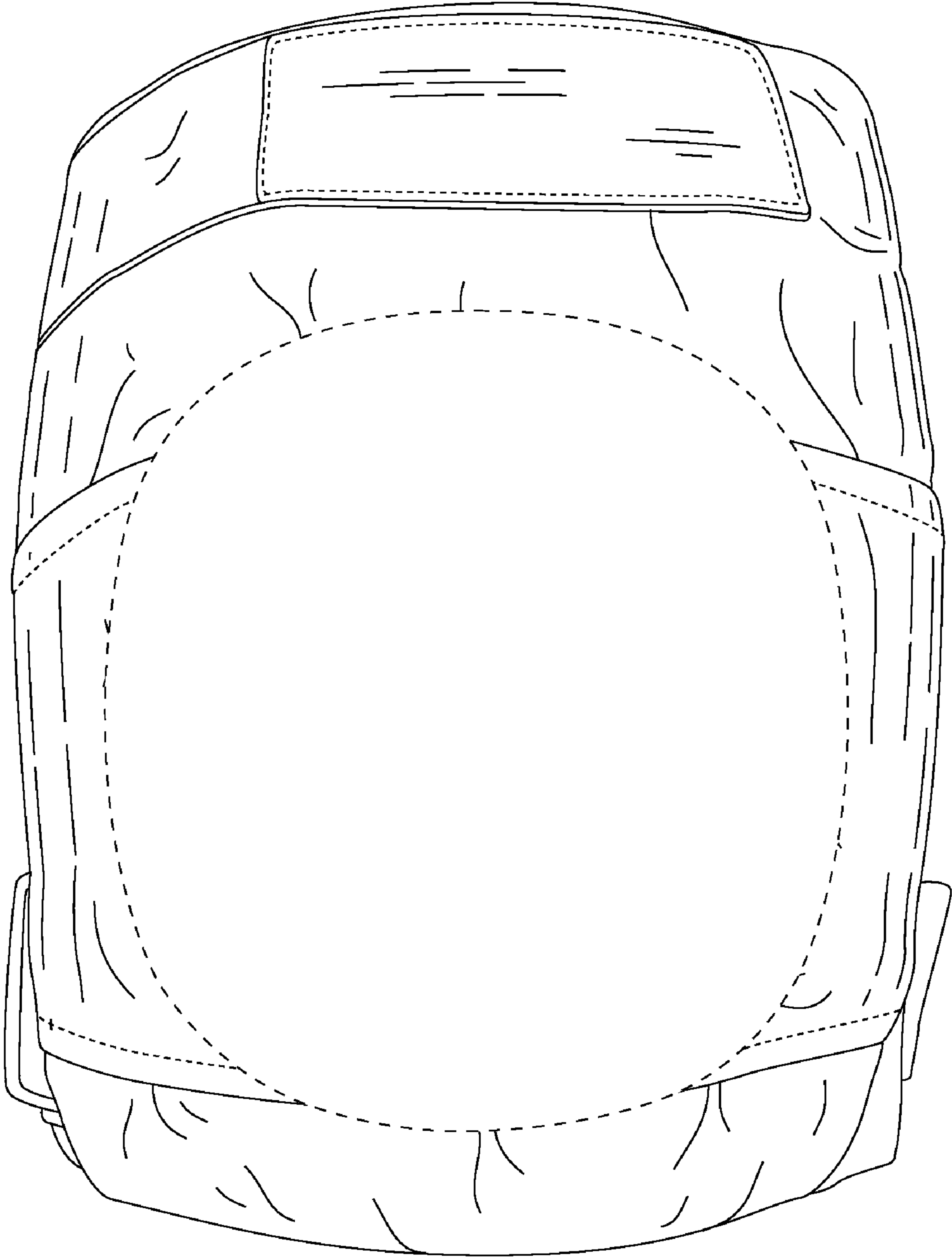

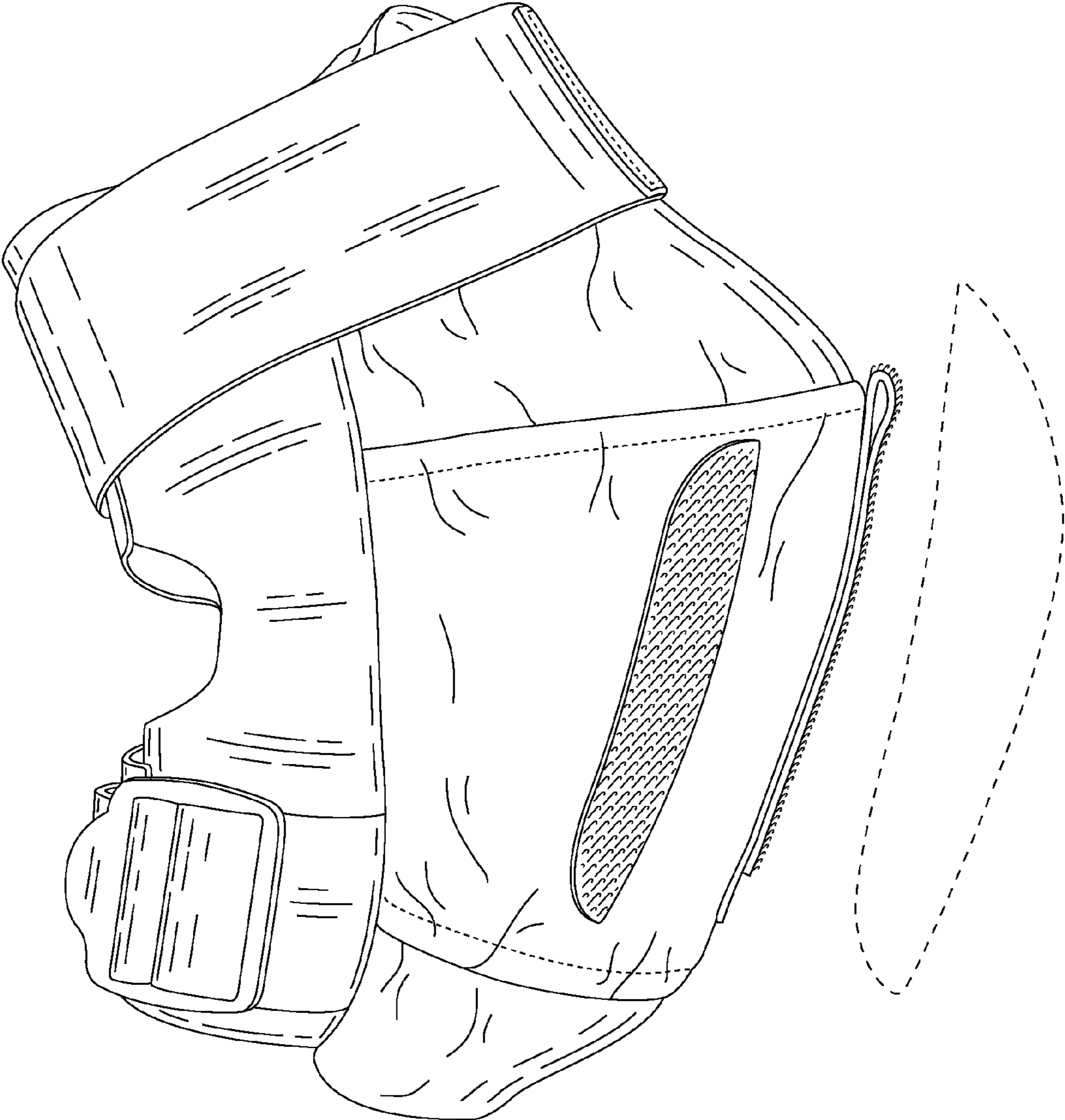

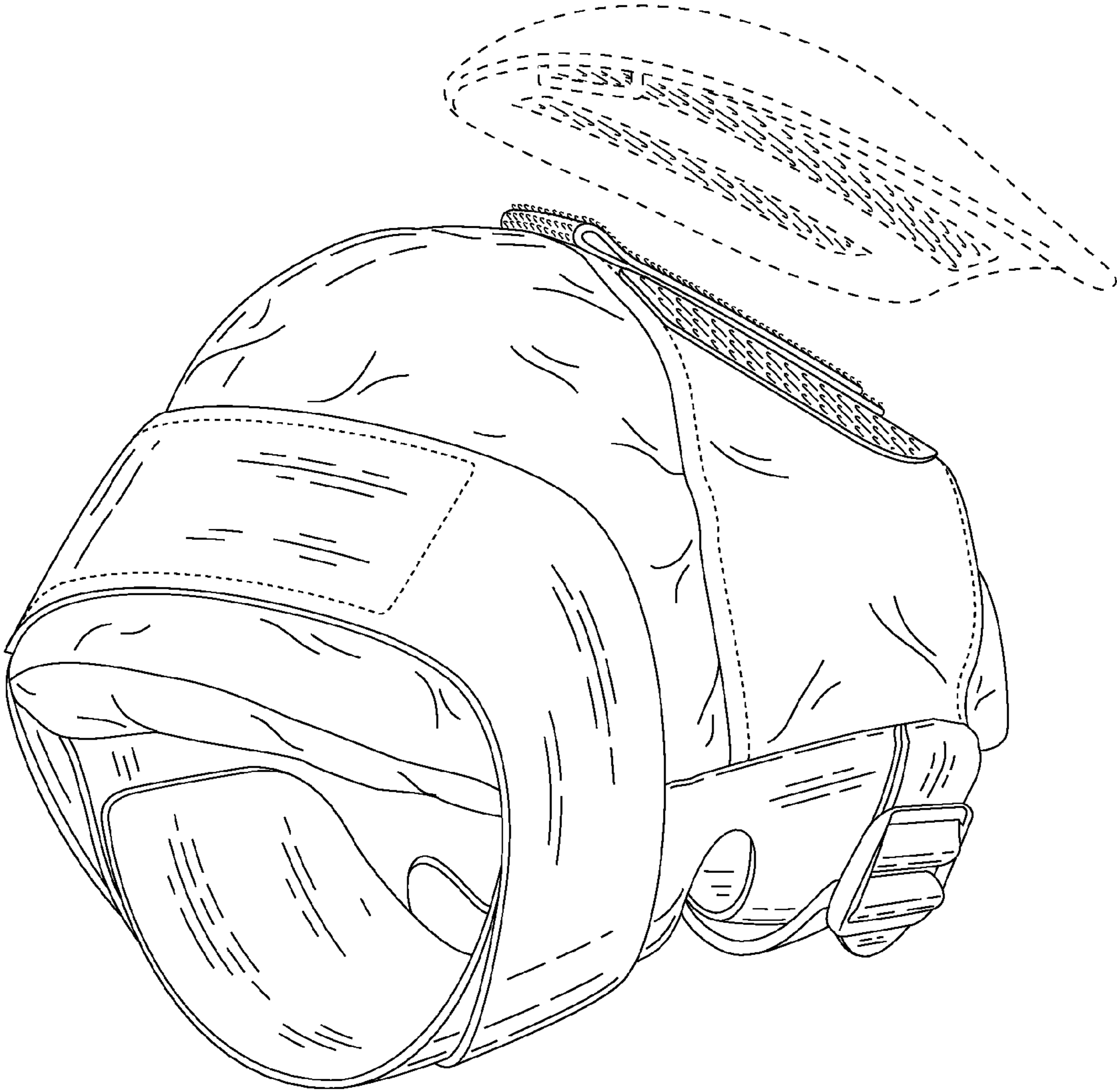
