FIG. 2 is a top view of thereof.

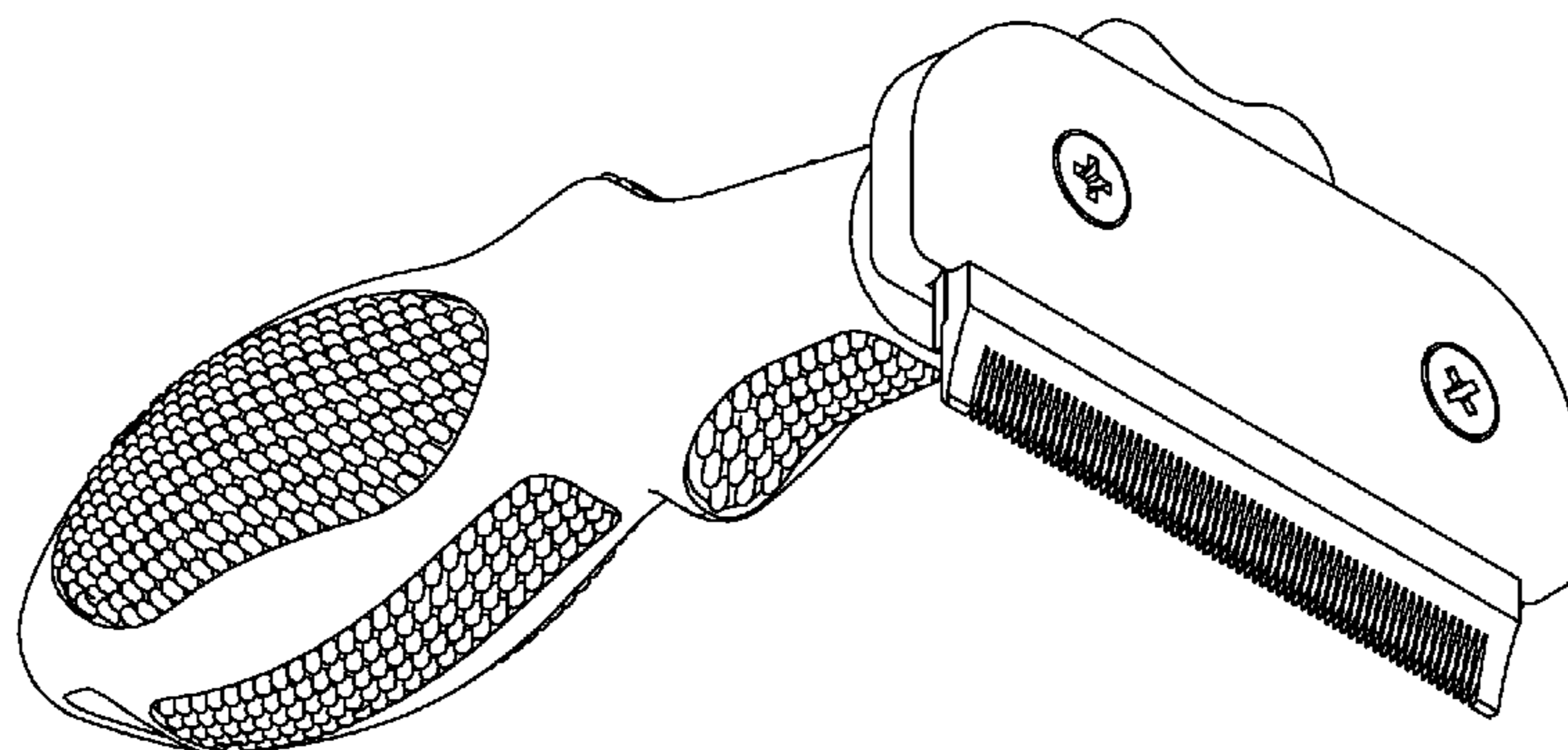
FIG. 3 is a front view thereof.

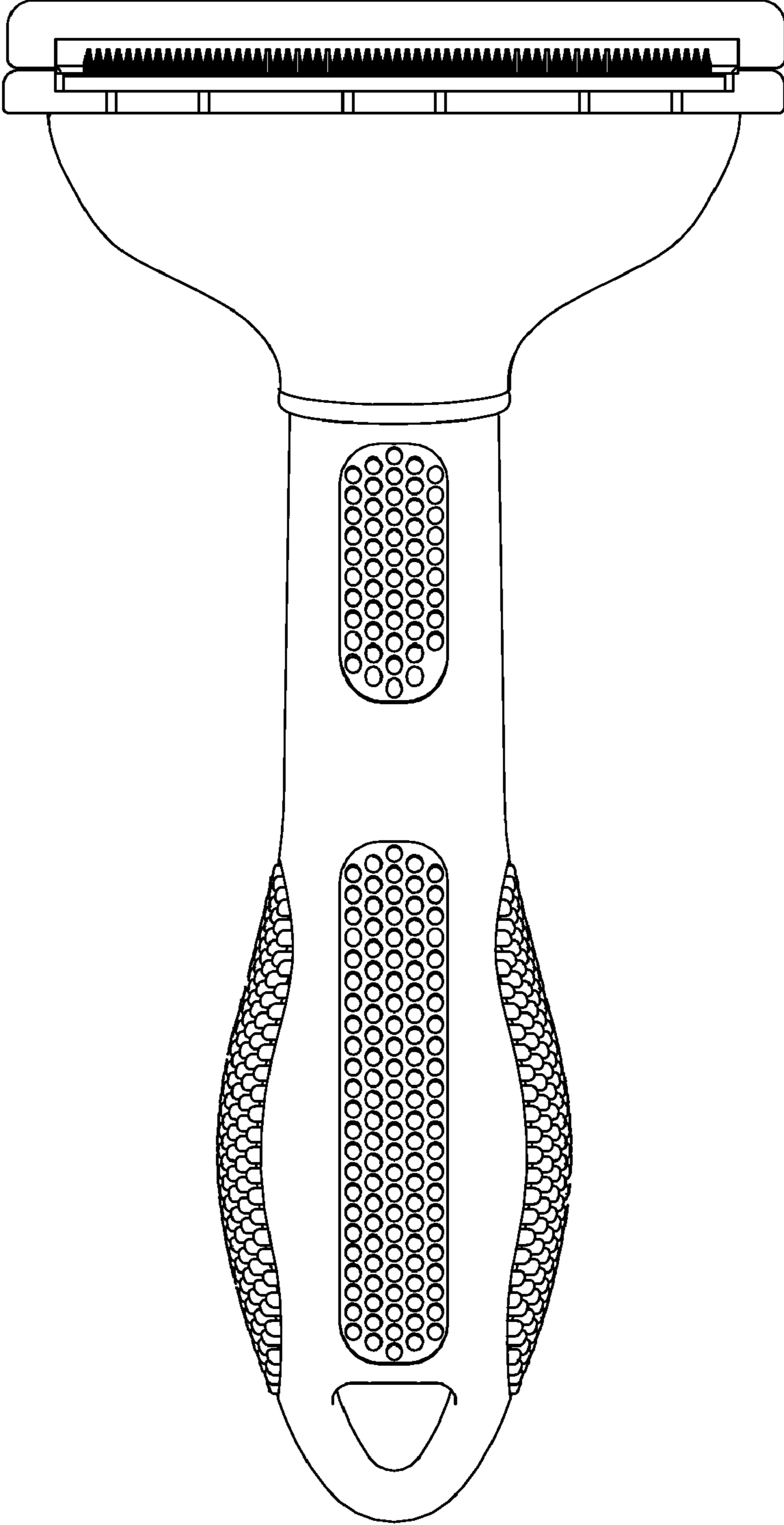

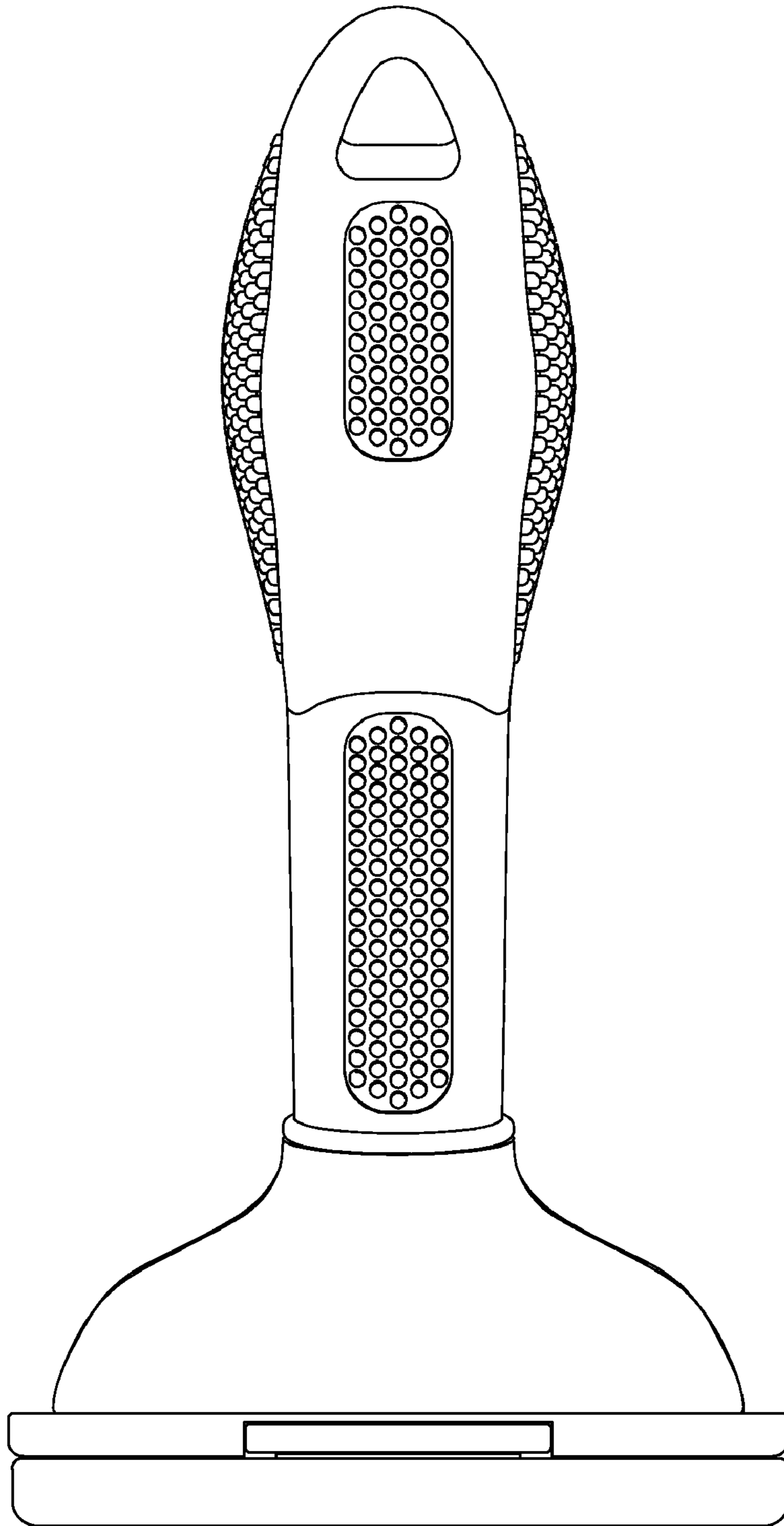

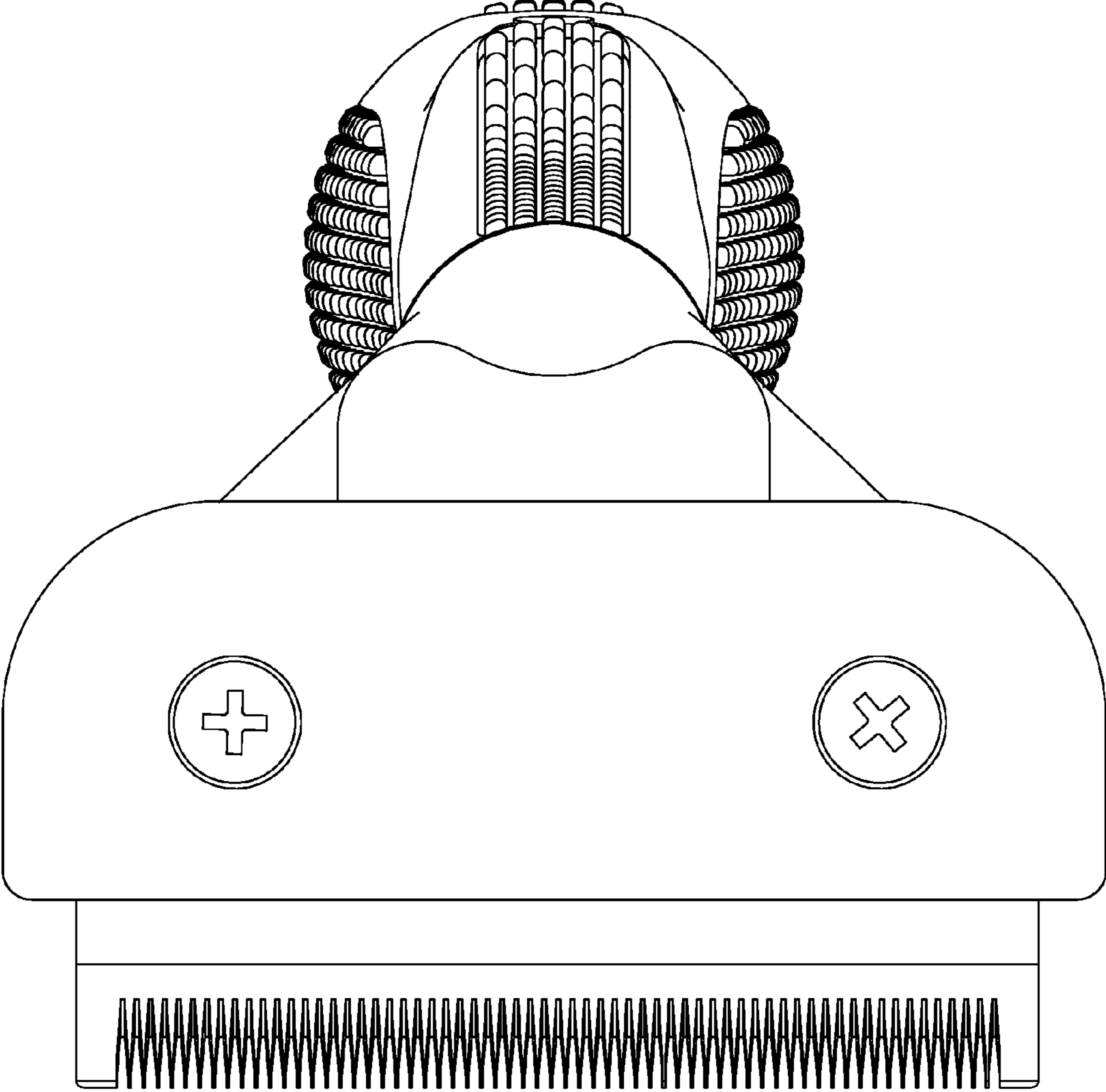

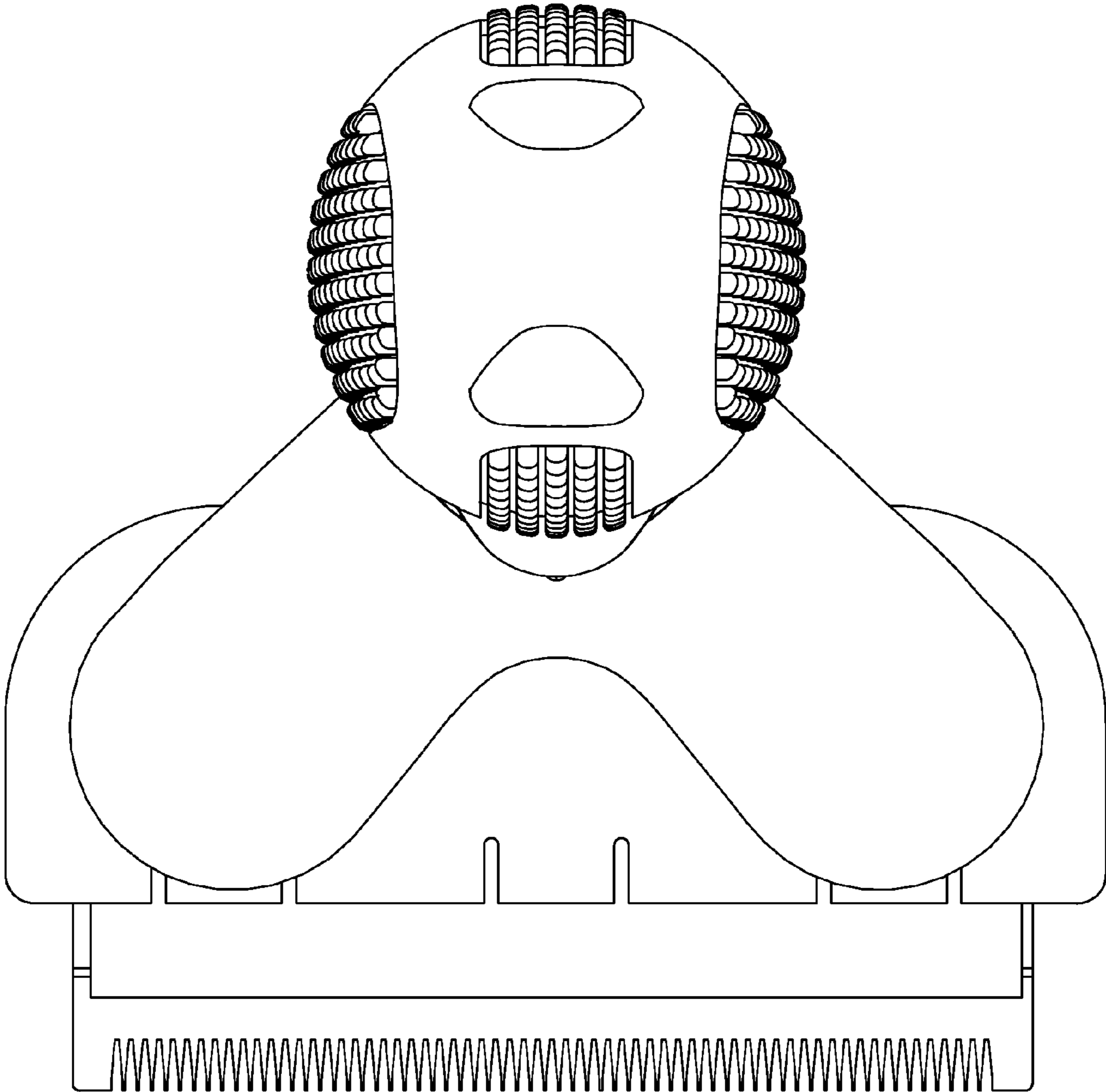

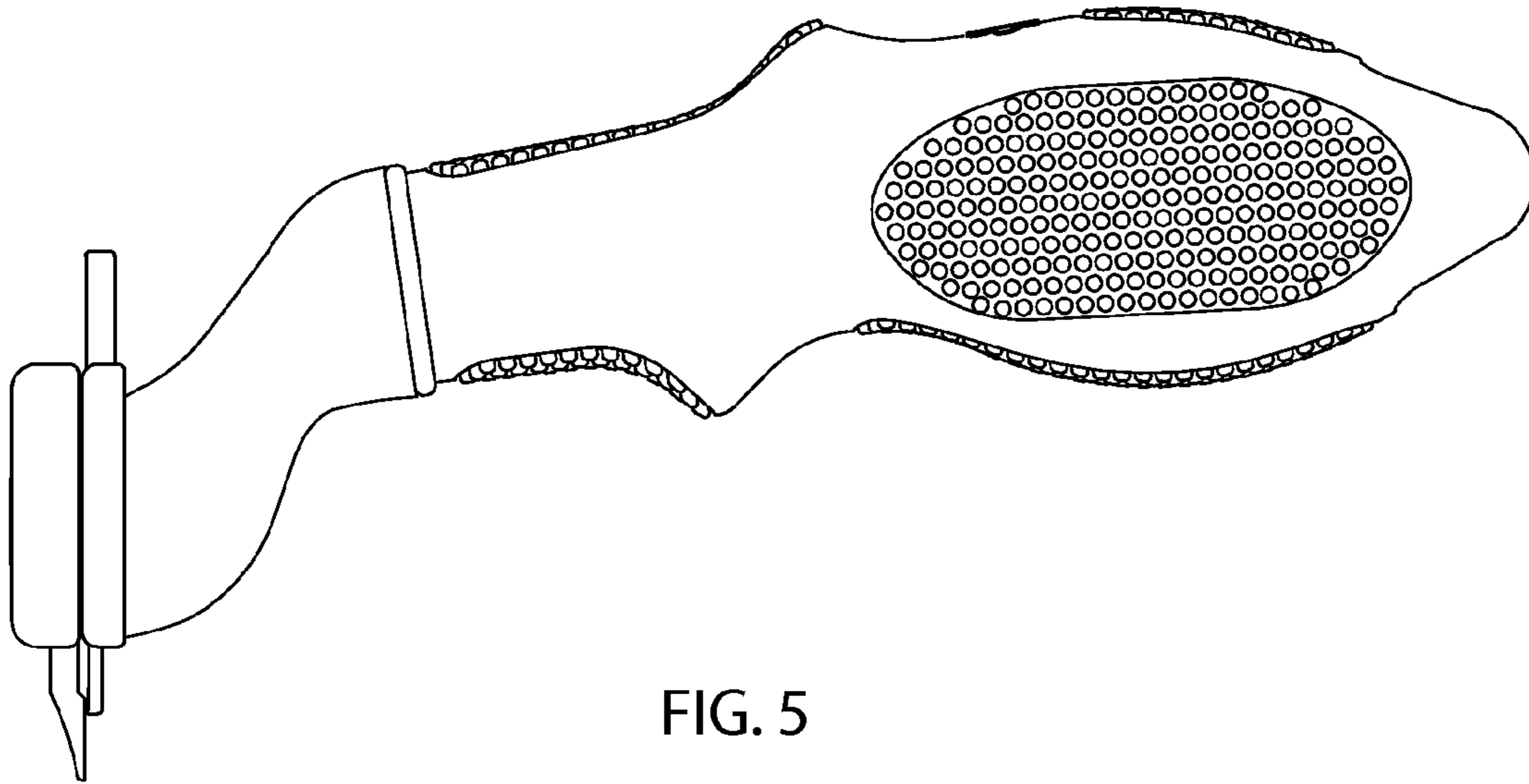

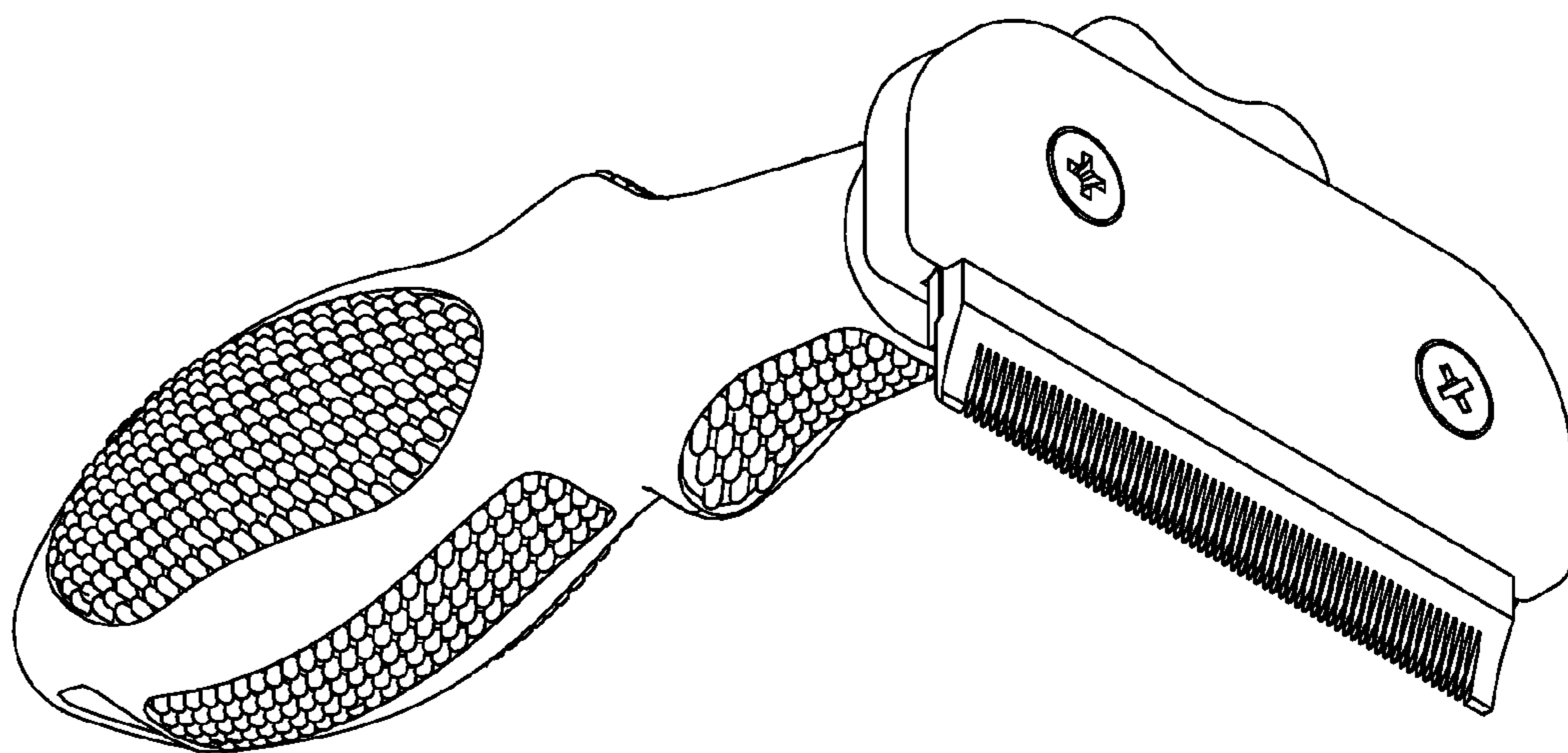
