FIG. 7 is a bottom view of the design of FIG. 1.

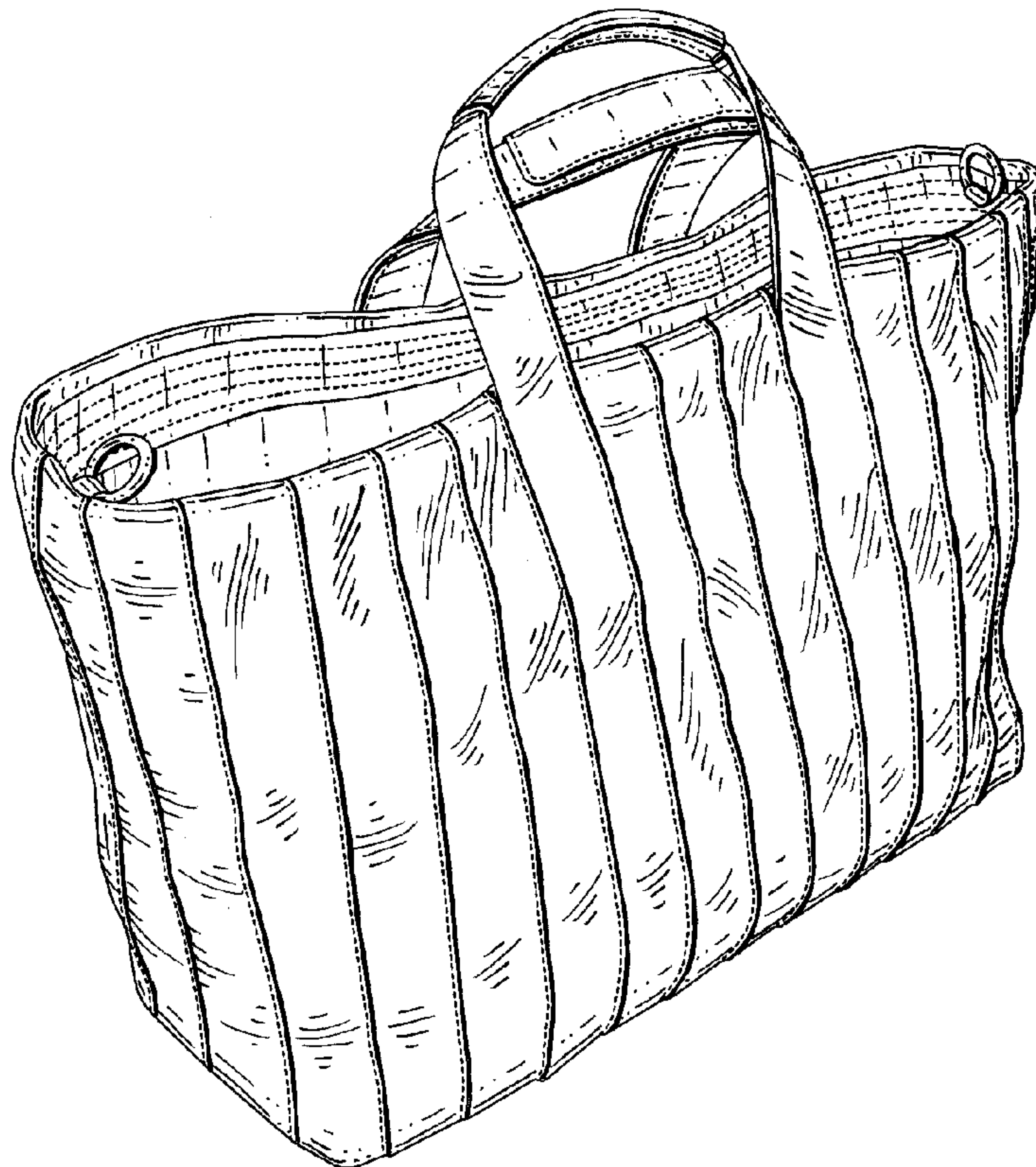
The dashed lines in the interior of the bag represent stitching and ARE part of the claimed design.

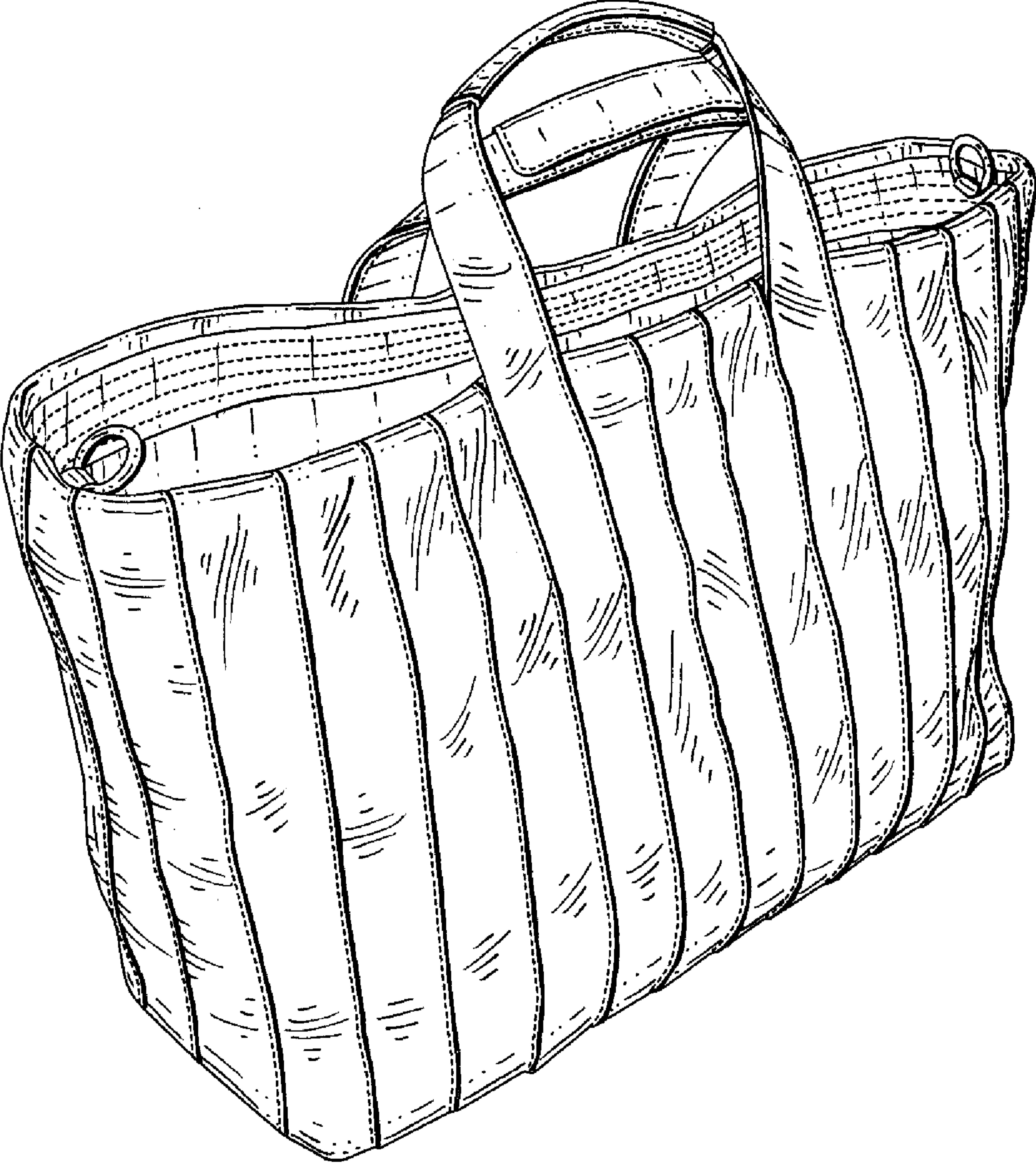

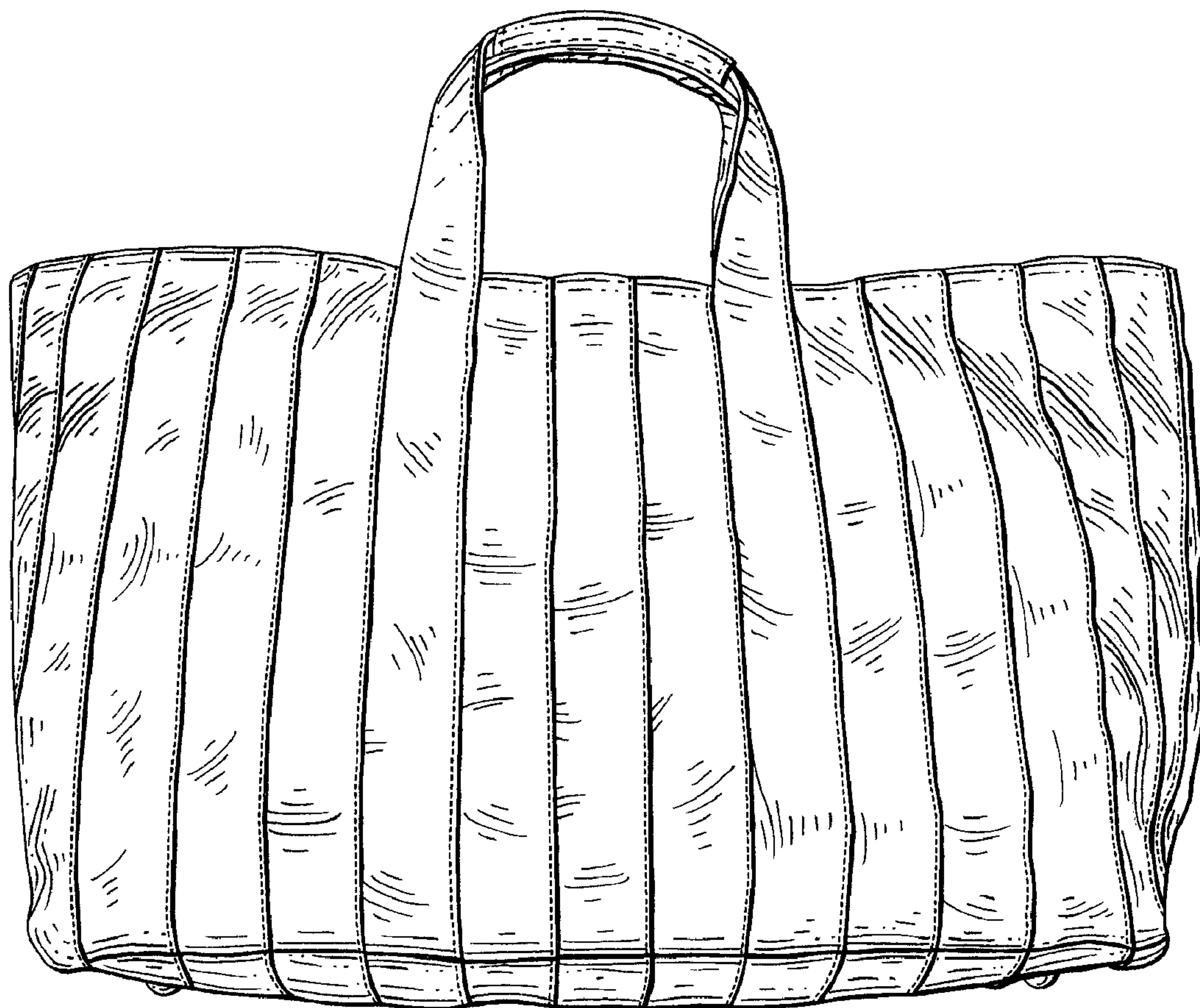

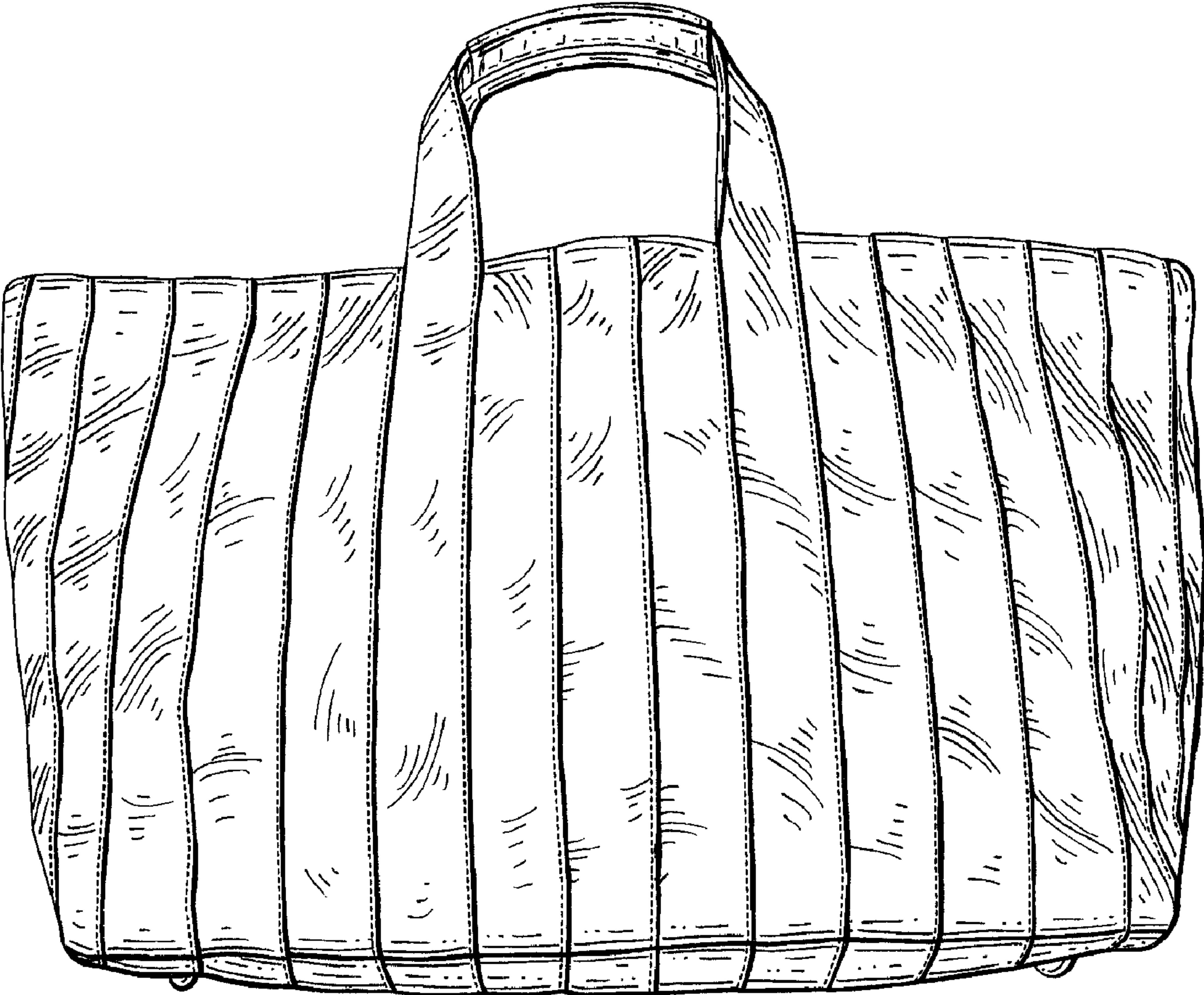

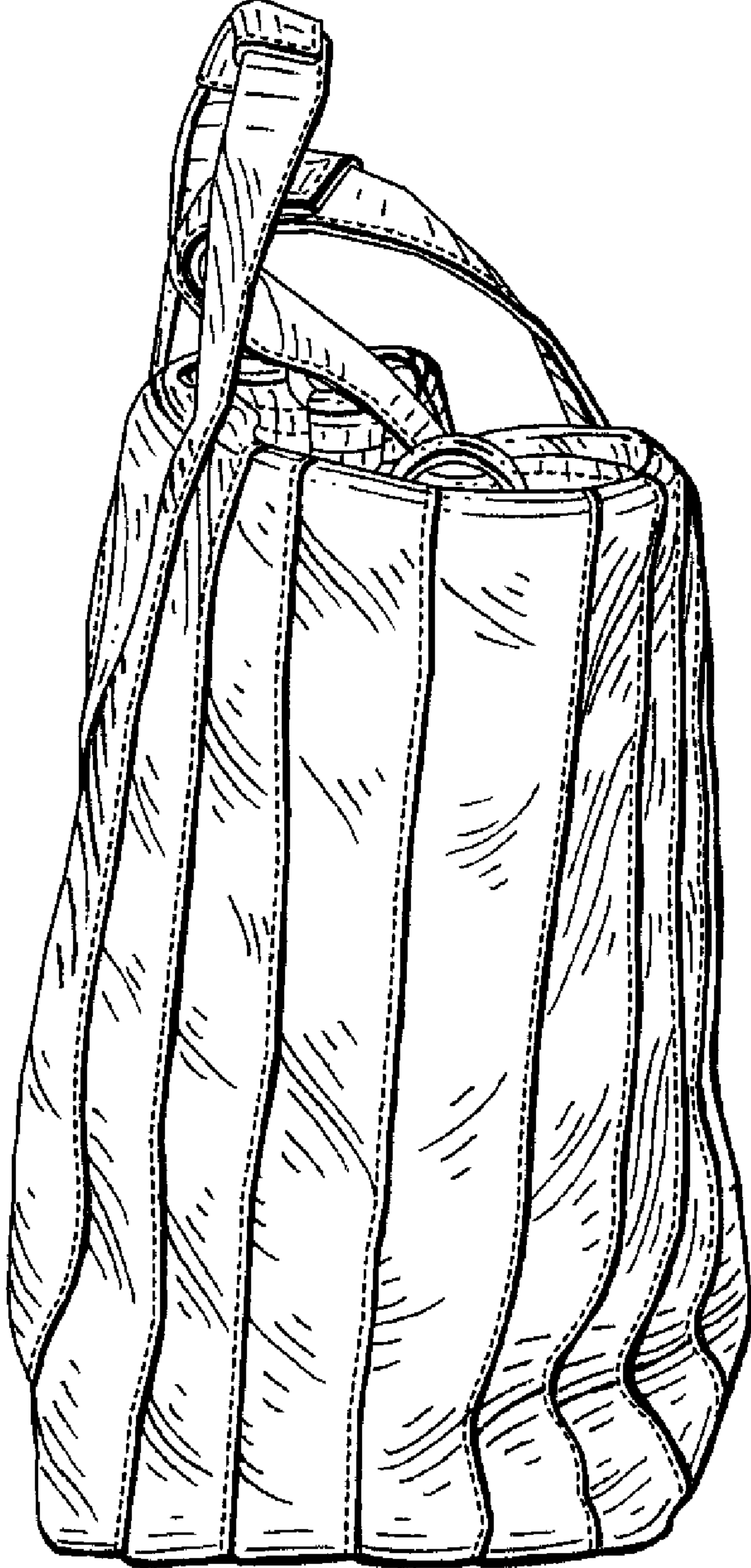

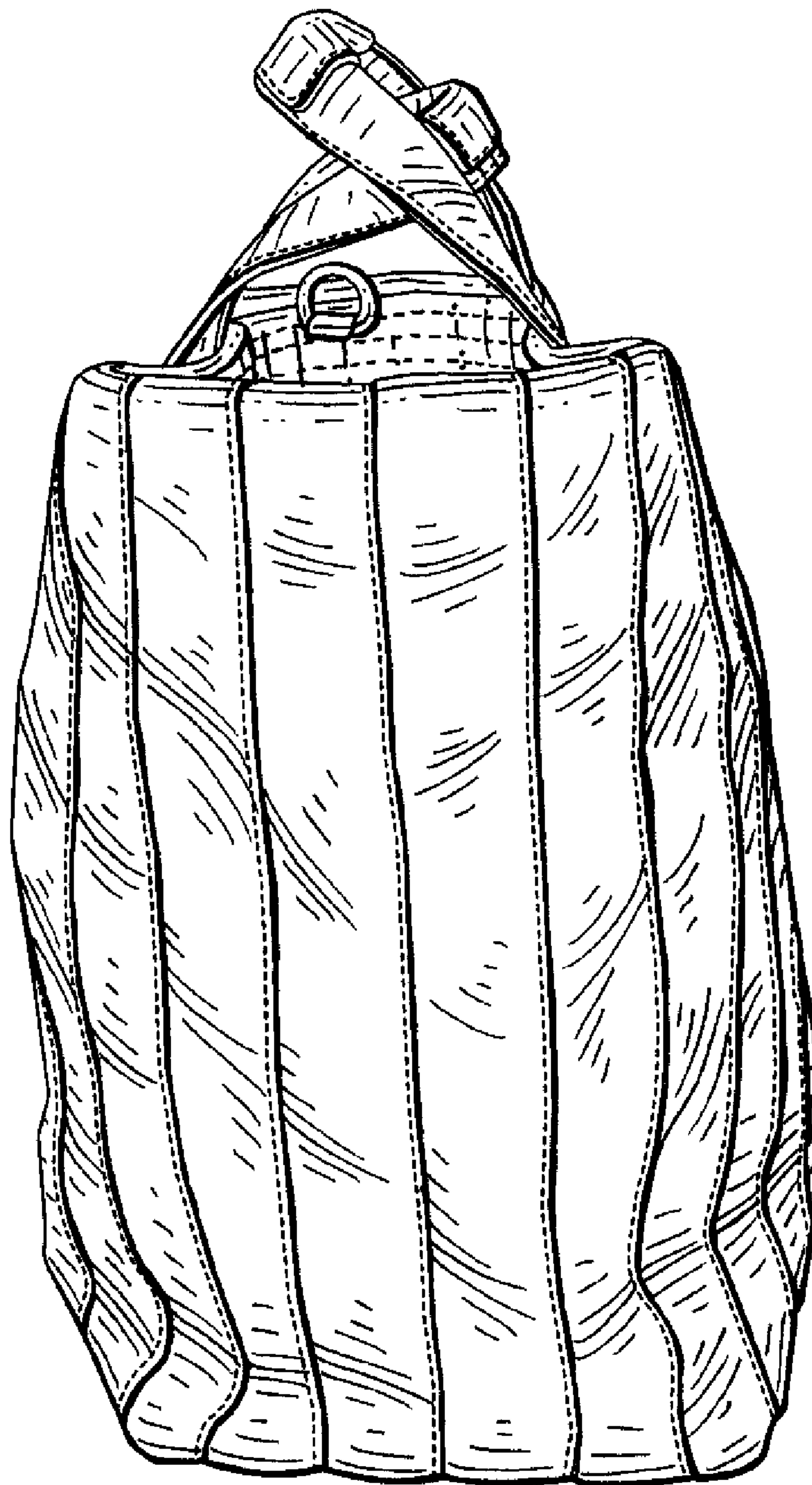

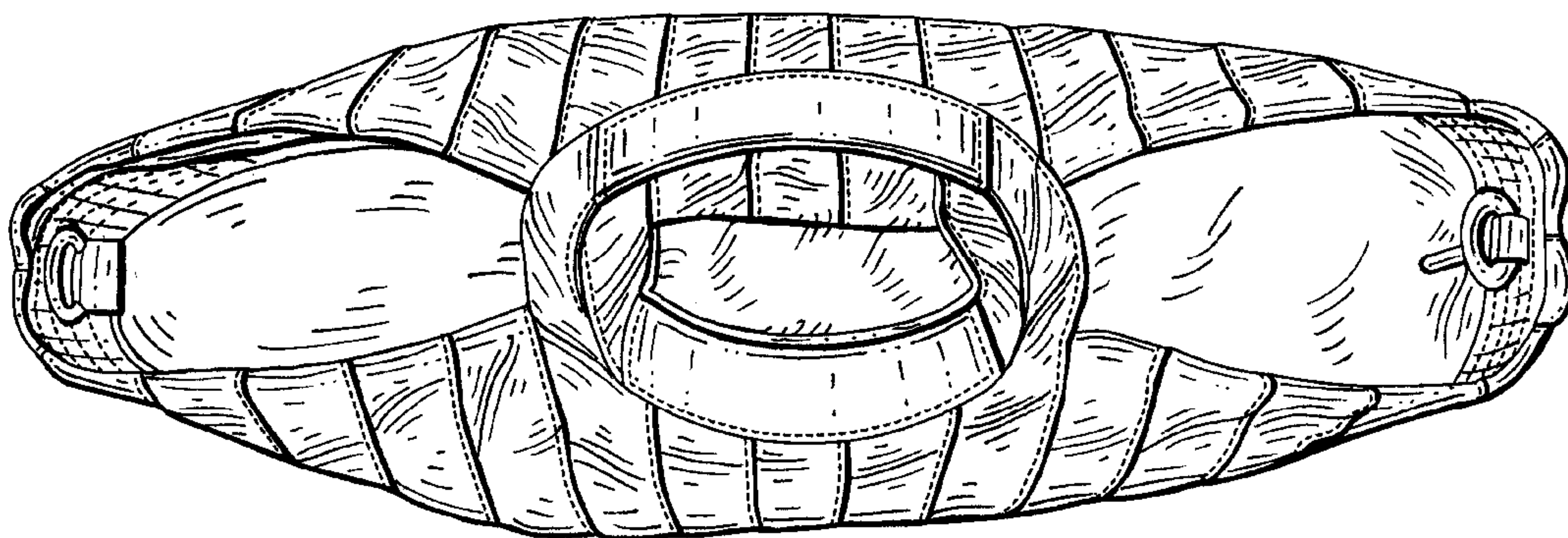

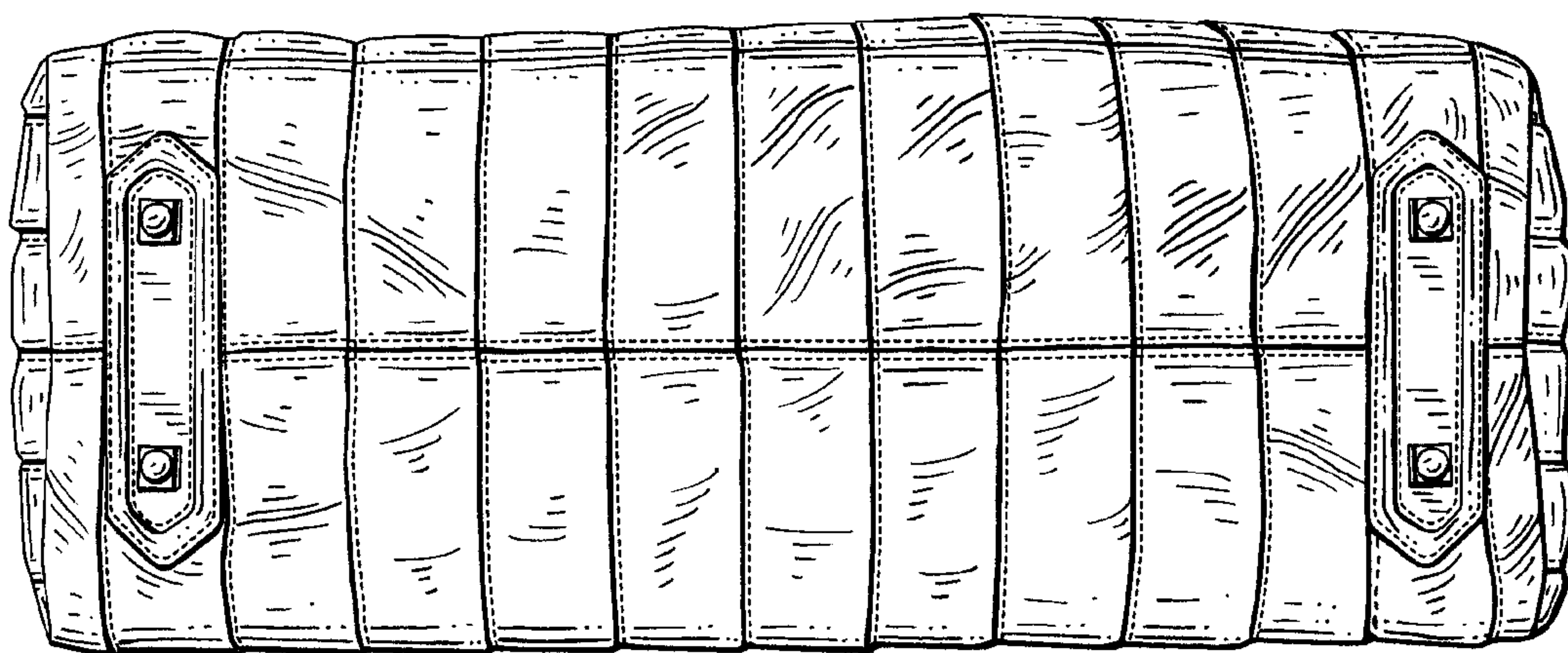
