(57) **CLAIM**

The ornamental design for a bag with surface fasteners for removable attachments, as shown and described.

DESCRIPTION

FIG. 1 is a front side view of a bag with surface fasteners for removable attachments showing my design without the attachments;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a front side view of the surface pattern for a bag with a number of removable attachments connected; and,

FIG. 4 is a front perspective view thereof.

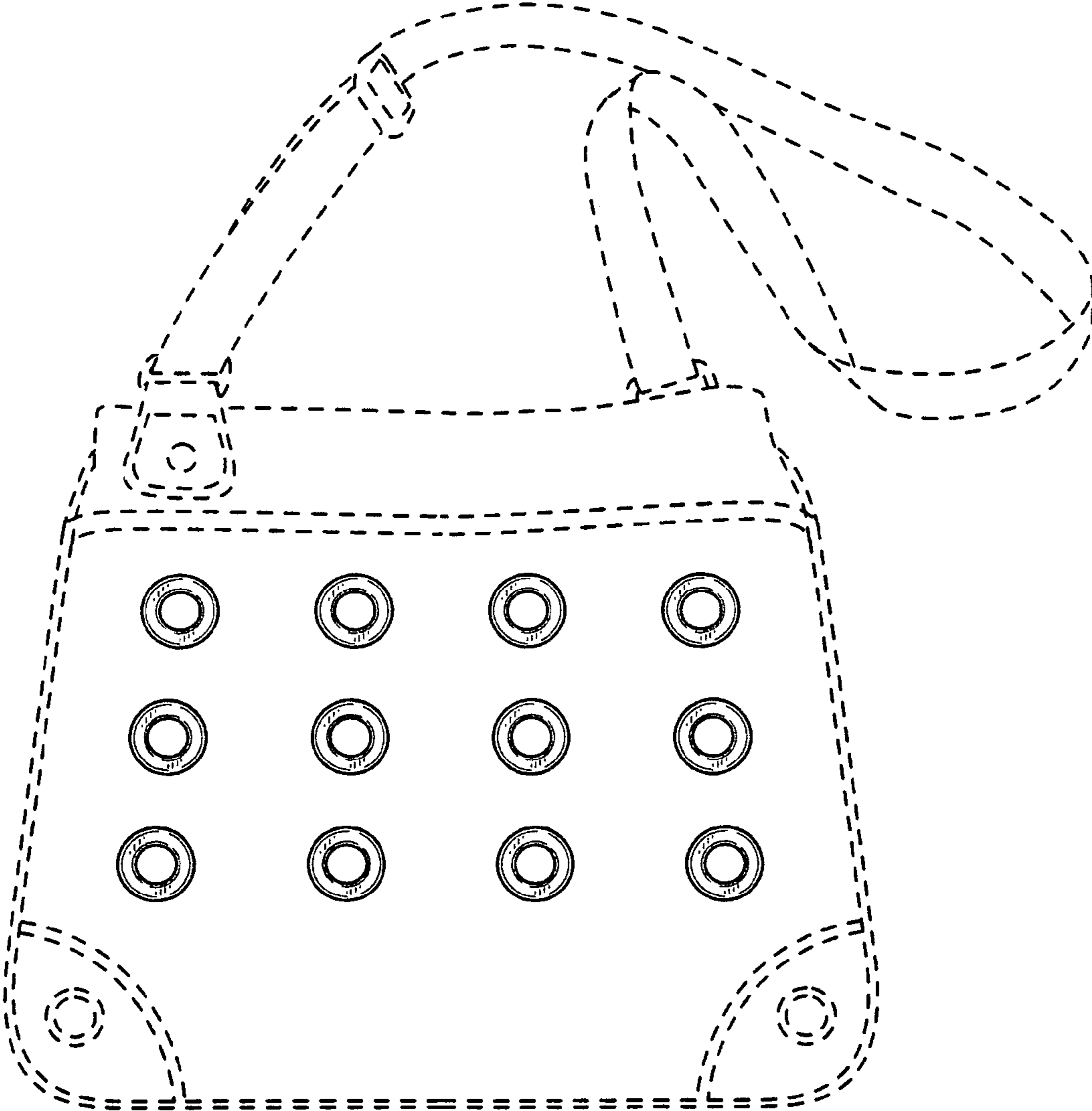

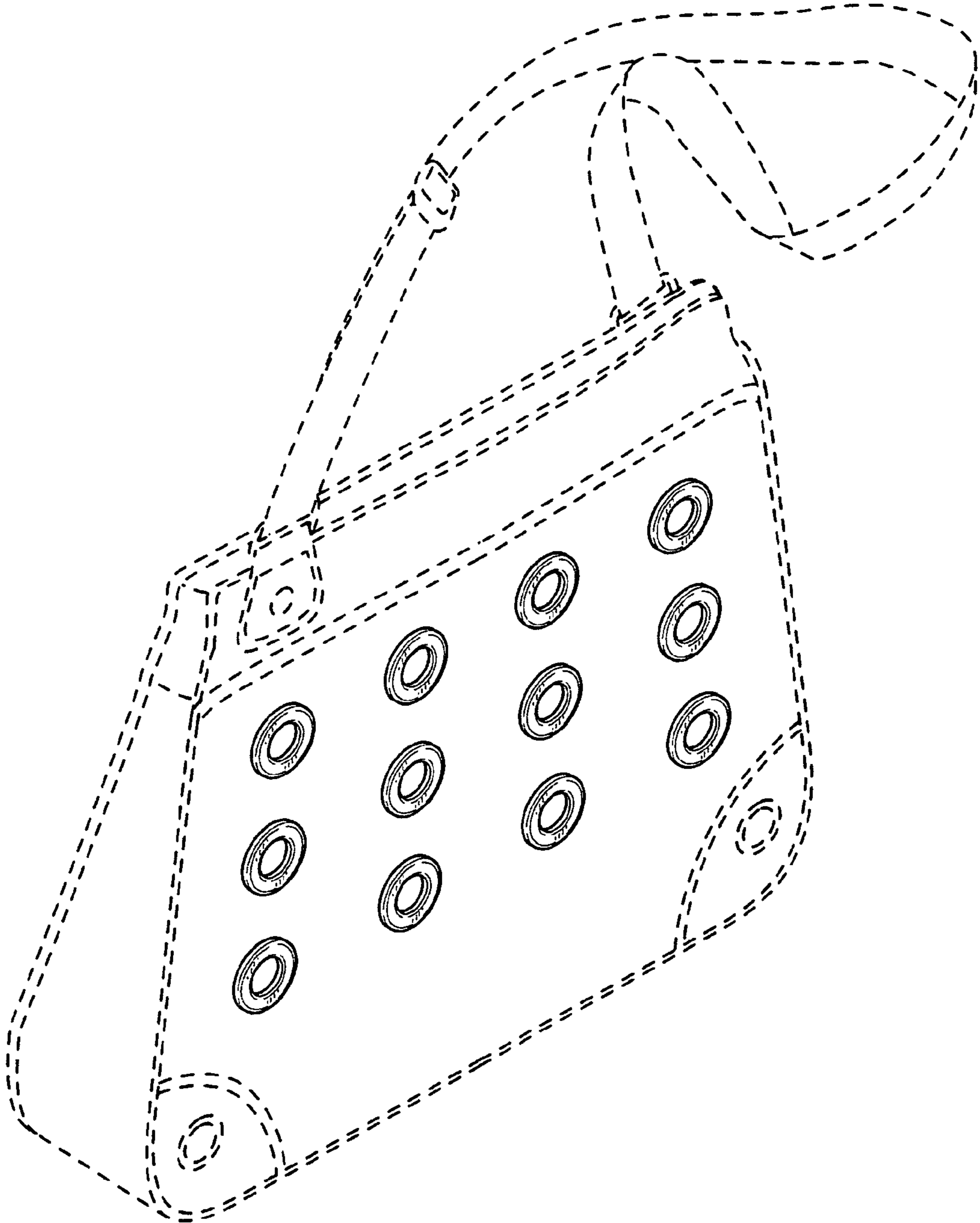

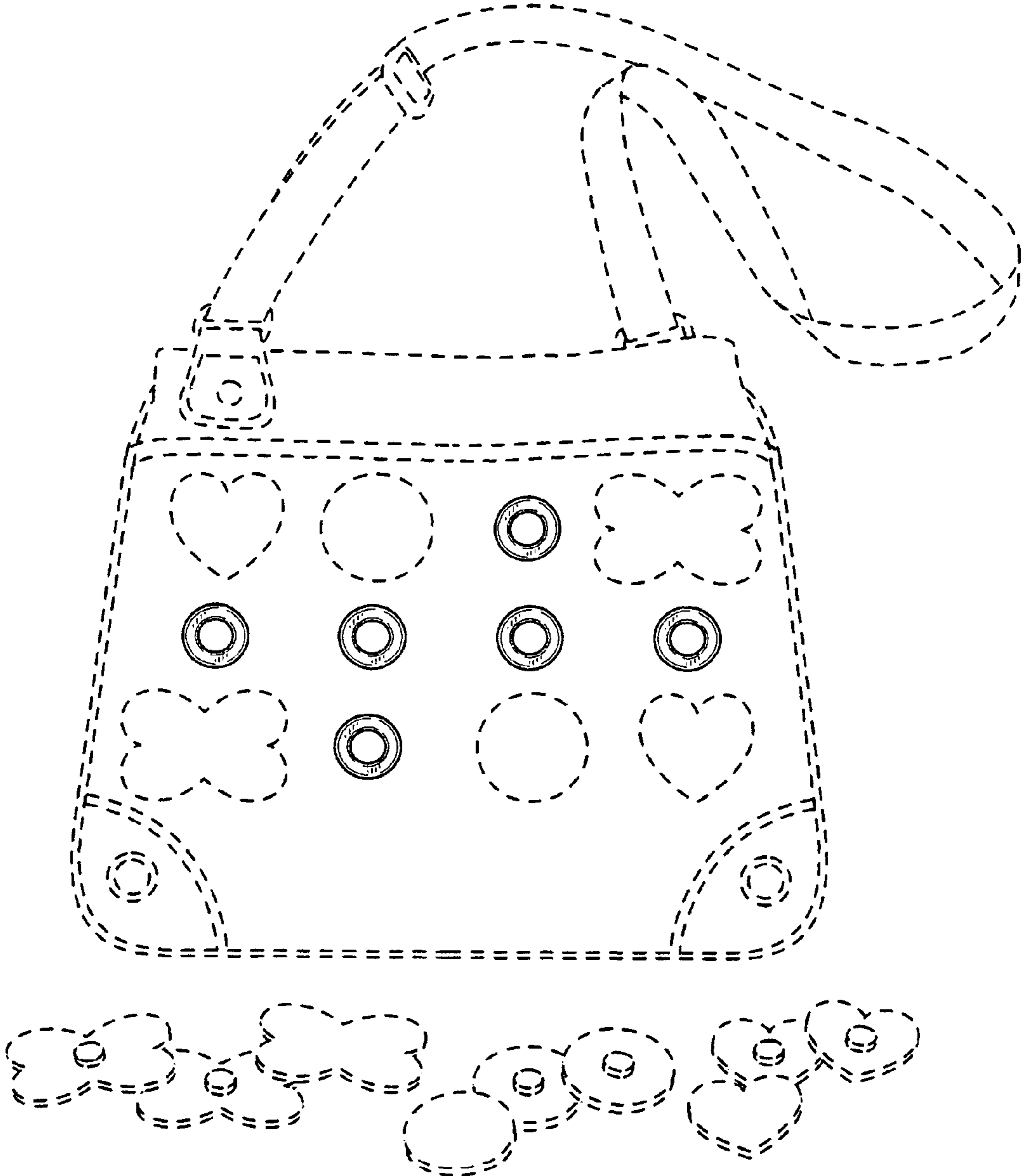

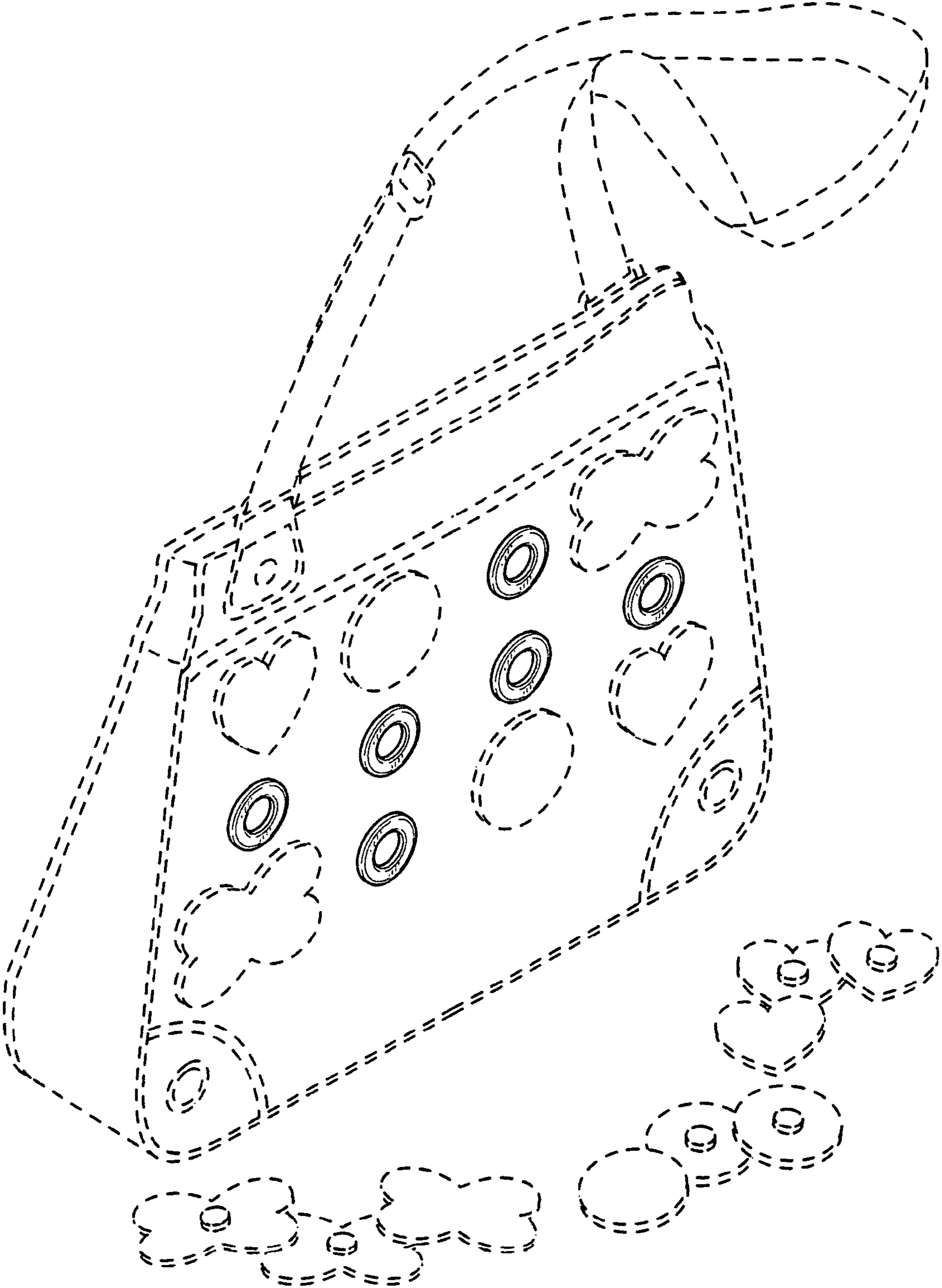
