smaller volume; and,

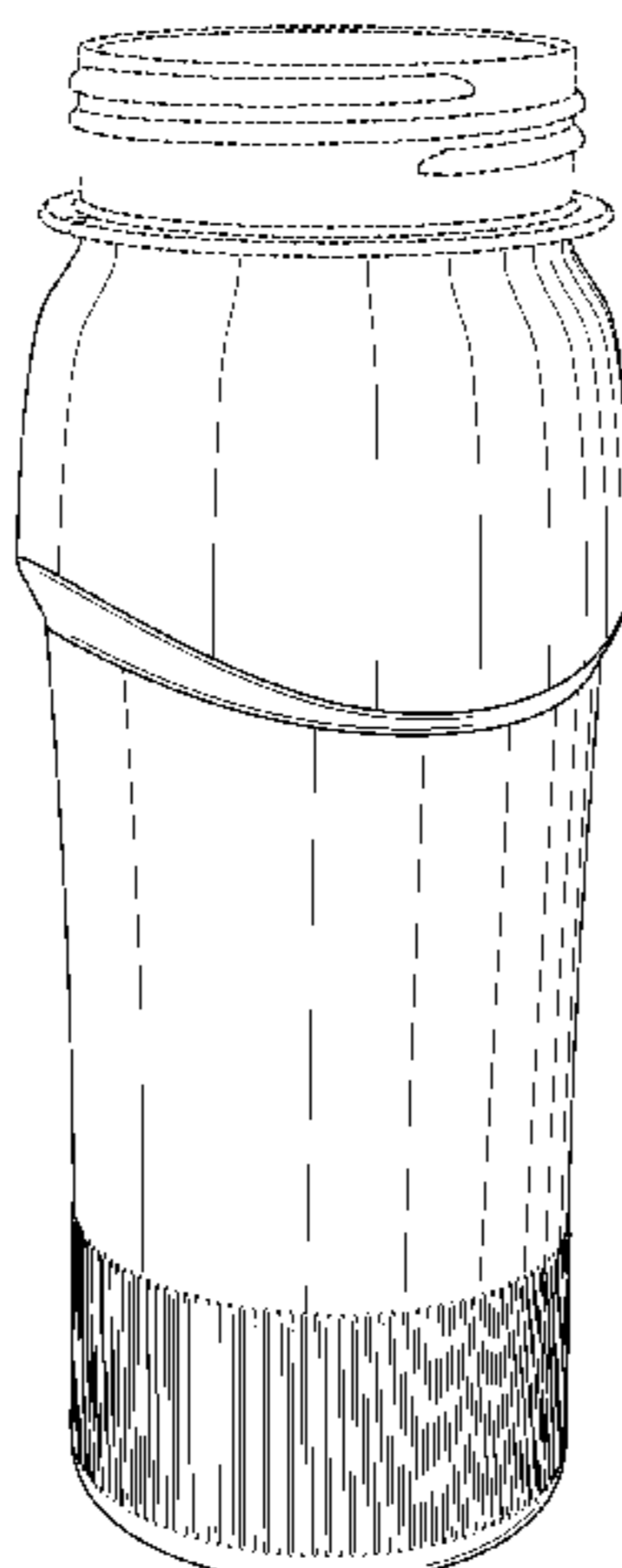
FIG. 7 is a top front left side perspective view of a beverage

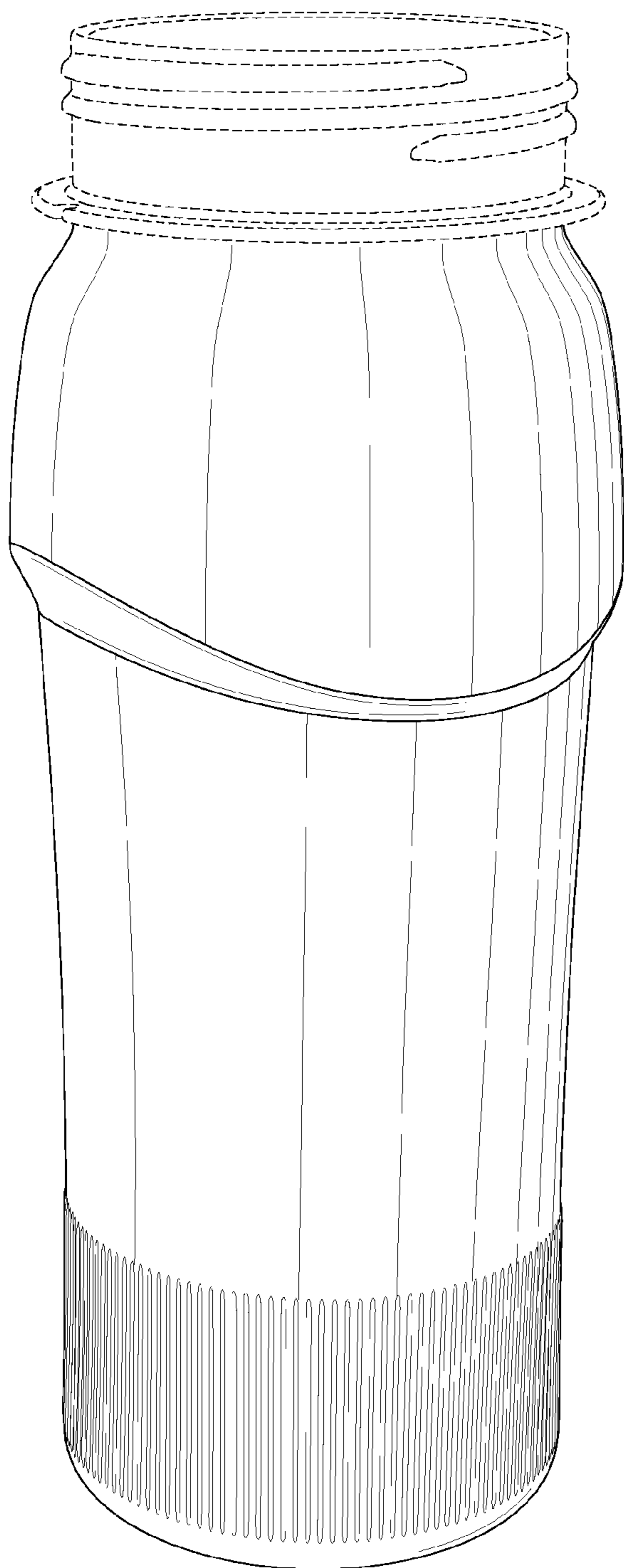

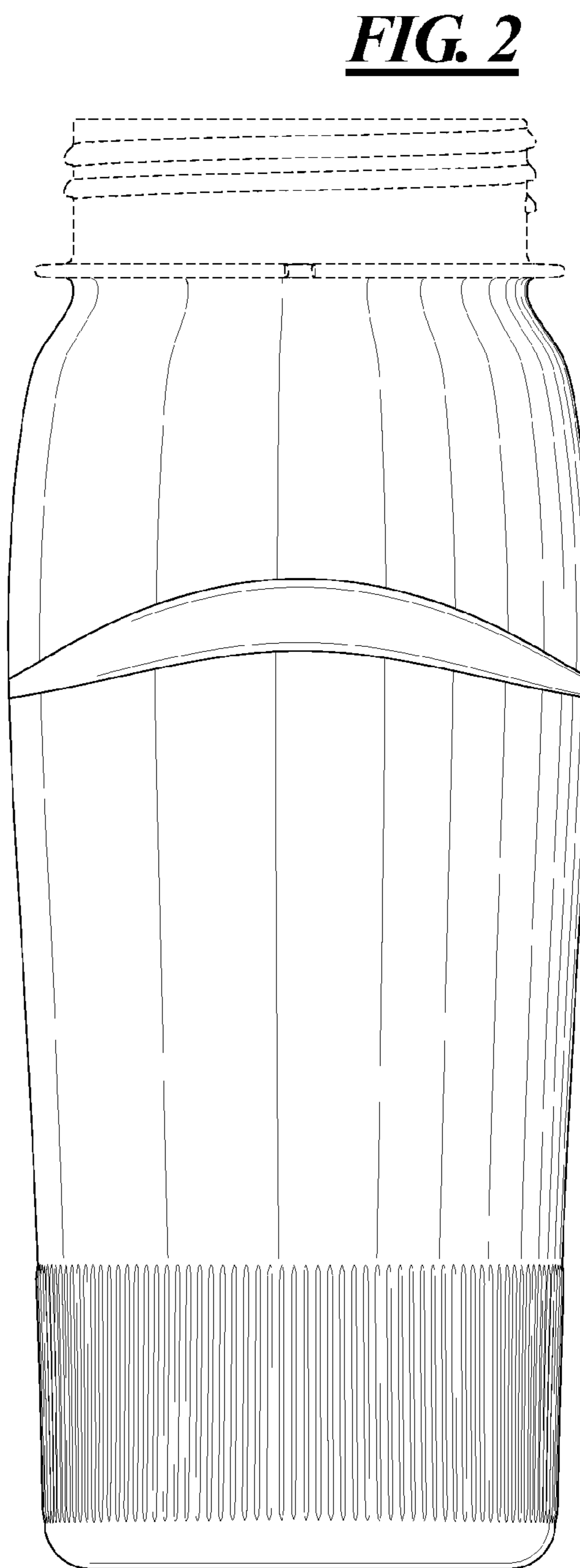

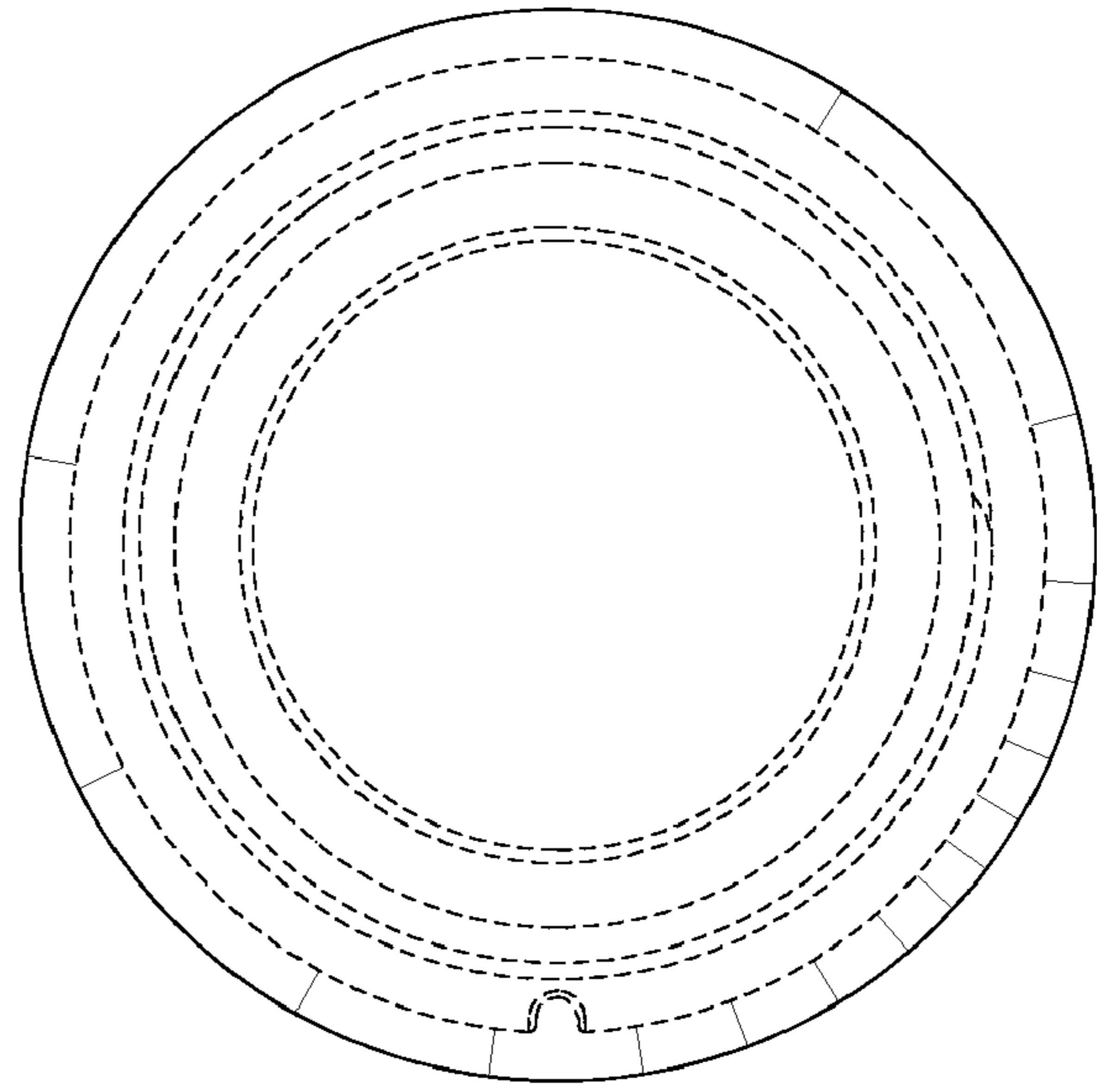
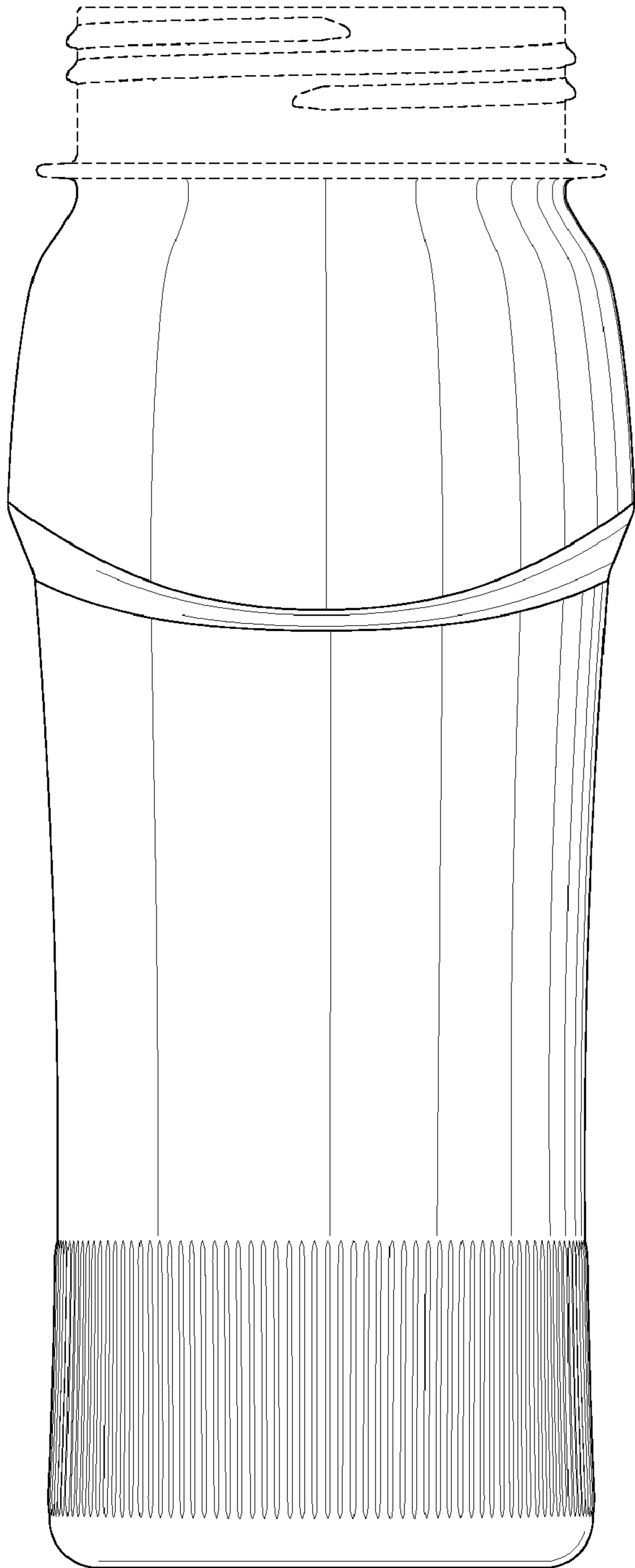

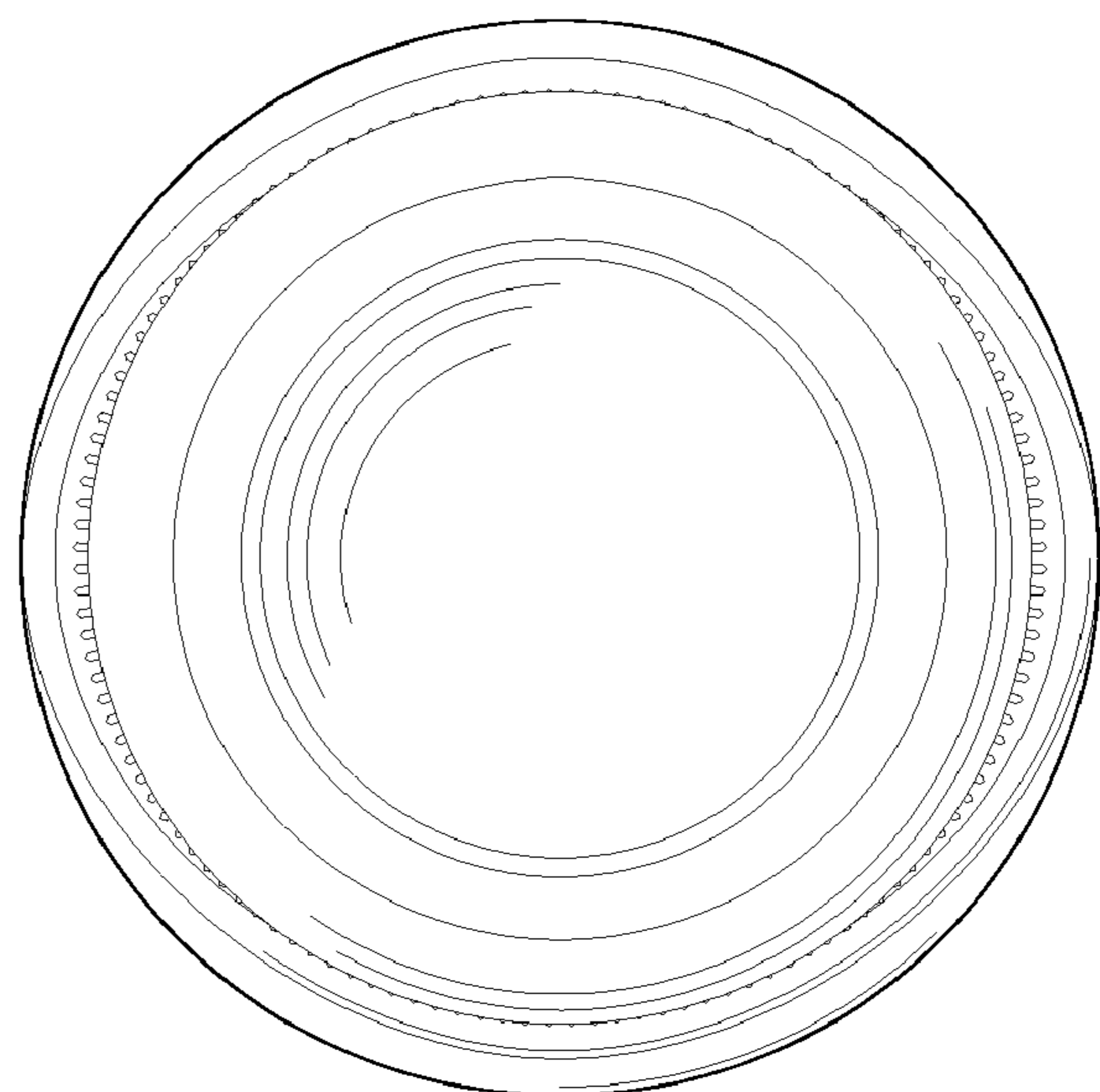

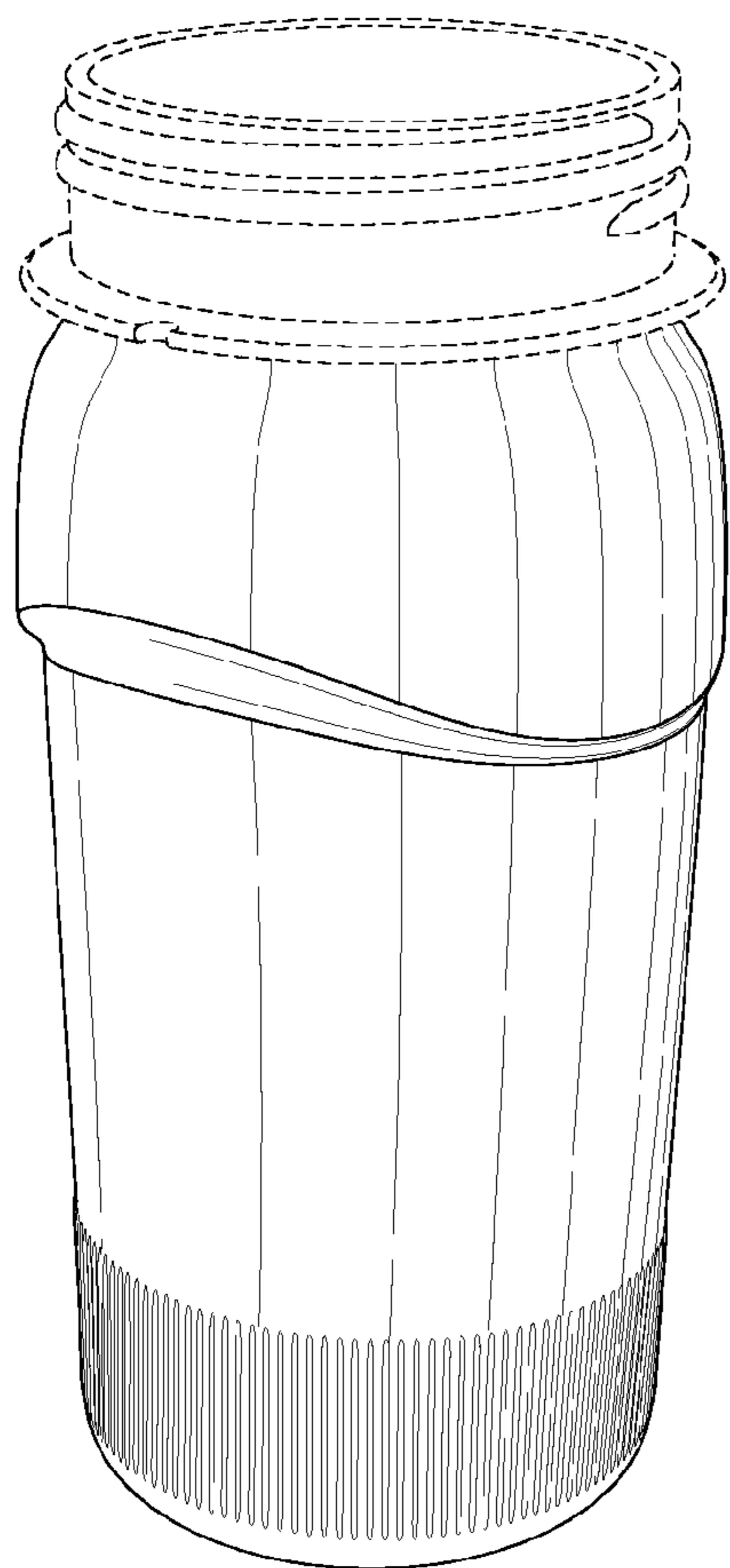

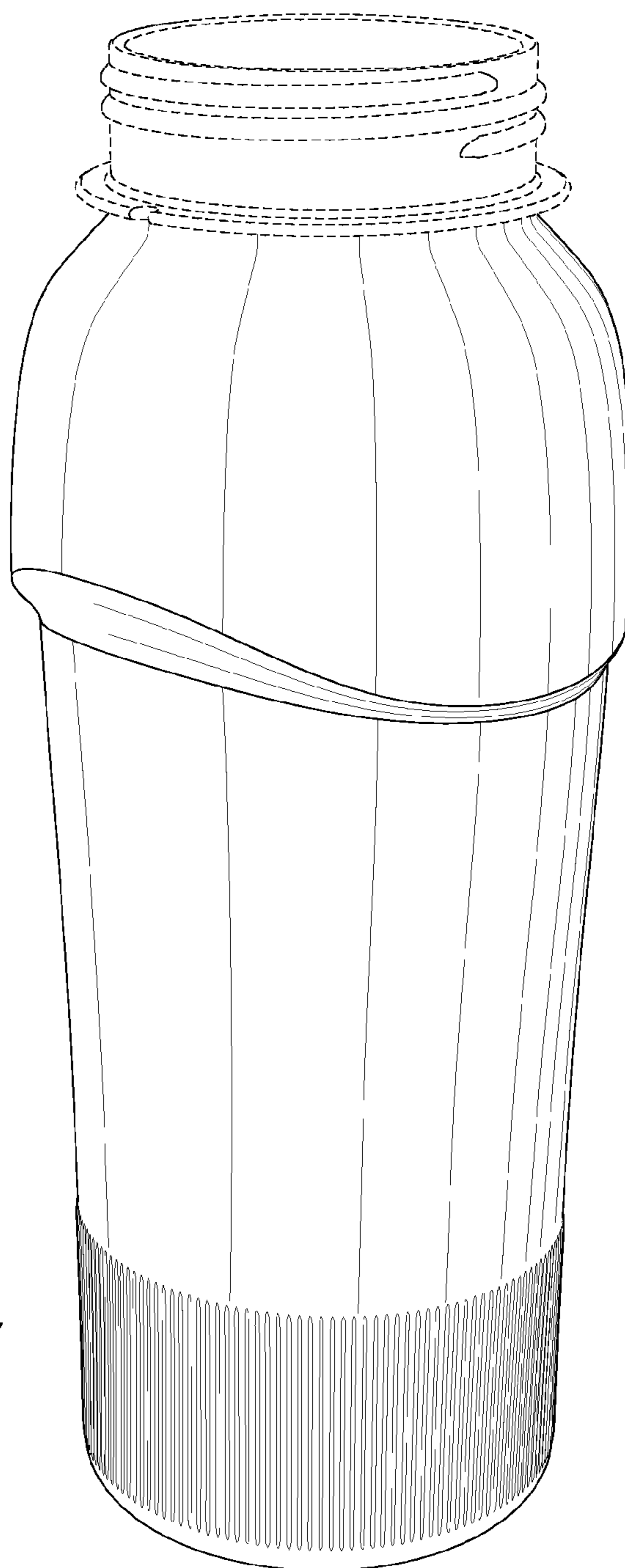
