(57) **CLAIM**

The ornamental design for the food server tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the food server tray of the present invention;

FIG. 2 is an elevational view of a first side of the food server tray as shown in FIG. 1;

FIG. 3 is an elevational view of a second side of the food server tray as shown in FIG. 1;

FIG. 4 is a rear elevational view of the food server tray as shown in FIG. 1;

FIG. 5 is a front elevational view of the food server tray as shown in FIG. 1;

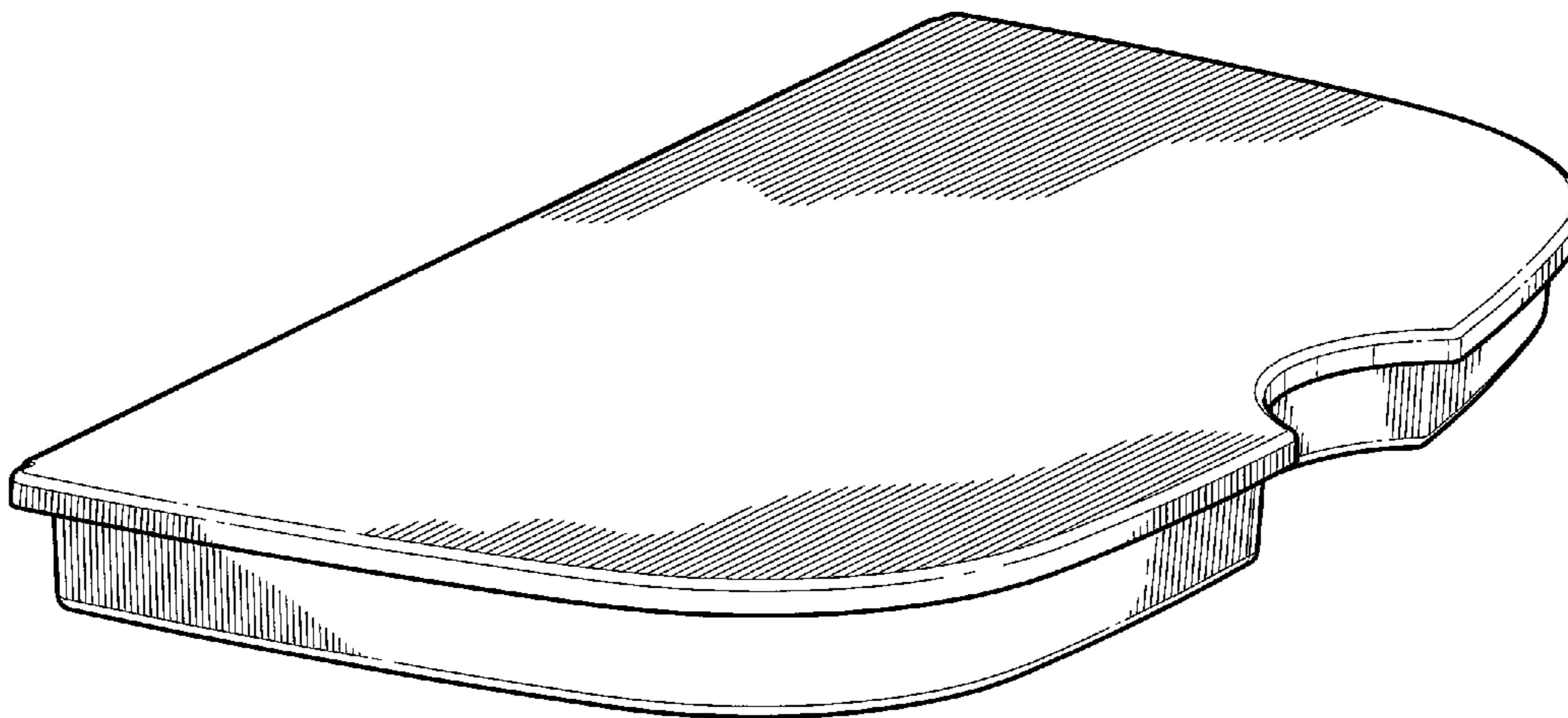
FIG. 6 is a top plan view of the food server tray as shown in FIG. 1;

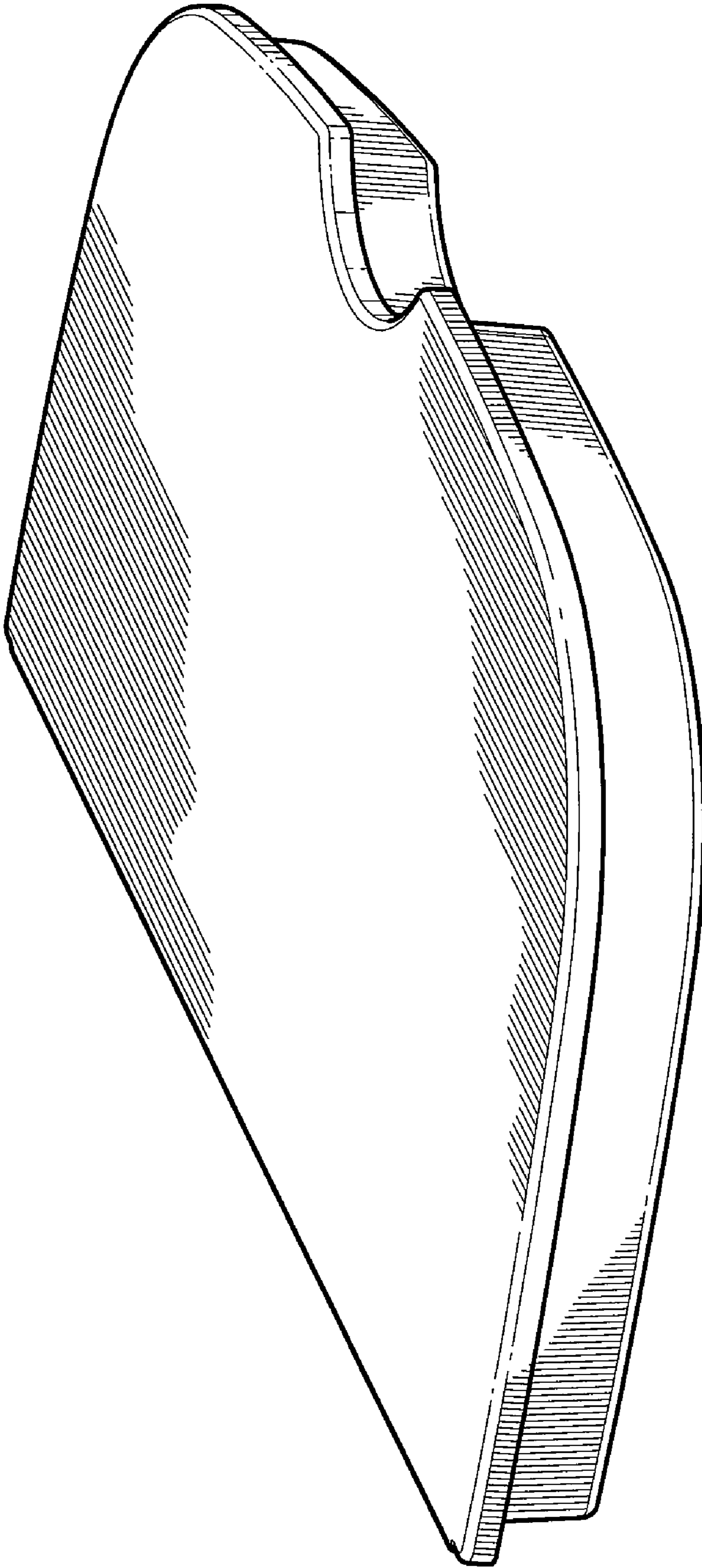

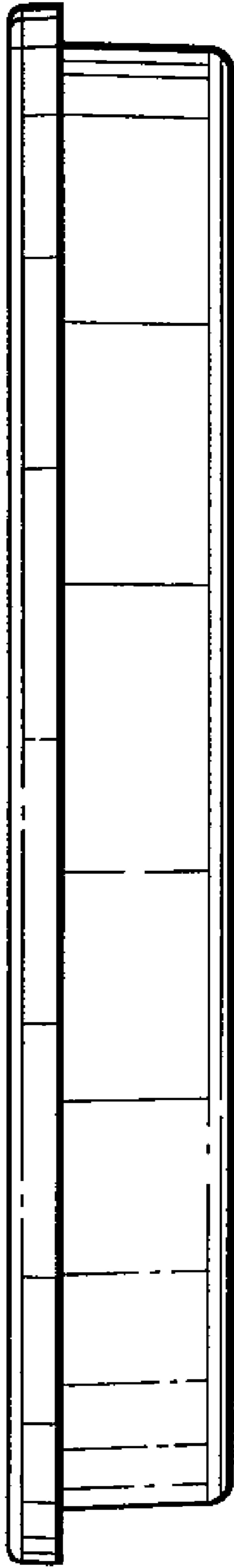

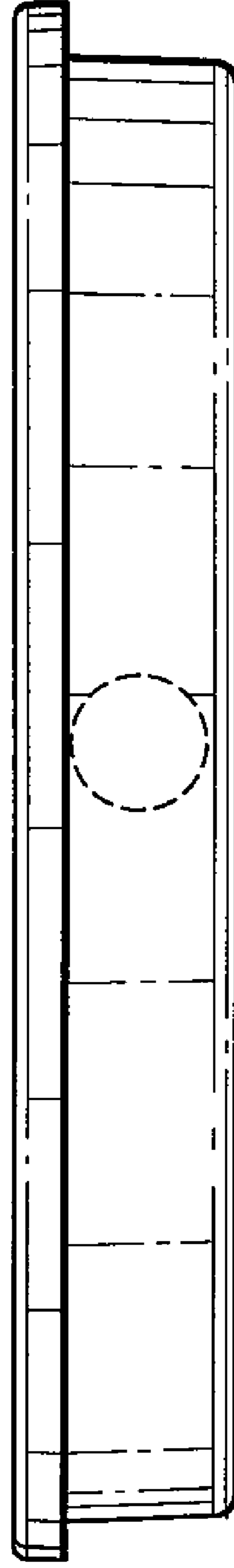

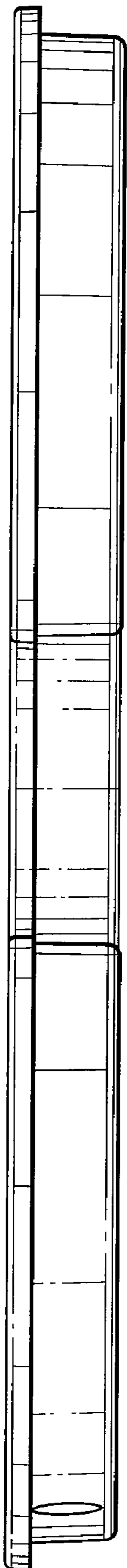

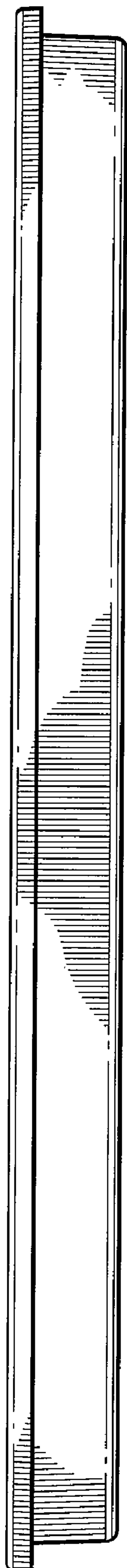

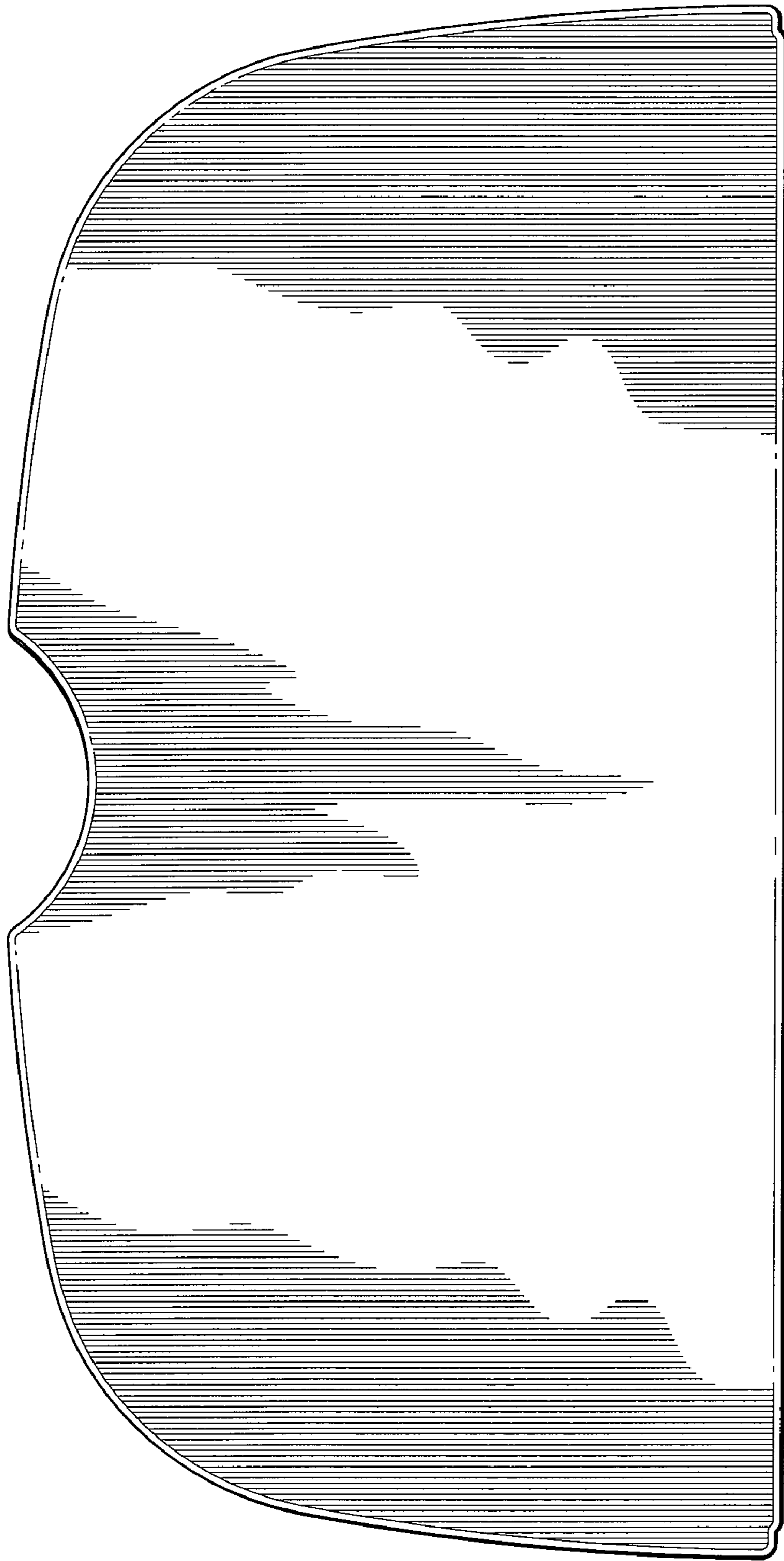

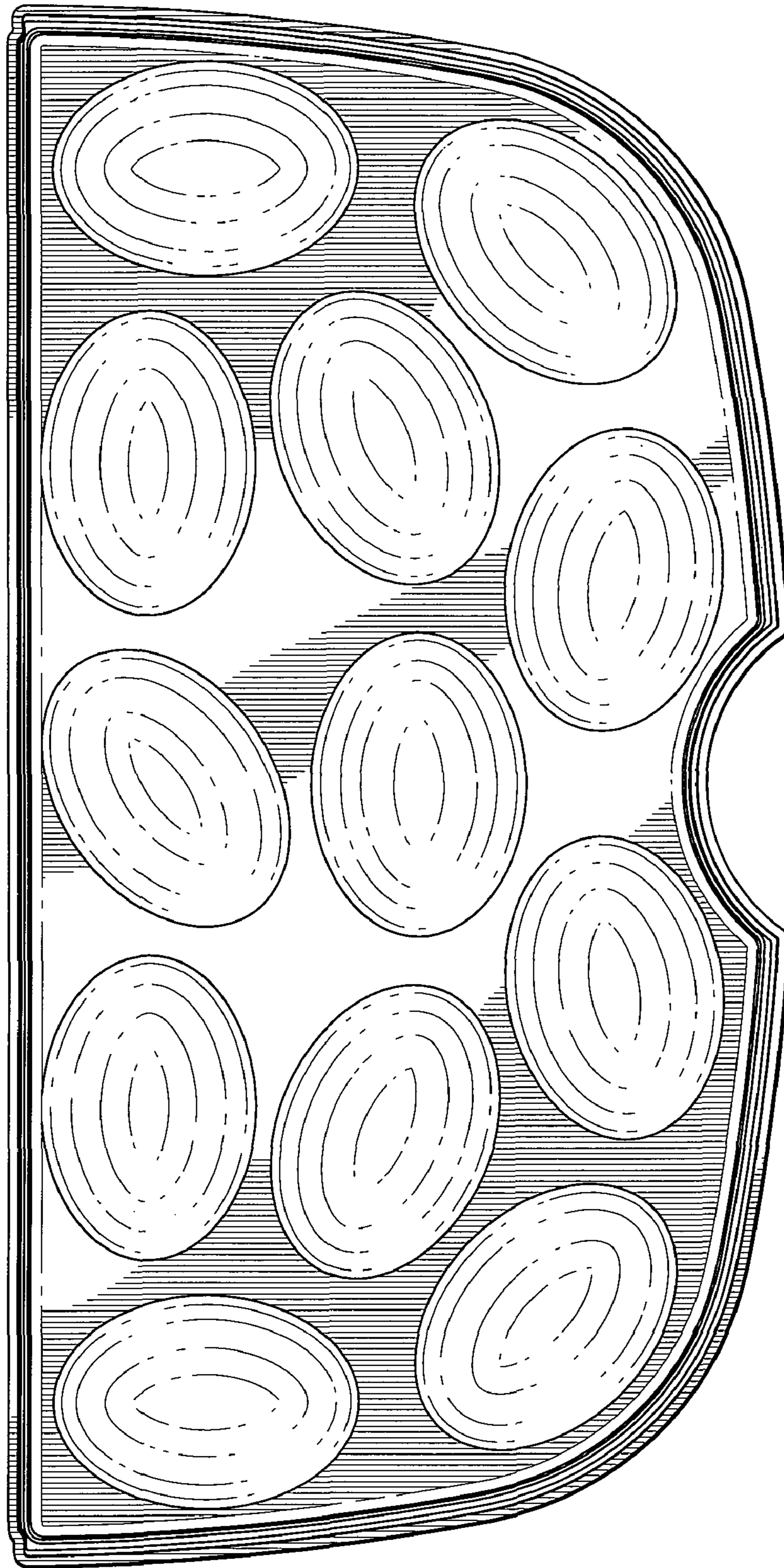

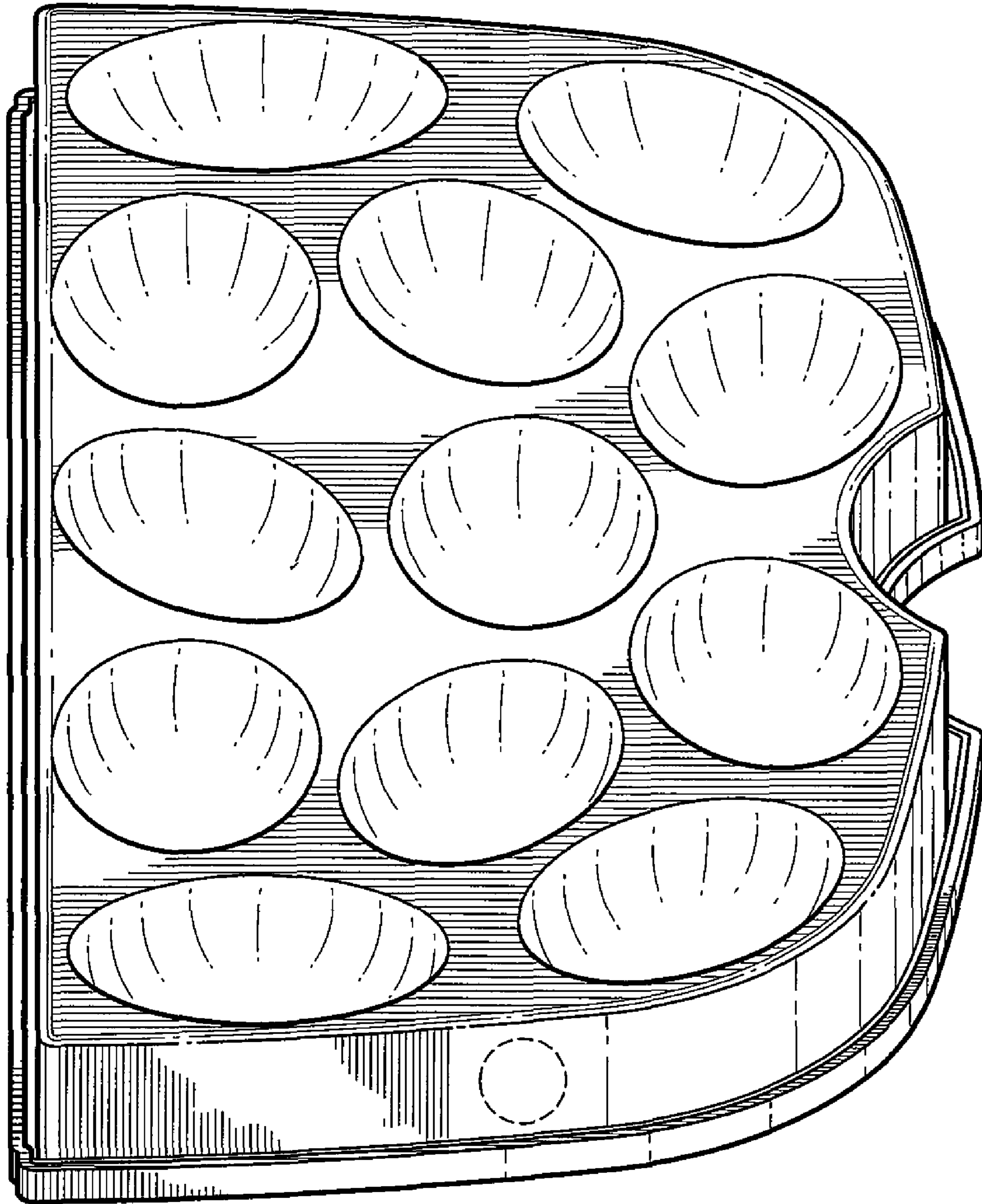
