**DESCRIPTION**

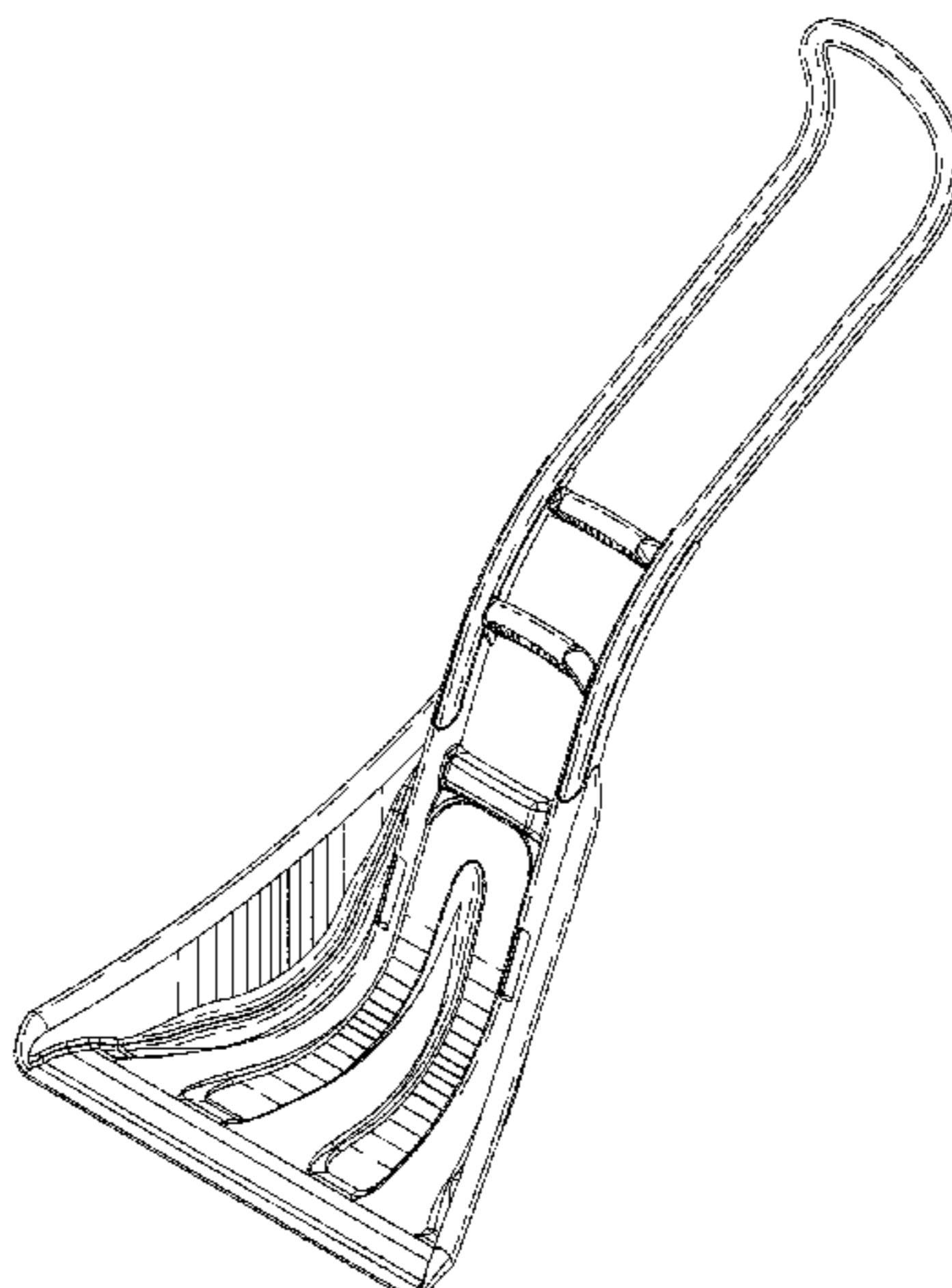
FIG. 1 is perspective view of a shovel showing our new design;

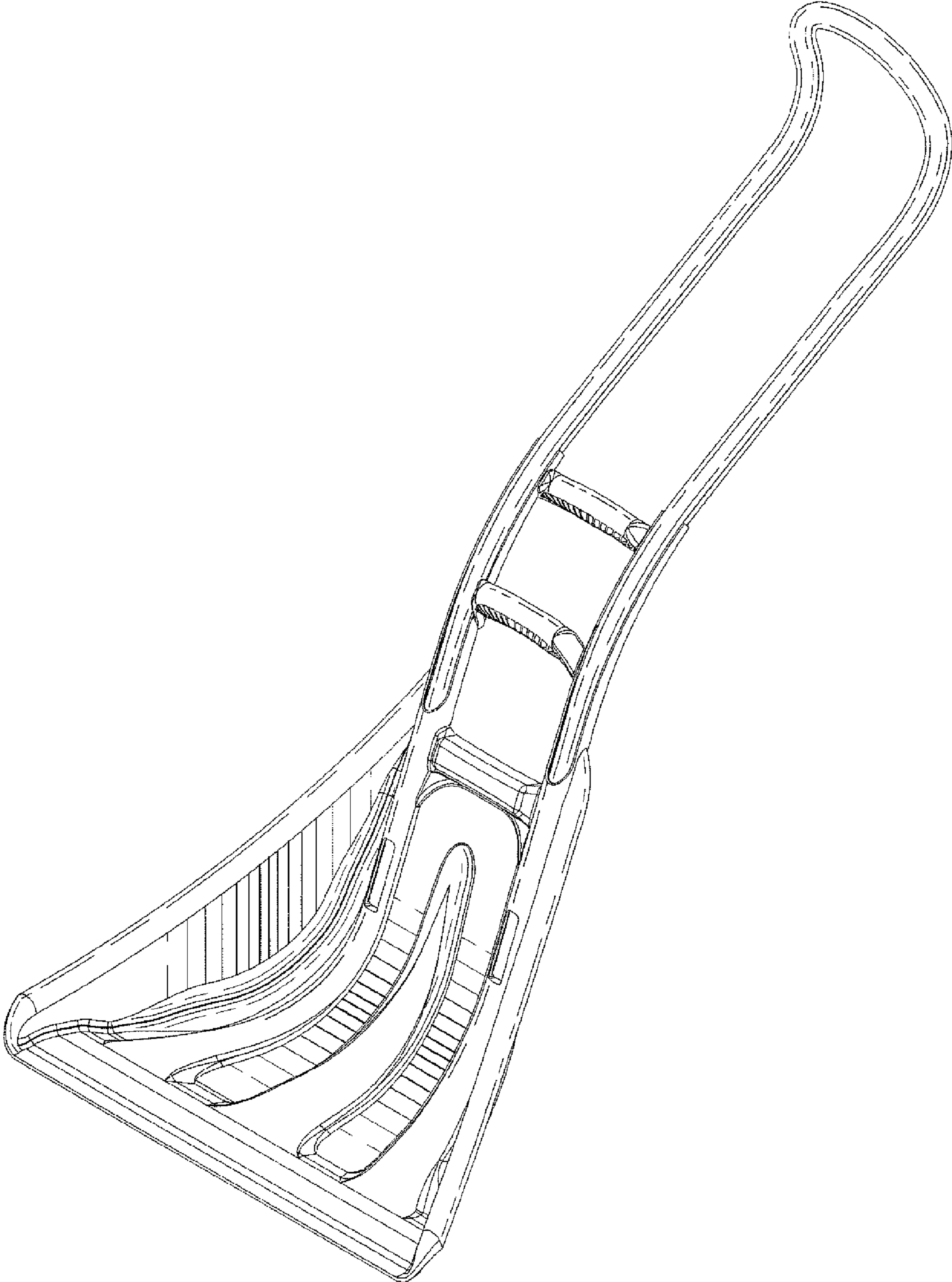

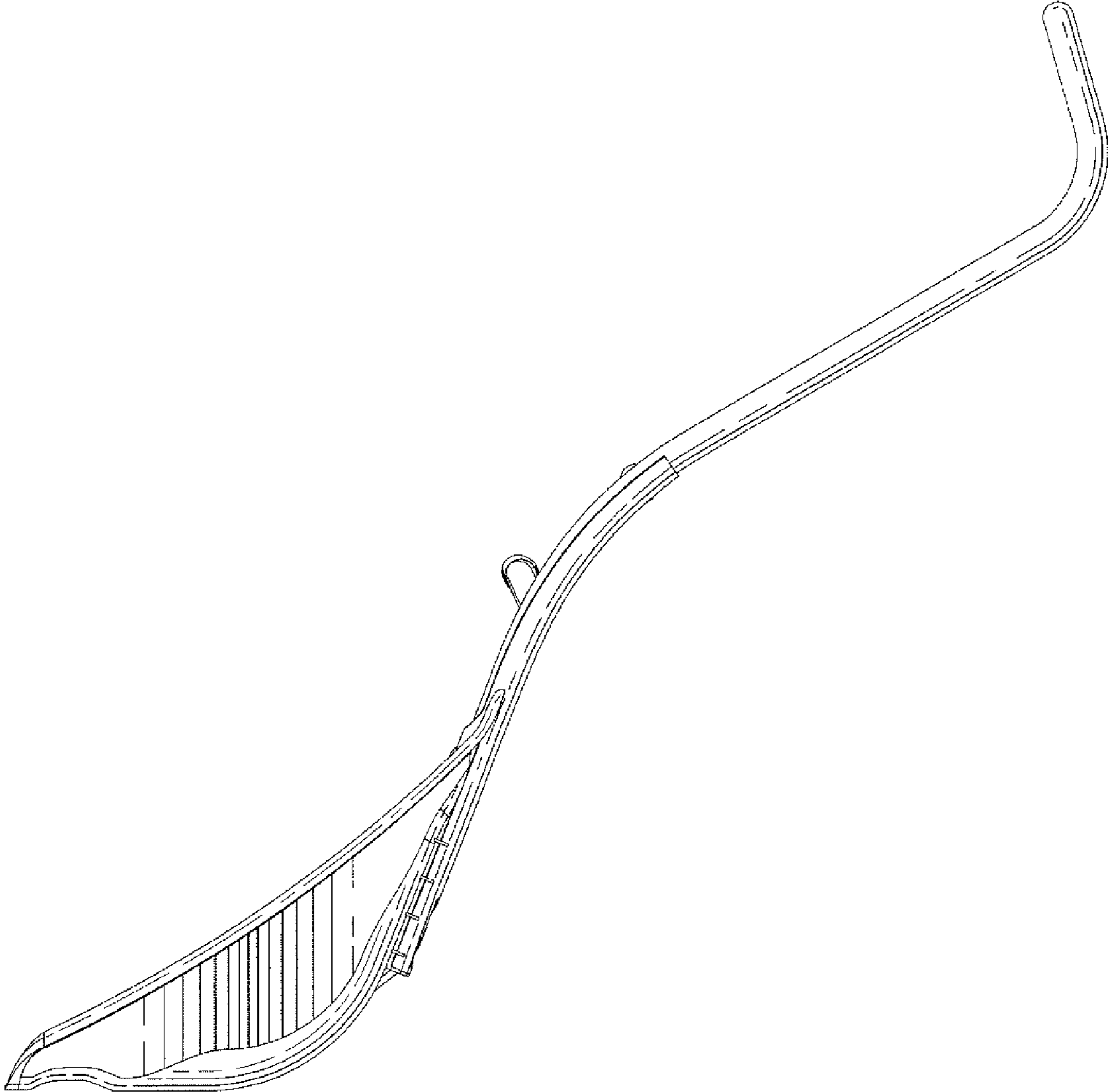

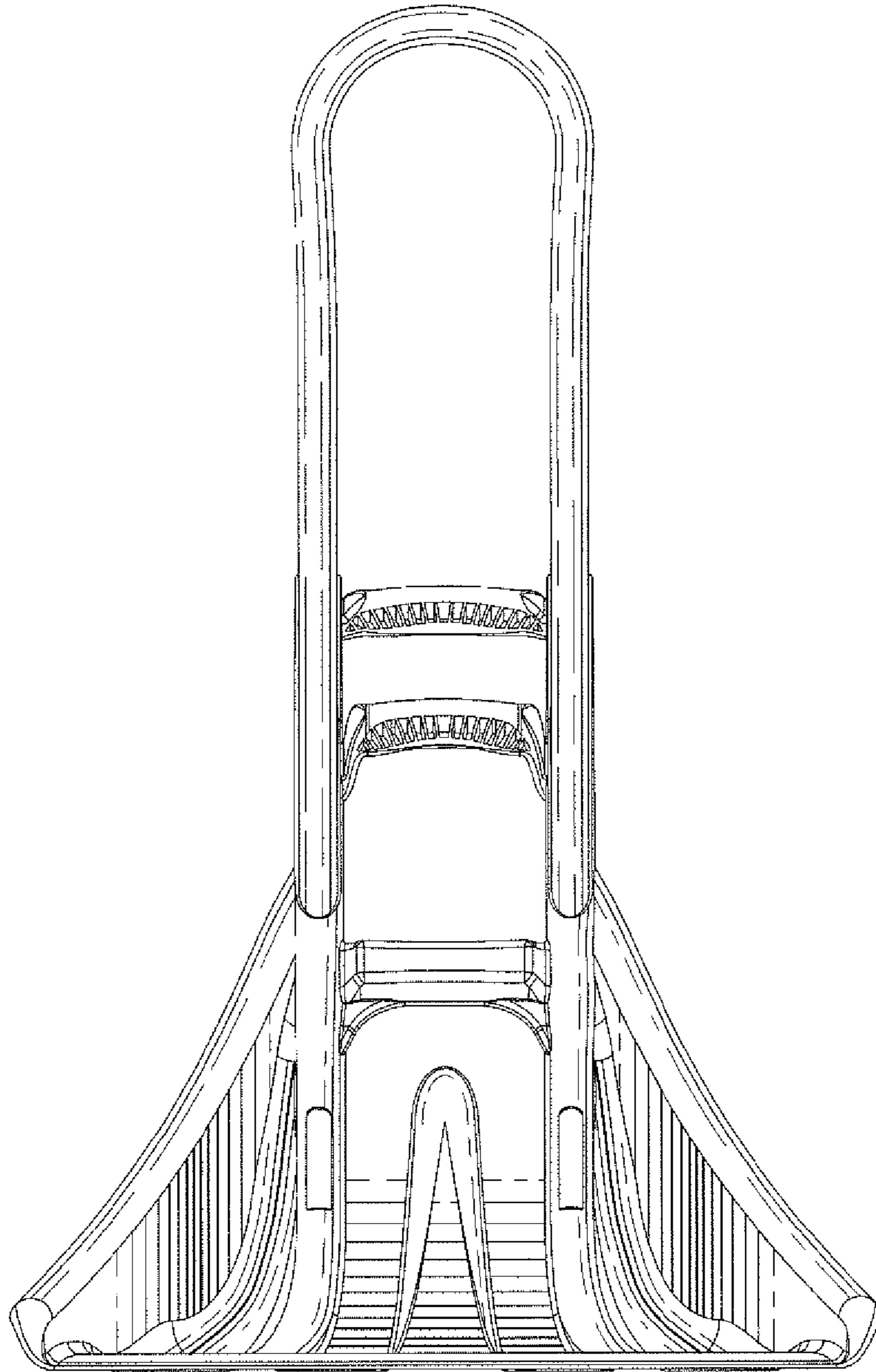

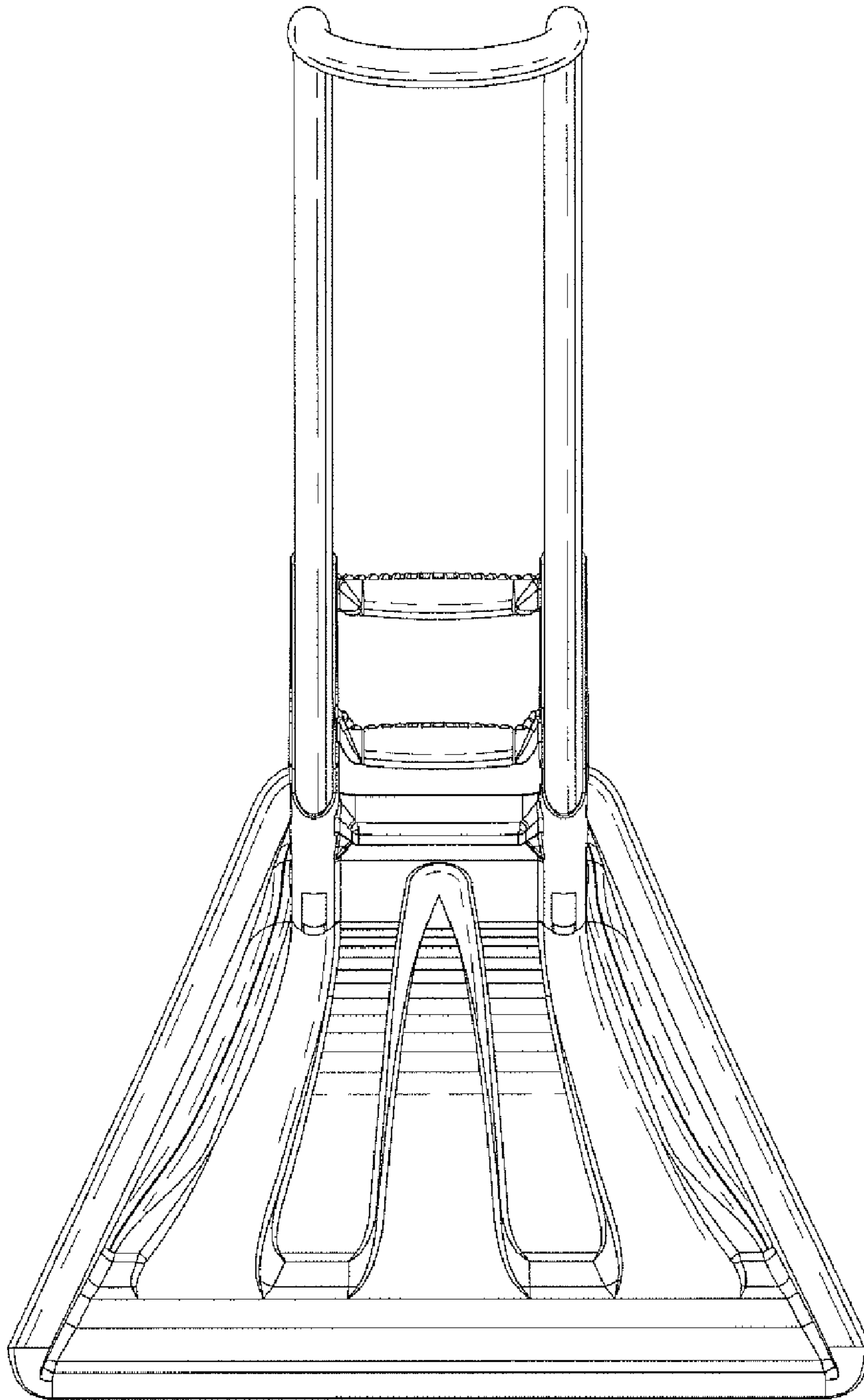
