(57) **CLAIM**

I claim the ornamental design for a set of hooks, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a set of hooks of the present invention with the broken lines showing a mounting apparatus being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a right side view of the set of hooks of FIG. 1, the left side view being a mirror image of the right side view shown;

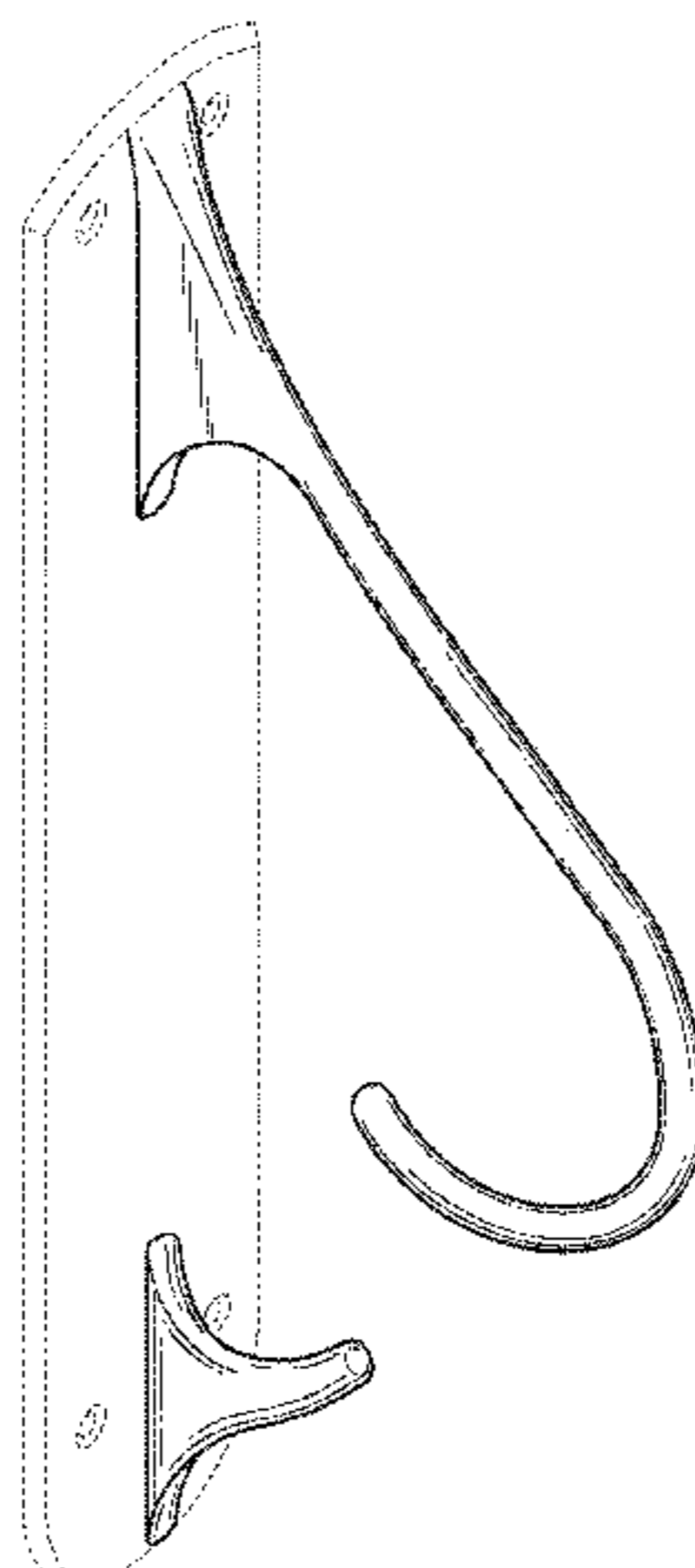
FIG. 3 is a front view of the set of hooks of FIG. 1;

FIG. 4 is a rear view of the set of hooks of FIG. 1;

FIG. 5 is a top view of the set of hooks of FIG. 1; and,

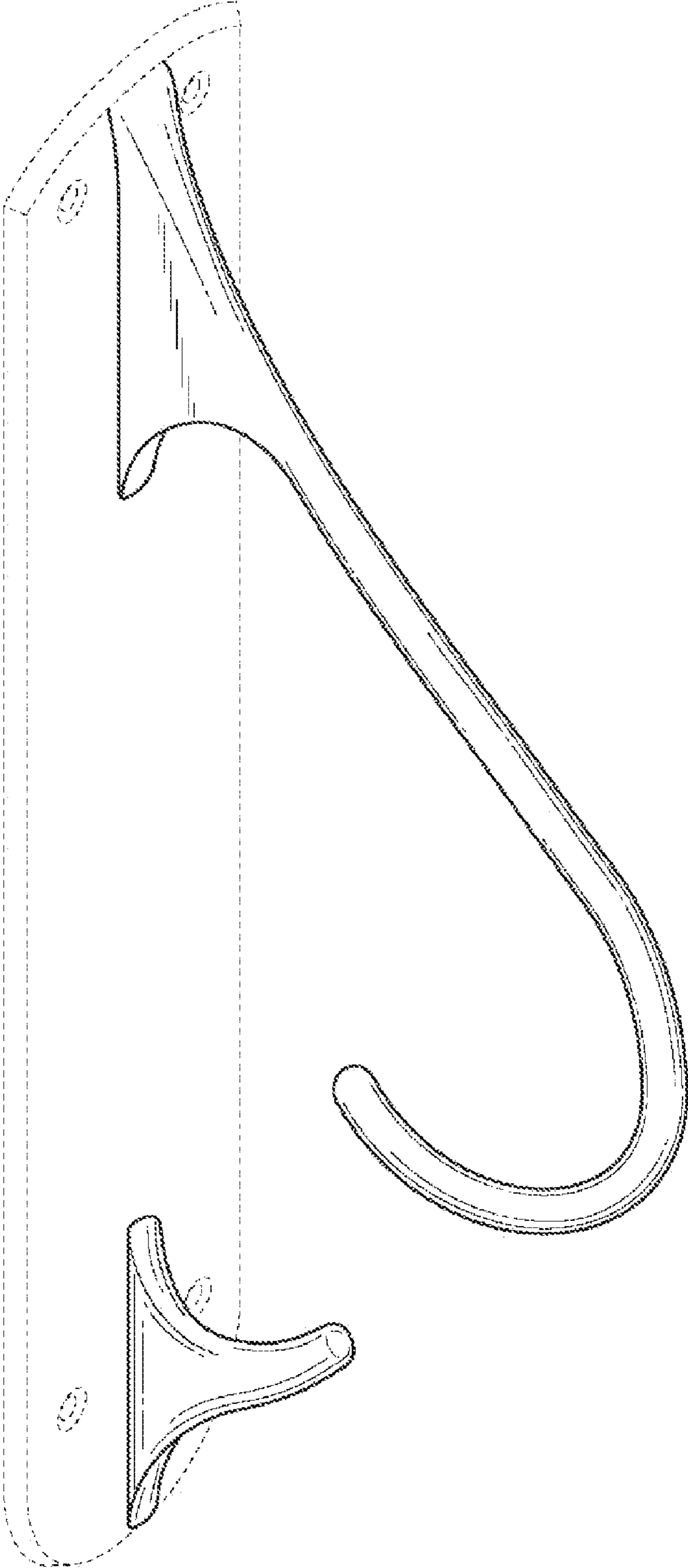

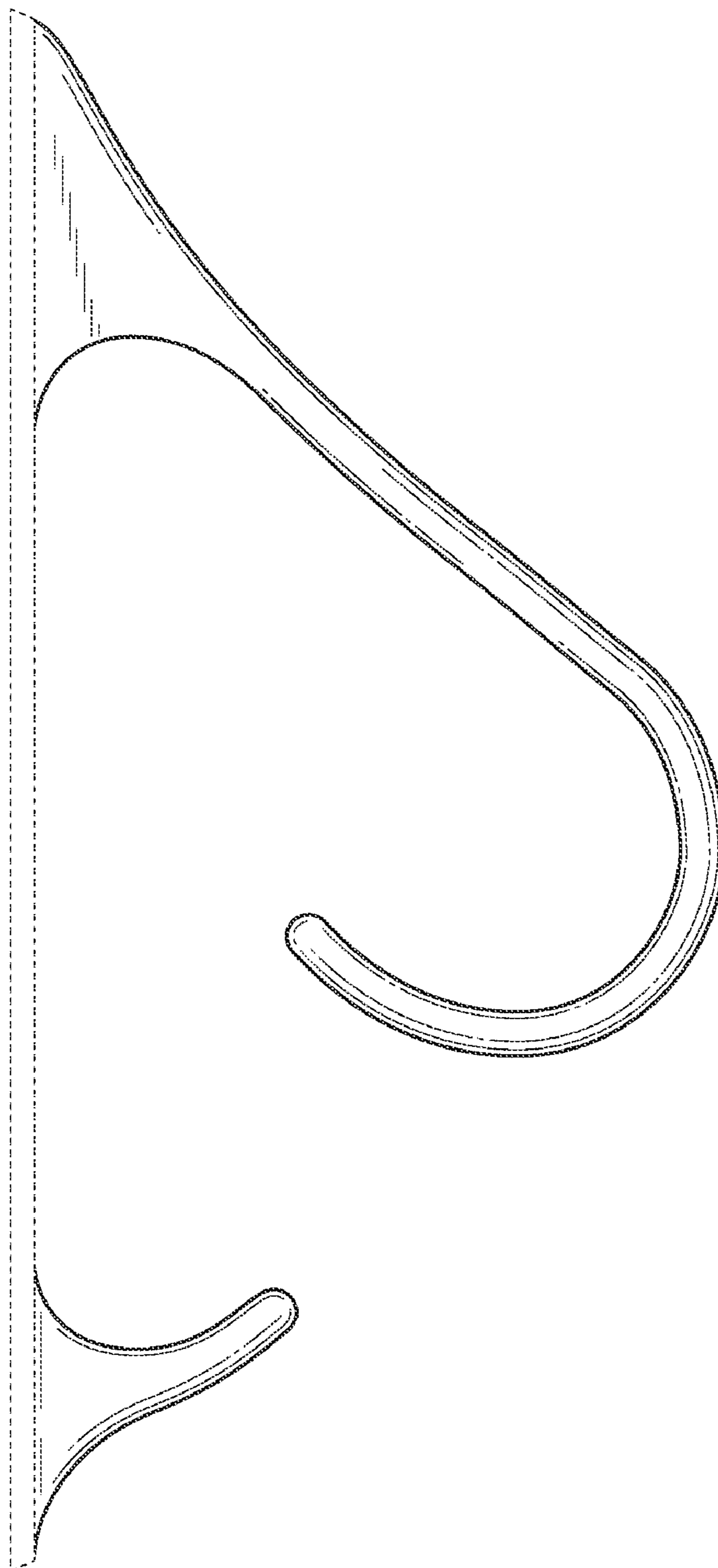
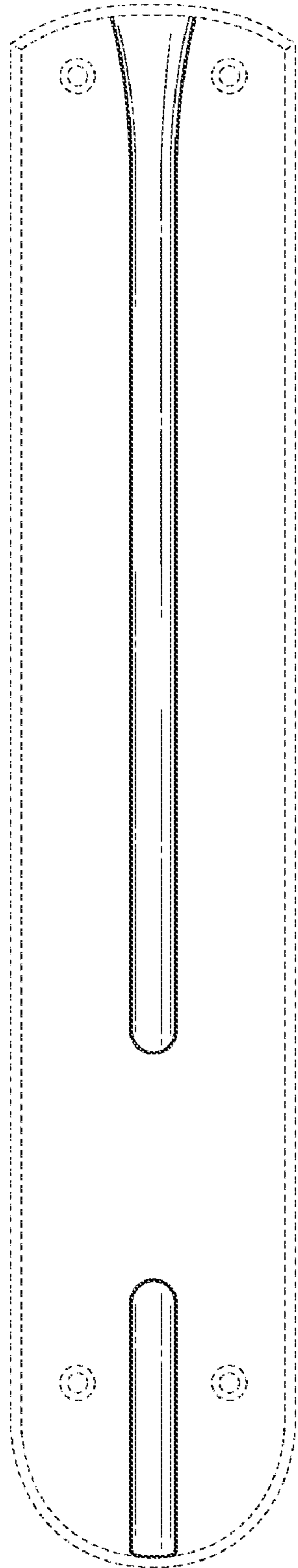
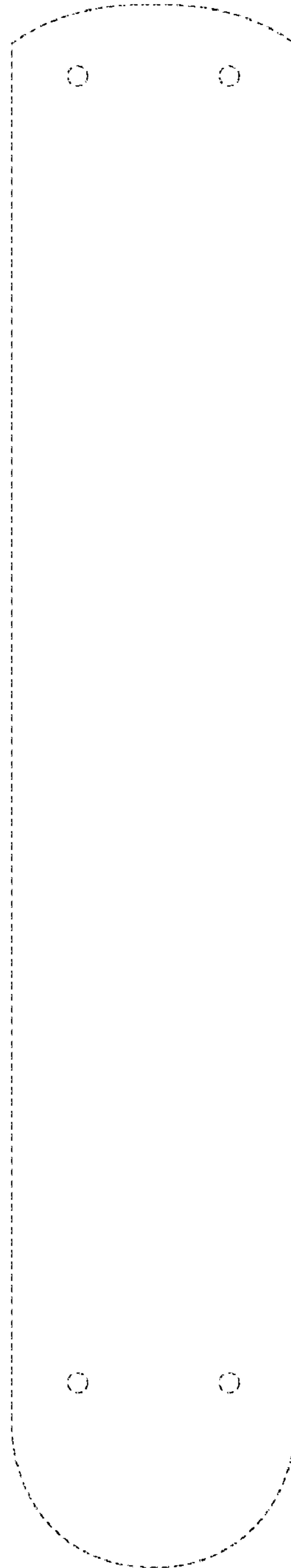


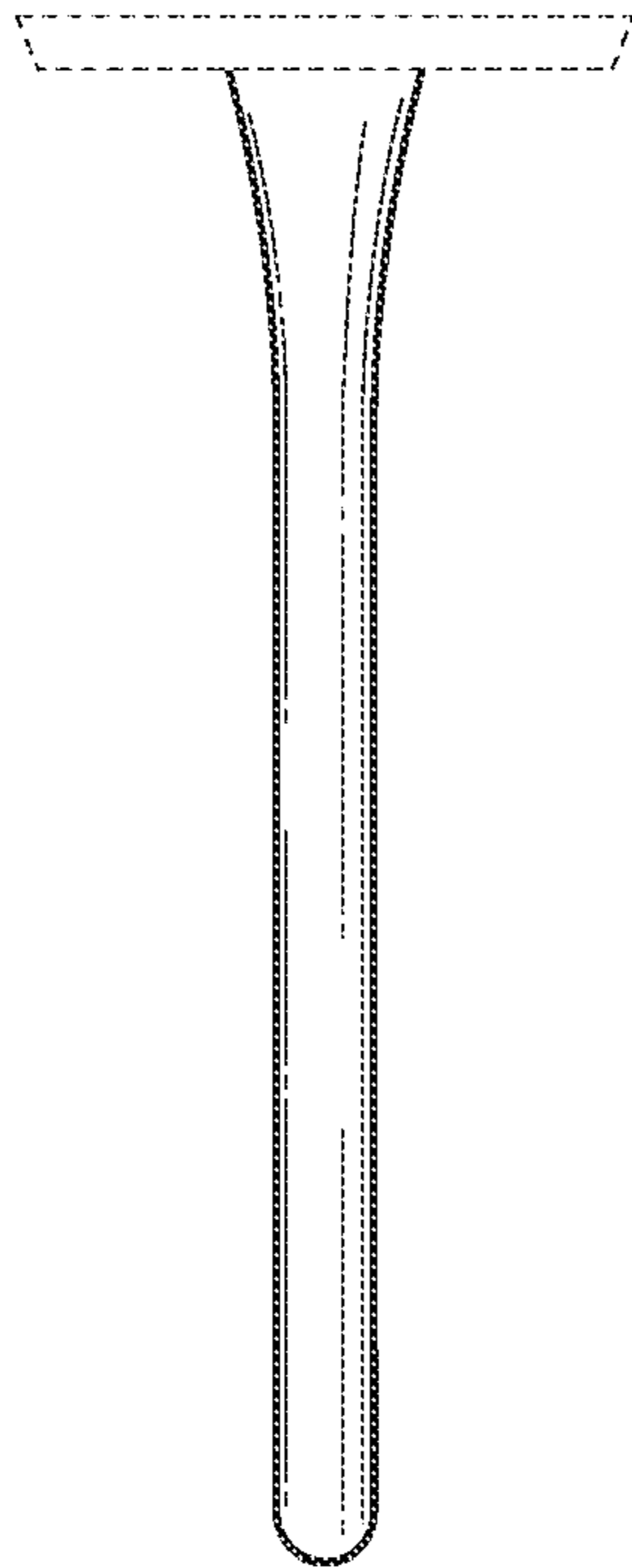

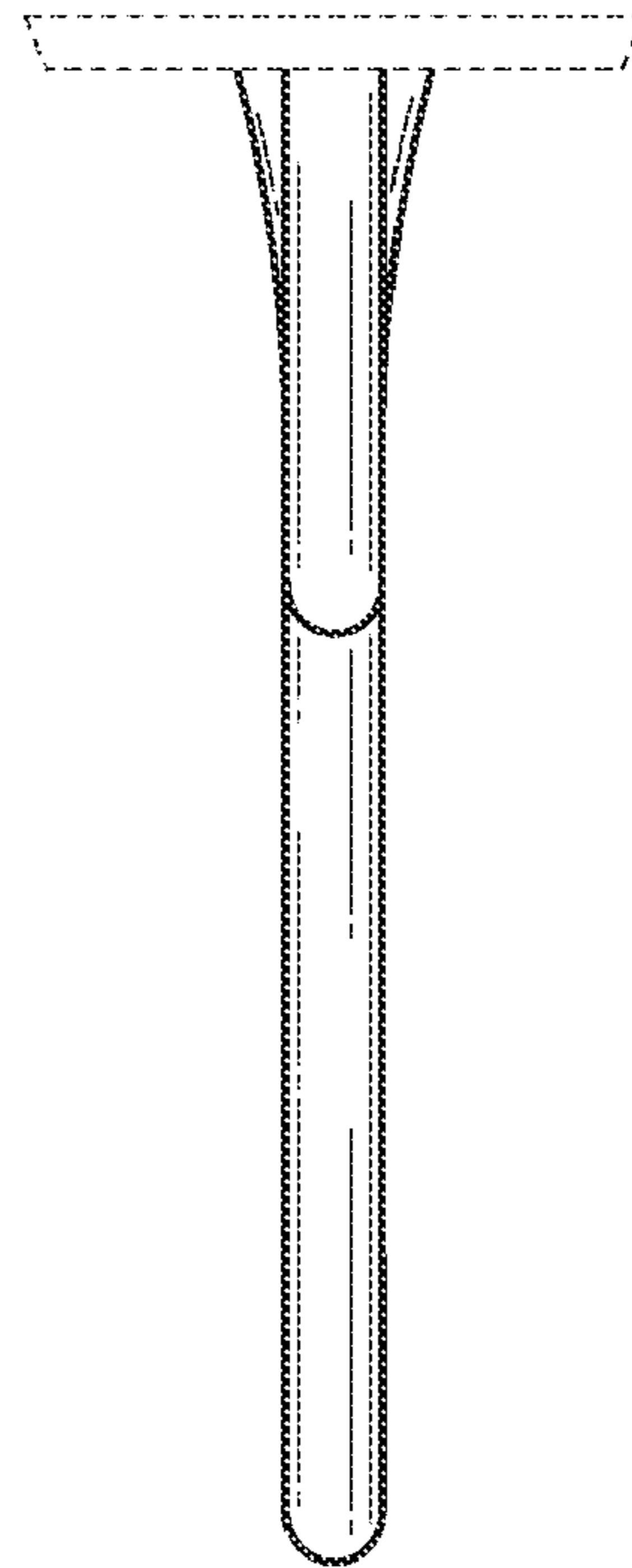
