DESCRIPTION

FIG. 1 is a top, front, and right side perspective view showing my new design for a finger loop for a beverage bottle;

FIG. 2 is a front view of the finger loop for a beverage bottle shown in FIG. 1;

FIG. 3 is a left side view of the finger loop for a beverage bottle shown in FIG. 1, the right side view being a mirror image thereof;

FIG. 4 is a top view of the finger loop for a beverage bottle shown in FIG. 1;

FIG. 5 is a bottom view of the finger loop for a beverage bottle shown in FIG. 1;

FIG. 6 is a rear view of the finger loop for a beverage bottle shown in FIG. 1; and,

FIG. 7 is a top, front, and left side perspective view of the finger loop for a beverage bottle shown in FIG. 1 in a normal use environment on a beverage bottle.

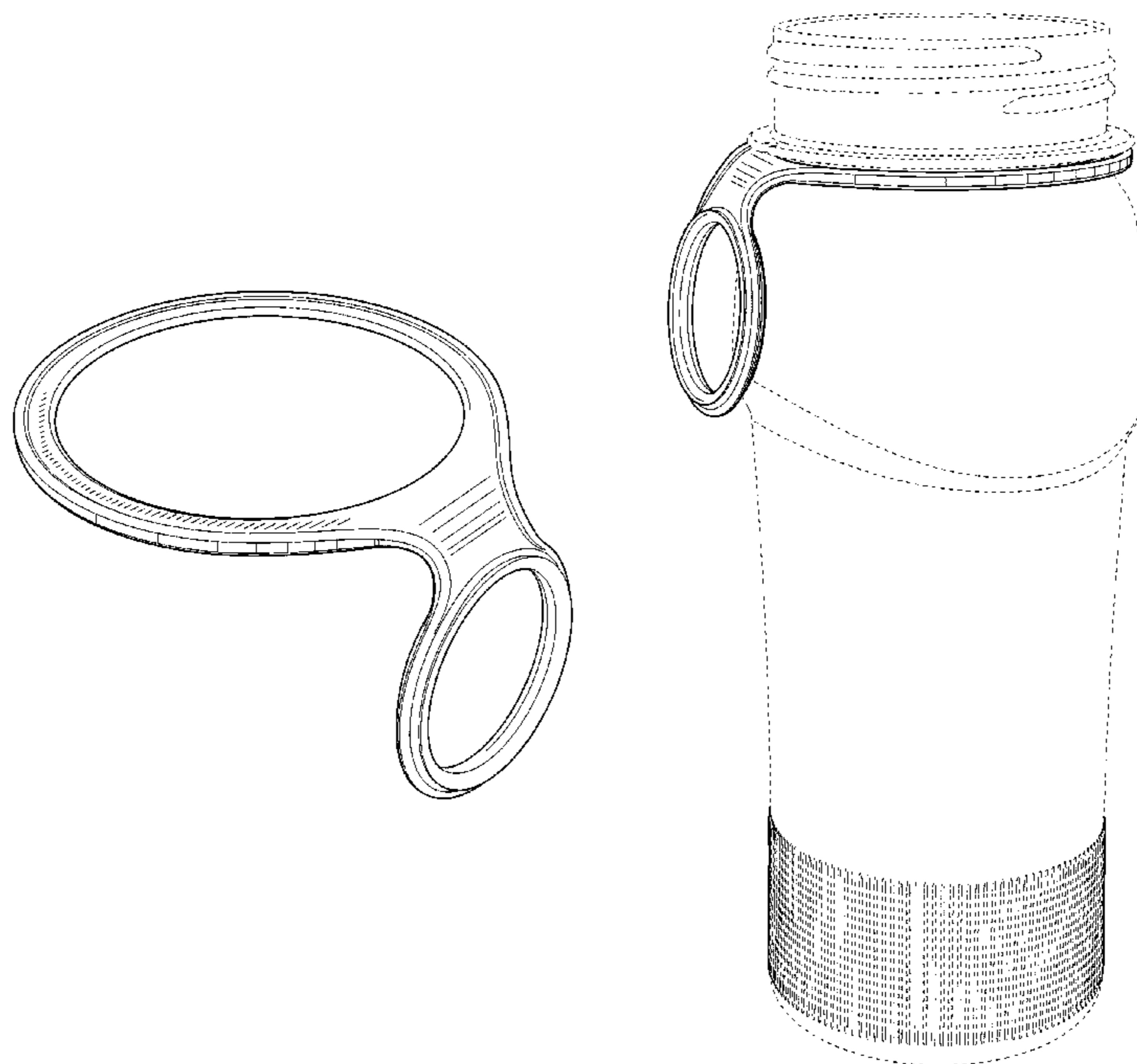

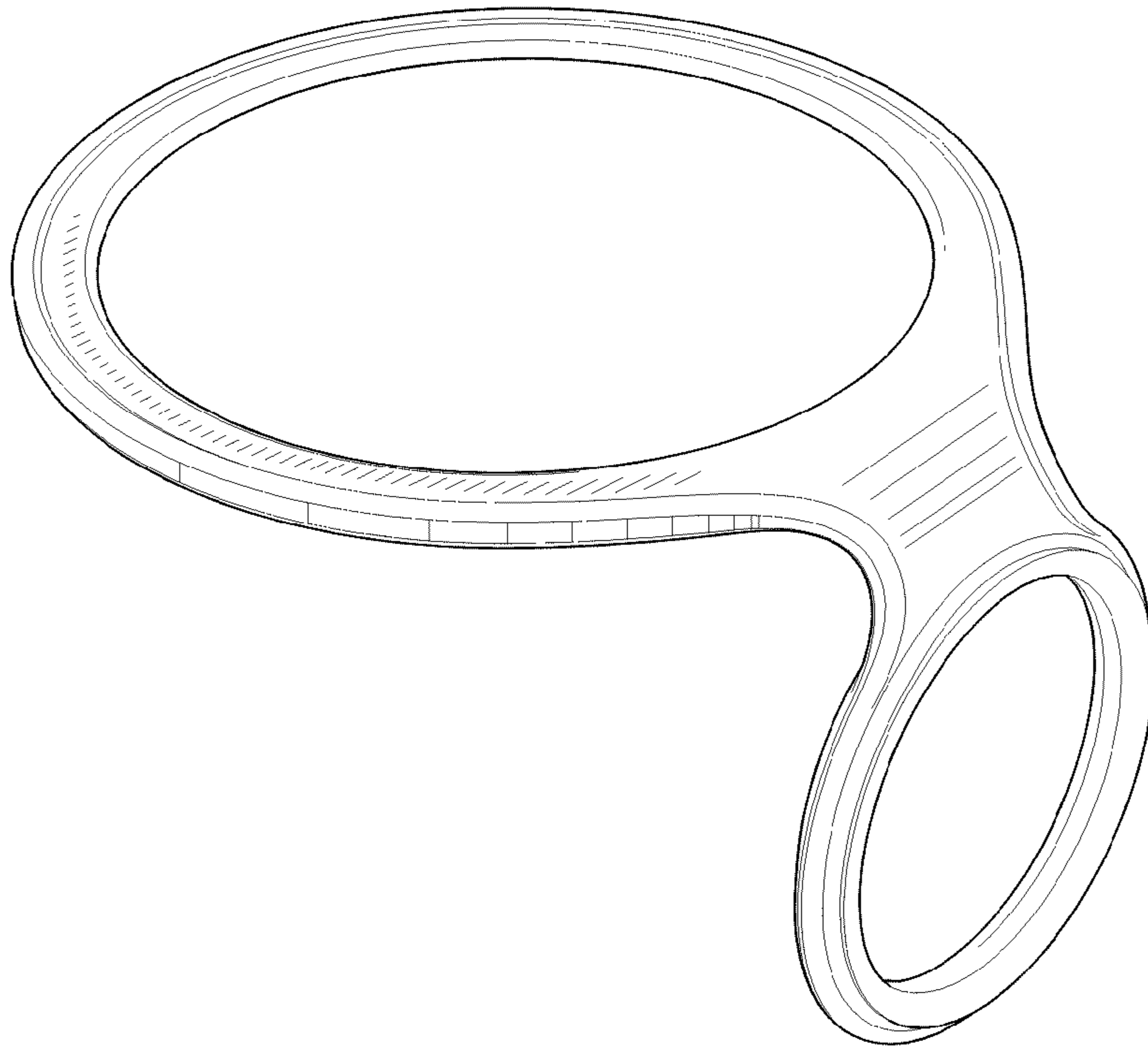

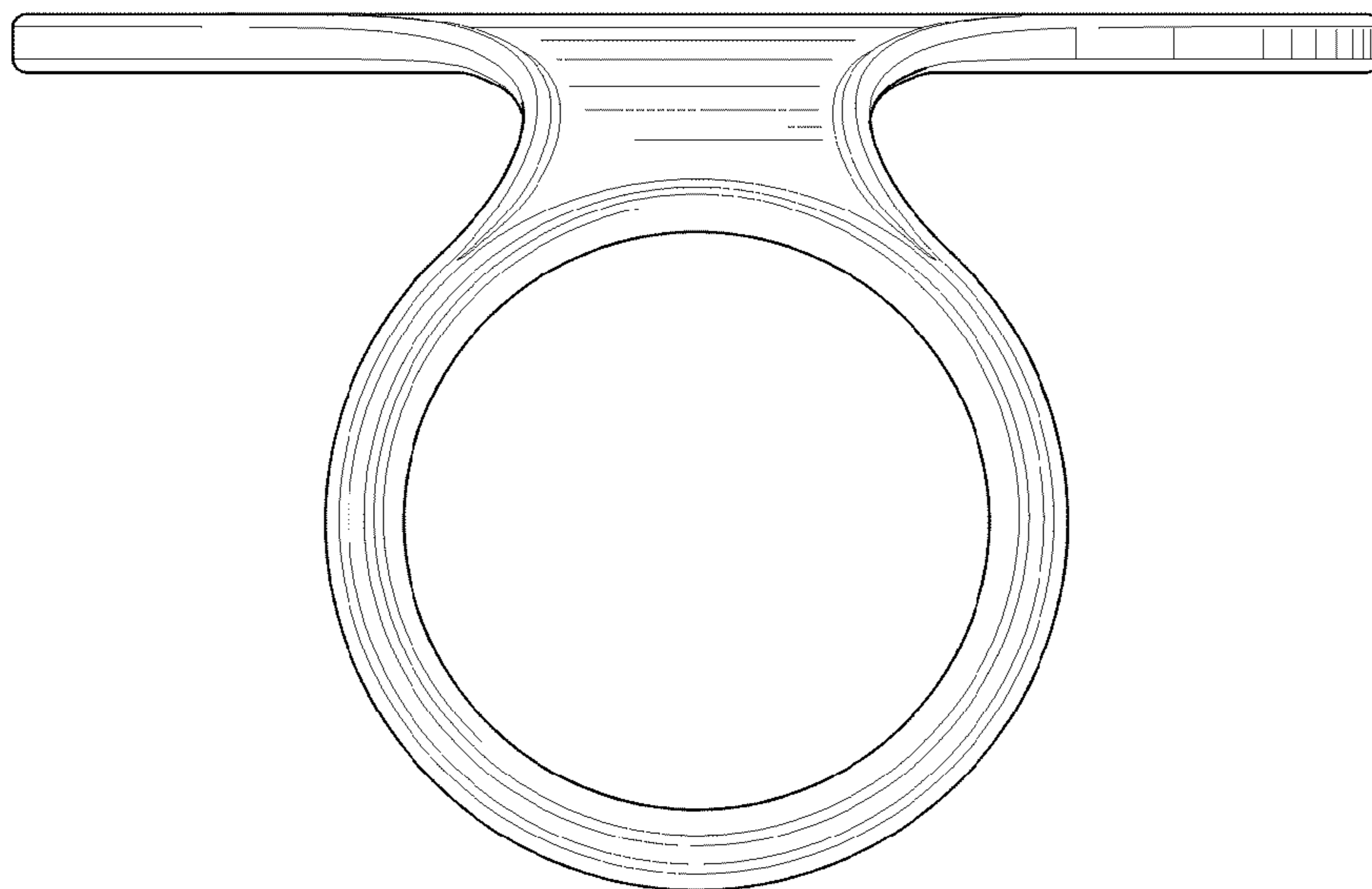

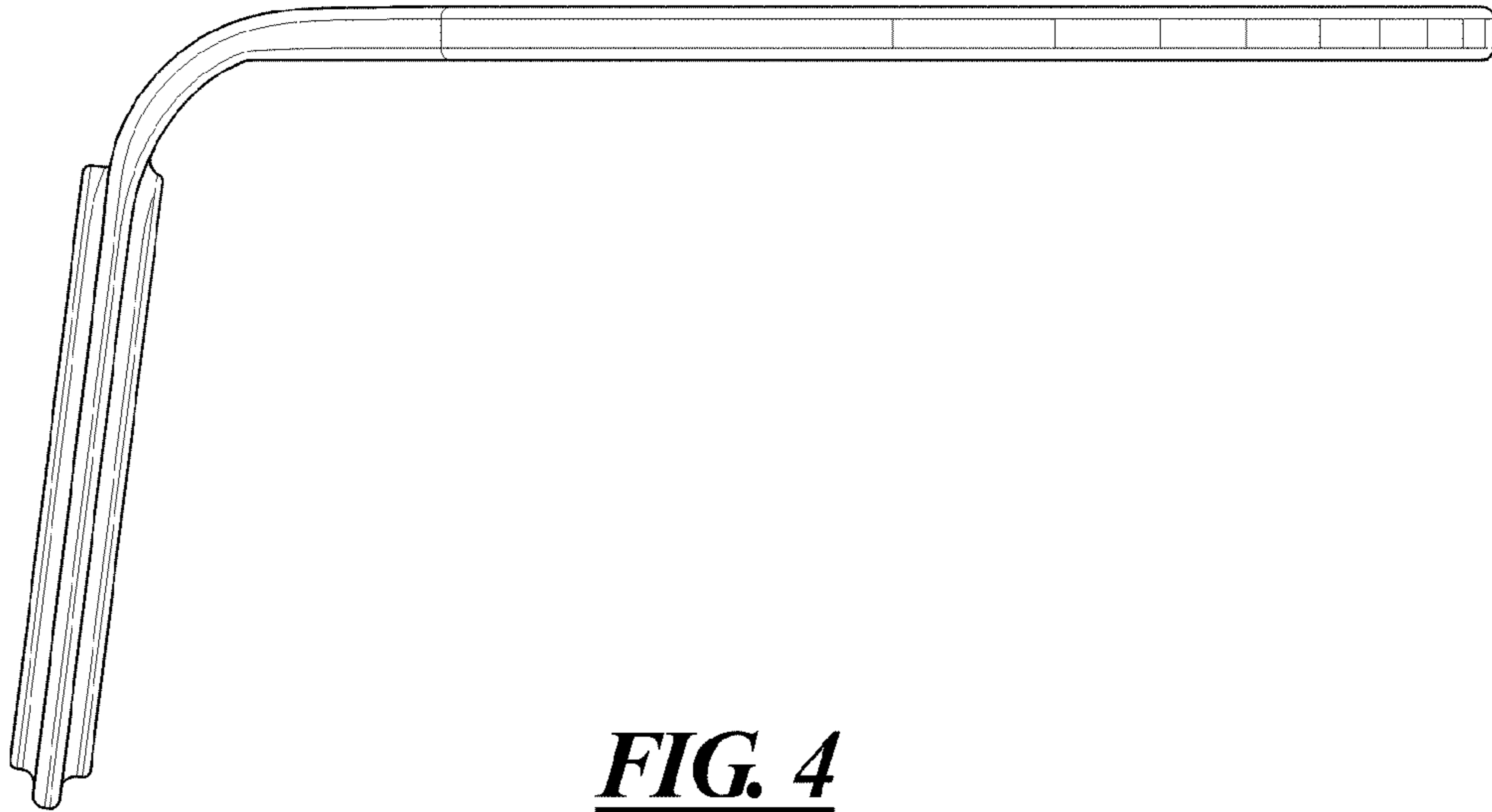
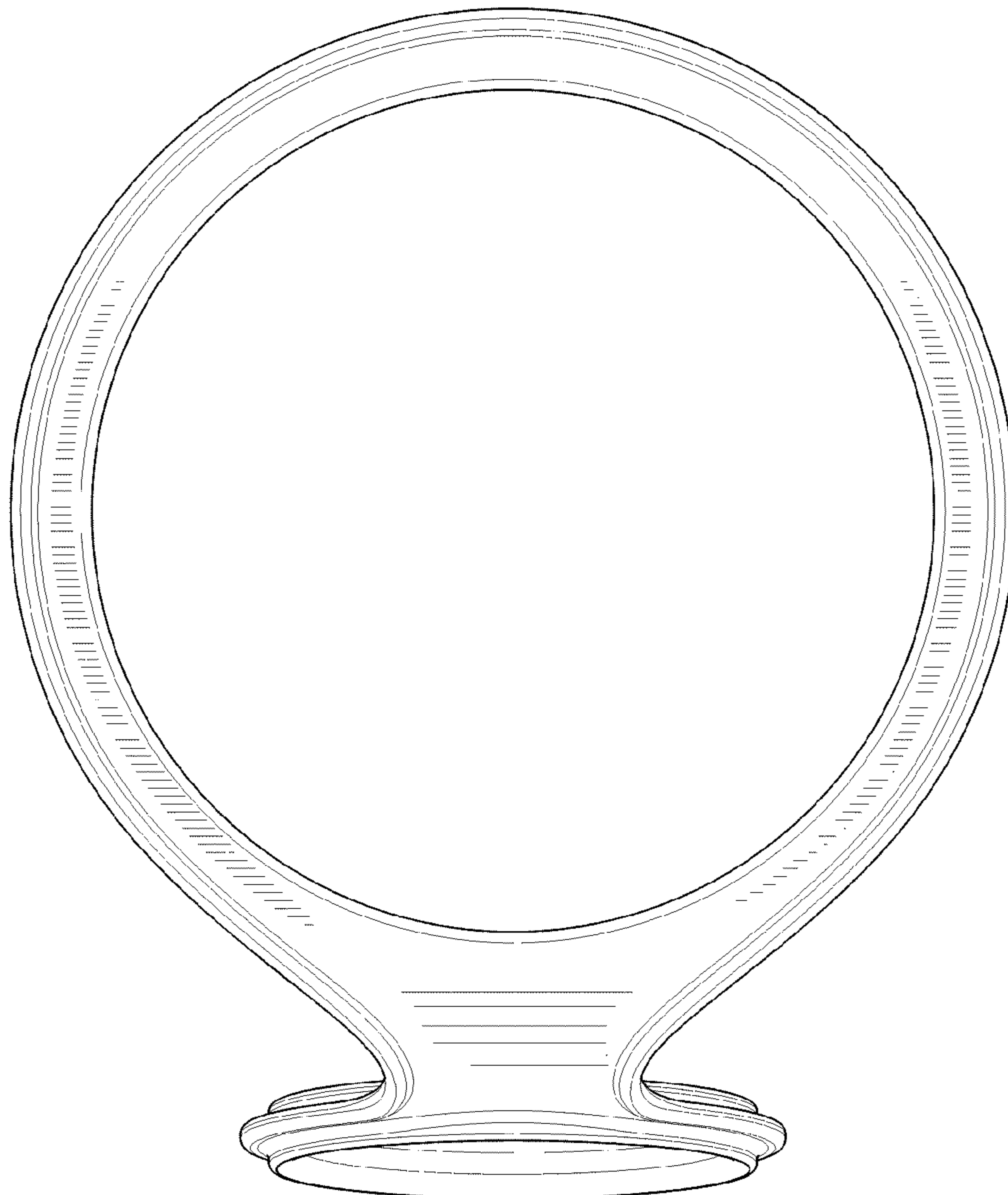

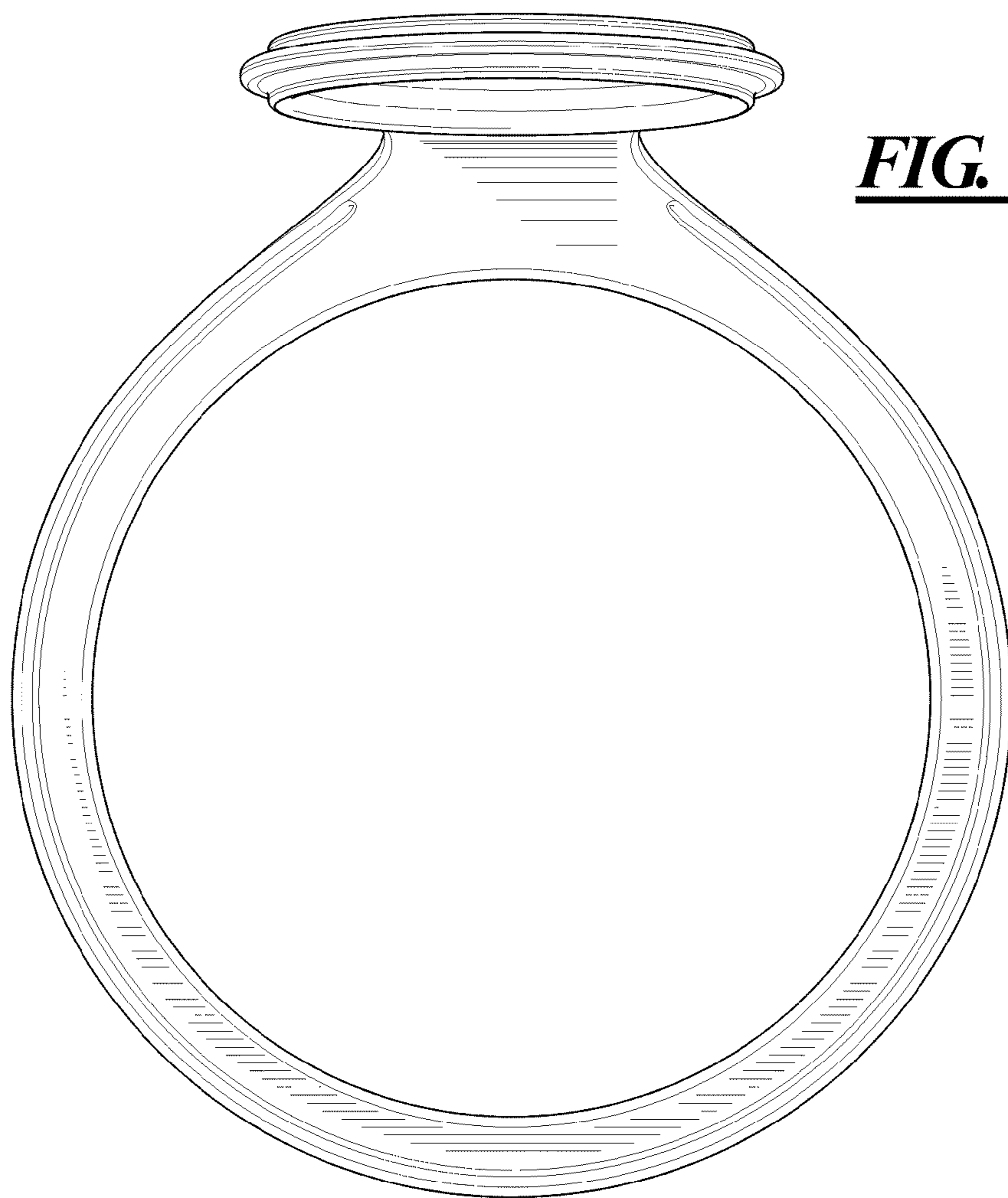

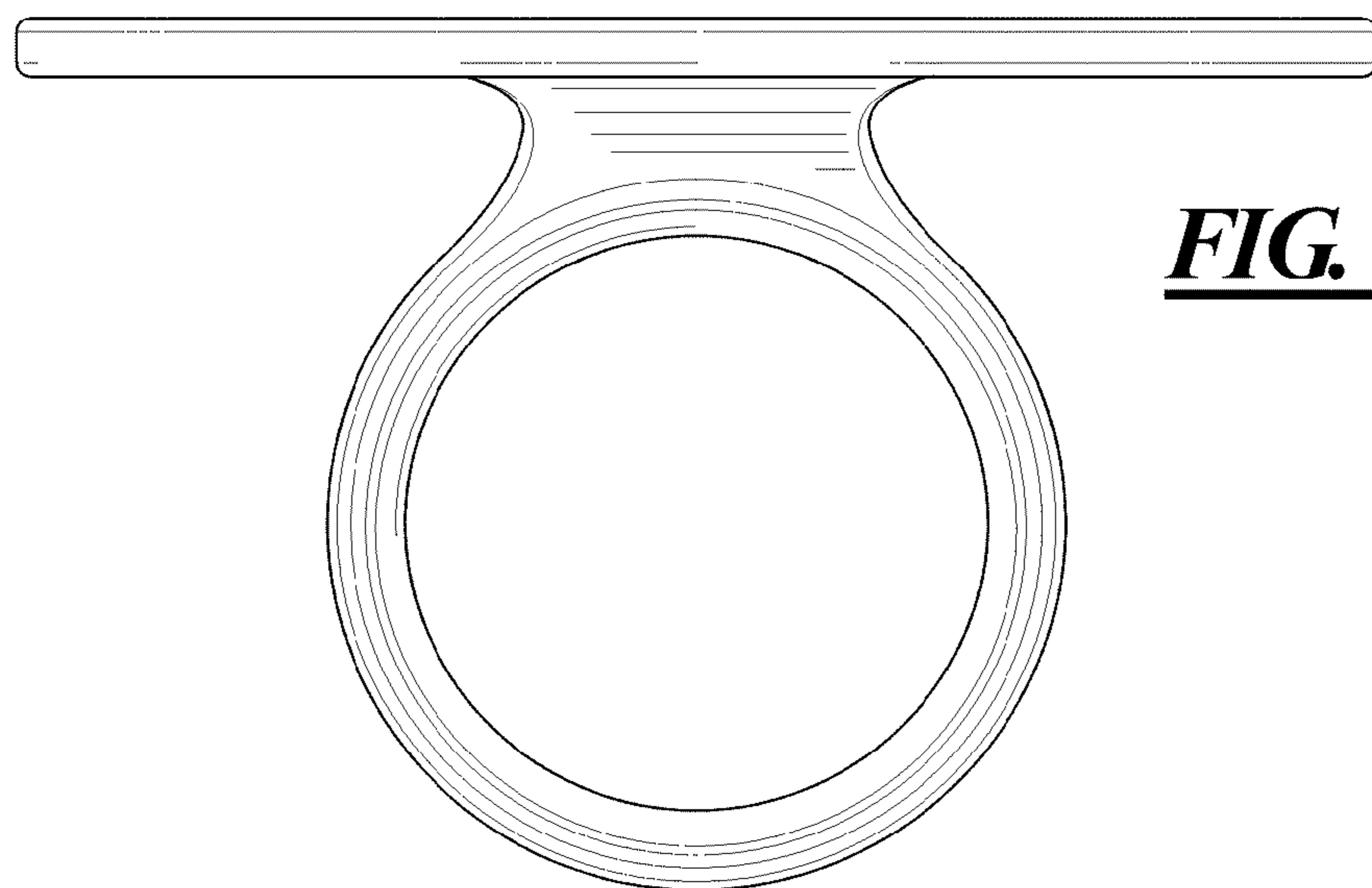
