FIG. 3 is a front elevation view of the bottle with cap of FIG. 1.

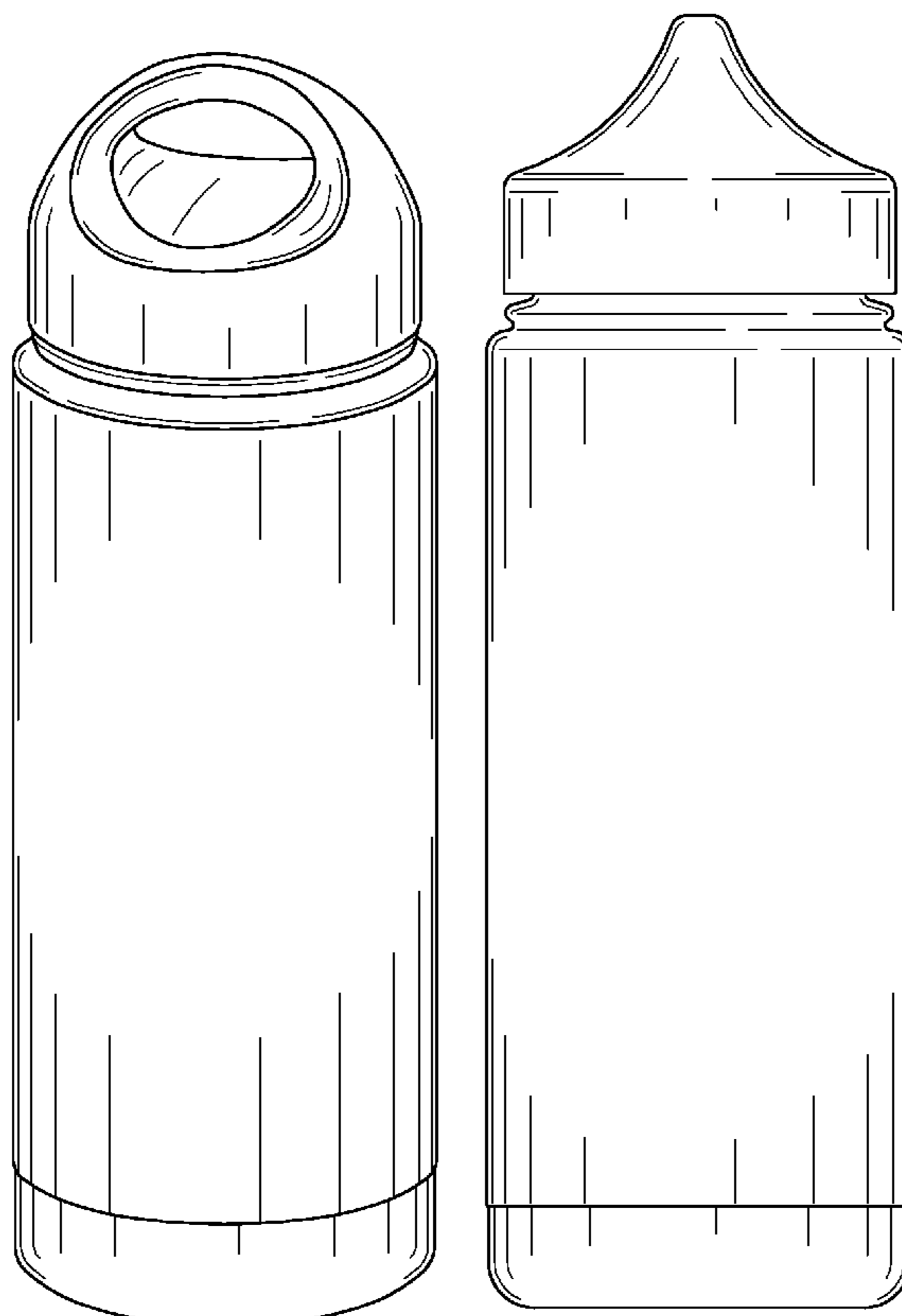
FIG. 4 is a back elevation view of the bottle with cap of FIG. 1.

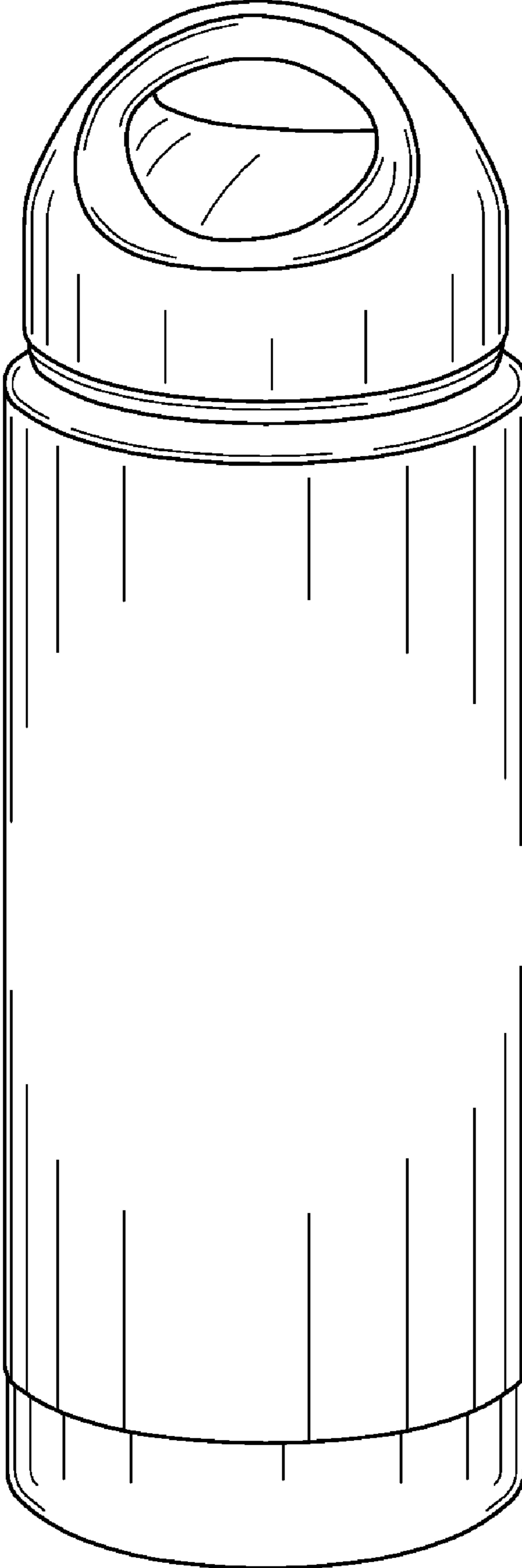

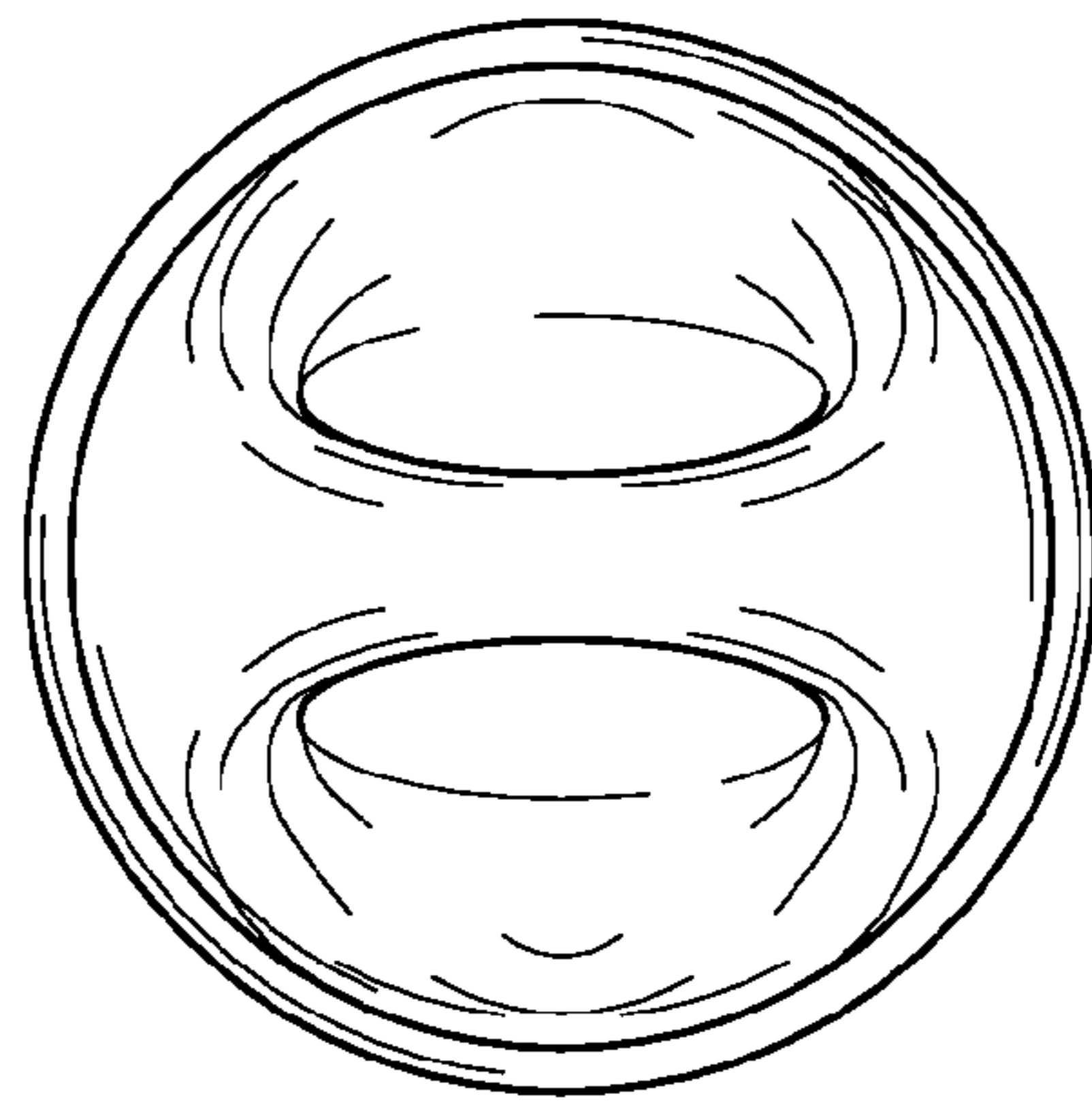

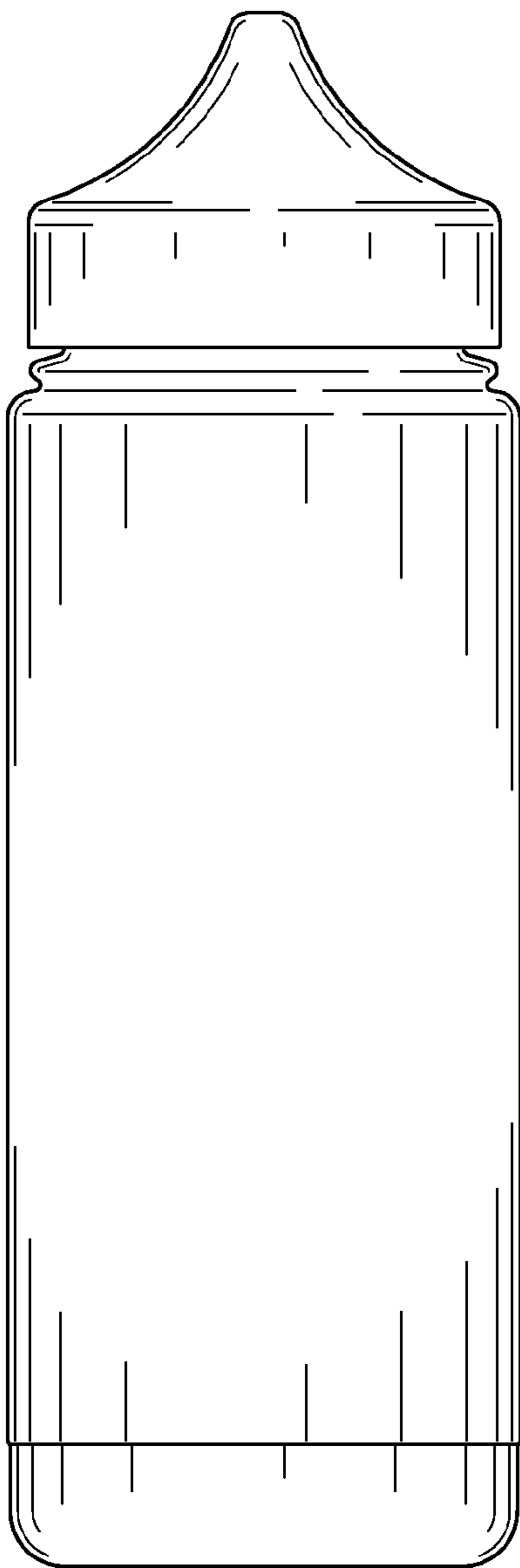

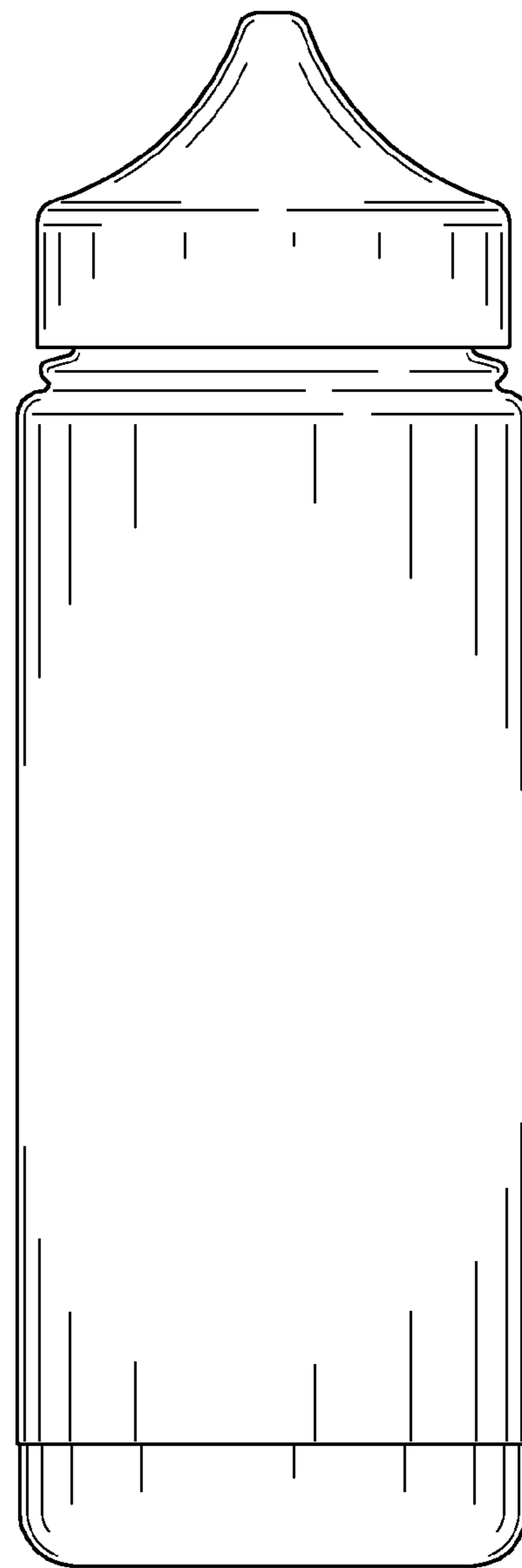

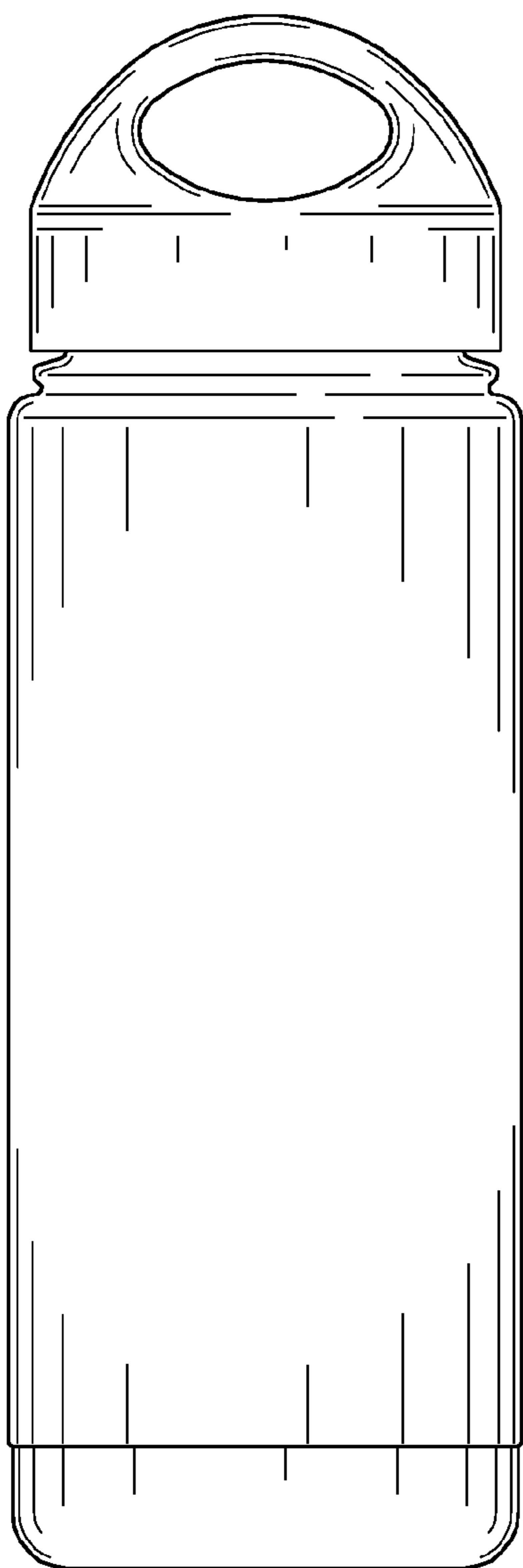

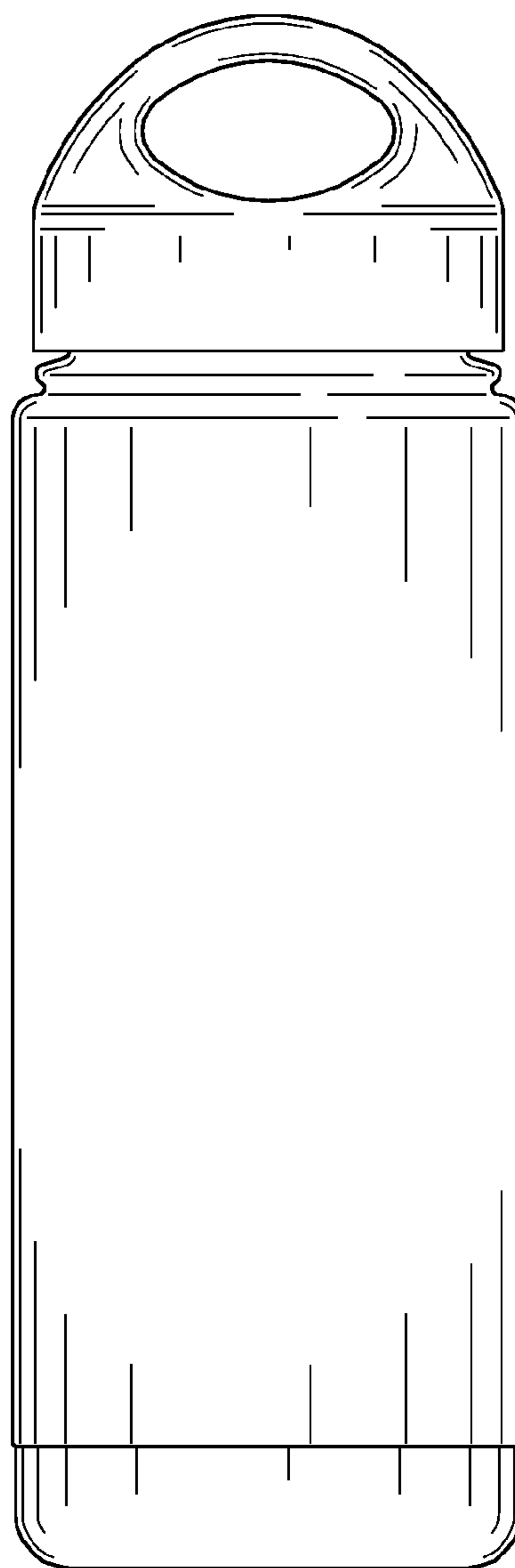

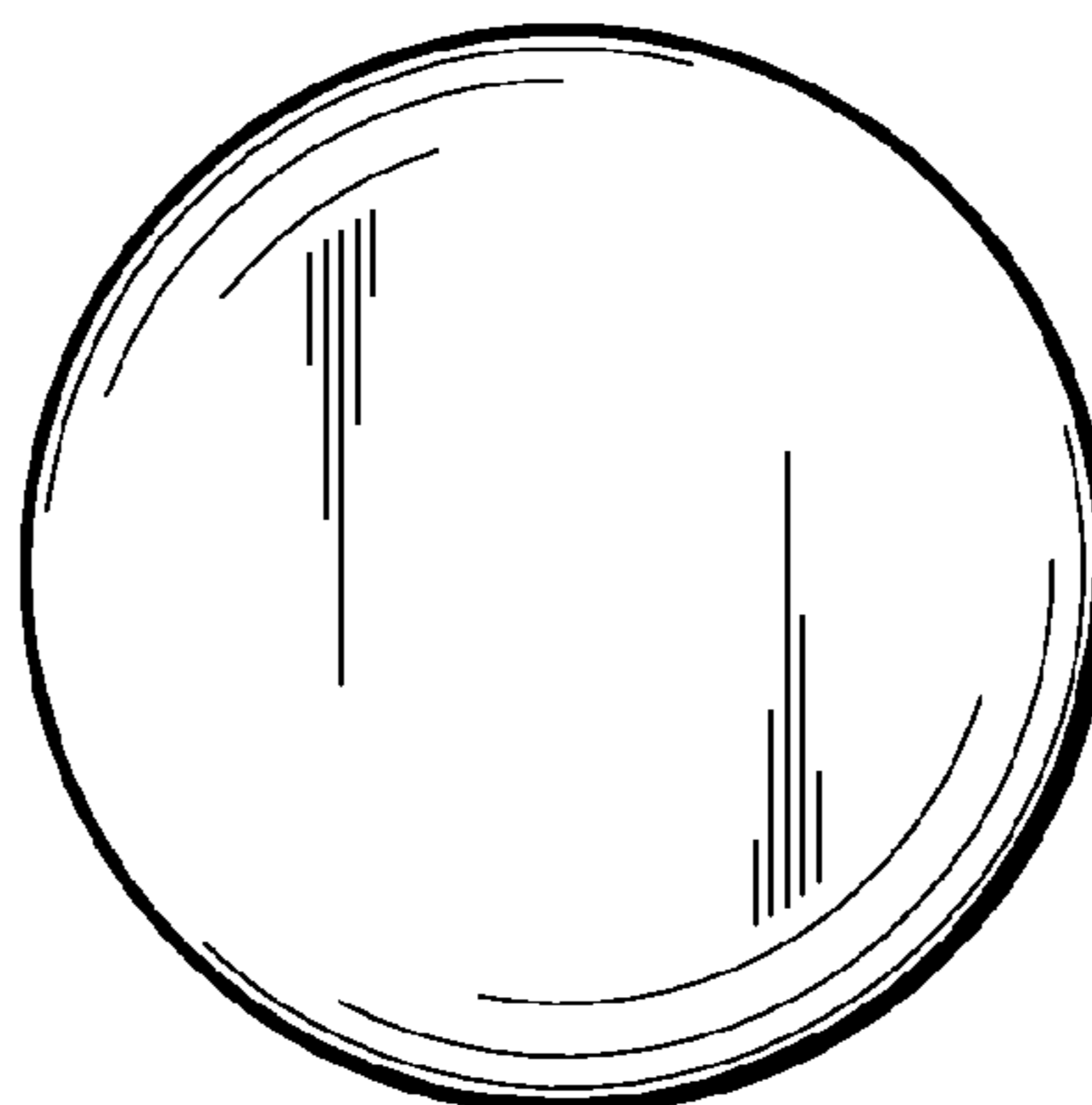
