(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is front perspective view of a container of my new design;

FIG. 2 is a front view thereof, the right side view, the left side view, and the rear view being identical thereto;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

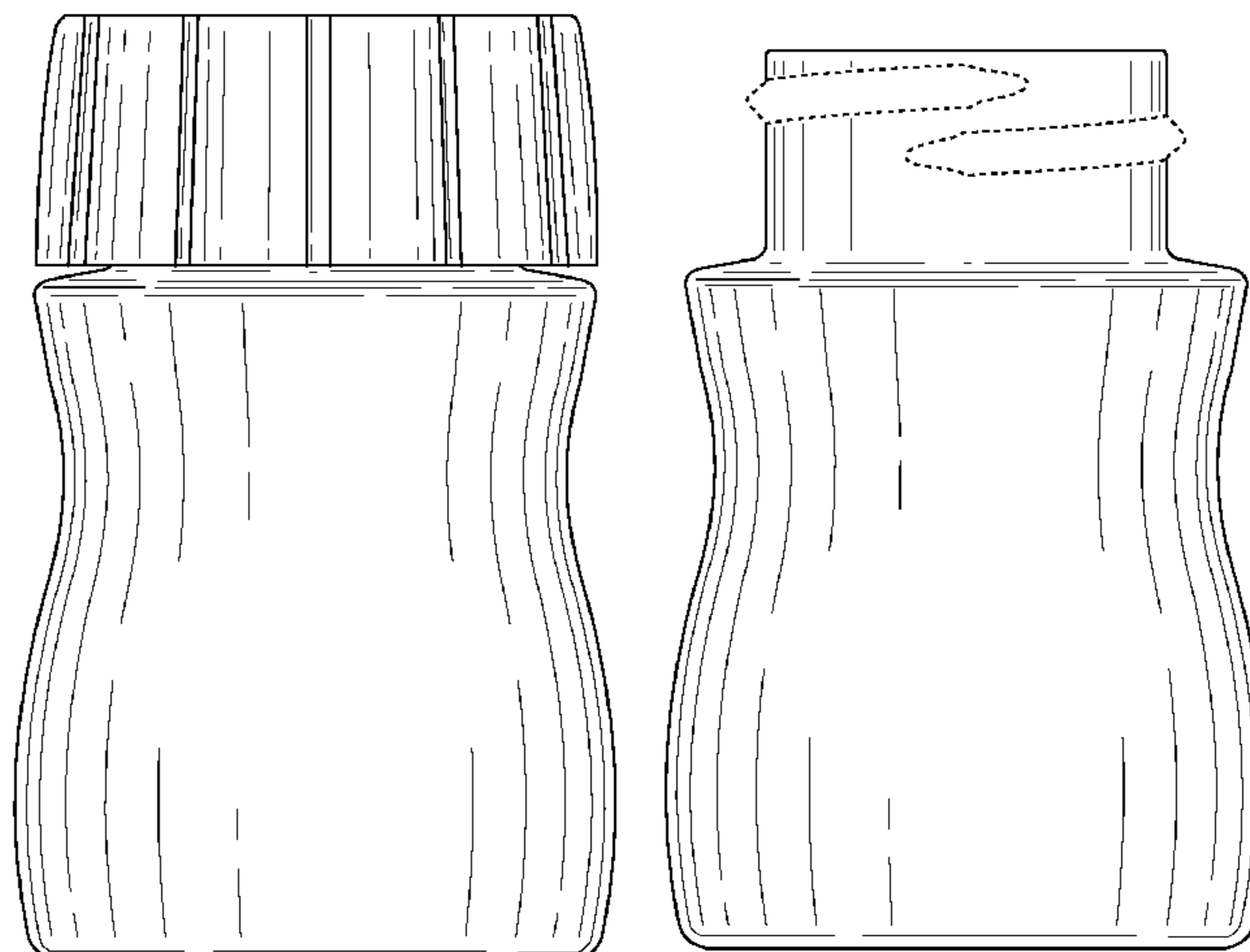
FIG. 5 is a front perspective view of the container in an open position with the cap removed.

FIG. 6 is a front view thereof, the right side, left side and rear views being identical except for the unclaimed thread detail; and,

FIG. 7 is a top view thereof.

The dot-dash broken line in the FIG. 4 drawing view defines the bounds of the claim and forms no part thereof. The evenly dashed broken lines in the drawings illustrate the portions of the design that form no part of the claim.

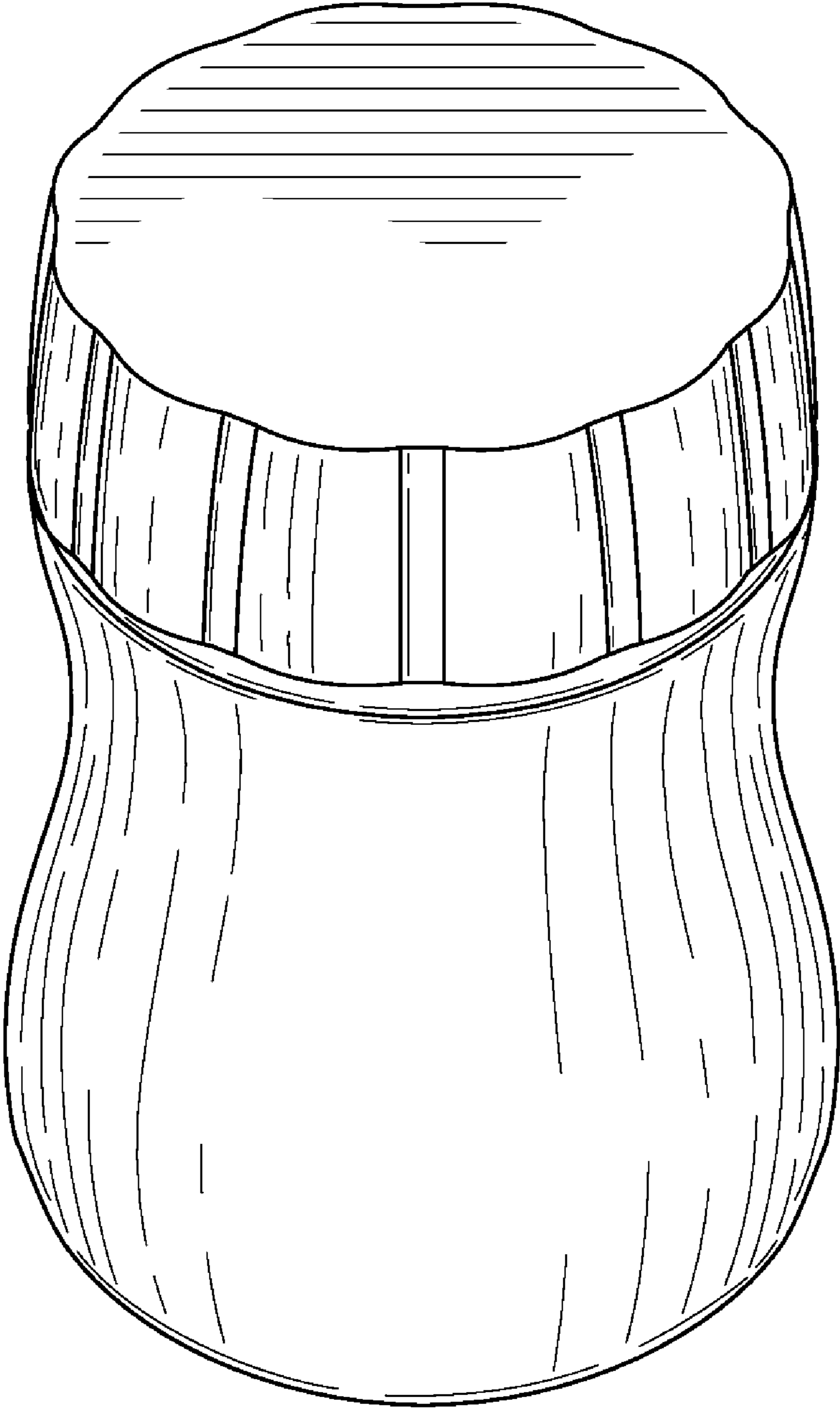

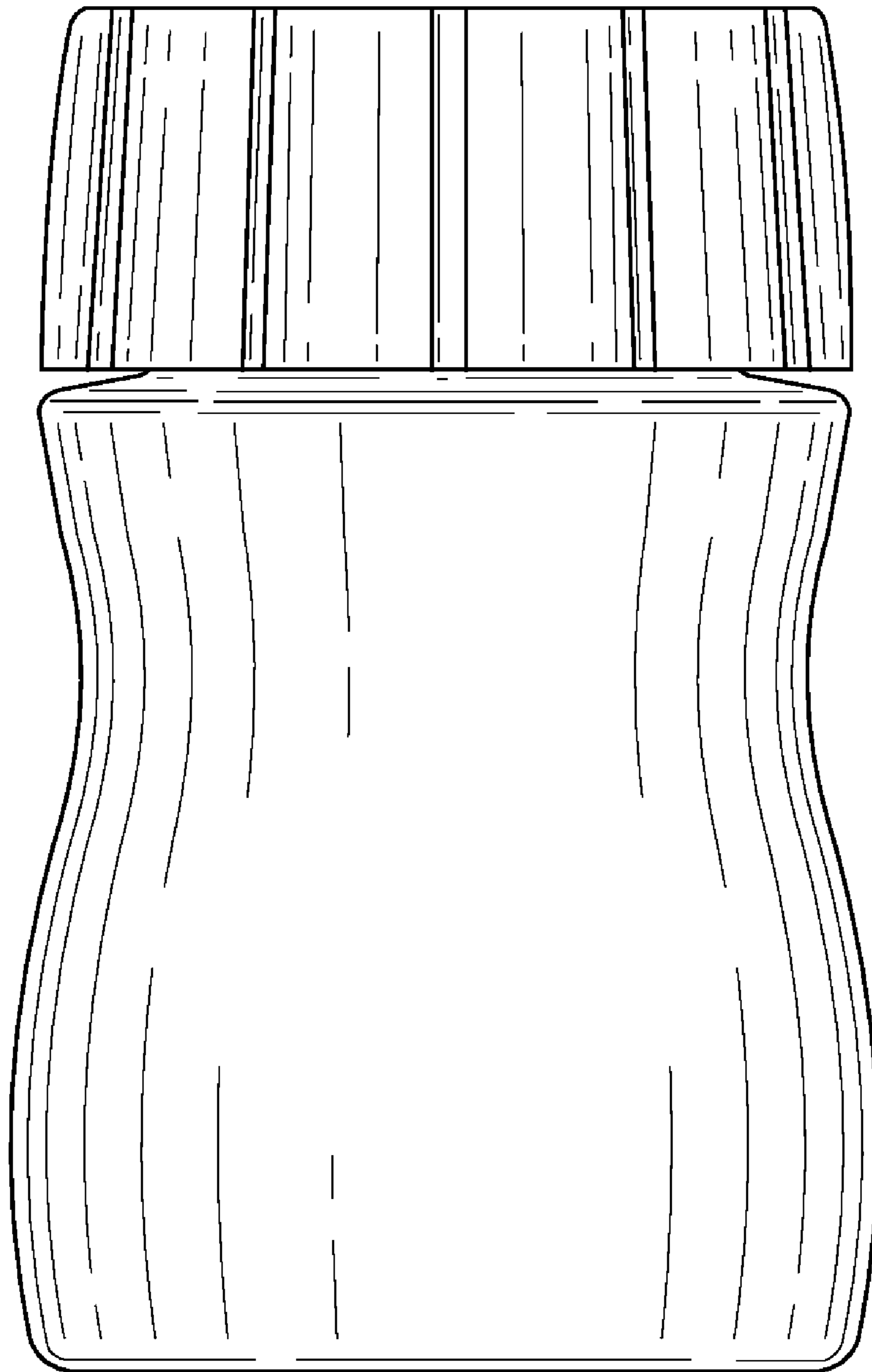

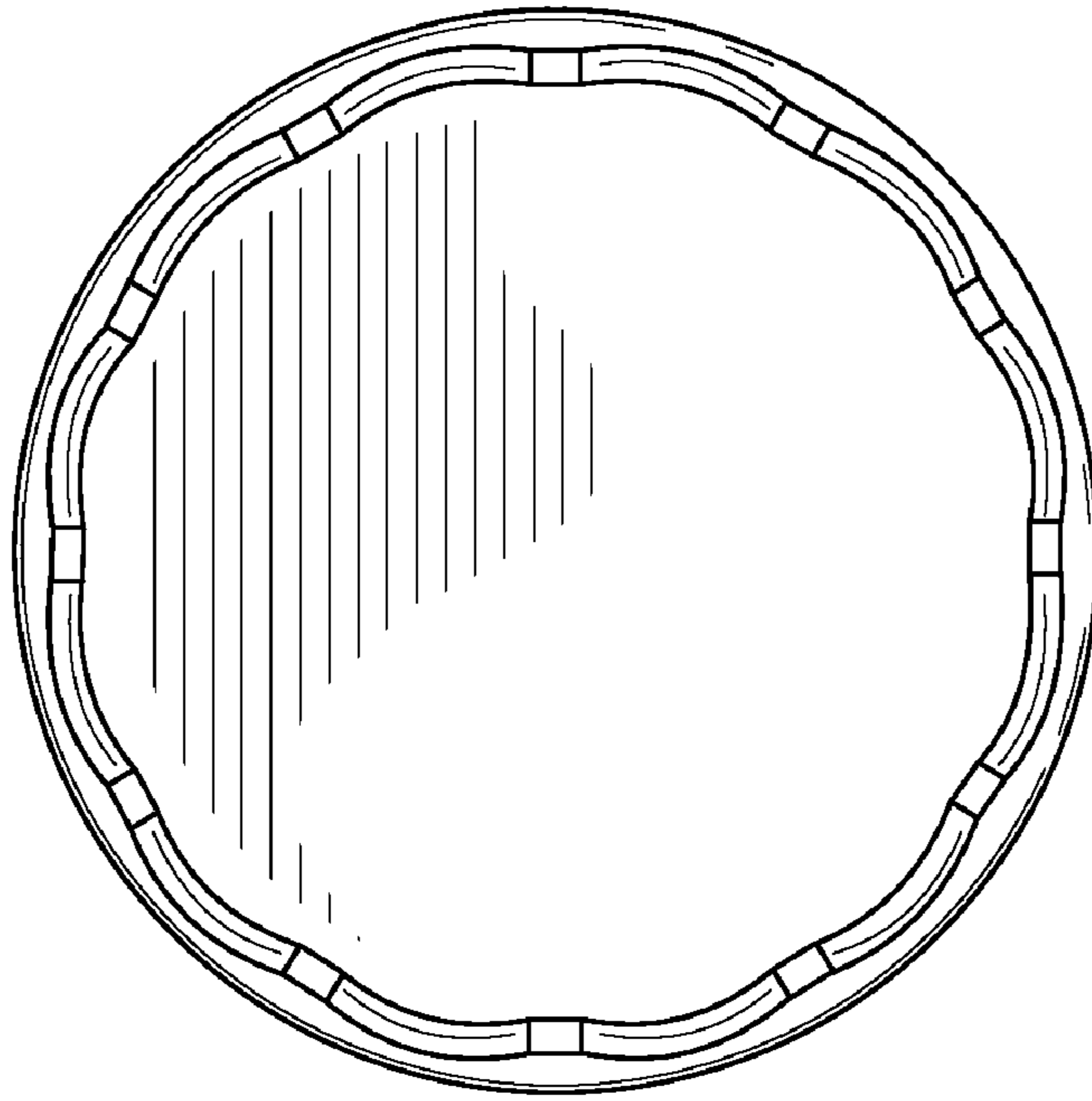

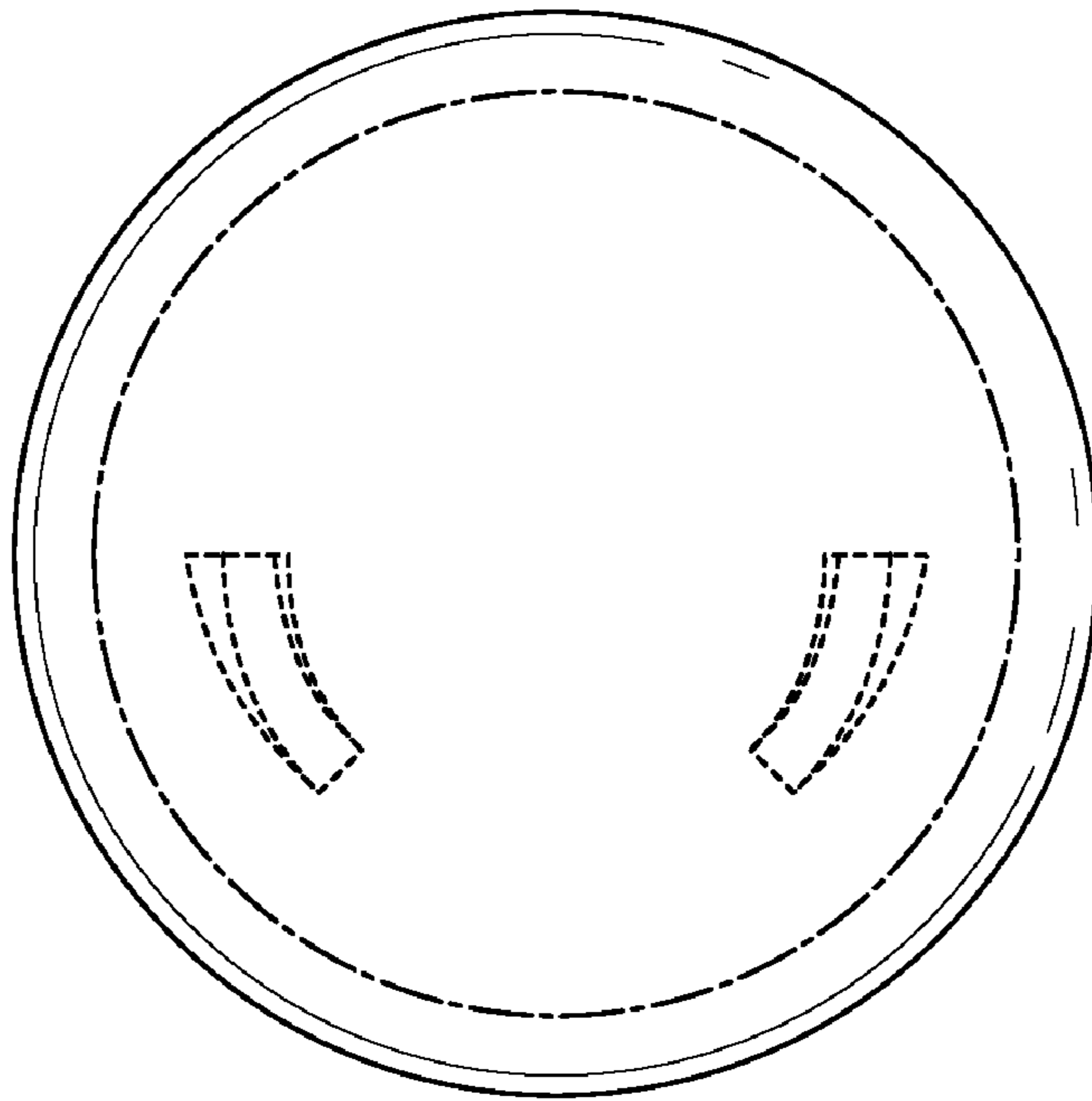

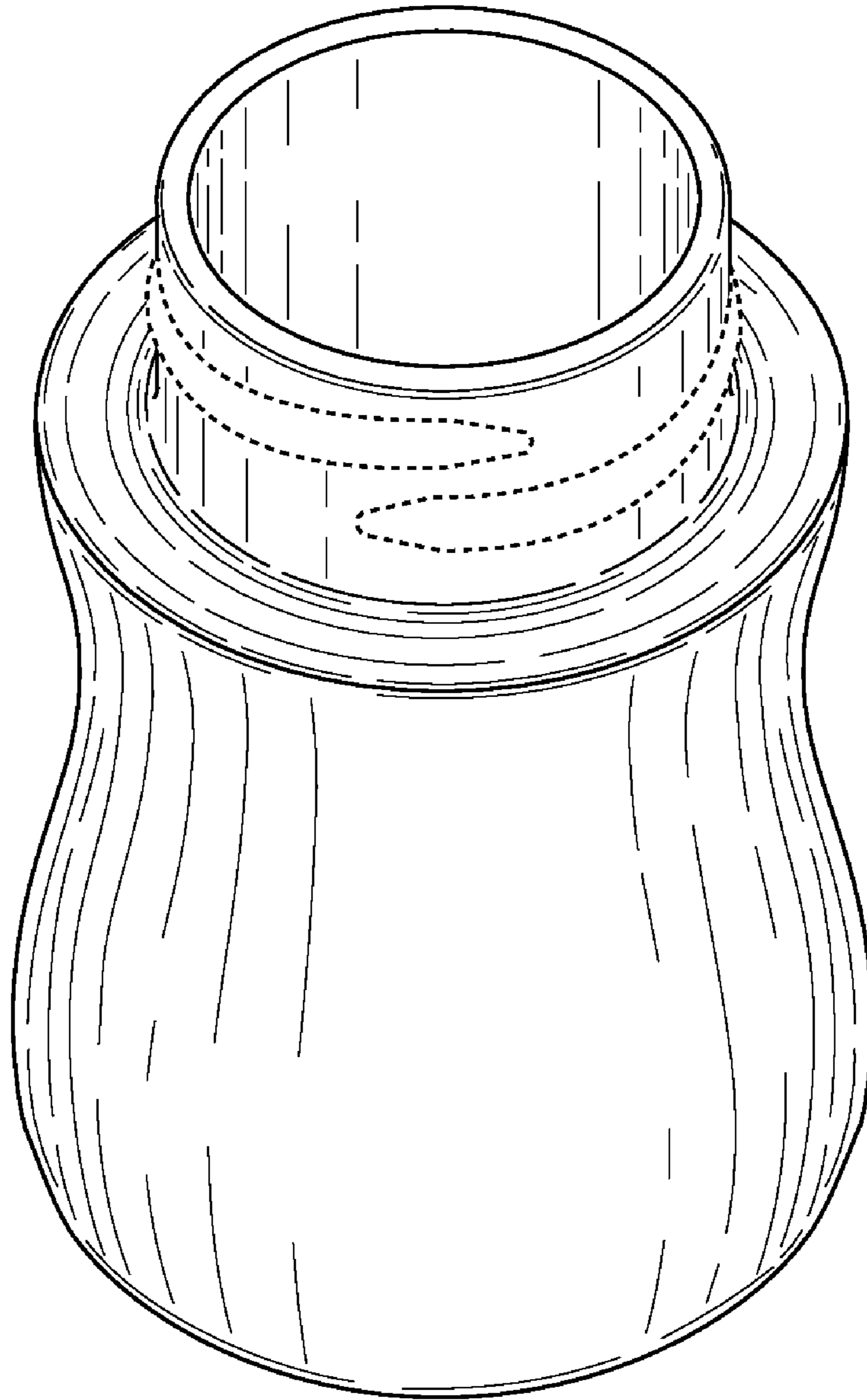

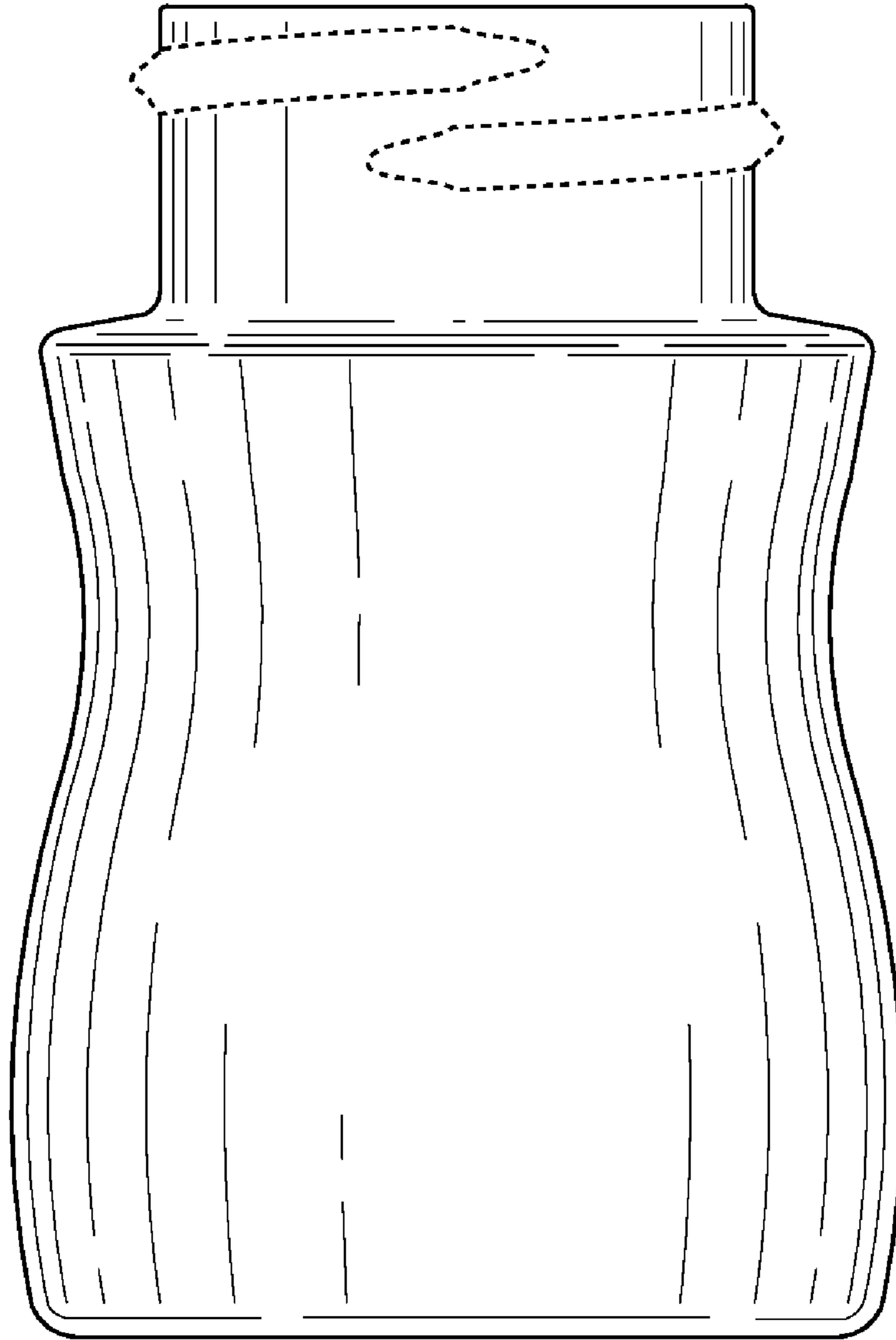

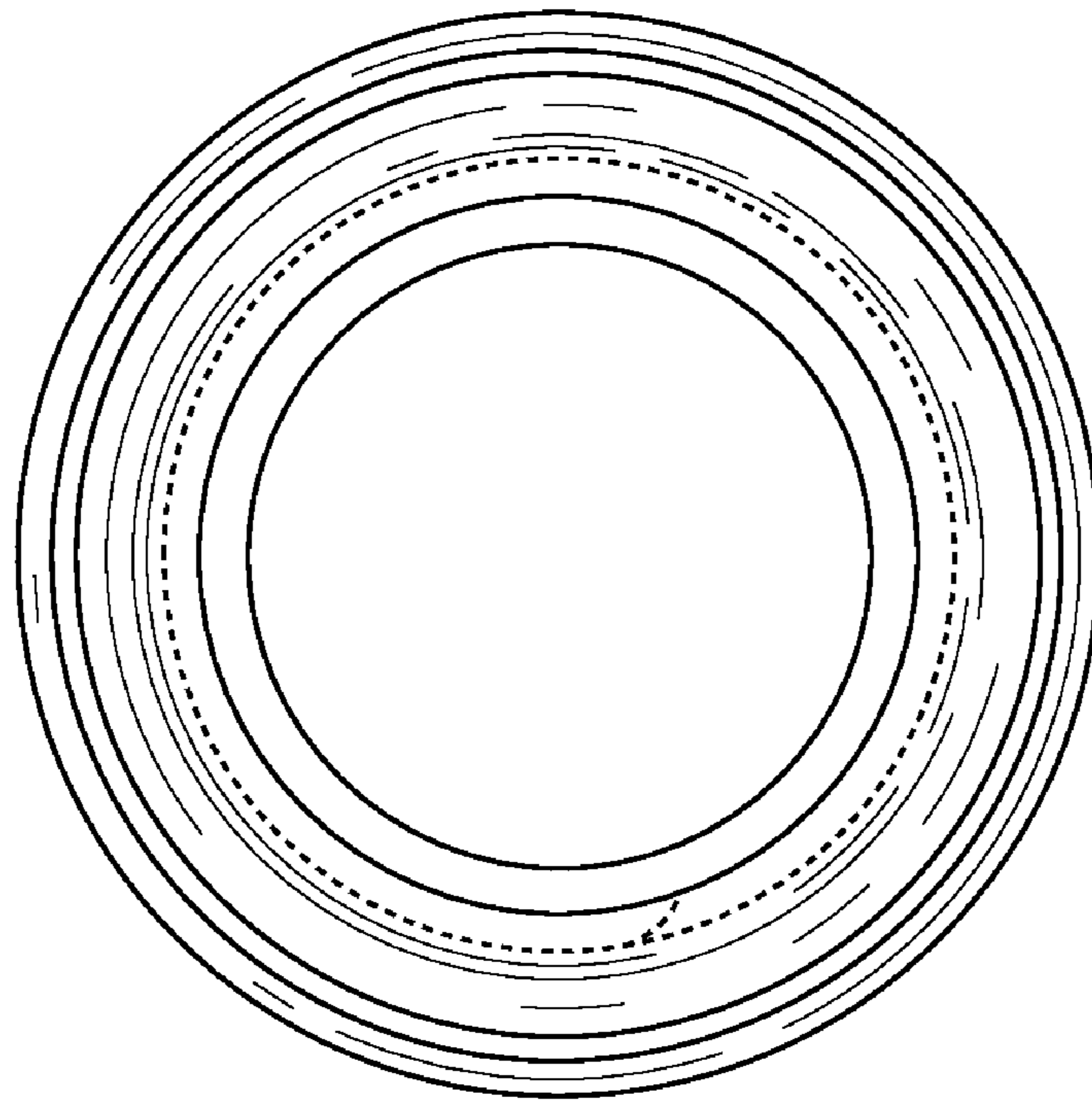
