The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a perfume bottle showing my new design;

FIG. 2 is a front view thereof, the rear view being the same thereof;

FIG. 3 is a side view thereof, the other side view being the same thereof;

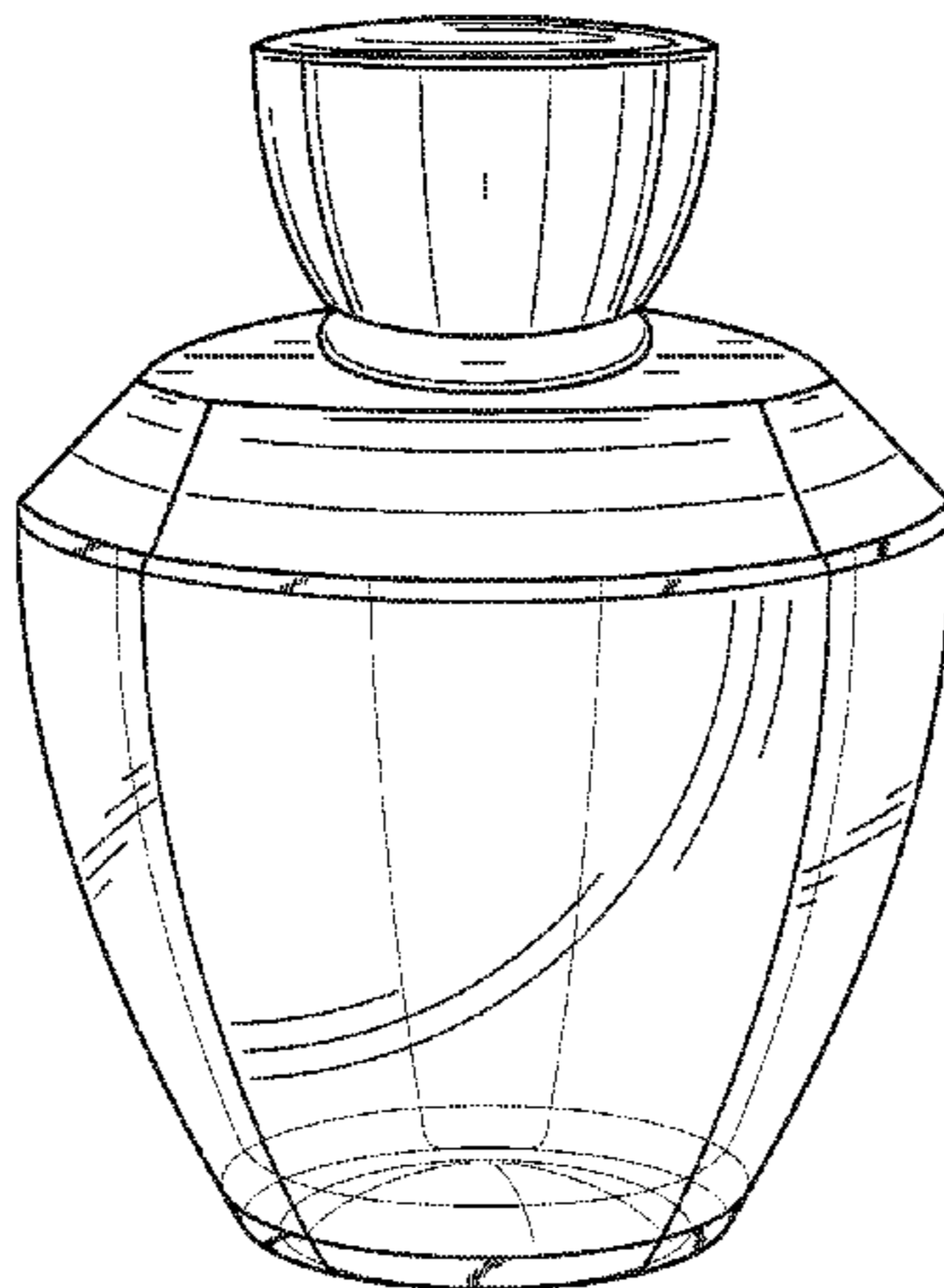
FIG. 4 is a right edge frontal view thereof, the rear view being the same thereof;

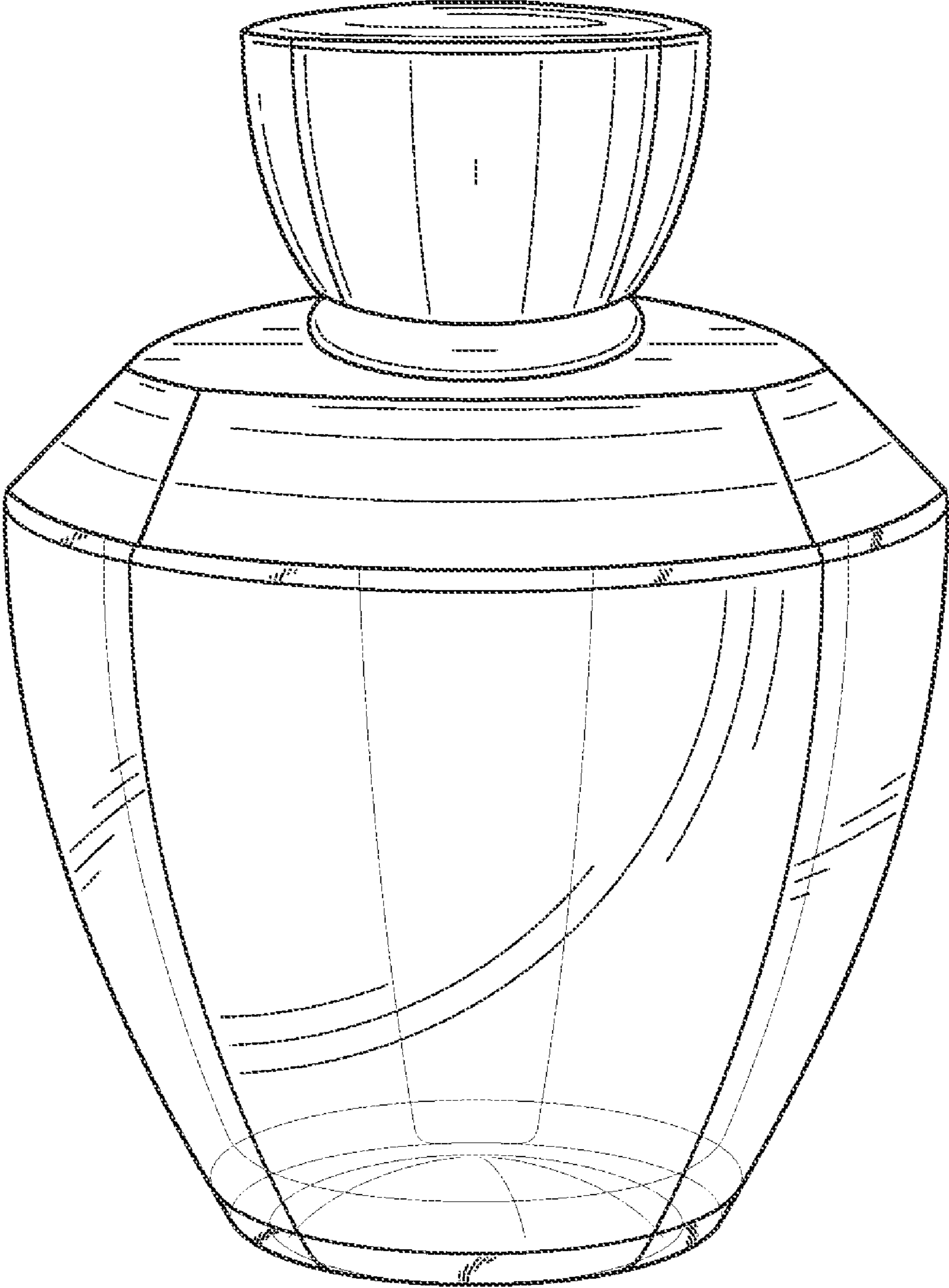

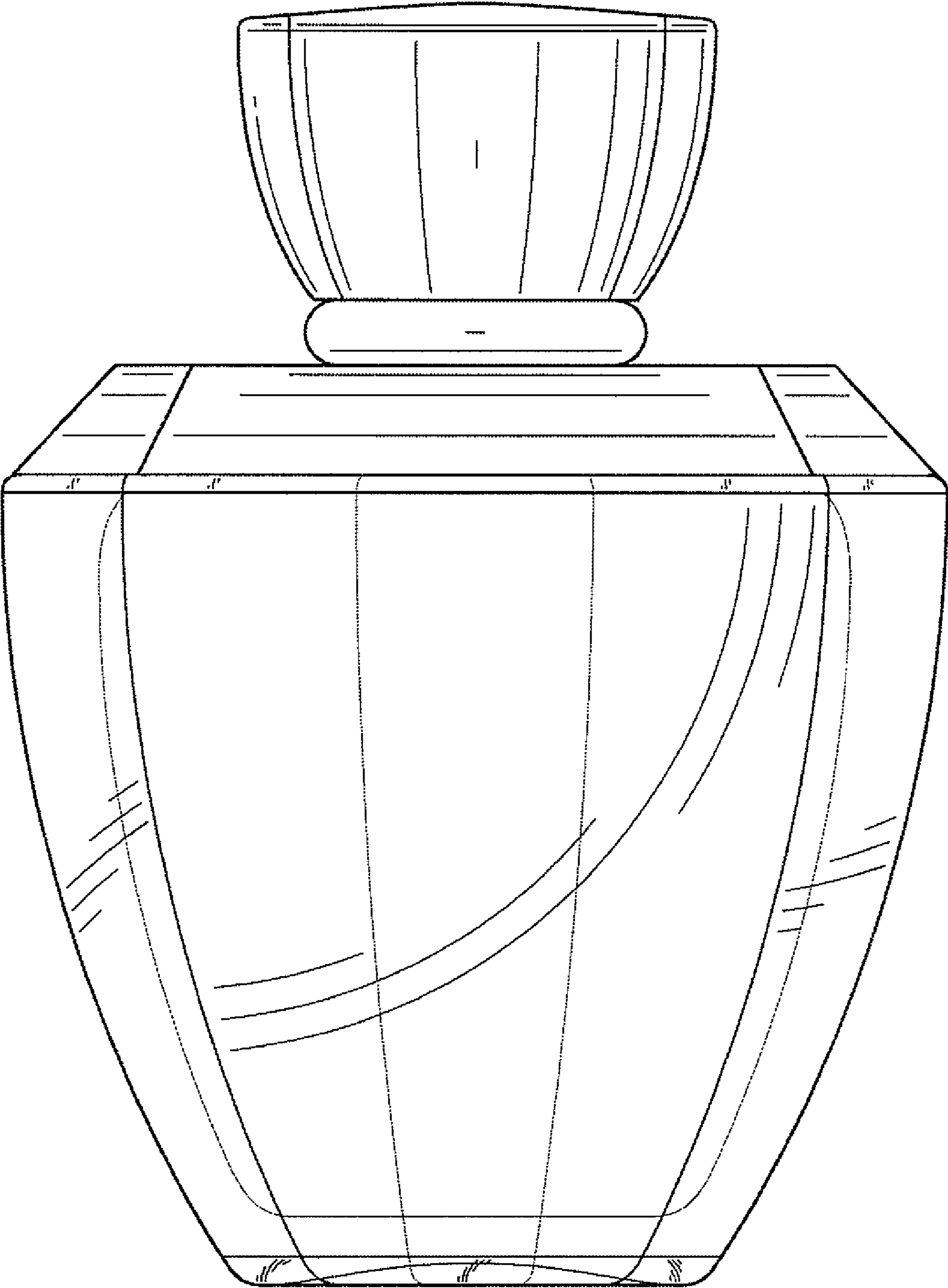

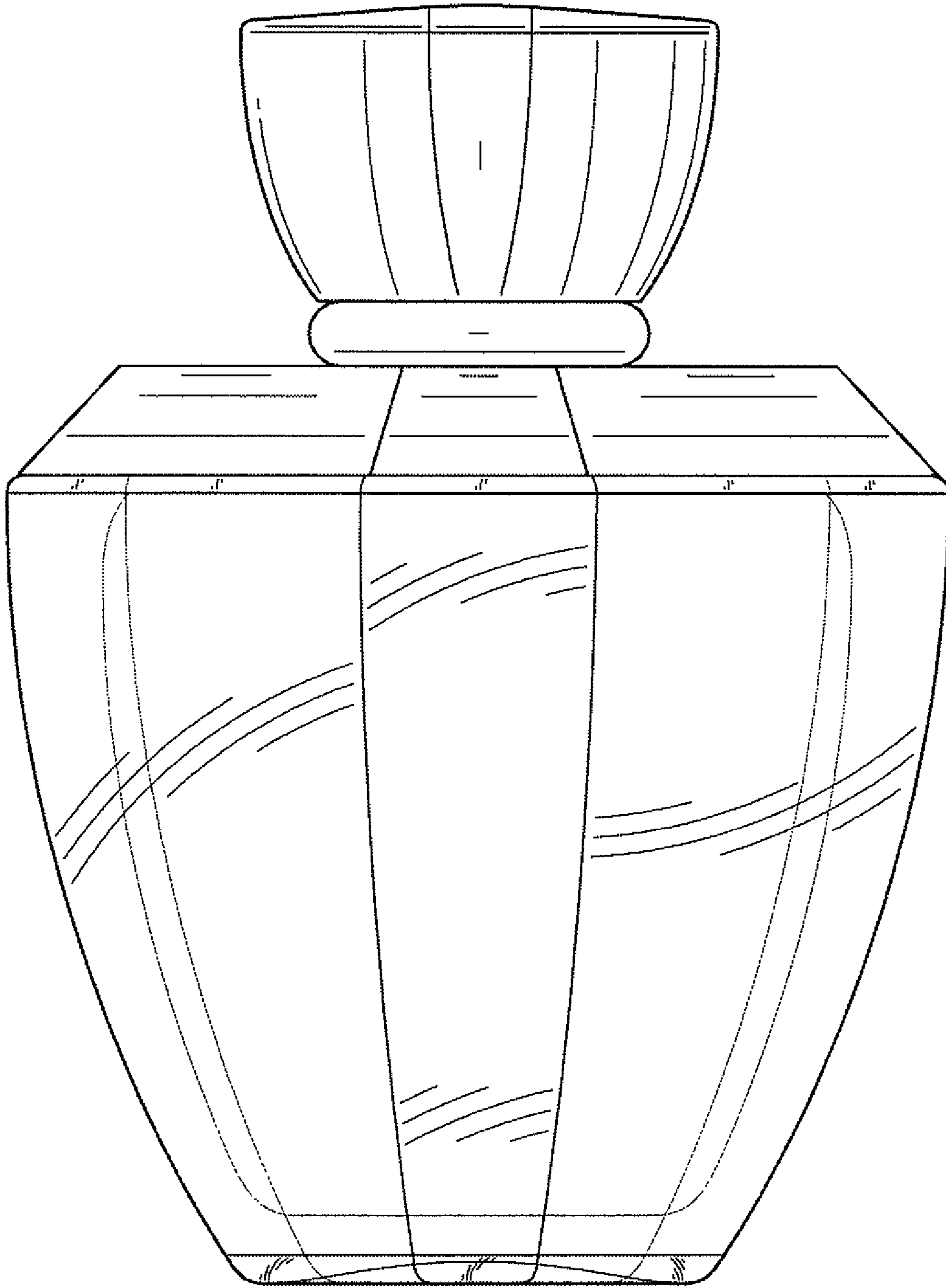

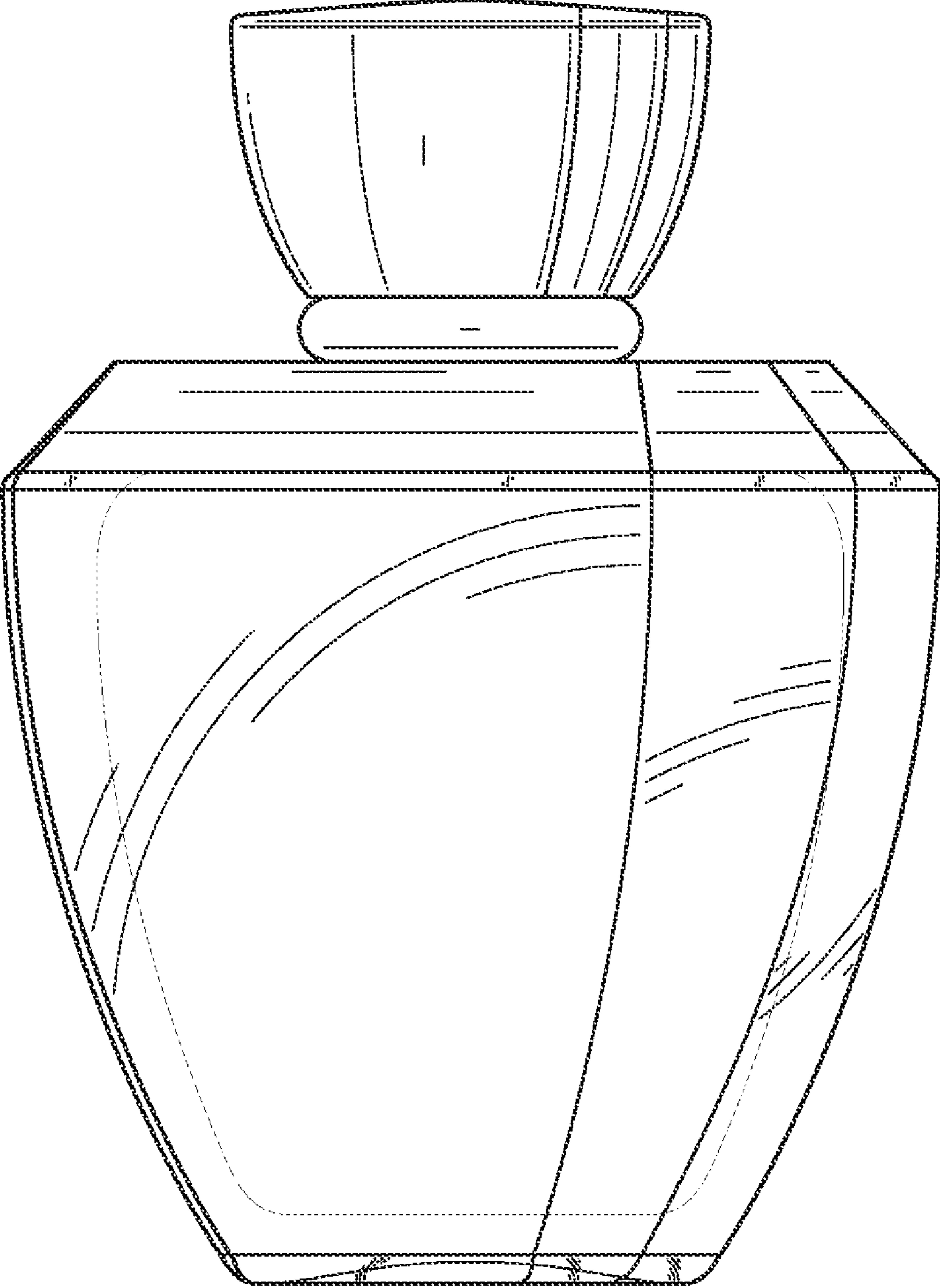

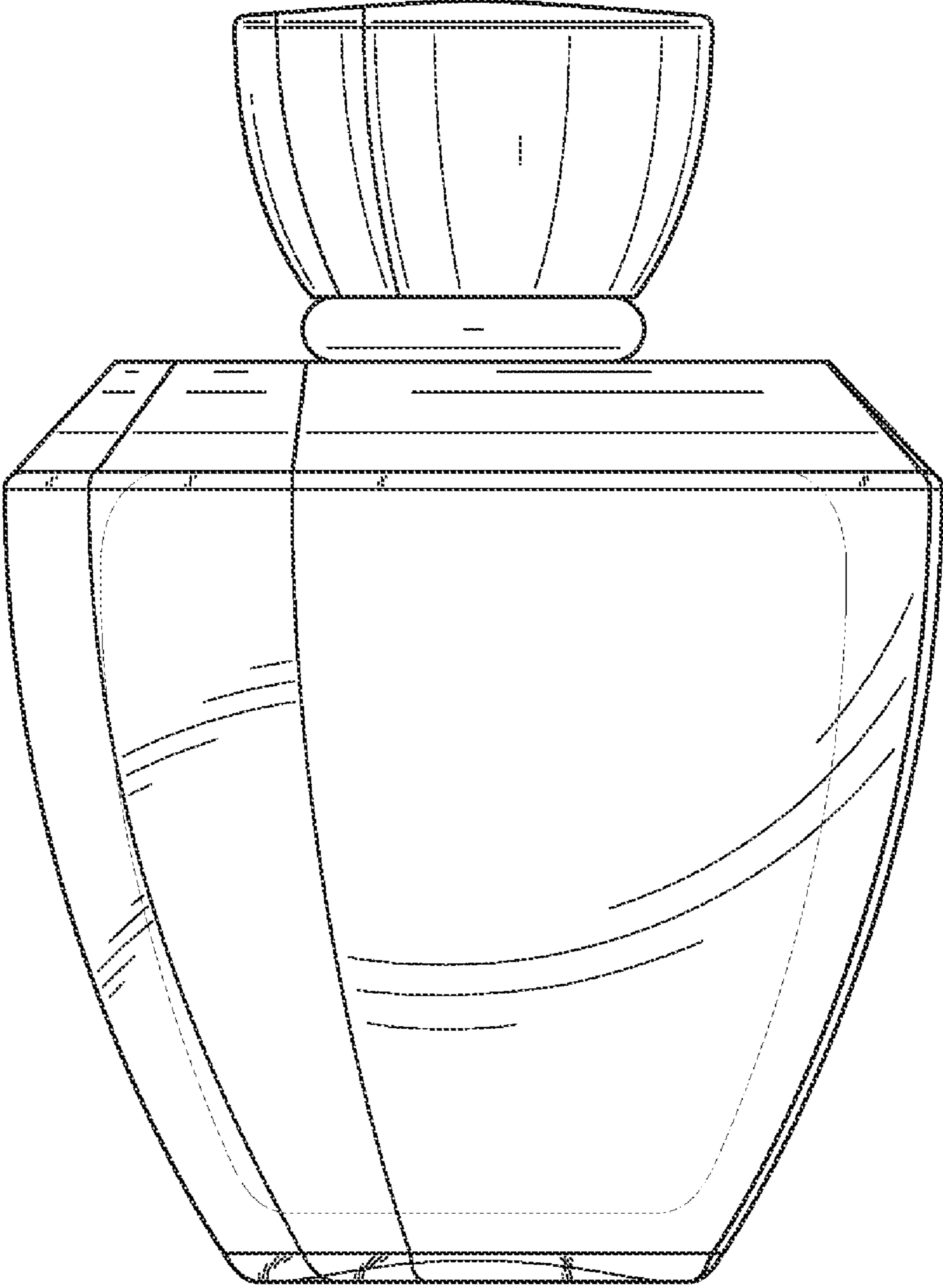

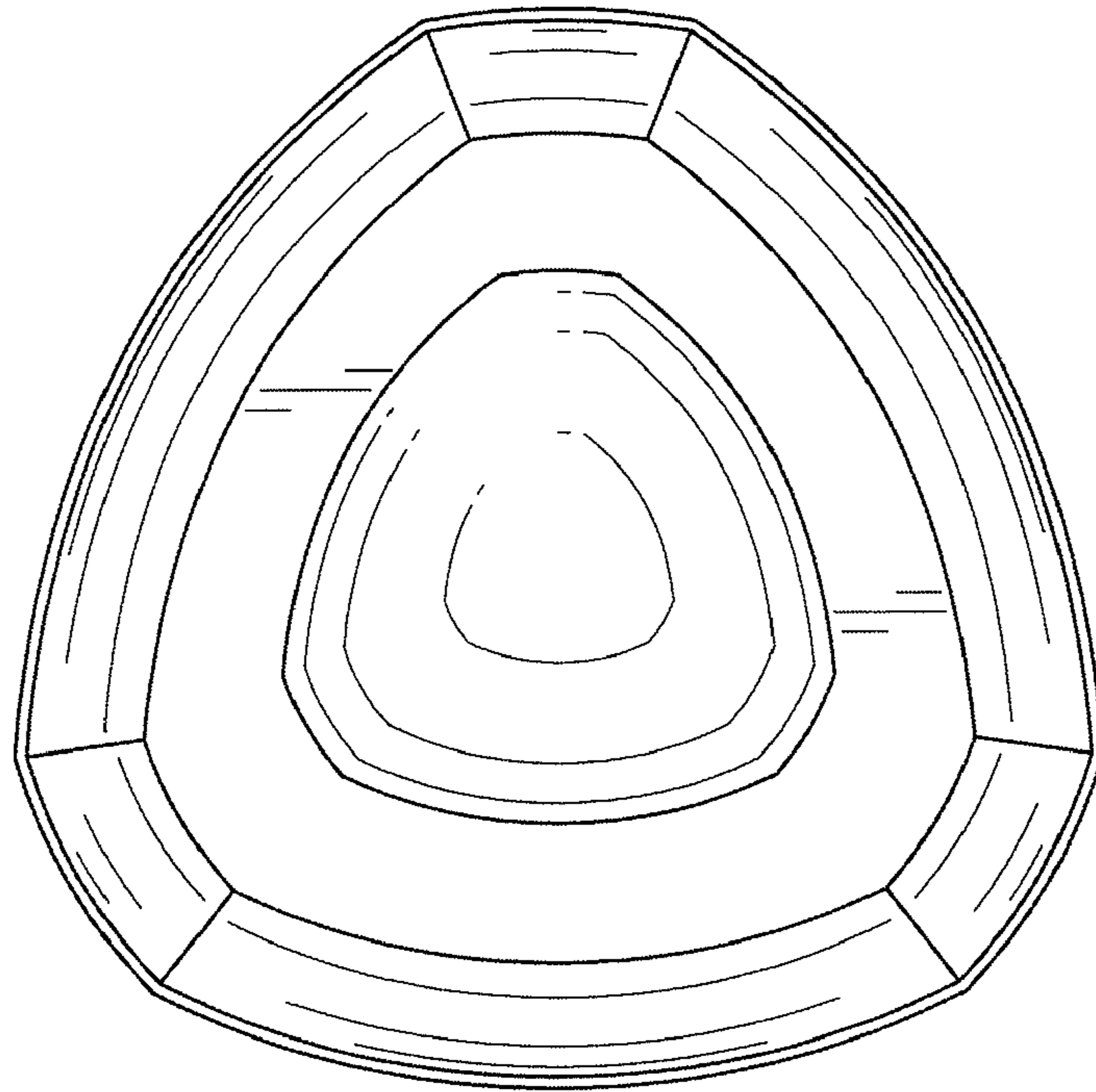

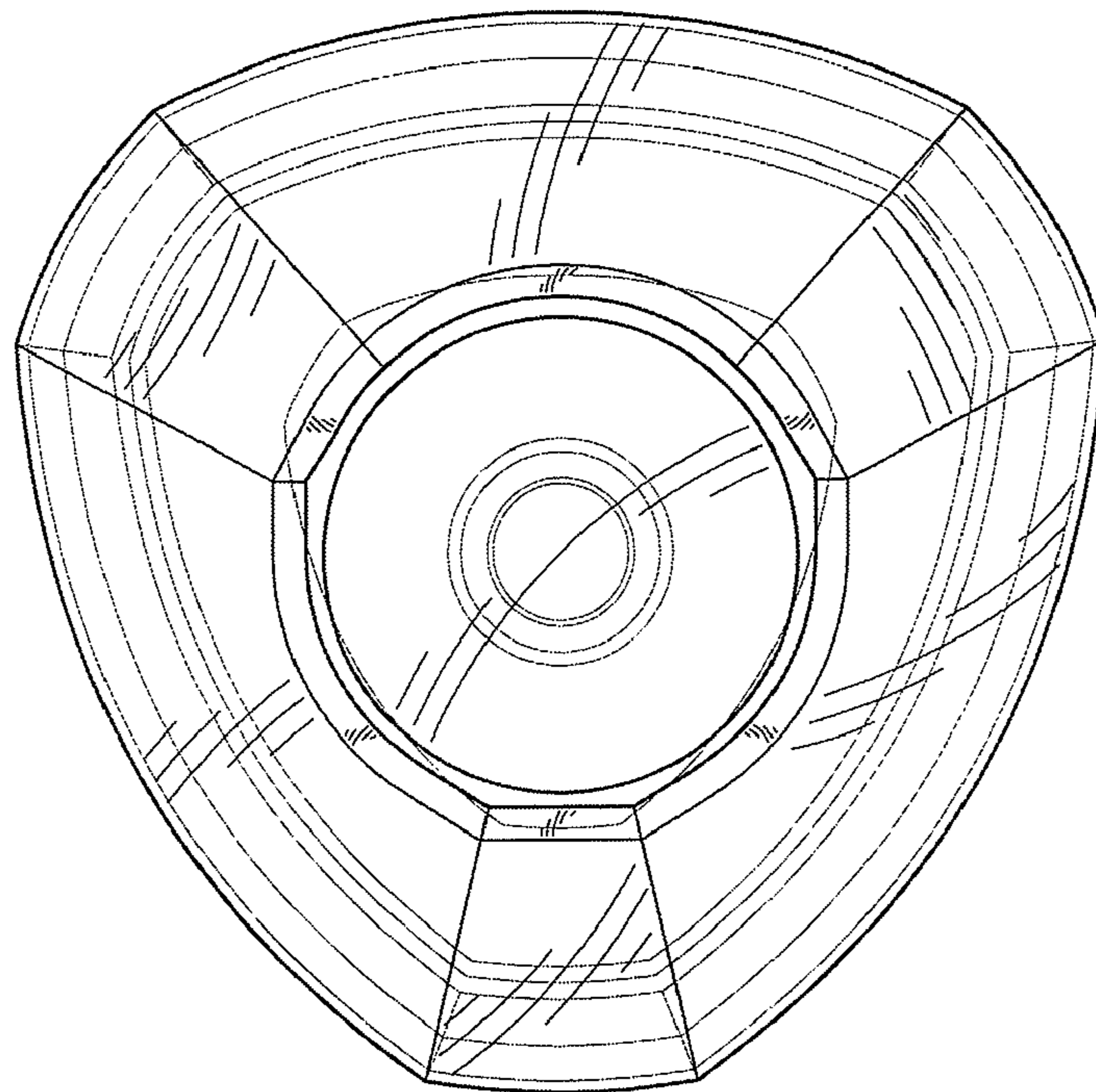
