(57) **CLAIM**

The ornamental design for a shirt and tie arranged in a box, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of a shirt and tie arranged in a box showing my new design;

FIG. 9 is a rear elevation view thereof;

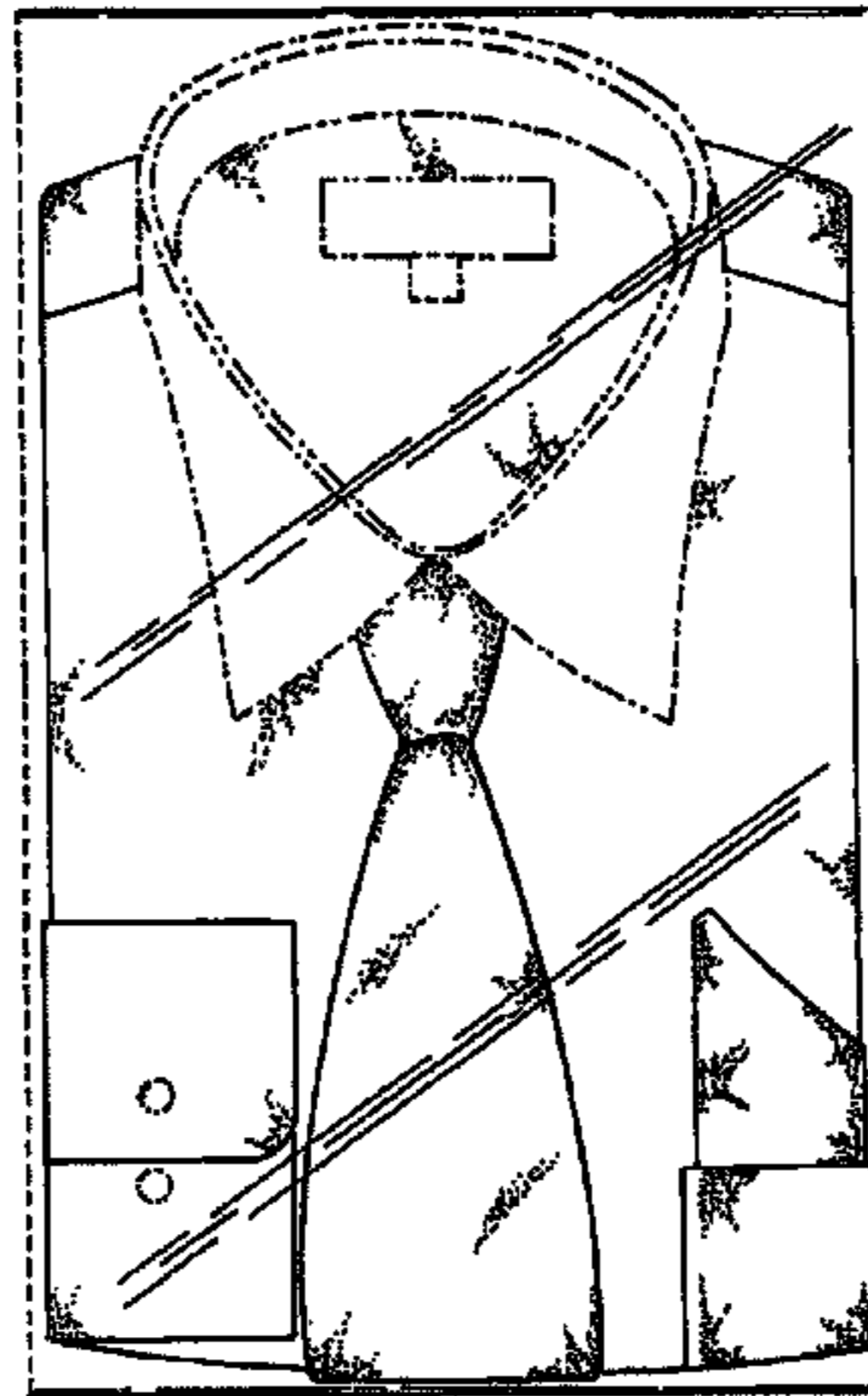
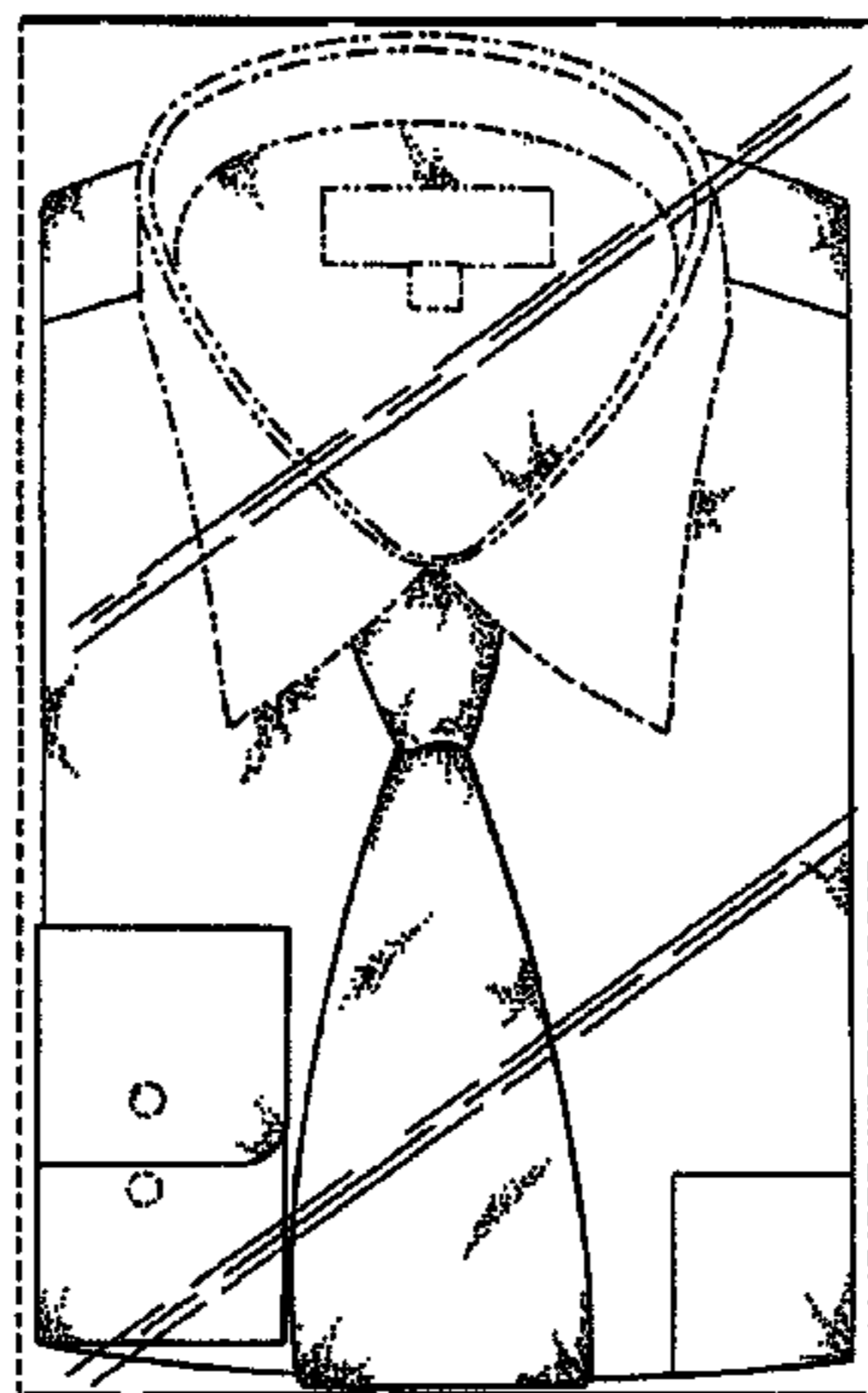
FIG. 10 is a bottom plan thereof;

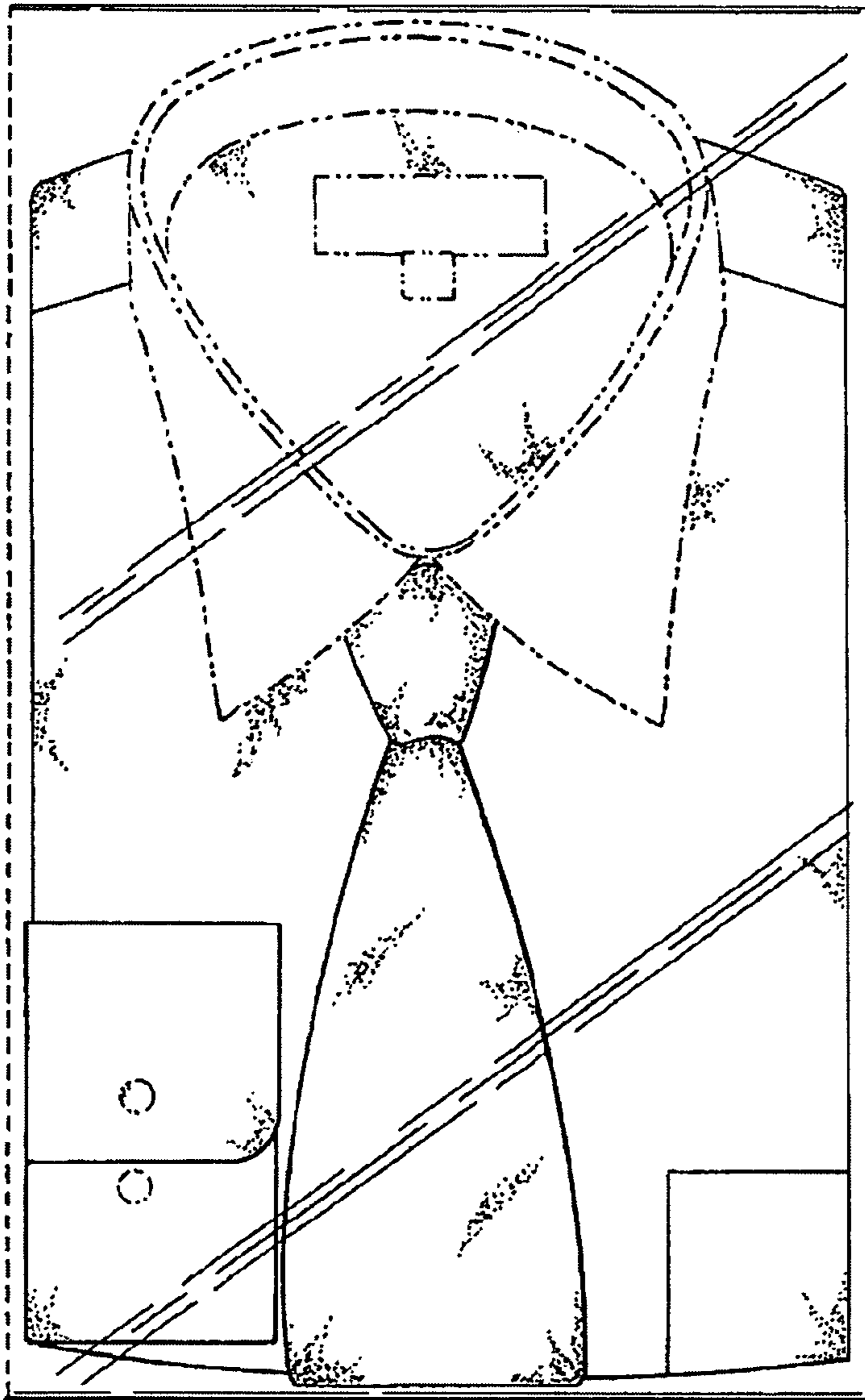

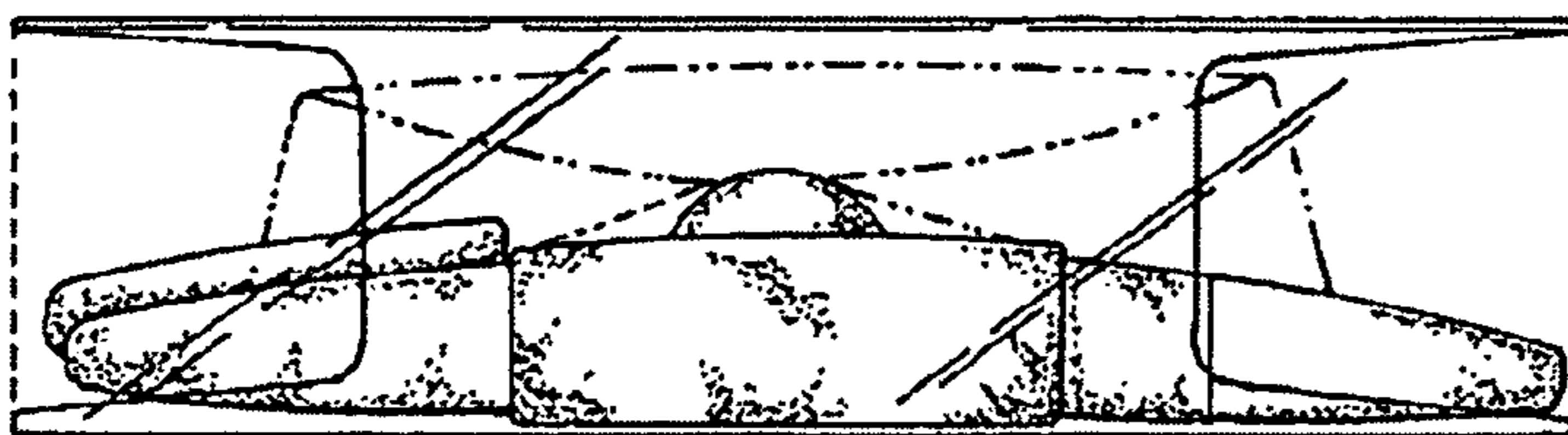

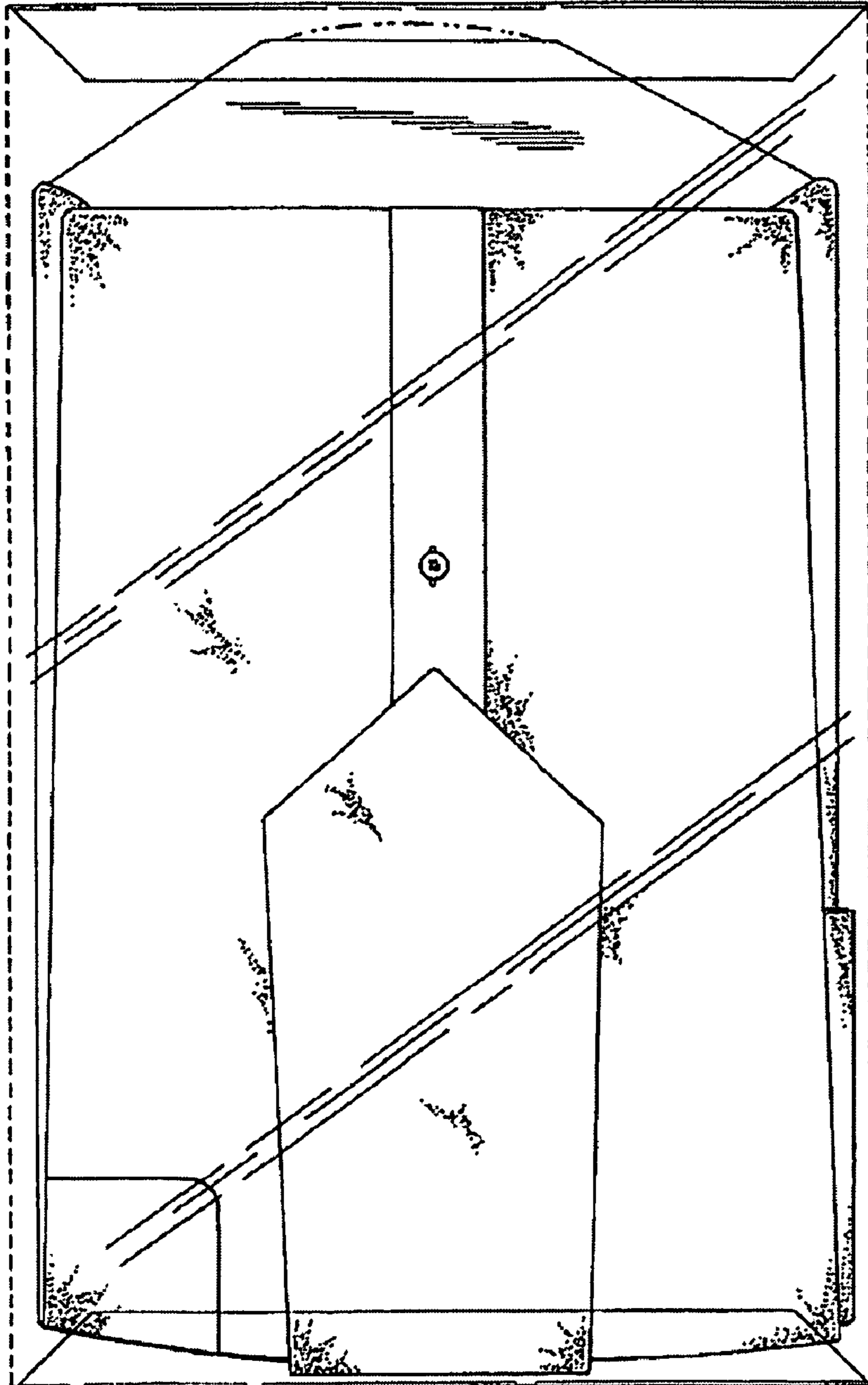

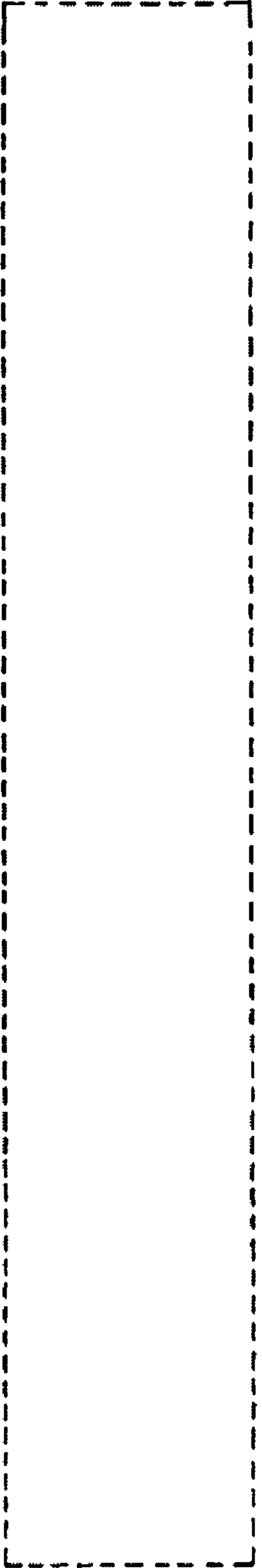

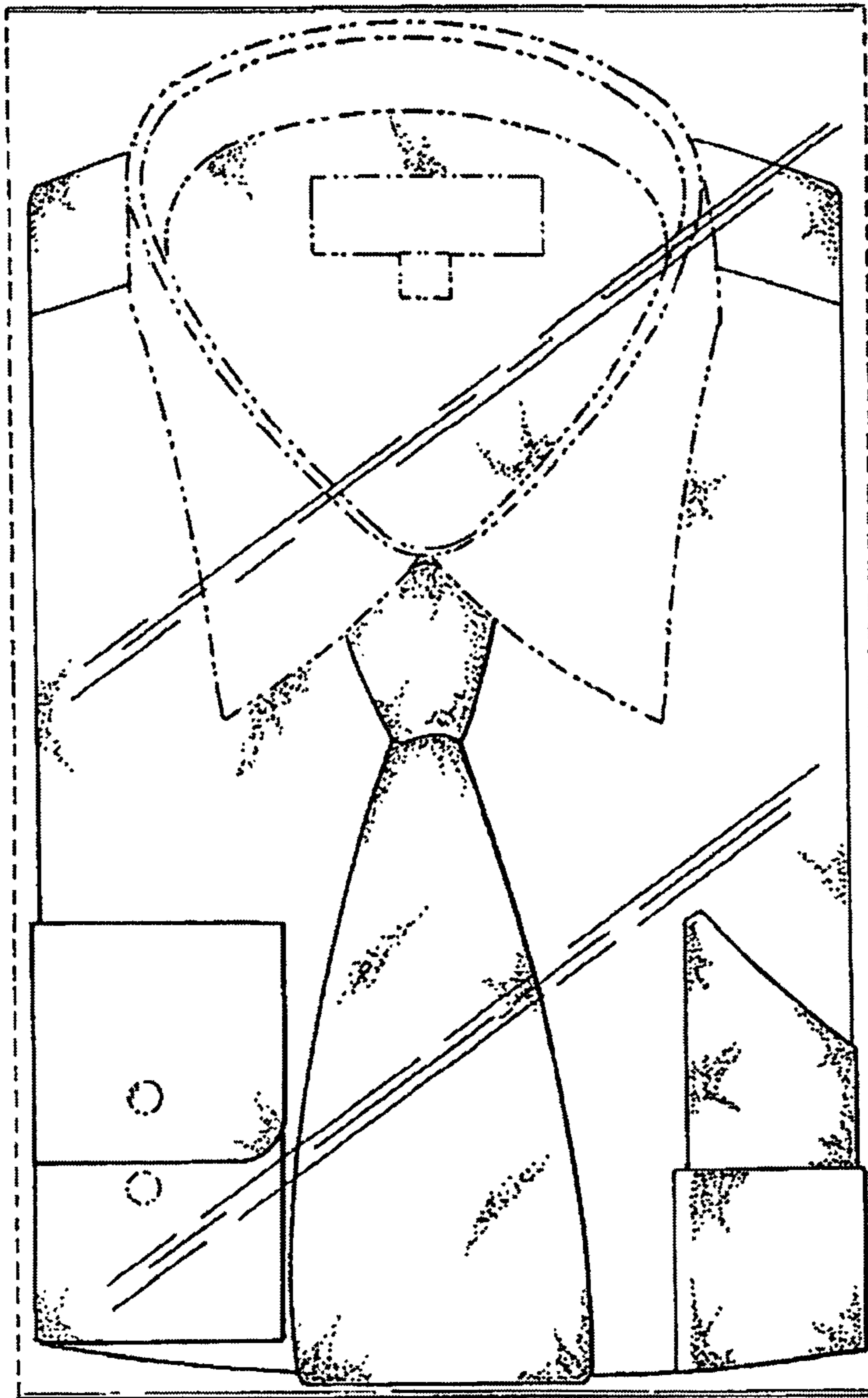

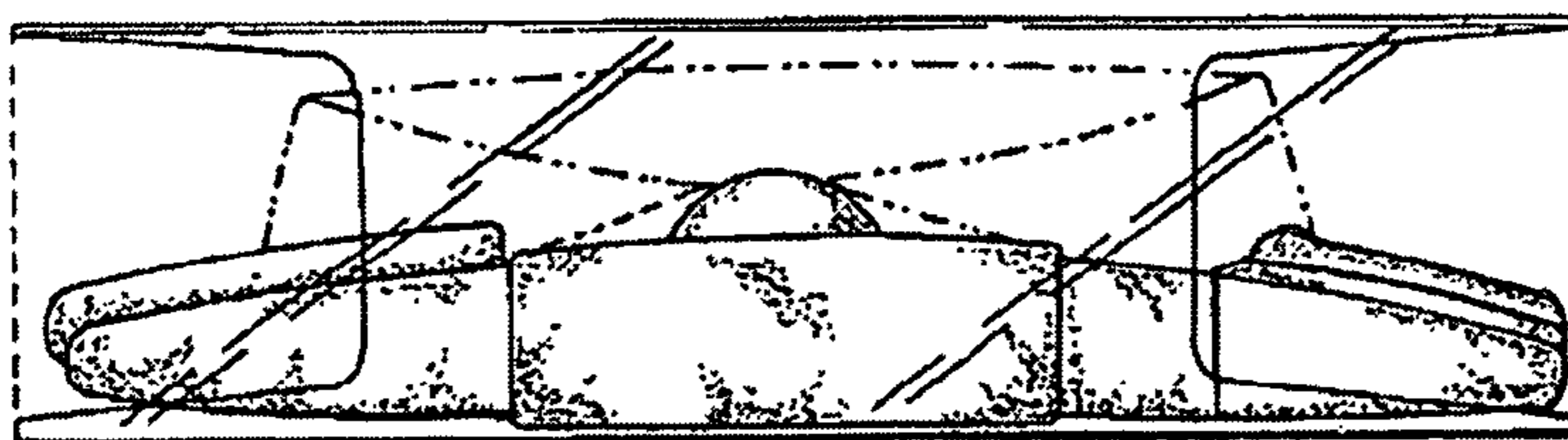

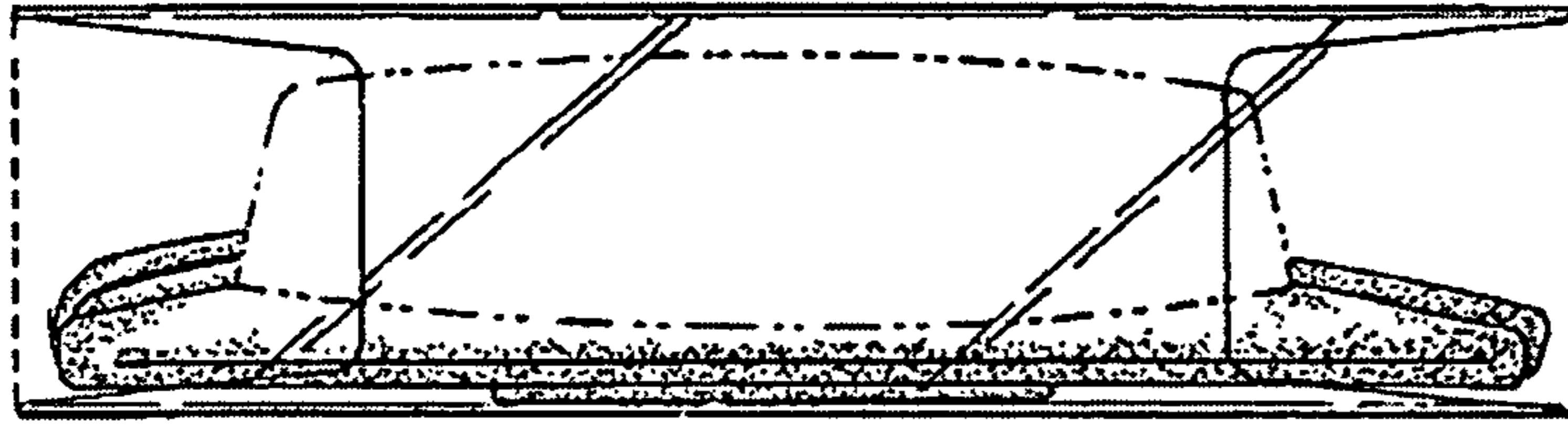

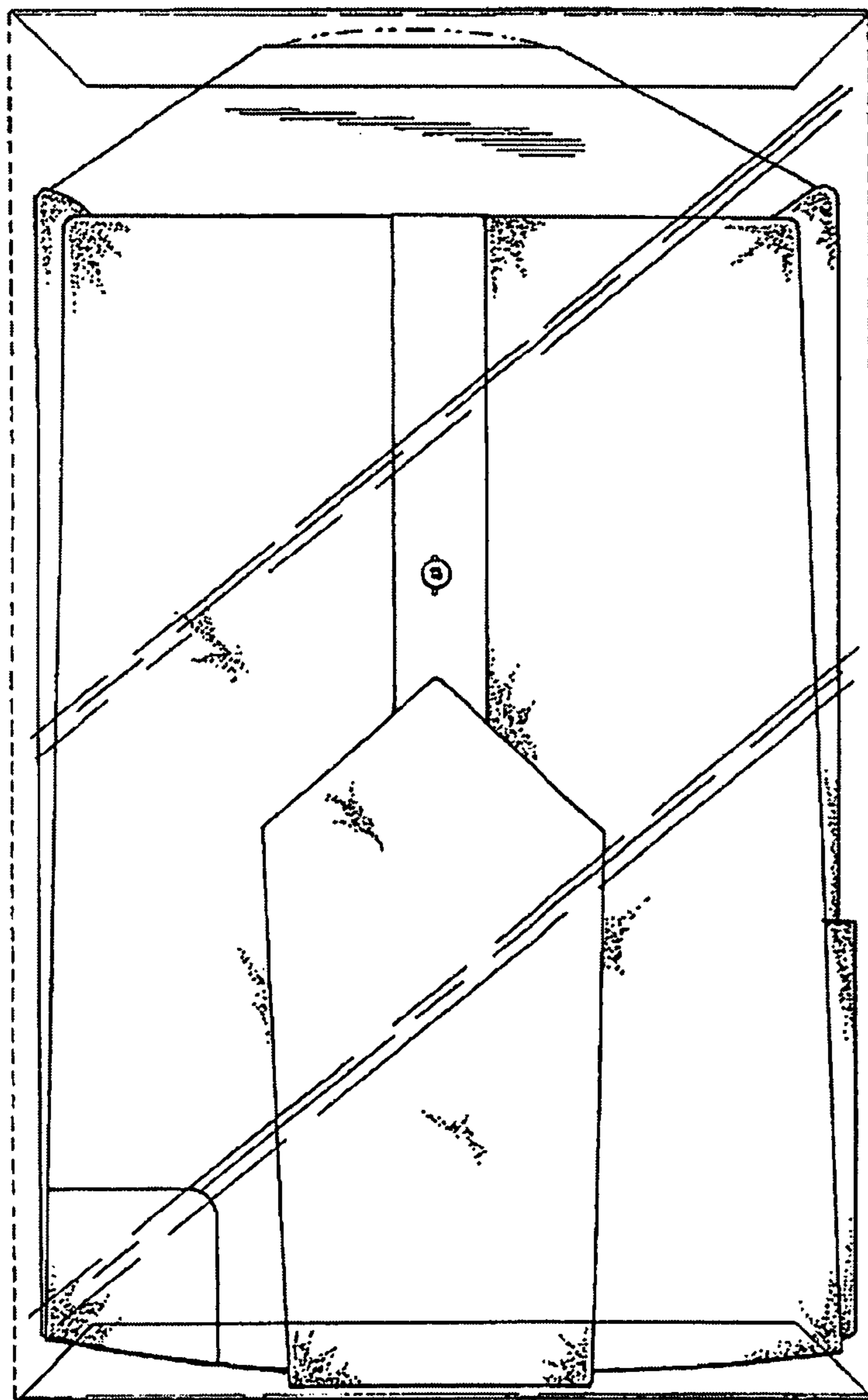

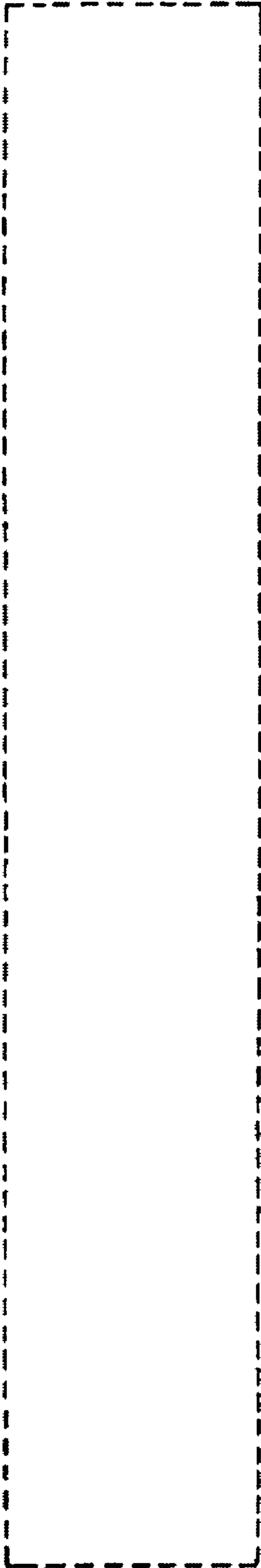

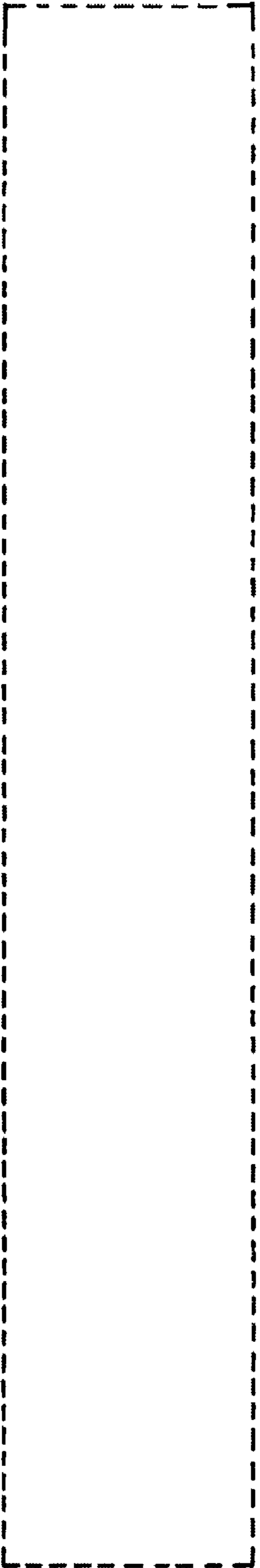
