(57) **CLAIM**

We claim the ornamental design for a sensor assembly for a vehicle door, as shown and described.

**DESCRIPTION**

FIG. 1 is a top right perspective view of the sensor assembly for a vehicle door;

FIG. 2 is a top left perspective view thereof;

FIG. 3 is a bottom left perspective view thereof;

FIG. 4 is a bottom right perspective view thereof;

FIG. 5 is a front view thereof;

FIG. 6 is a rear view thereof;

FIG. 9 is a top view thereof;

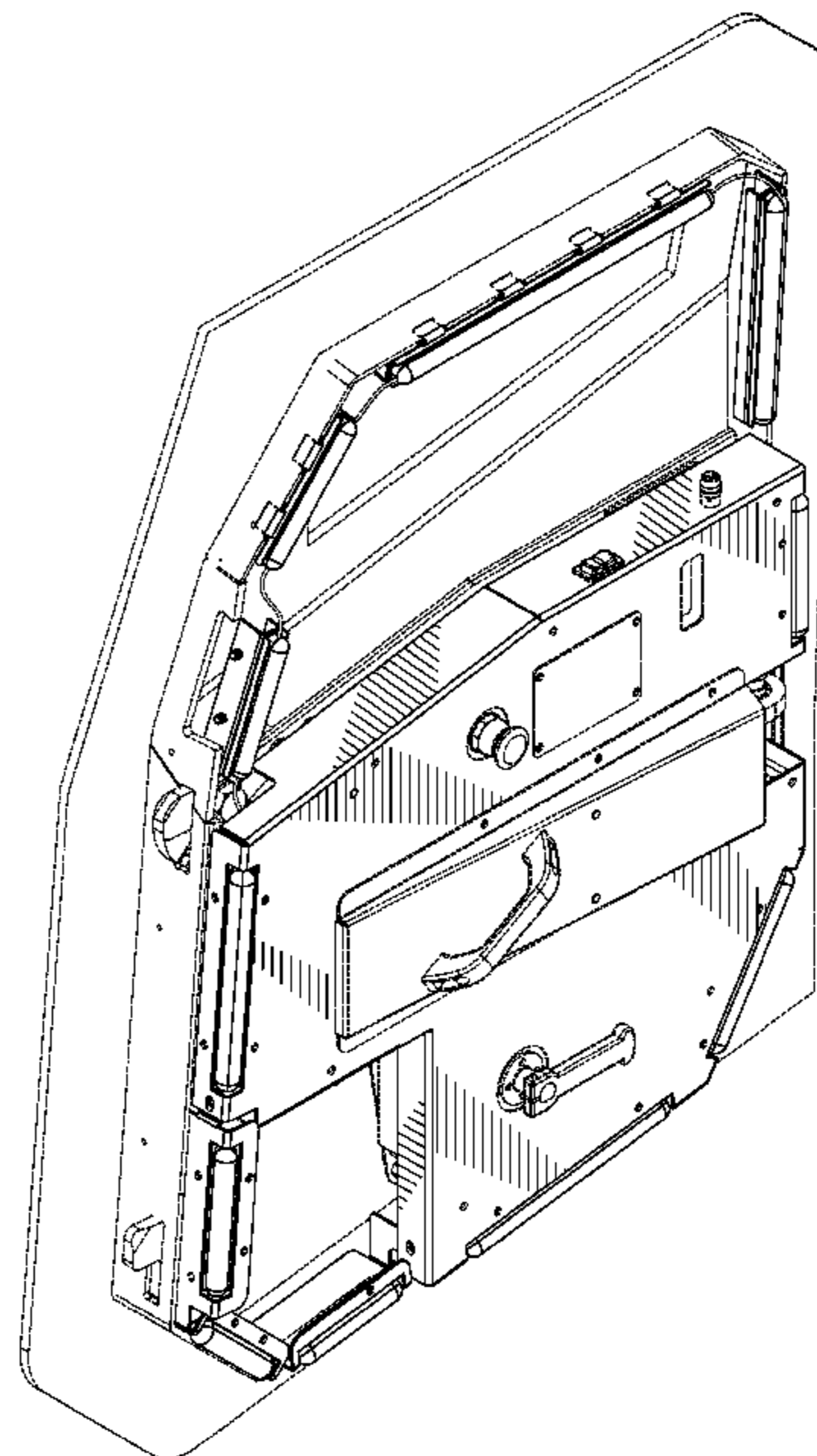
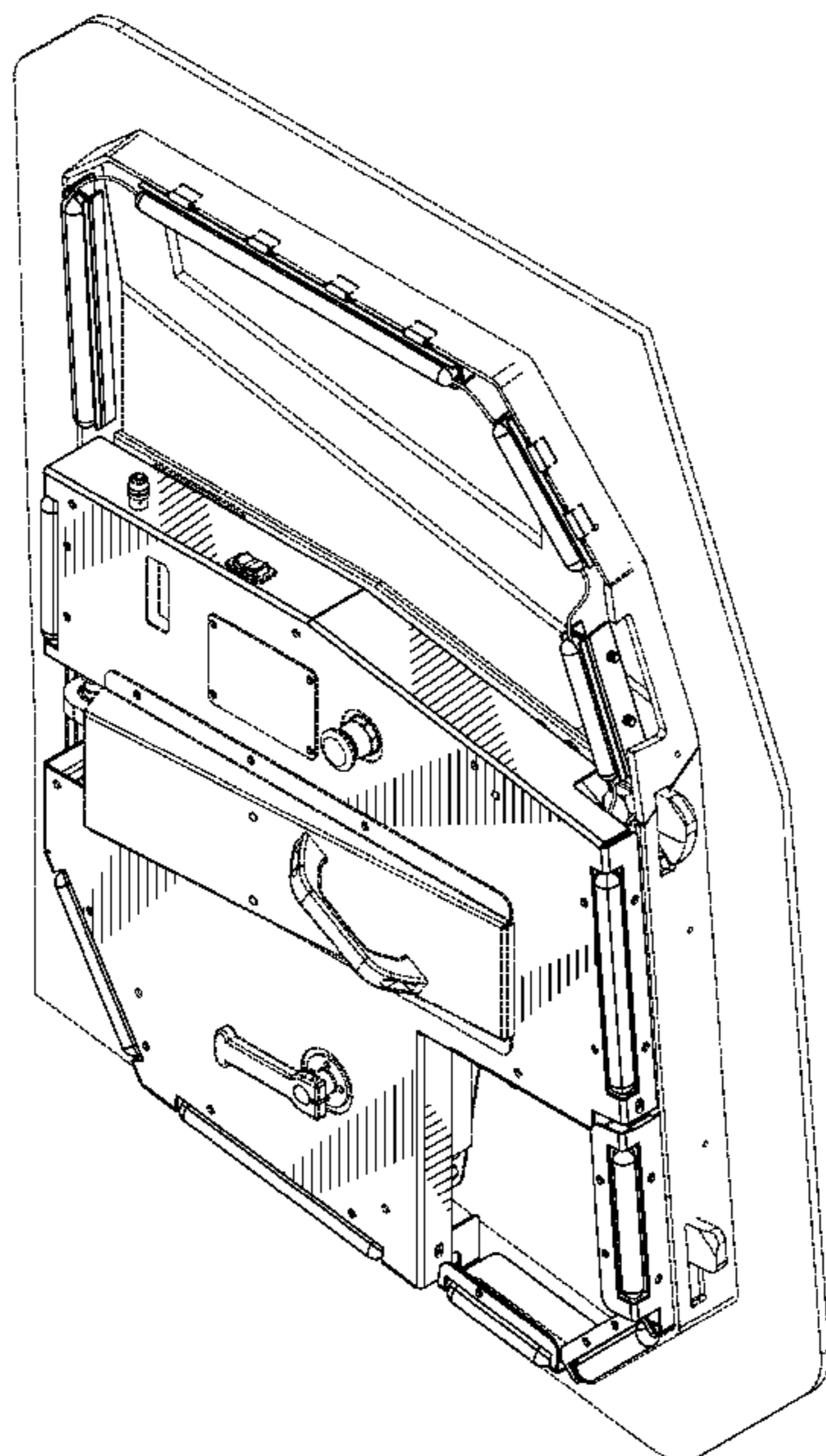
FIG. 10 is a bottom view thereof; and,

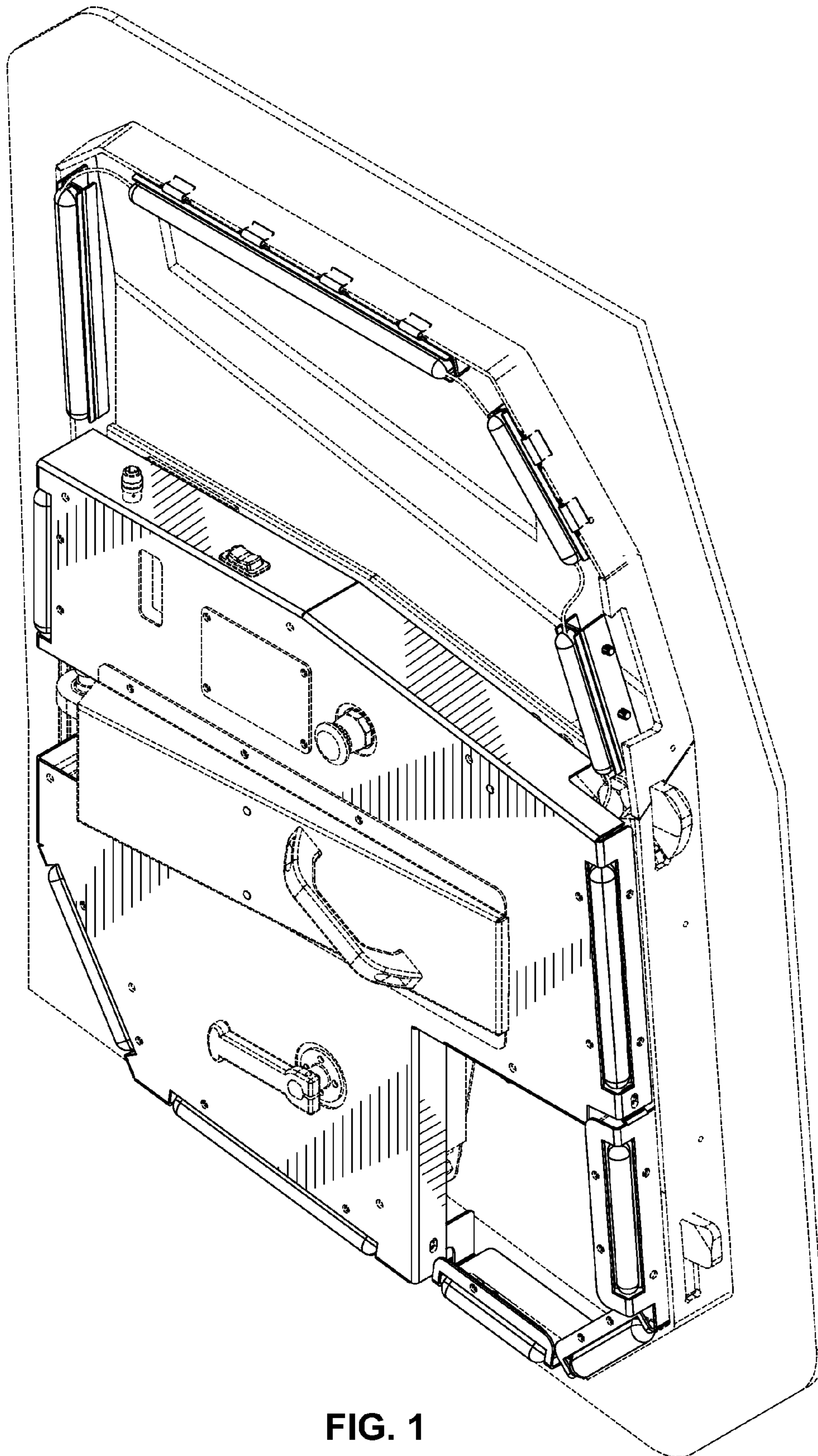

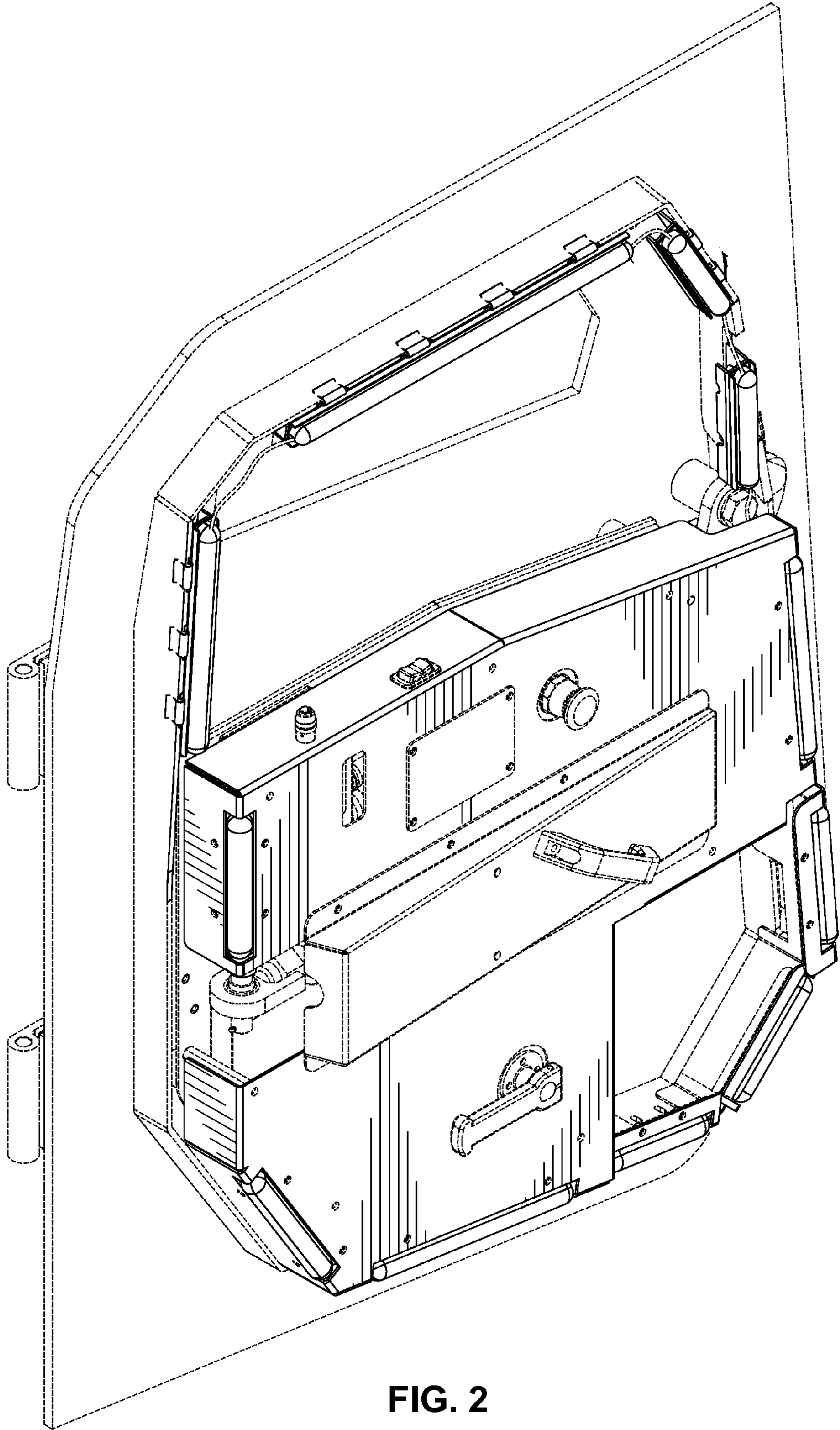

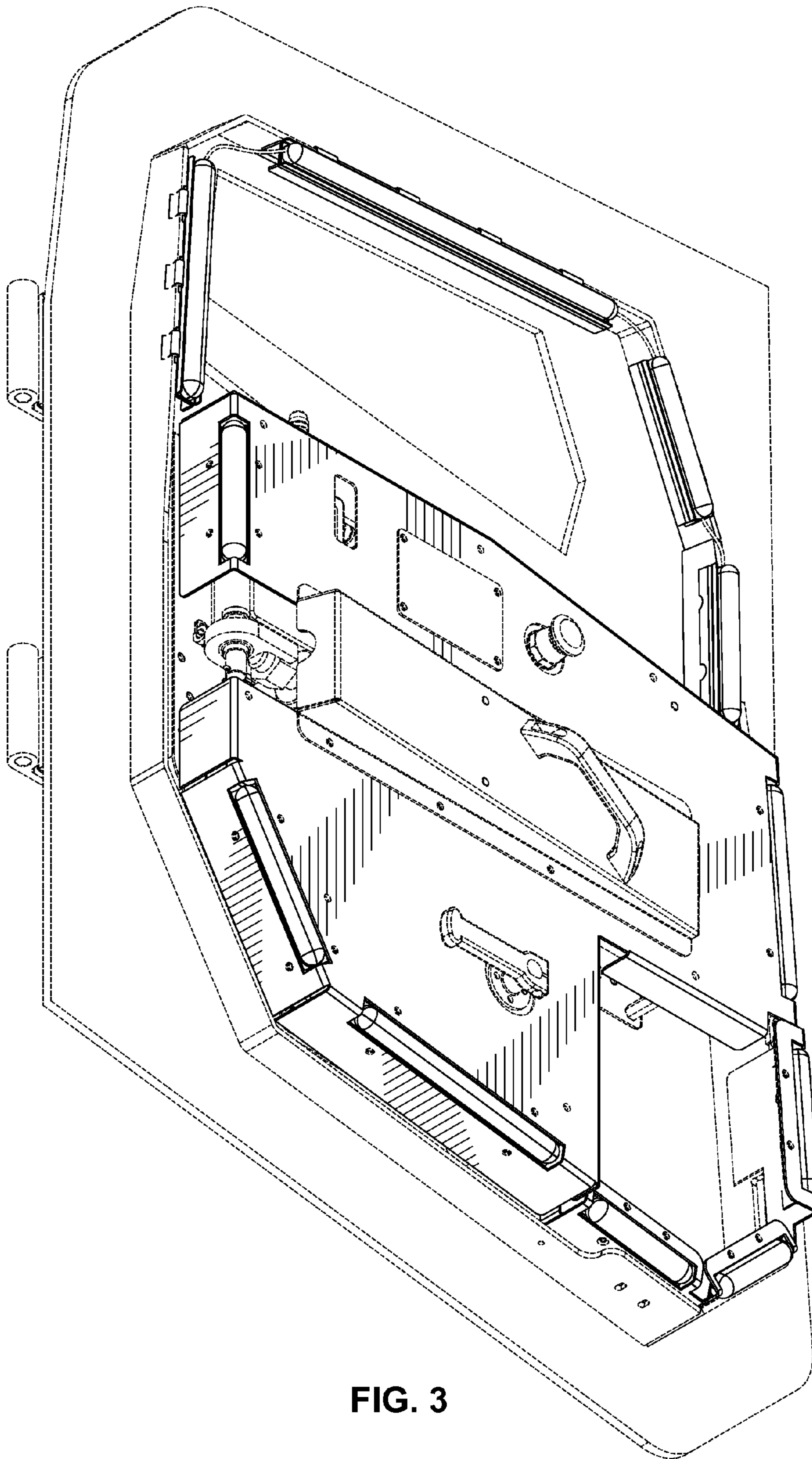

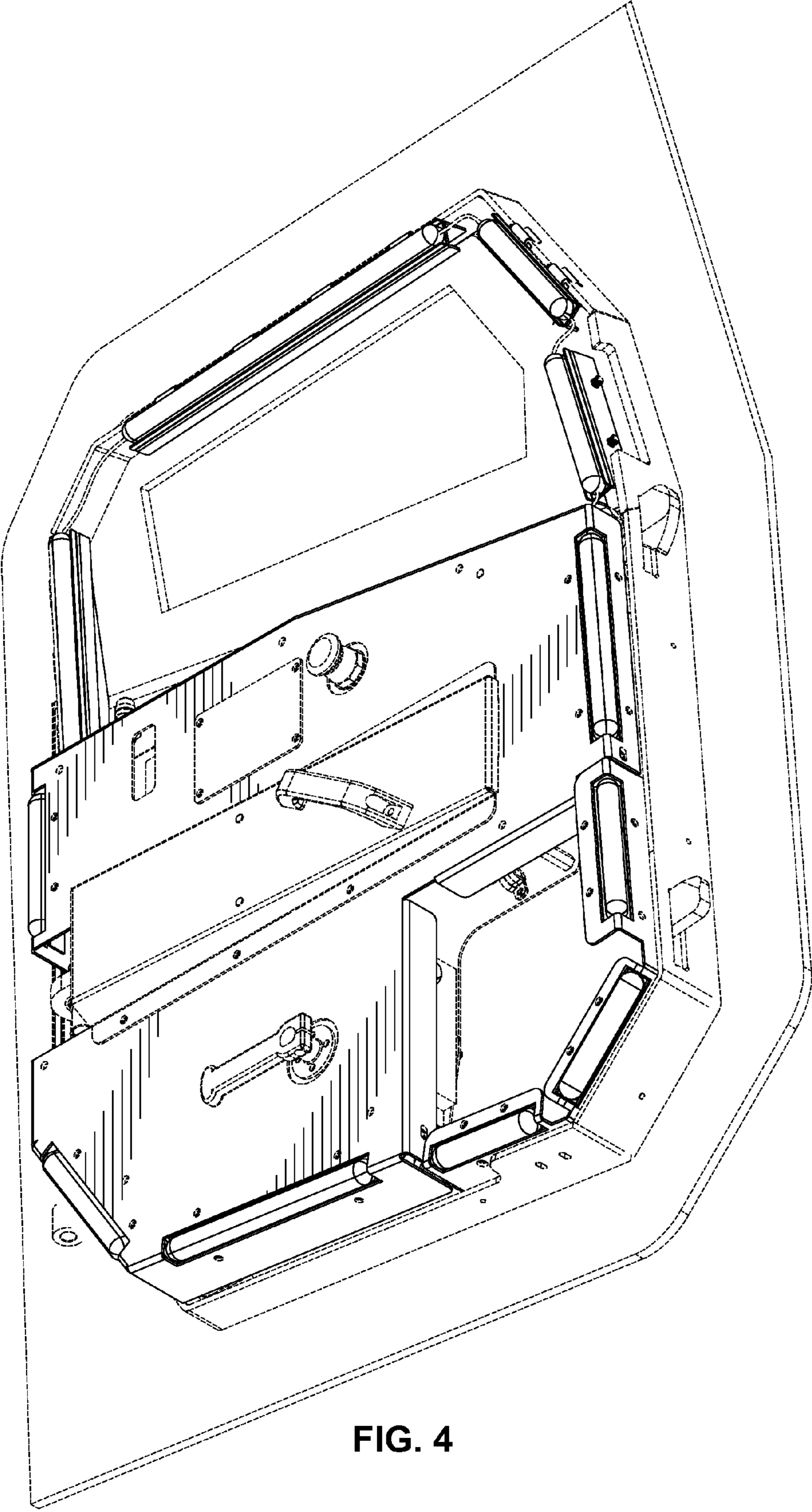

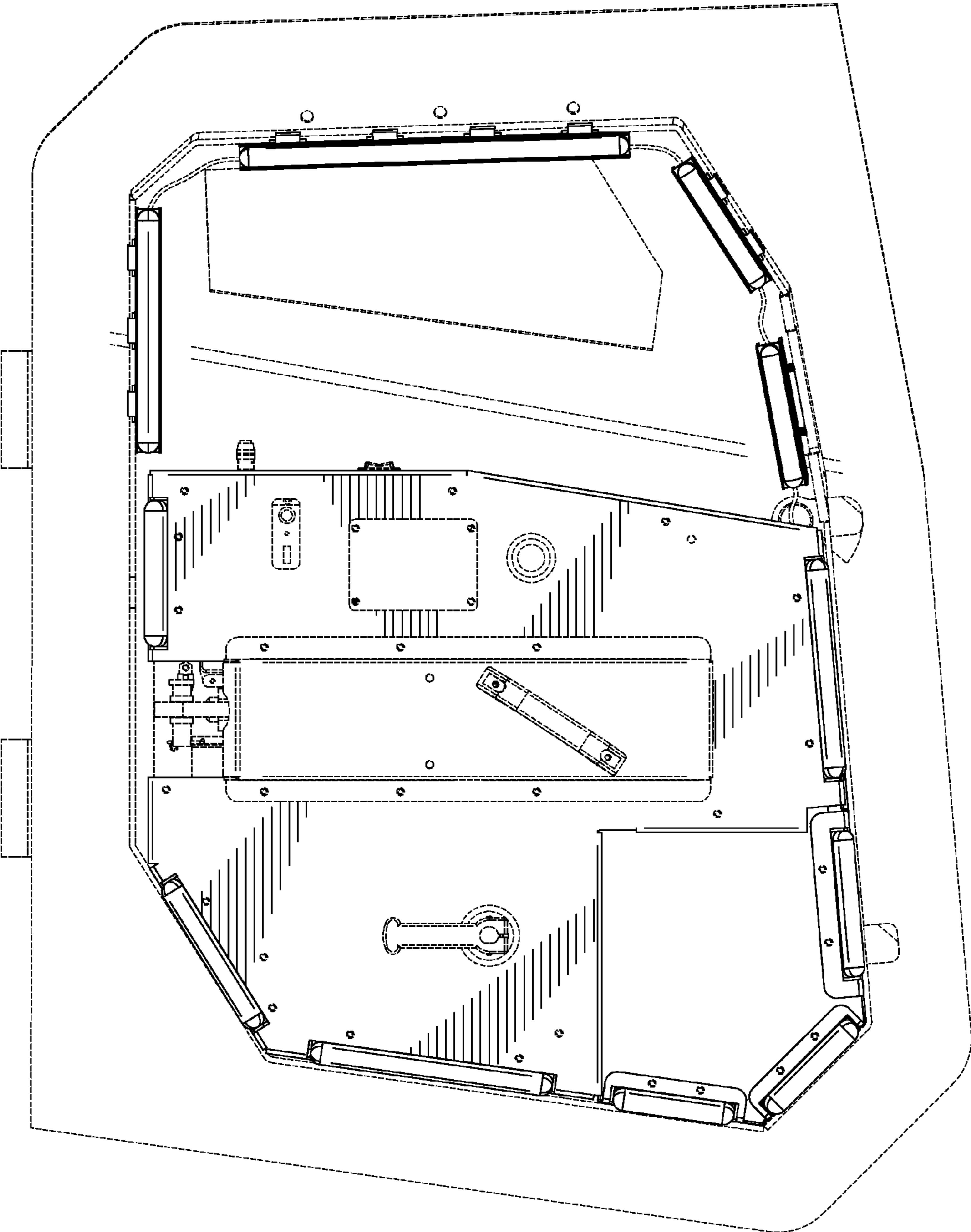

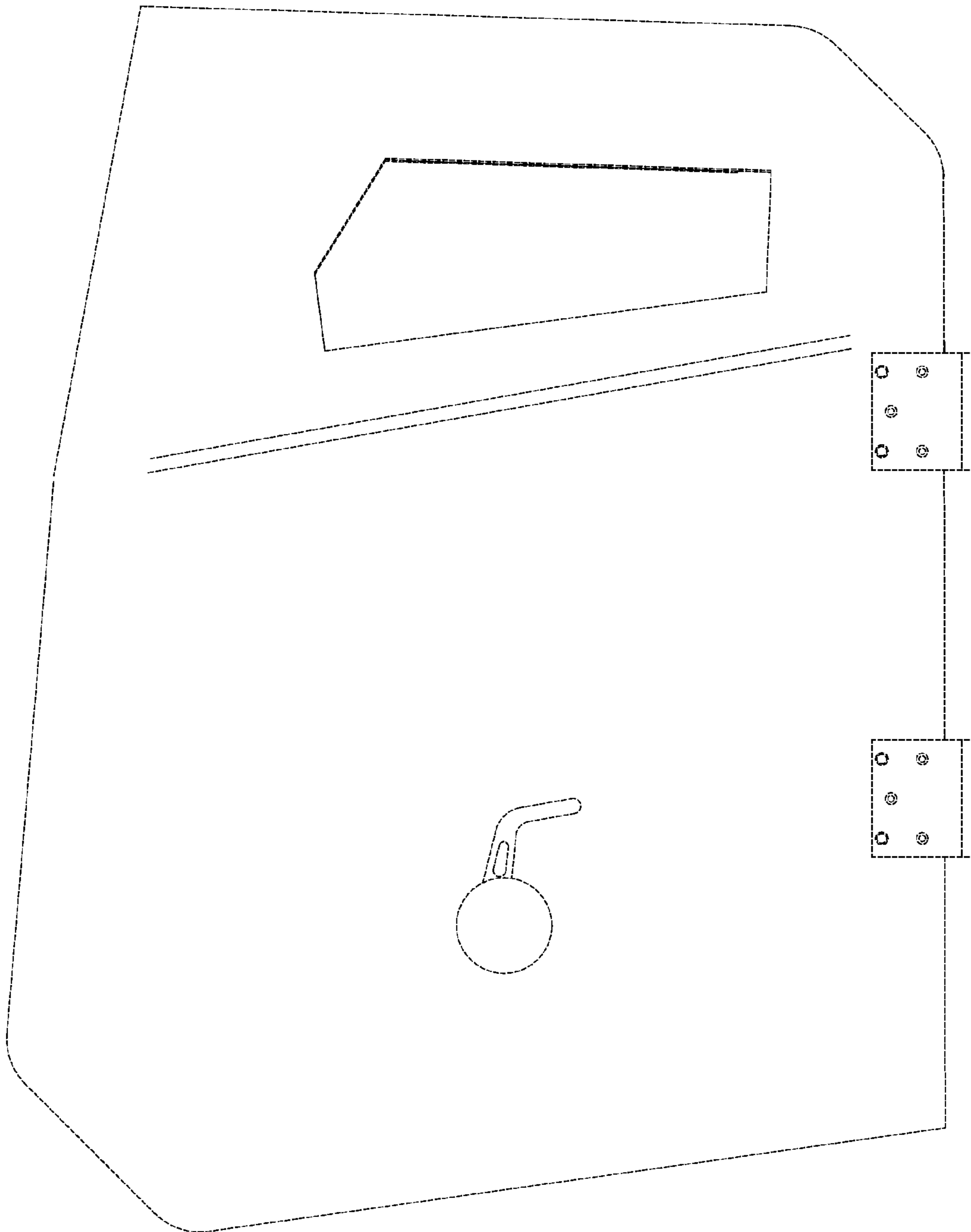

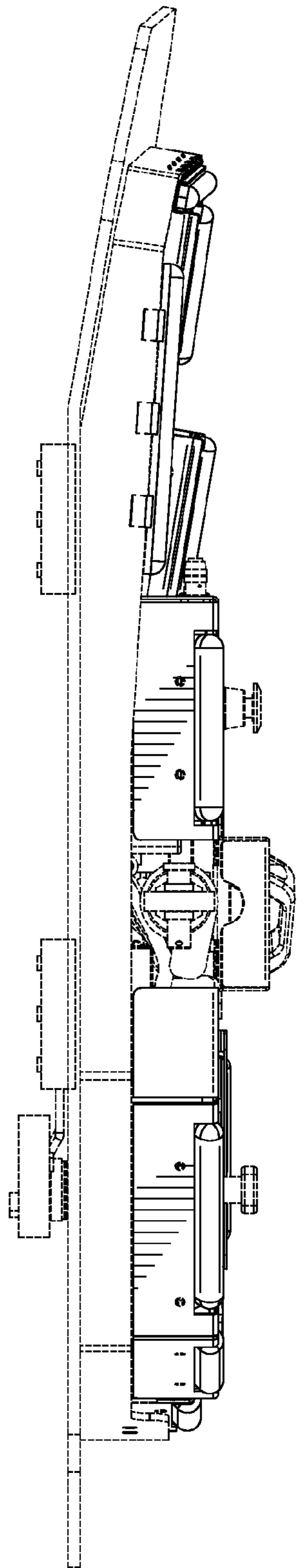

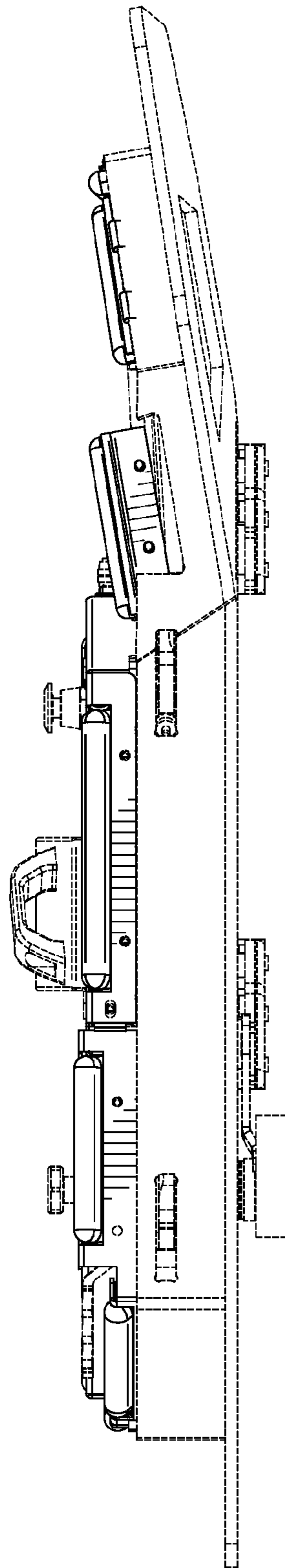

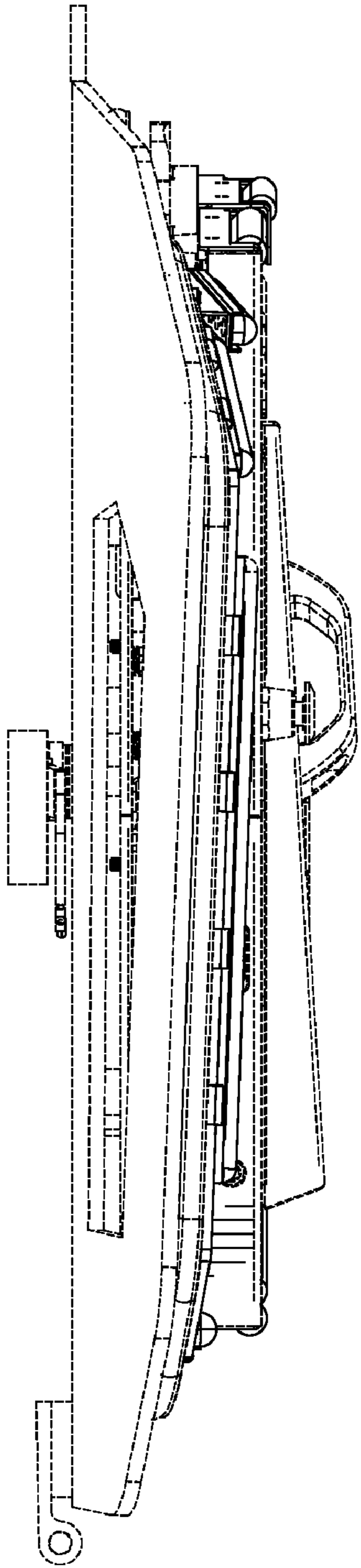

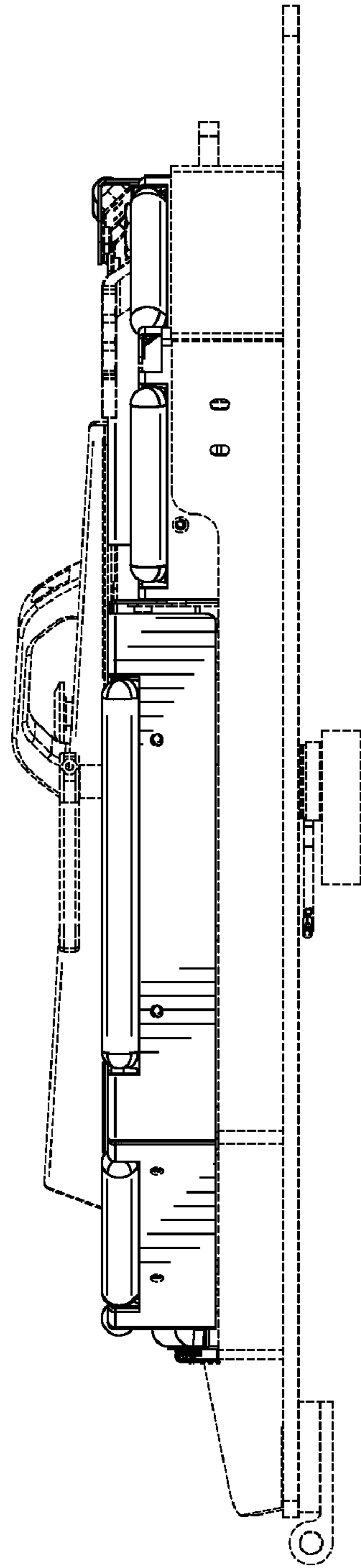

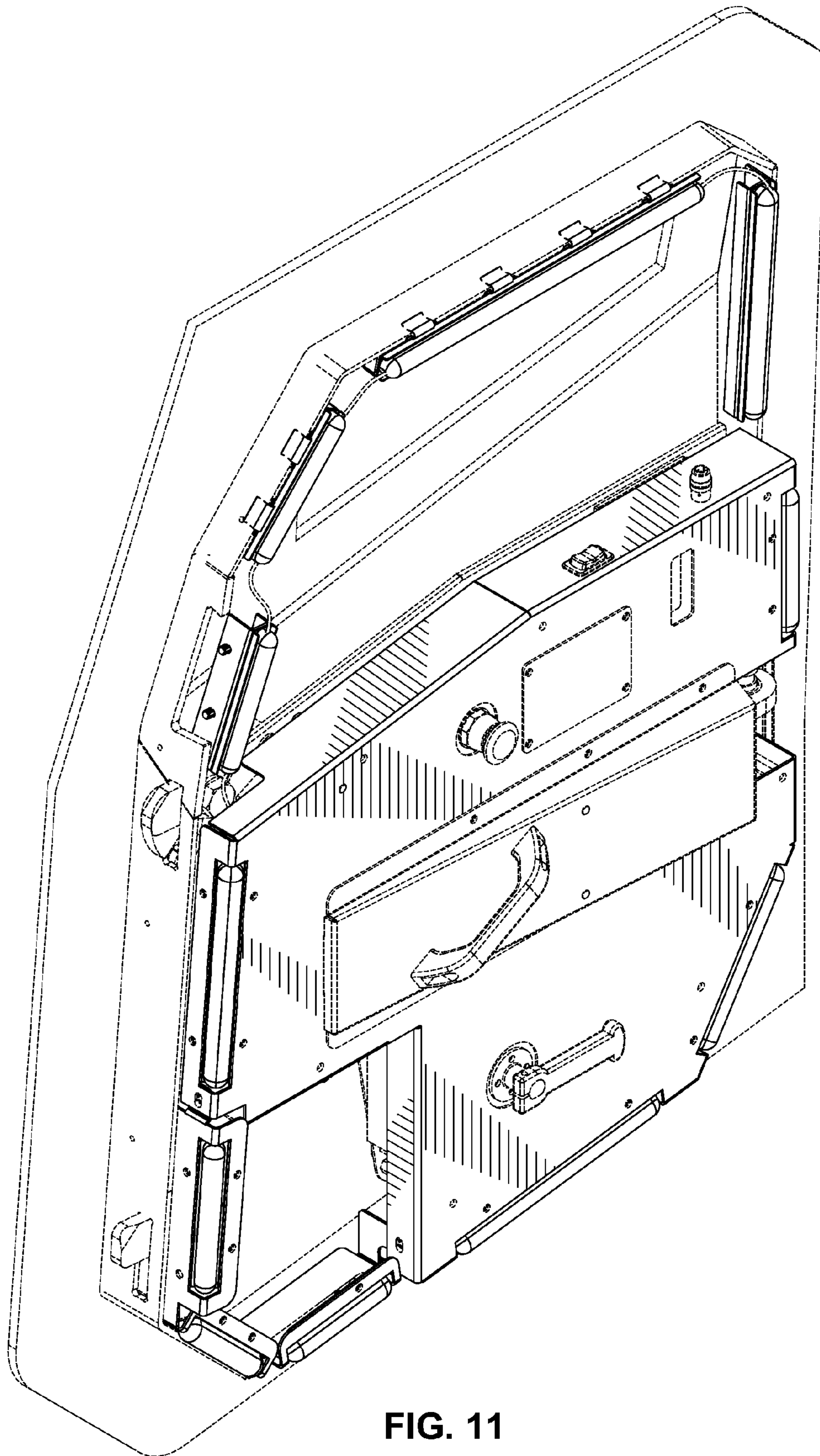
