FIG. 8 illustrates a bottom view thereof;

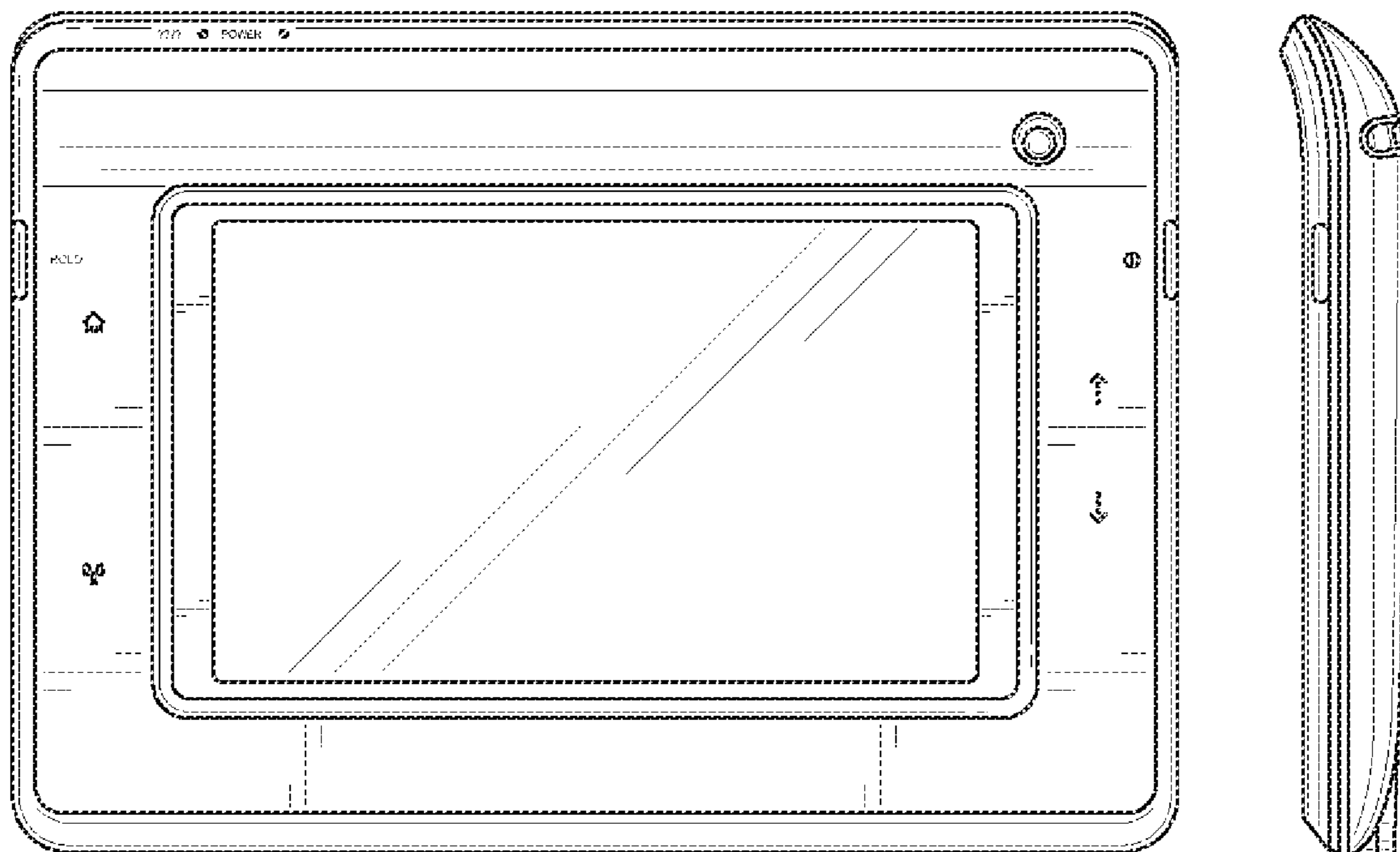
FIG. 9 illustrates a front view thereof;

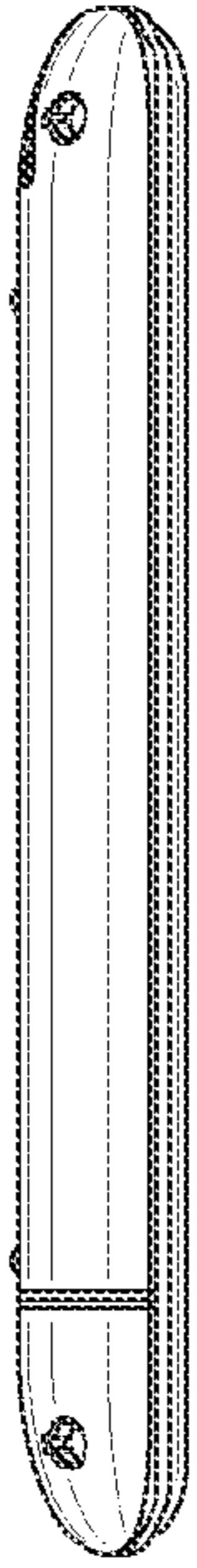

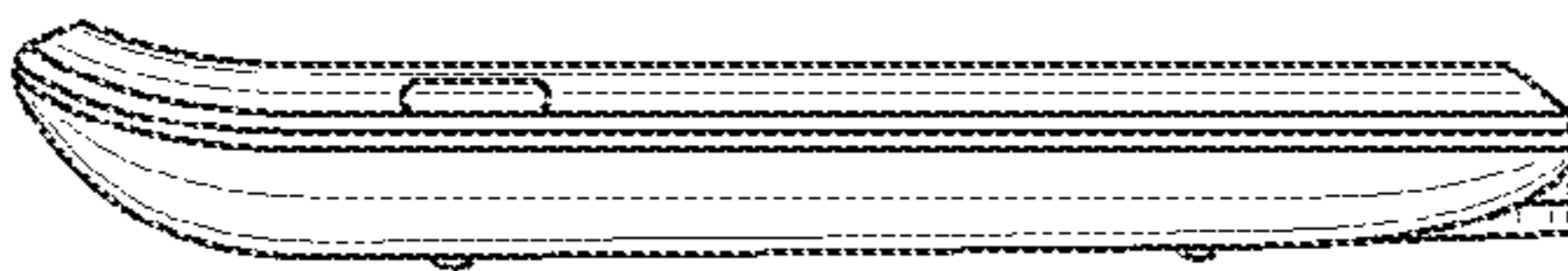

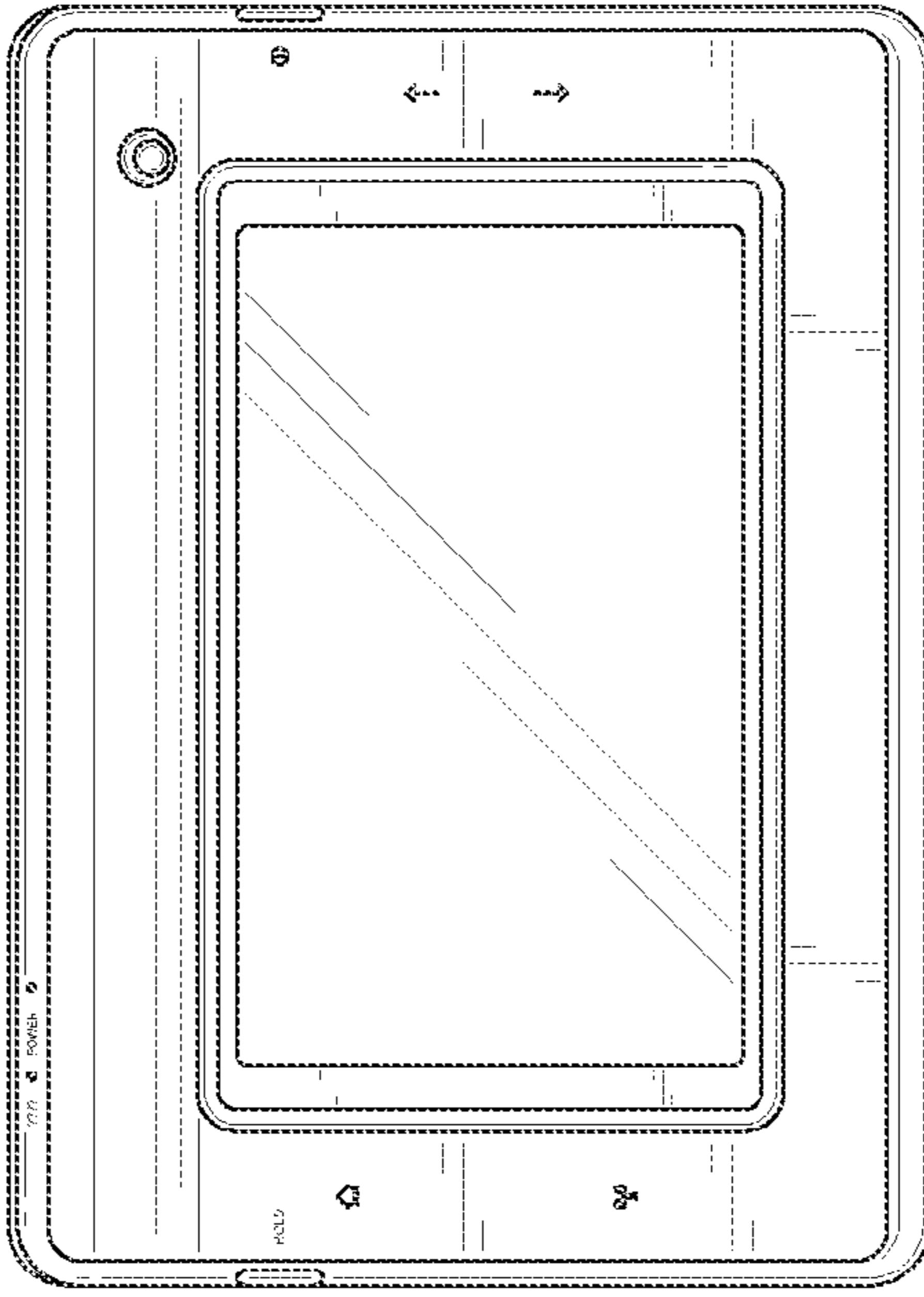

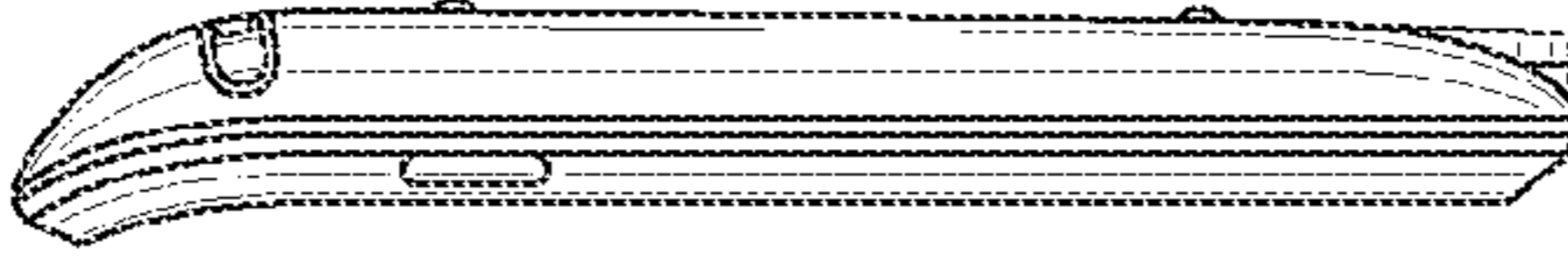

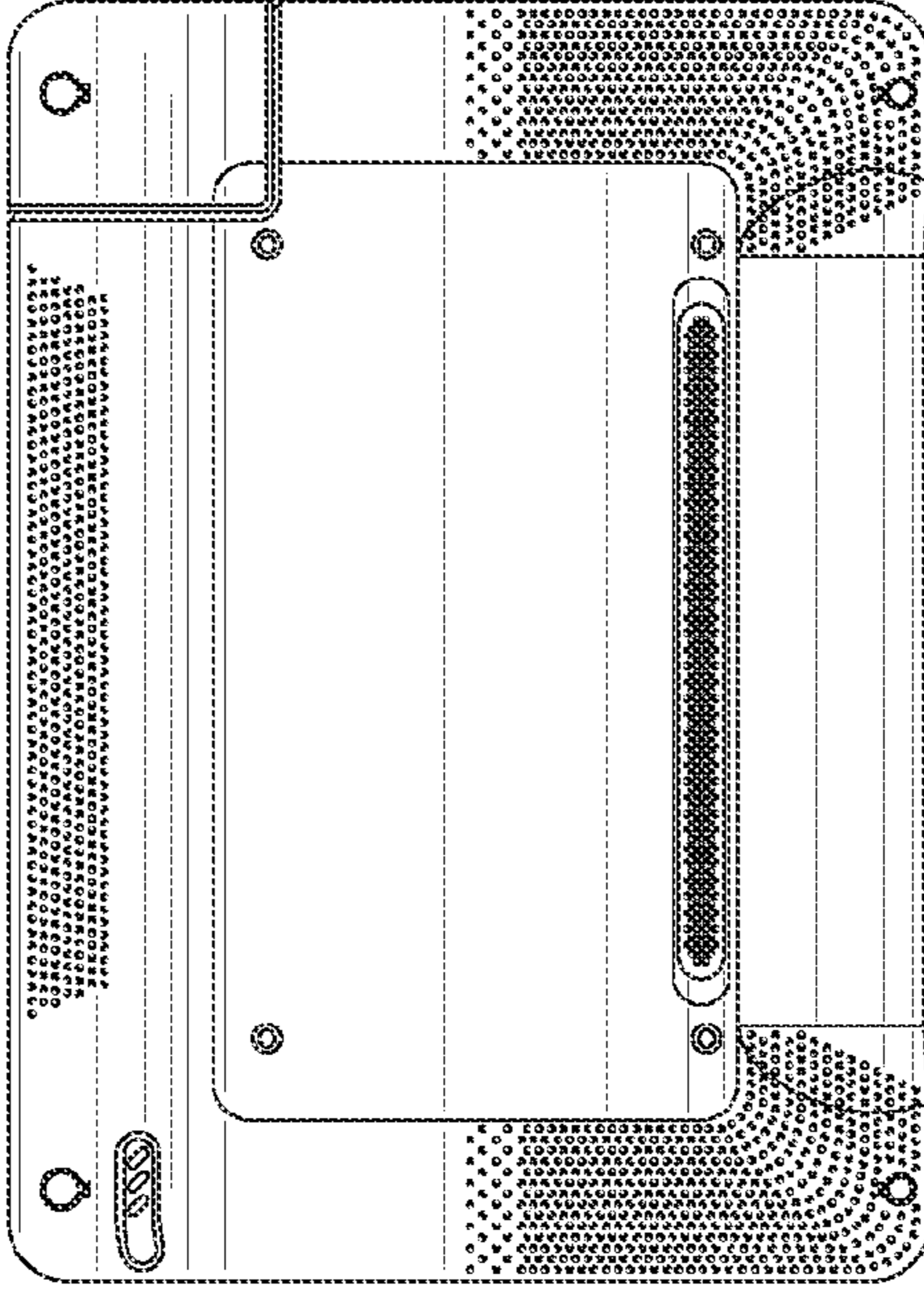

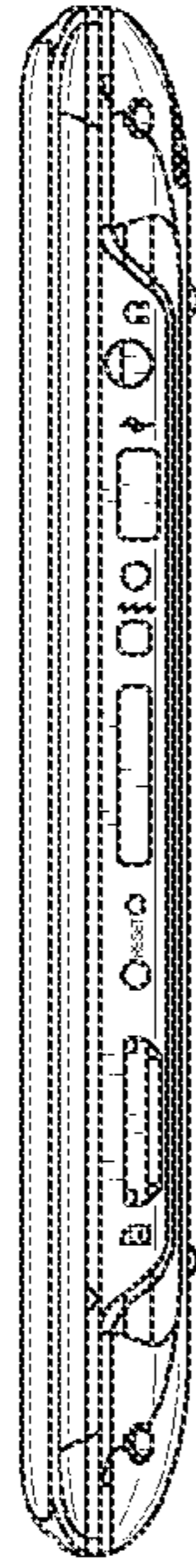

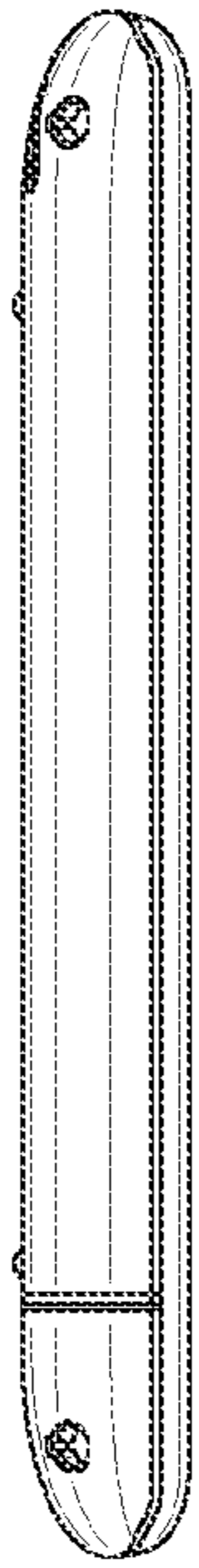

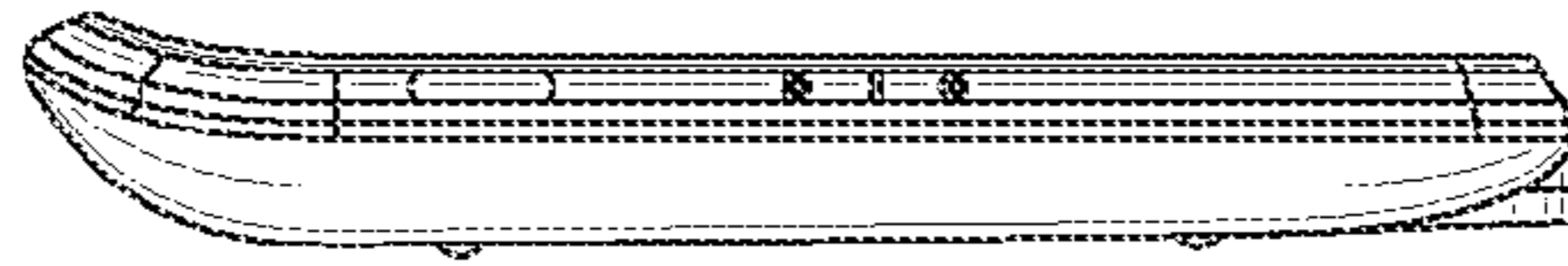

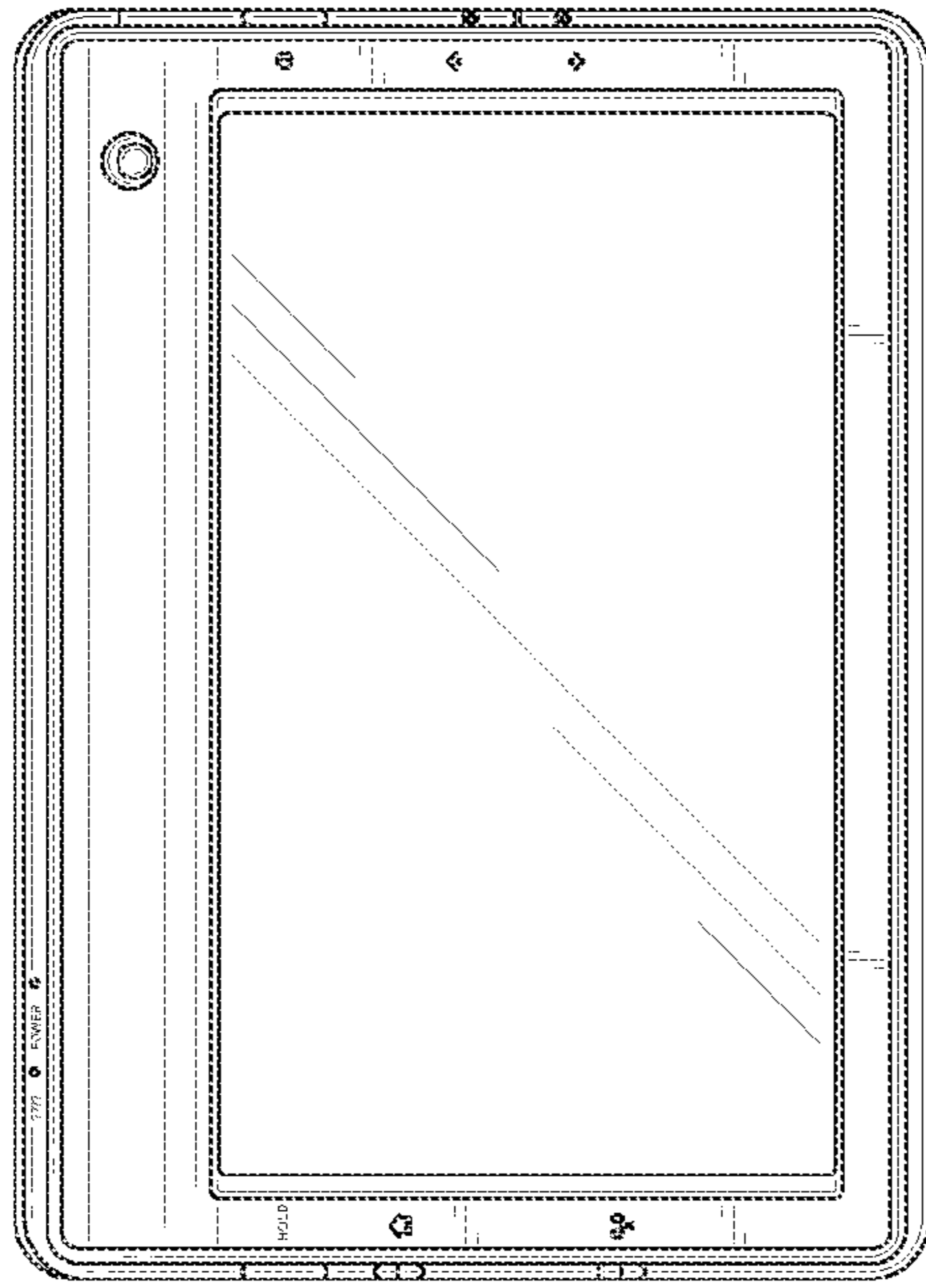

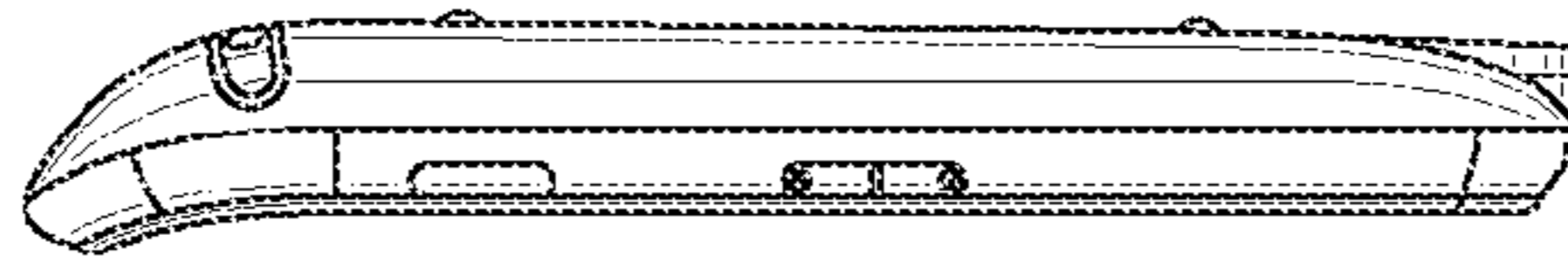

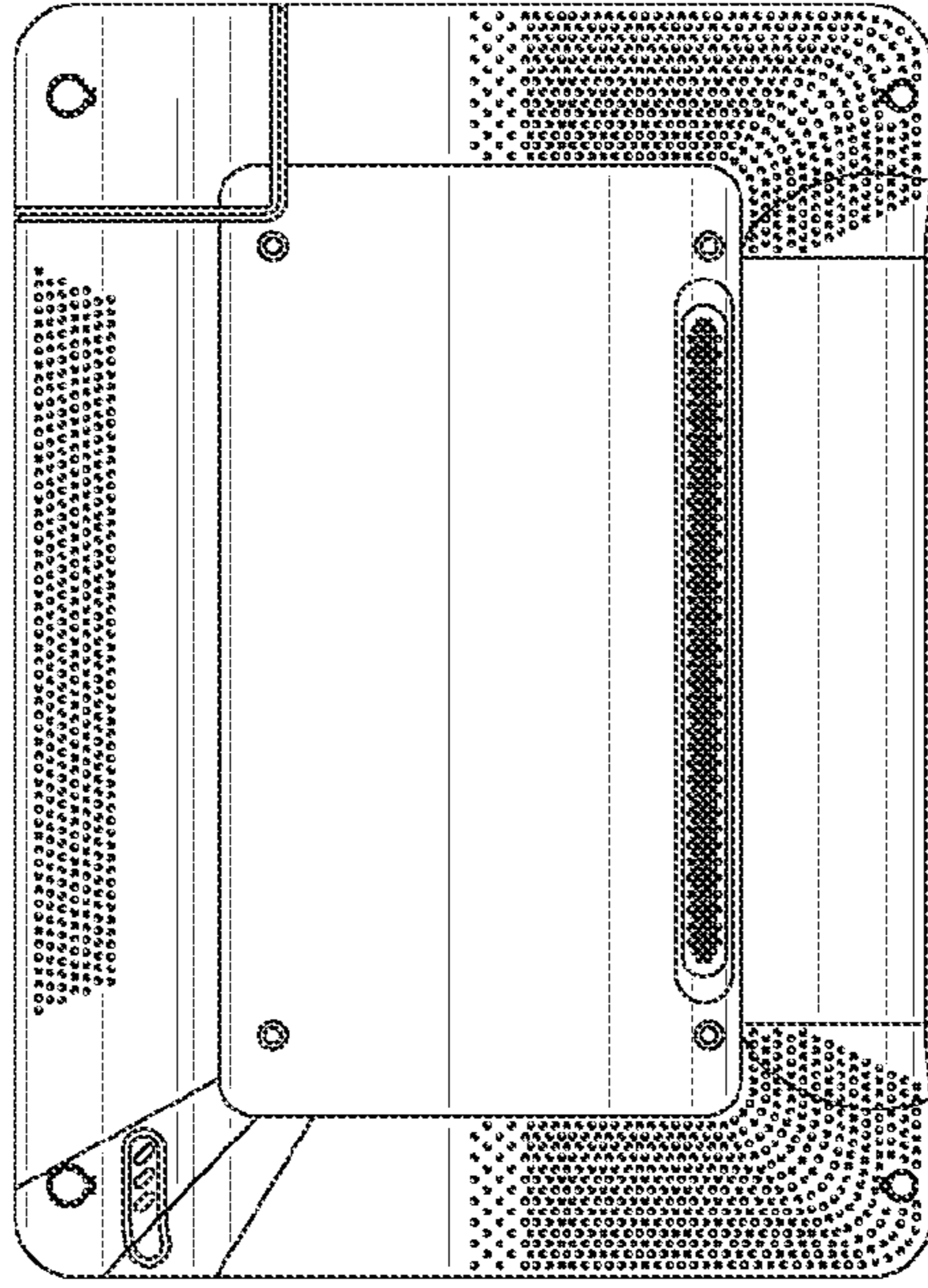

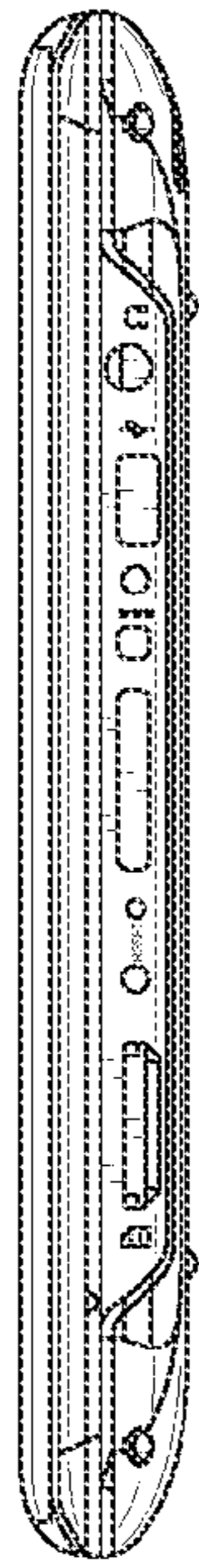
