FIG. 11 is a cross sectional view thereof taken along line 11—11 of FIG. 2;

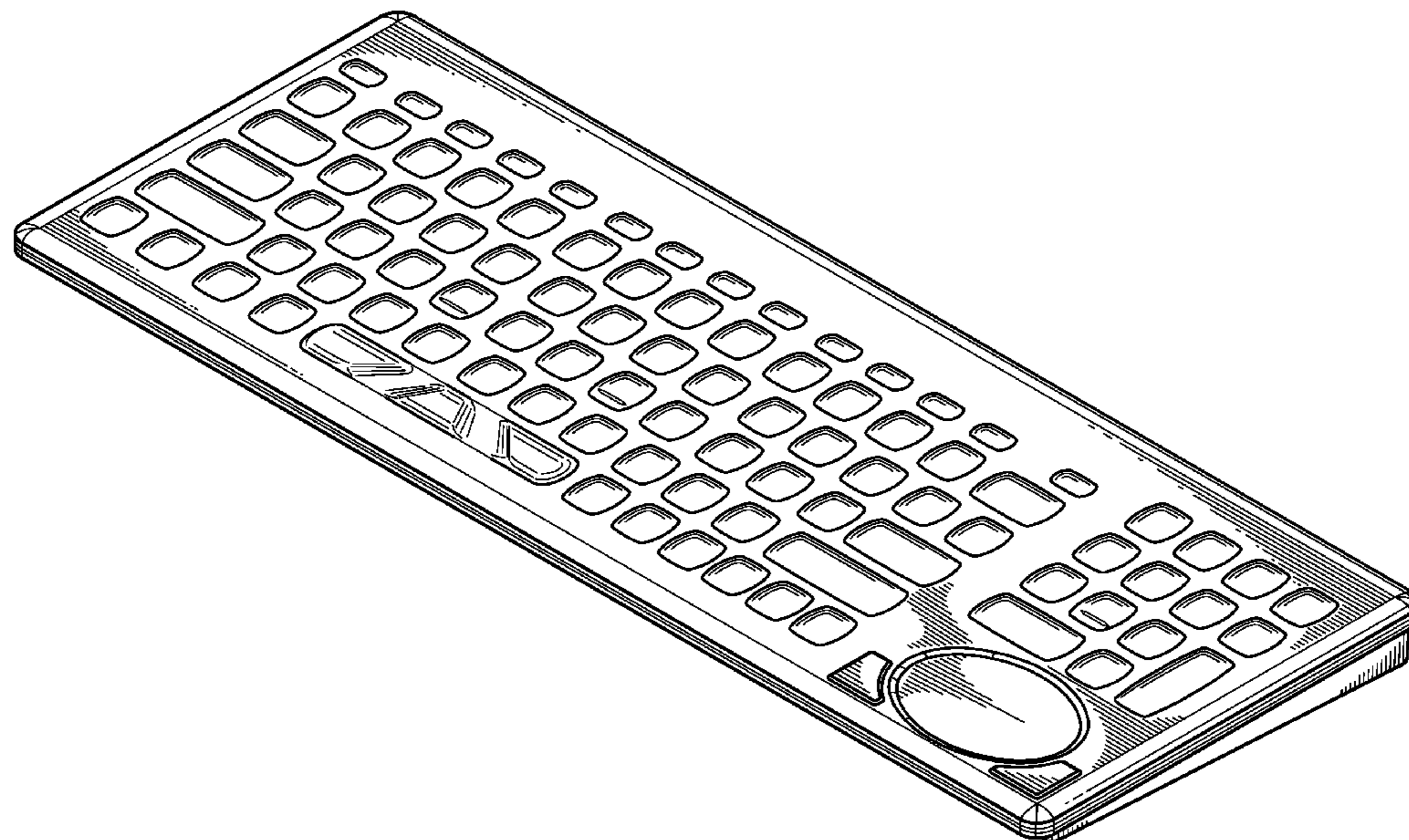
FIG. 12 is a cross sectional view thereof taken along line 12—12 of FIG. 2;

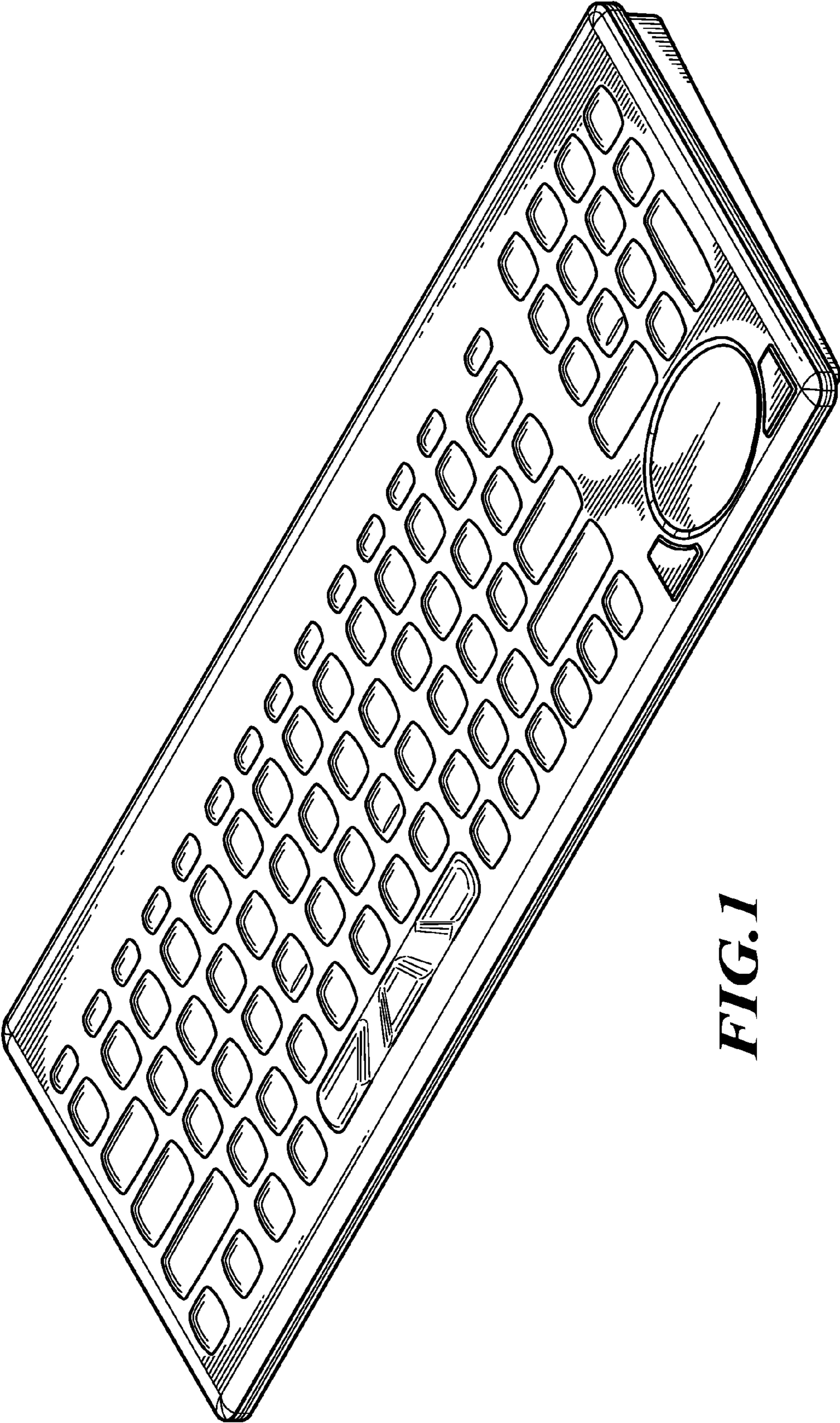
FIG. 13 is a cross sectional view thereof taken along line 13—13 of FIG. 2;

FIG. 14 is a cross sectional view thereof taken along line 14—14 of FIG. 2; and,

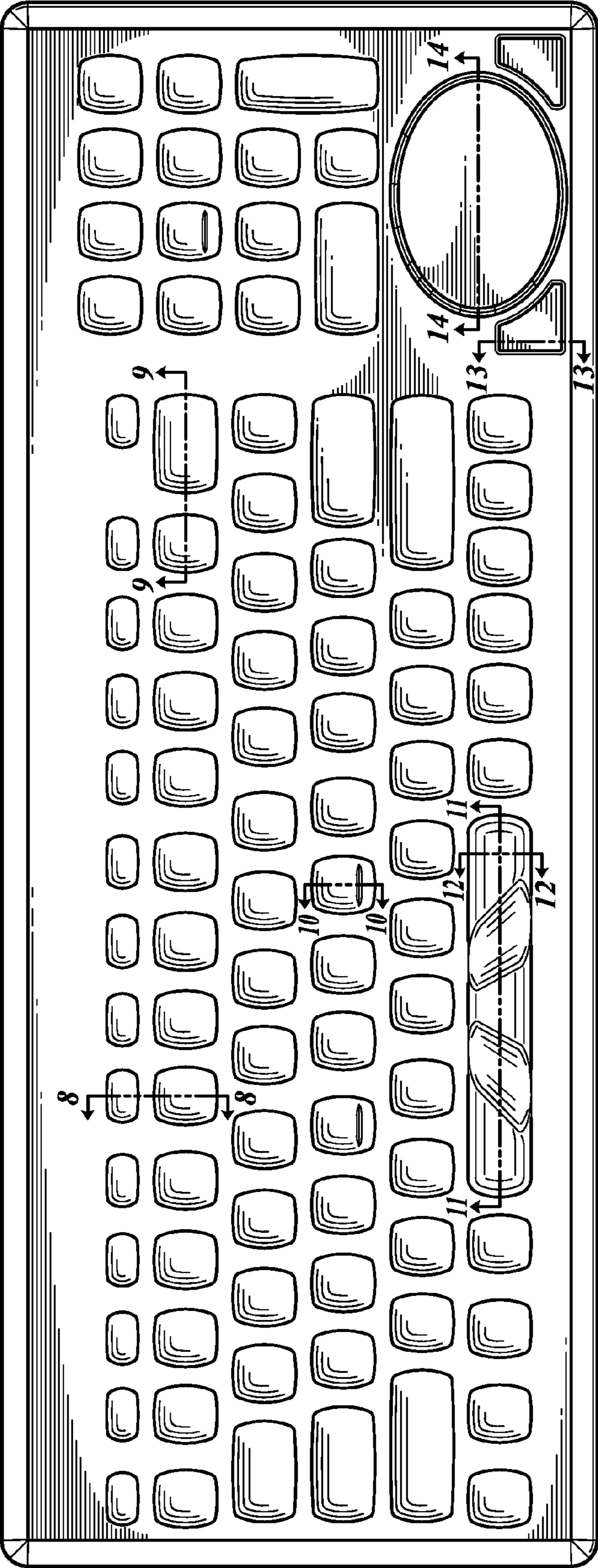
FIG. 15 is a cross sectional view thereof taken along line 15—15 of FIG. 3.

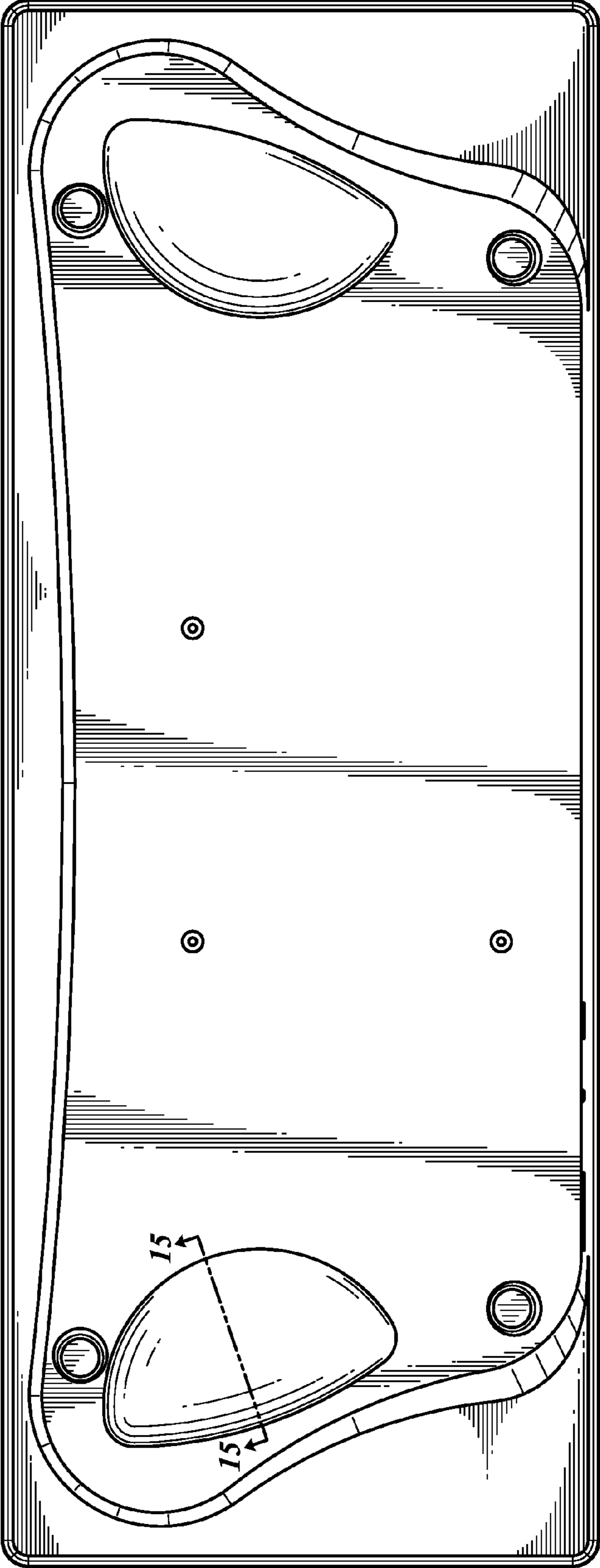




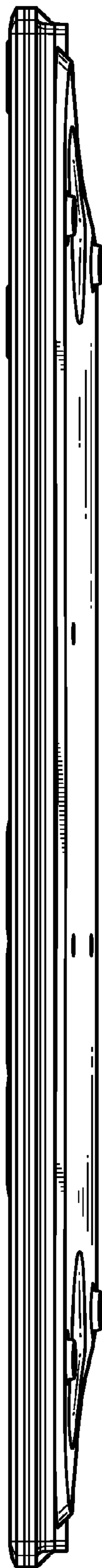

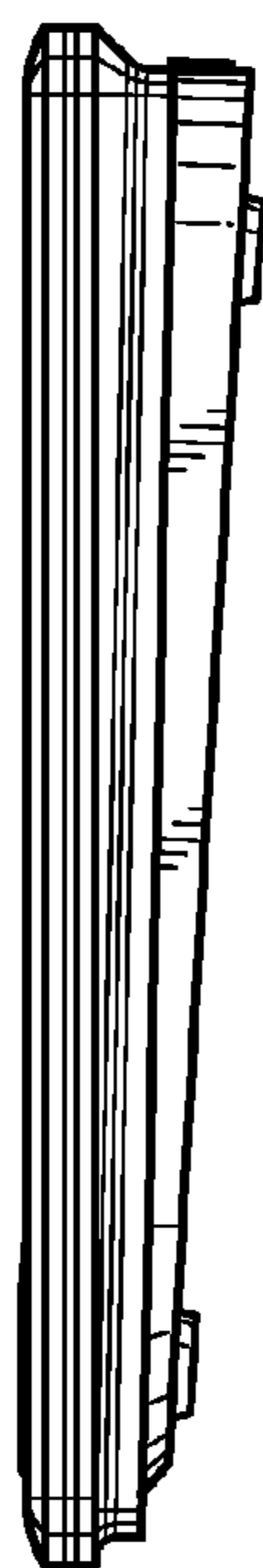

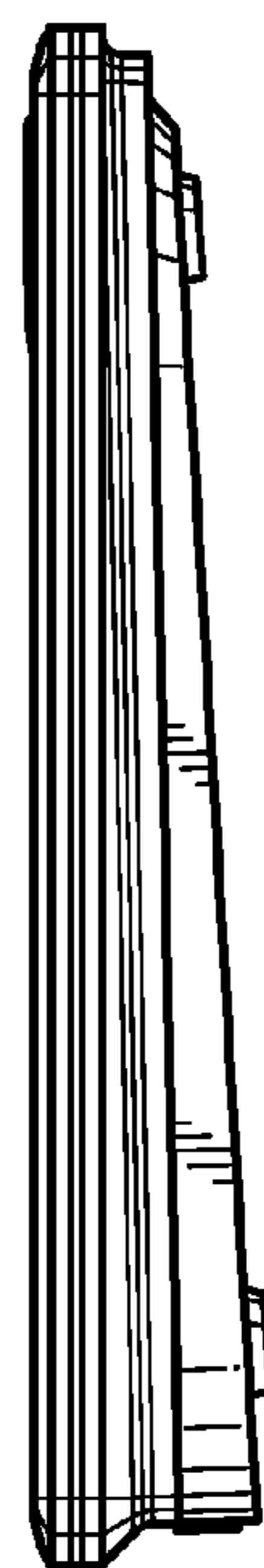

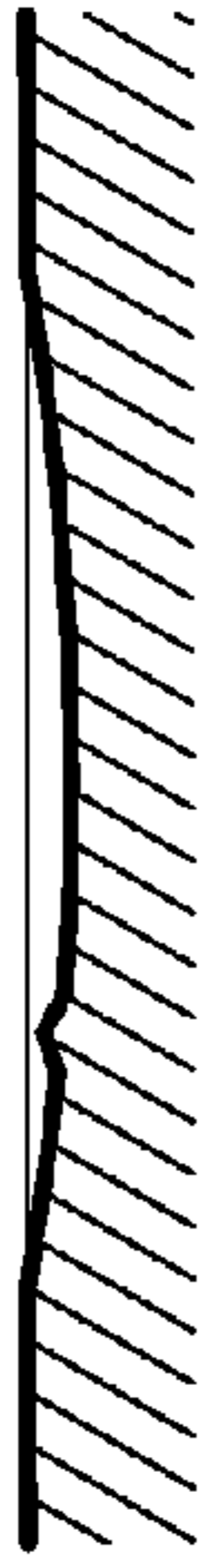

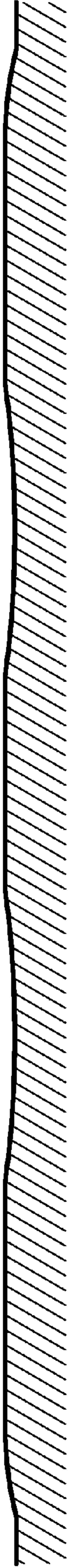

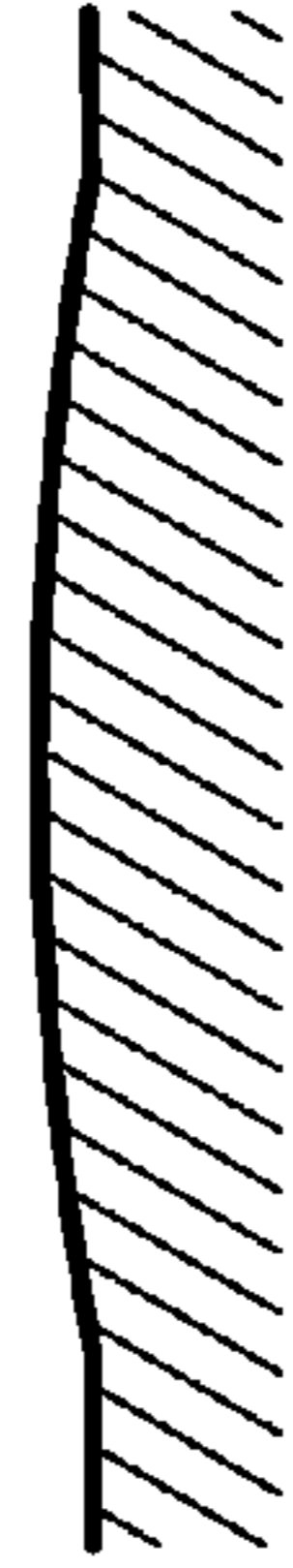
