FIG. 13 is a rear view thereof; and,

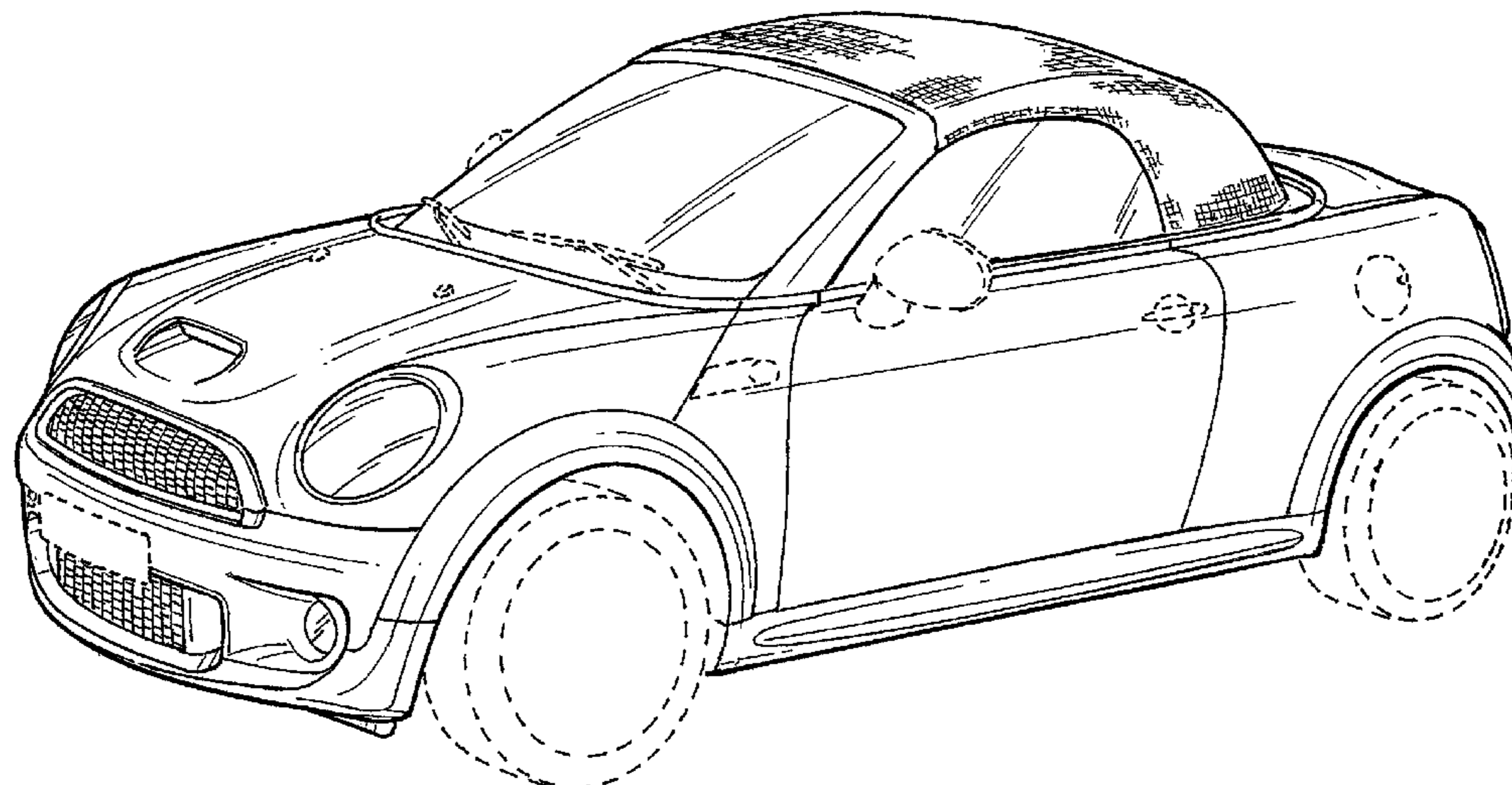

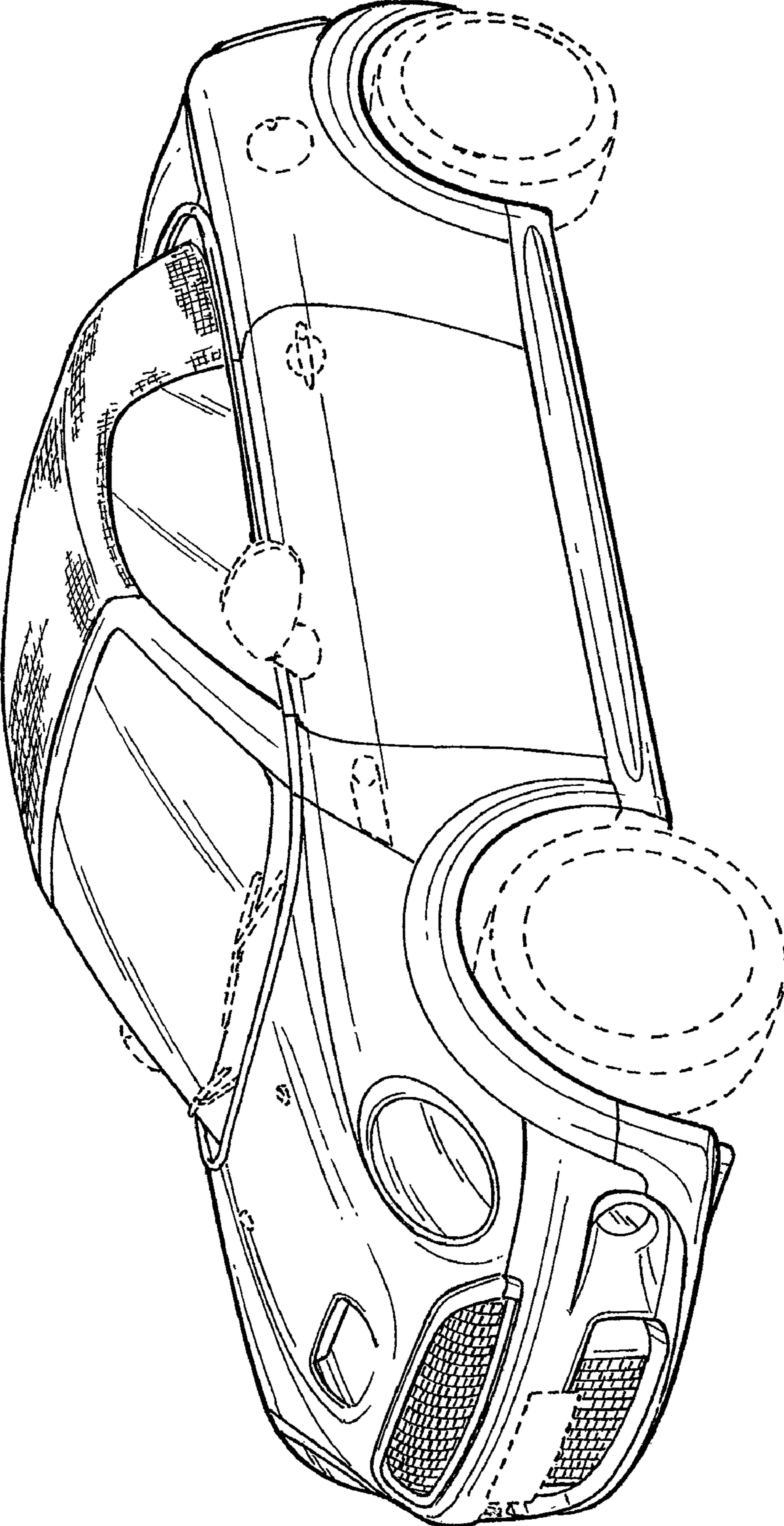

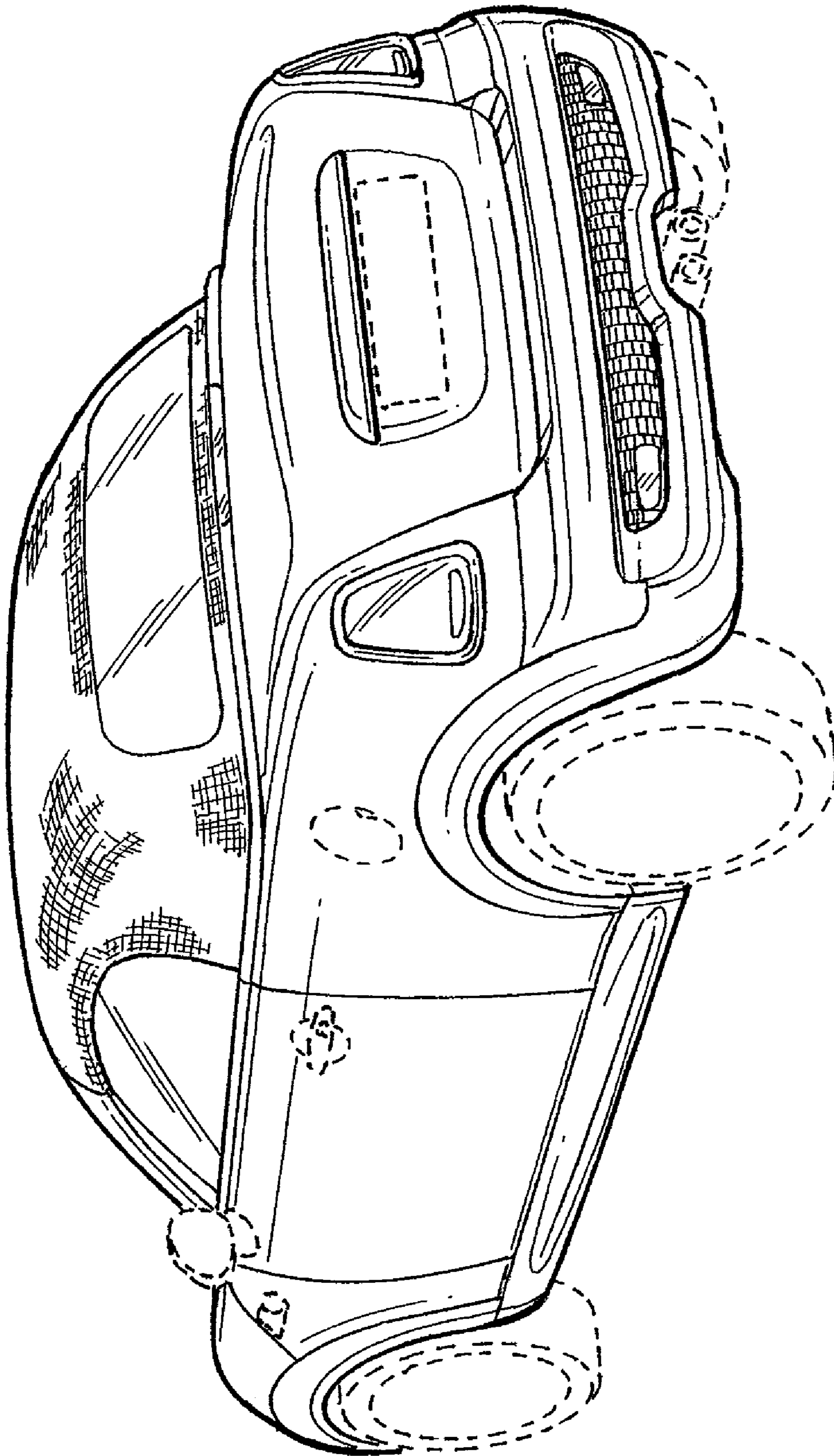

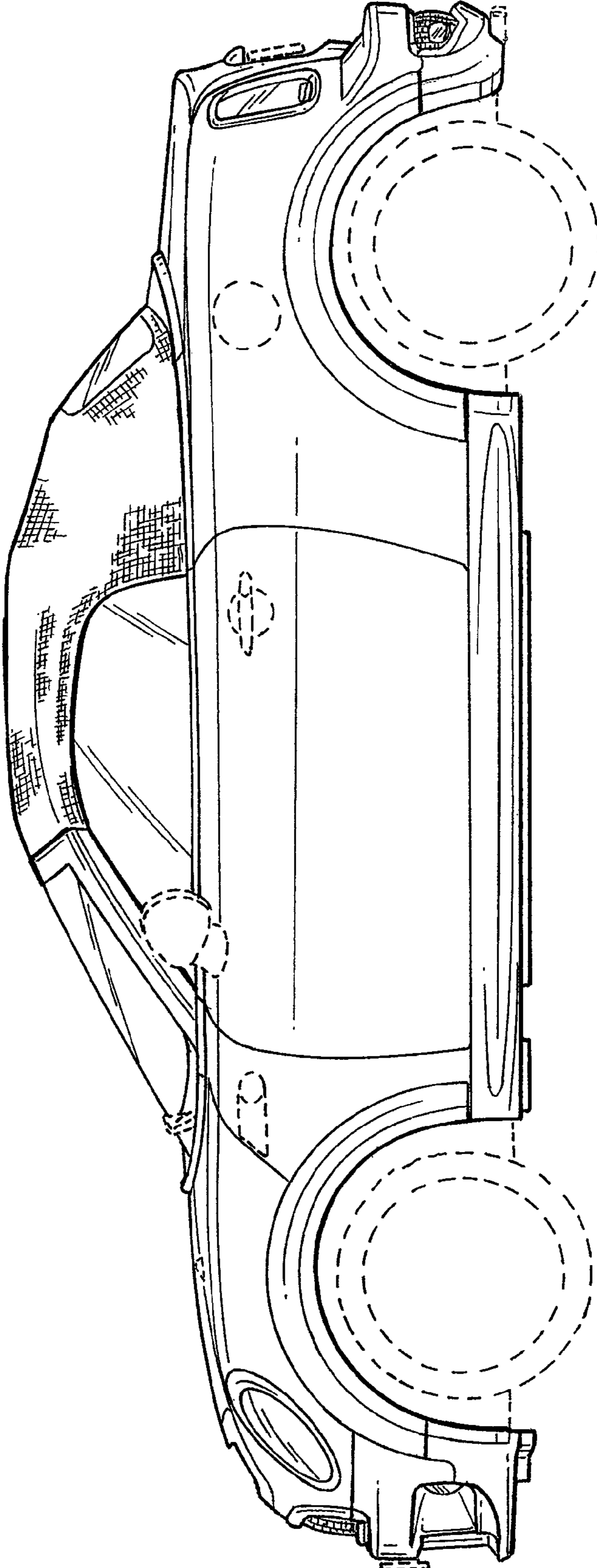

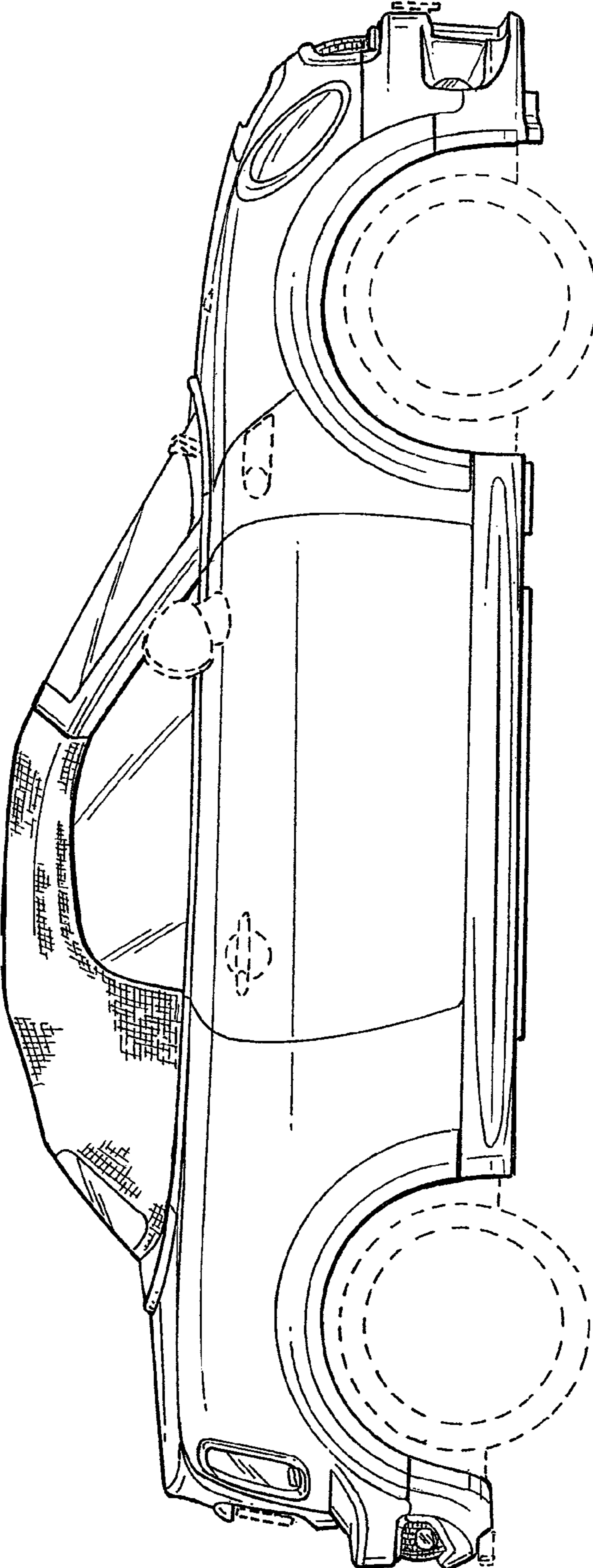

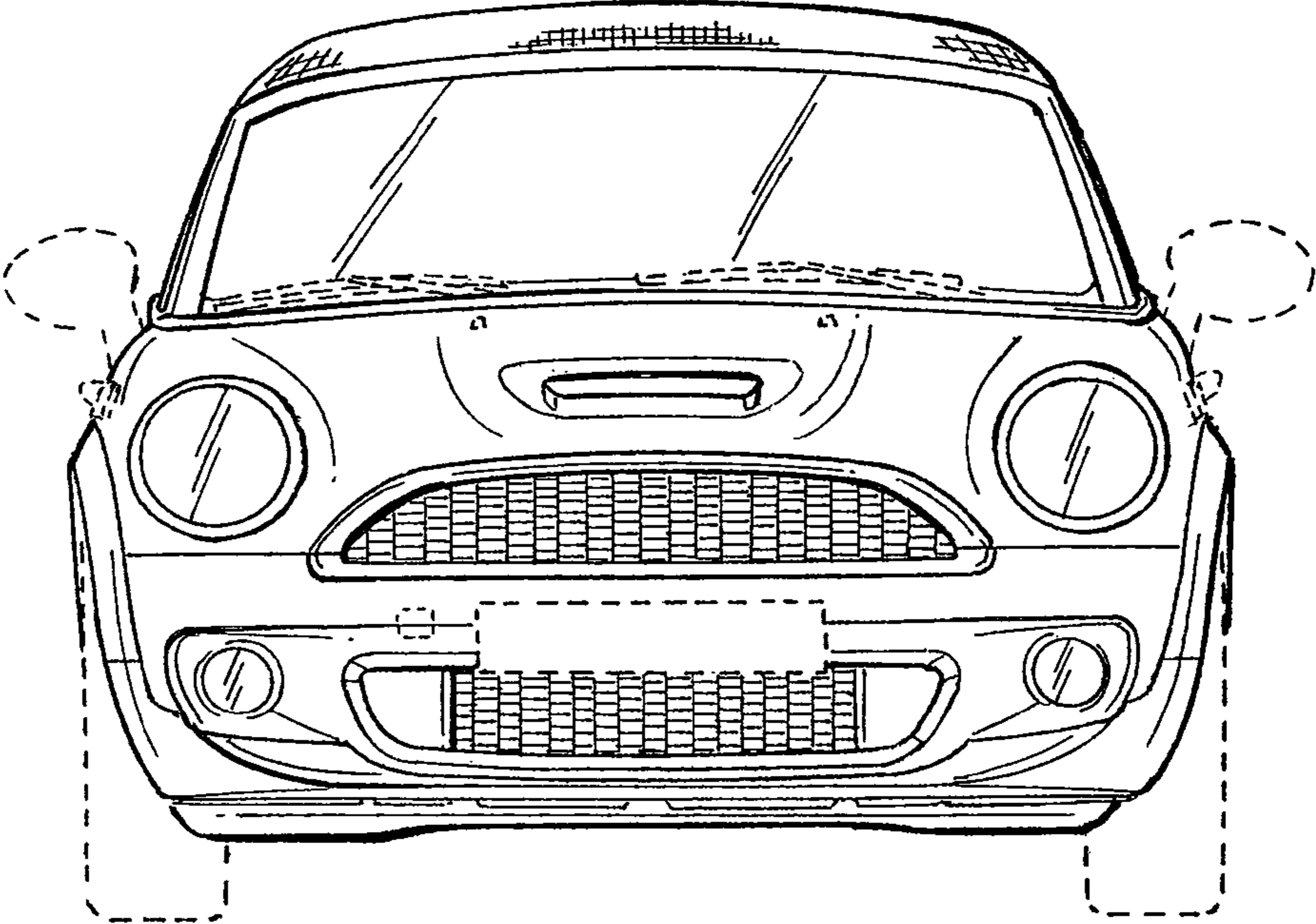

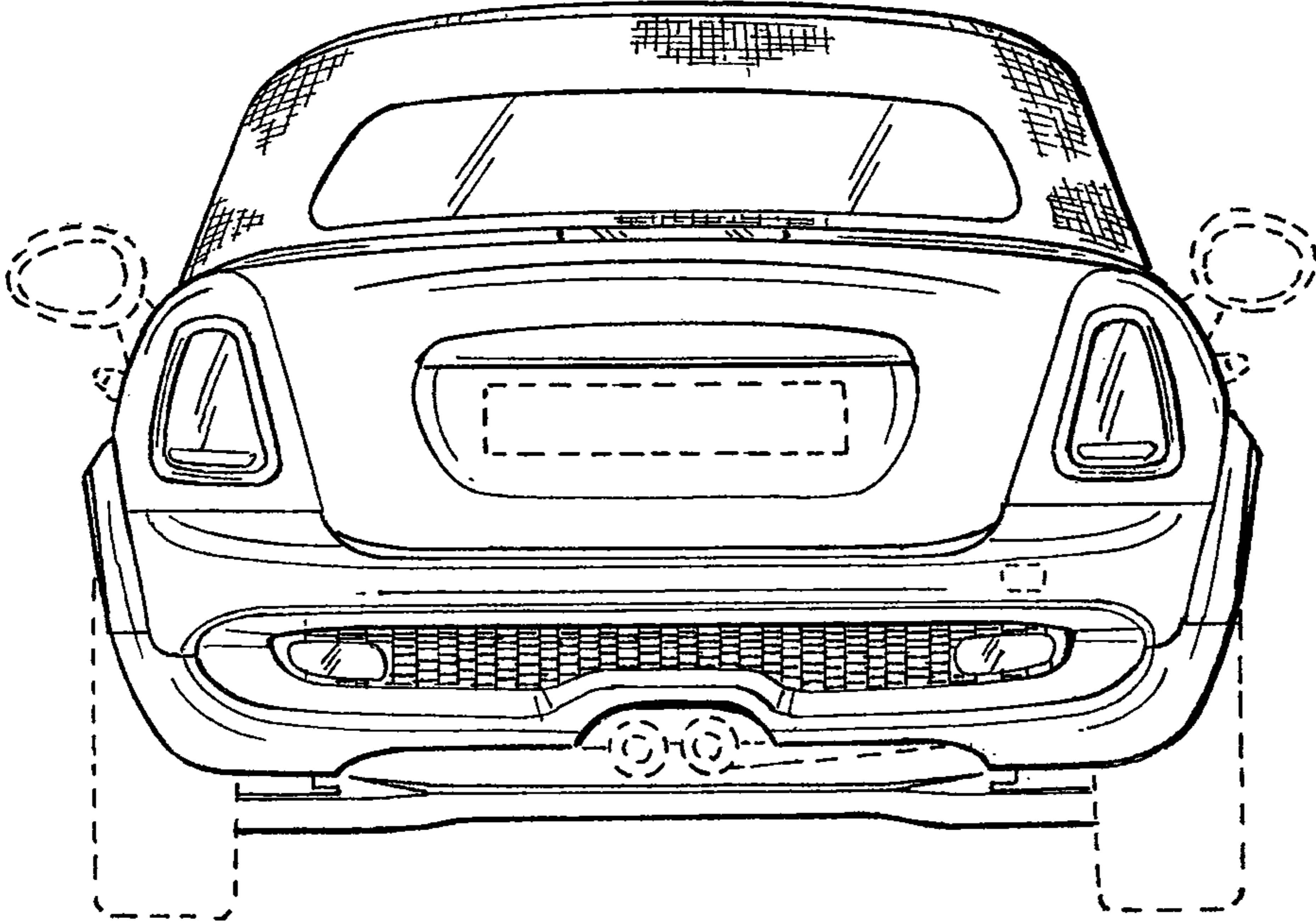

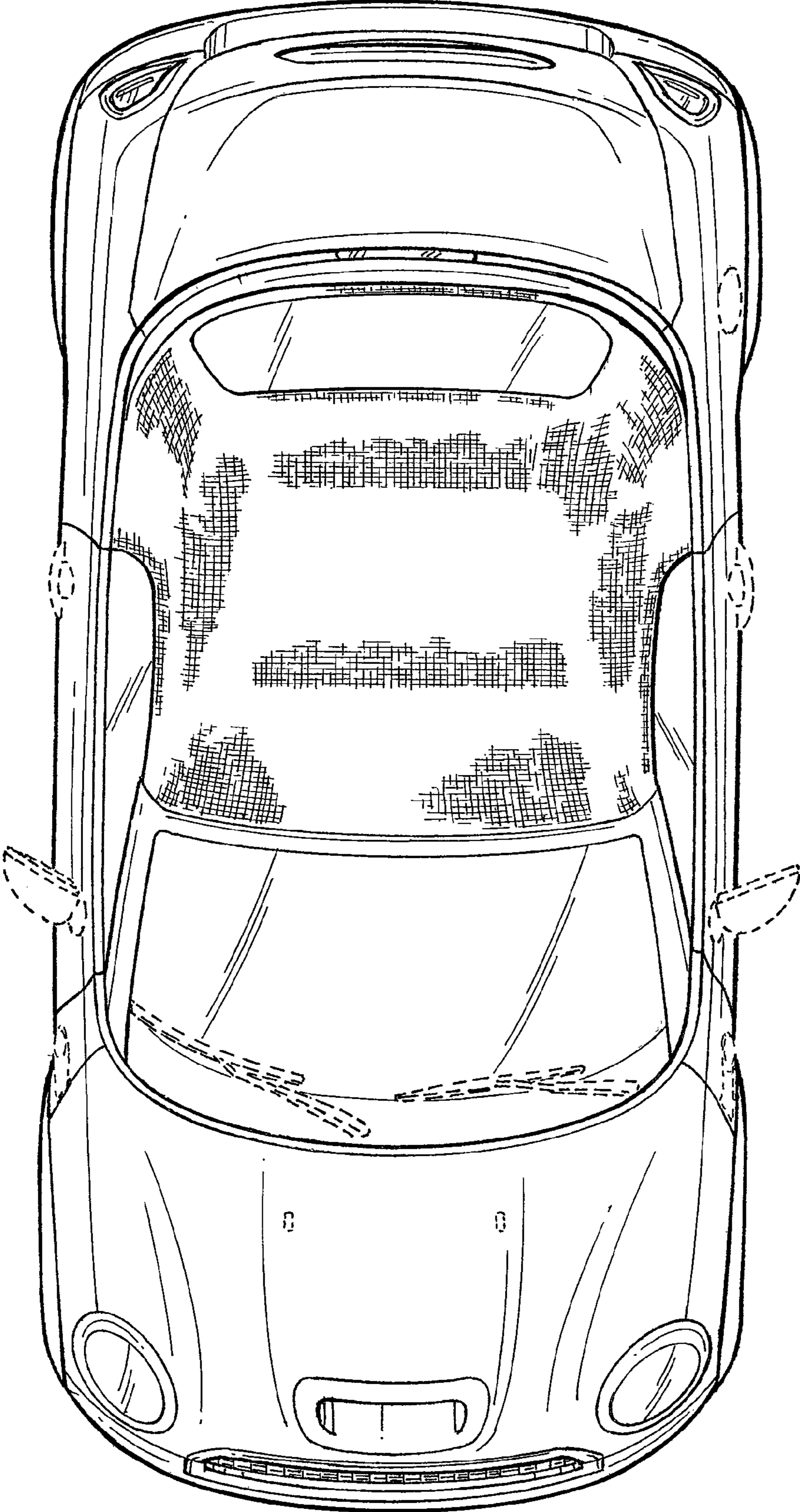

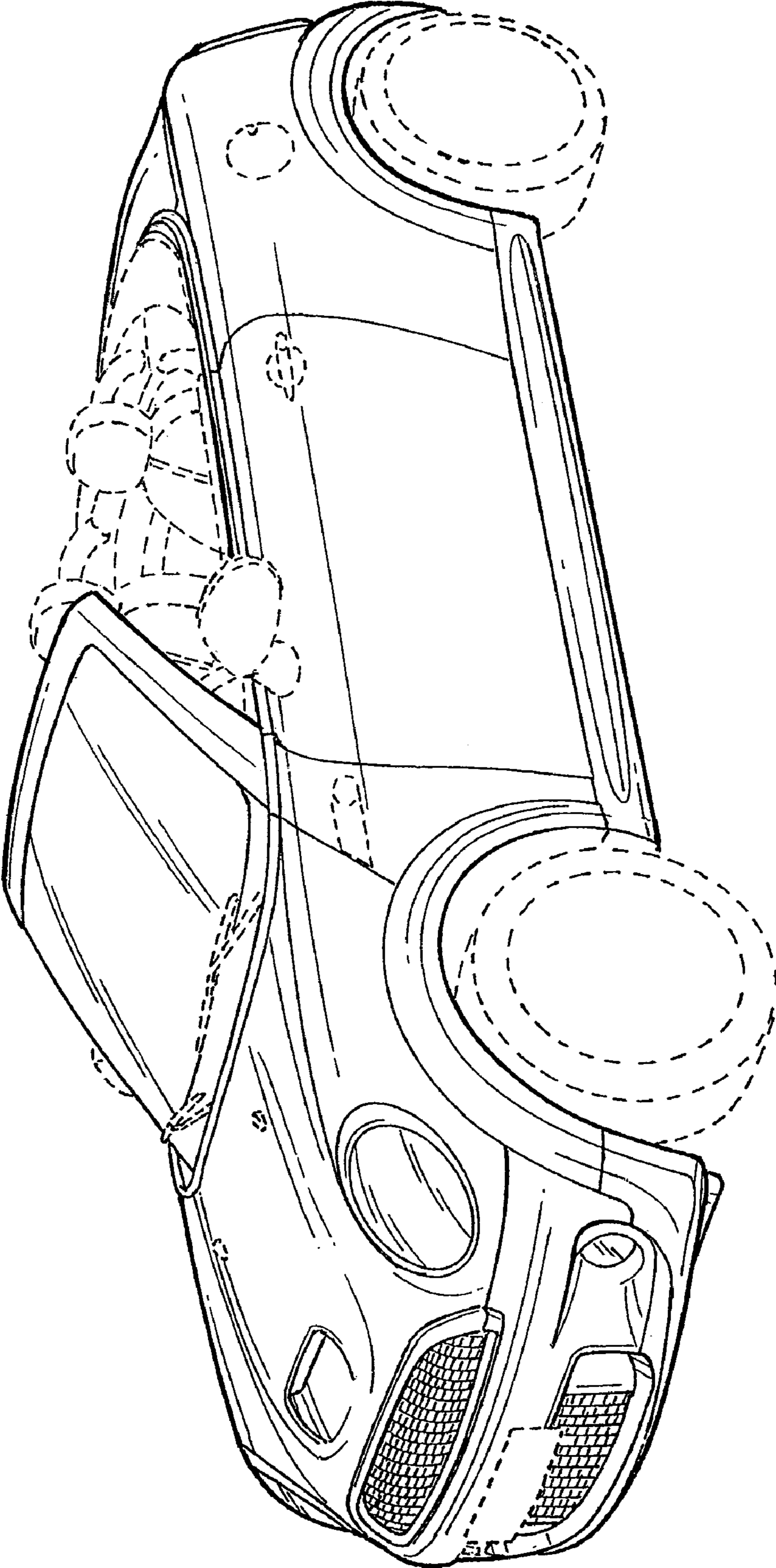

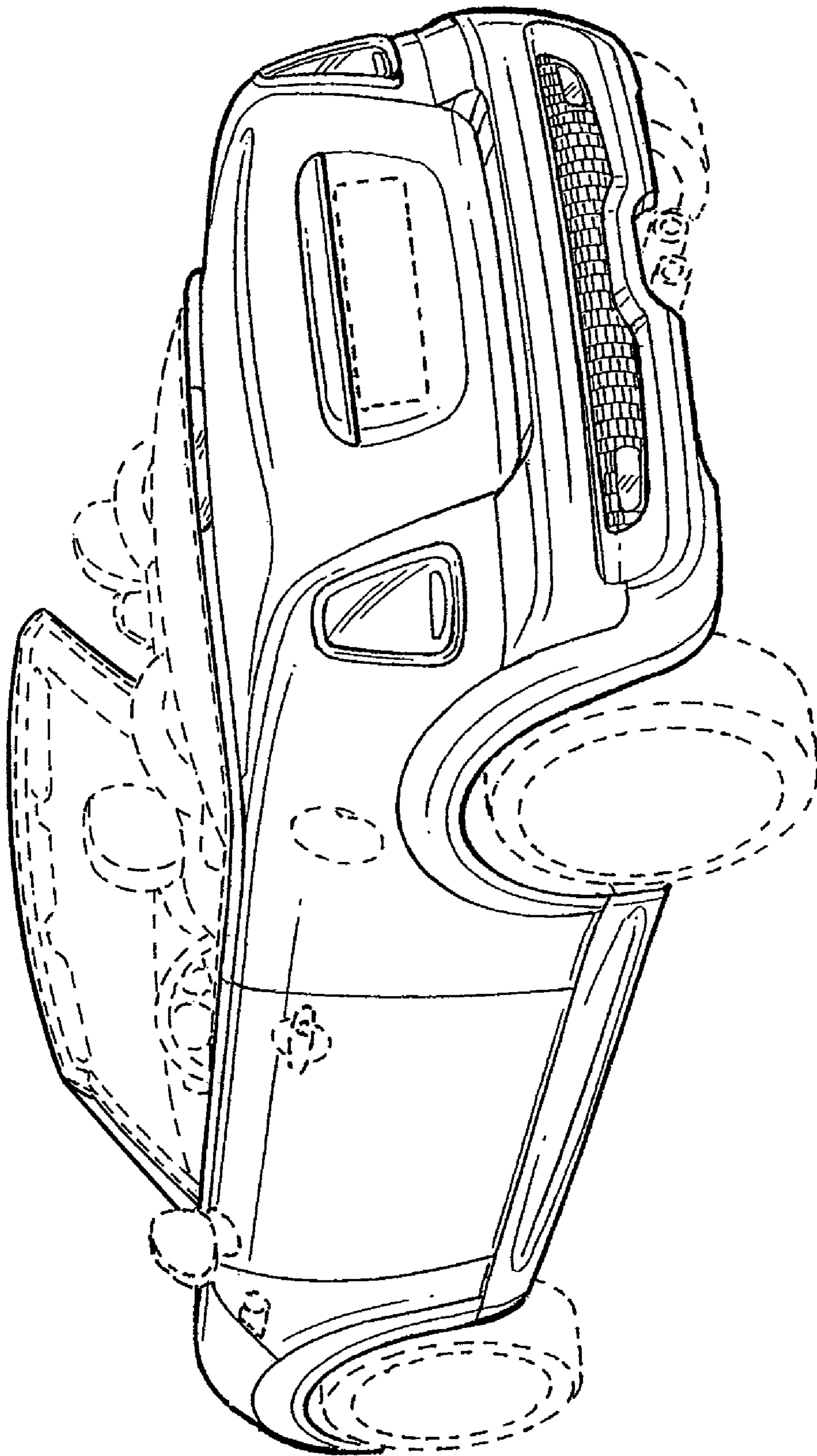

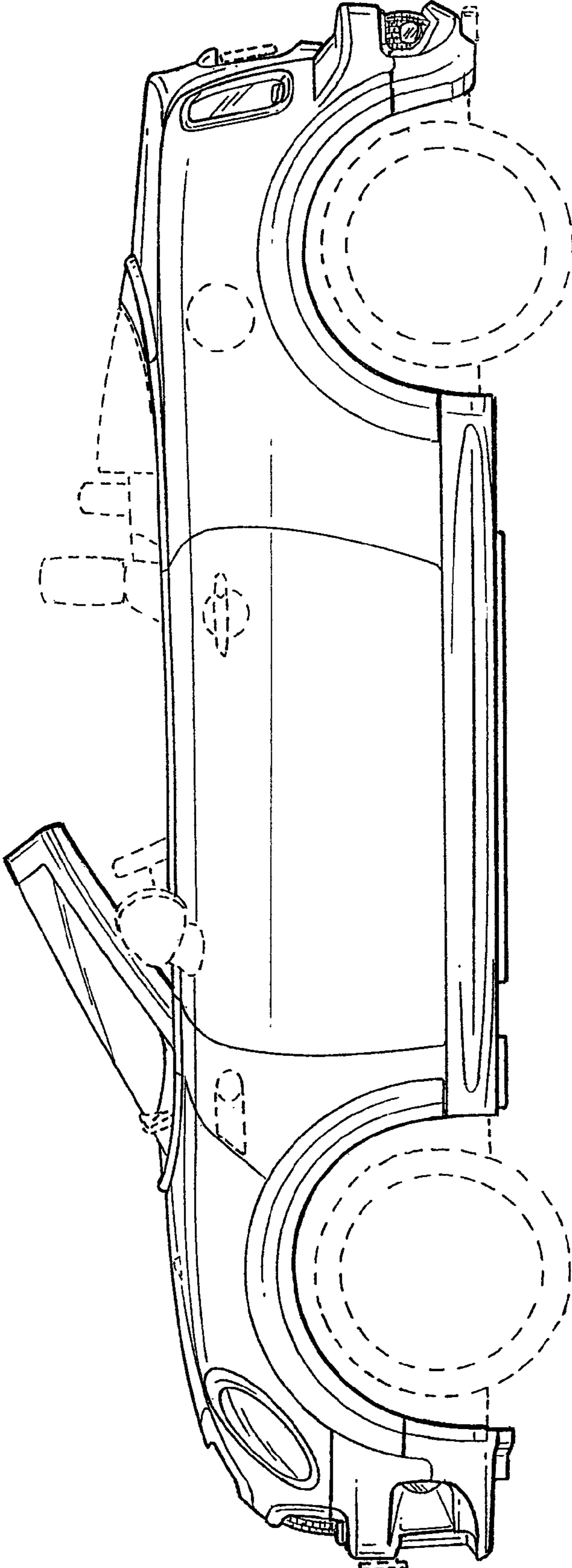

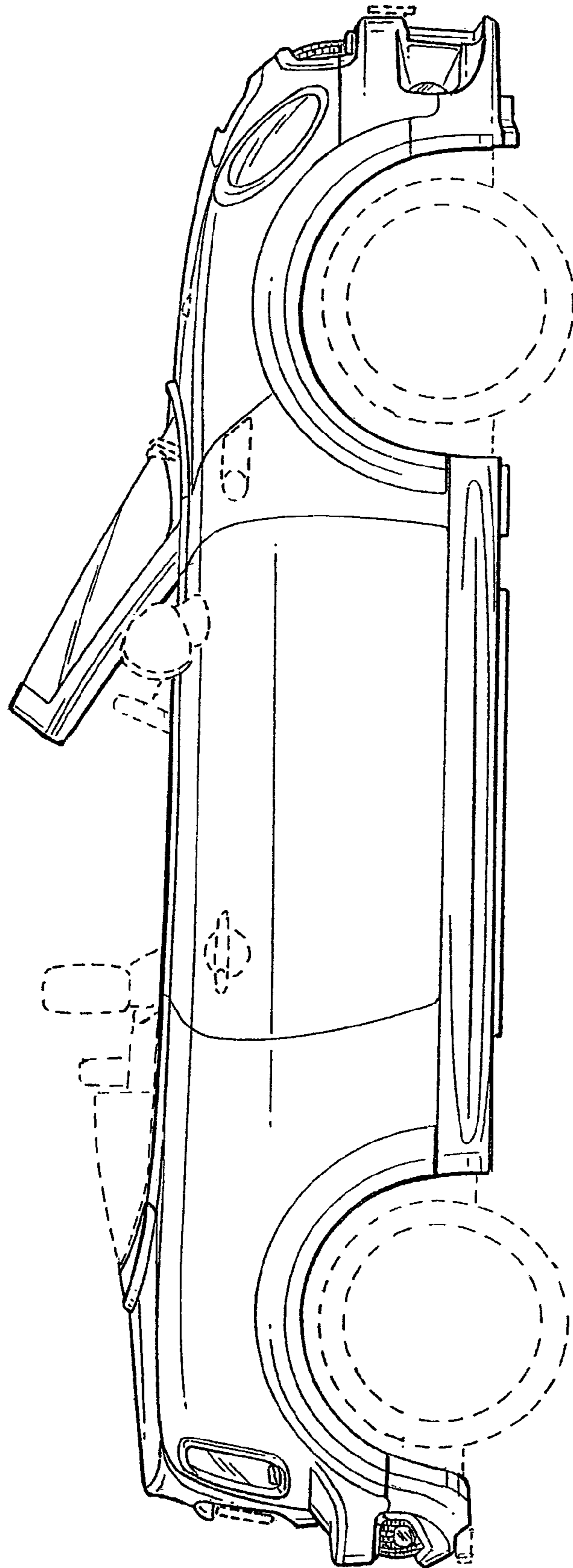

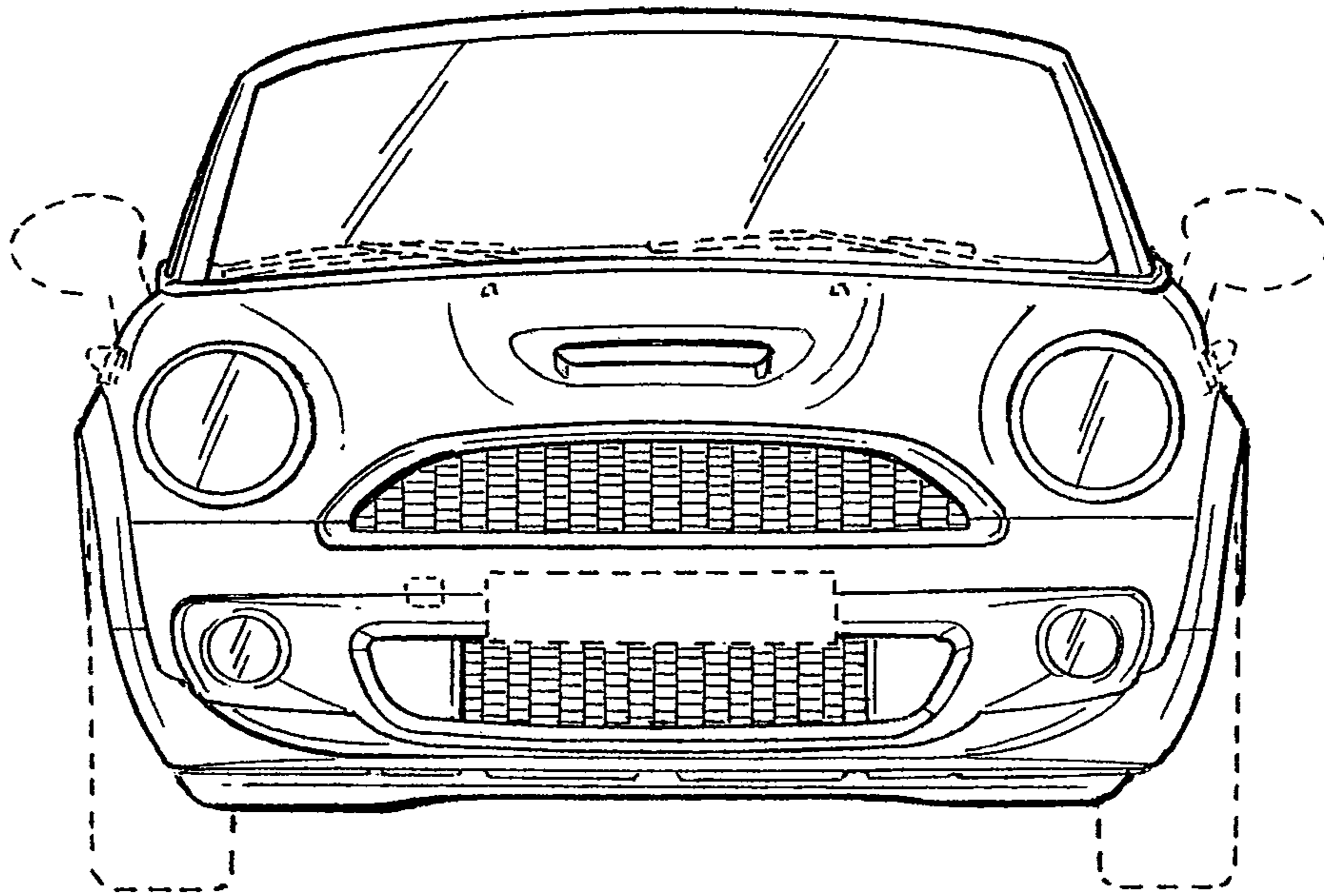

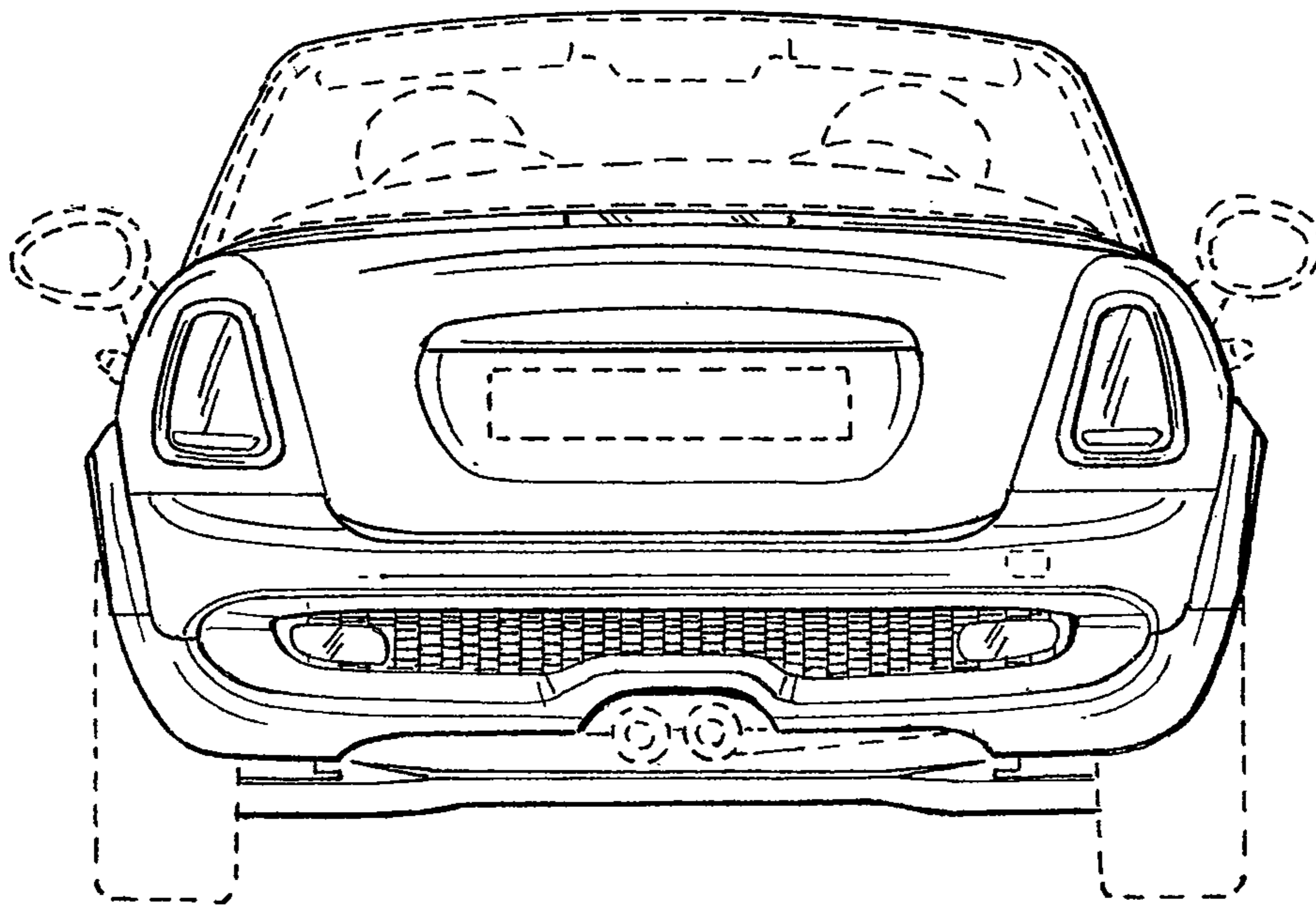

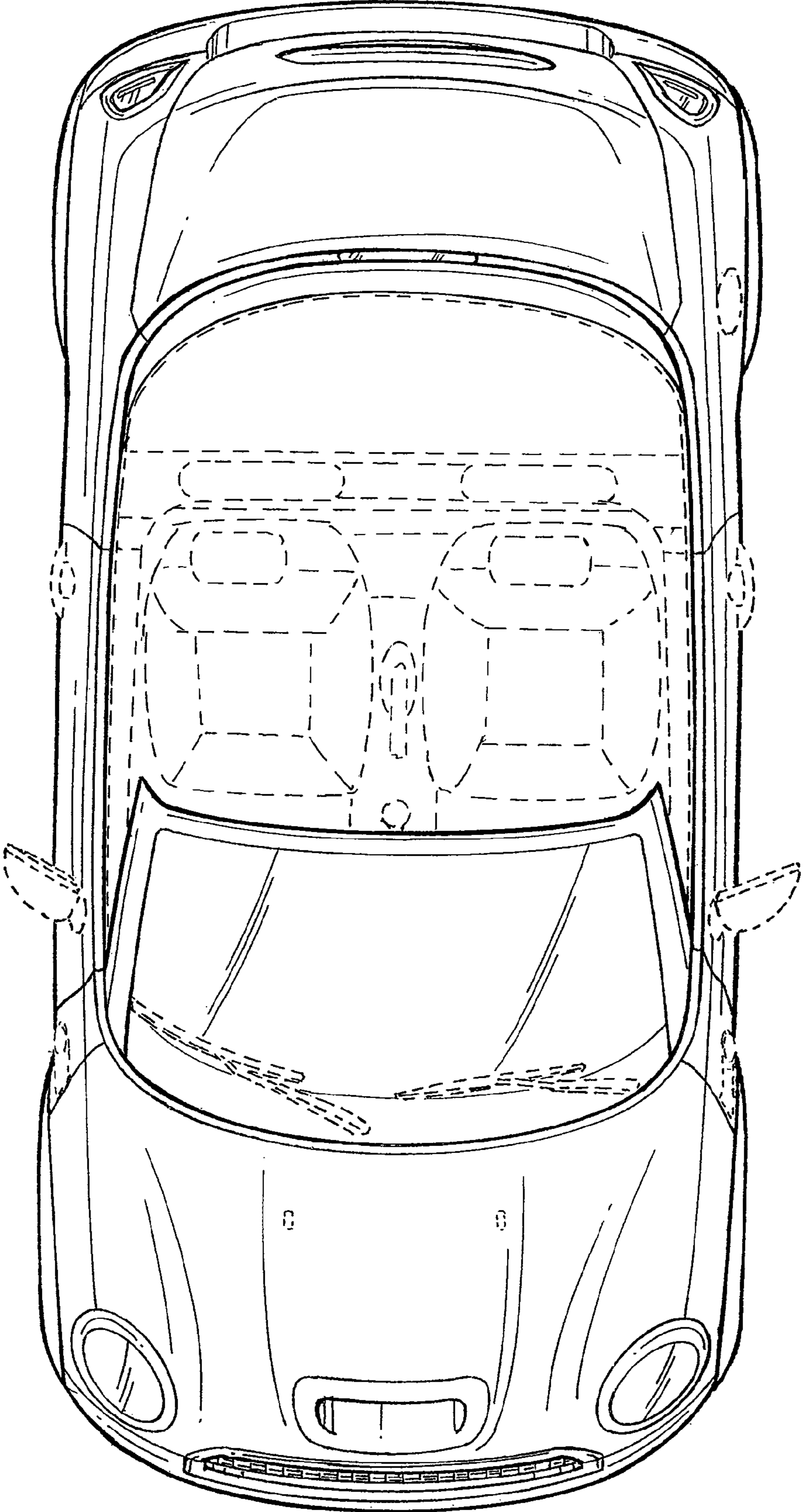
