FIG. 1 is a front, right side perspective view of the gaming machine showing our new design;

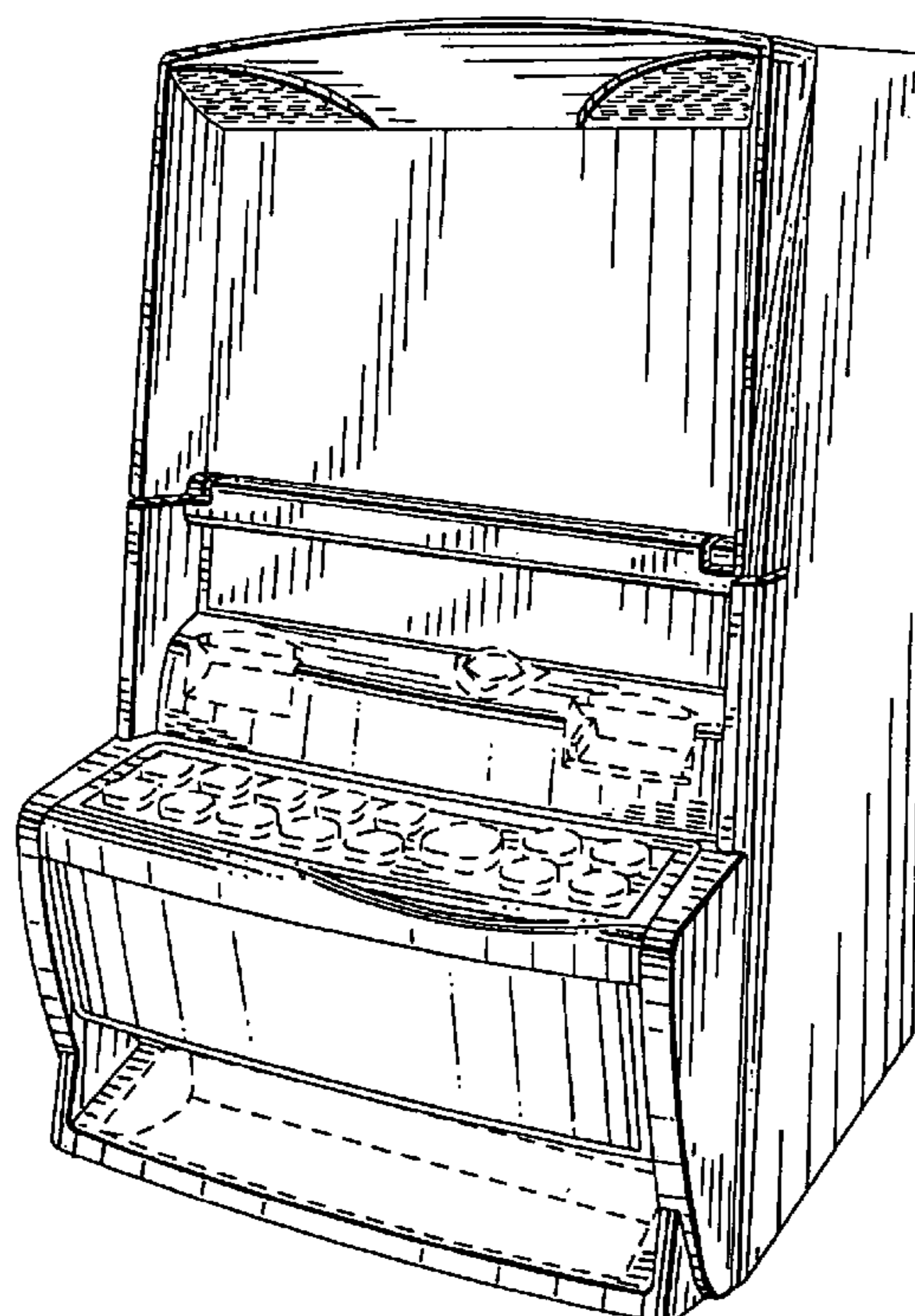
FIG. 2 is a front elevation view thereof;

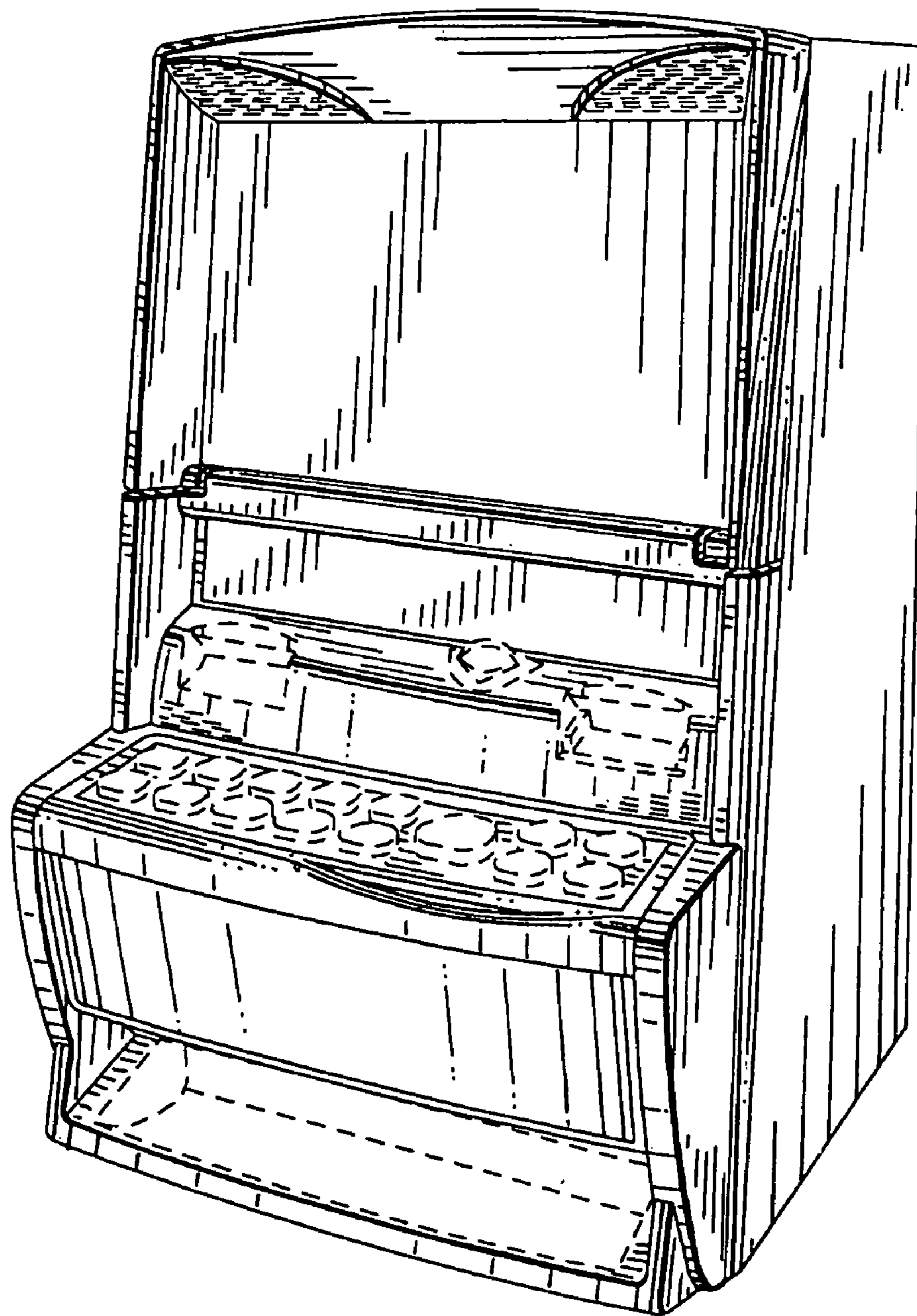

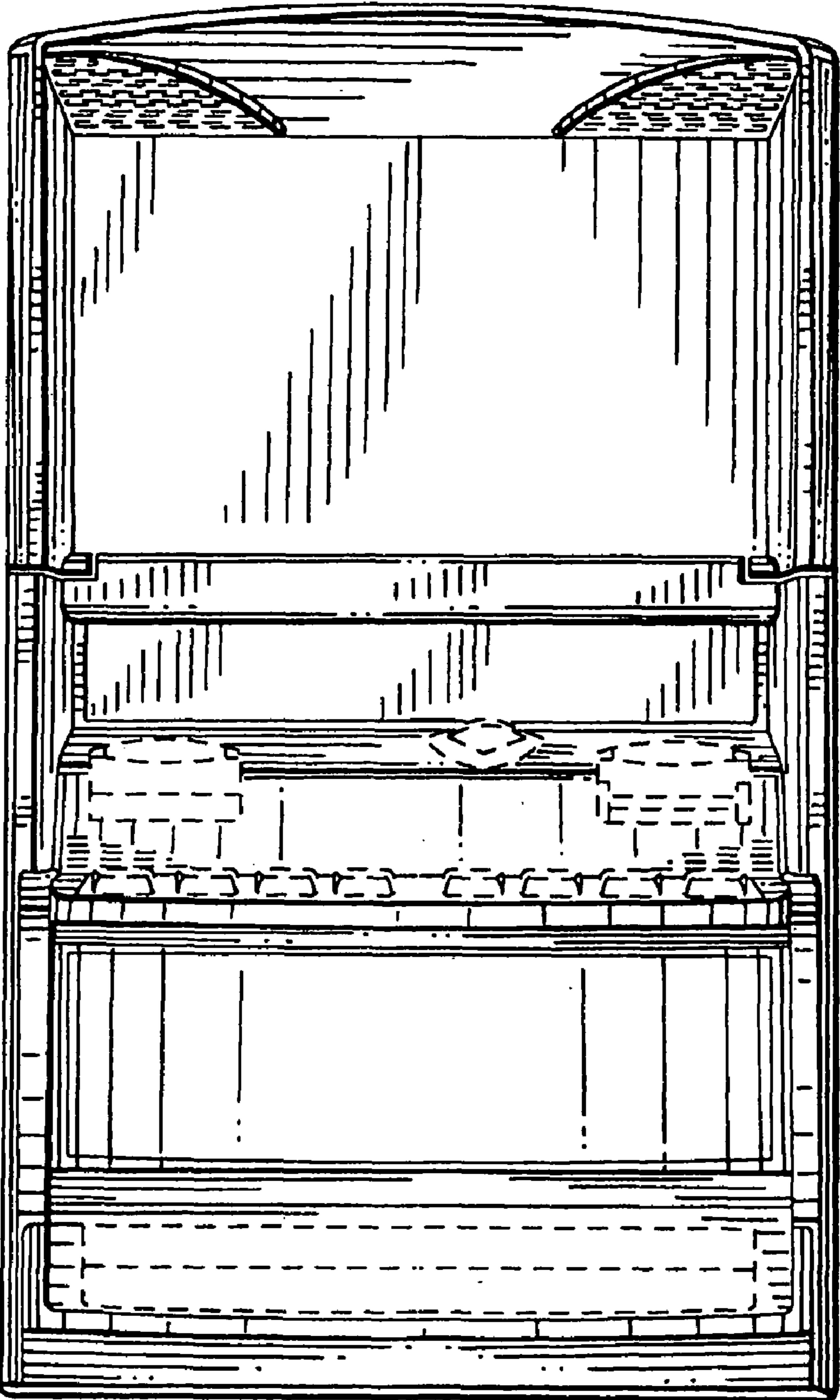

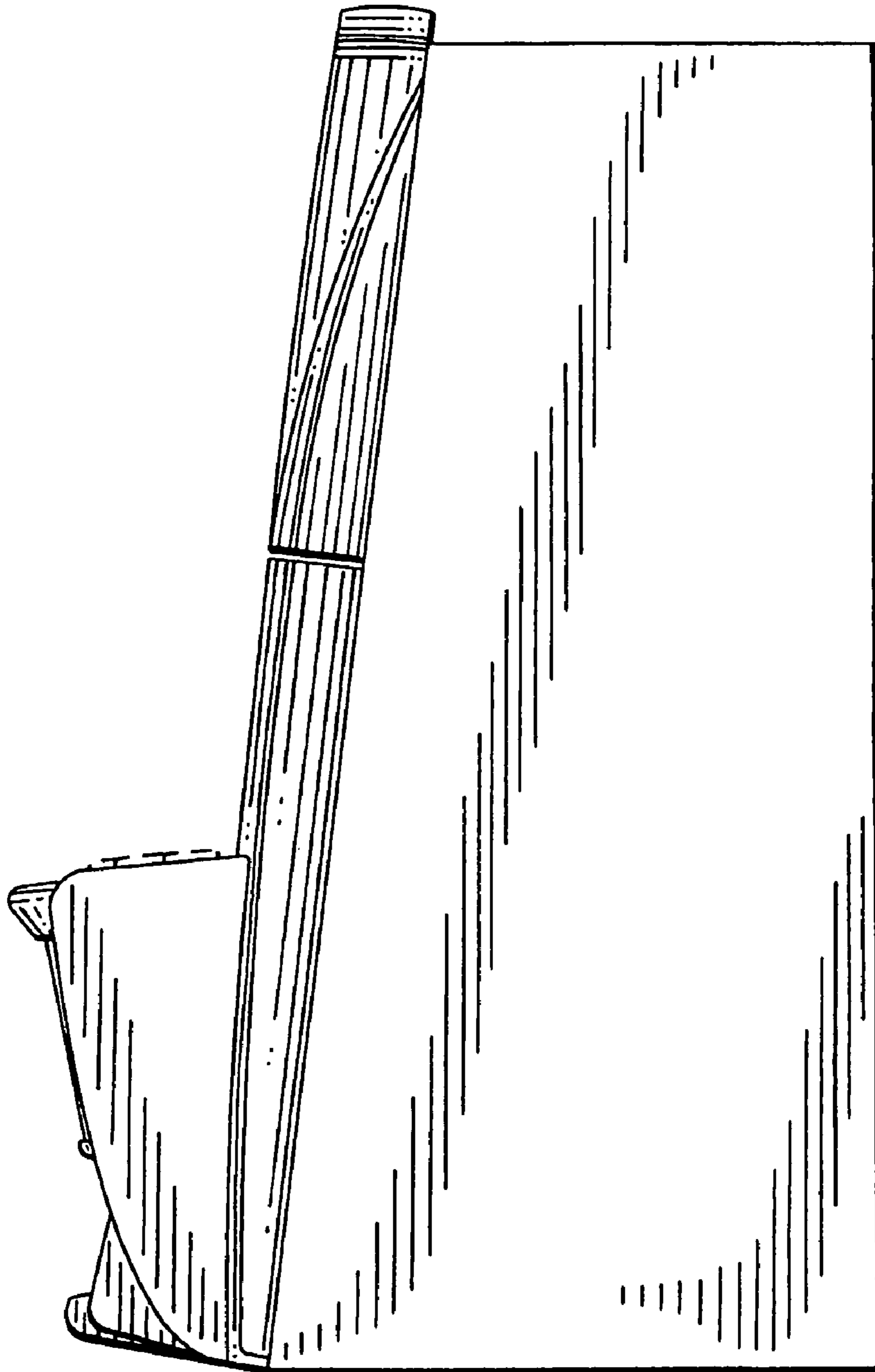

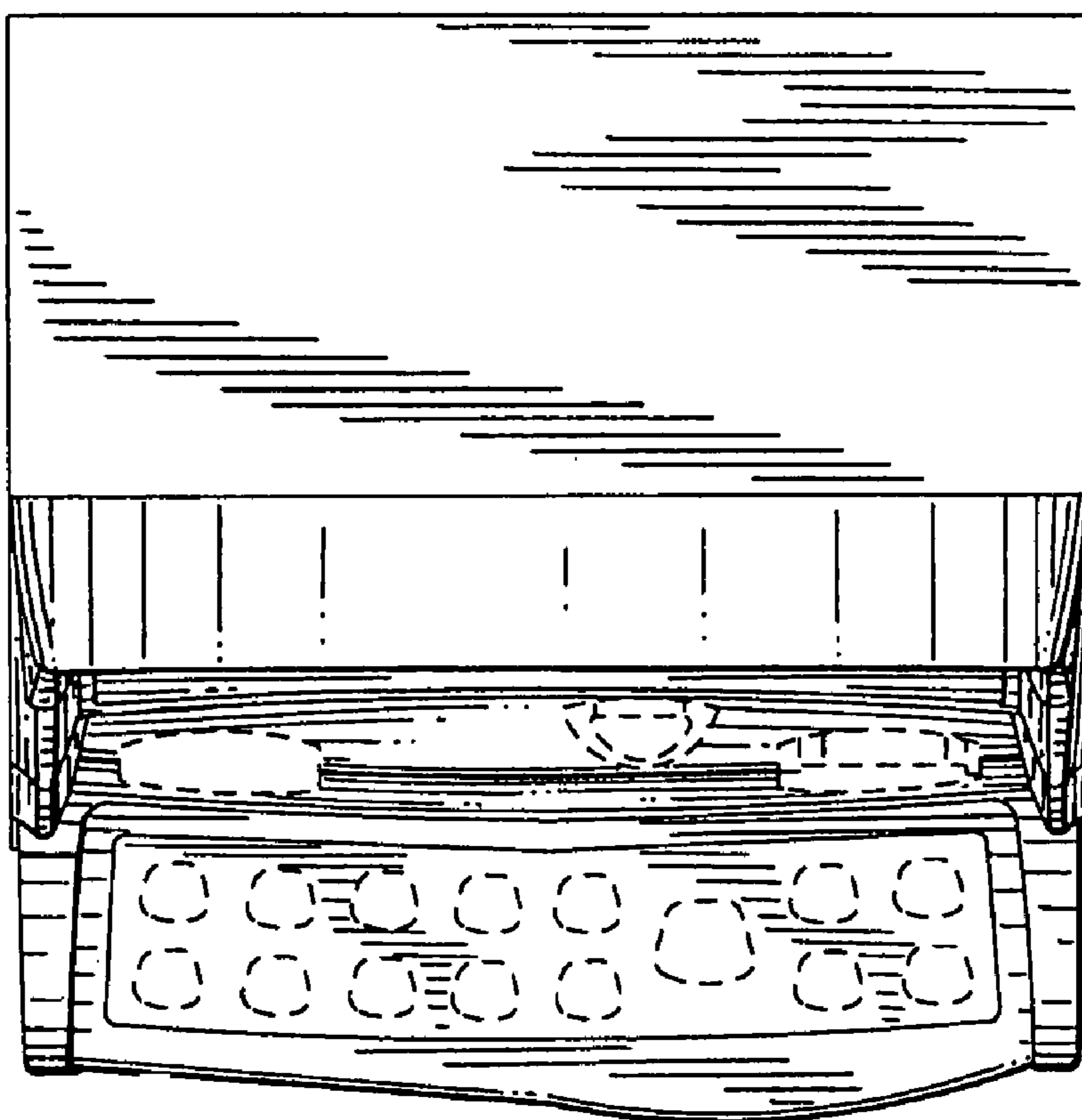
