showing my new design;

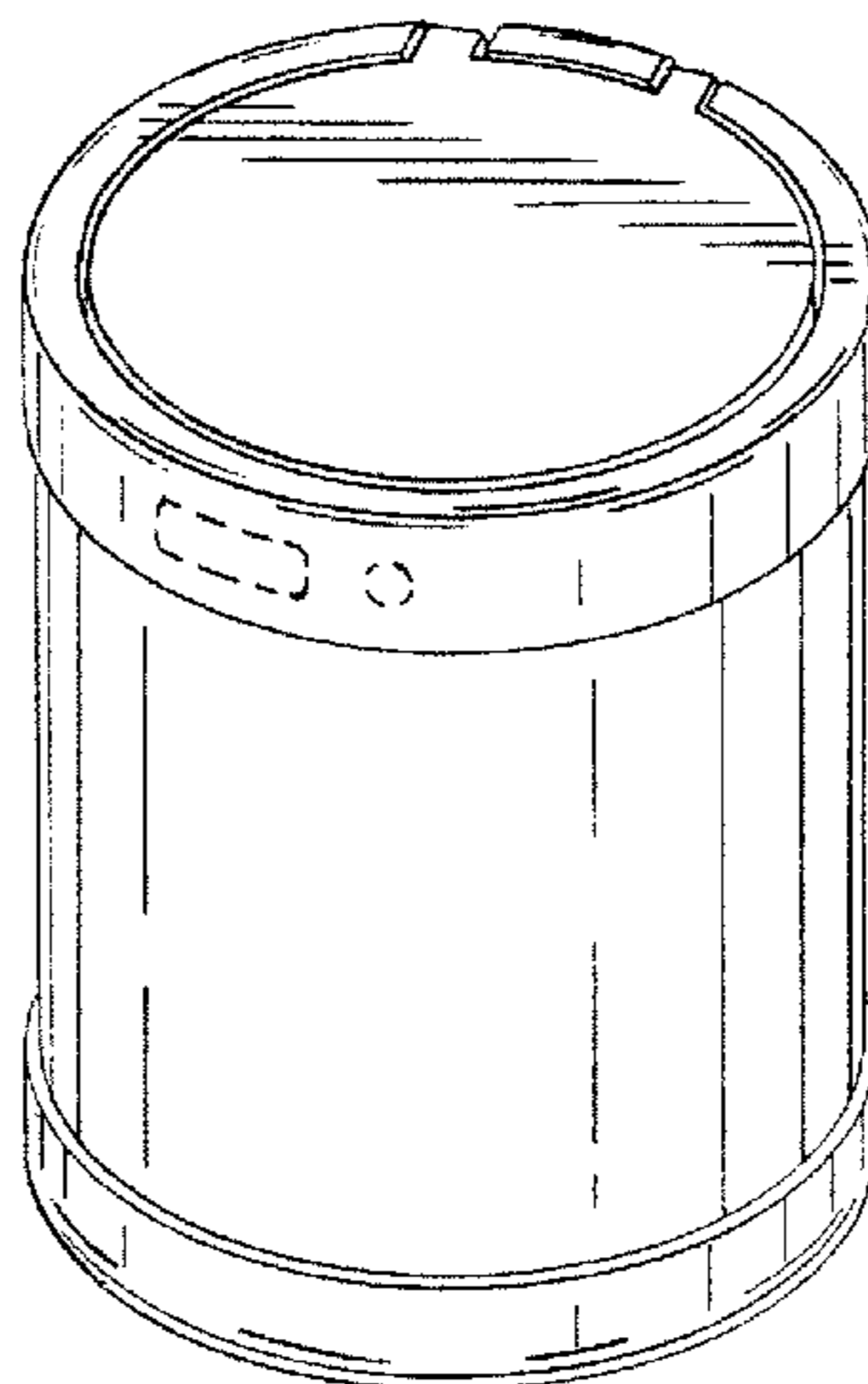
FIG. 3 is a top plan view of a towel warming device showing

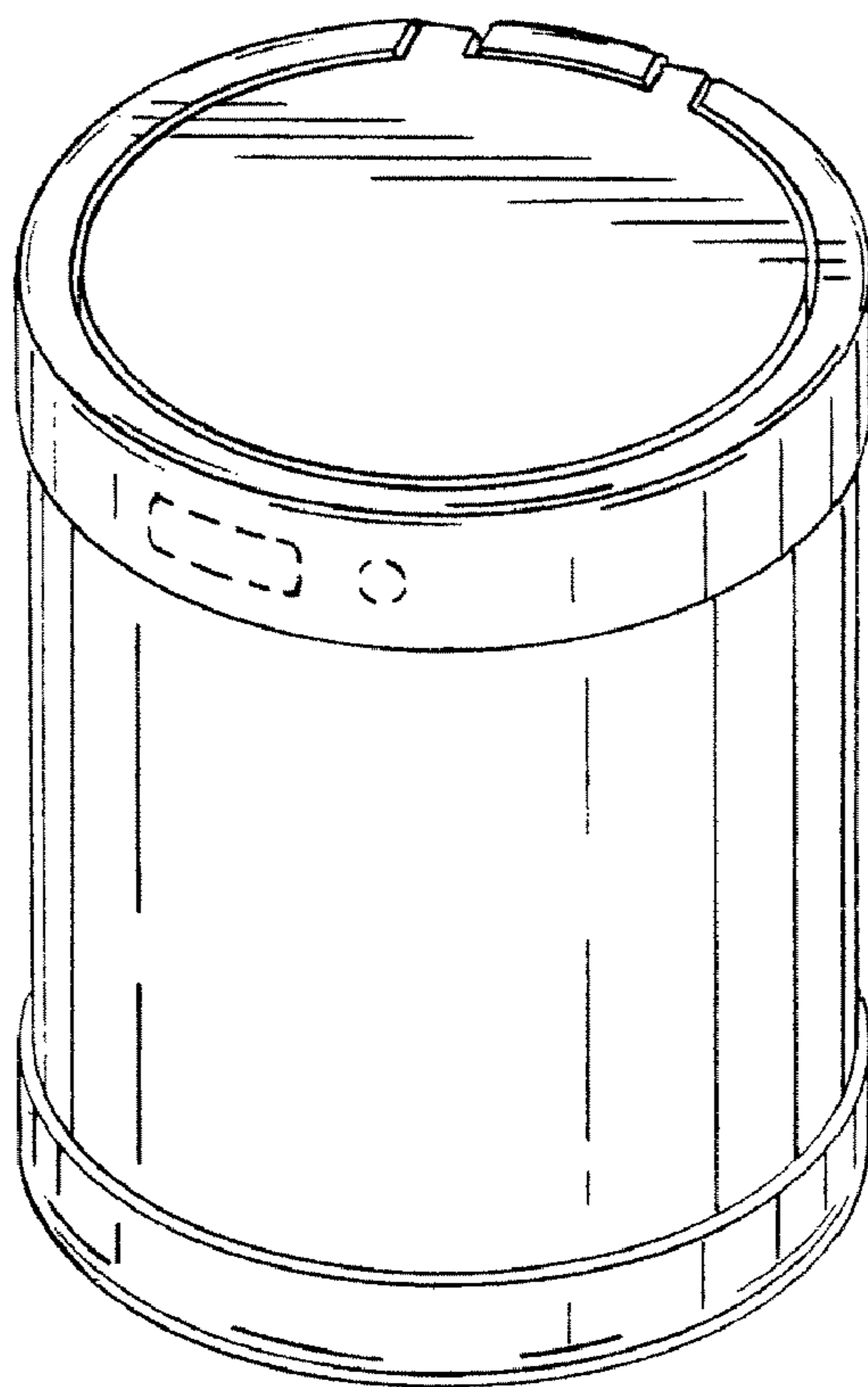

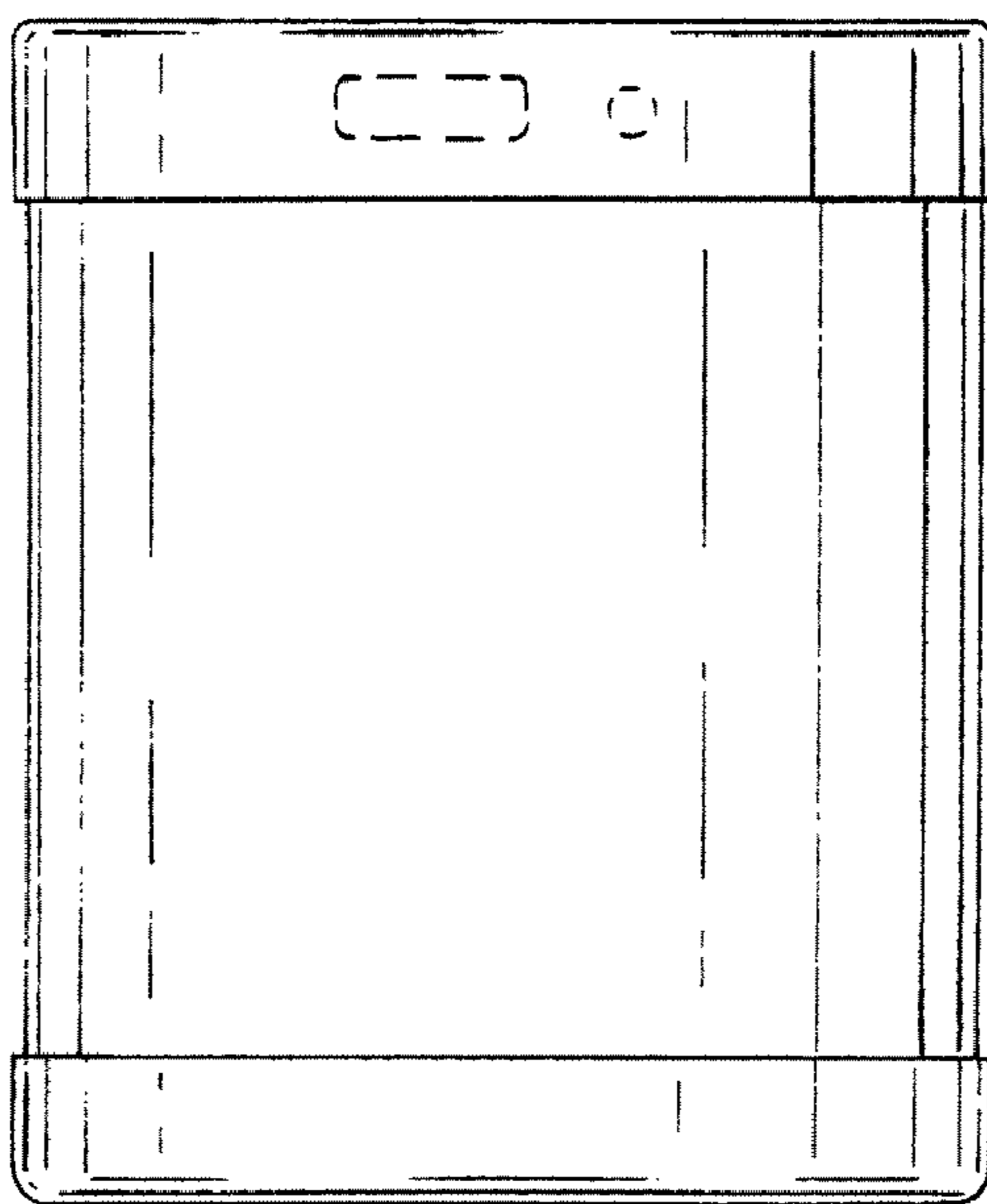

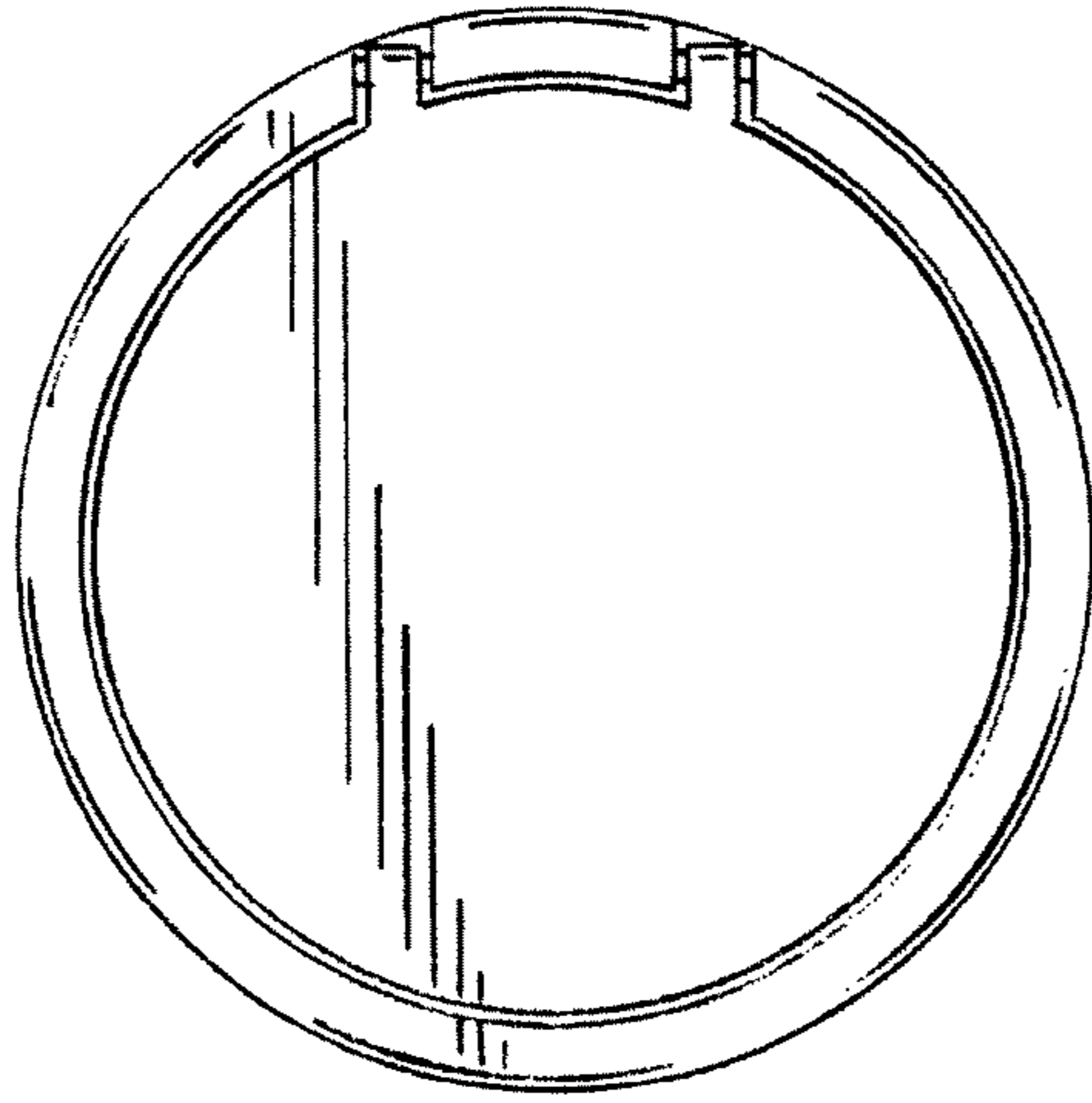

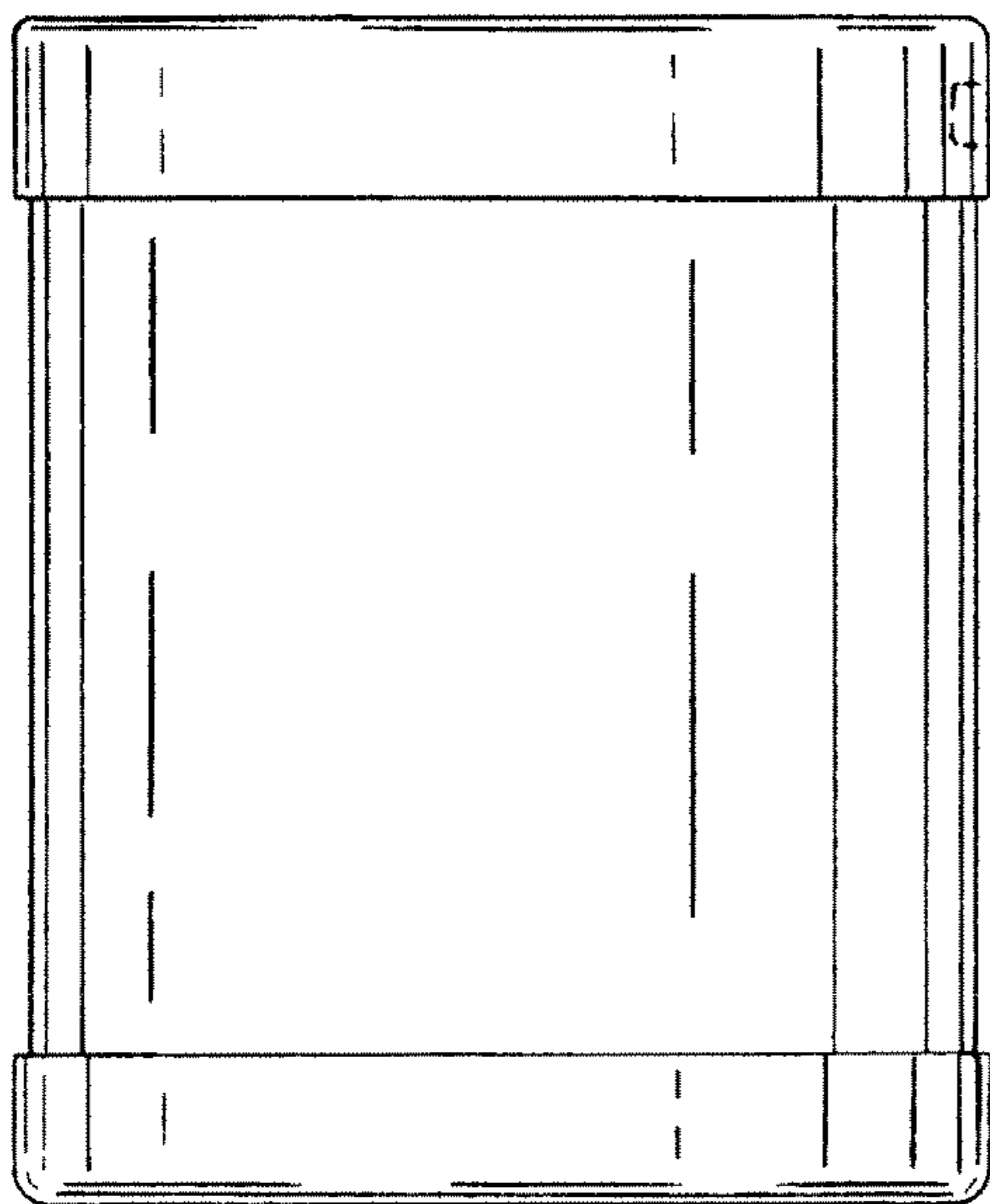

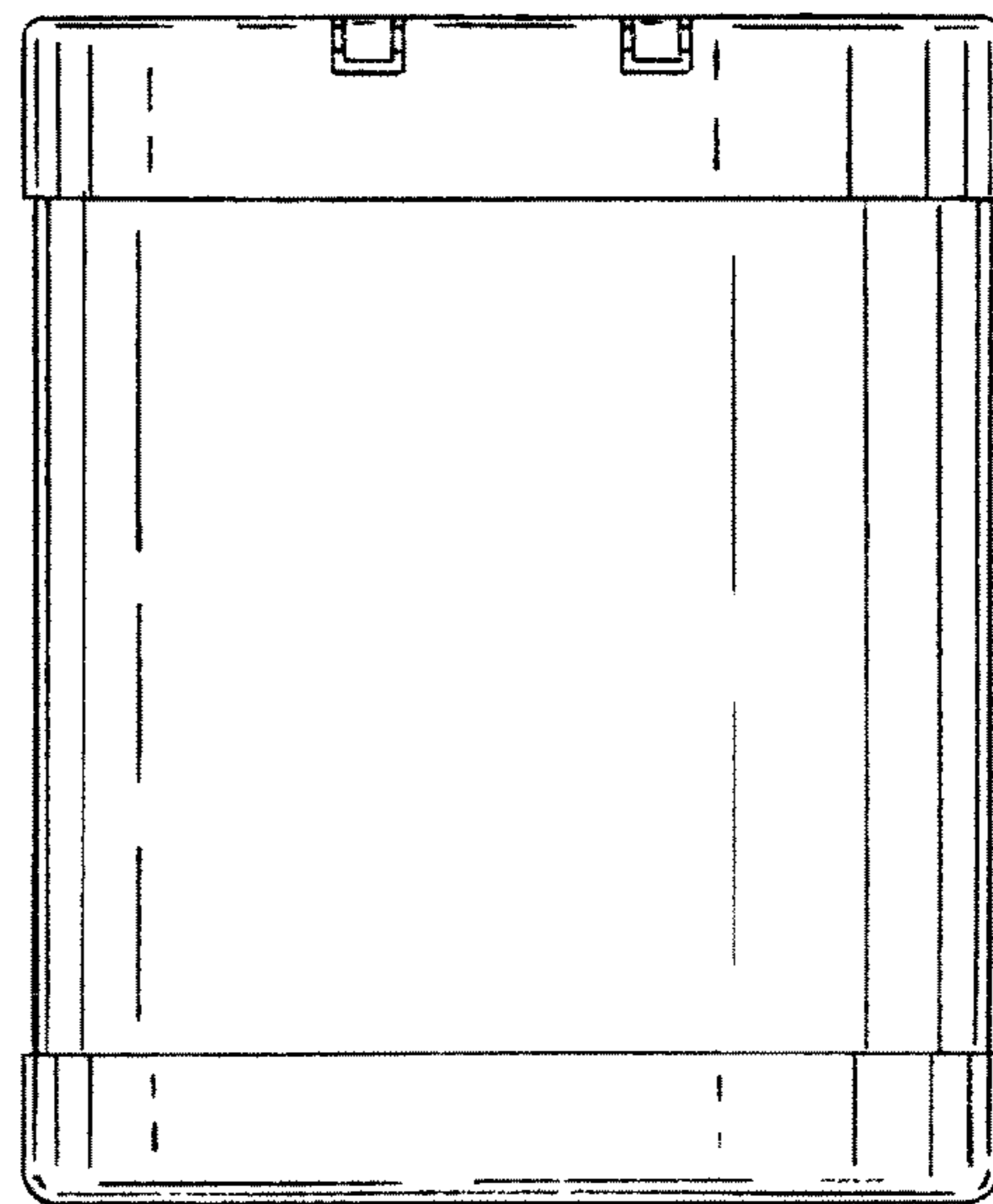
