(57) **CLAIM**

The ornamental design for a building house with integrated  
power generator system, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a building house with  
integrated power generator system showing a first embodi-  
ment of the new design;

FIG. 2 is a front elevational view thereof, the rear elevational  
view and the left side elevational view being identical;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a top perspective view of a building house with  
integrated power generator system showing a second embodi-  
ment of the new design;

FIG. 7 is a front elevational view thereof, the rear elevational  
view being identical;

FIG. 8 is a right side elevational view thereof;

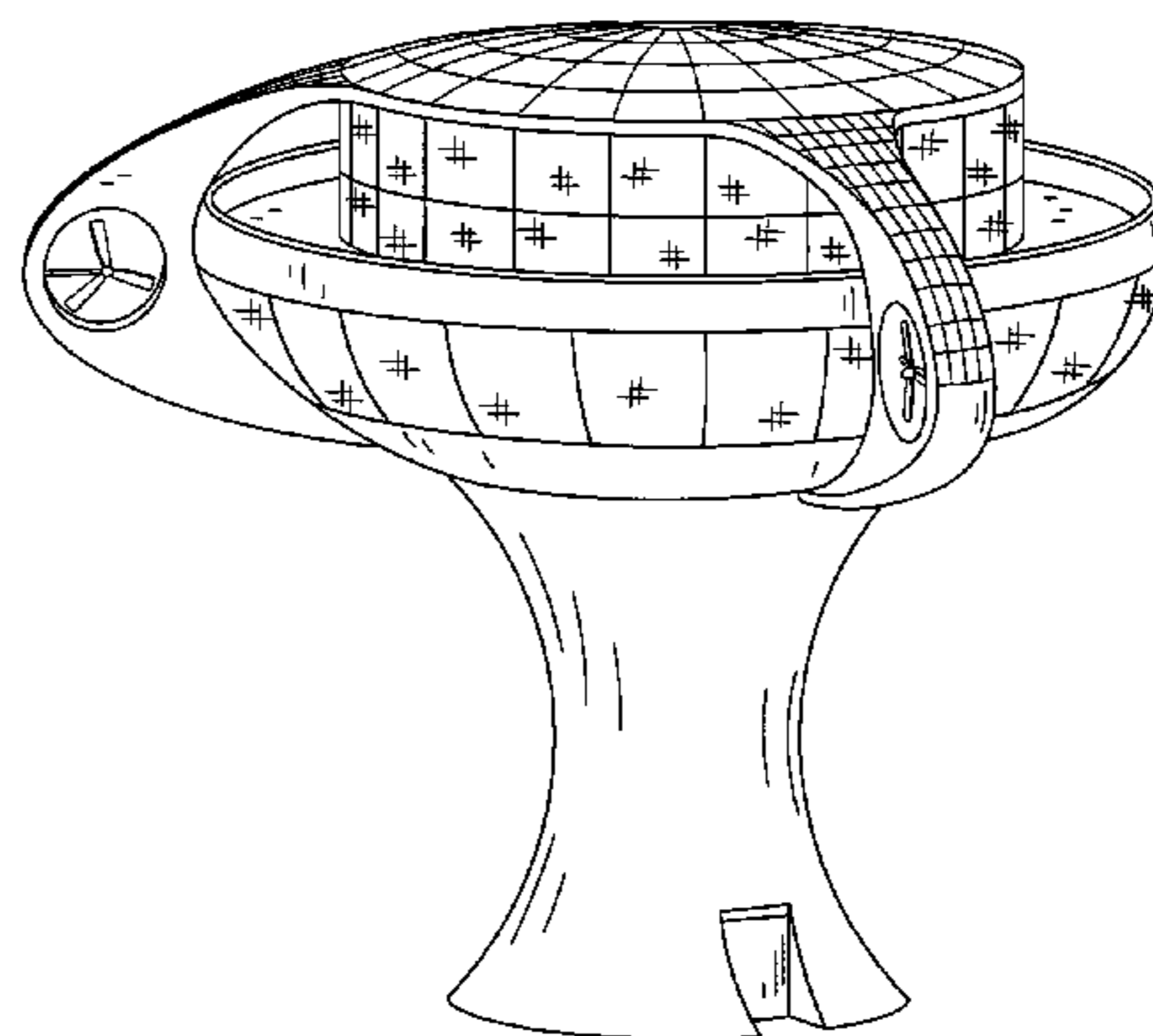
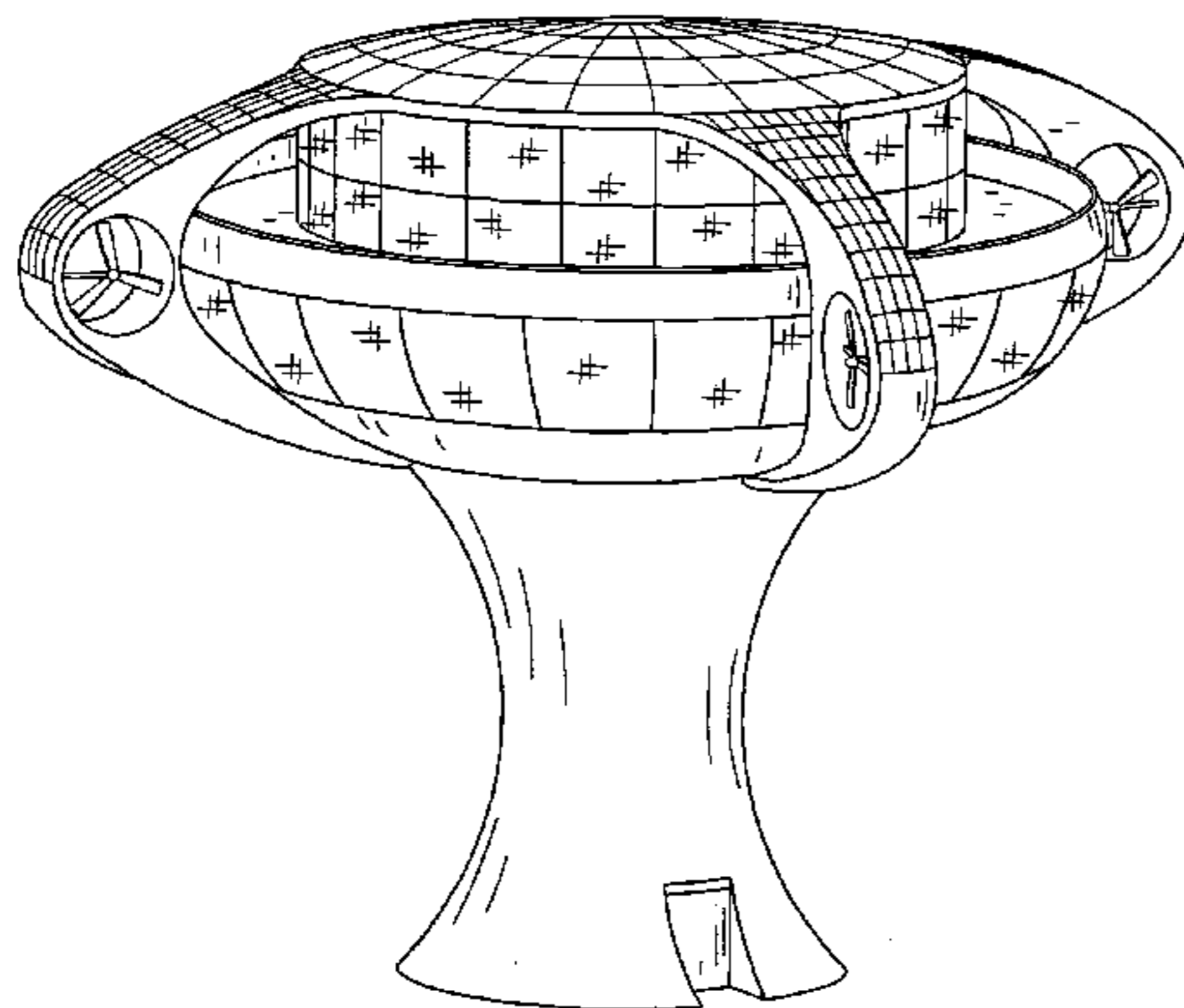
FIG. 9 is a bottom plan view thereof;

FIG. 10 is a left side elevational view thereof; and,

FIG. 11 is a top plan view thereof.

In FIGS. 2 and 7, the broken lines representing elements such

of the design. In FIGS. 5 and 9, the broken lines representing  
partially hidden lower sections of the curved supports that are  
not sufficiently detailed are for illustrative purposes only and  
do not form part of the design.

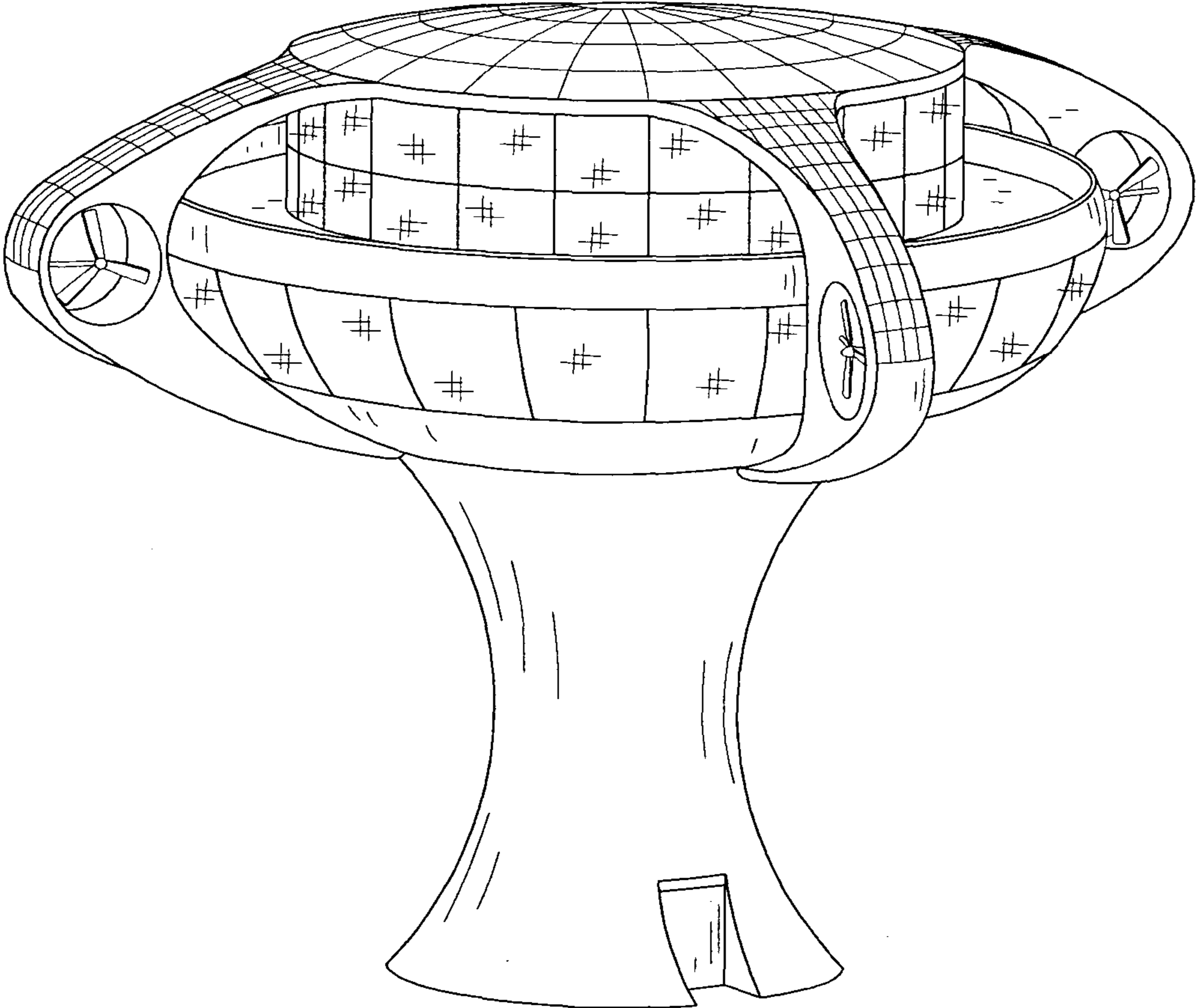

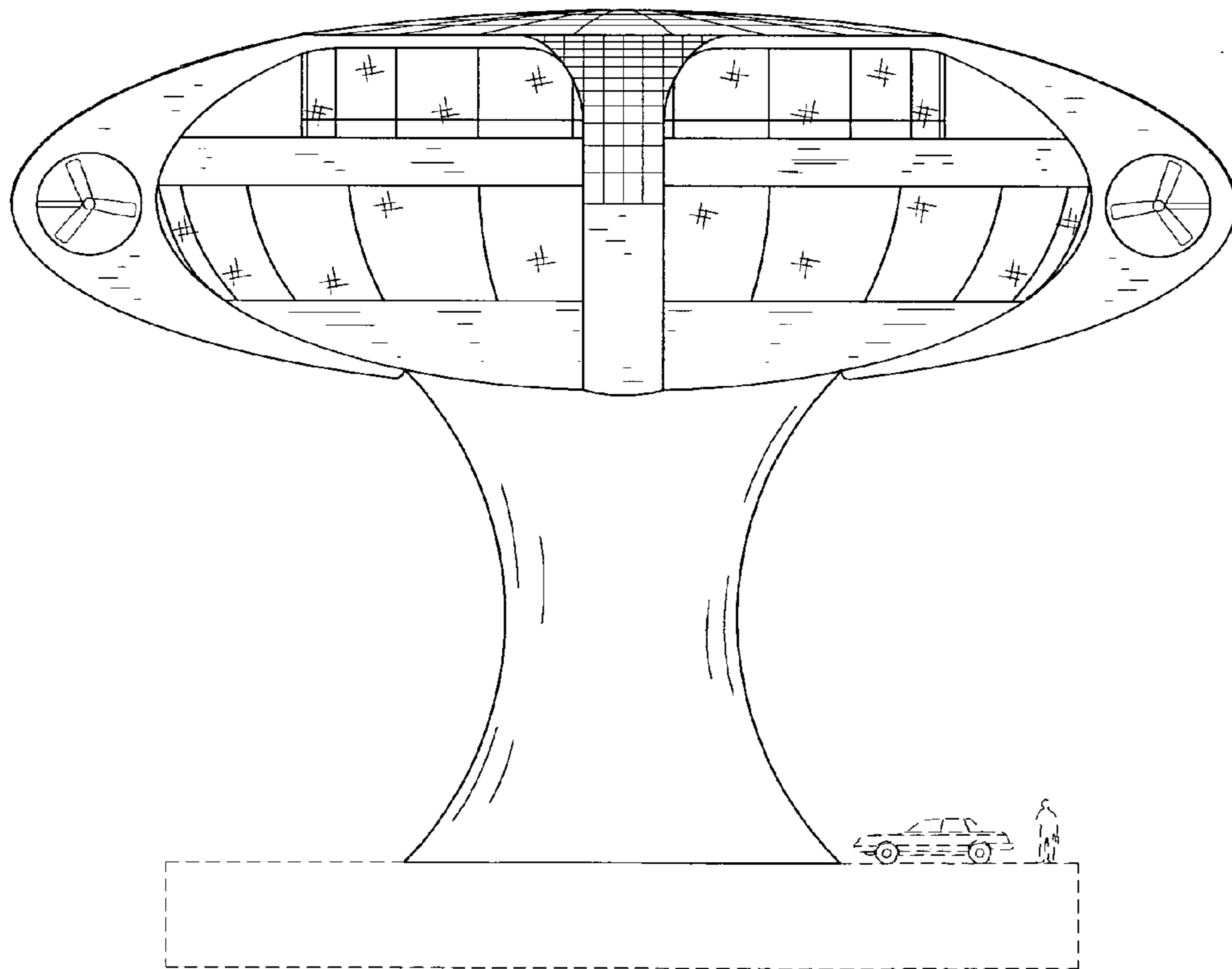

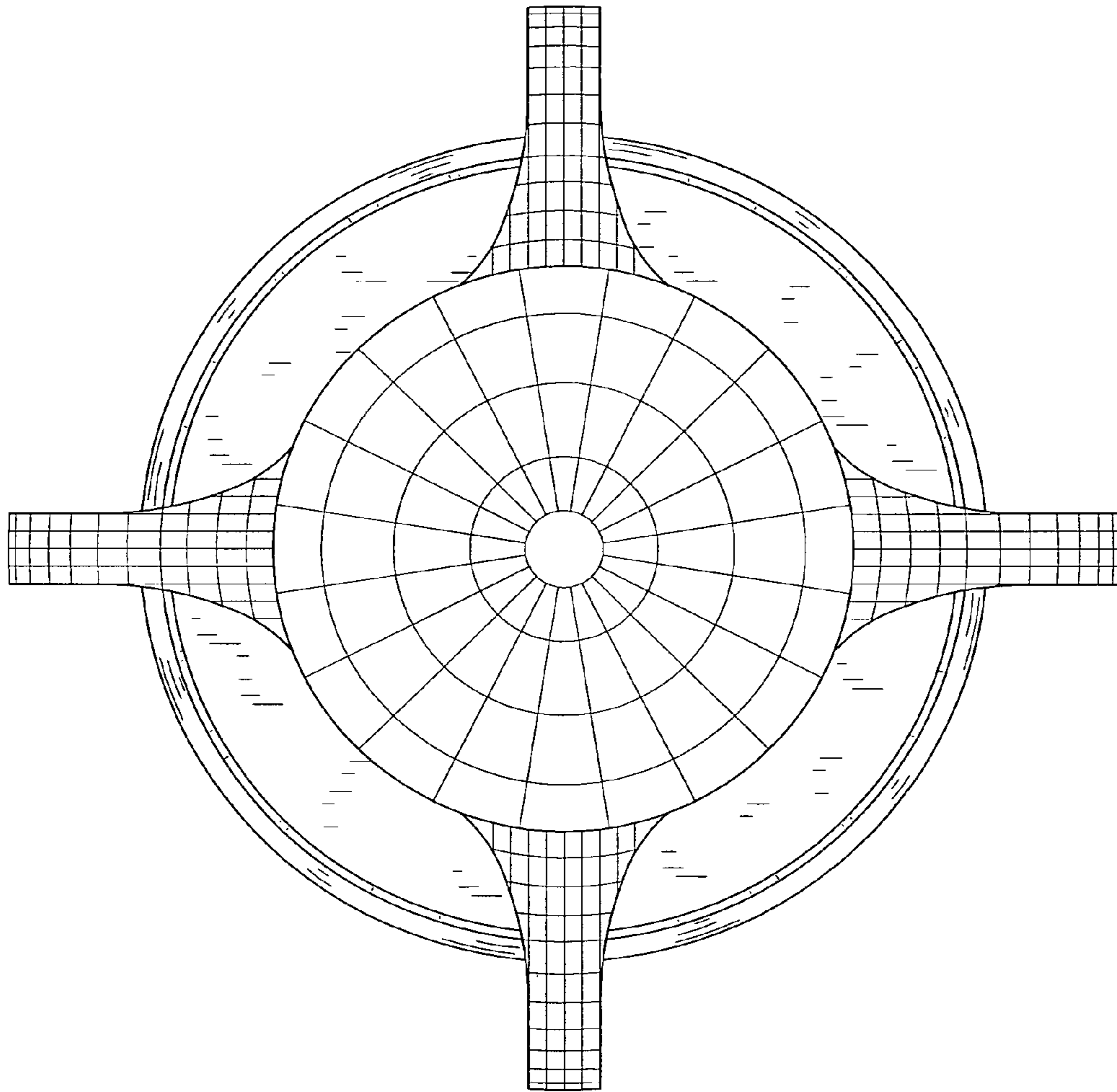

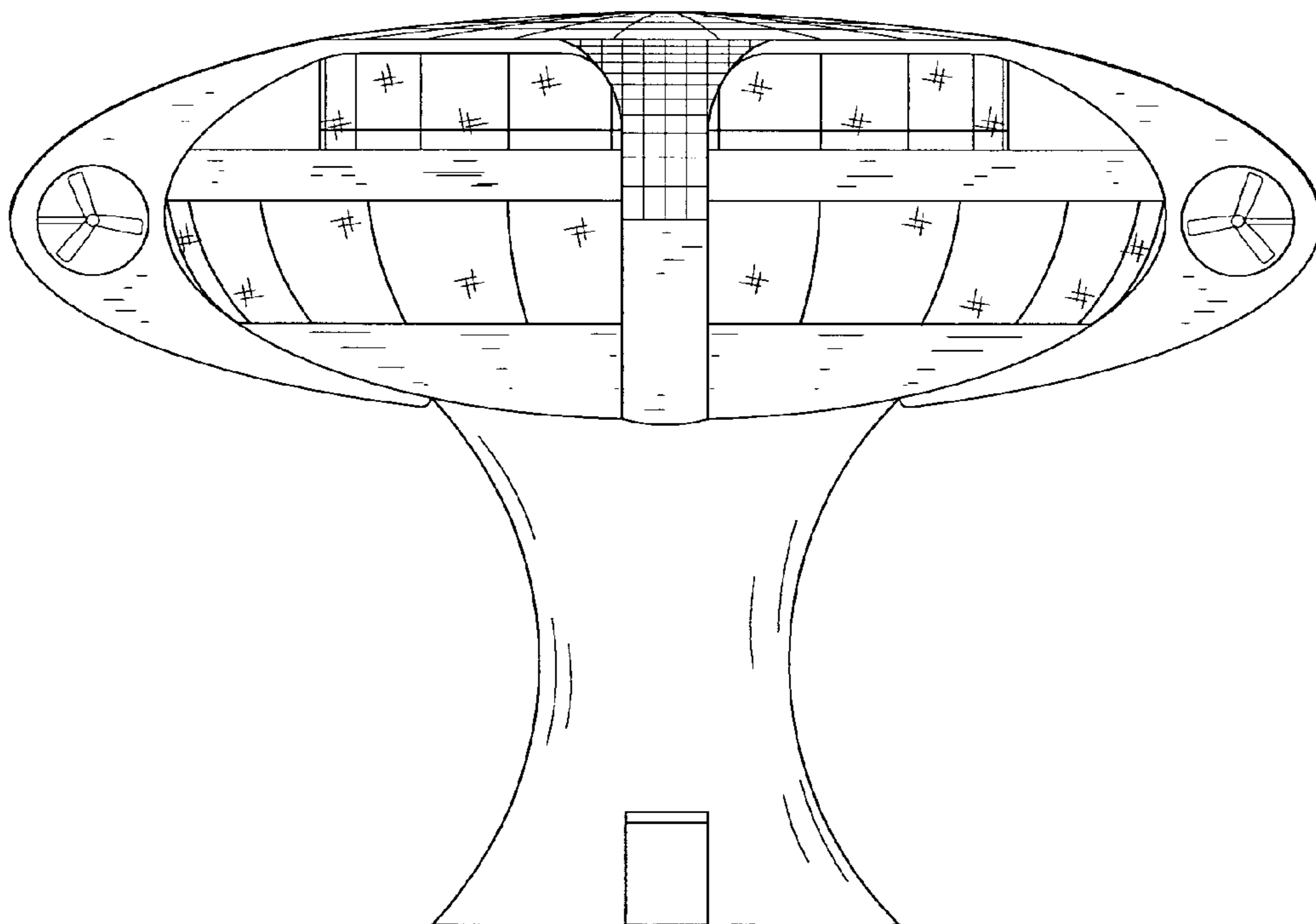

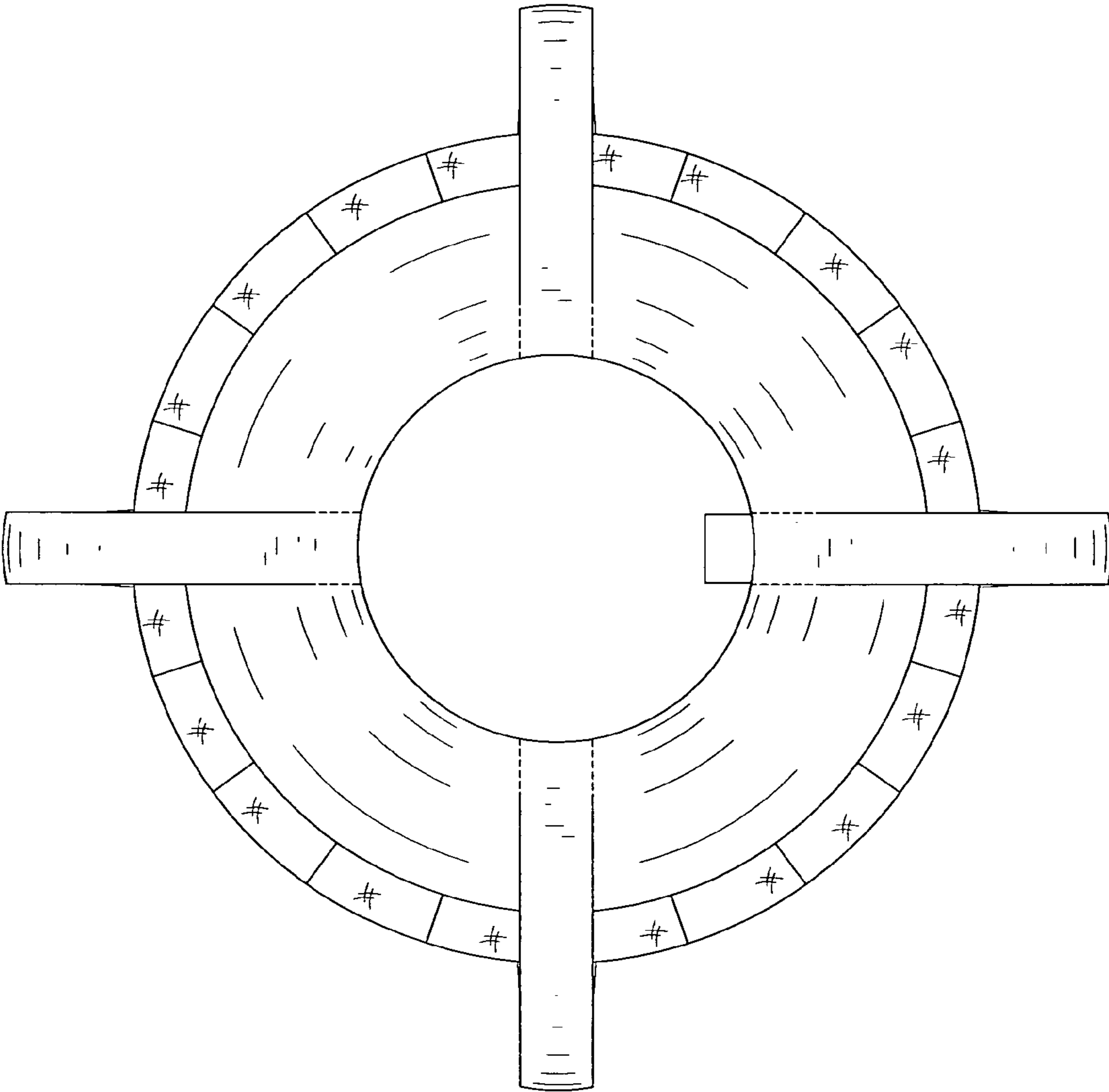

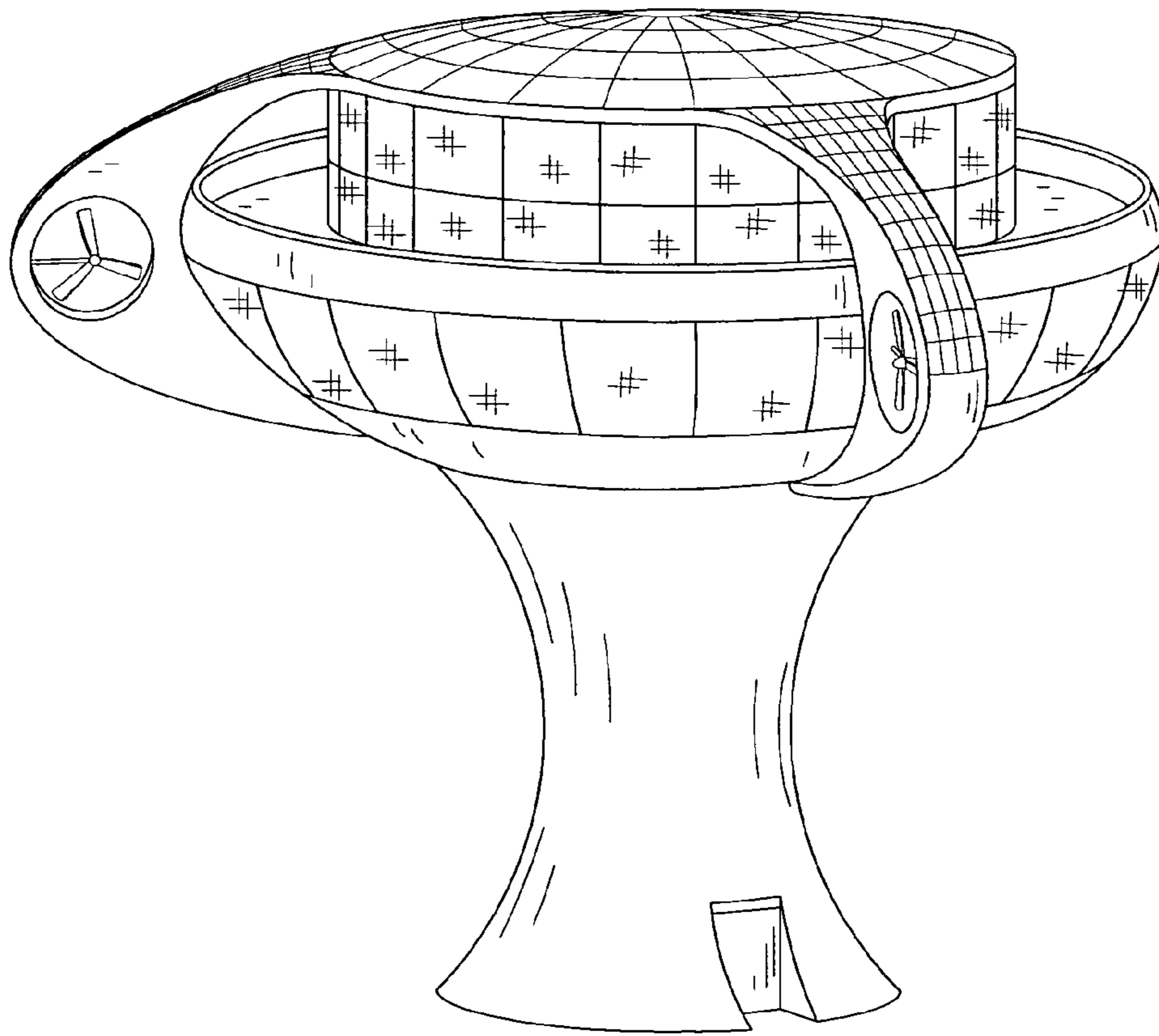

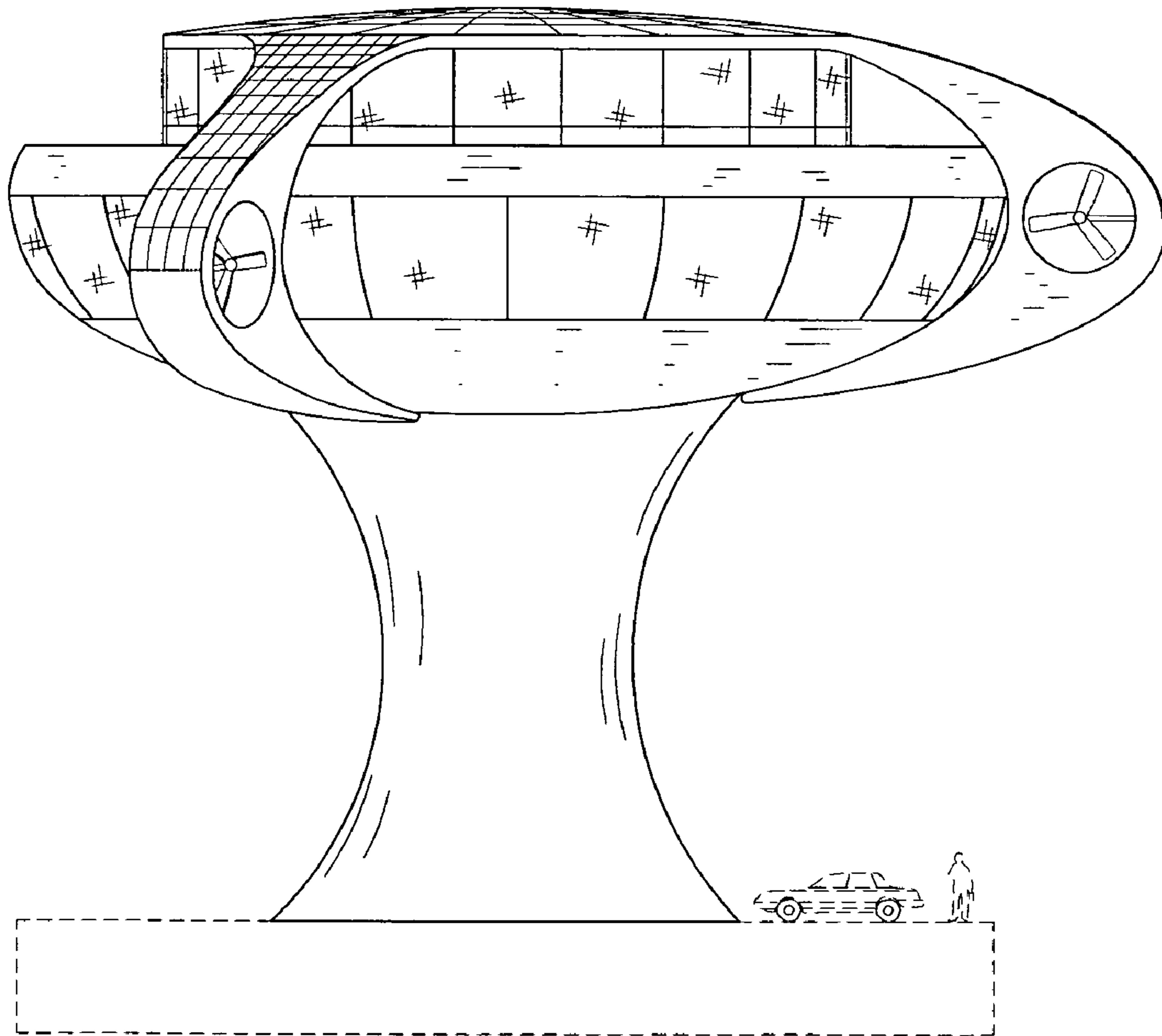

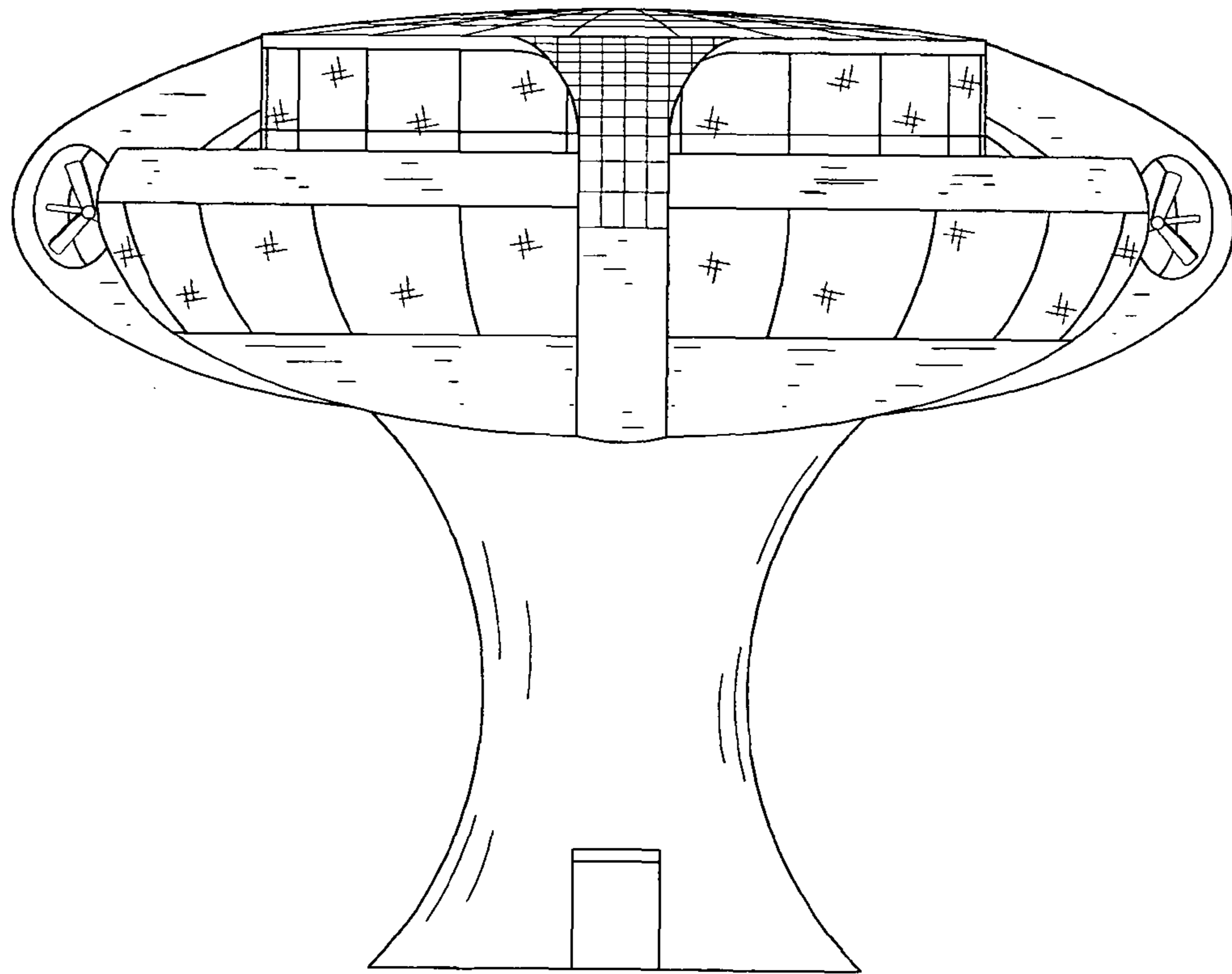

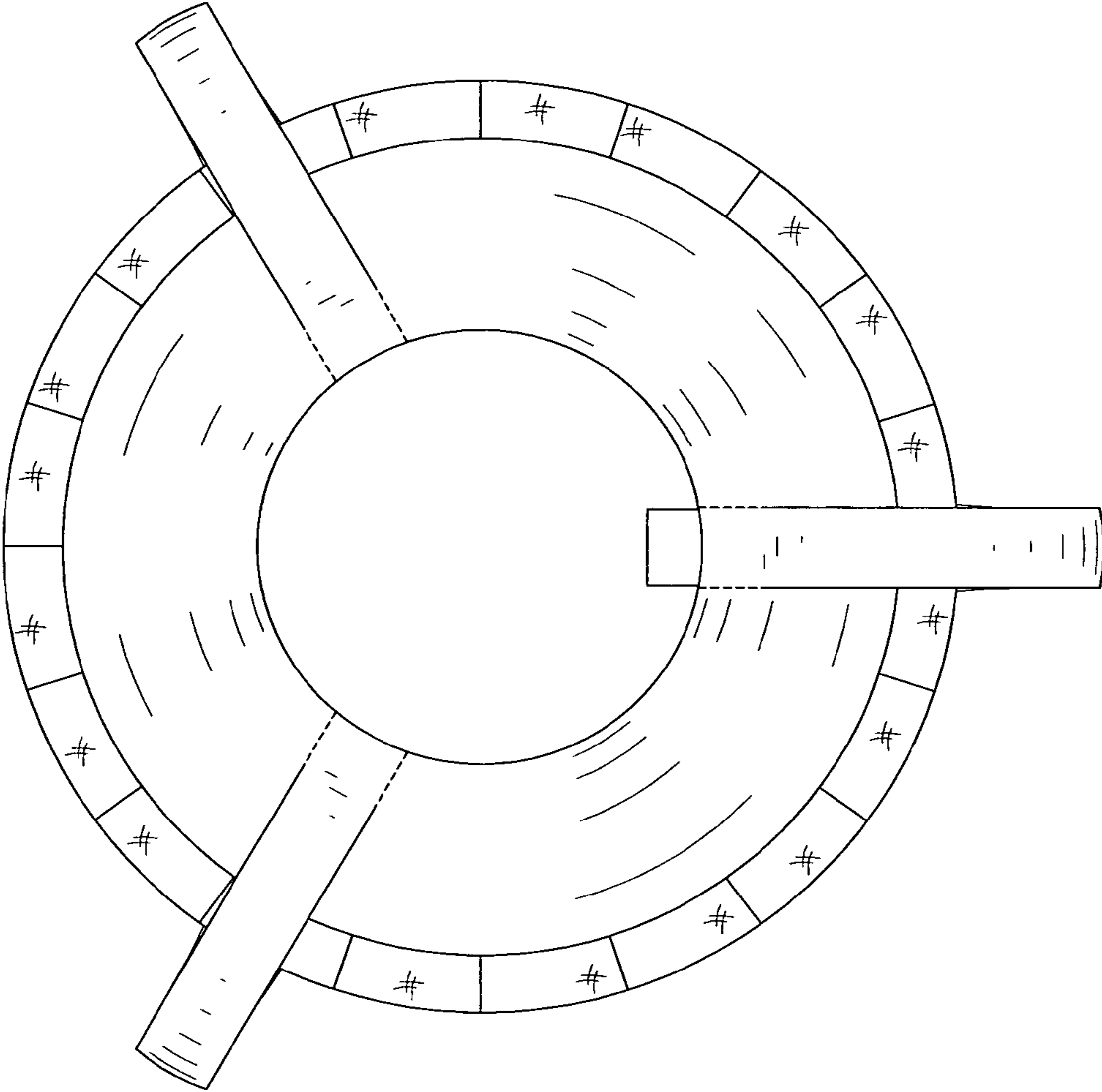

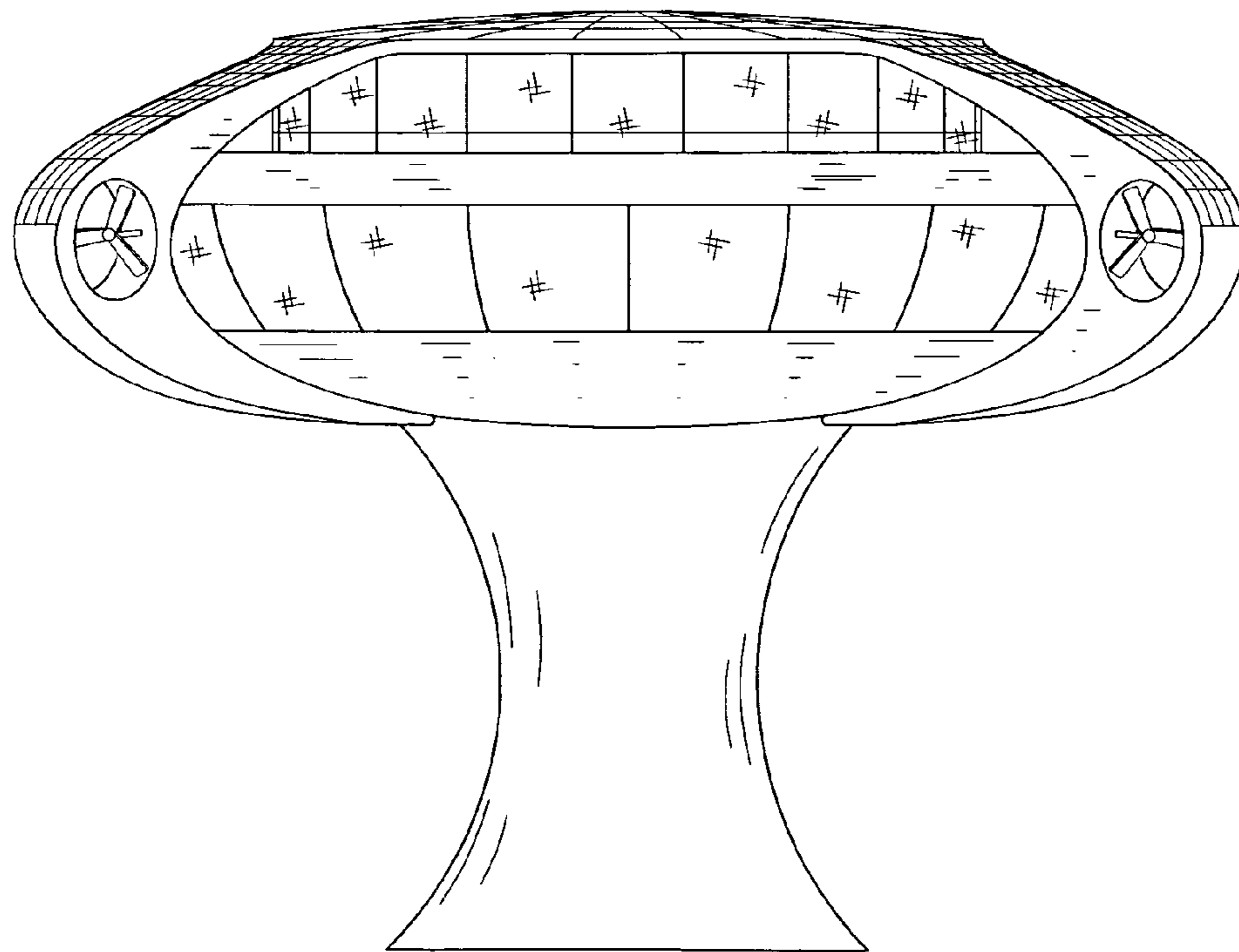

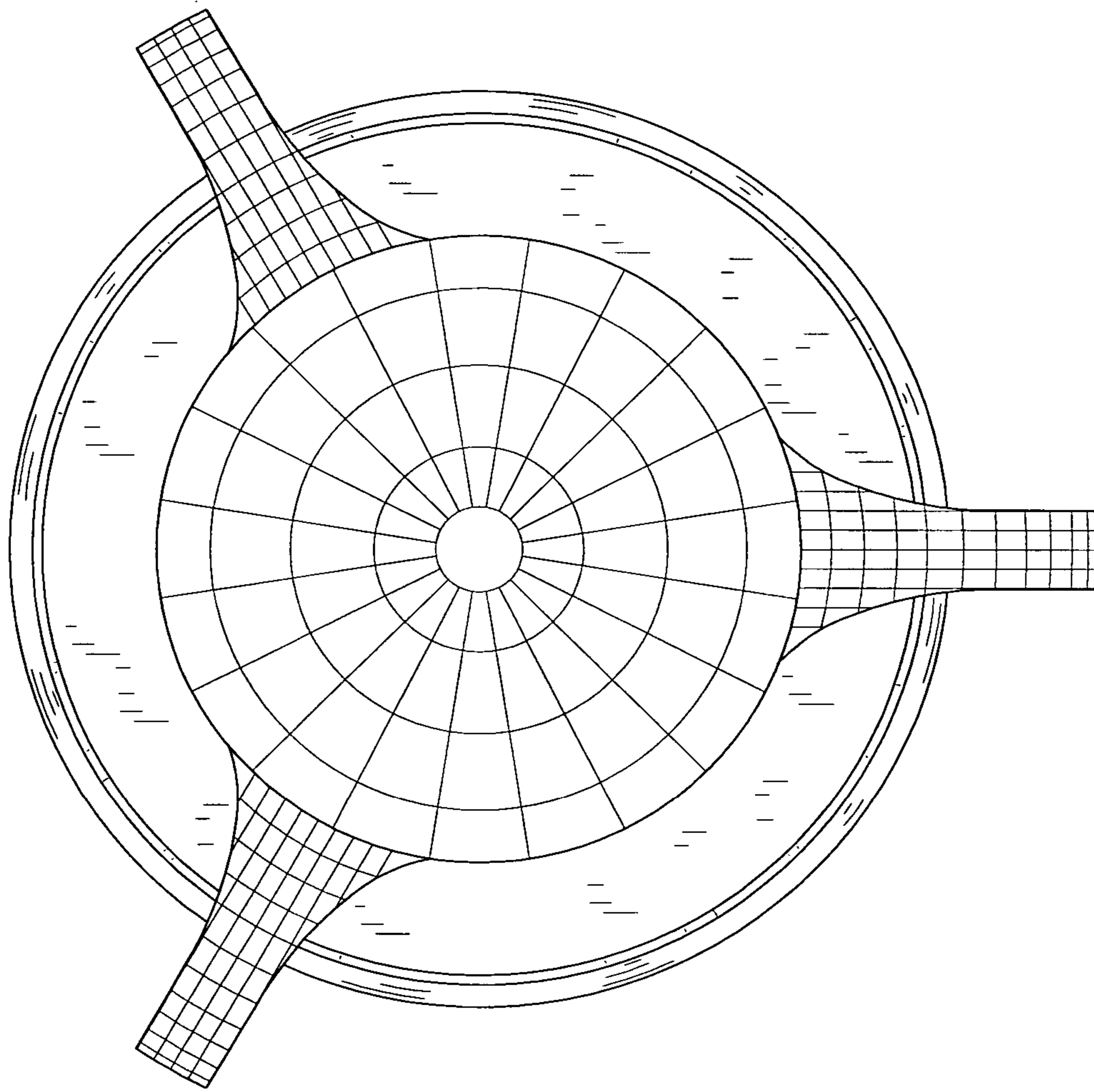
