FIG. 11 is a left side view thereof;

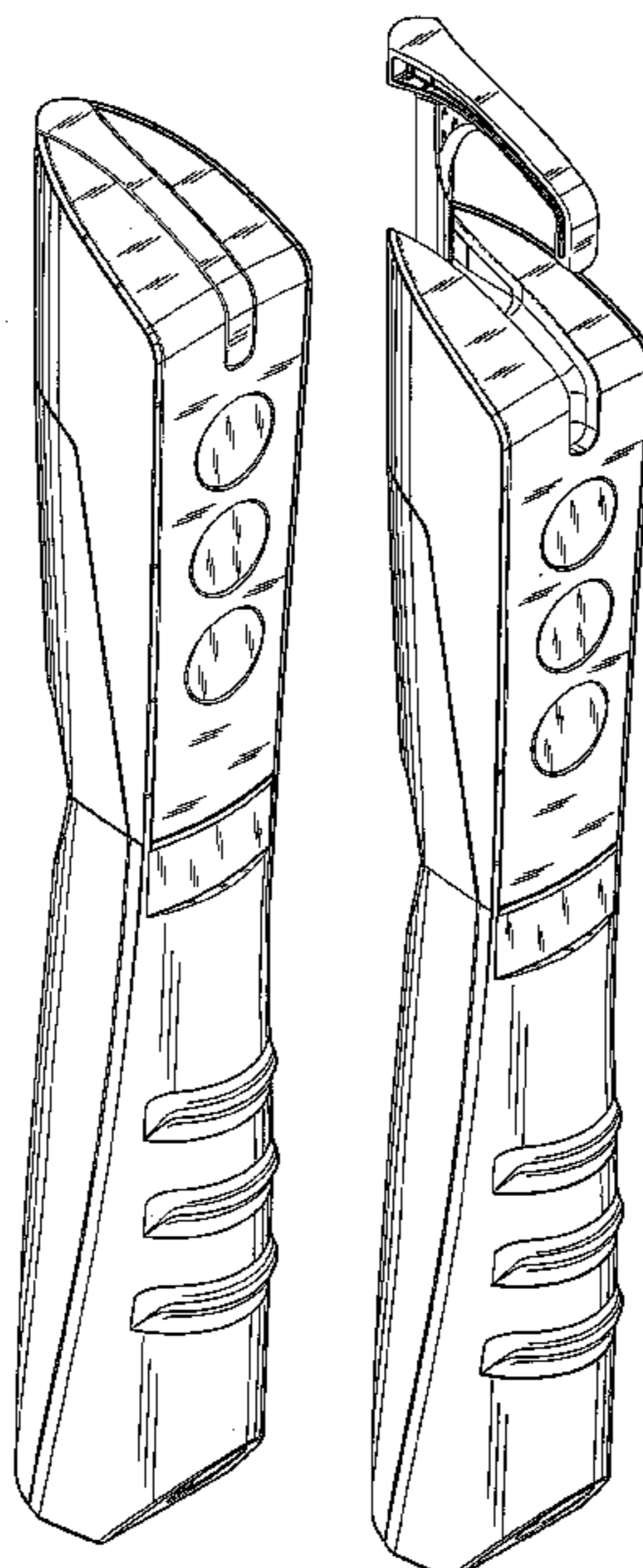
FIG. 12 is a right side view thereof;

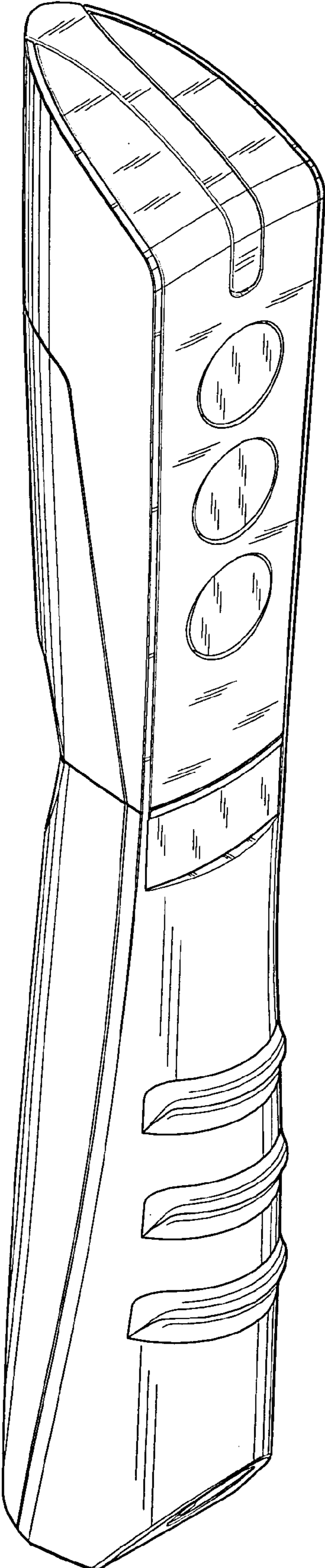
FIG. 13 is a top view thereof; and,

FIG. 14 is a bottom view thereof.

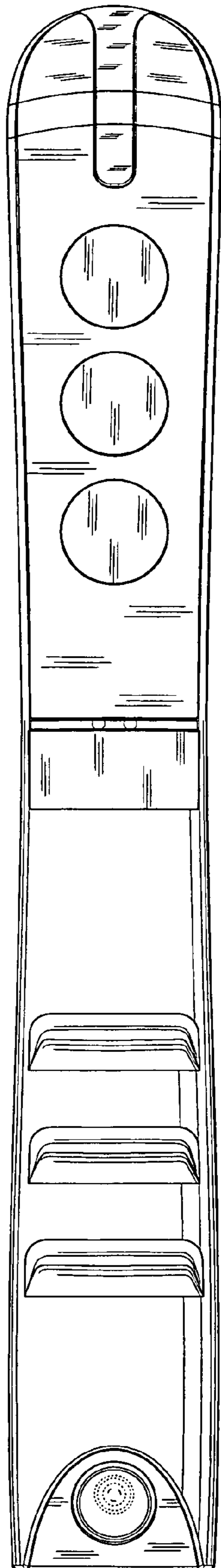
The broken lines in FIGS. 2, 3, 7, 9, 10, and 14 form no part of the claimed design.

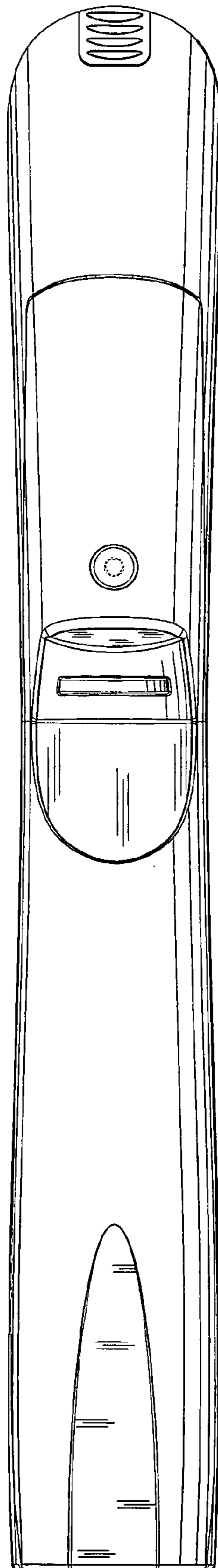




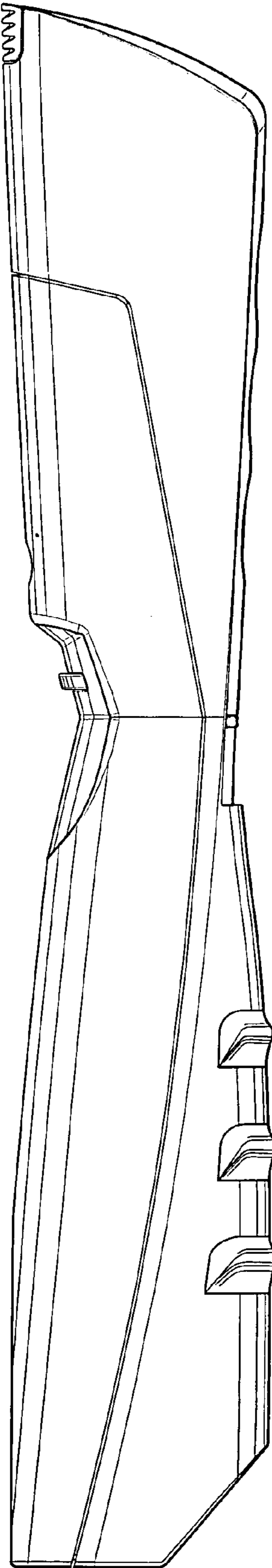

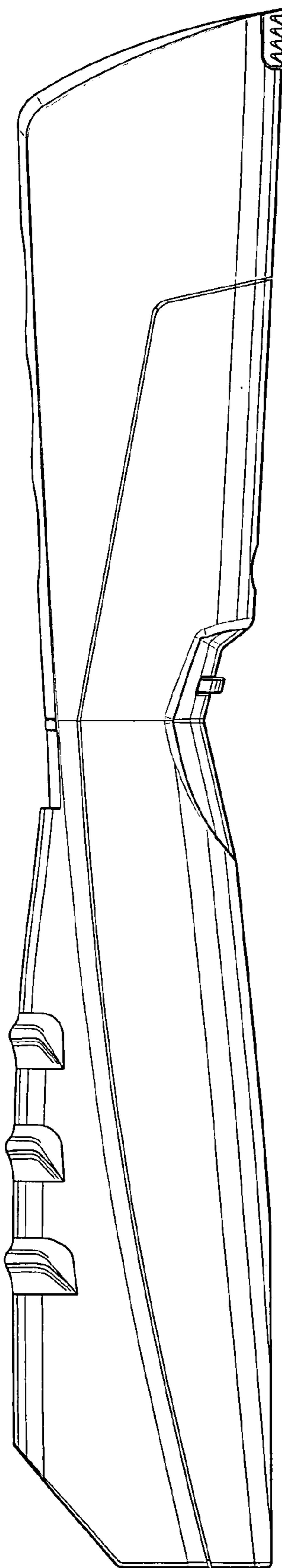

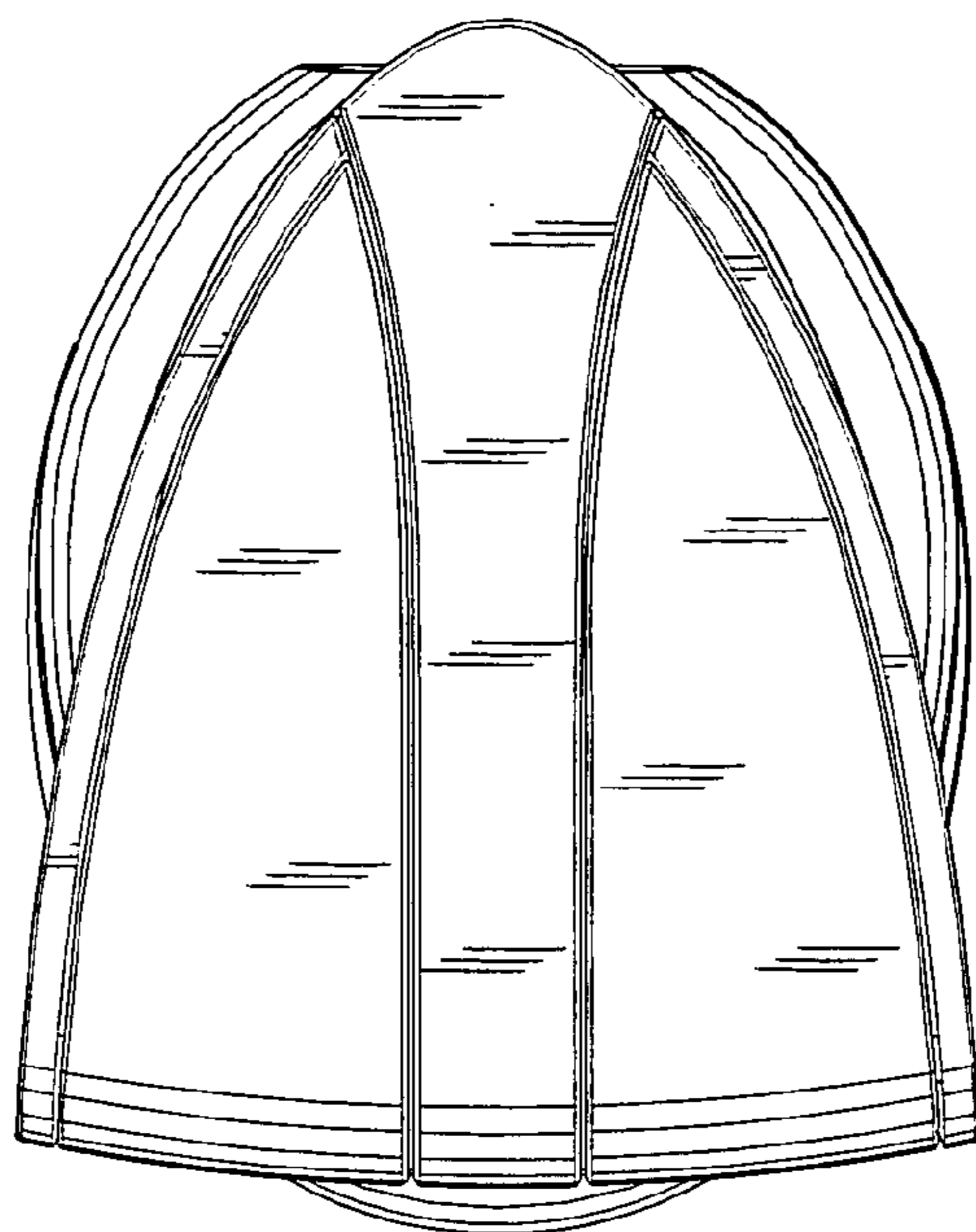

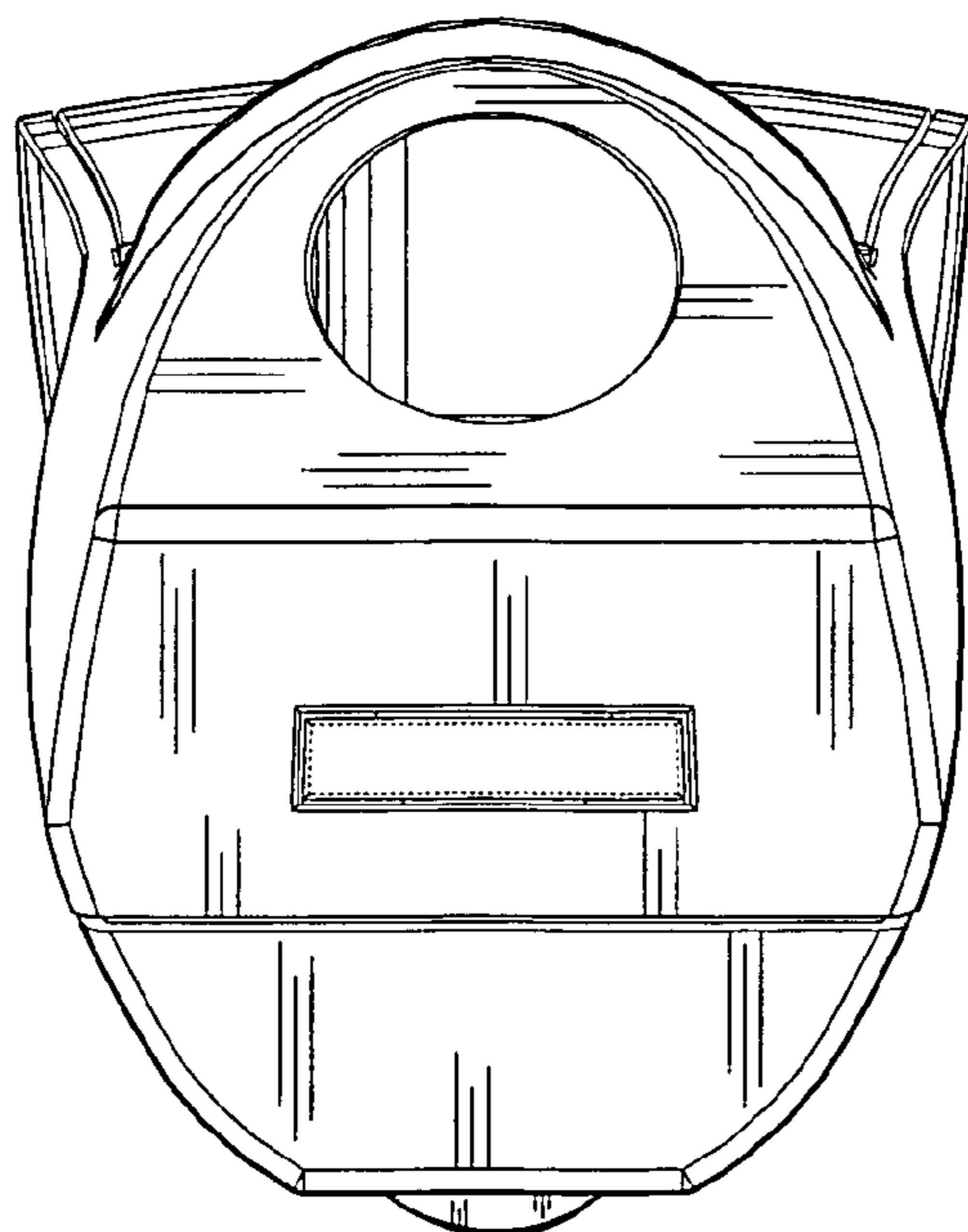

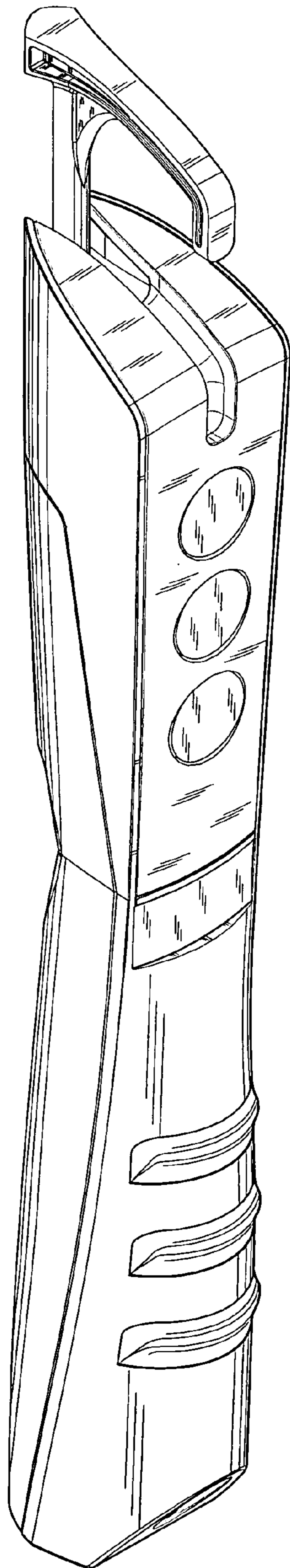

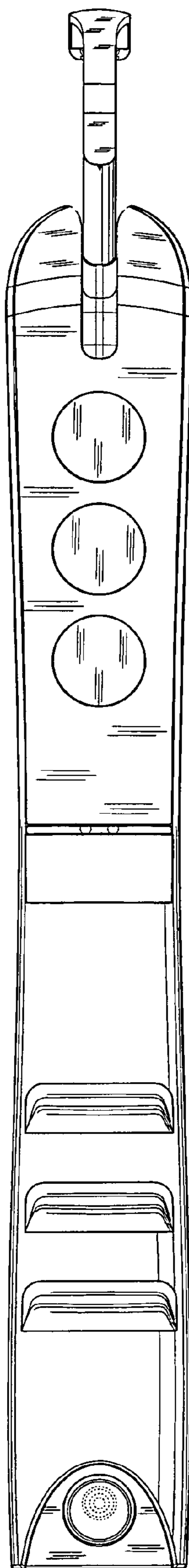

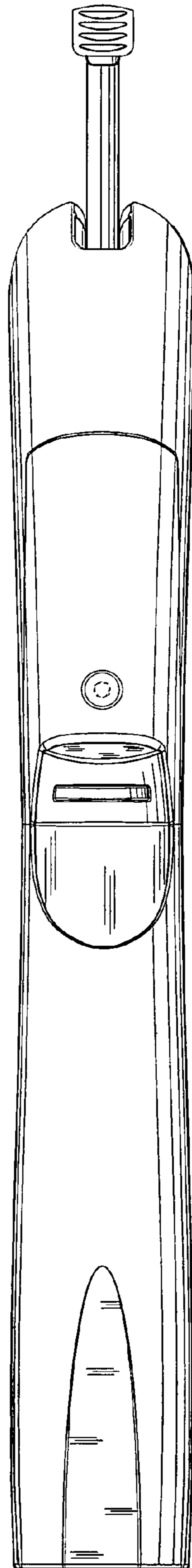

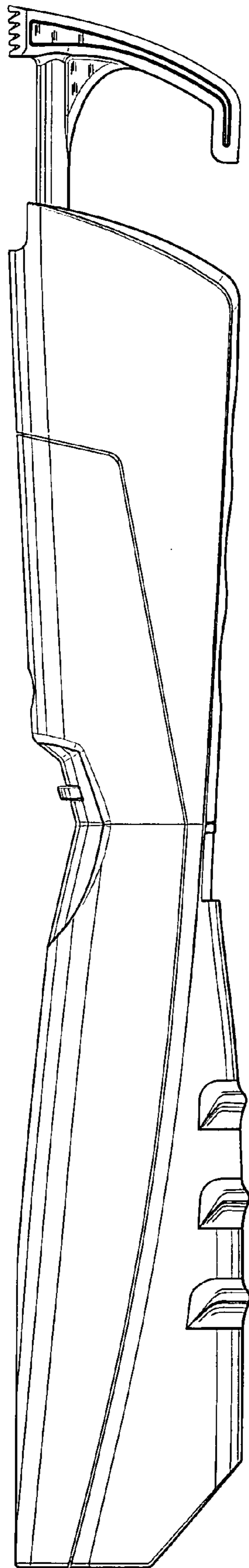




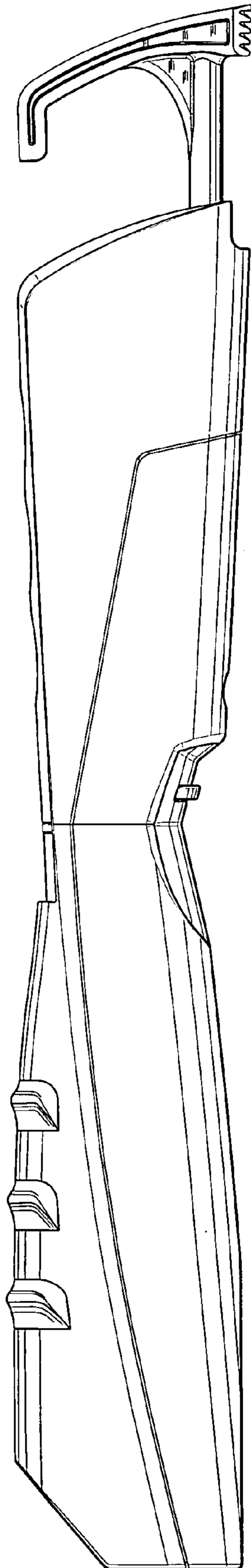

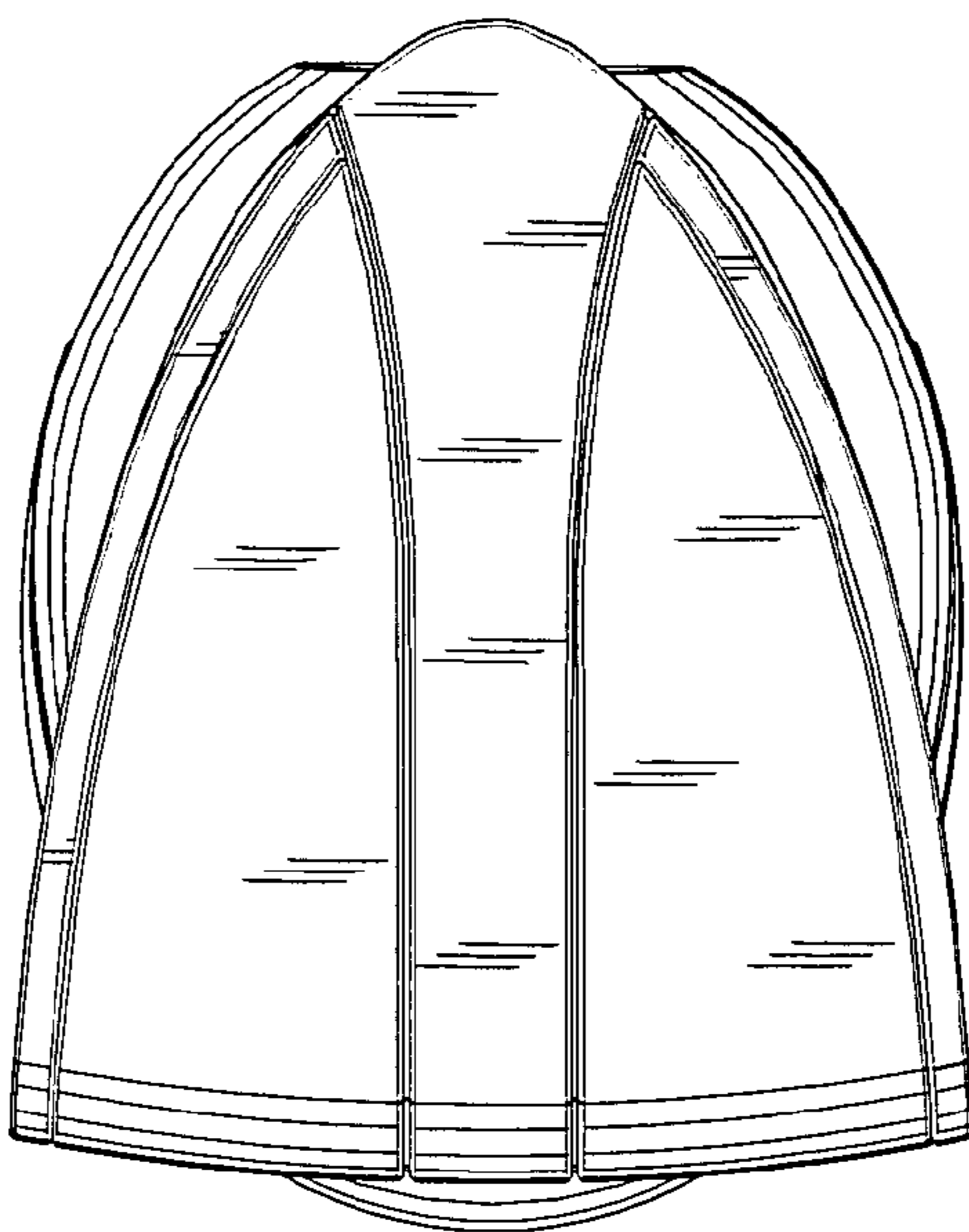

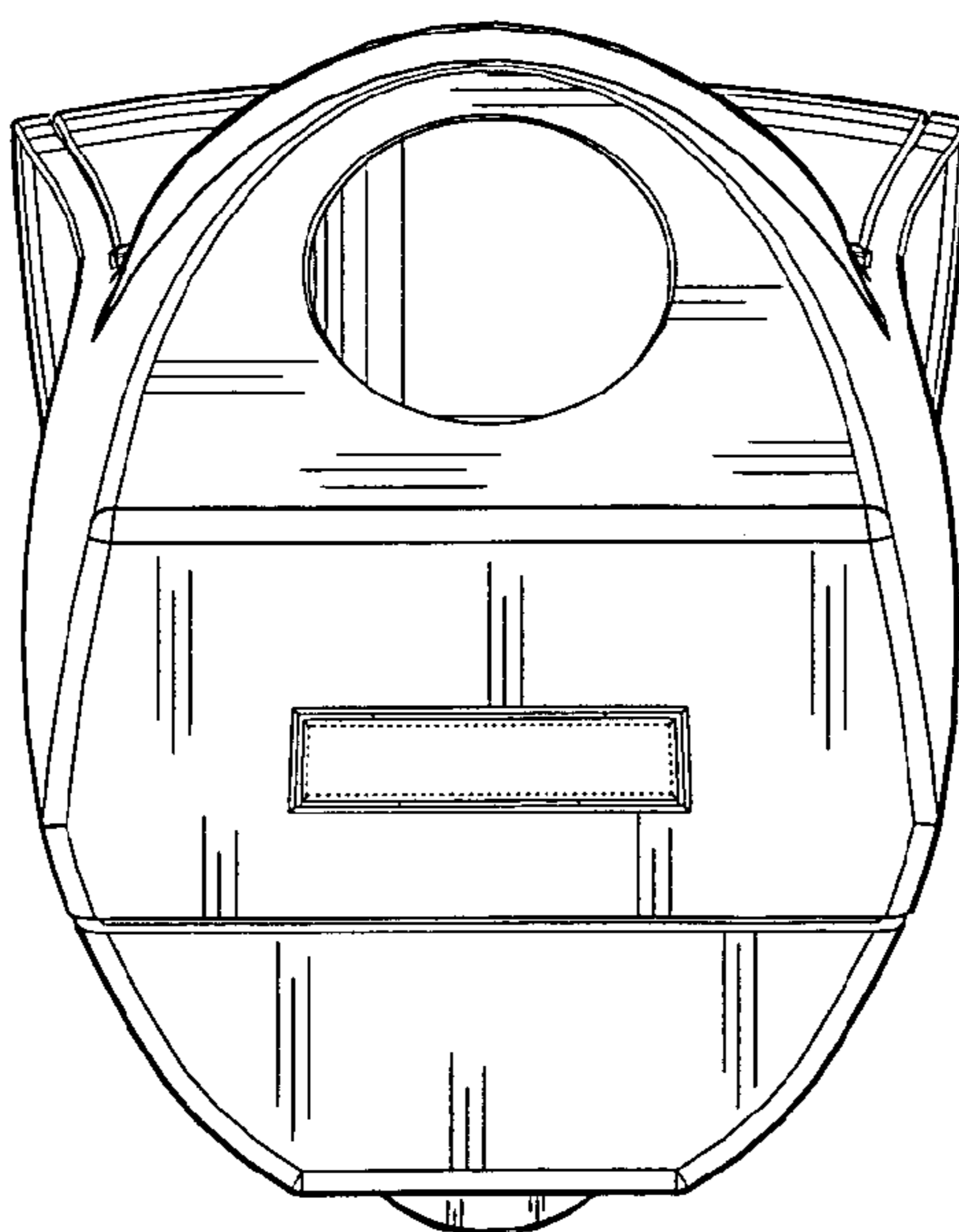
