FIG. 2 is a top plan elevational view thereof;

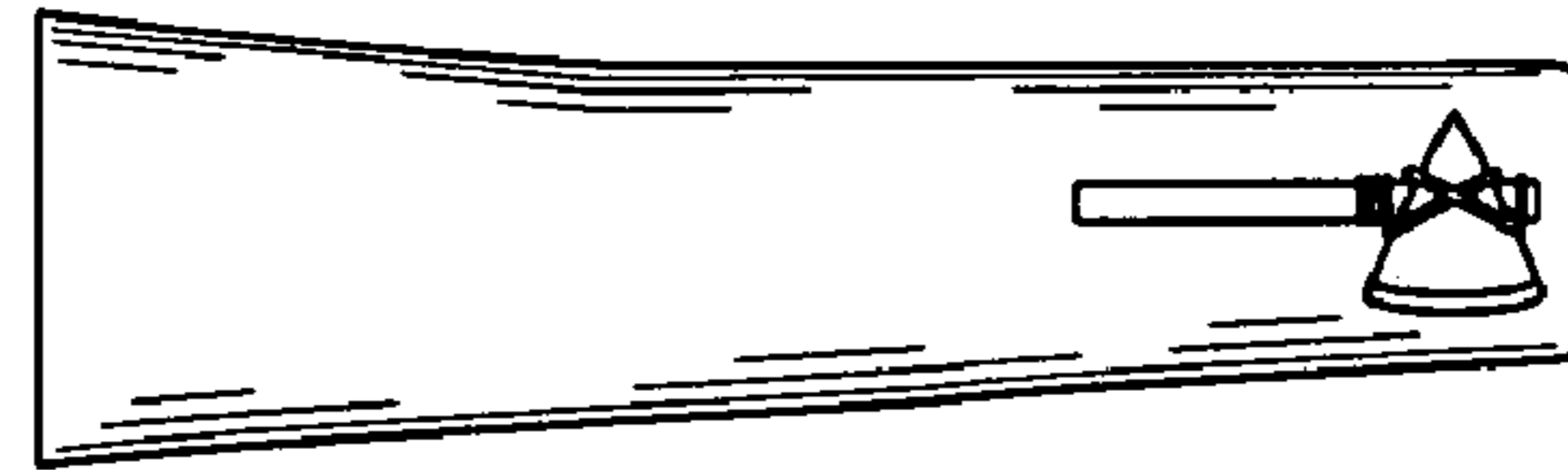
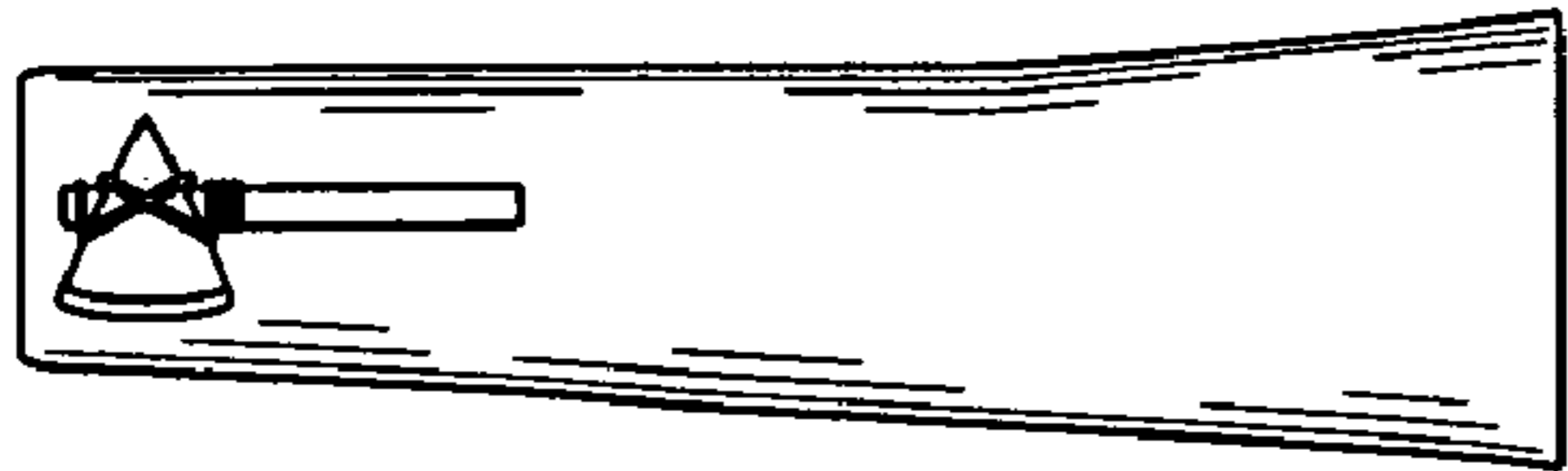
FIG. 3 is a bottom plan elevational view thereof;

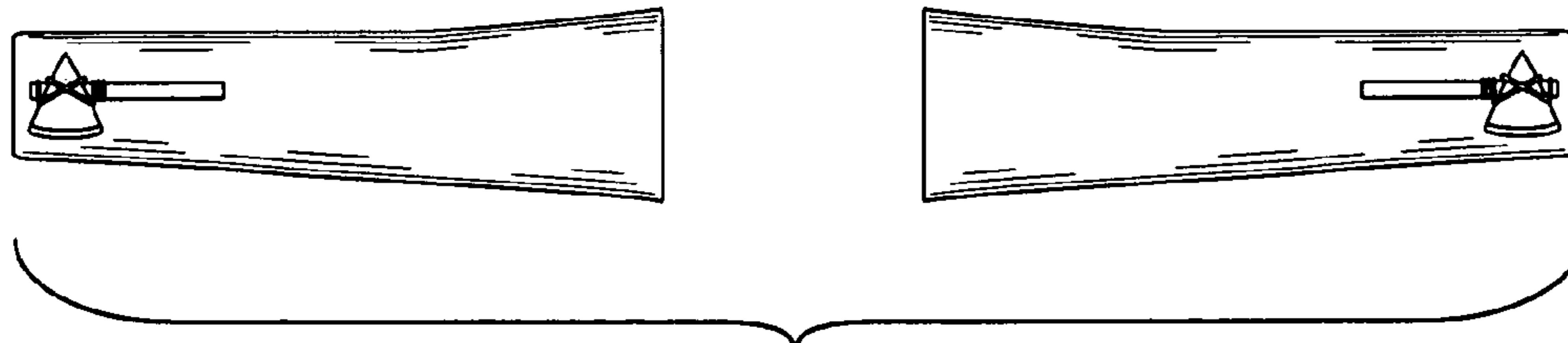

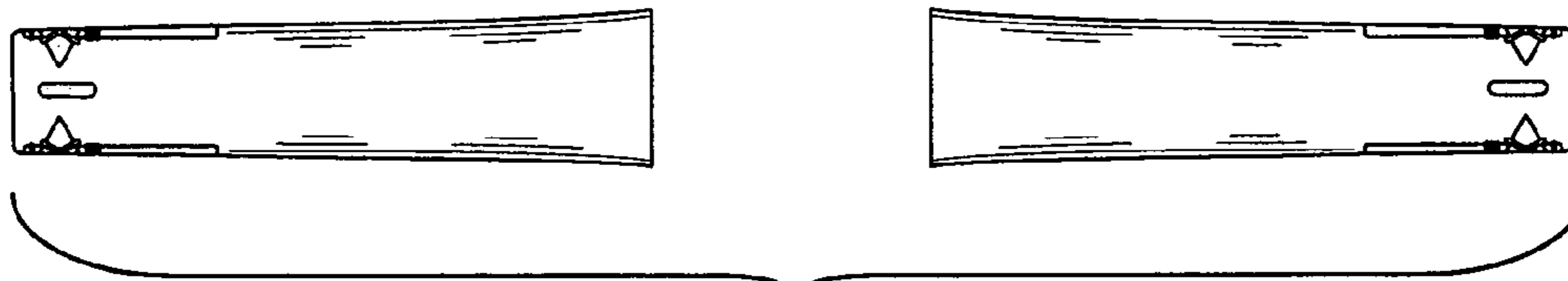

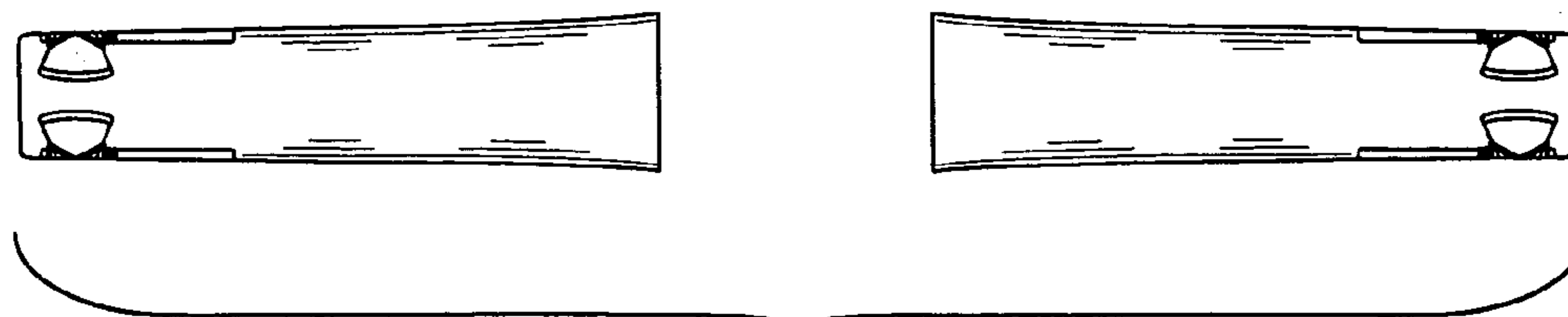

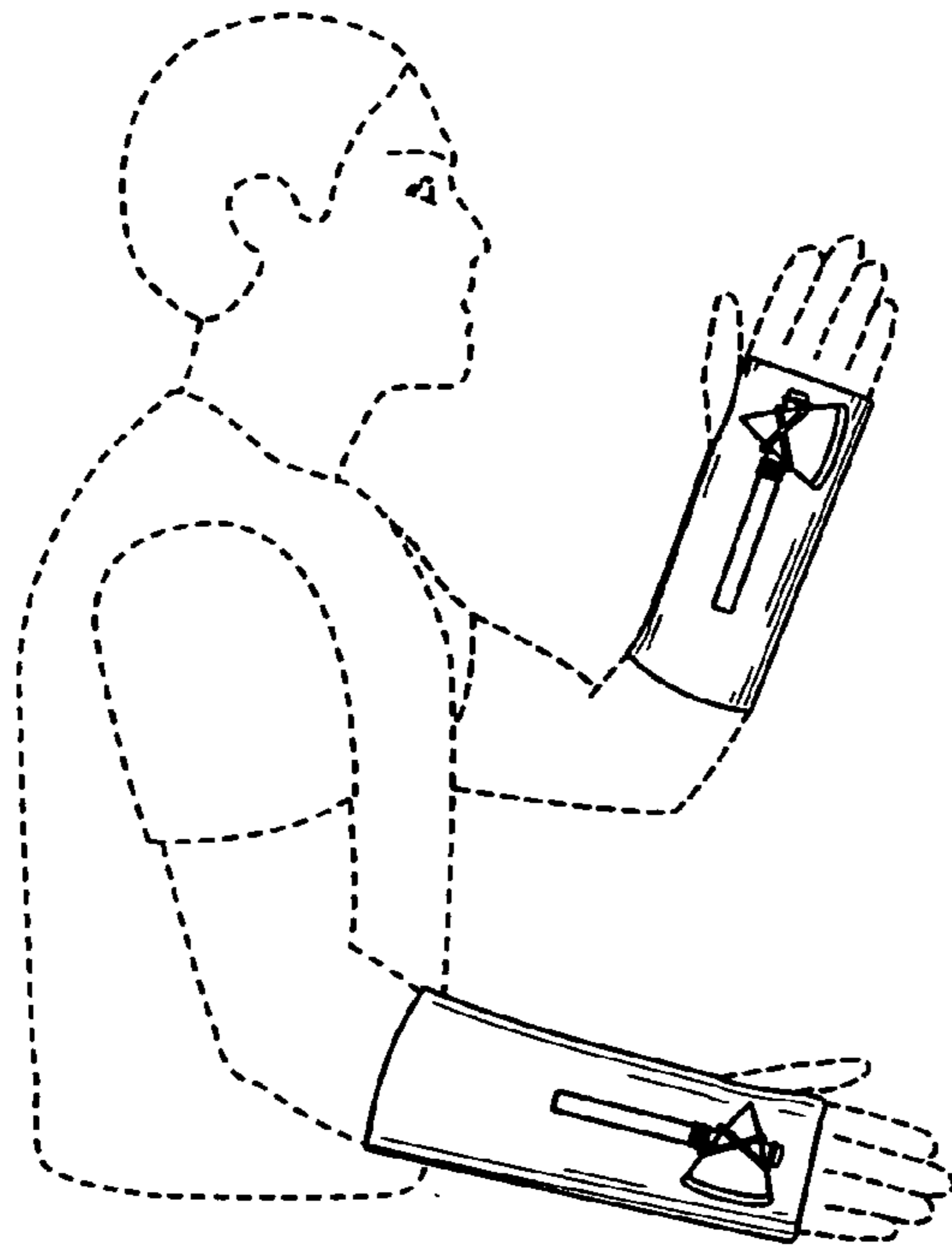

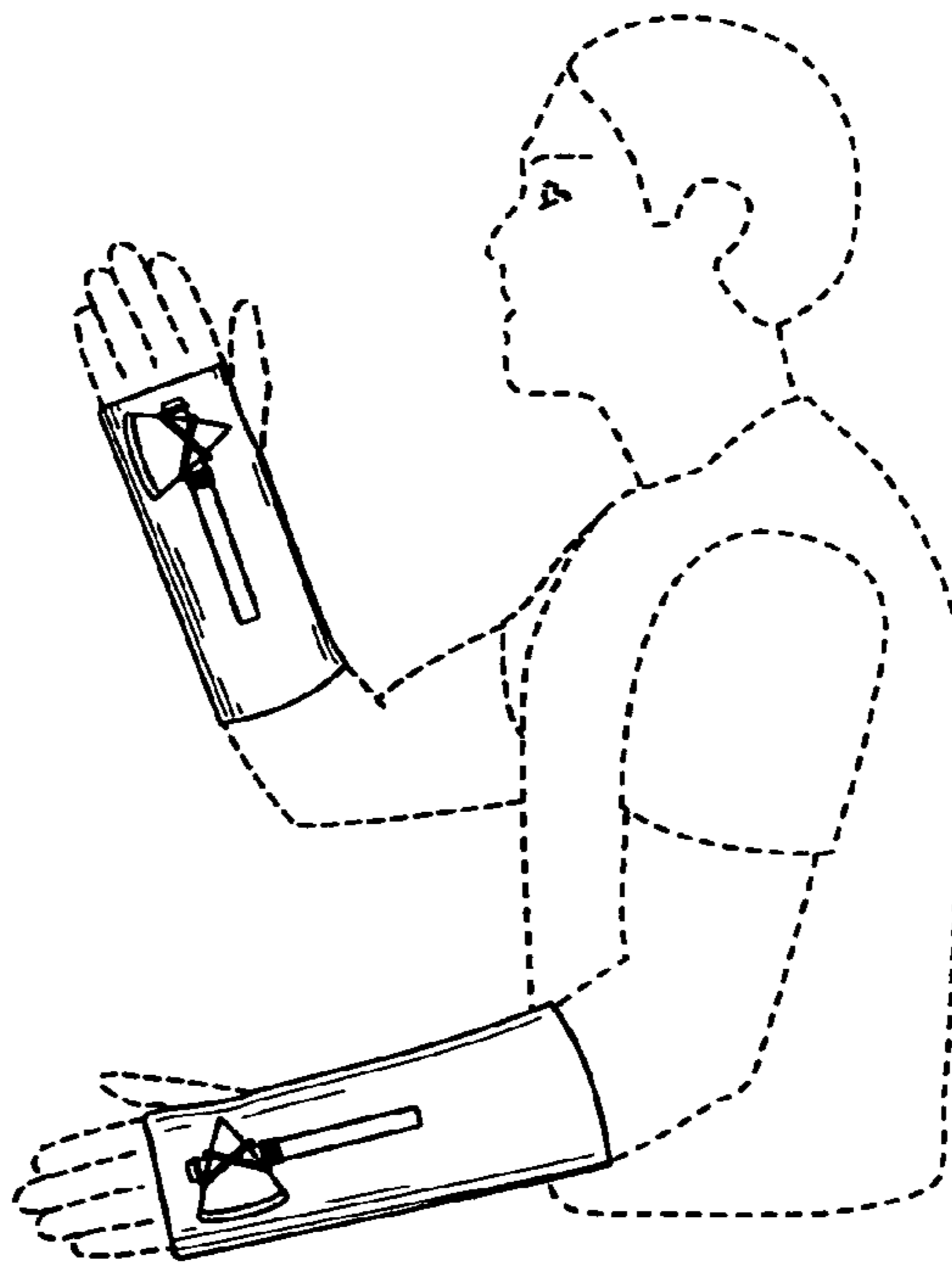
