(57) **CLAIM**

The ornamental design for a convertible hat with integral storage case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above of a convertible hat with integral storage case showing my new design with the hat enclosed within the integral case.

FIG. 2 is a front view of the convertible hat with integral storage case of FIG. 1 showing my new design.

FIG. 3 is a left side view of the convertible hat with integral storage case of FIG. 1 showing my new design.

FIG. 4 is a right side view of the convertible hat with integral storage case of FIG. 1 showing my new design.

FIG. 5 is a top view of the convertible hat with integral storage case of FIG. 1 showing my new design; a bottom view of the convertible hat with integral storage case of FIG. 1 showing my new design is the mirror image of FIG. 5.

FIG. 6 is a rear view of the convertible hat with integral storage case of FIG. 1 showing my new design.

FIG. 7 is a perspective view of a convertible hat with integral storage case showing my new design with the hat opened inside out.

FIG. 8 is a perspective view of a convertible hat with integral storage case shown in the opened position in which it would be worn.

FIG. 9 is a front view of the convertible hat with integral storage case of FIG. 8 showing my new design; a rear view of the convertible hat with integral storage case of FIG. 8 showing my new design is the mirror image of FIG. 9.

FIG. 10 is a left side view of the convertible hat with integral storage case of FIG. 8 showing my new design.

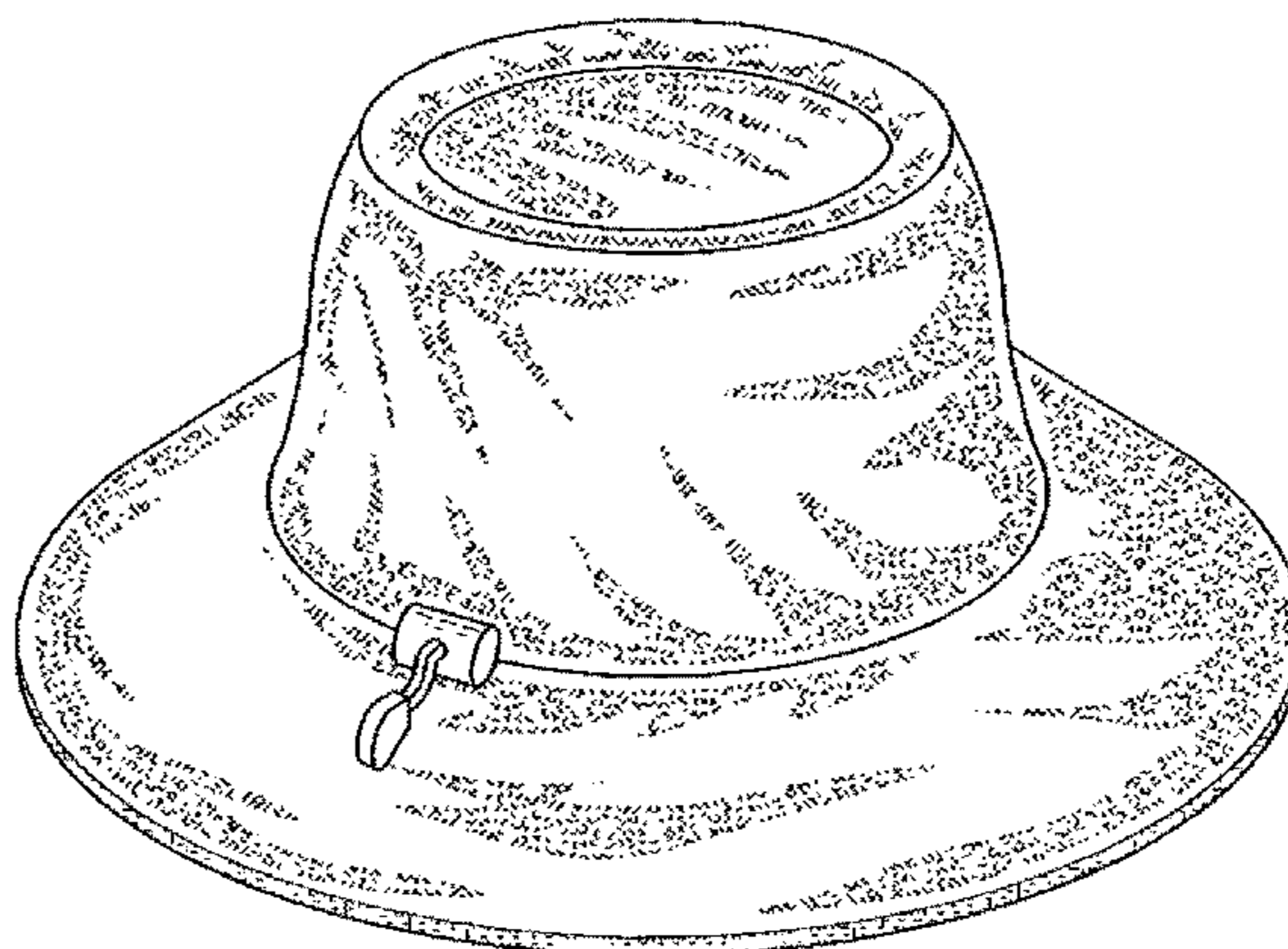
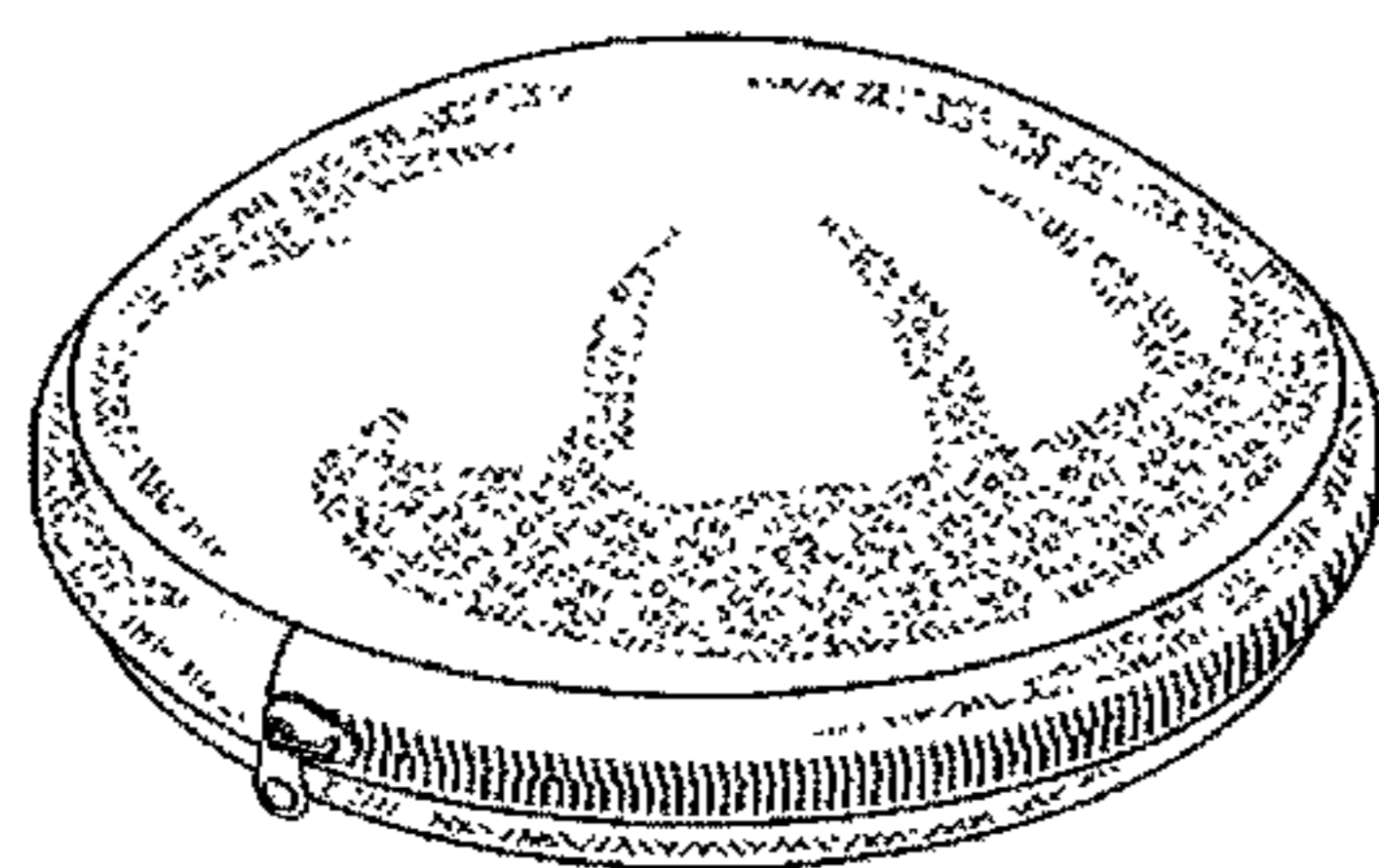
FIG. 11 is a right side view of the convertible hat with integral storage case of FIG. 8 showing my new design.

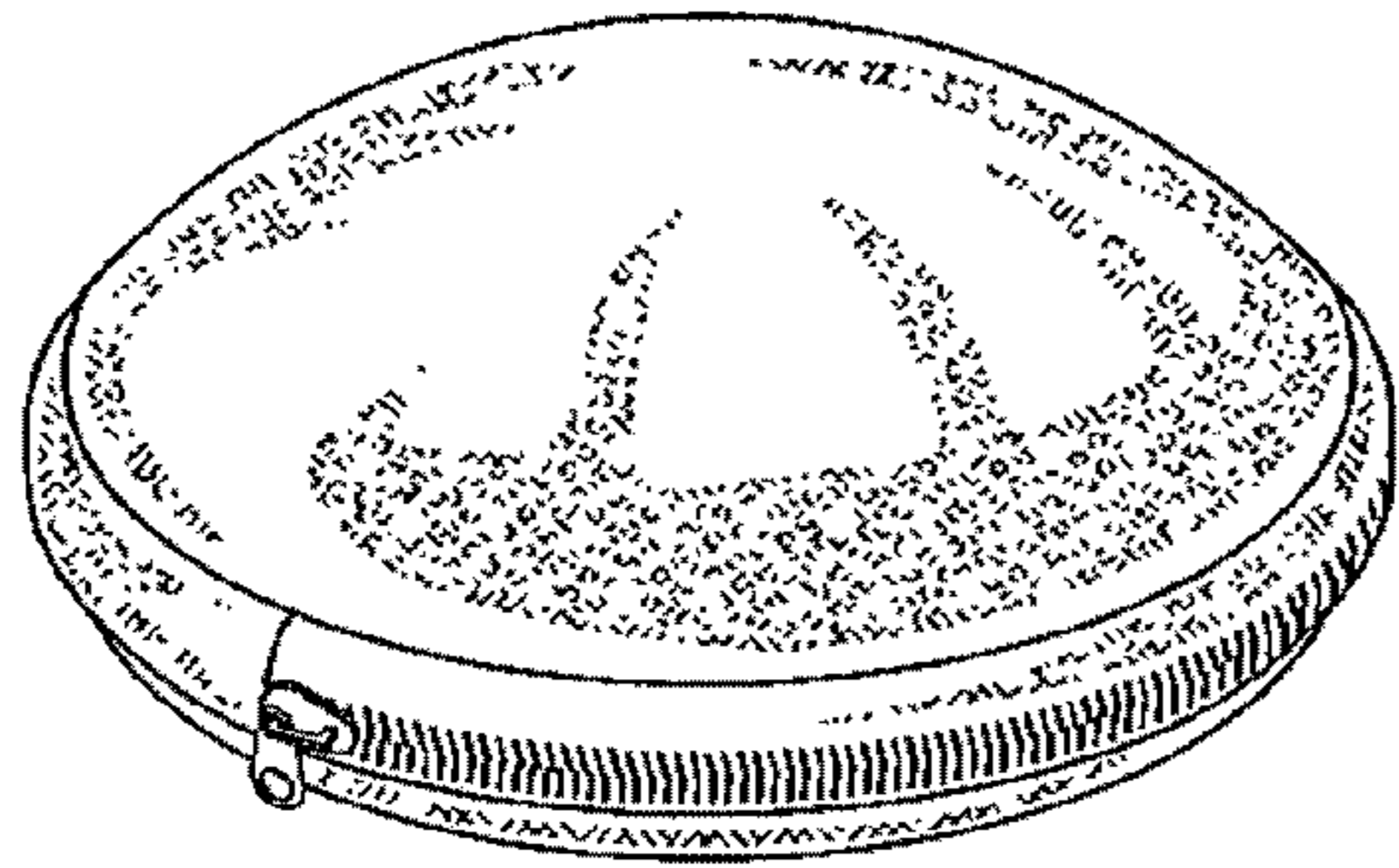

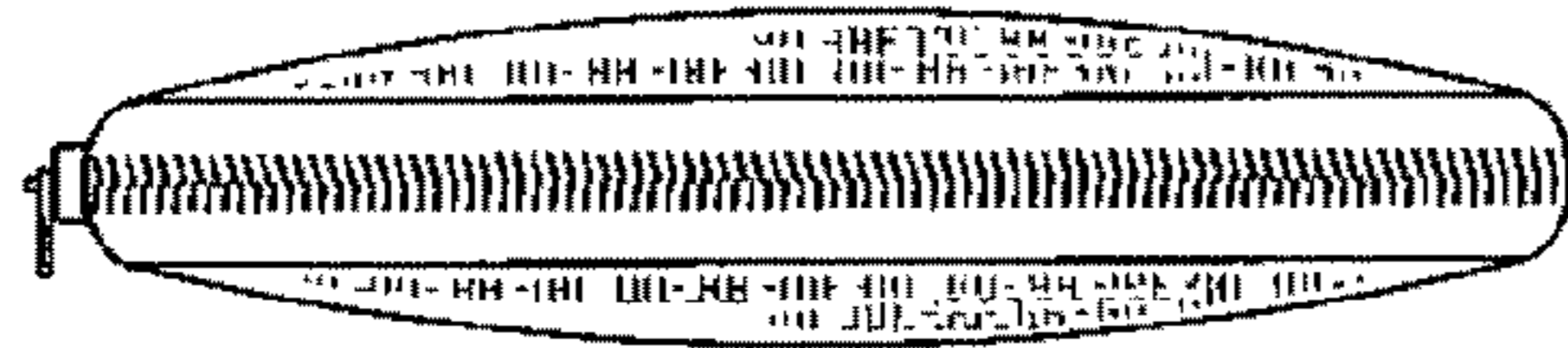

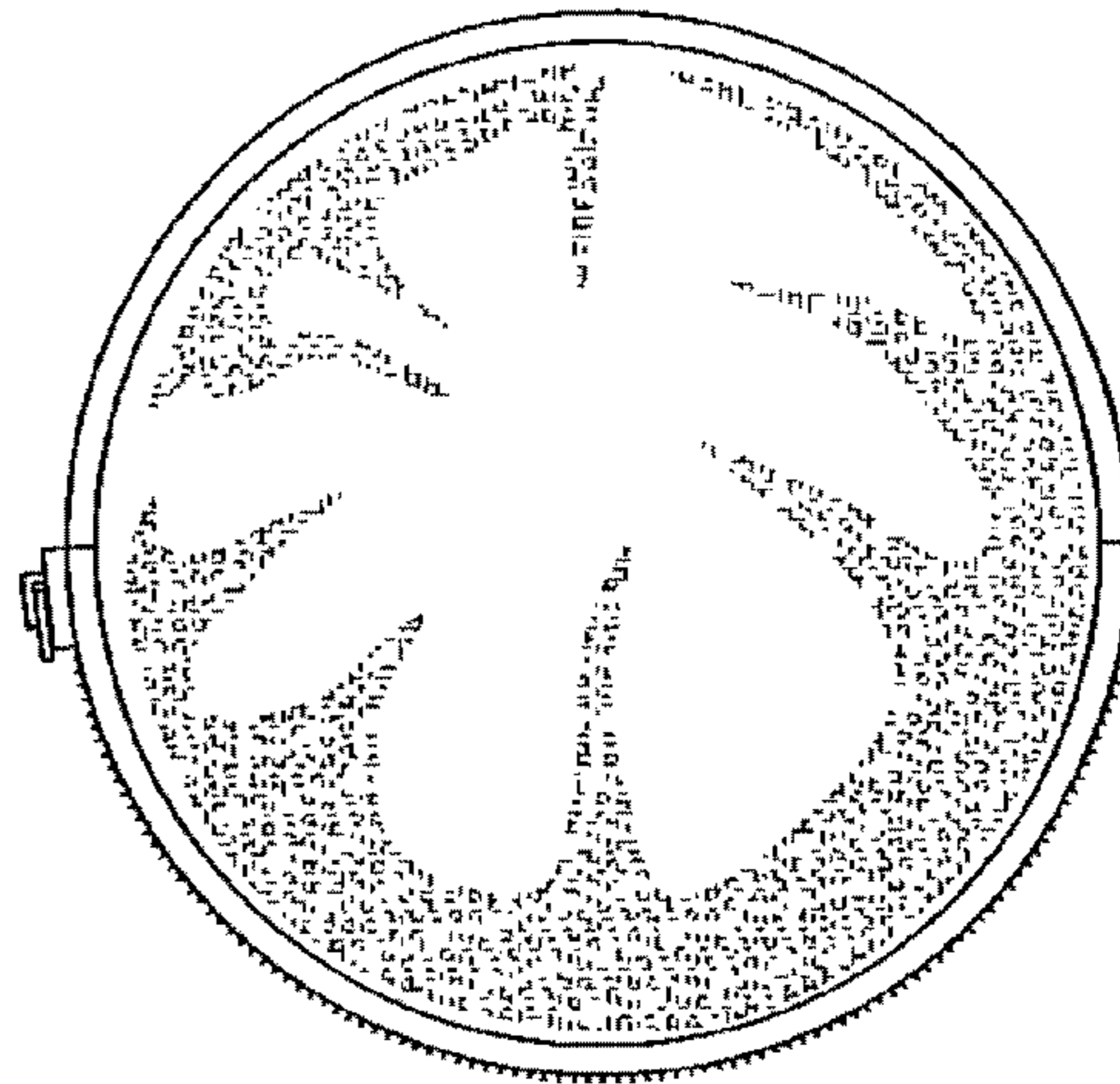

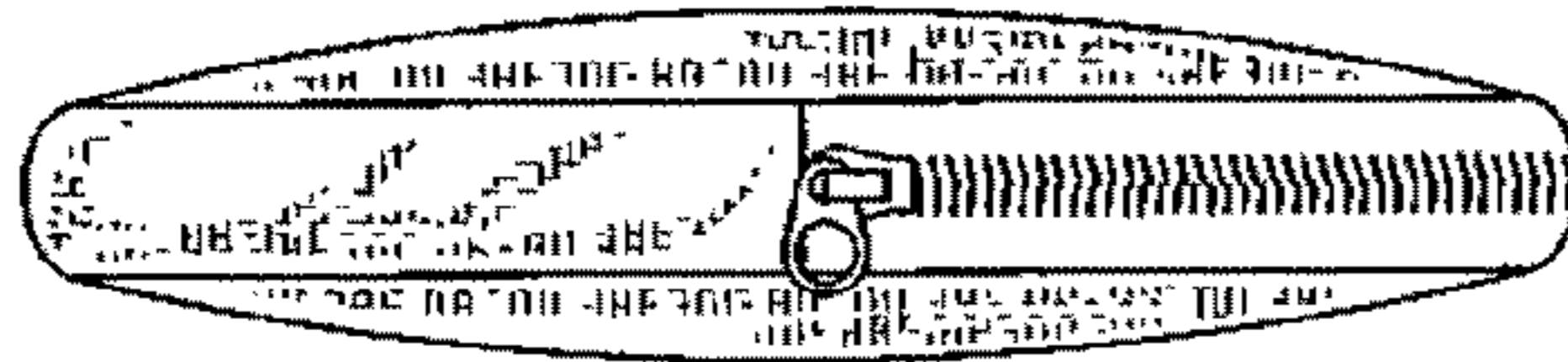

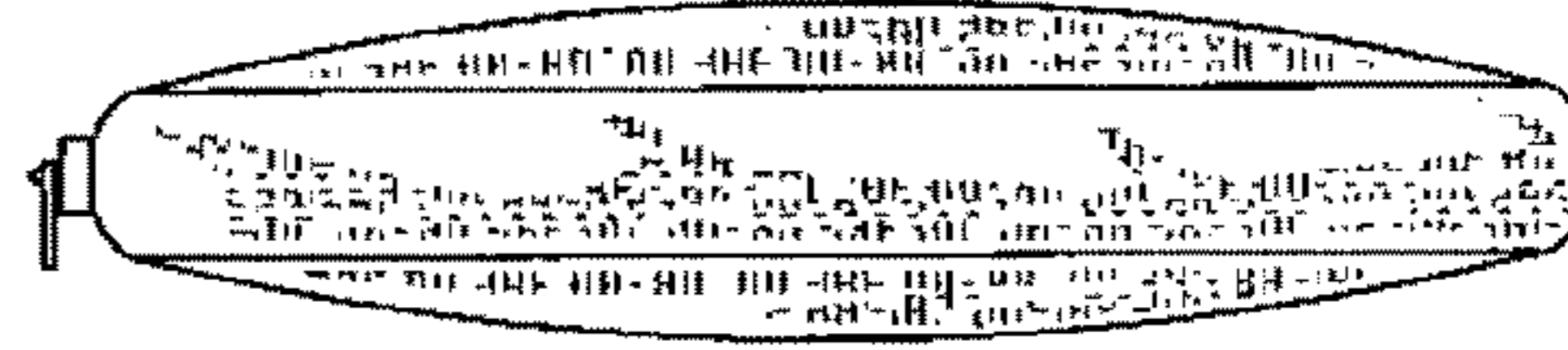

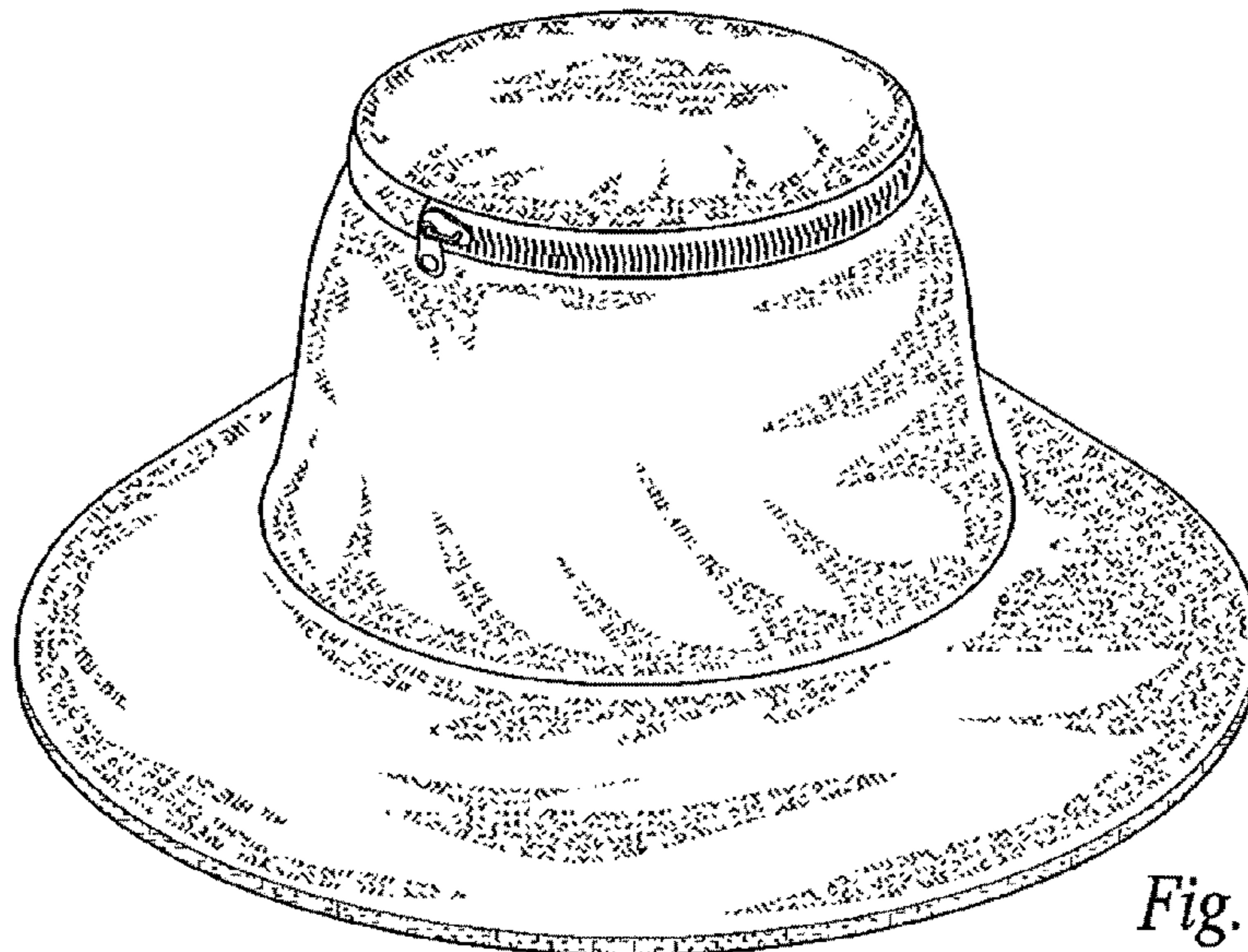

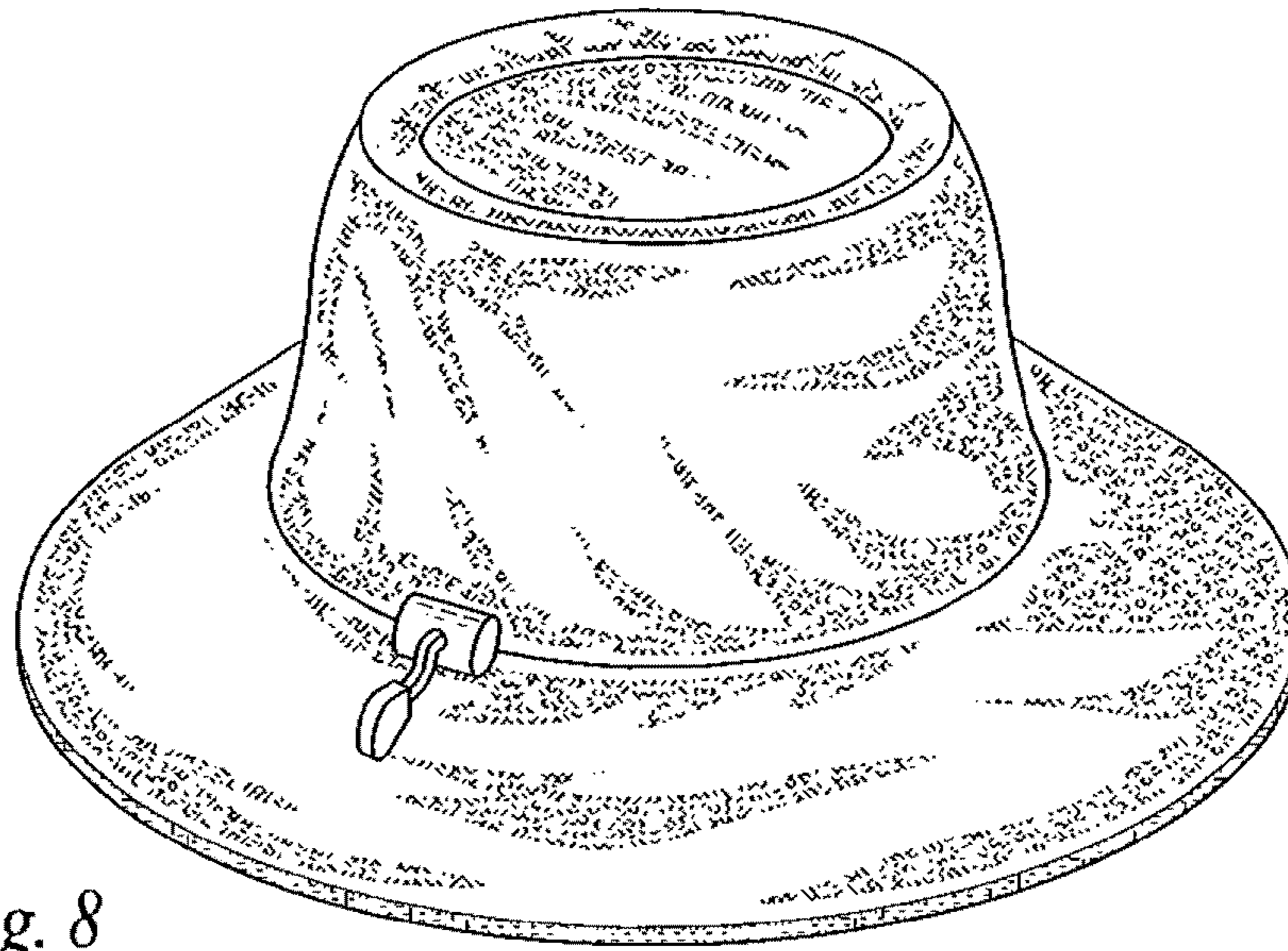

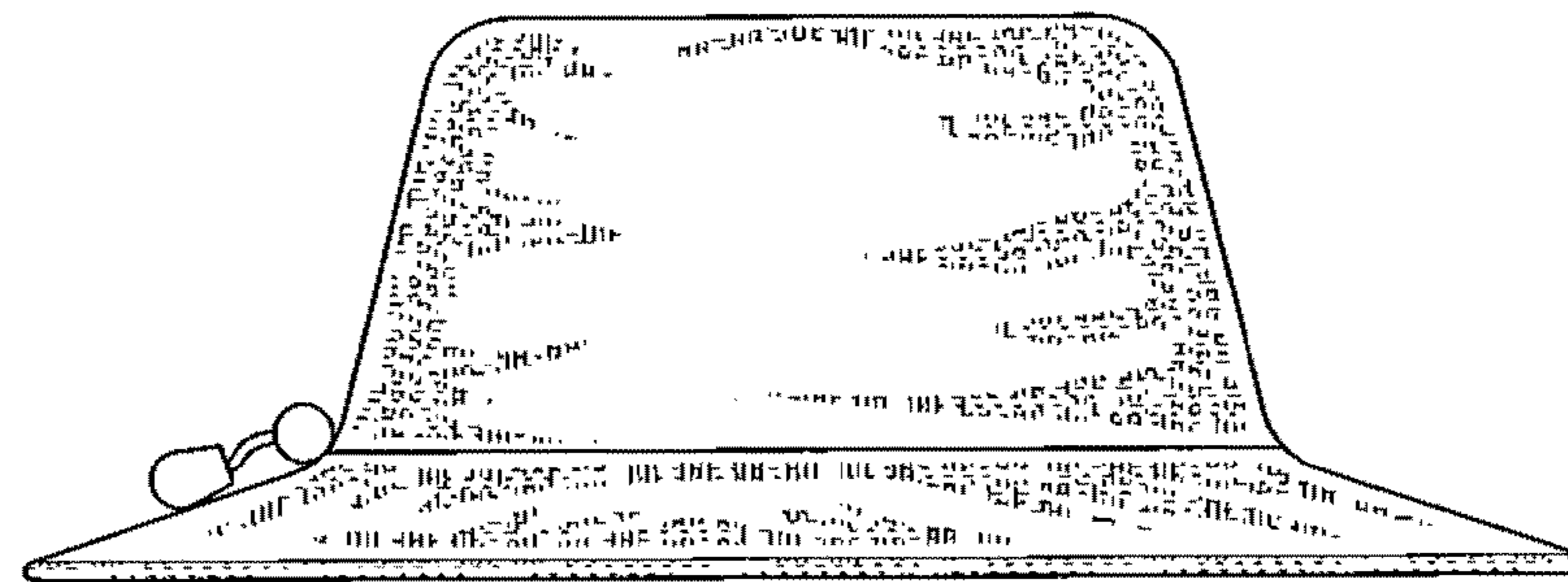

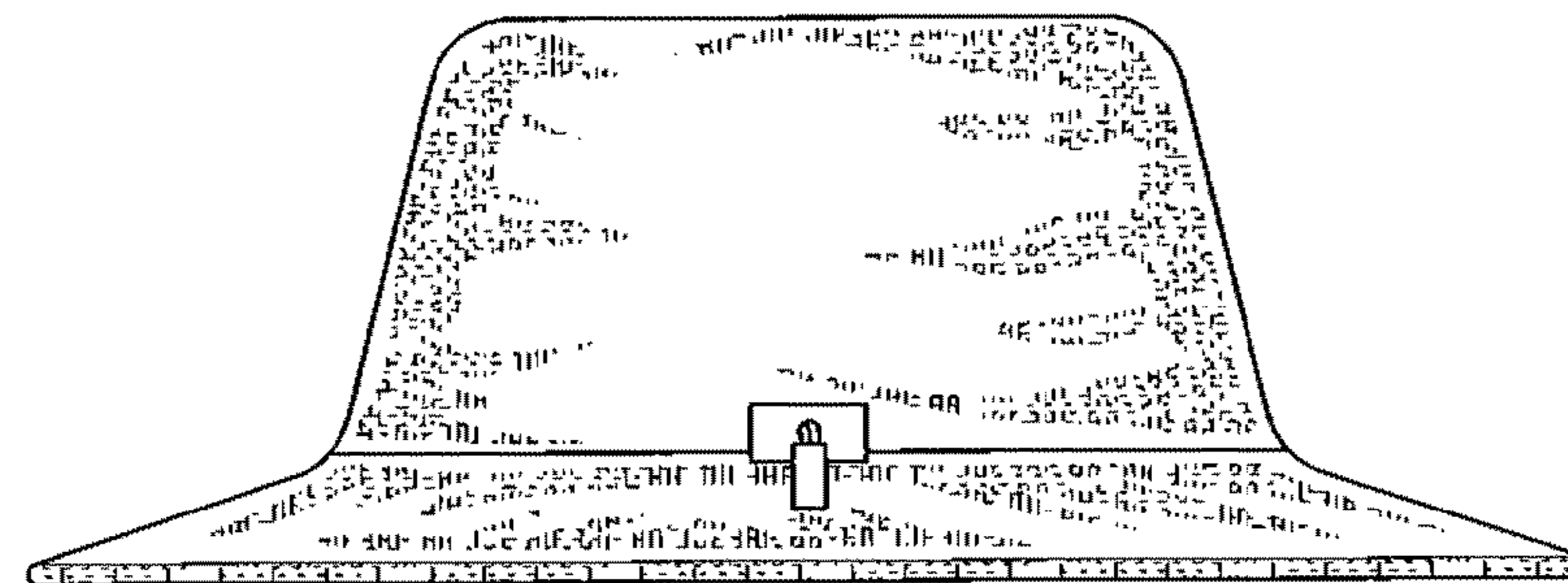

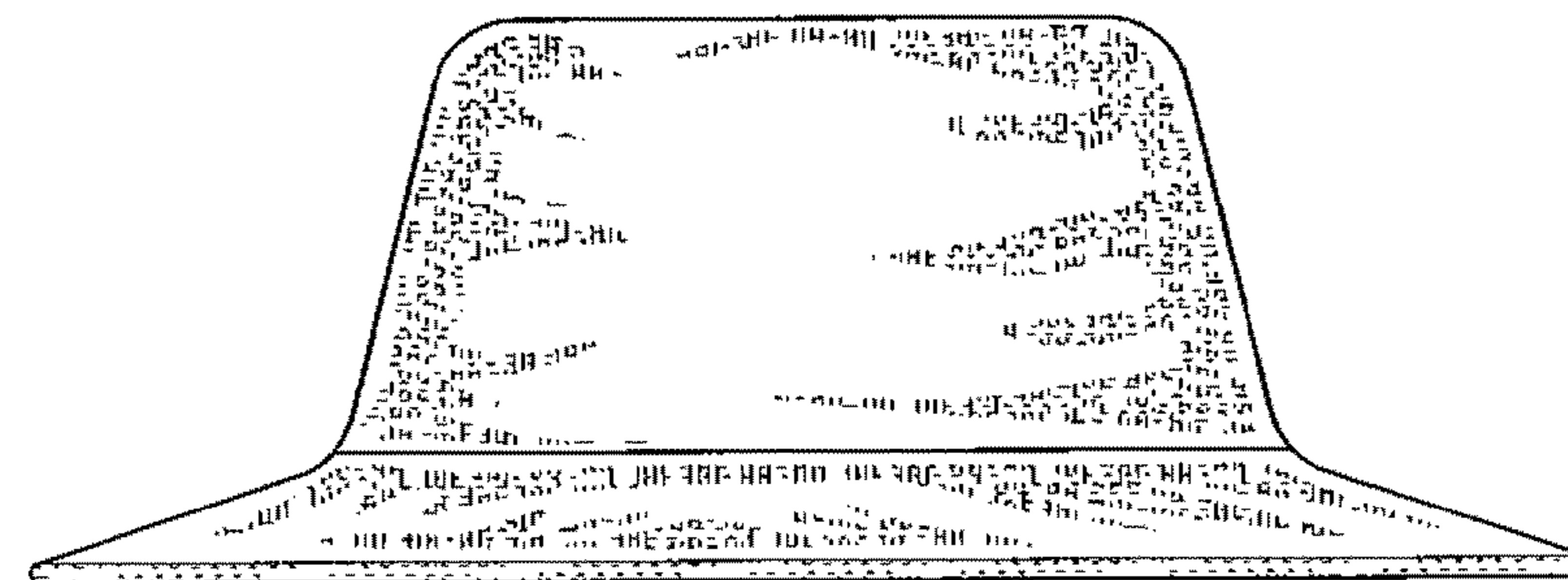

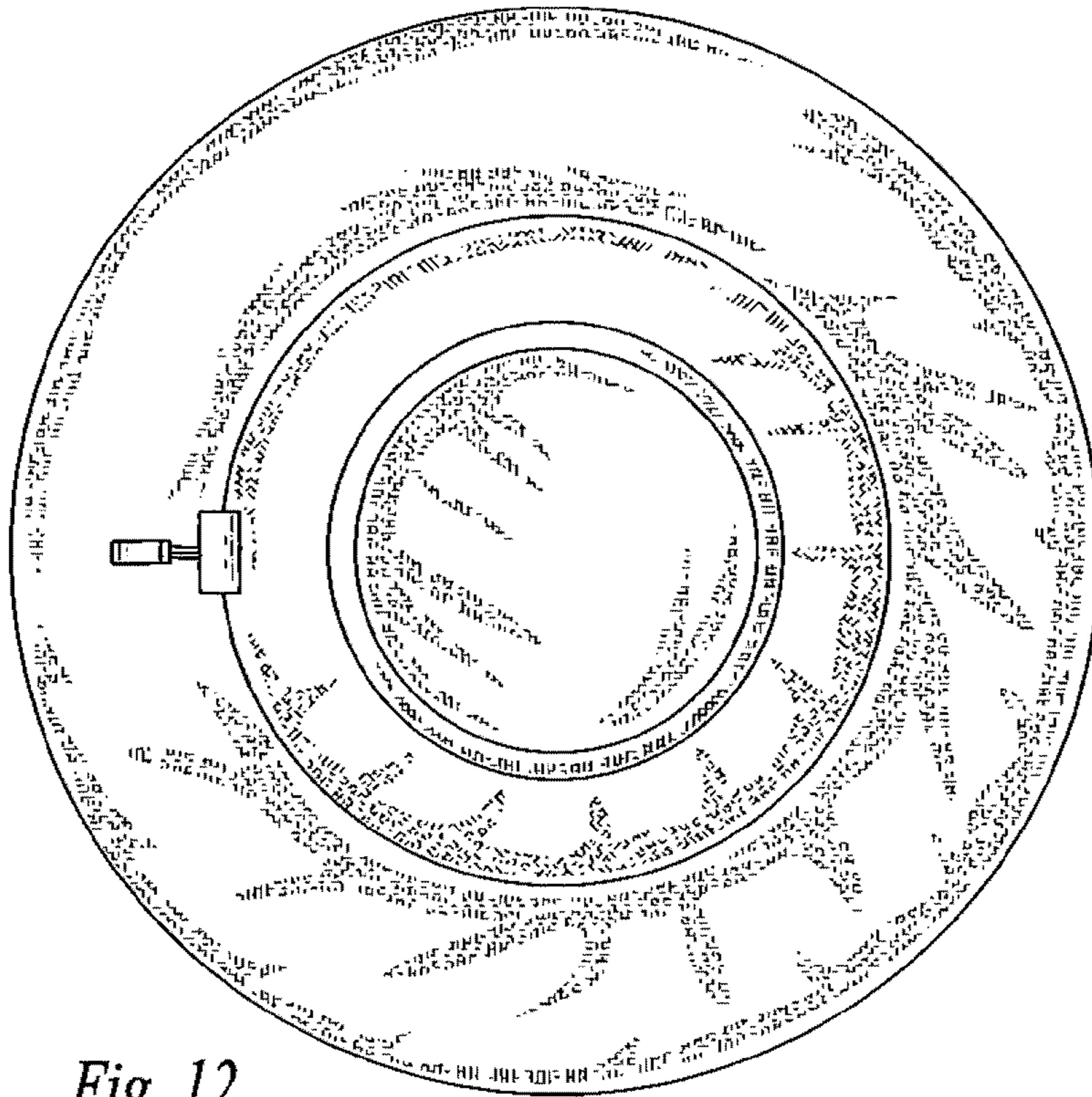

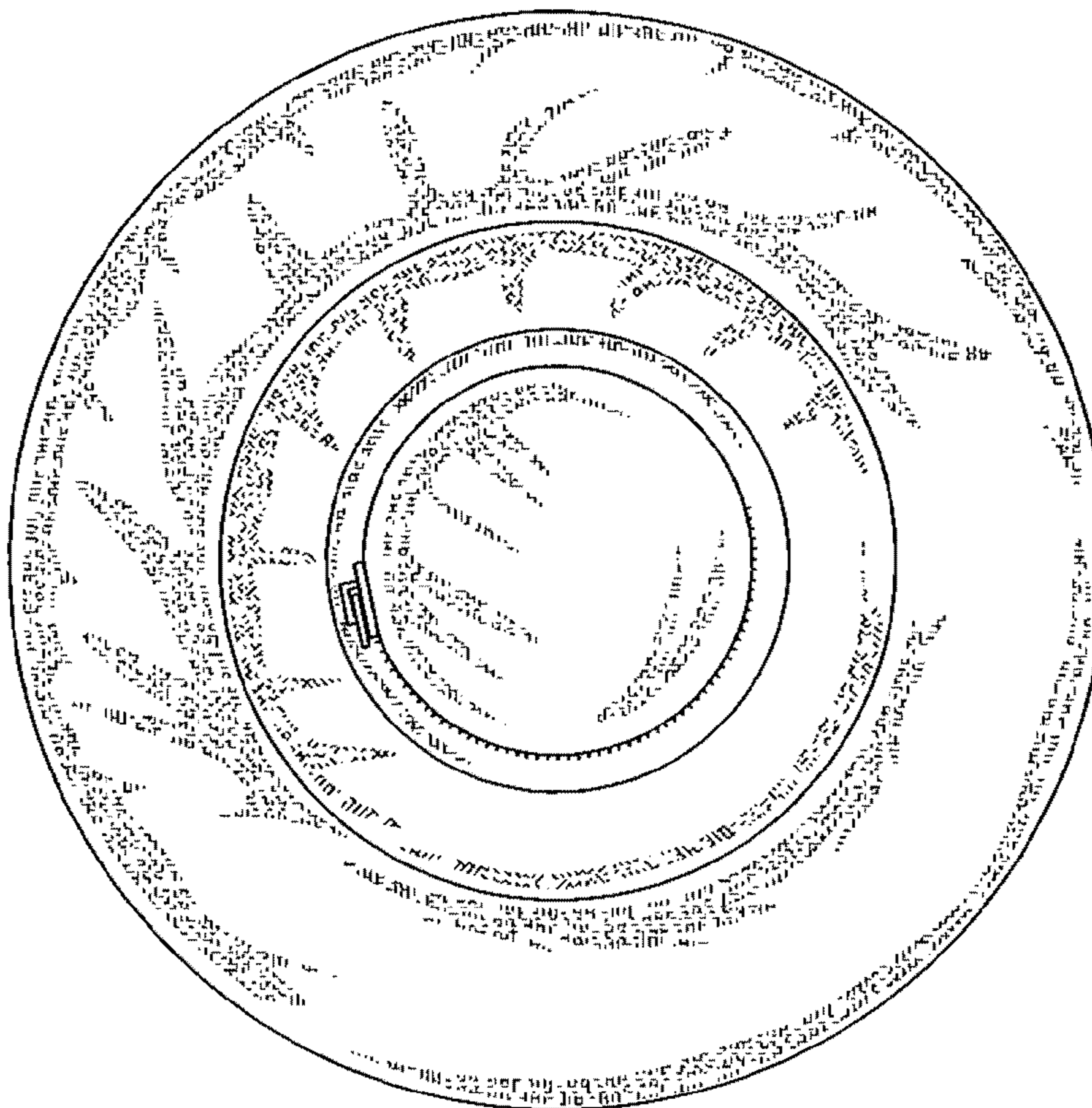
