FIG. 3 is a Back Plan view of a metallic food serving device;

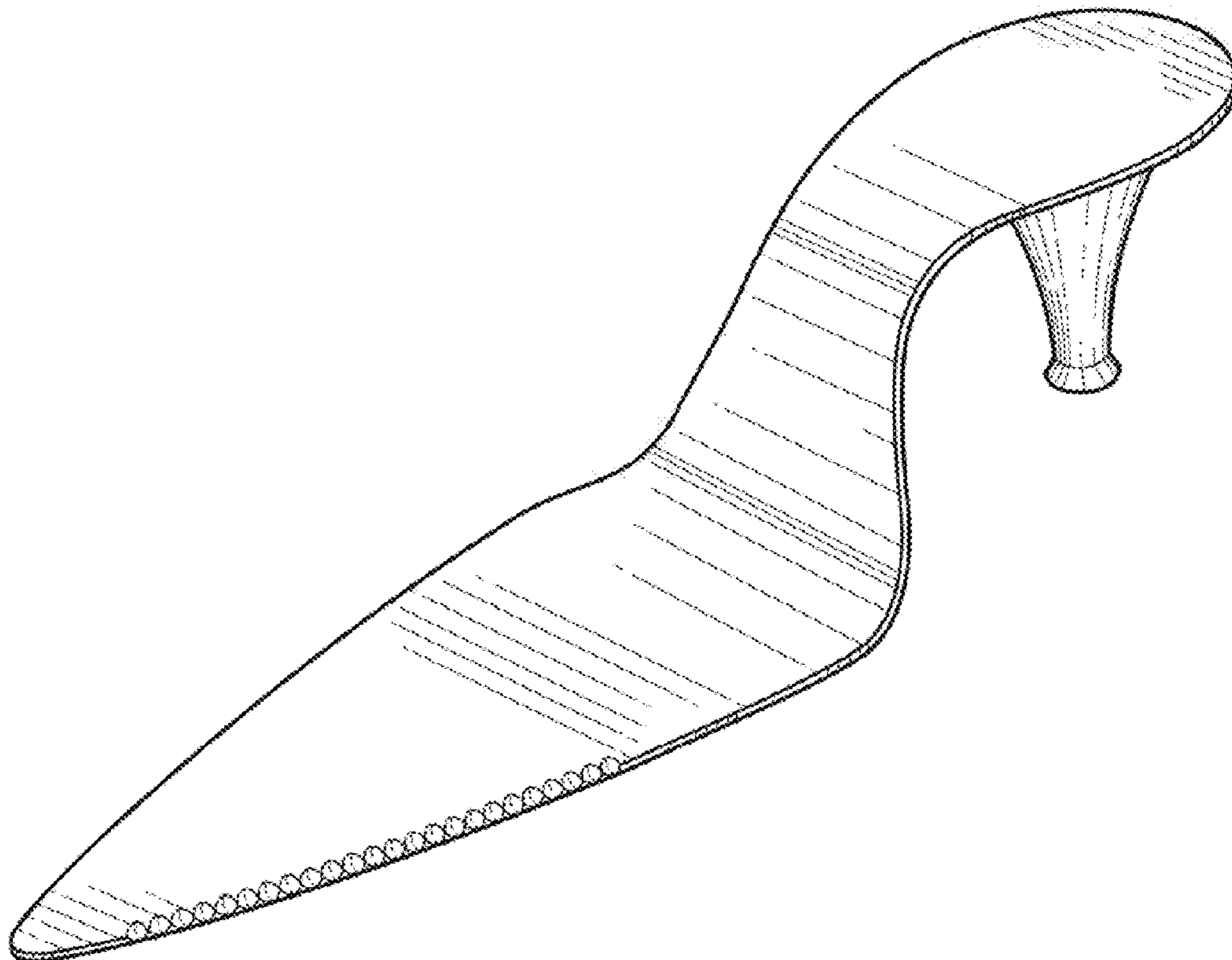
FIG. 4 is a Top Plan view of a metallic food serving device;

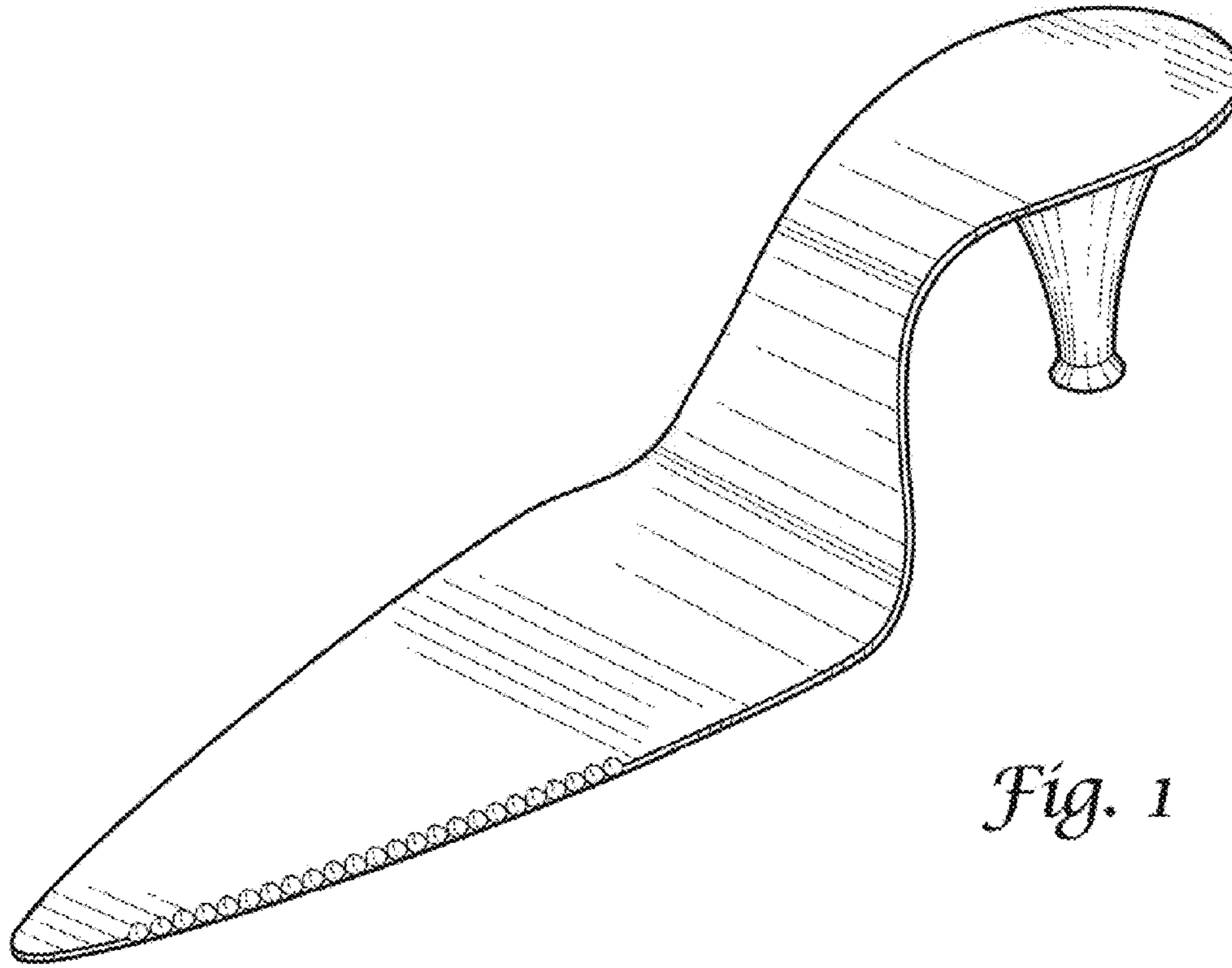

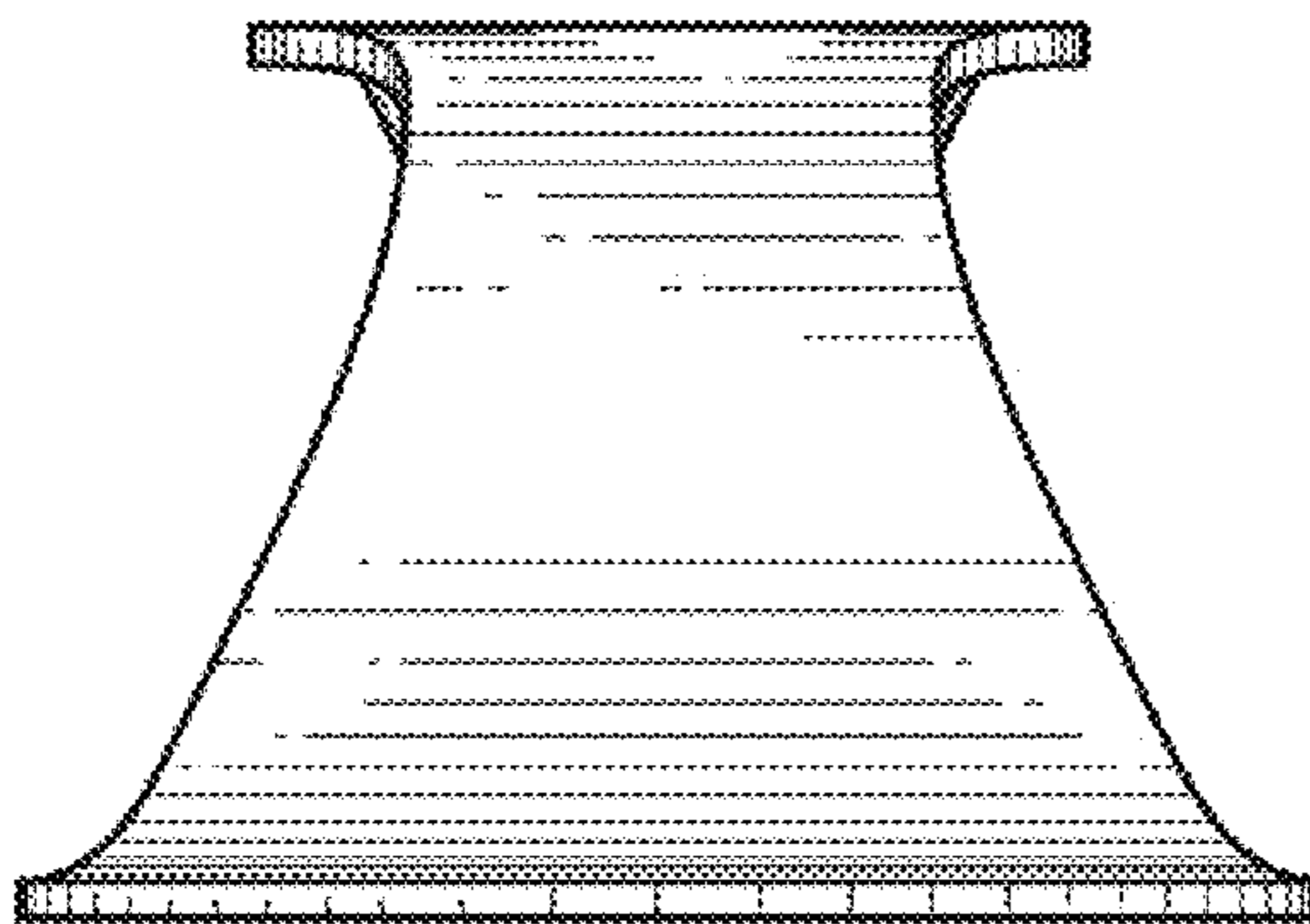

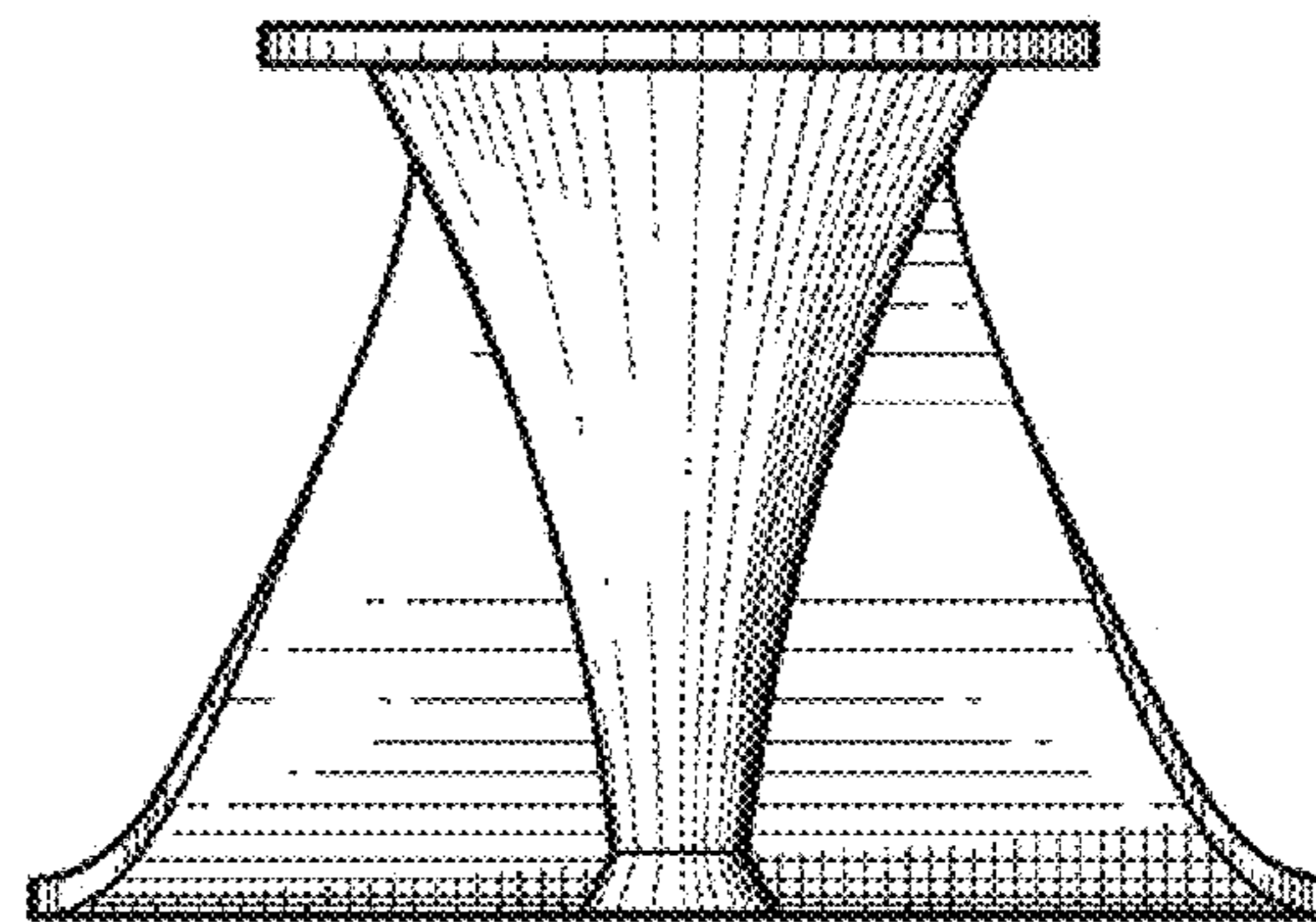

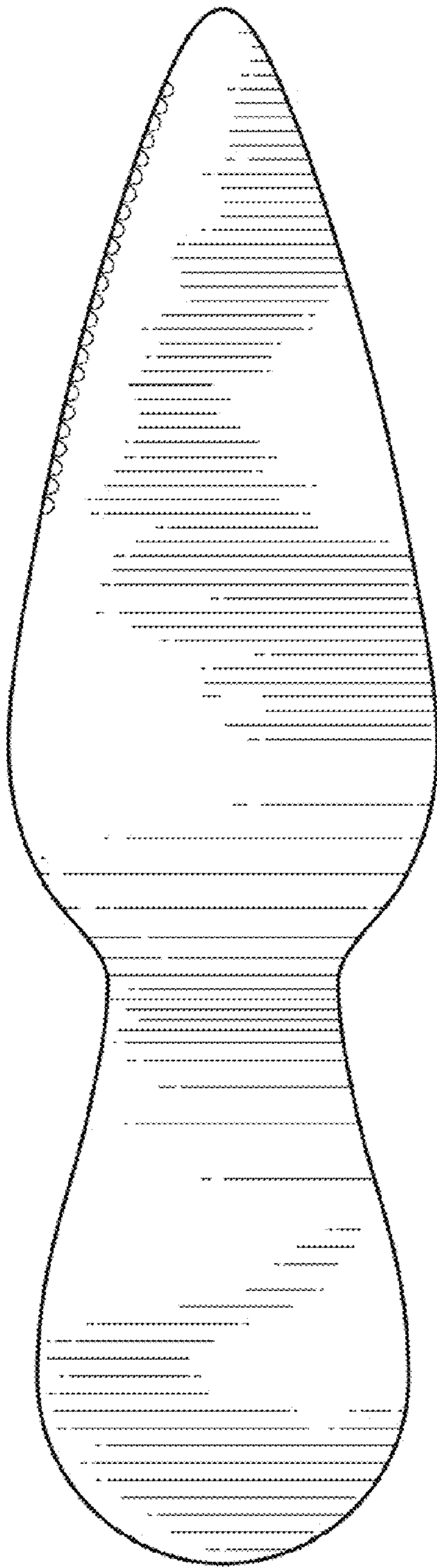

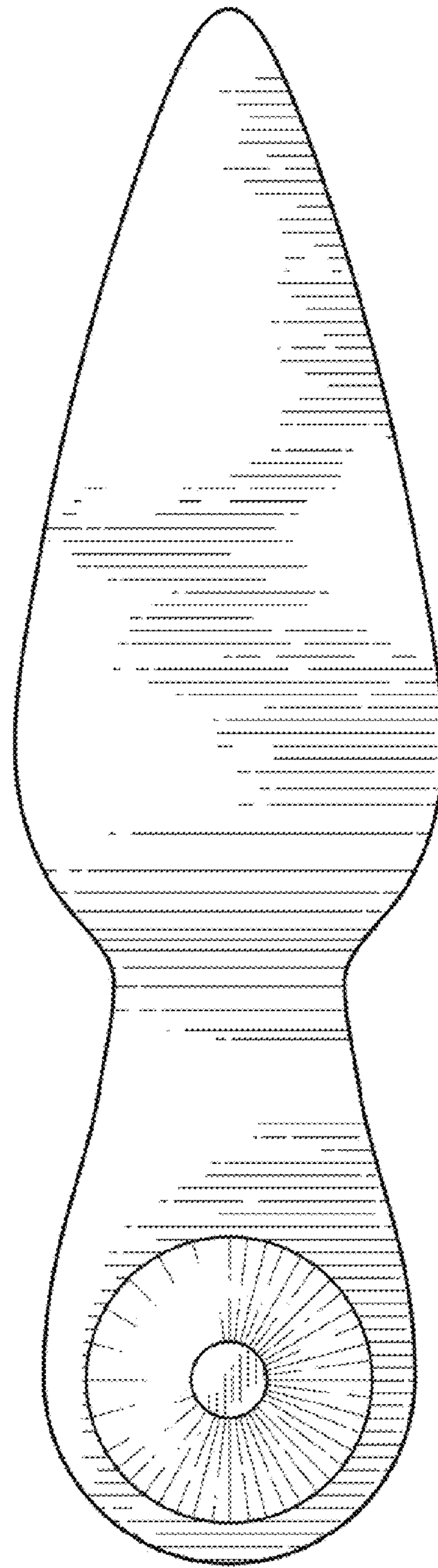

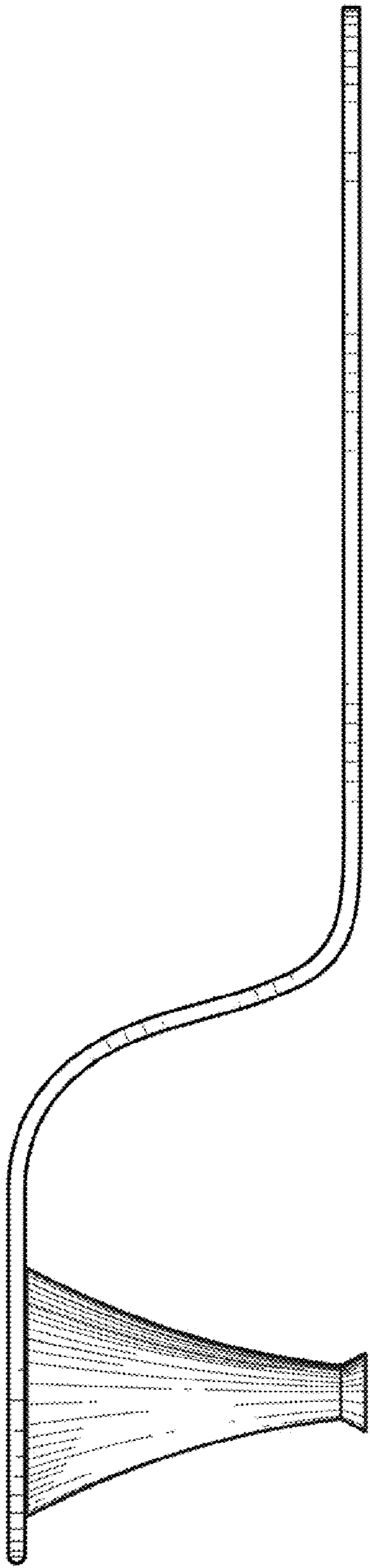

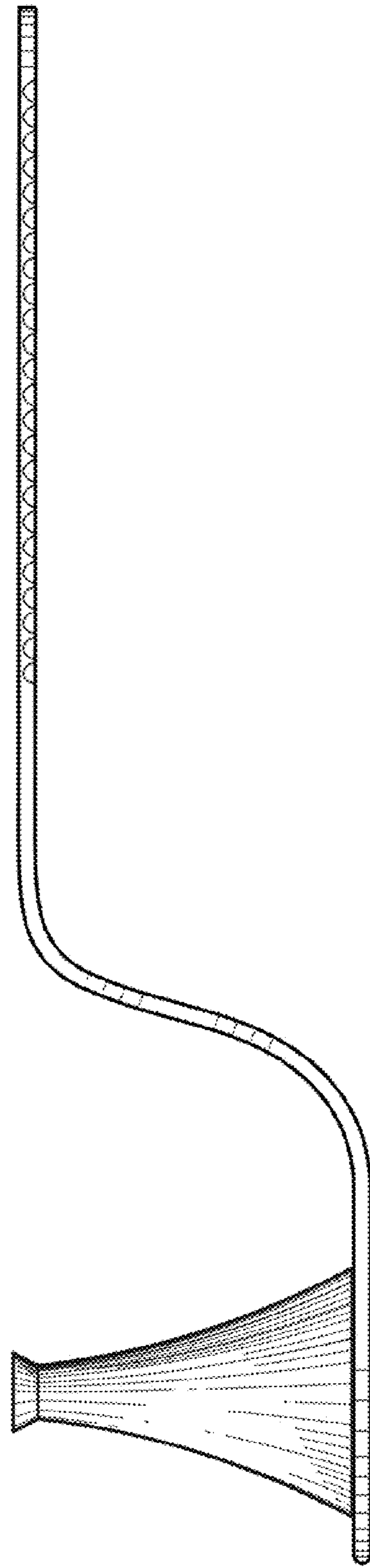
