The ornamental design for a package for linens, as shown and described.

DESCRIPTION

FIG. 12 is a back view of the package for linens of FIG. 1 shown in an exemplary display environment with every other packages arranged up side down in a stacked configuration;

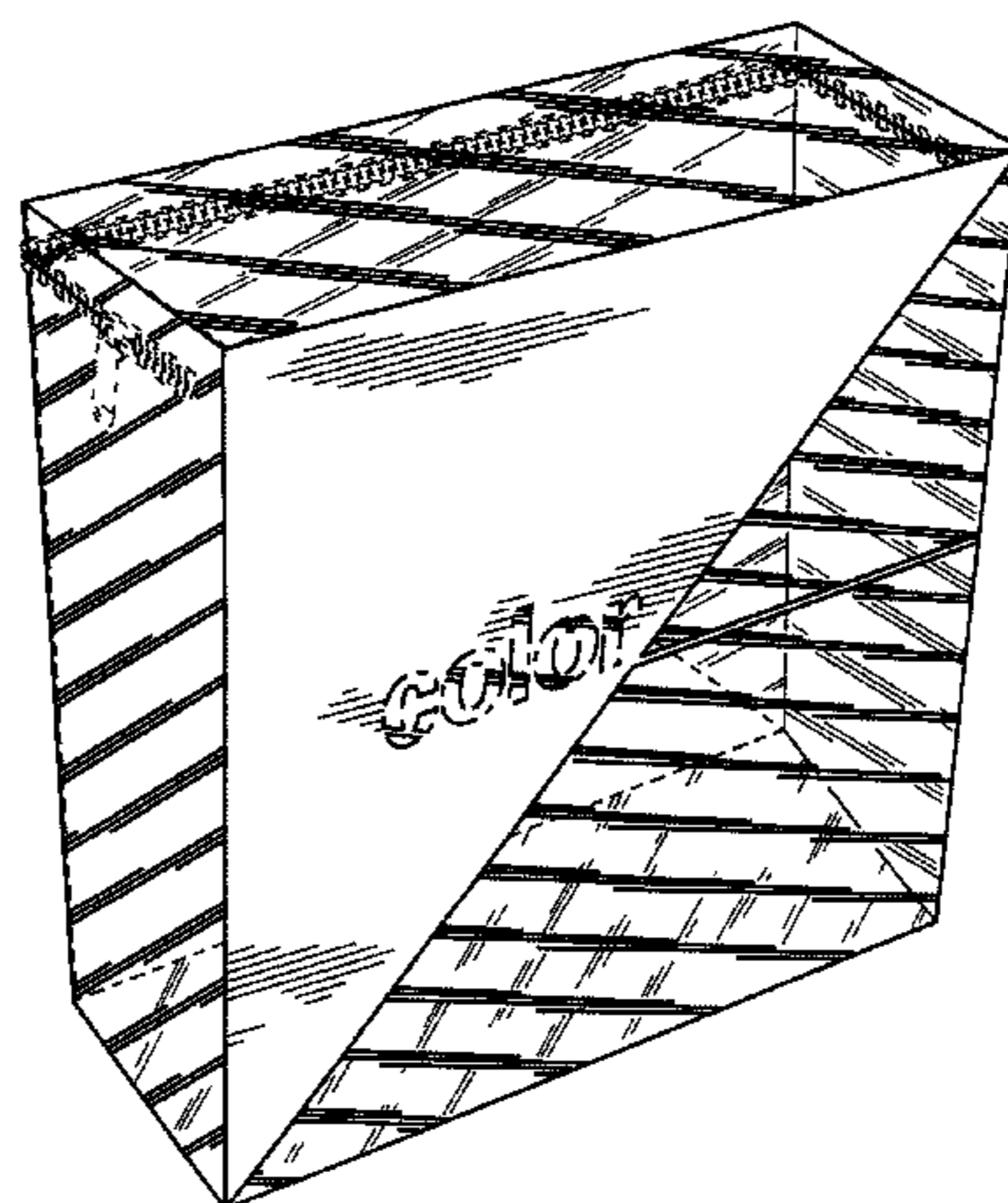
FIG. 13 is a back view of the package for linens of FIG. 1 shown in an exemplary display environment with other packages arranged right side up in a stacked configuration;

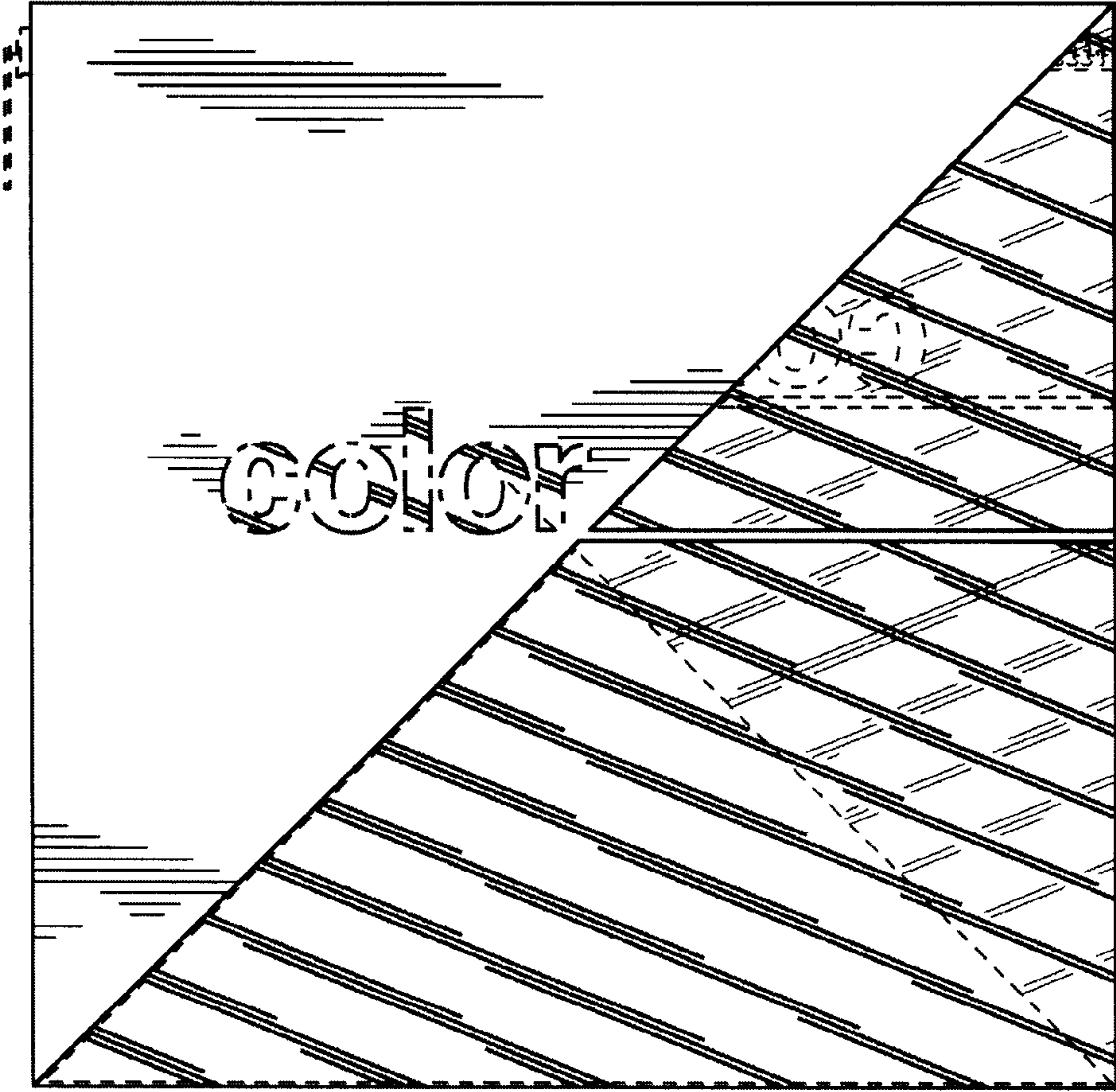

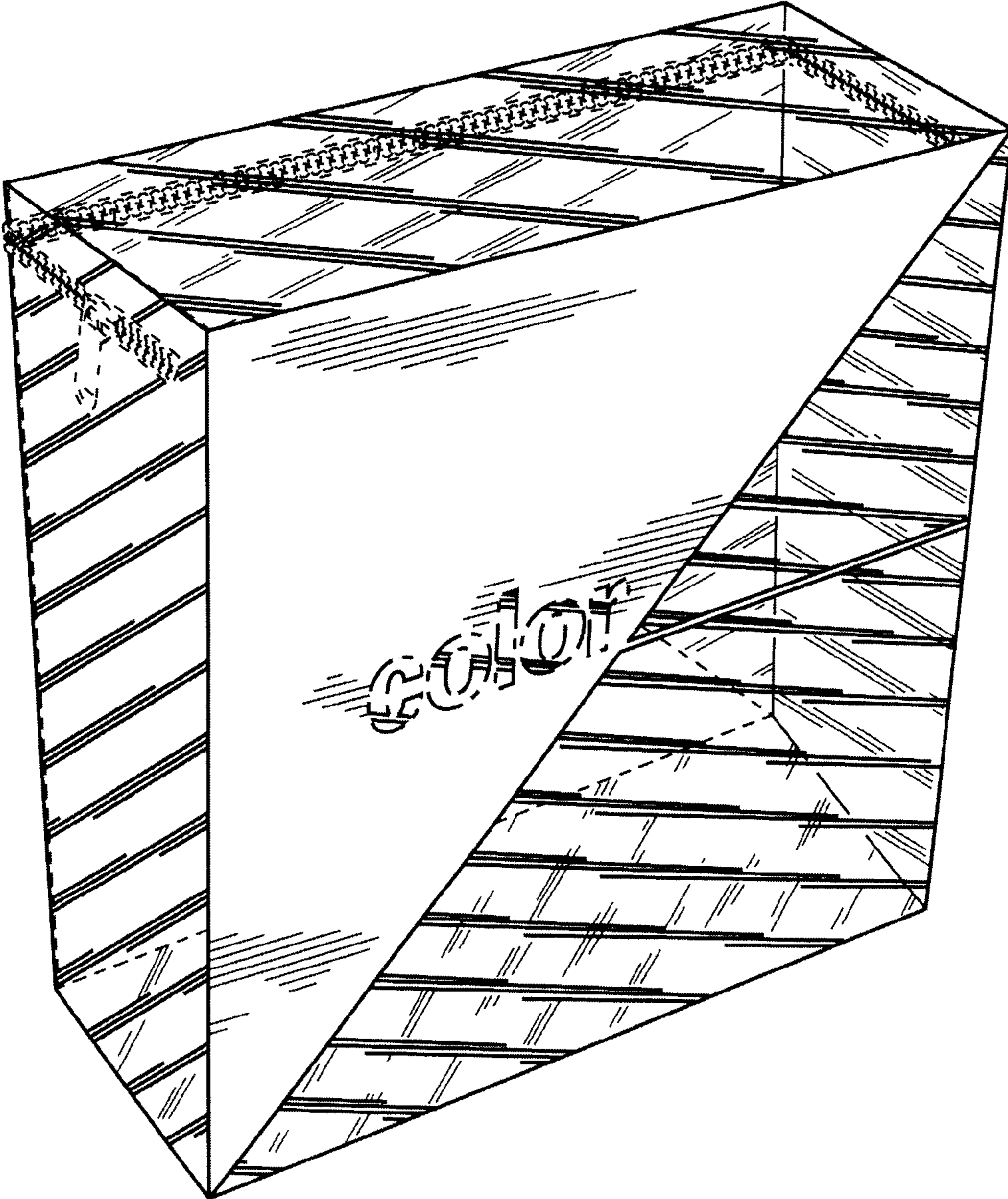

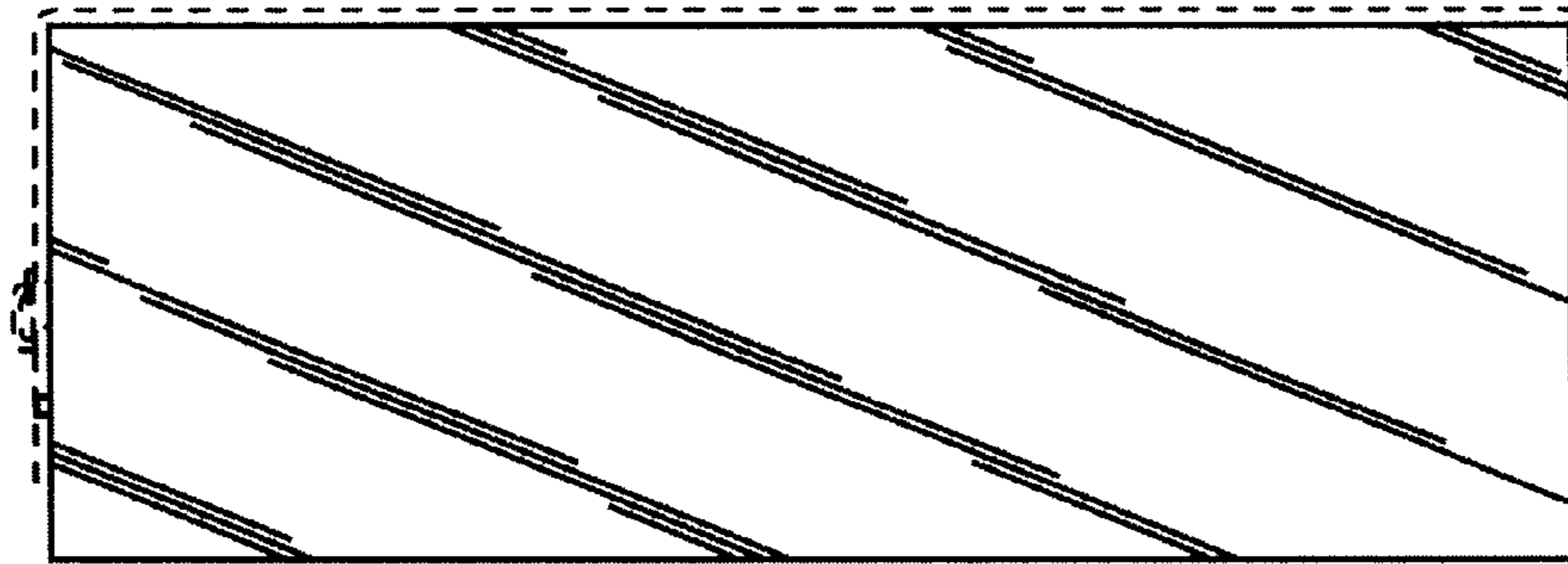

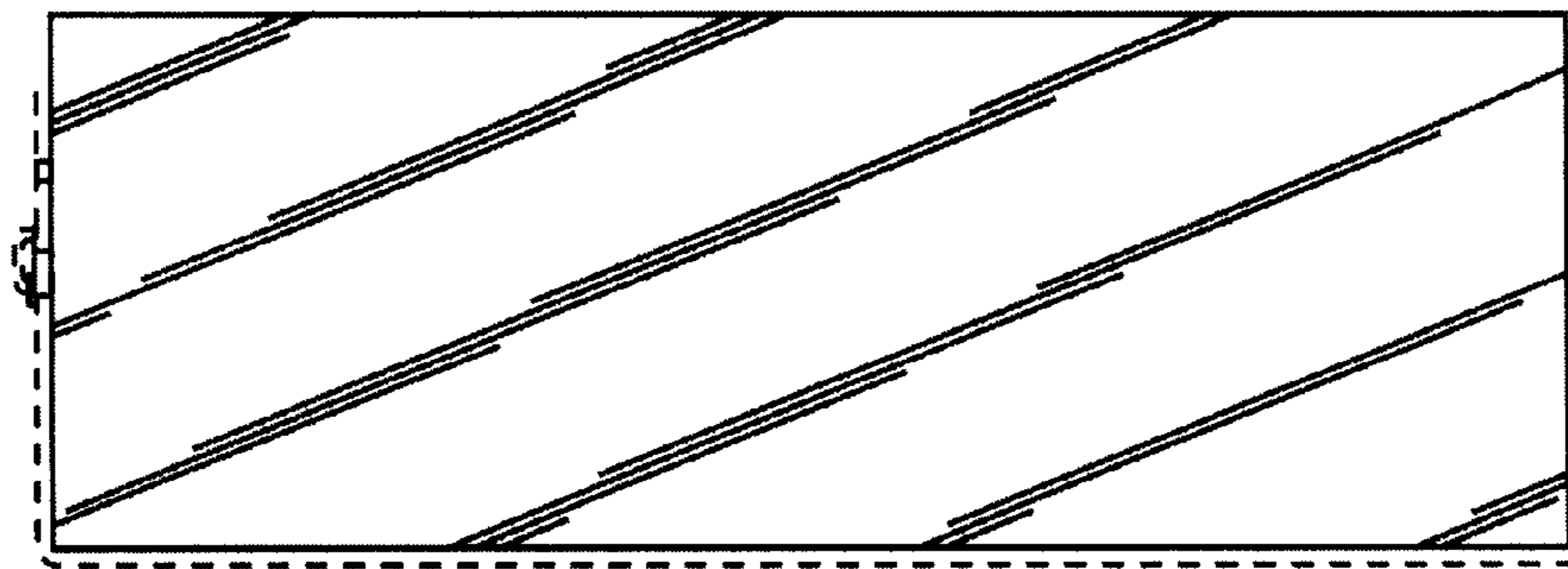

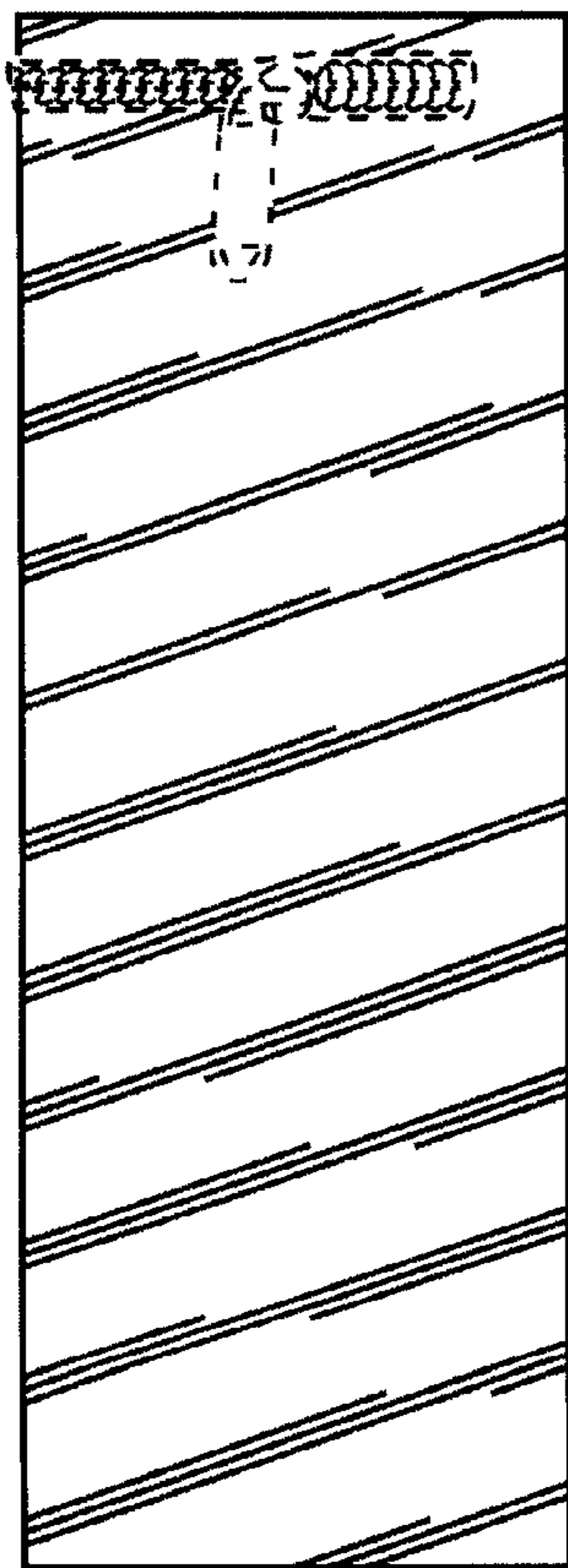

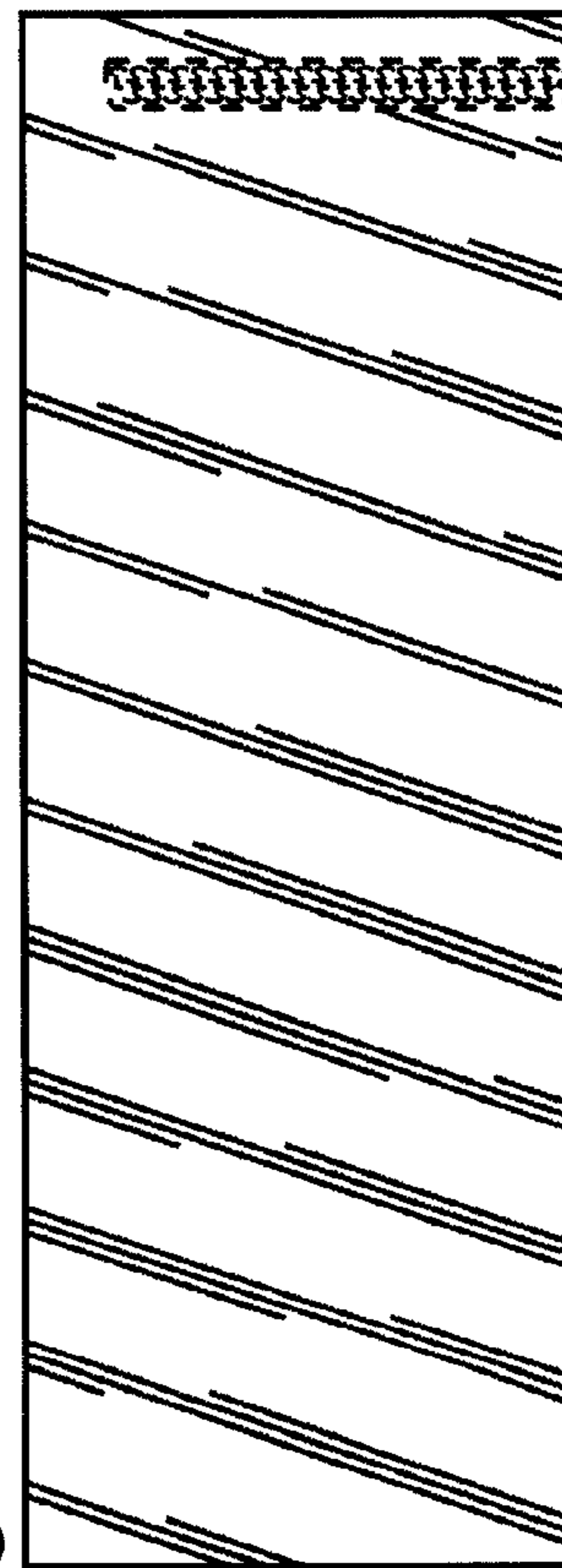

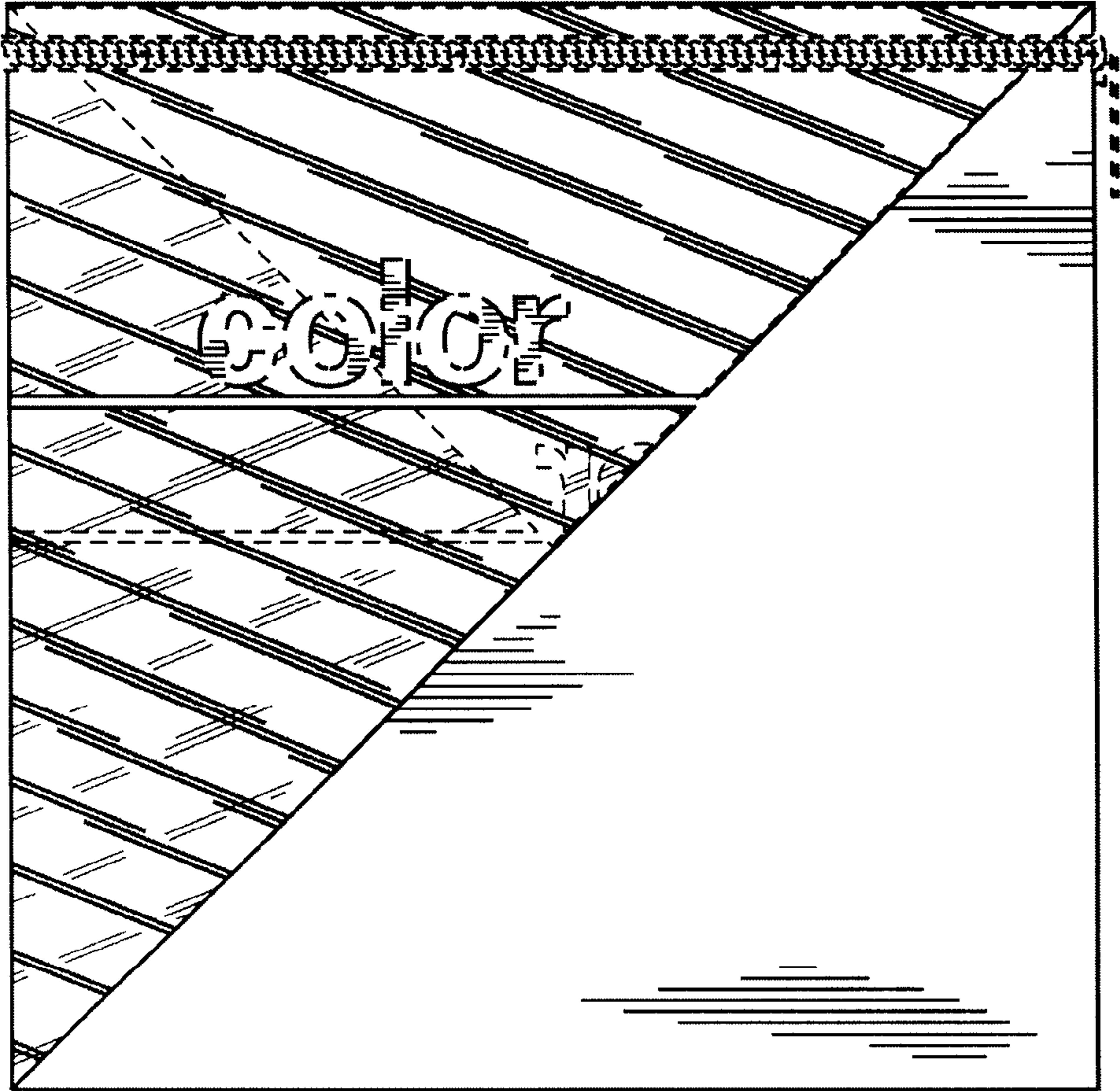

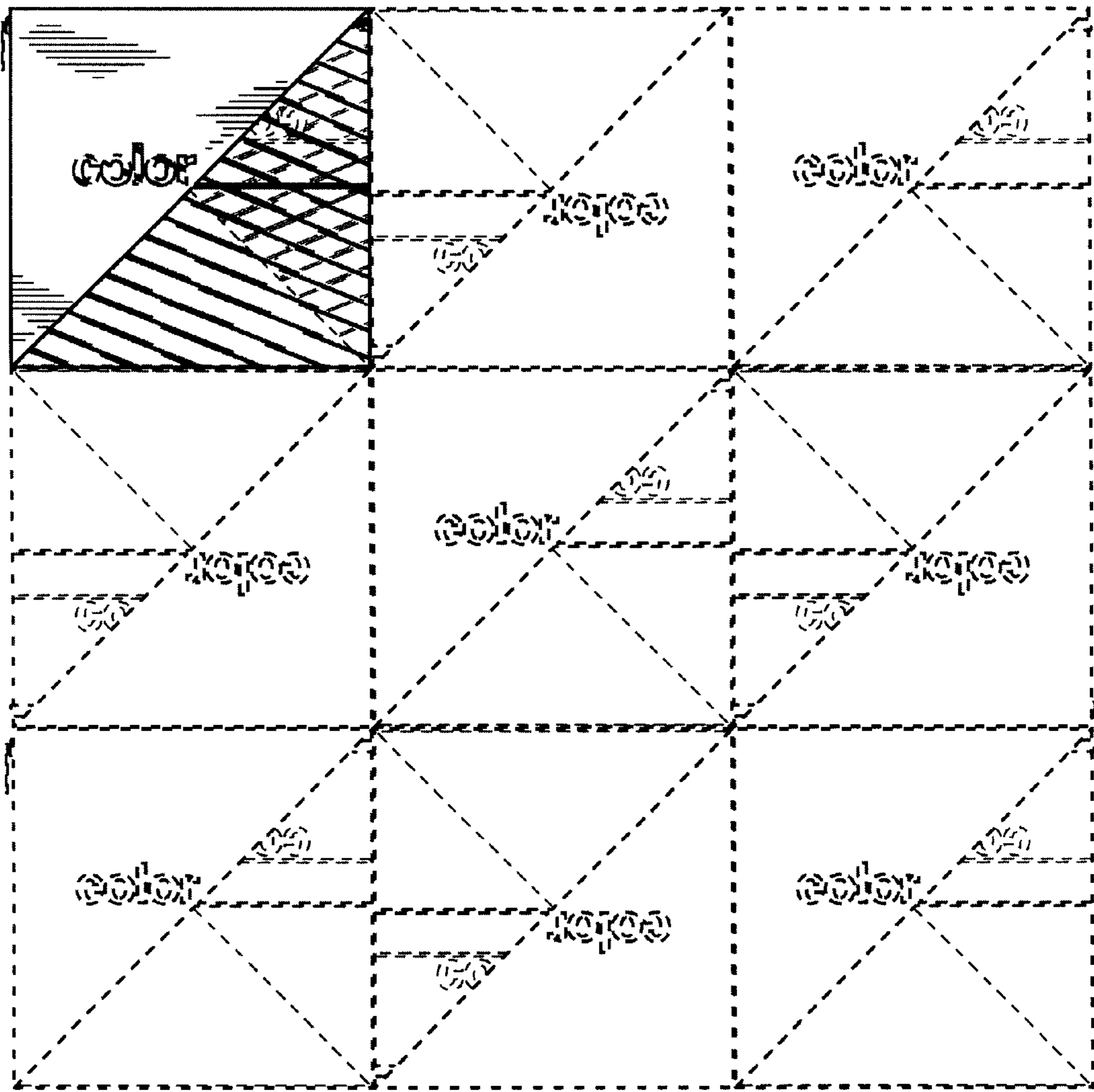

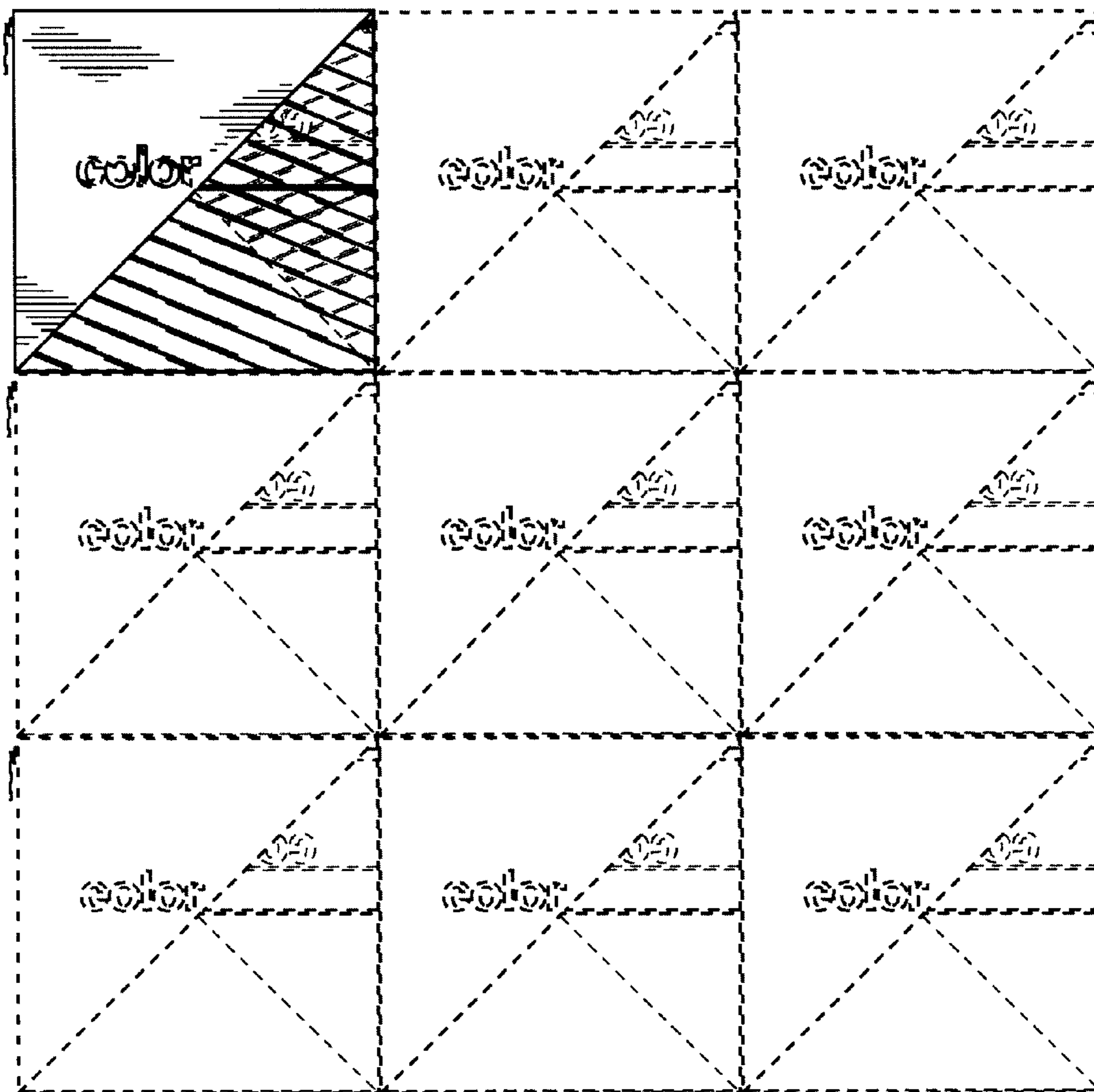

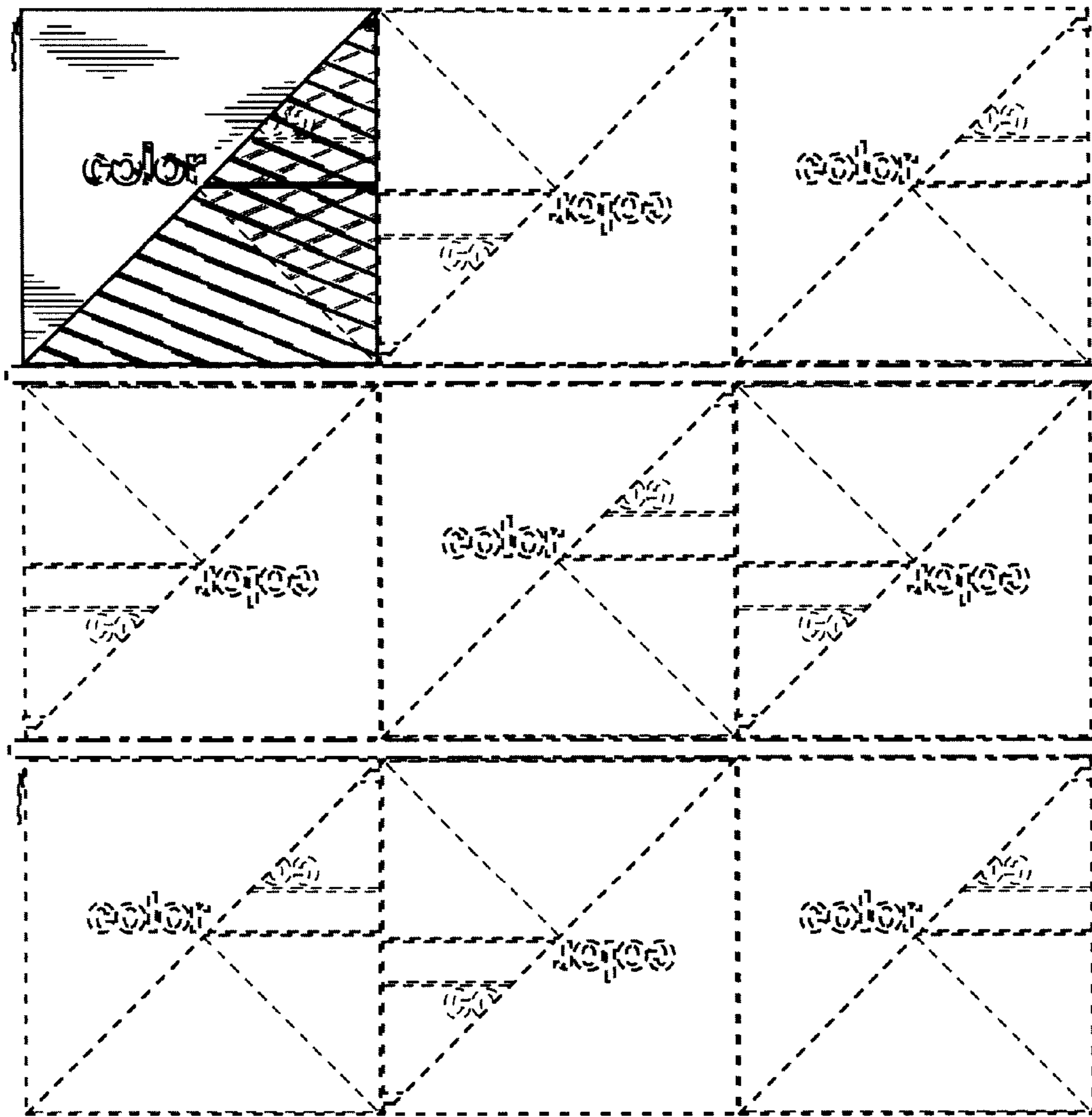

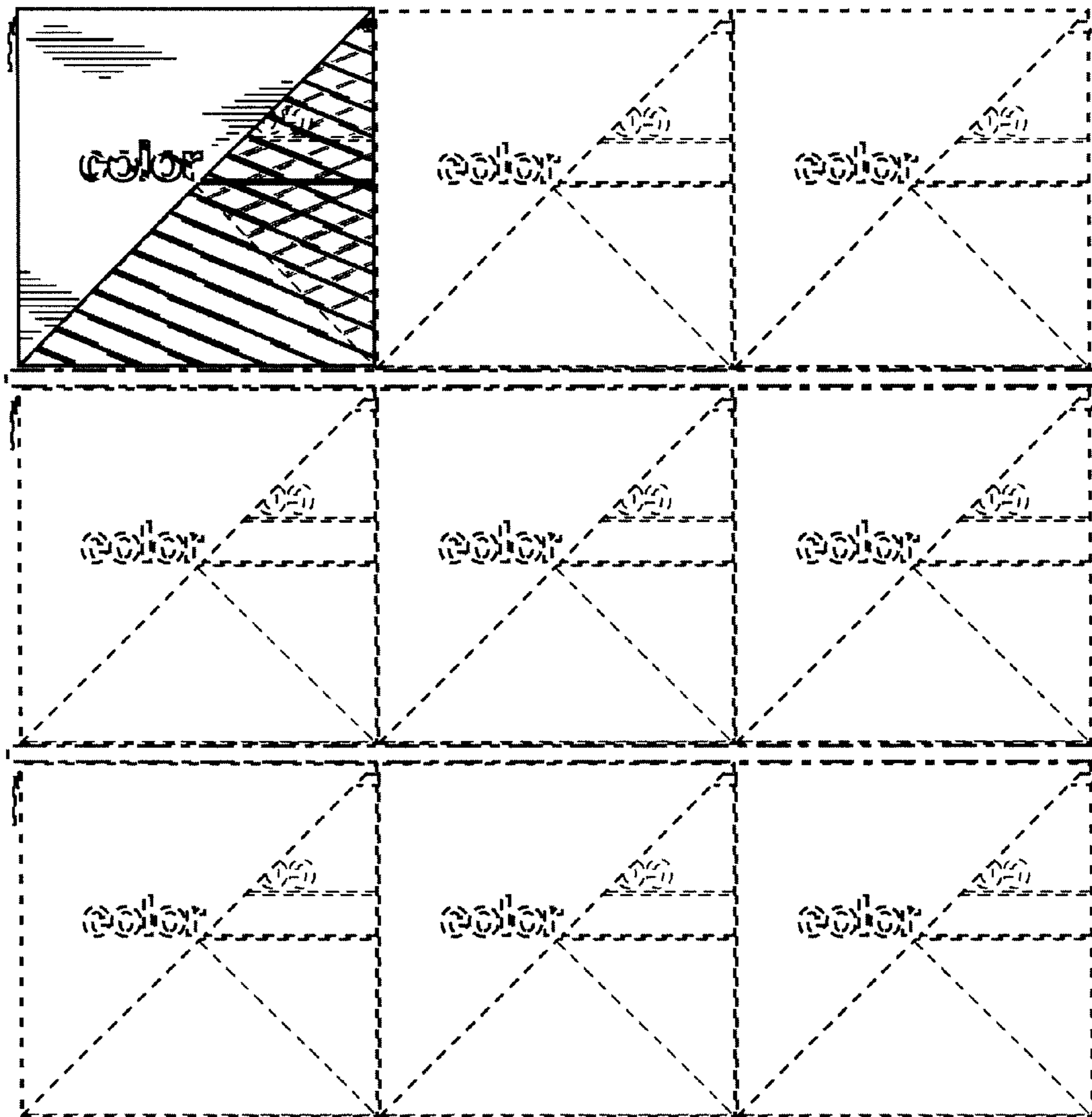

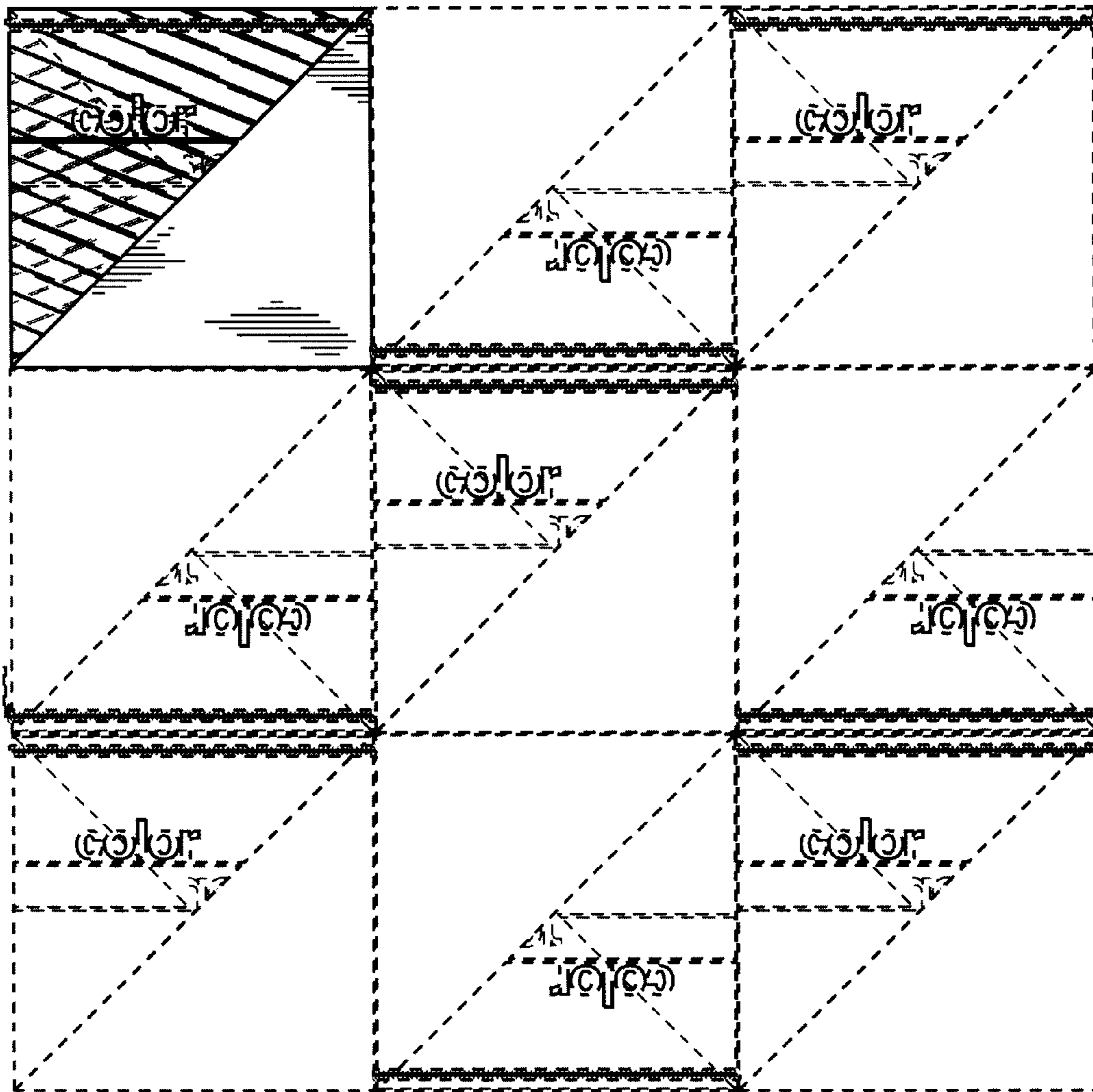

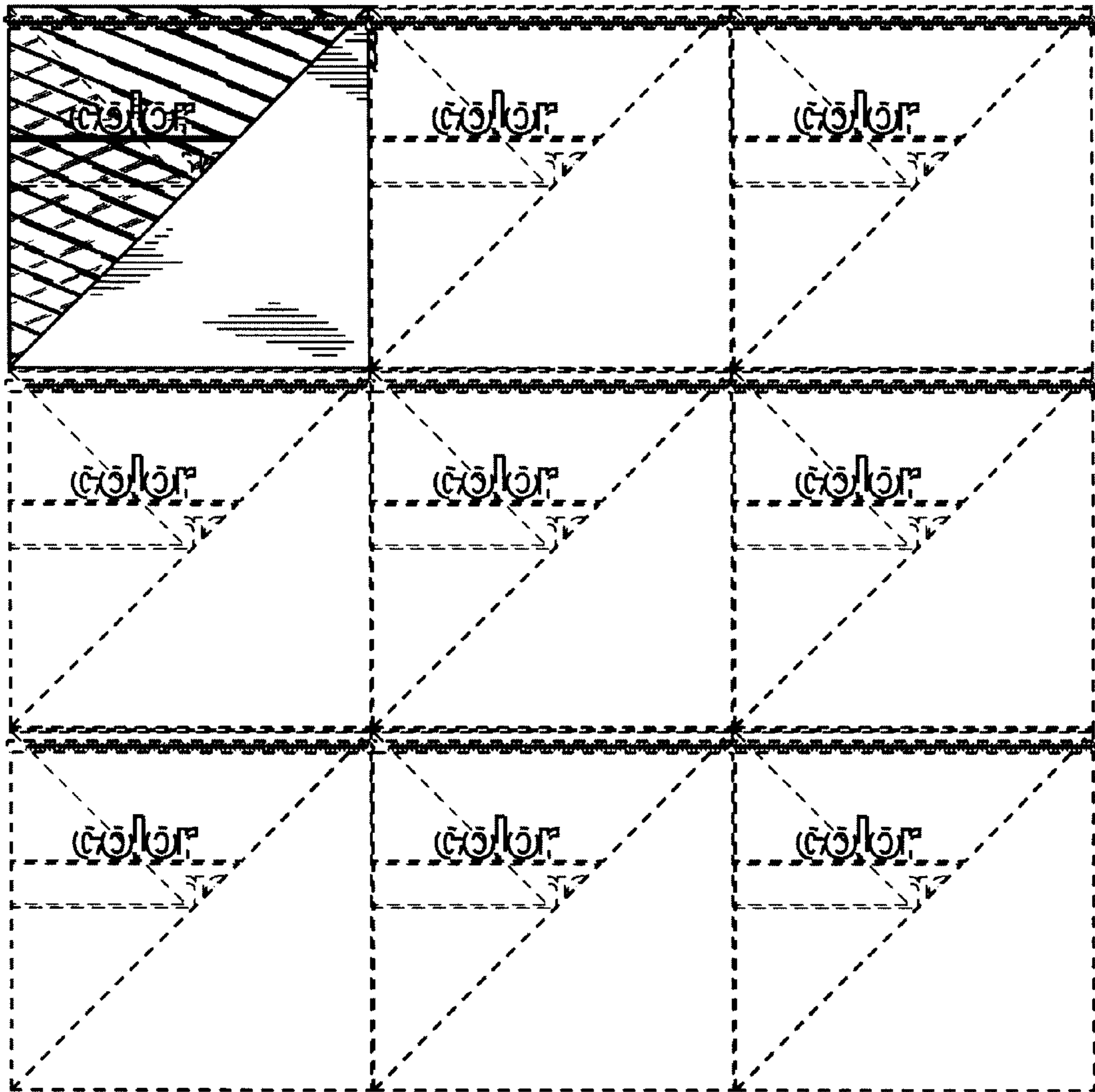

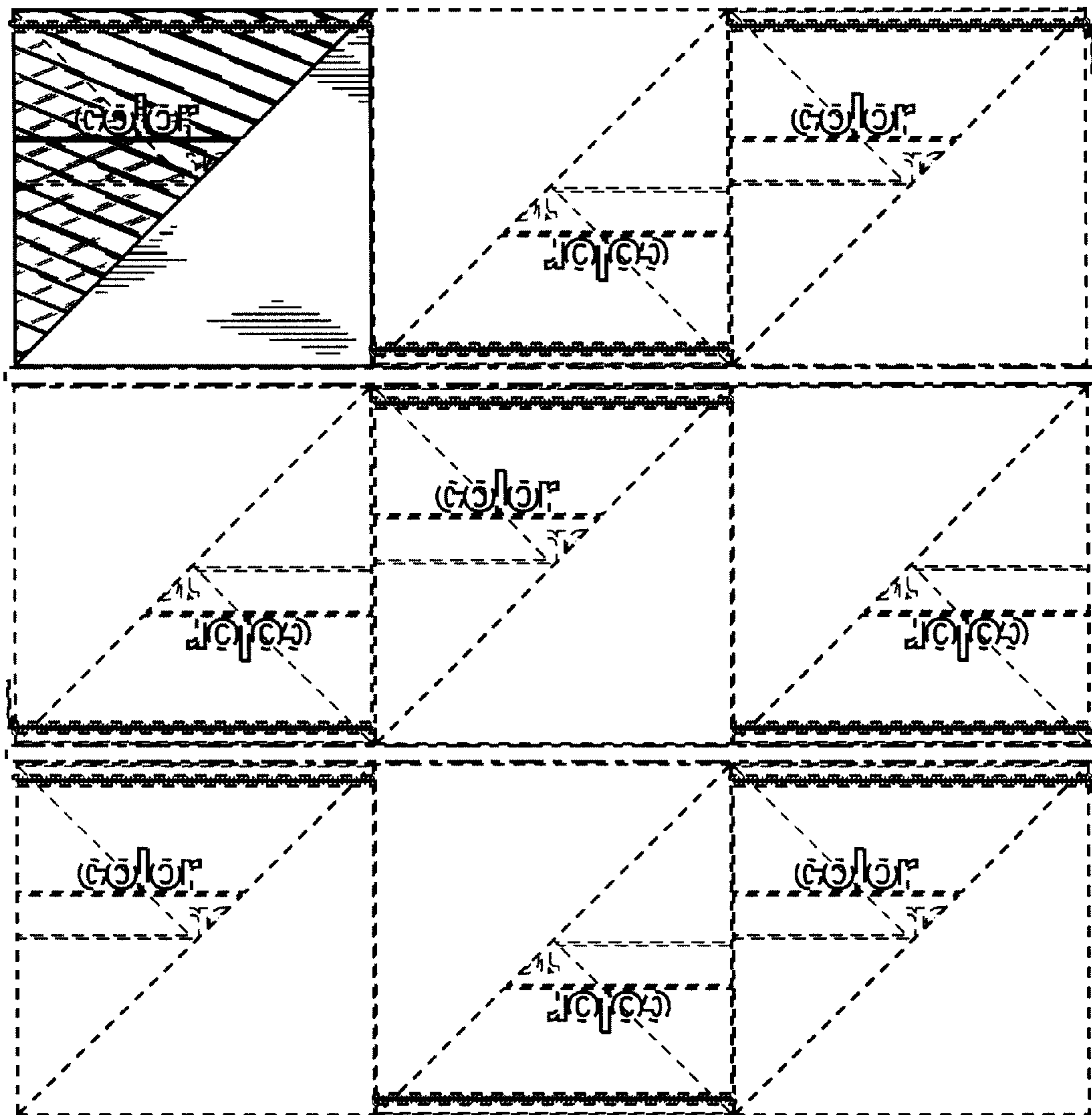
