The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle, showing my new design;

FIG. 2 is a front view thereof, with the back view being a mirror image;

FIG. 3 is a side view thereof, with the opposite side view being identical;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

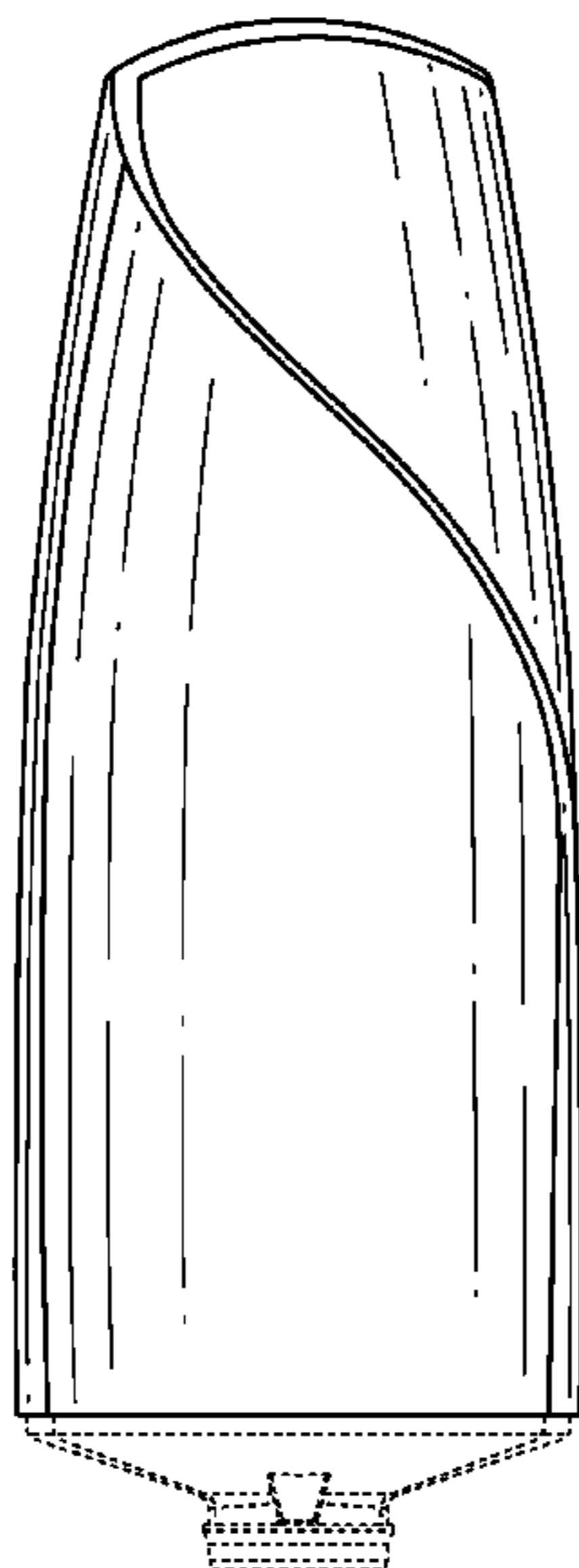

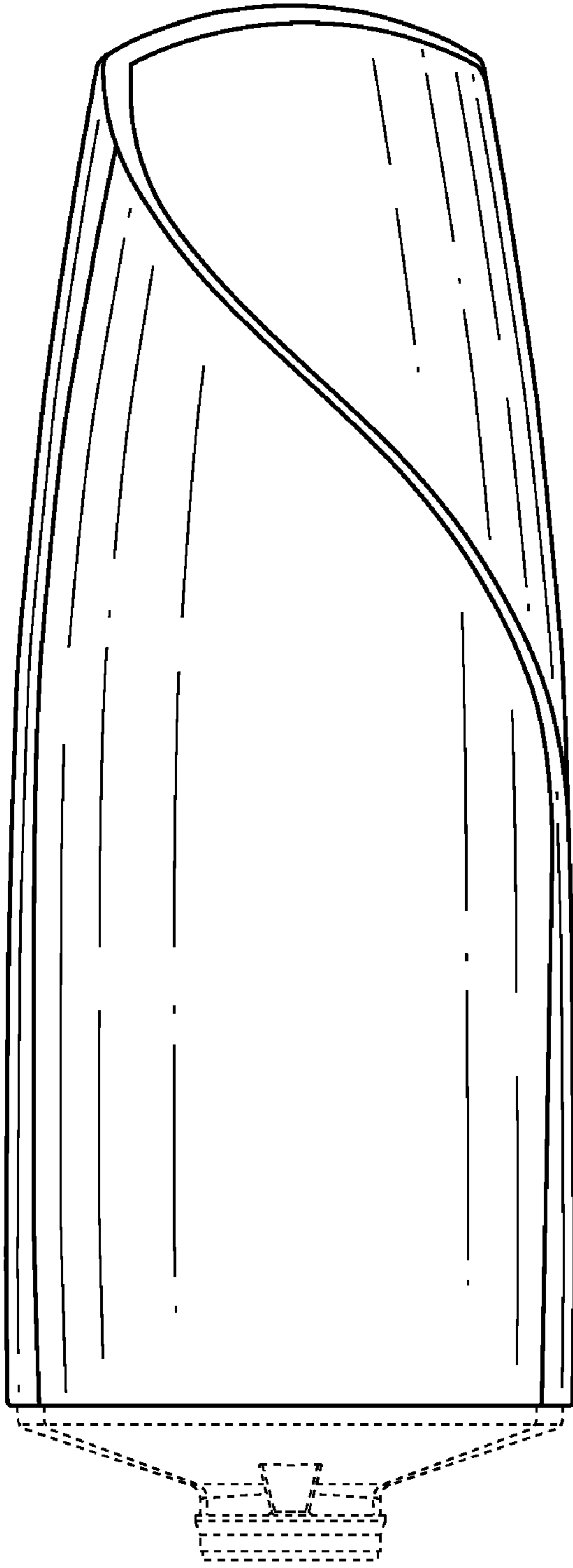

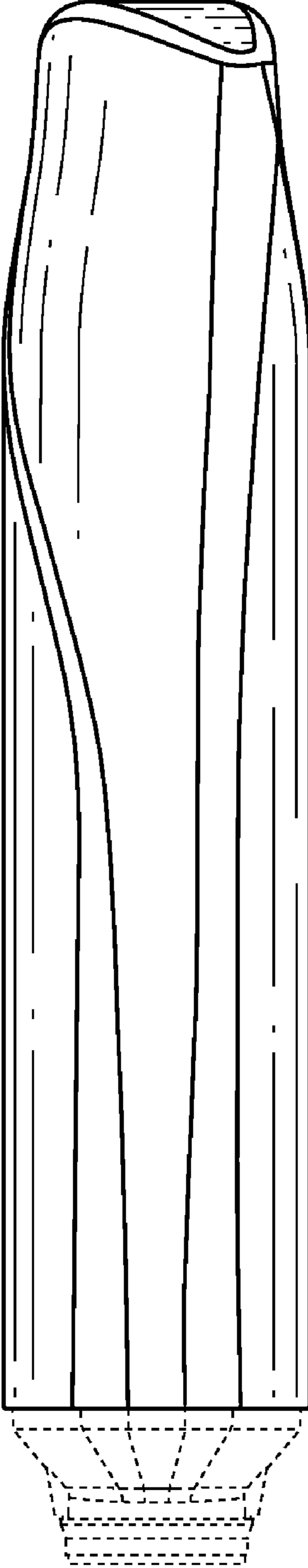

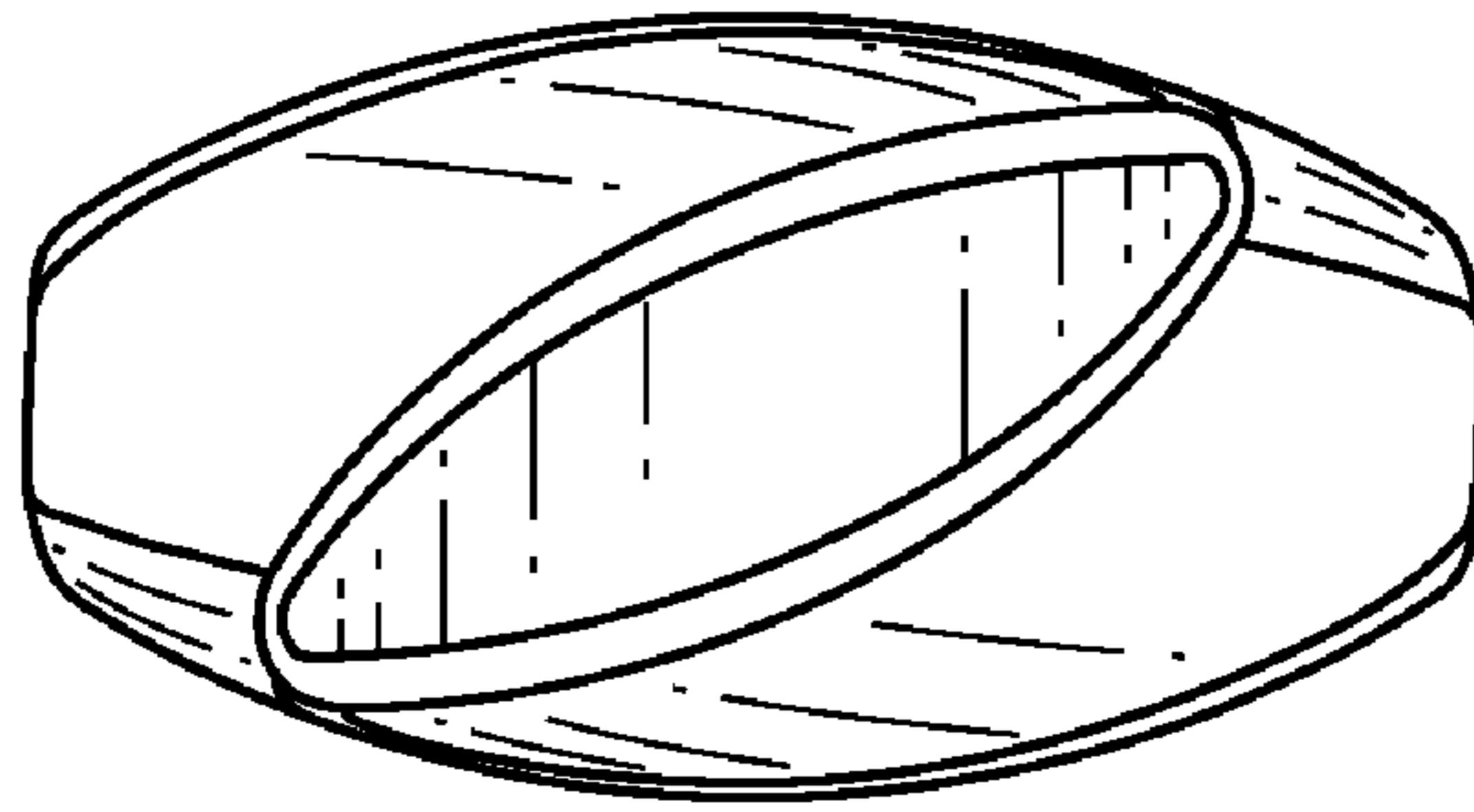

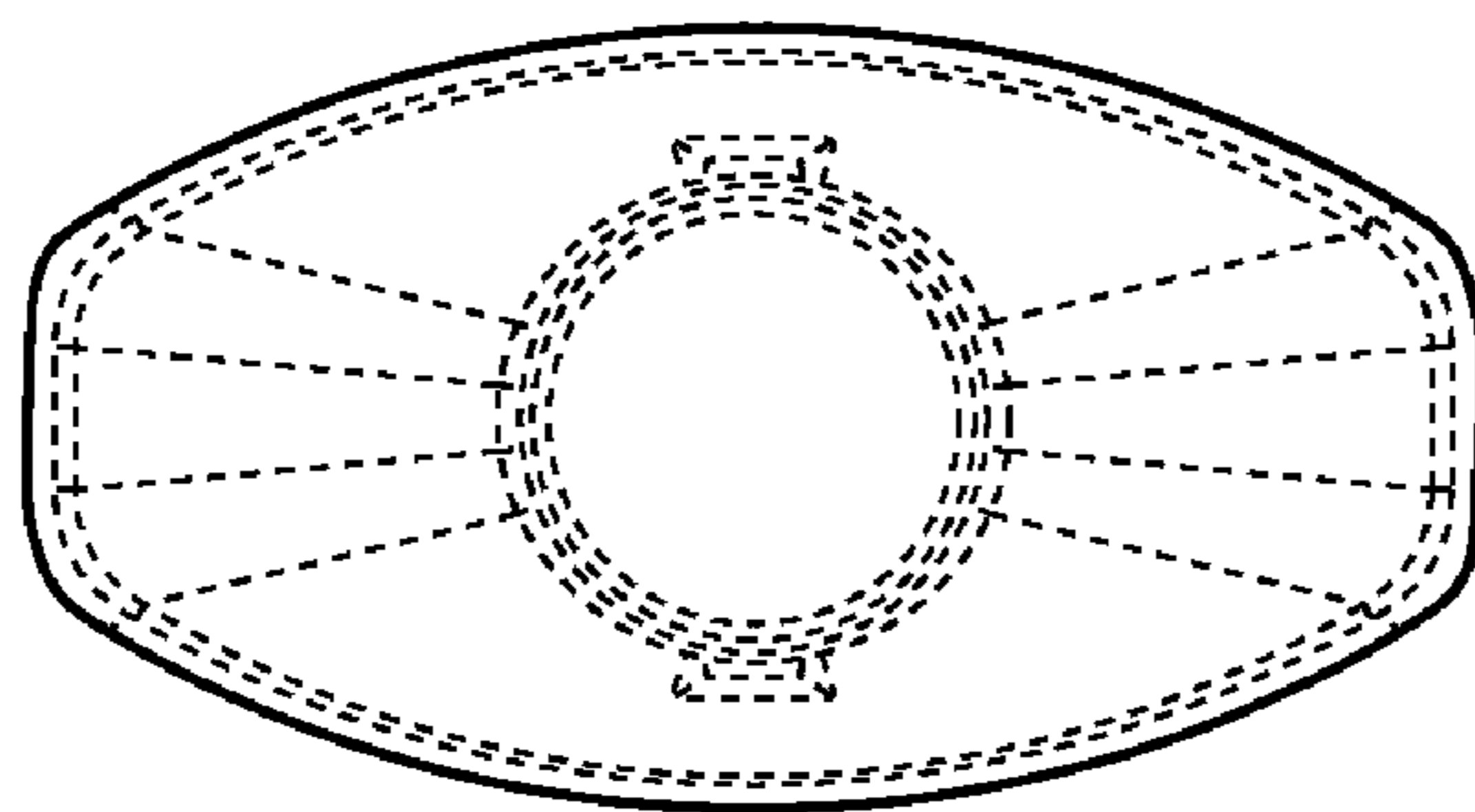
