(57) **CLAIM**

The ornamental design for a double leaf jewelry bail, as shown and described.

FIG. 1 is a perspective view of a double leaf jewelry bail, showing our new design.

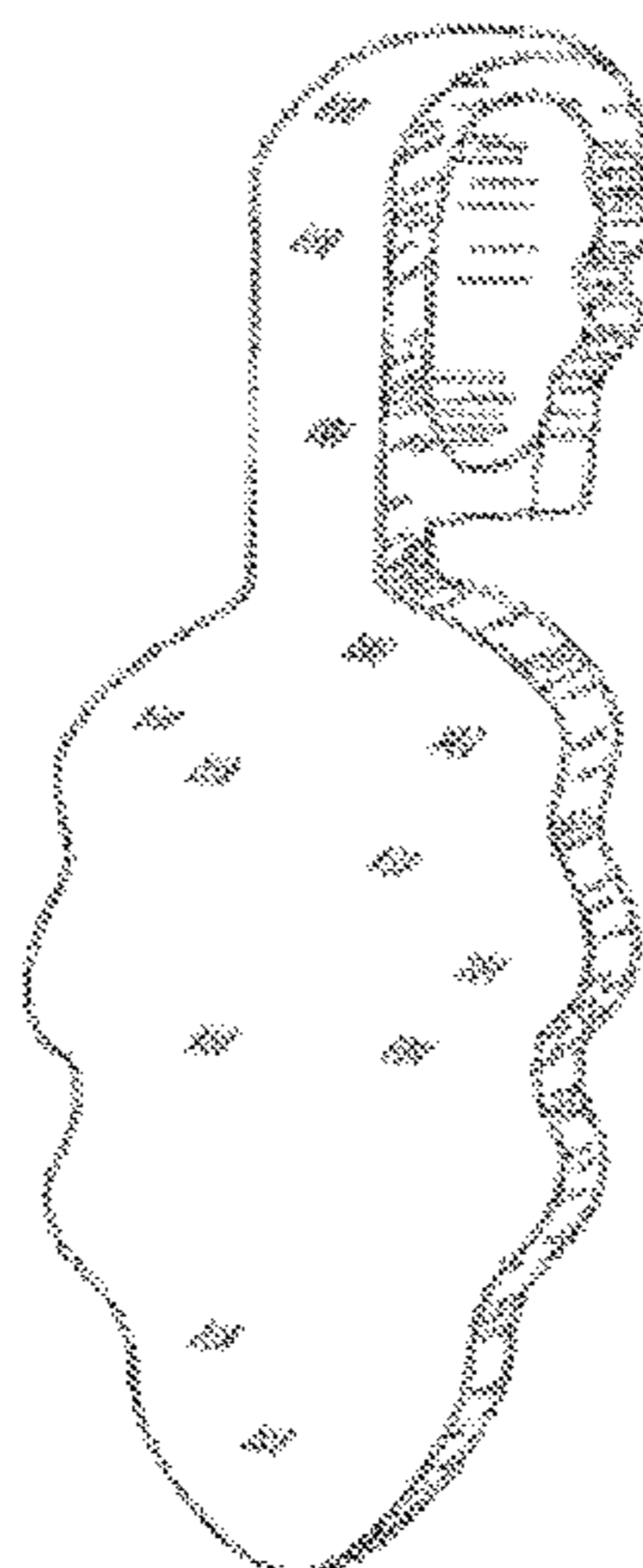
FIG. 2 is a front elevational view;

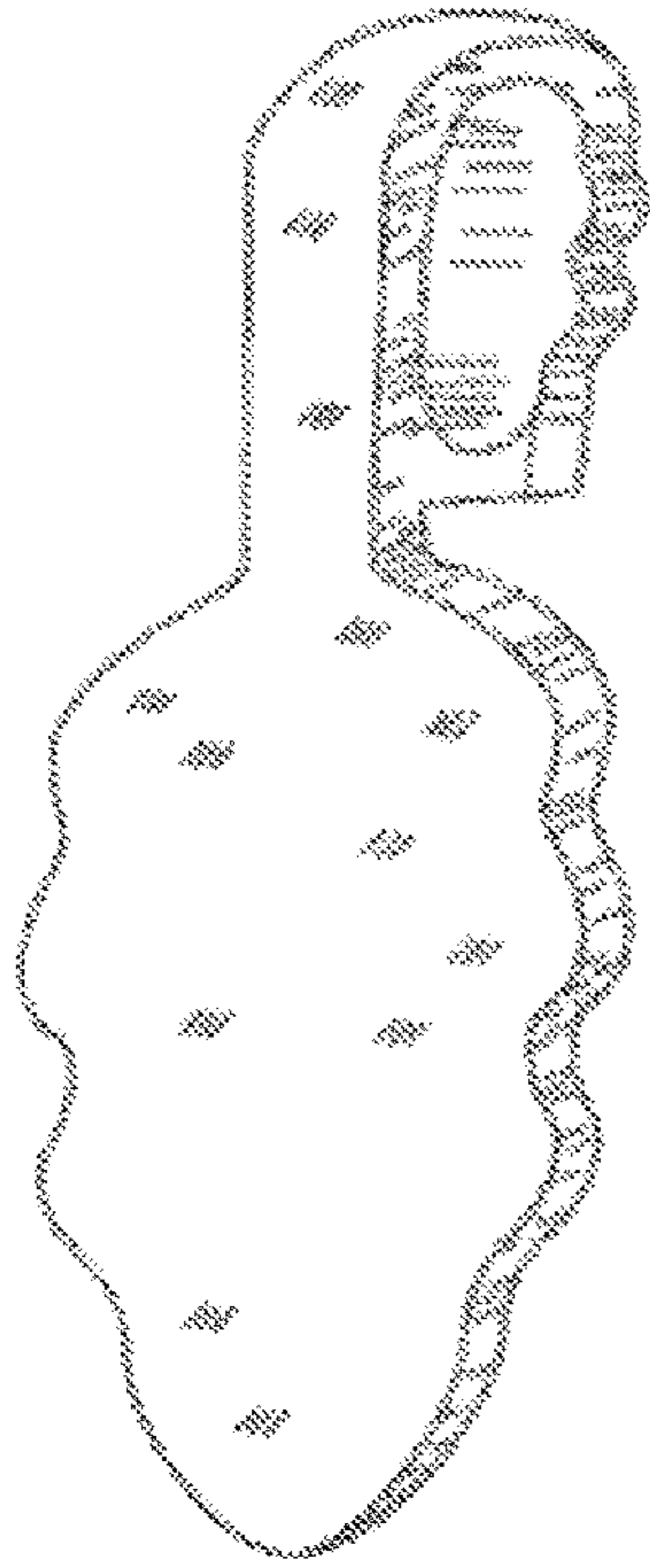

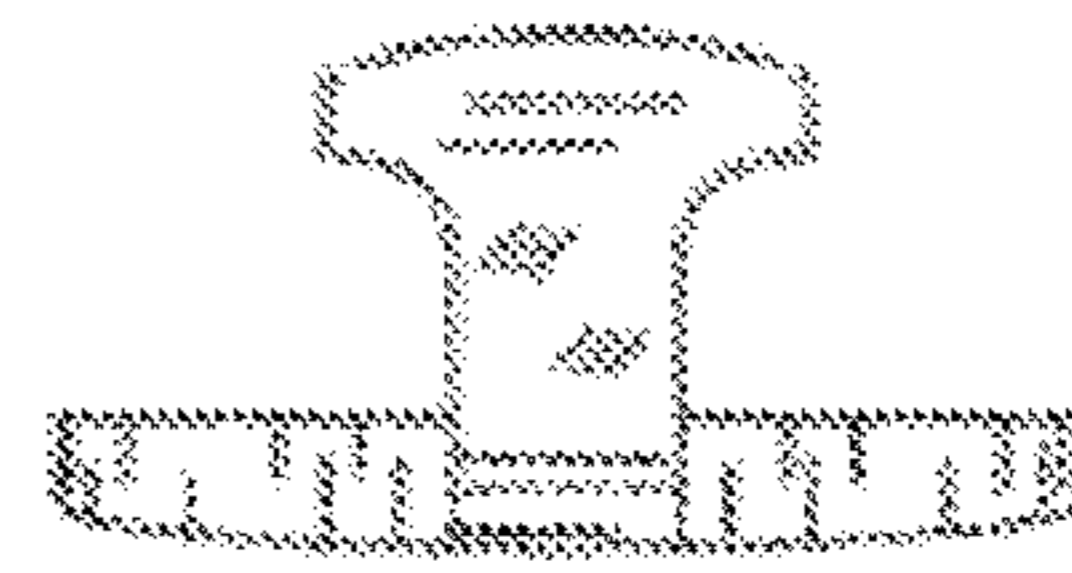

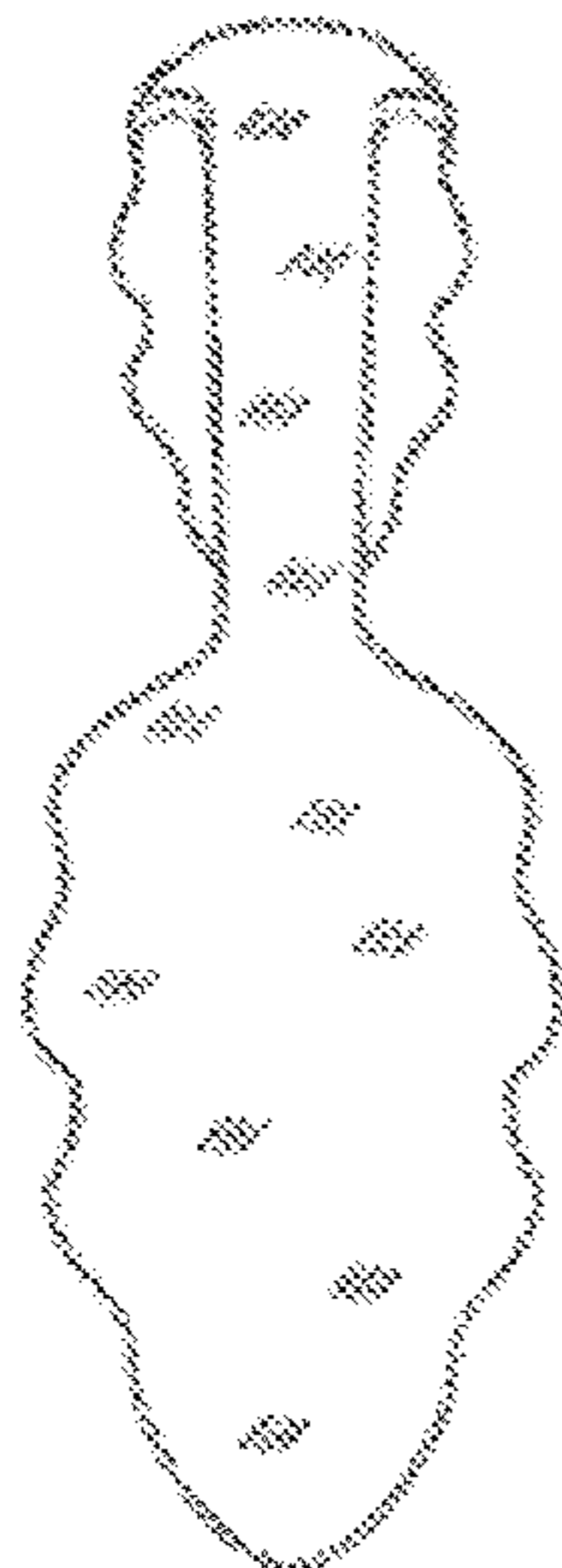

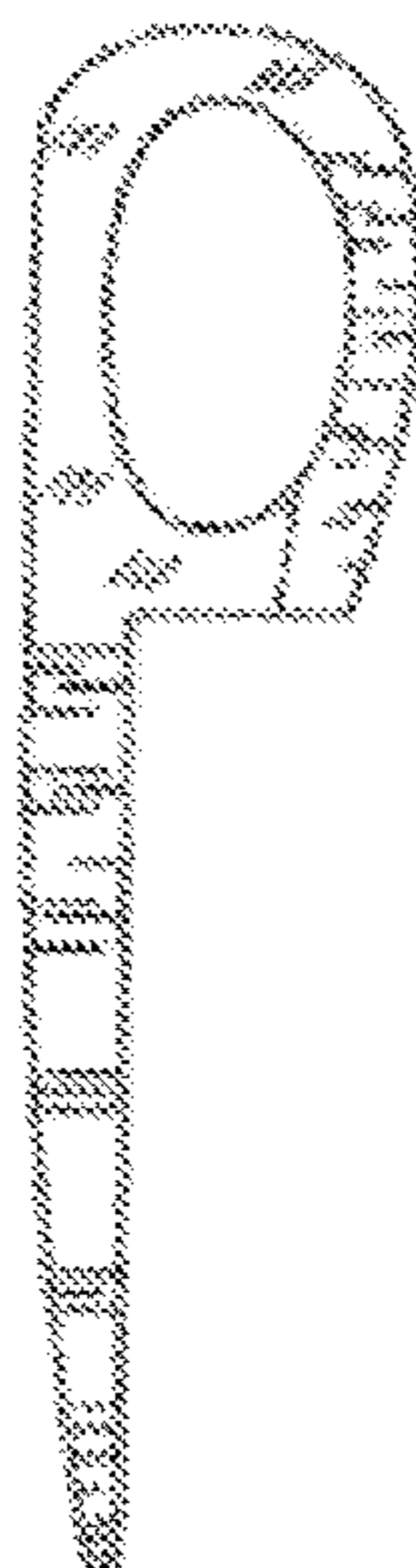

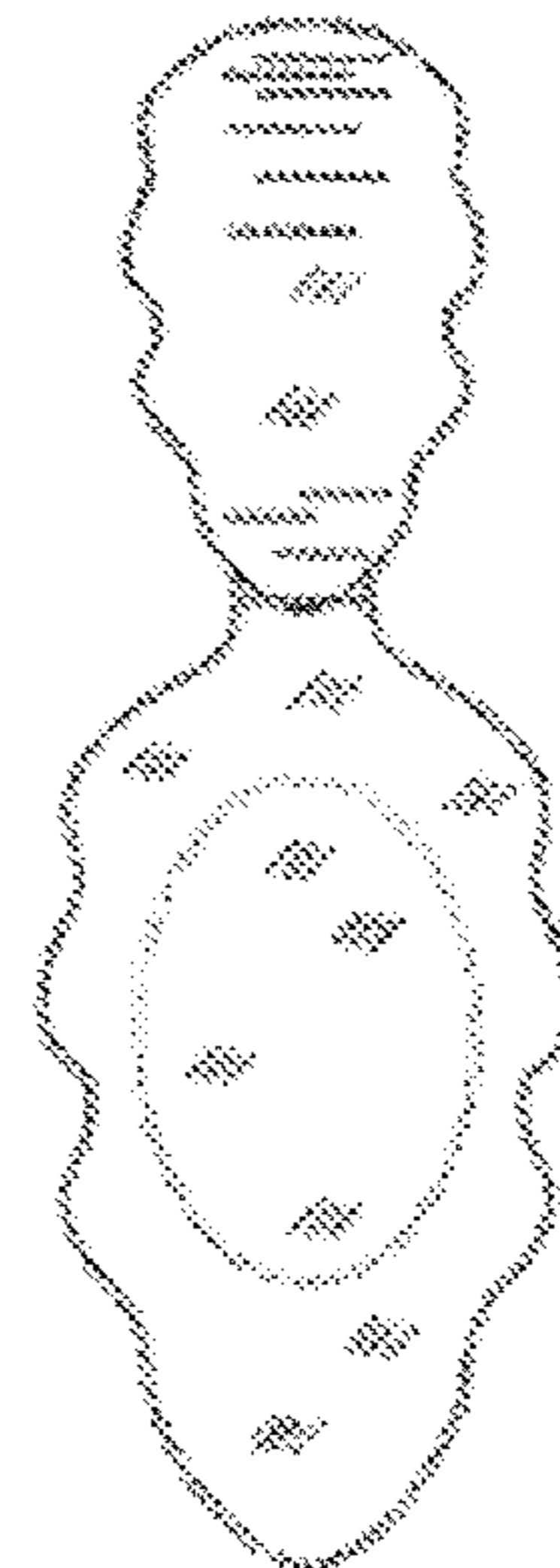
