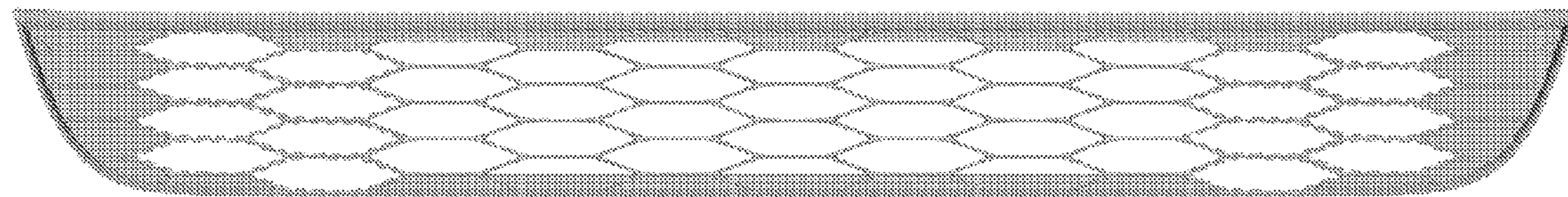
(57) **CLAIM**

An ornamental design for a vehicle grille lower, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a vehicle grille lower;
FIG. 2 is a bottom plan view of the vehicle grille lower;
FIG. 3 is a front elevational view of the vehicle grille lower;
FIG. 4 is a left side elevational view of the vehicle grille lower;
FIG. 5 is a right side elevational view of the vehicle grille lower; and,

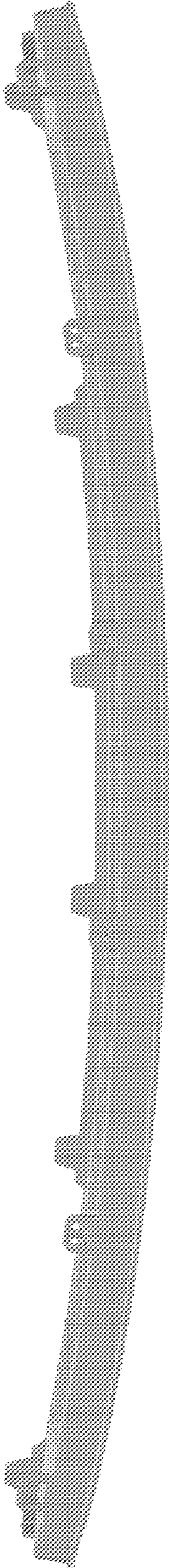
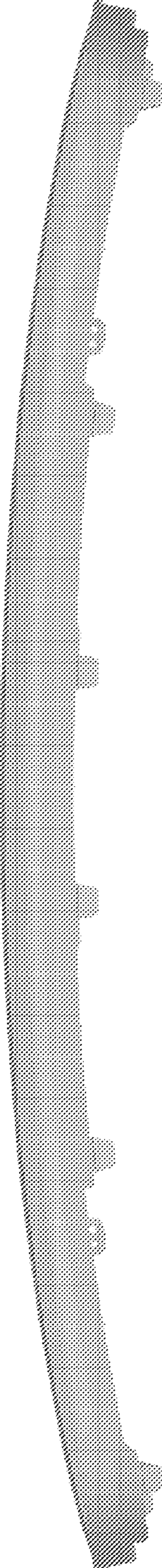

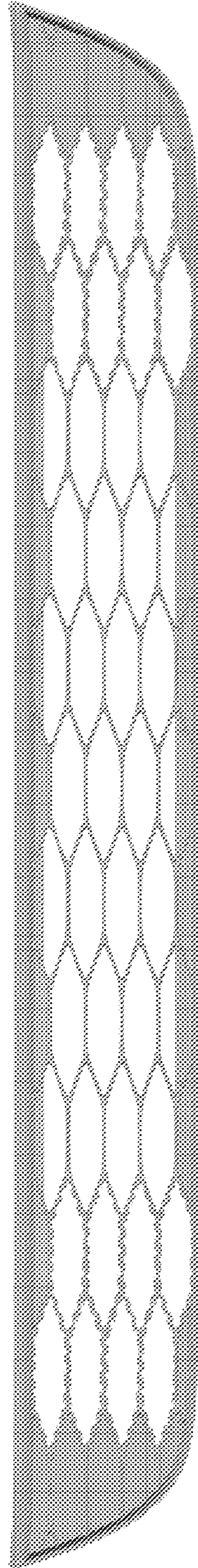

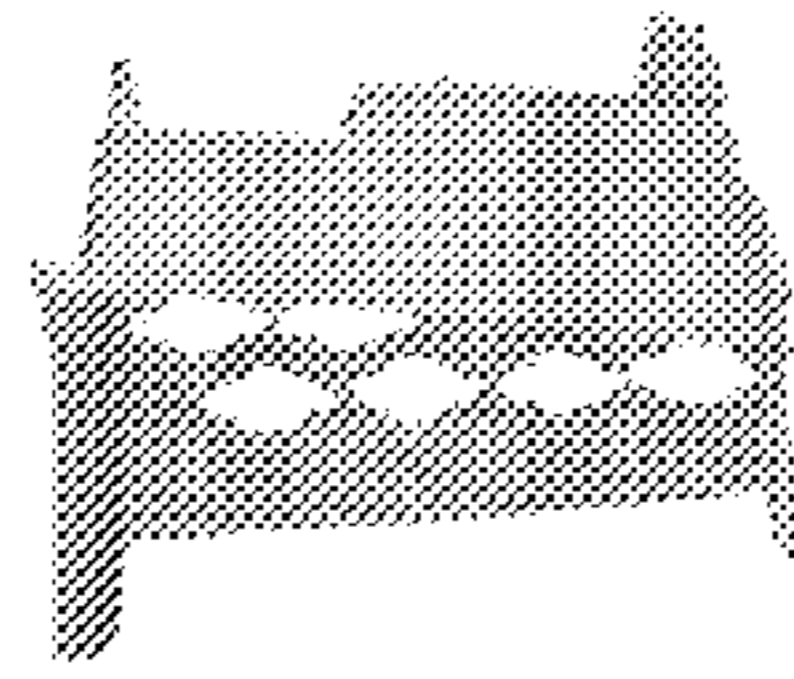

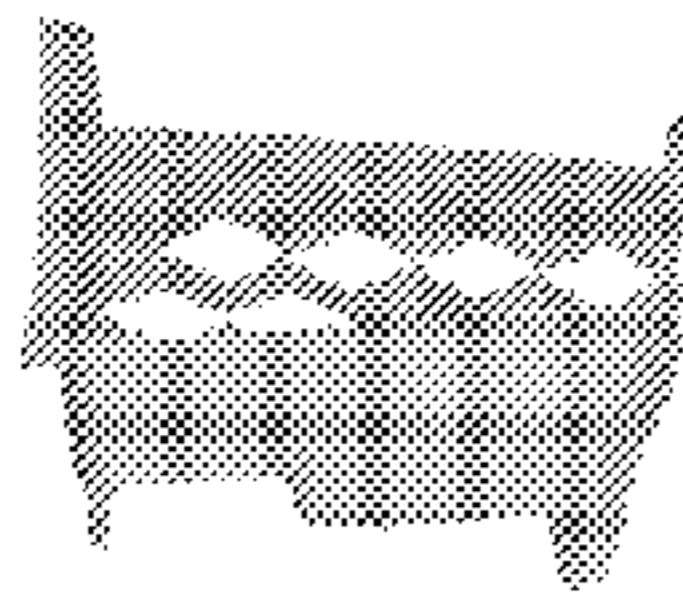

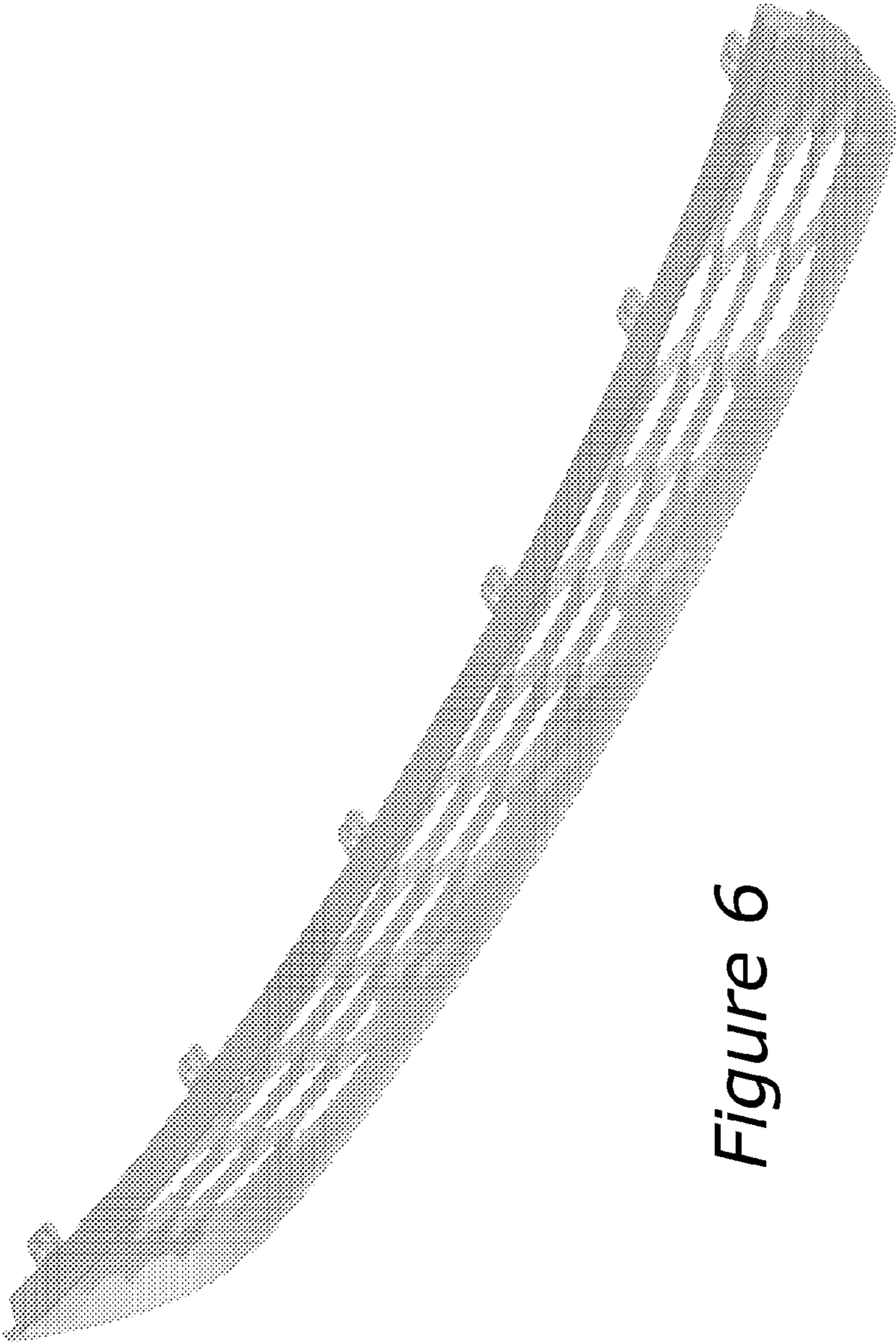
