(57) **CLAIM**

The ornamental design for a cell phone, substantially as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a cell phone showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a back elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left elevational view thereof; and,

FIG. 7 is a right elevational view thereof.

The broken lines shown at the bottom in FIG. 5 represent the bounds of the claimed design; the broken lines form no part of the claimed design.

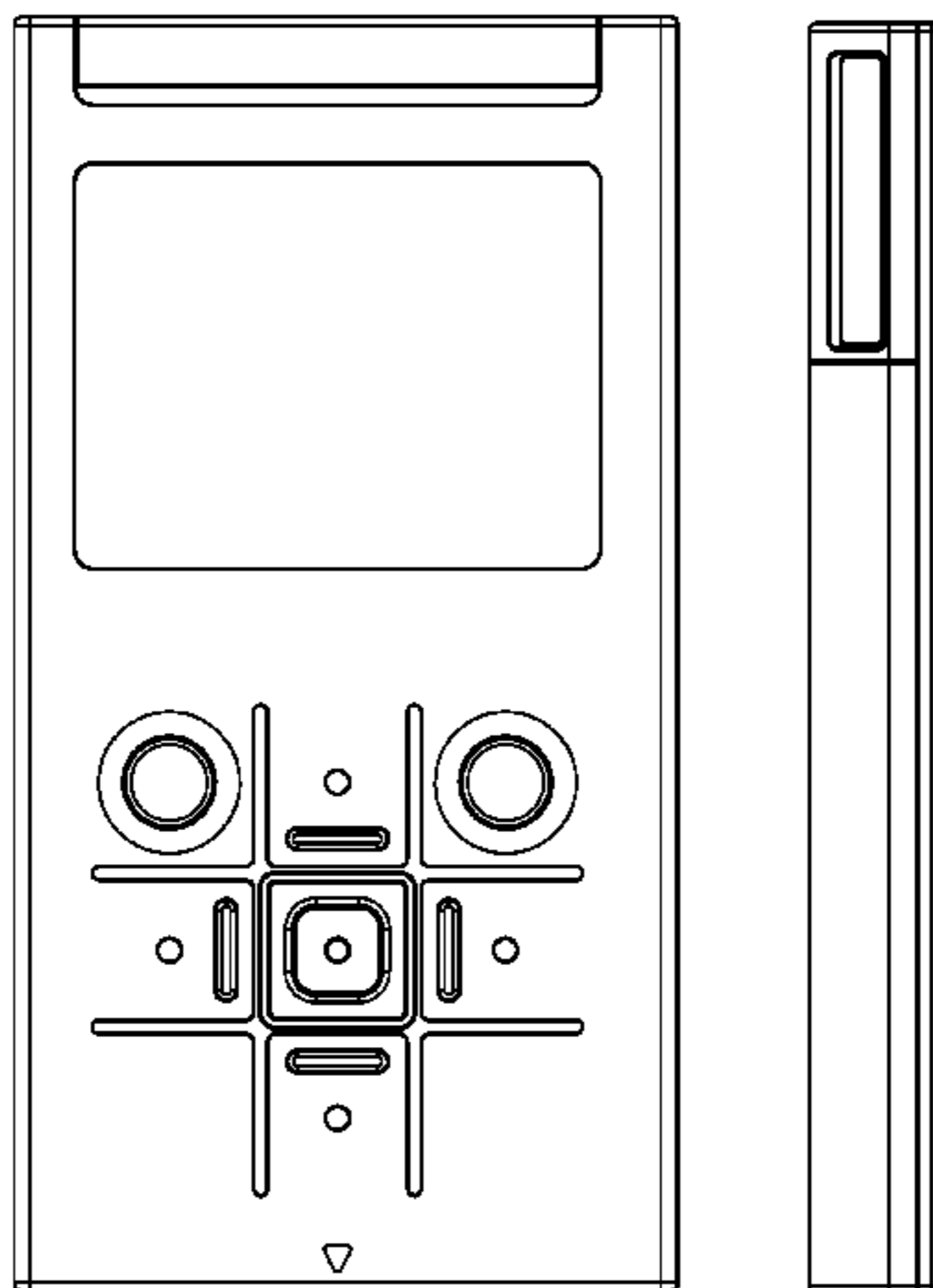

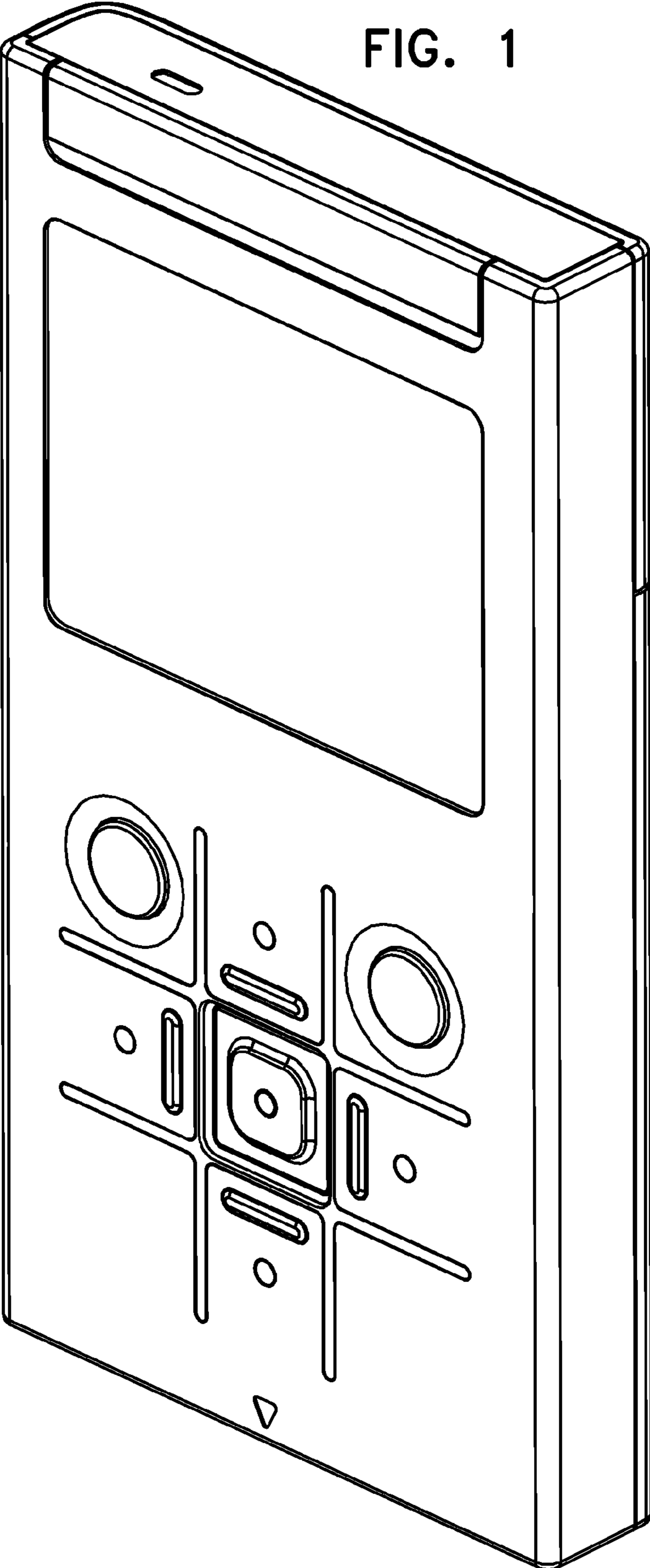

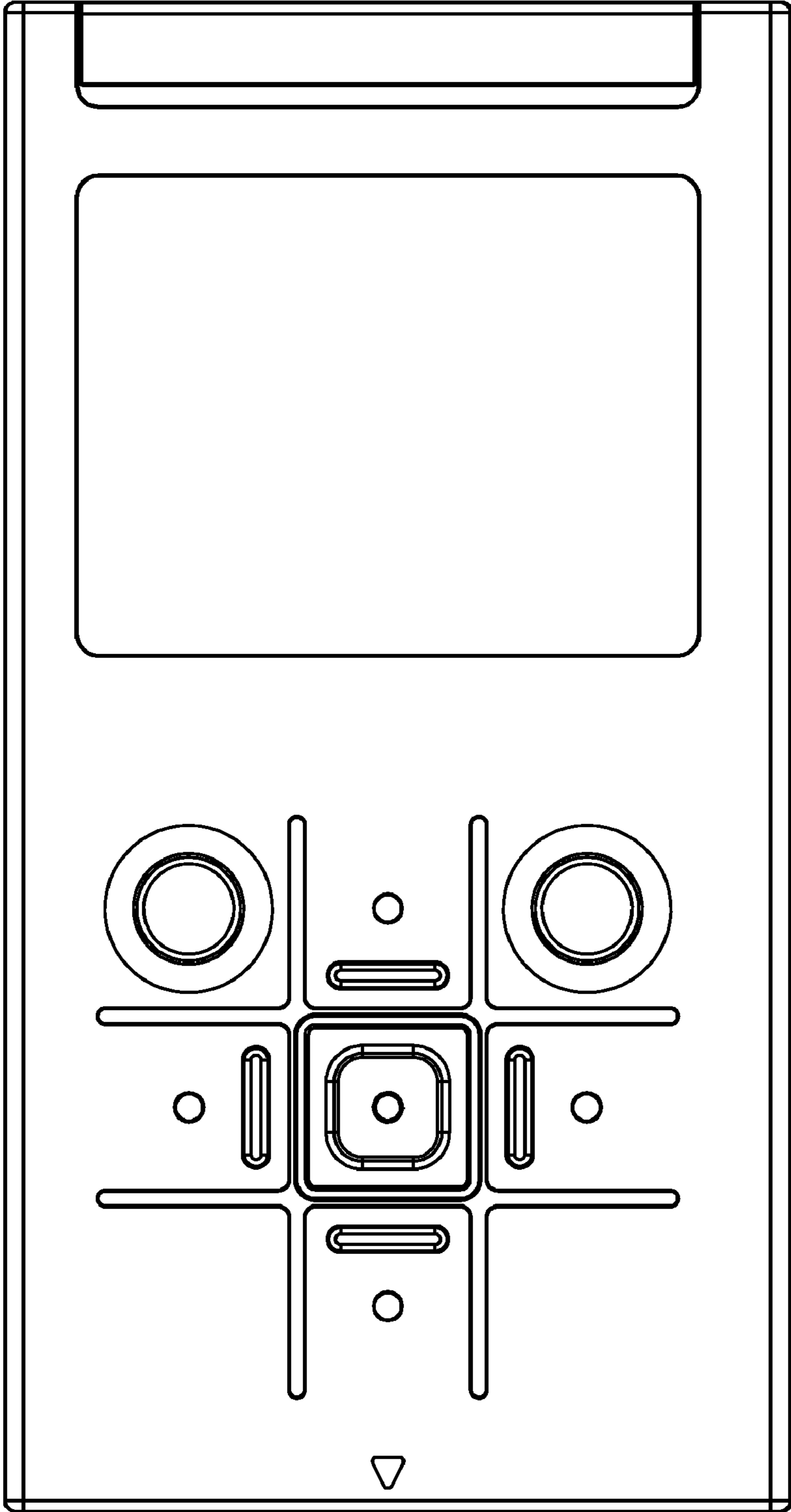

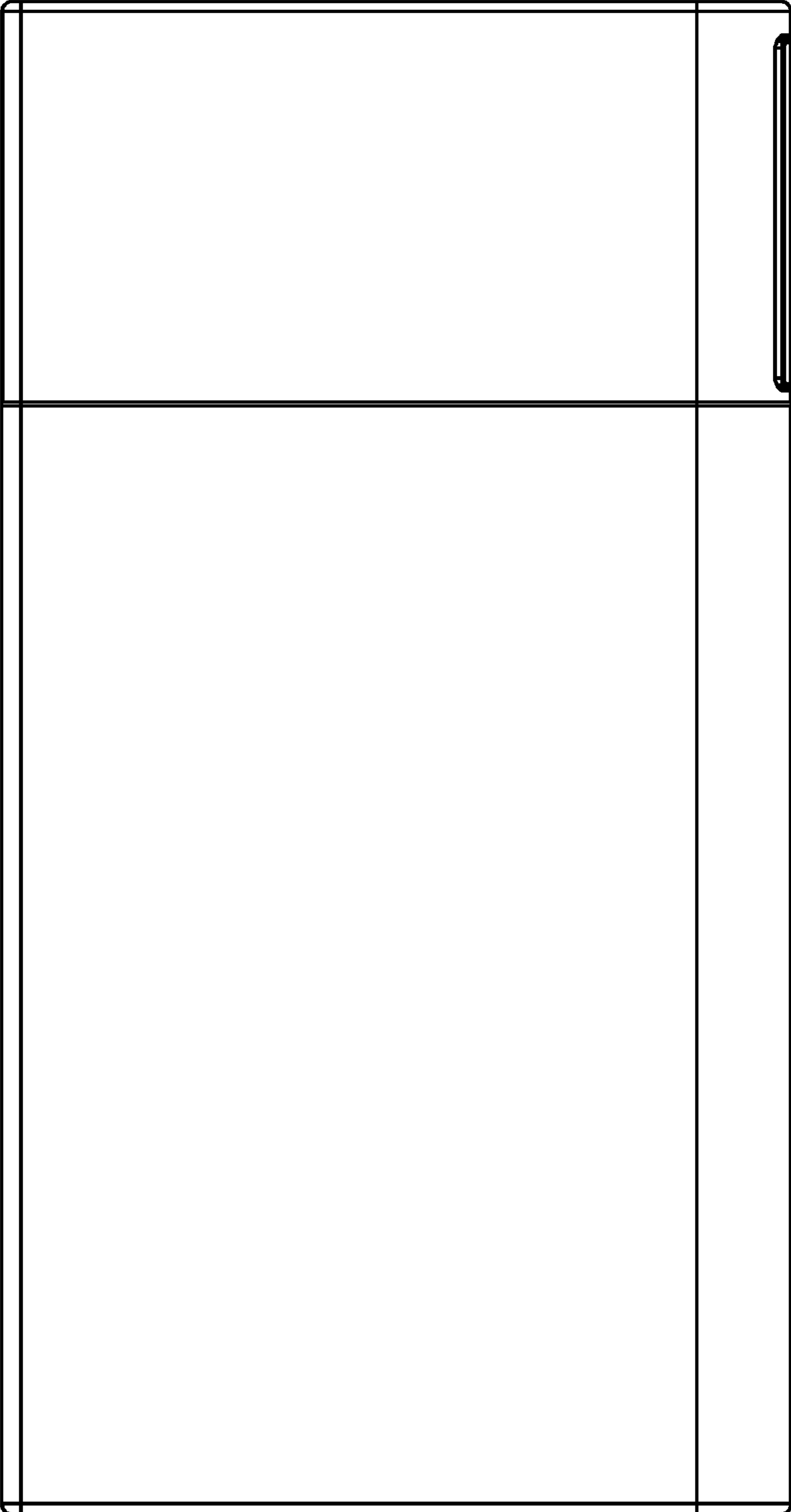

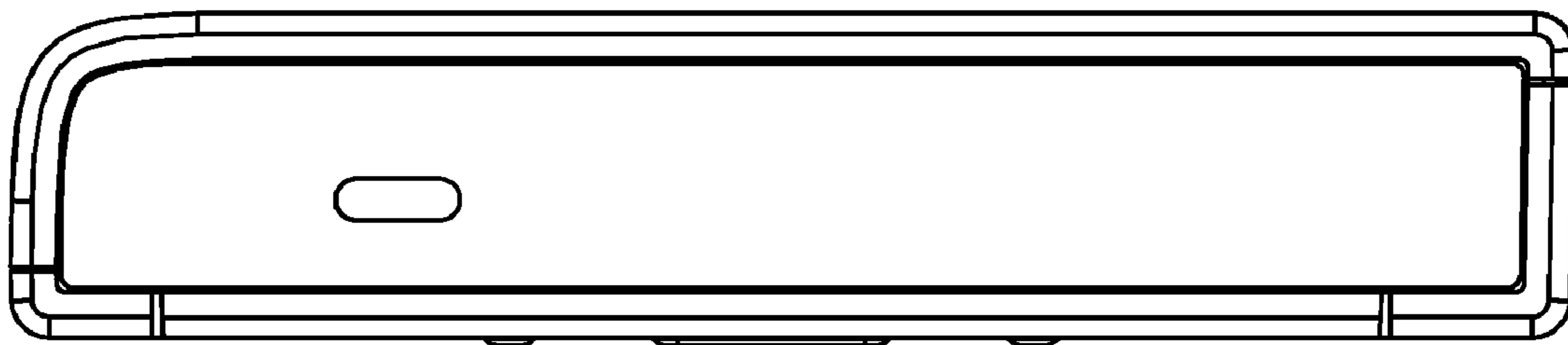

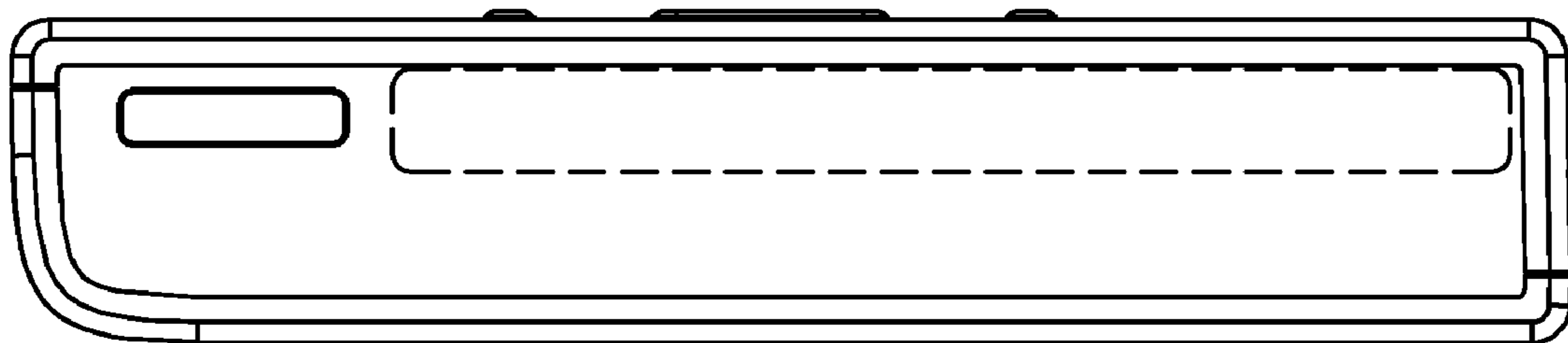

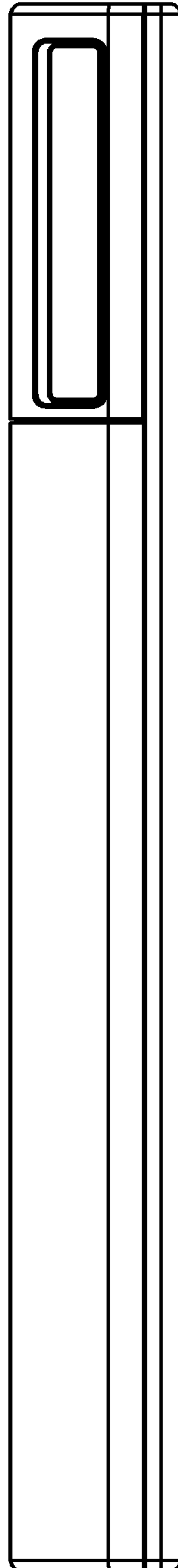
