(57) **CLAIM**

The ornamental design for an automatic tablet packing machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automatic tablet packing machine showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a left side view thereof; and,

FIG. 8 is another perspective view thereof showing a state with a cover and a door open, the tablet cases, one of which is pulled out, are shown in broken lines forming no part of the claimed design.

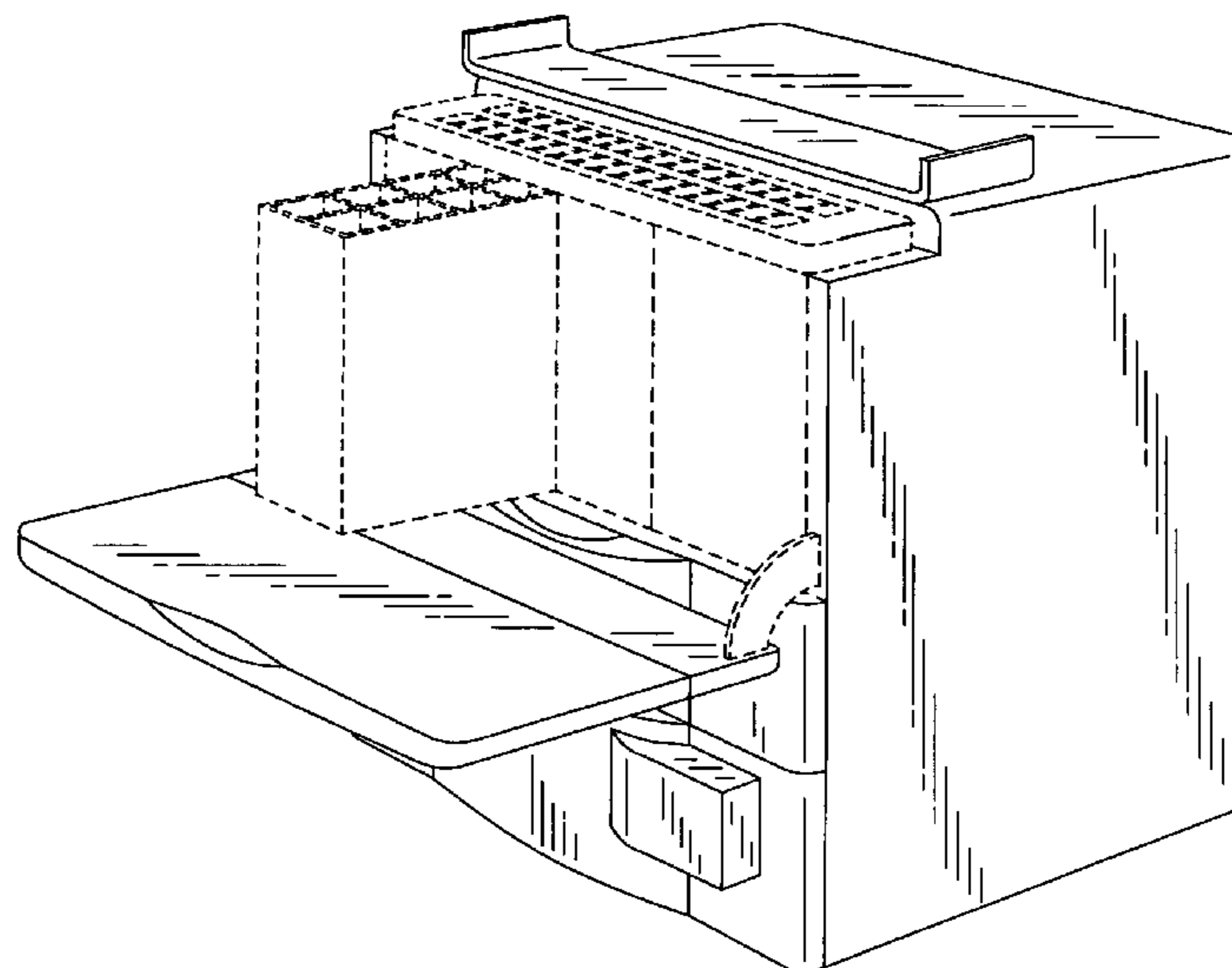
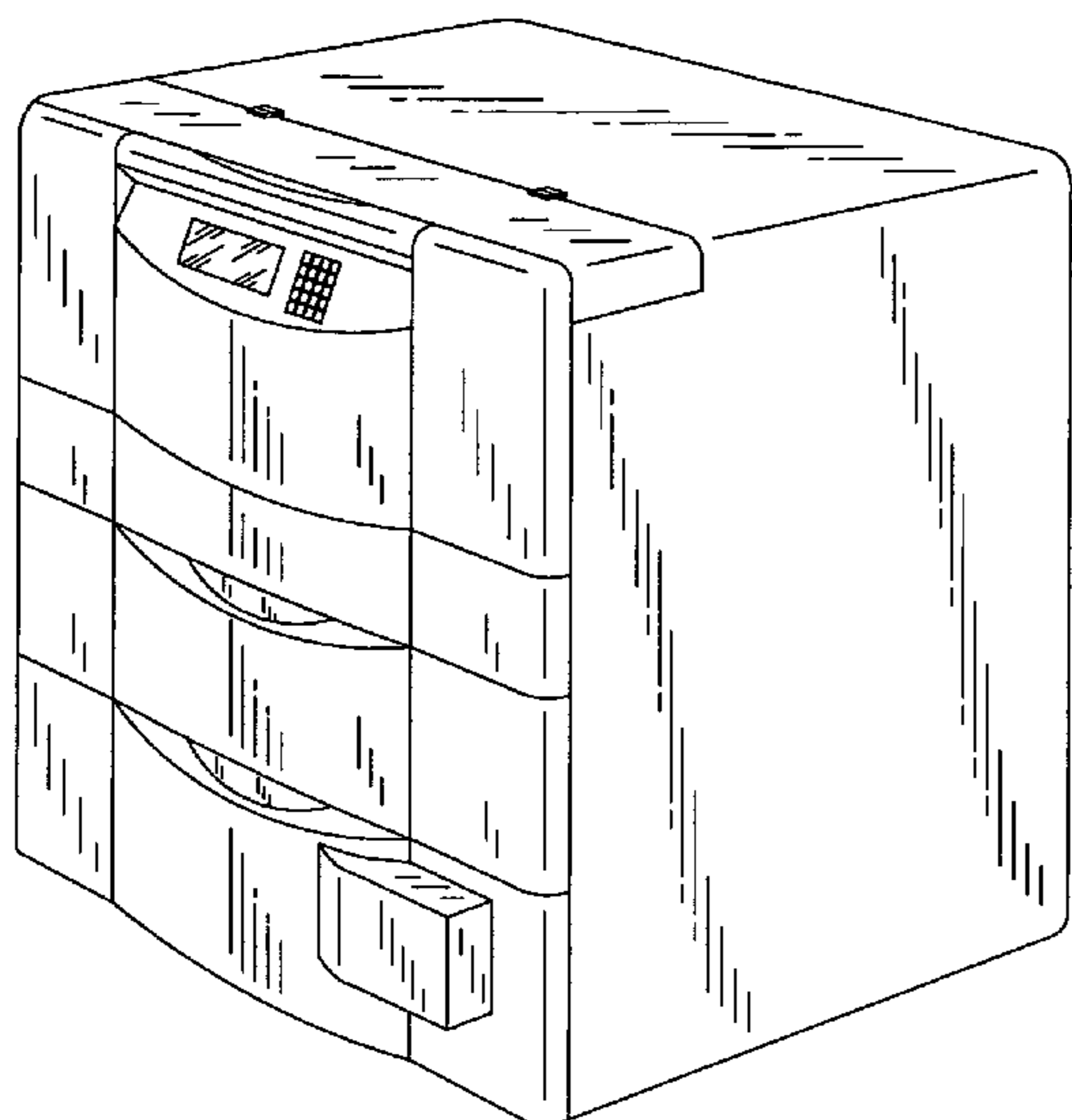

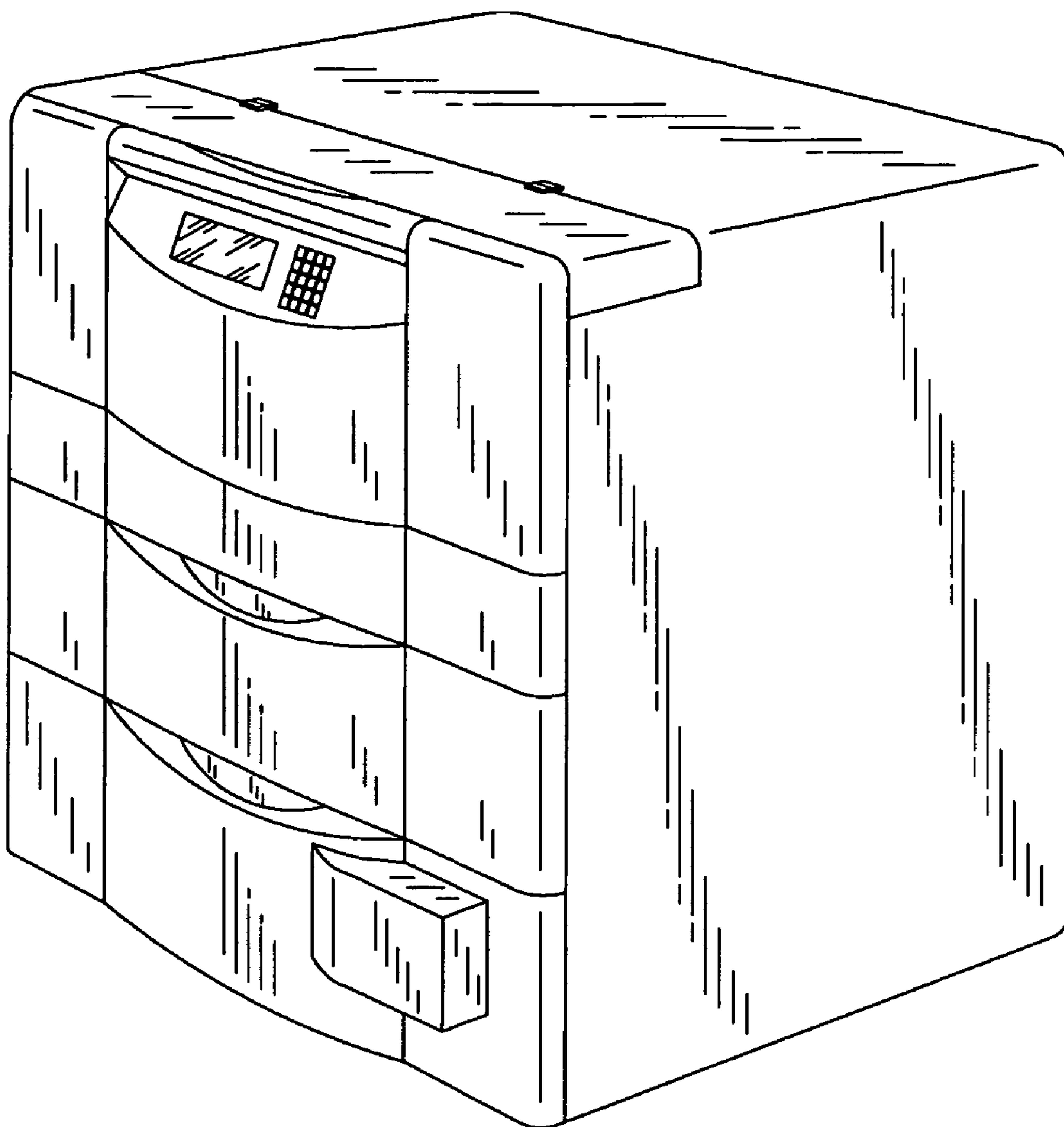

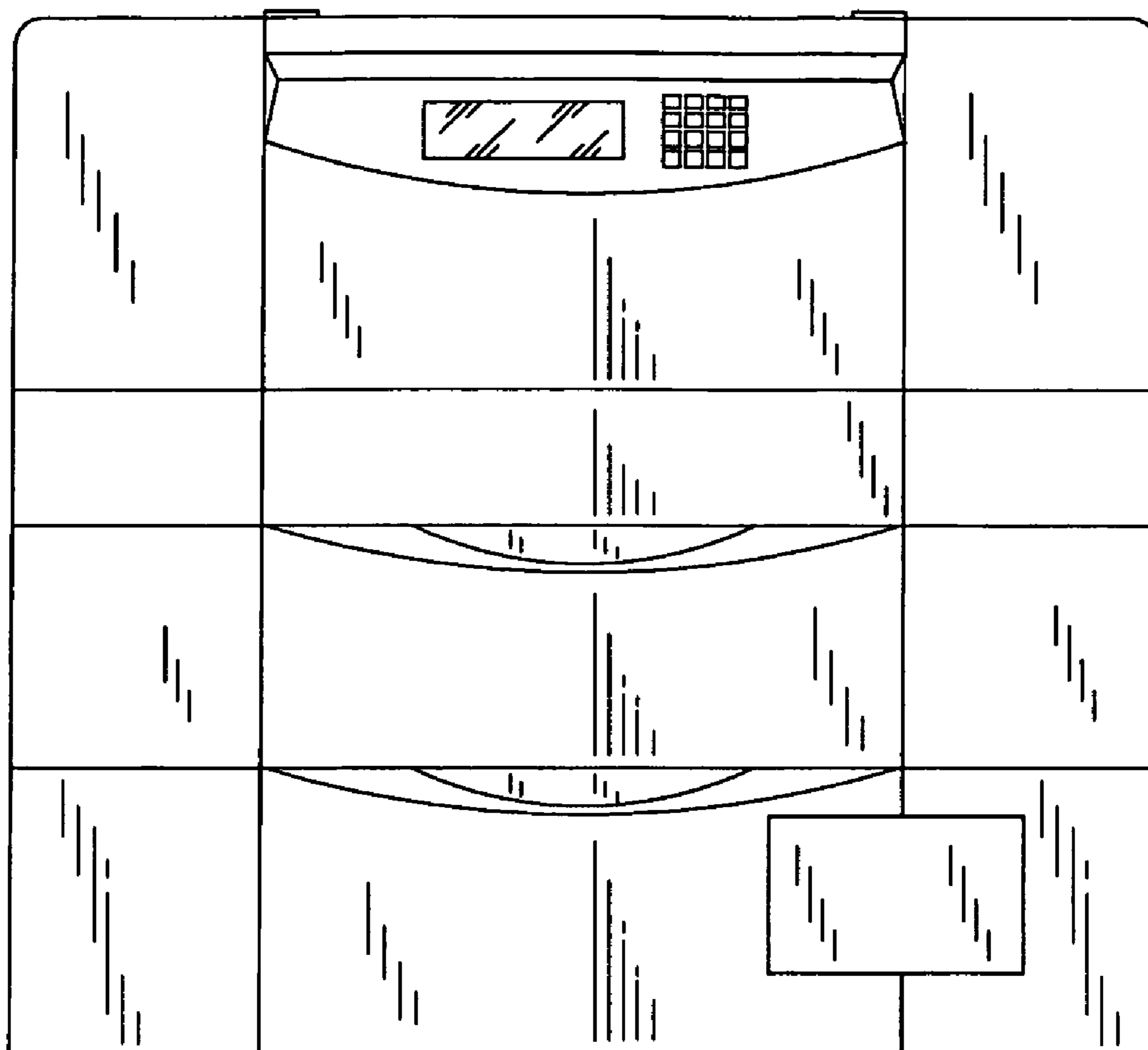

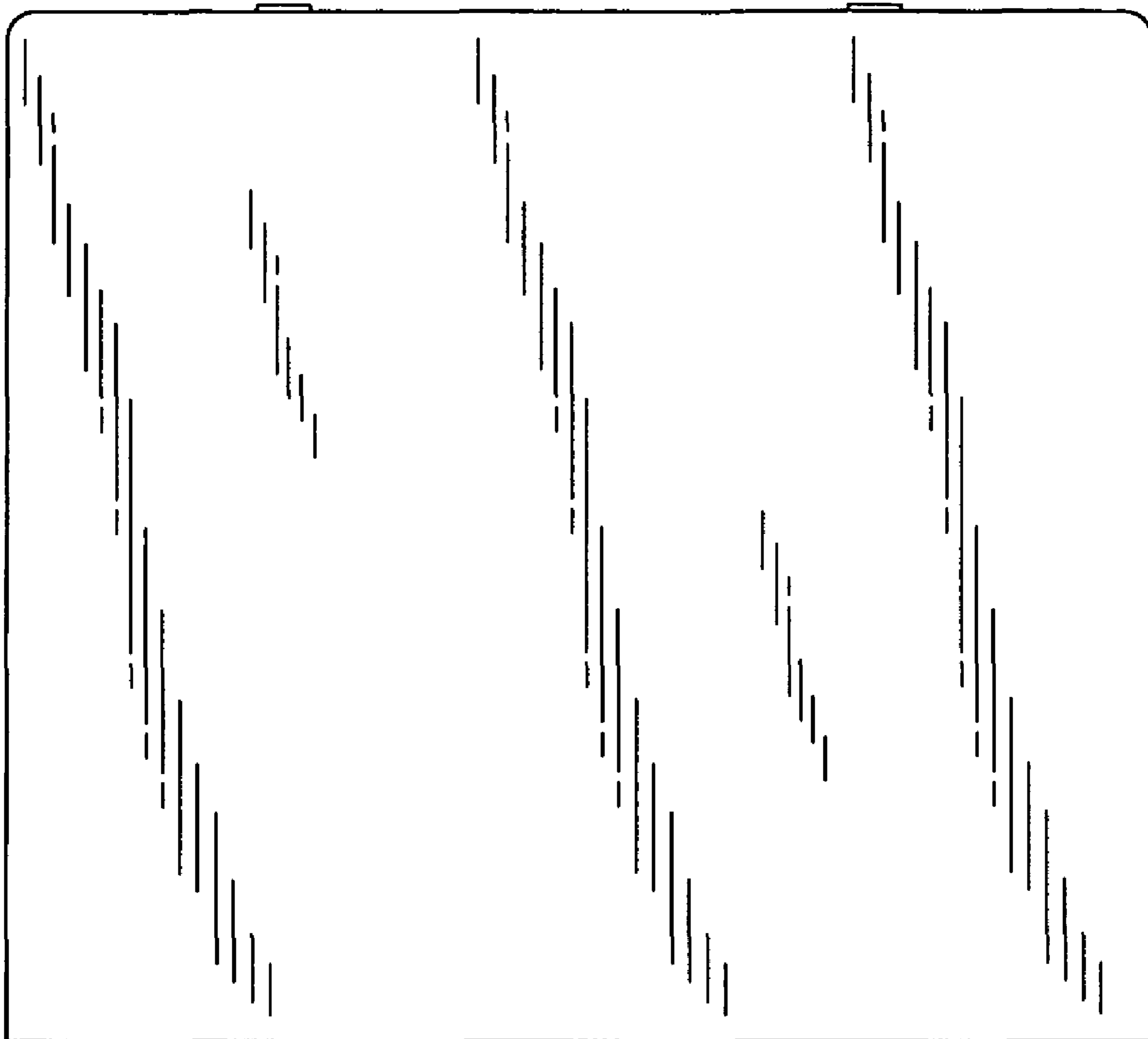

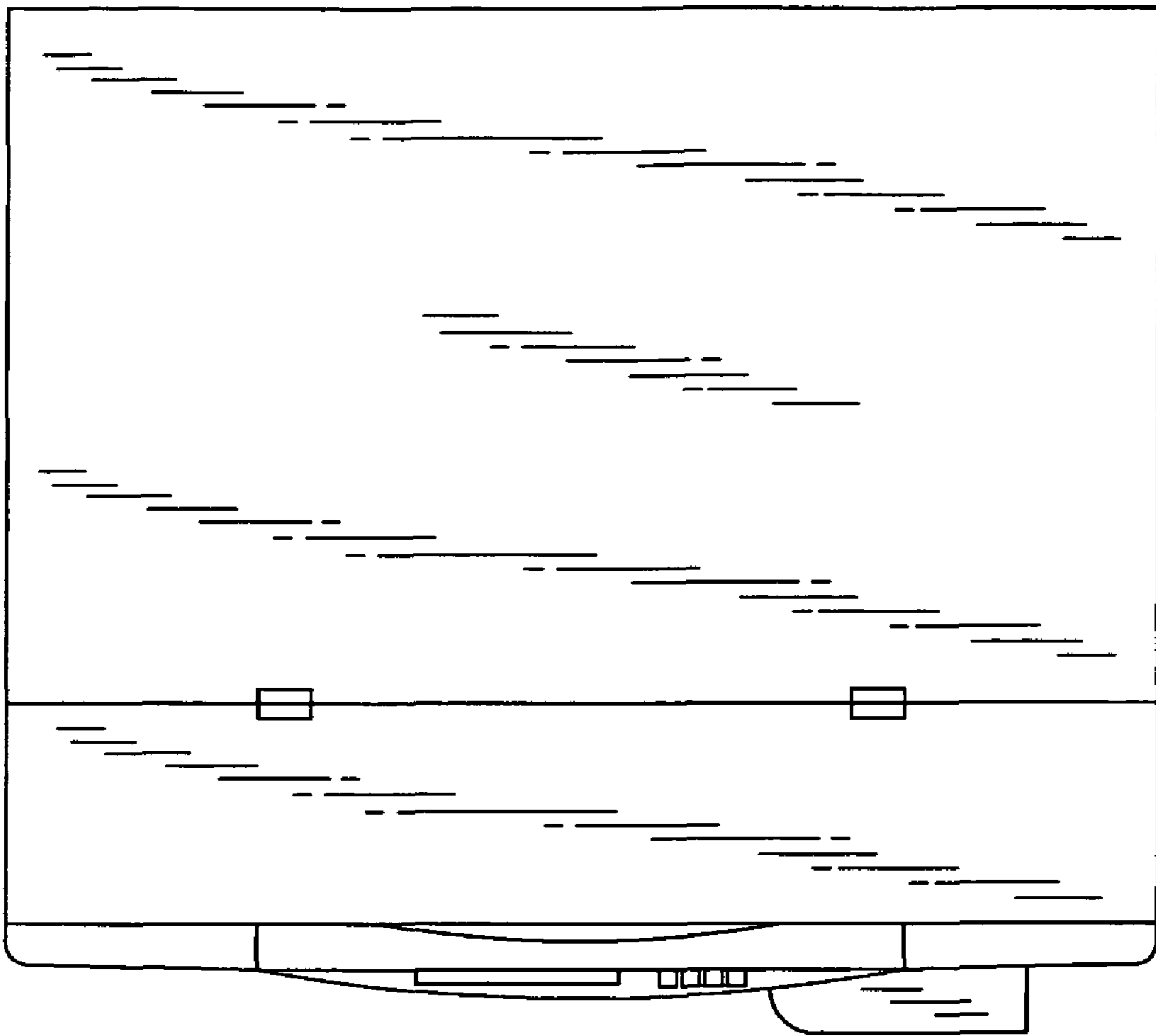

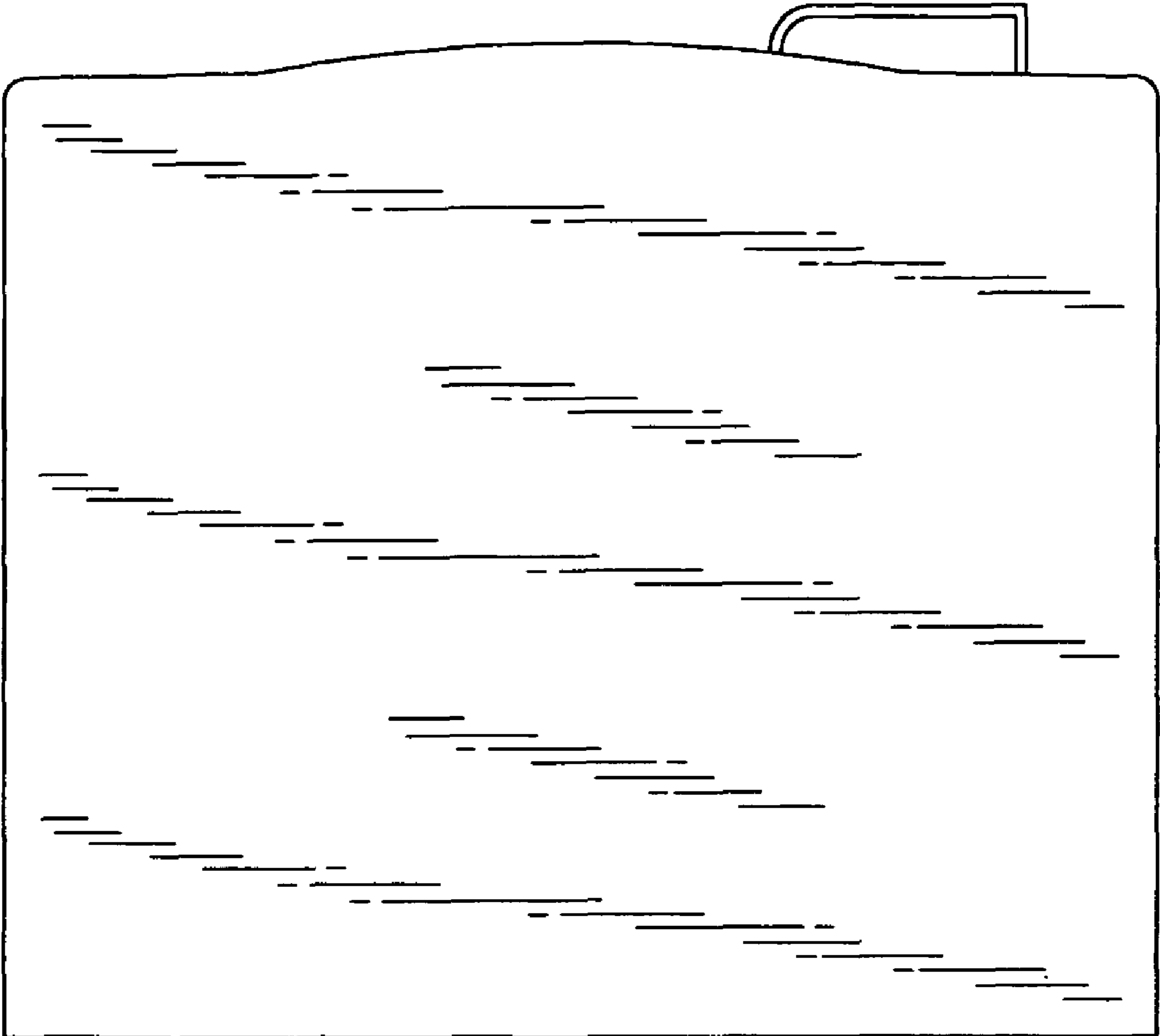

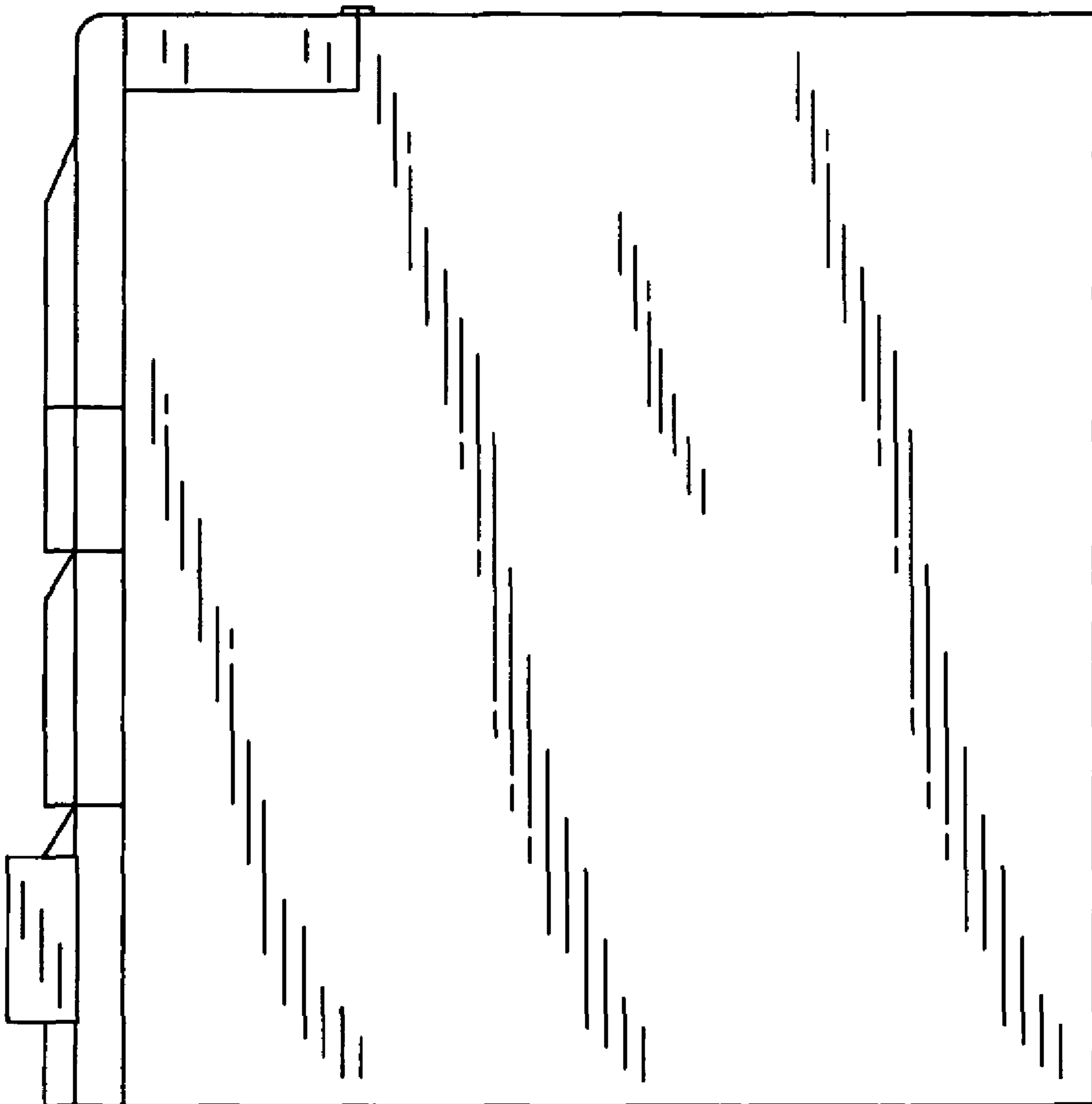

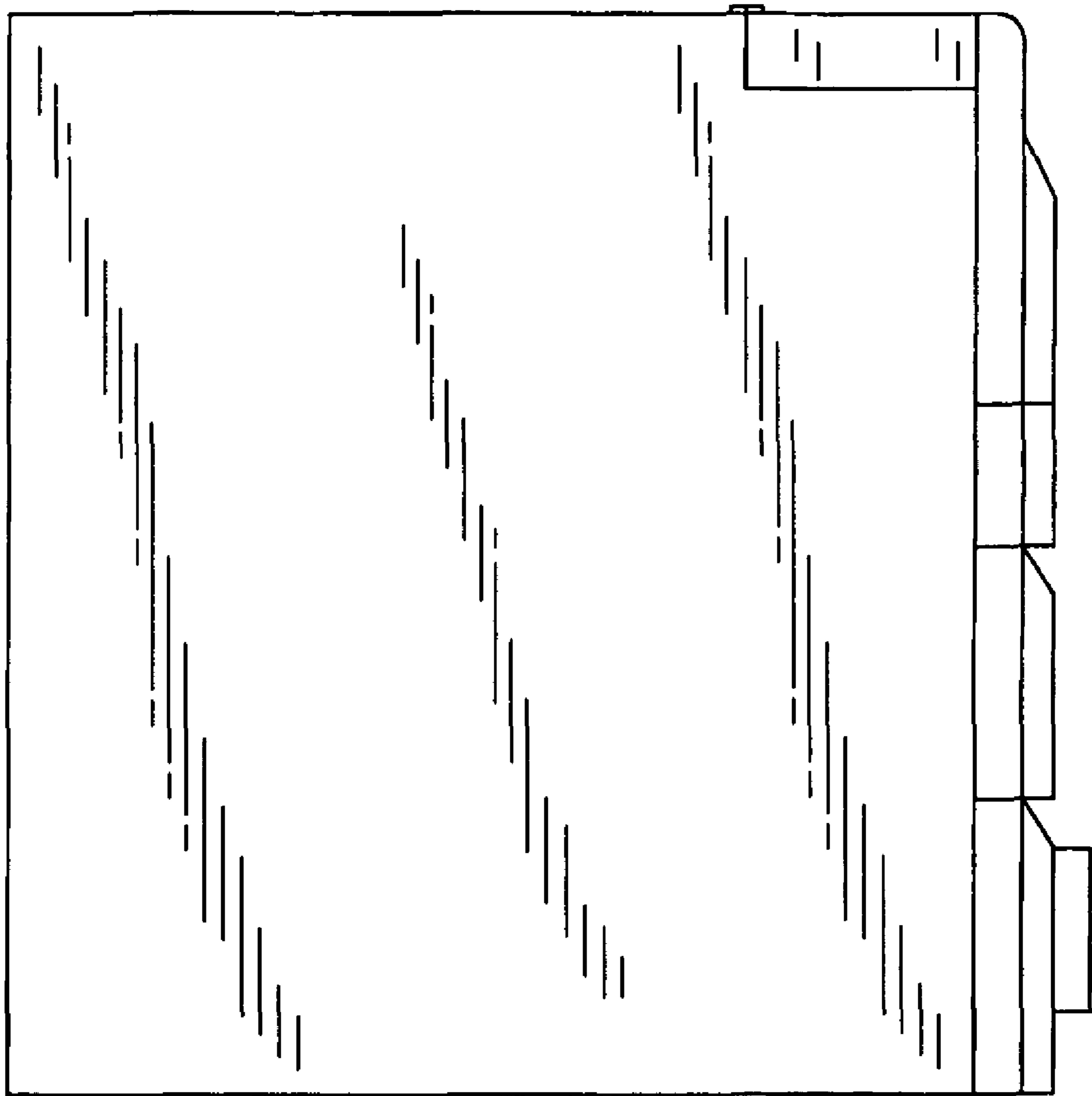
