FIG. 4 is a right side view of the marker of FIG. 1;

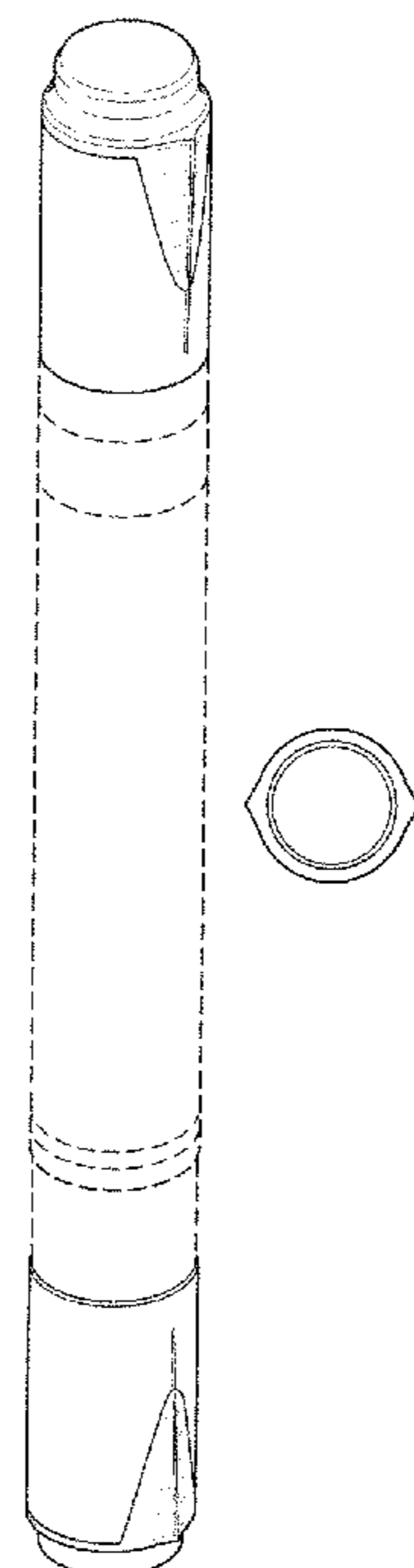
FIG. 5 is a rear view of the marker of FIG. 1;

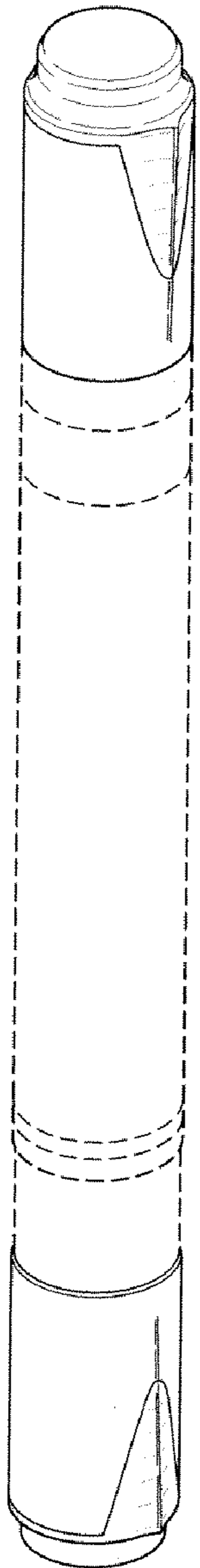

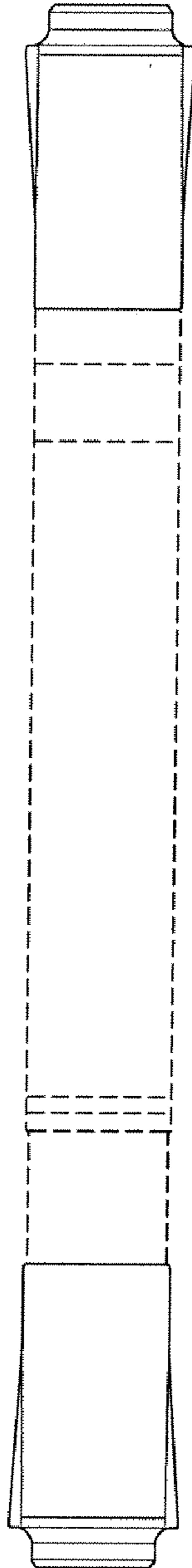

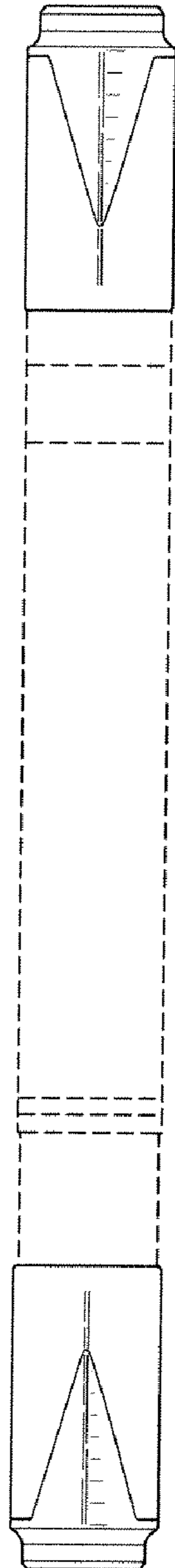

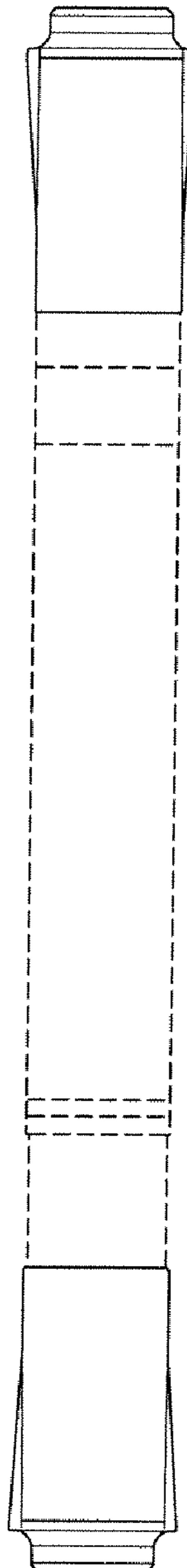

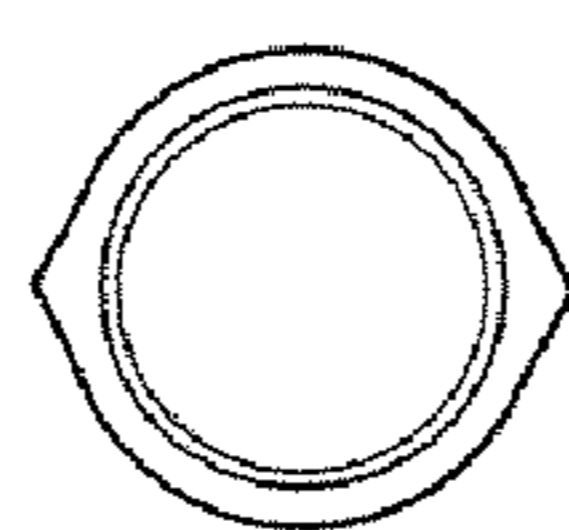
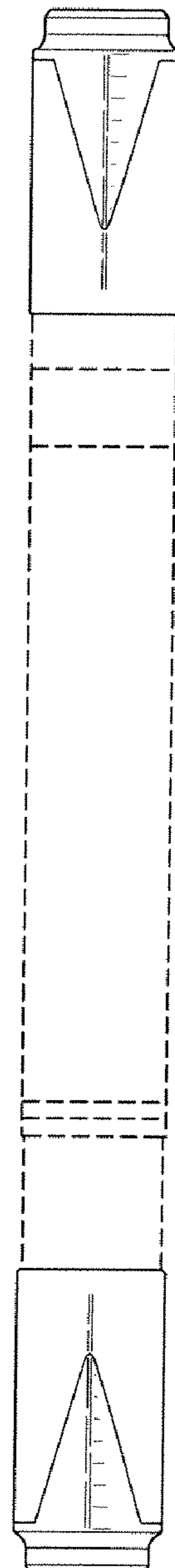

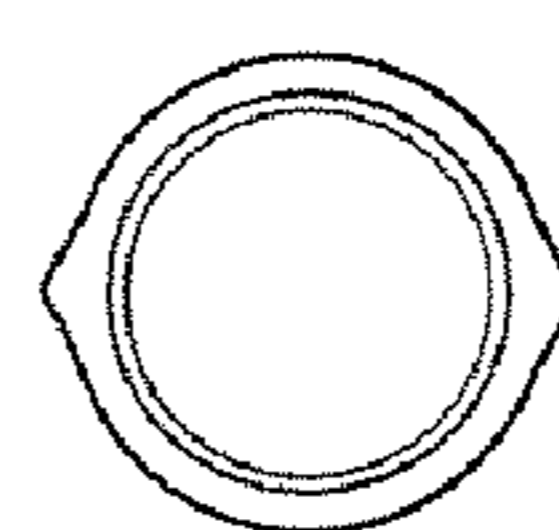
