The ornamental design for a ballpoint pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and right side of a ballpoint pen showing my new design, with the writing tip in a retracted position;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

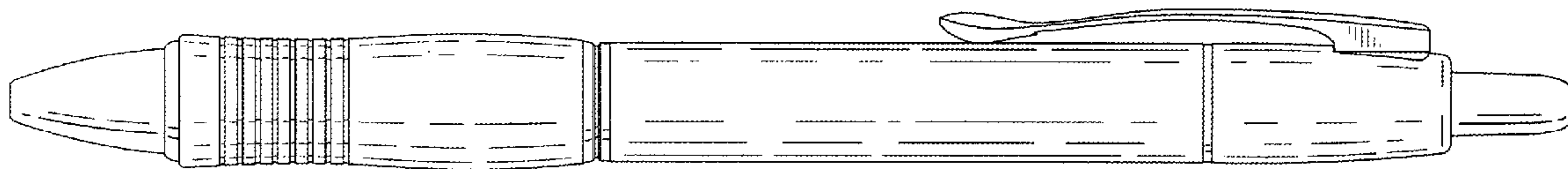
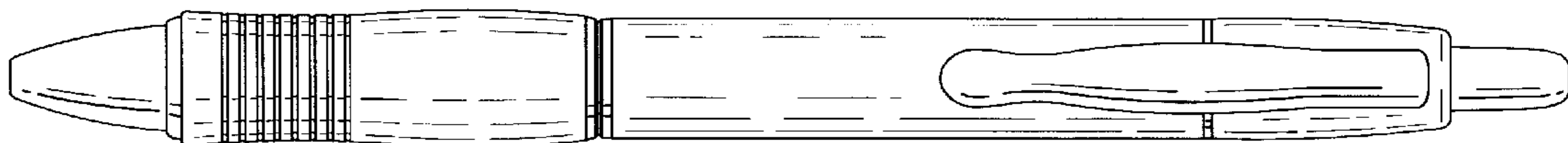
FIG. 4 is a left side elevational view thereof;

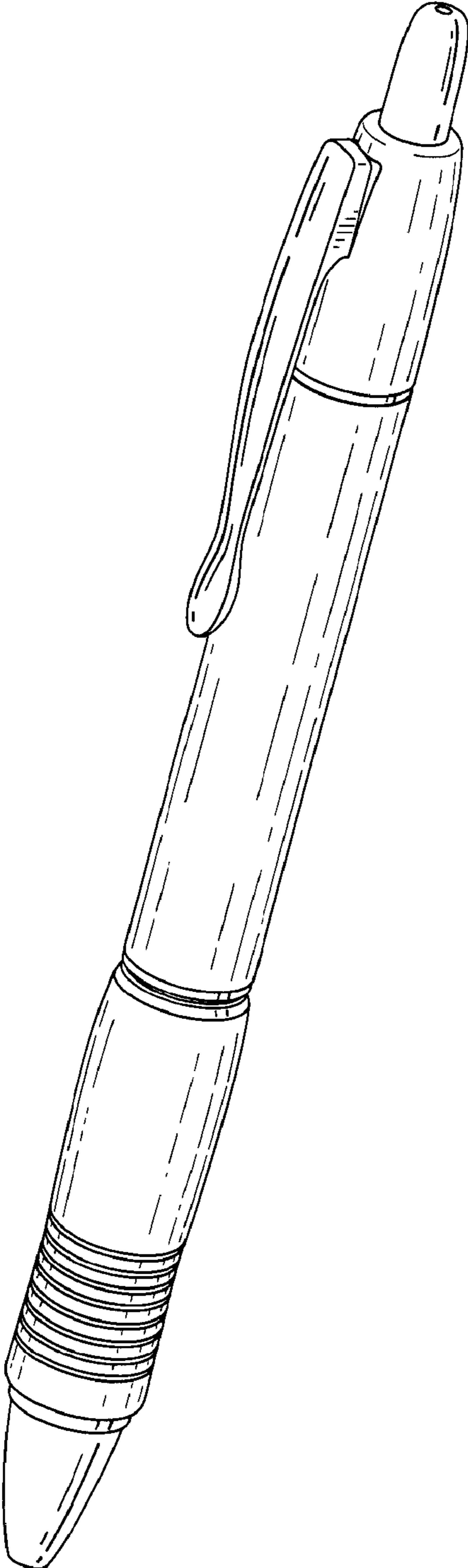

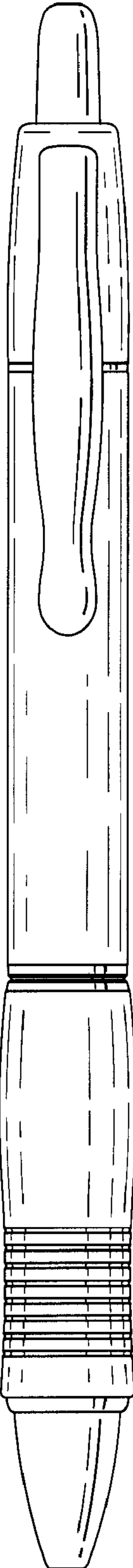

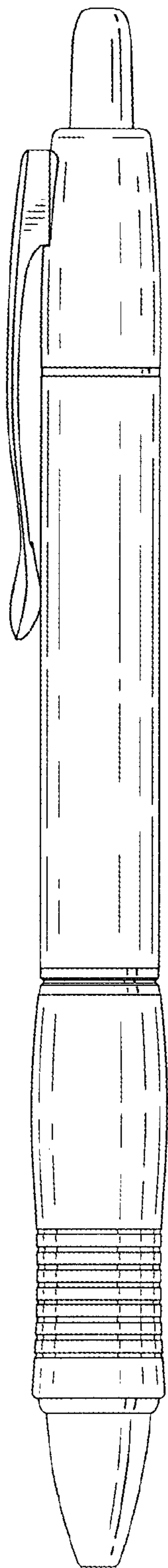

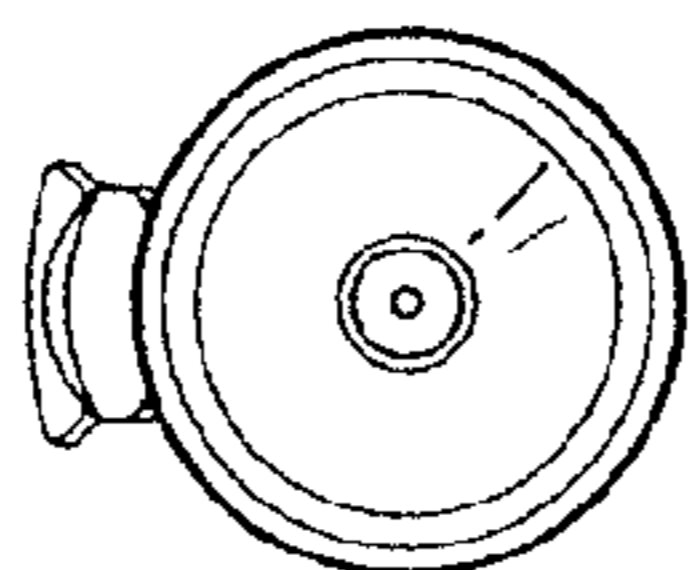

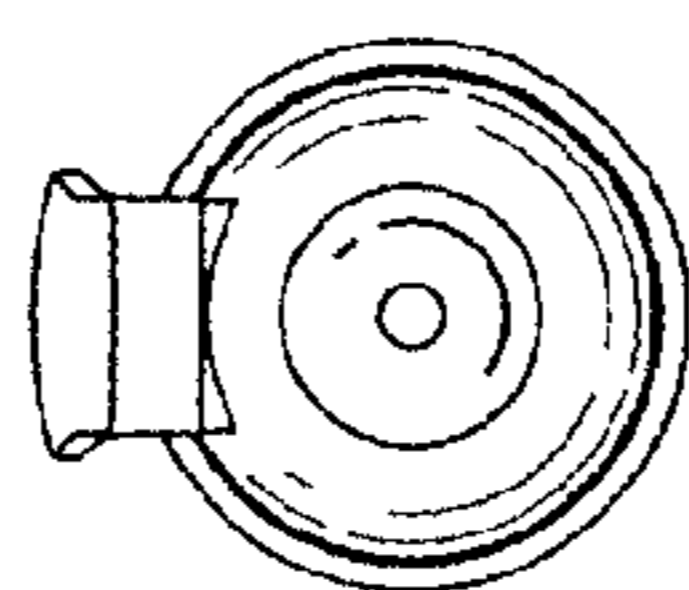
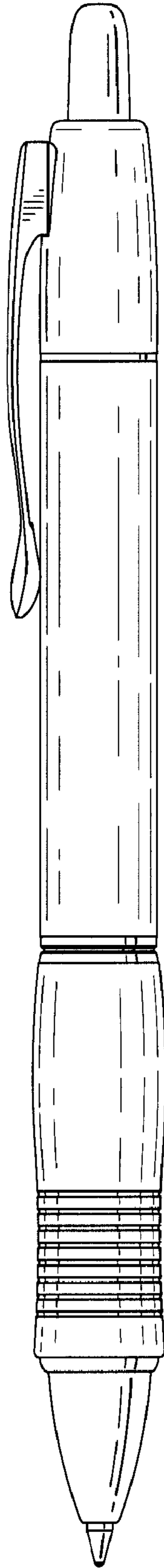
