FIG. 3 is a bottom plan view of the sink;

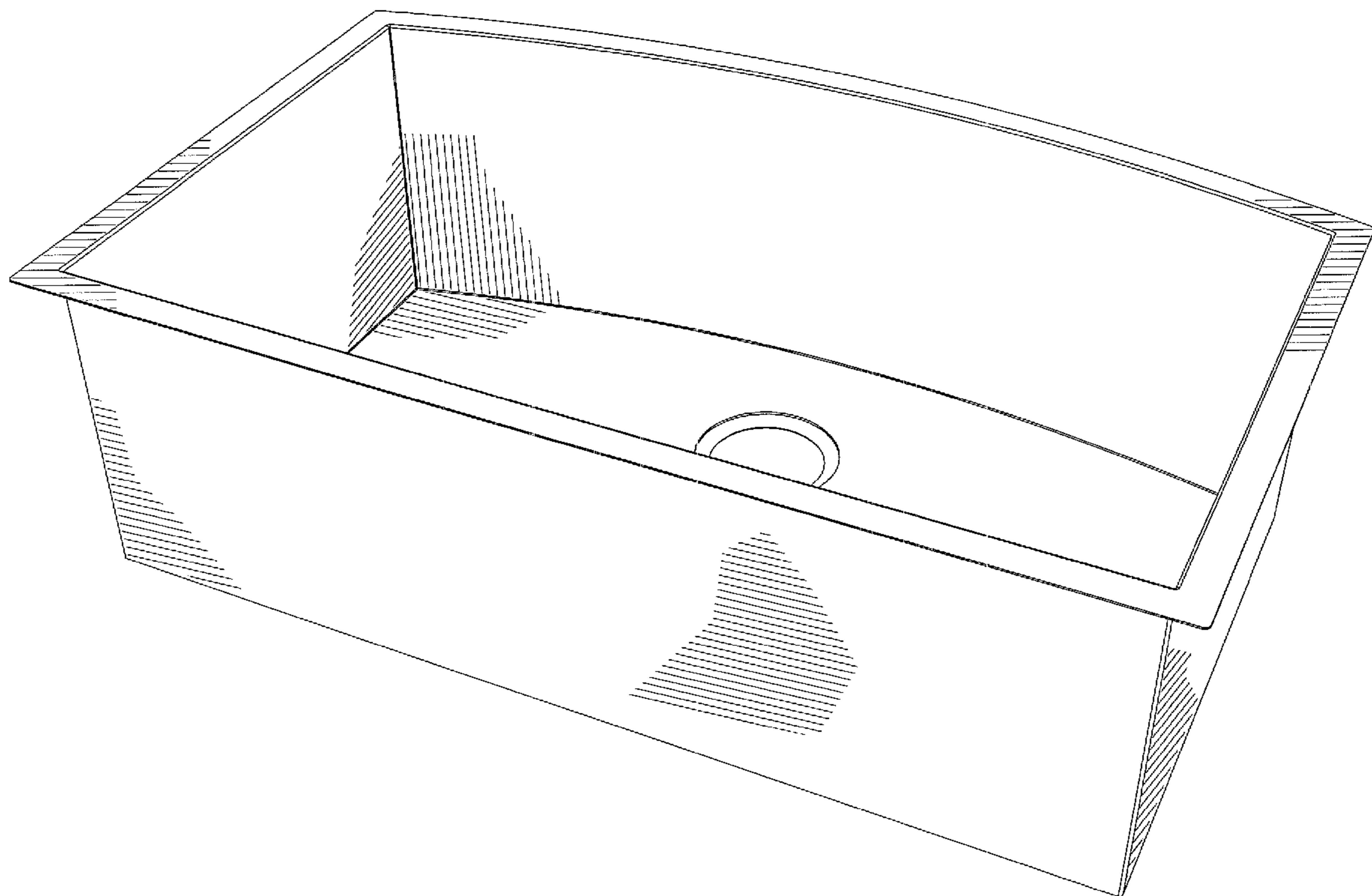
FIG. 4 is a front view of the sink;

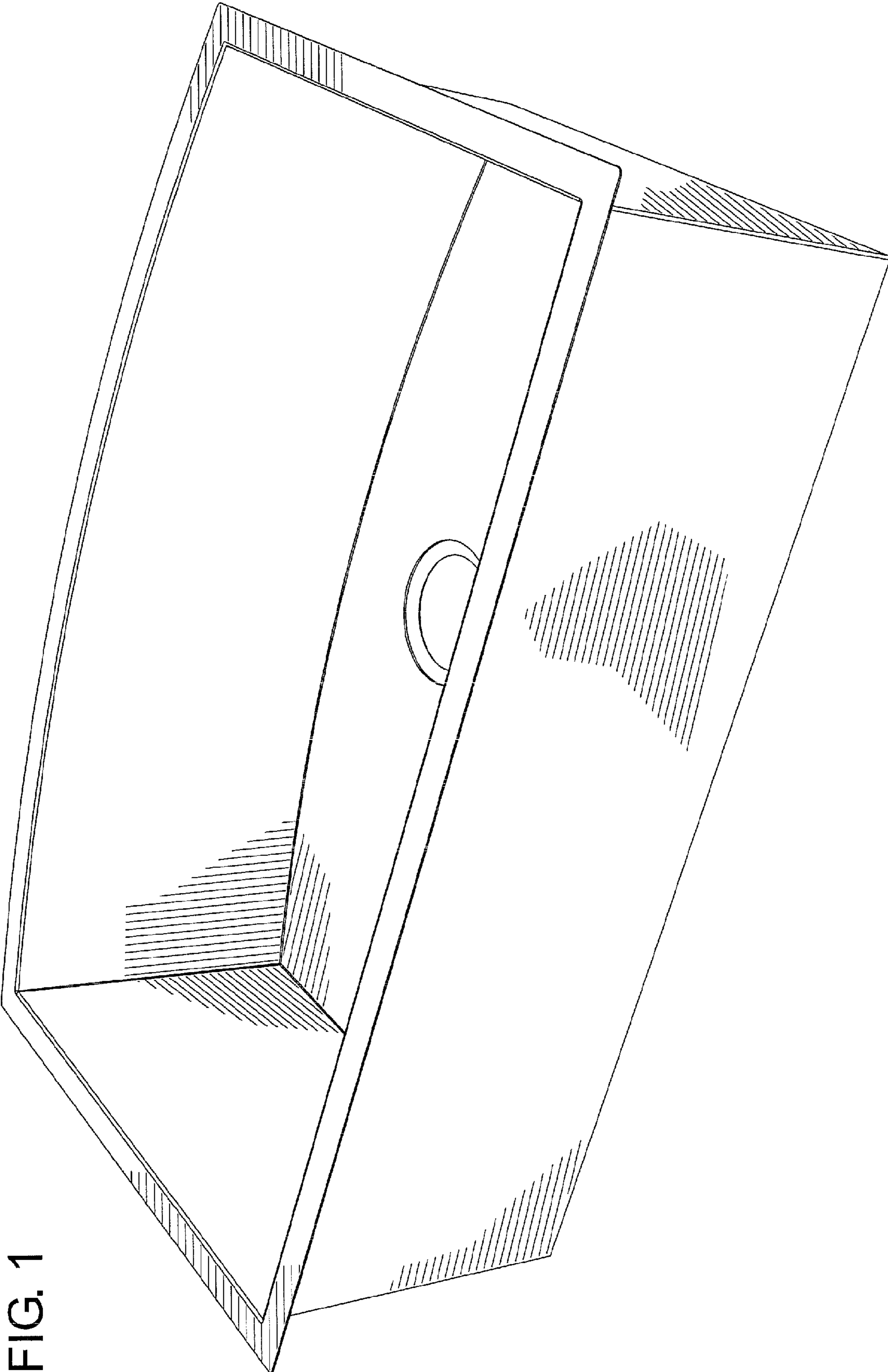

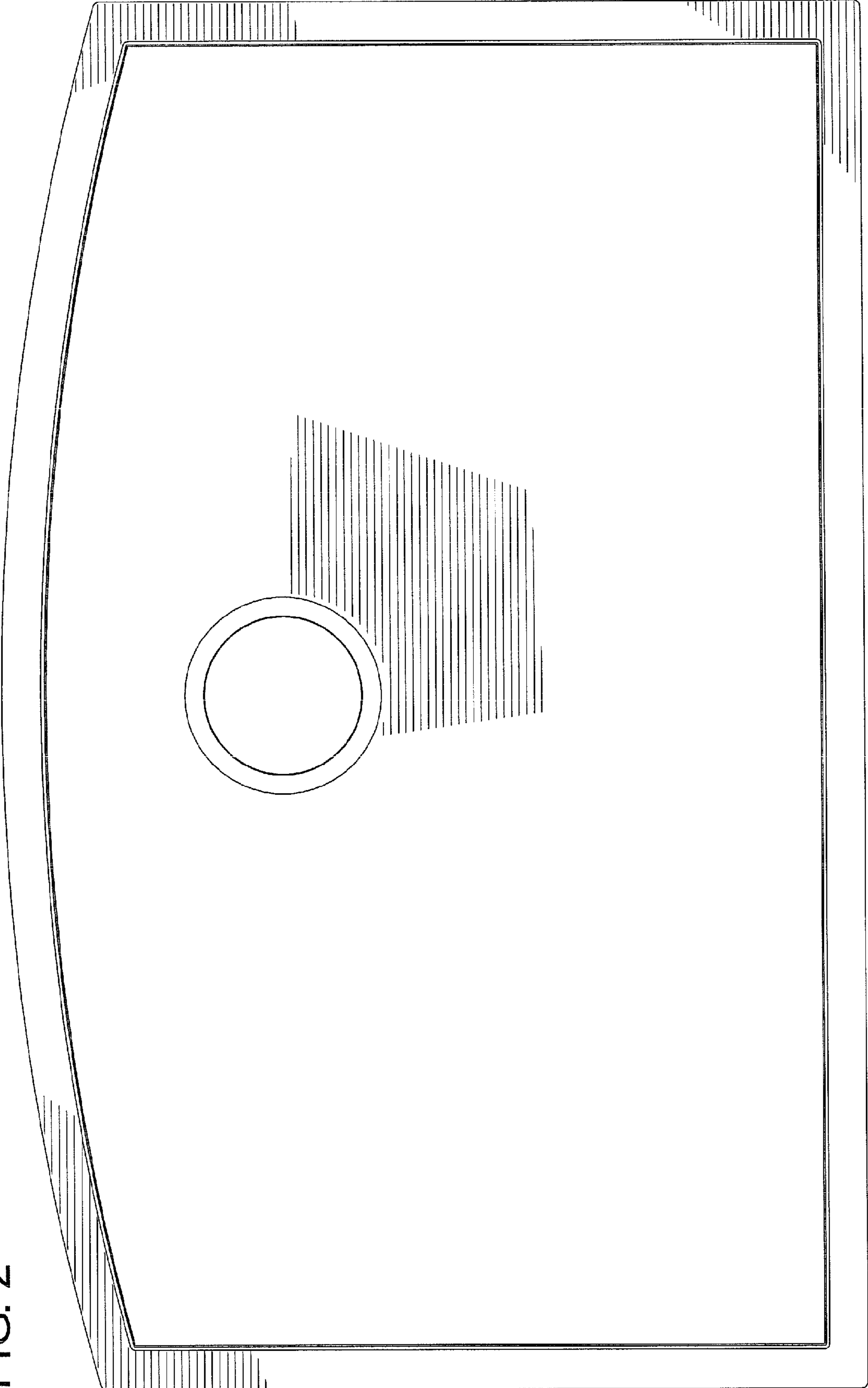

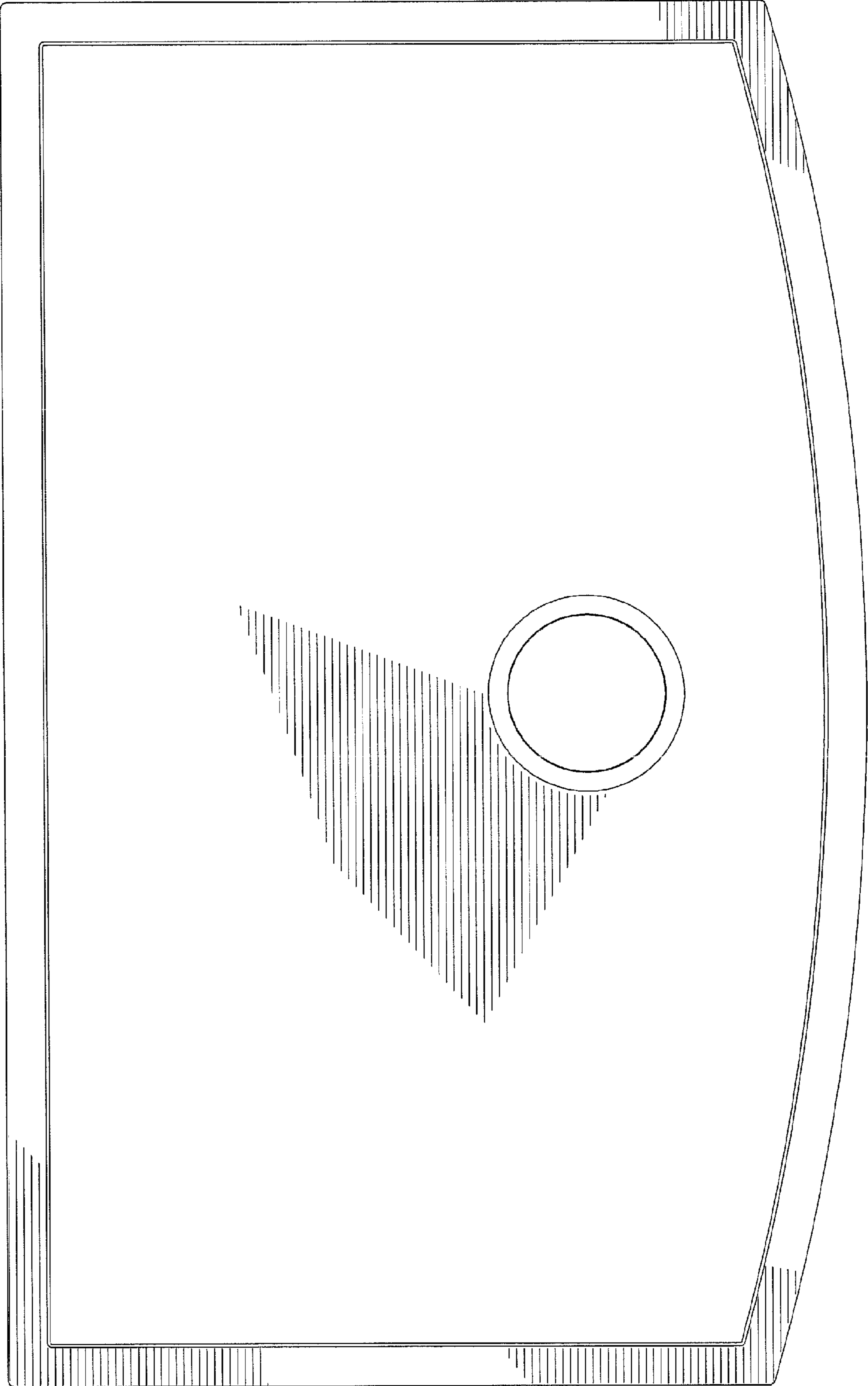

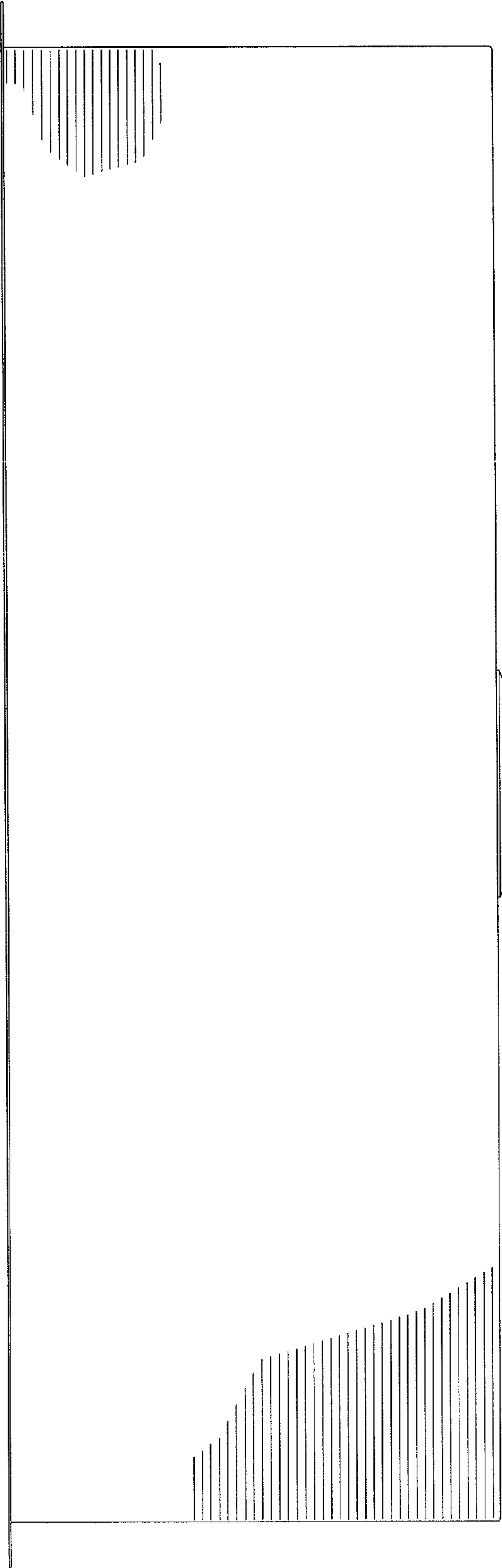
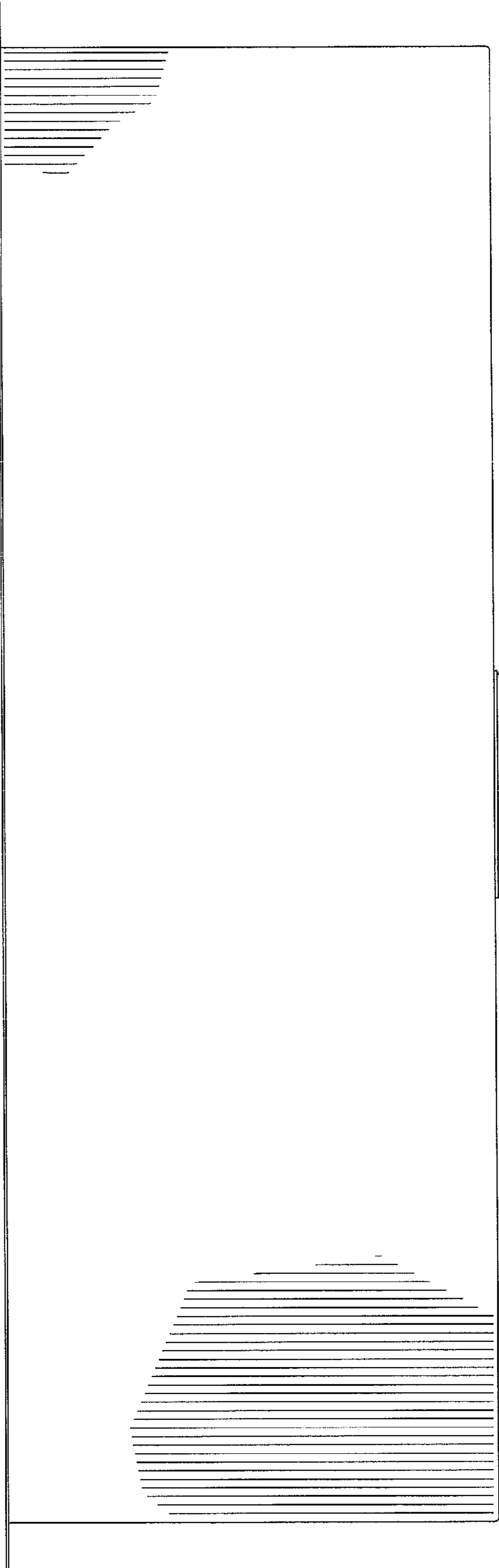

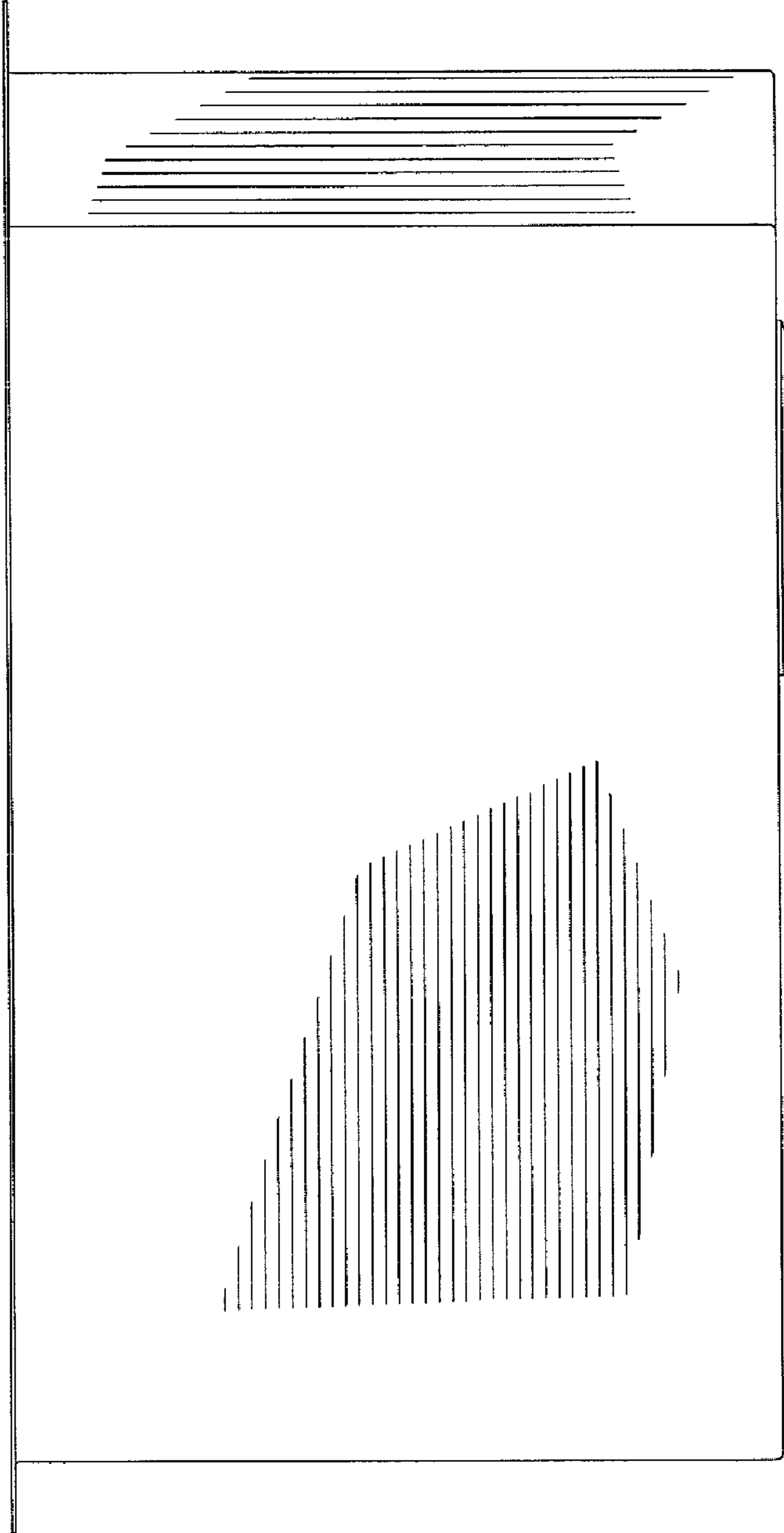

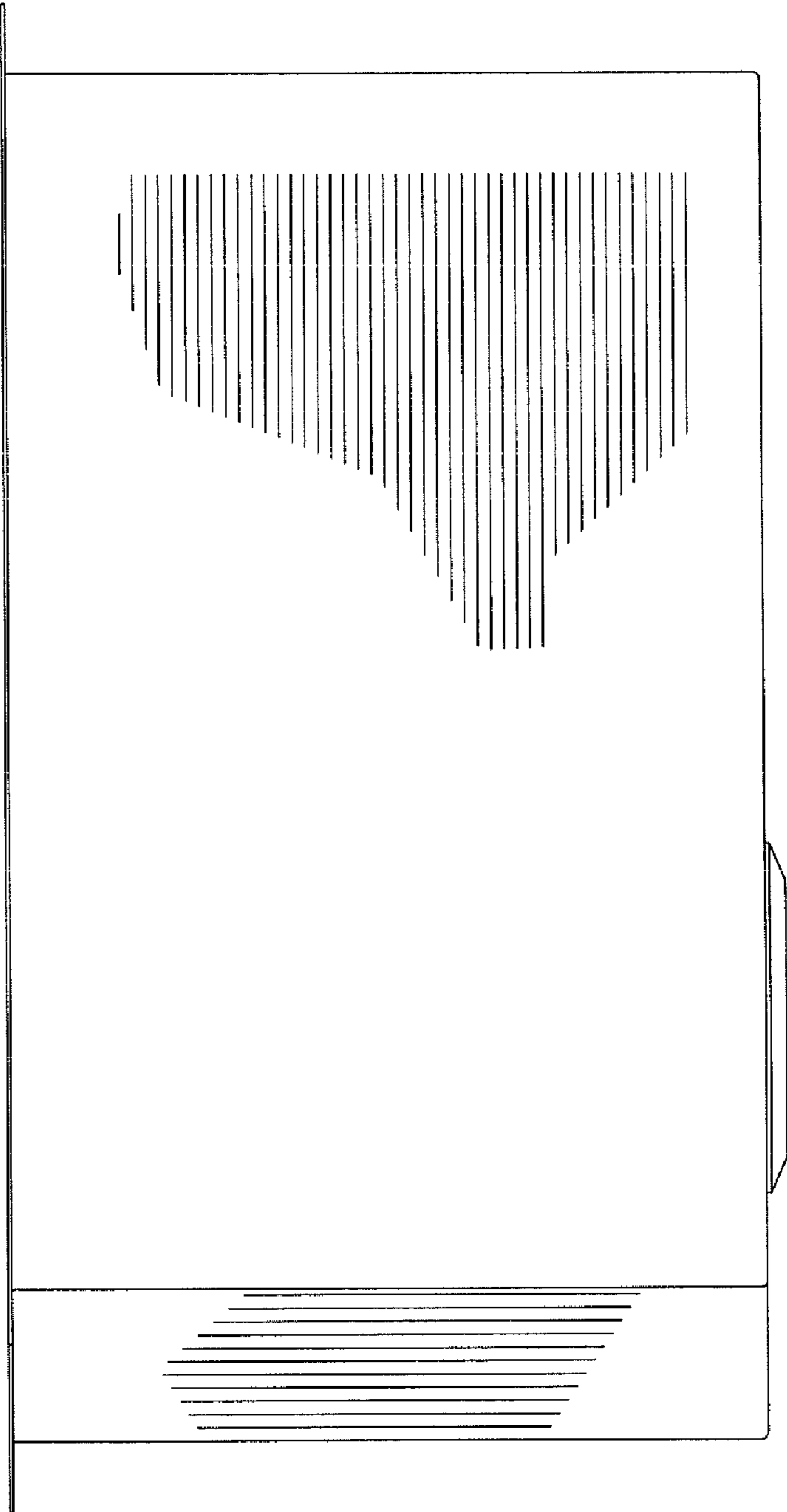
