FIG. 1 is a front and right-side perspective view of a visor showing my new design;

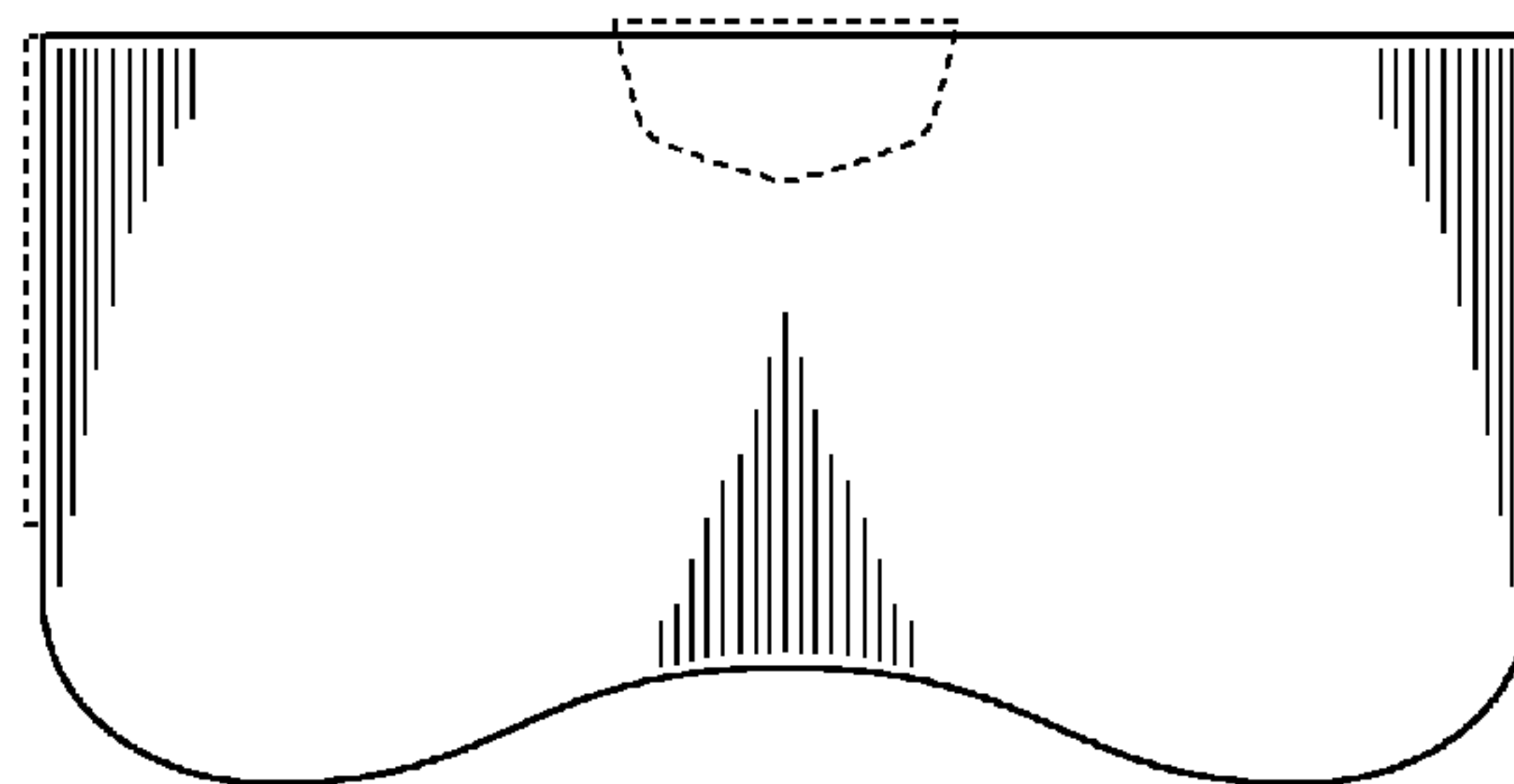
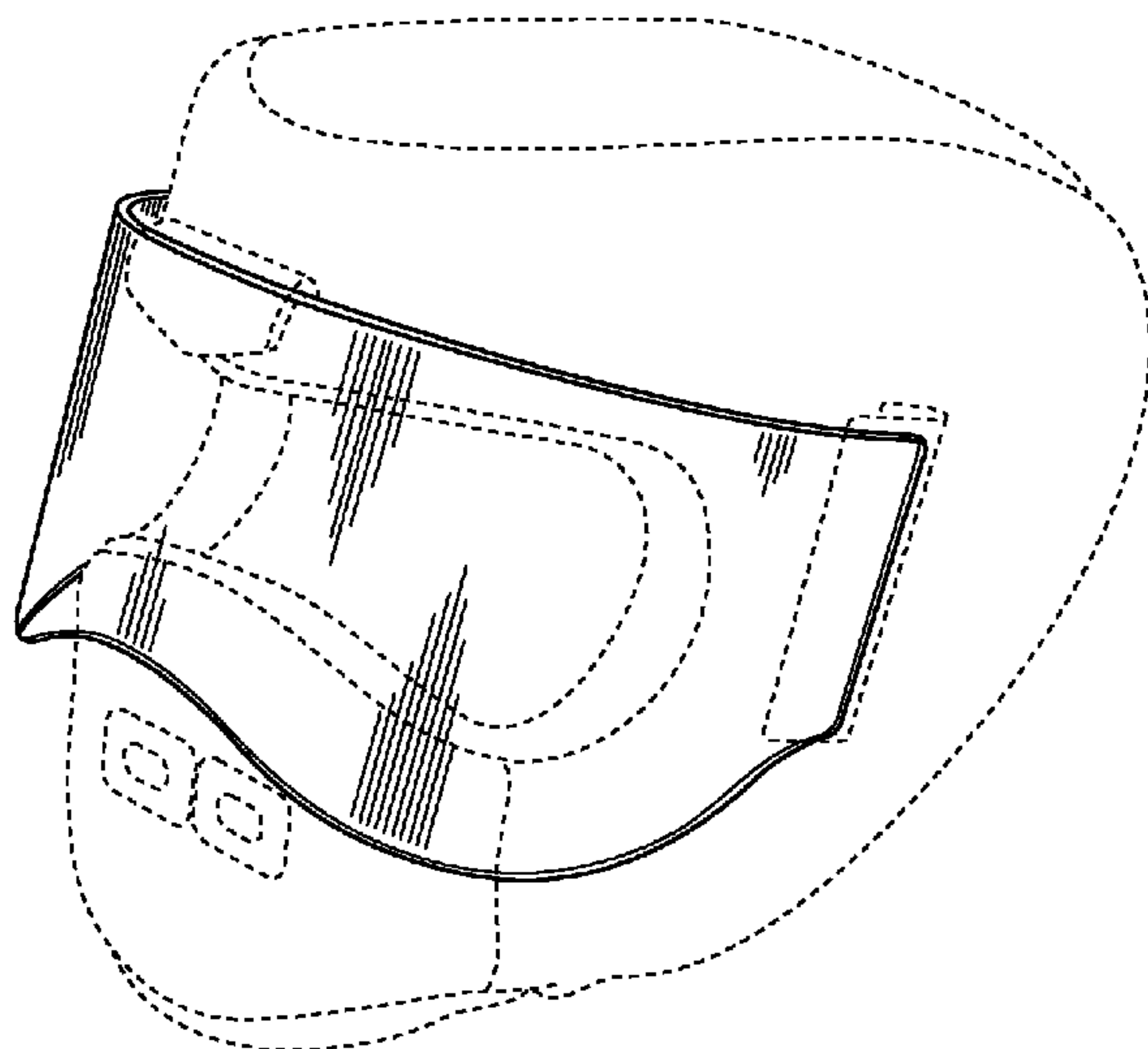
FIG. 2 is a front view thereof;

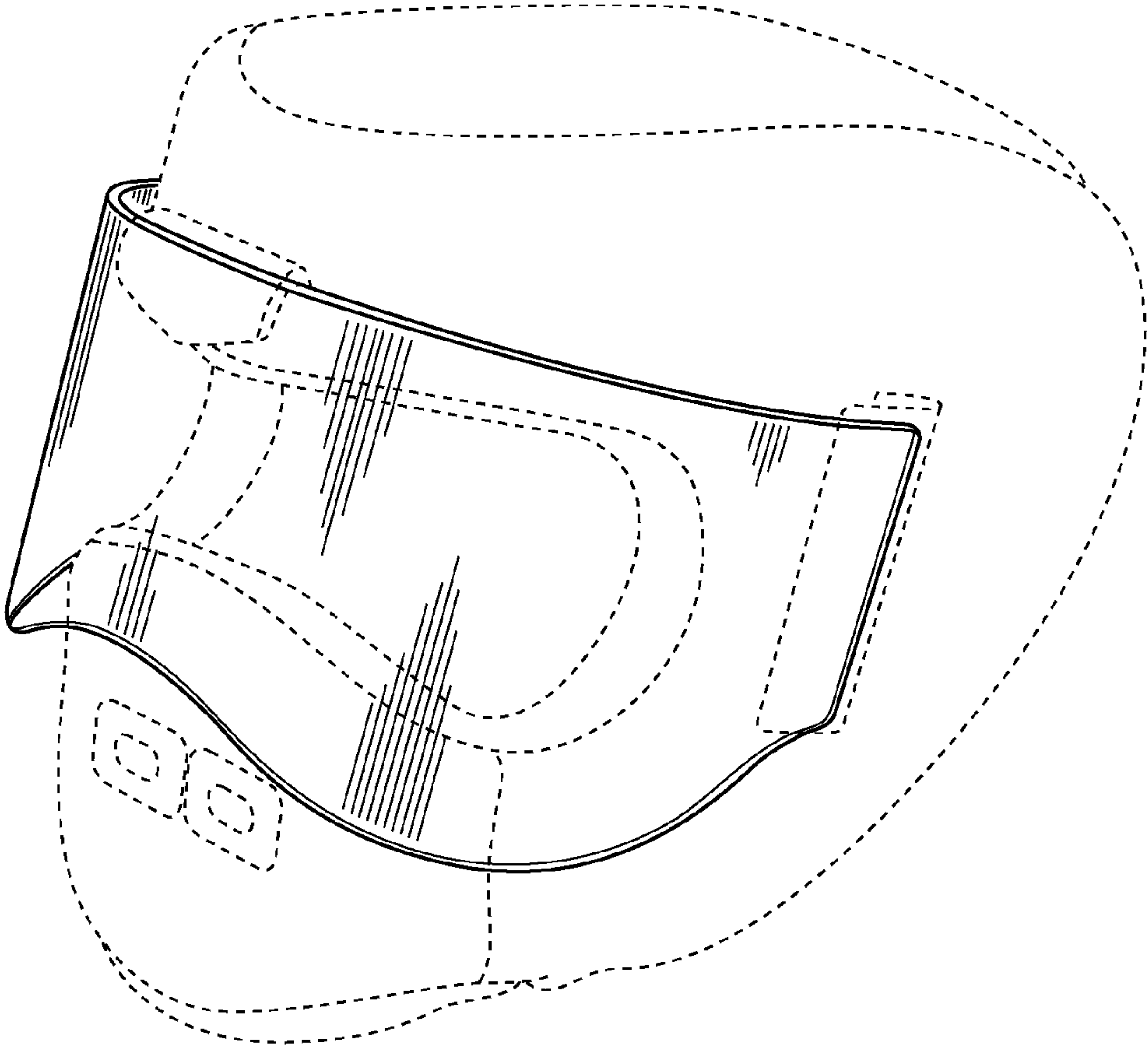

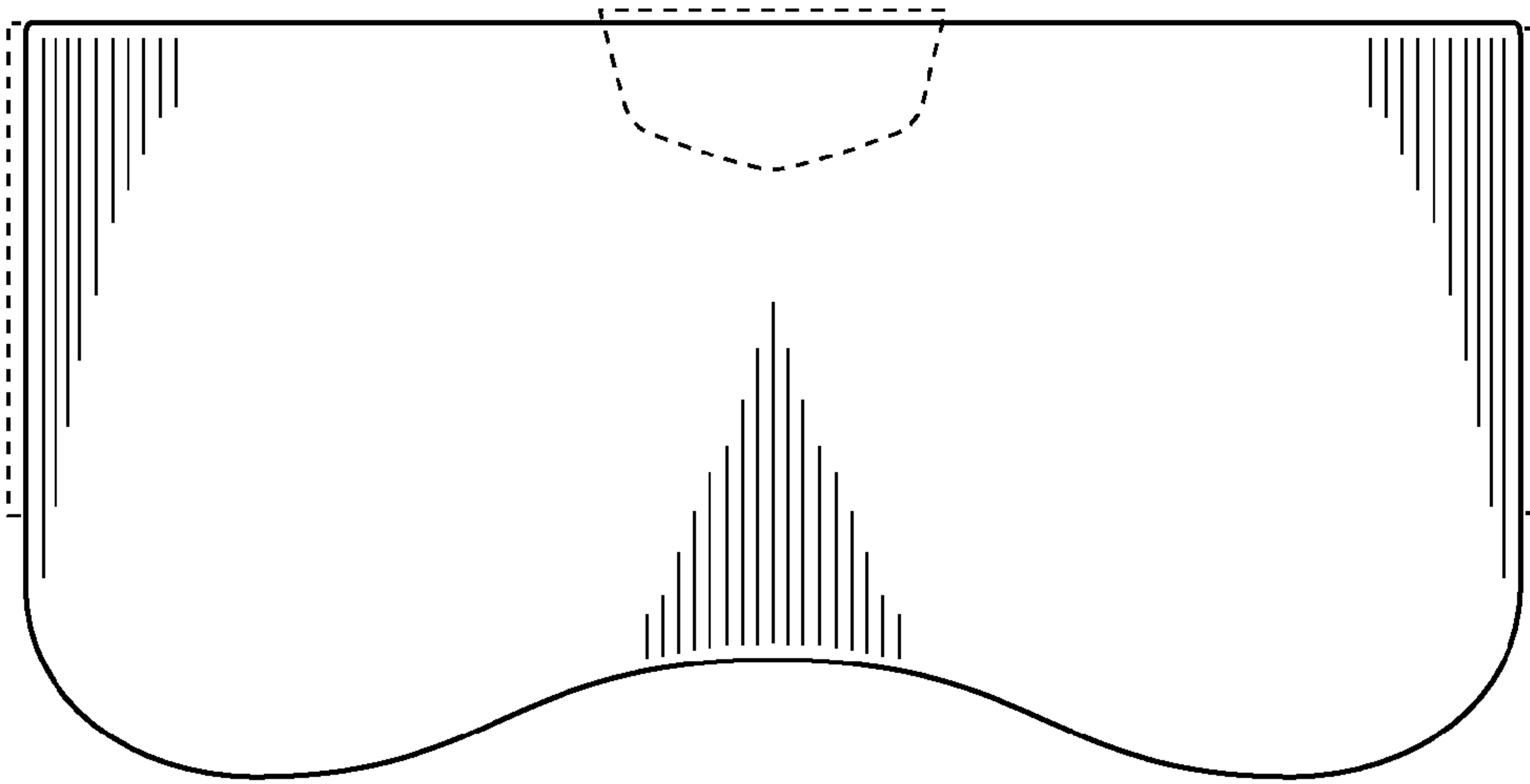

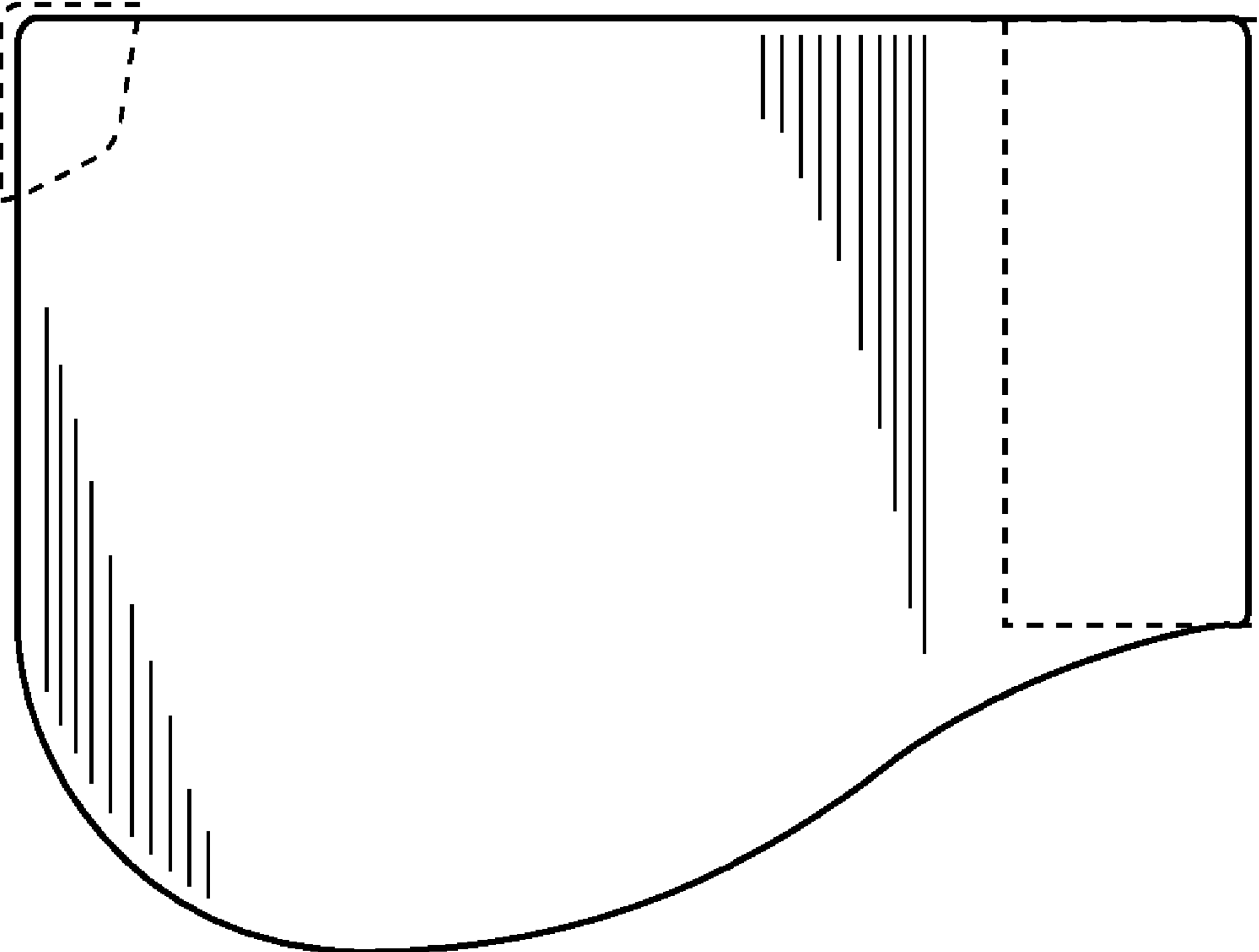

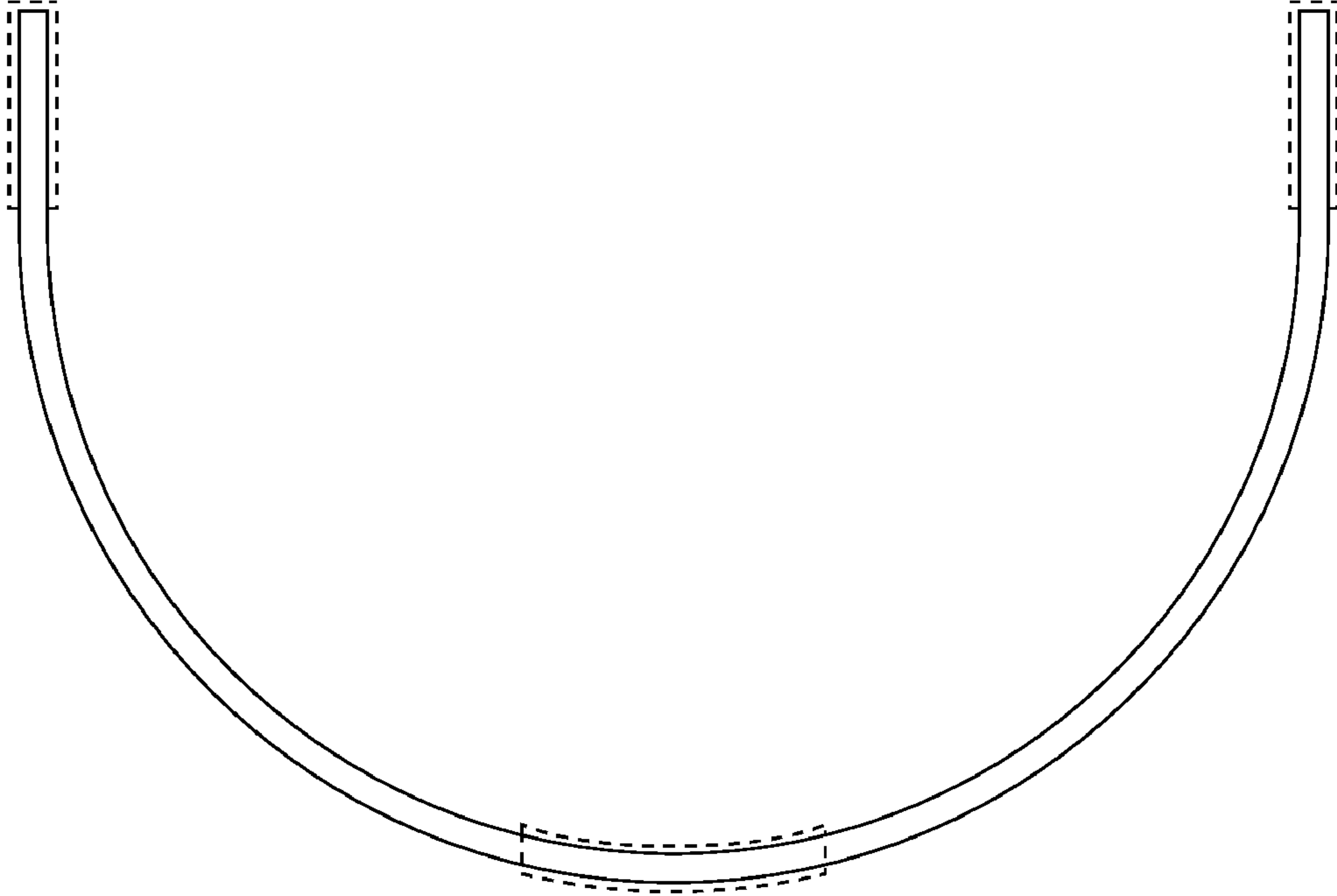
