(57) **CLAIM**

The ornamental design for a chocolate bar, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a chocolate bar showing our new design, according to a first embodiment;

FIG. 2 is a top view of the design shown in FIG. 1;

FIG. 3 is a bottom view of the design shown in FIG. 1;

FIG. 4 is a front view of the design shown in FIG. 1;

FIG. 5 is a rear view of the design shown in FIG. 1;

FIG. 6 is a left view of the design shown in FIG. 1;

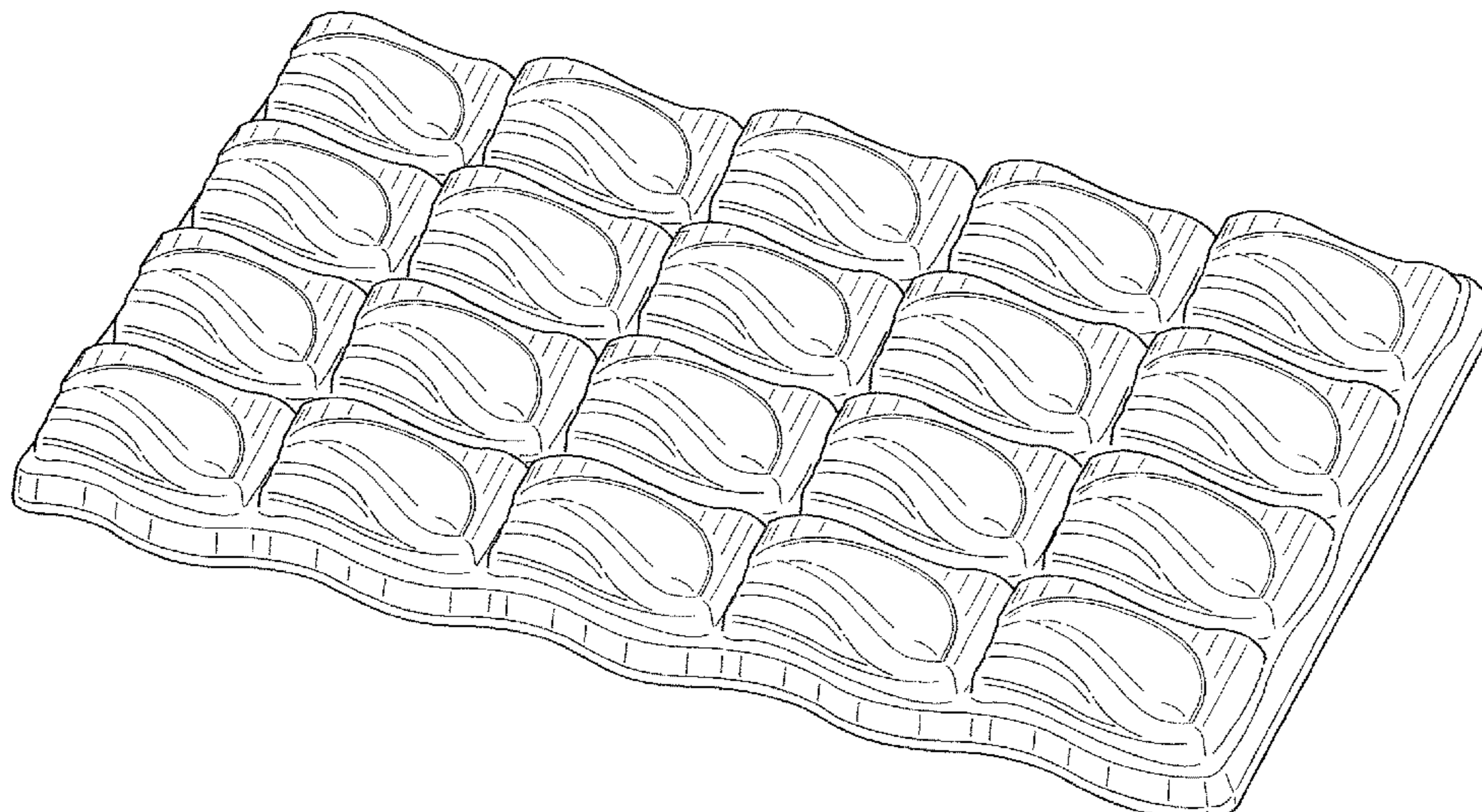
FIG. 7 is a right view of the design shown in FIG. 1;

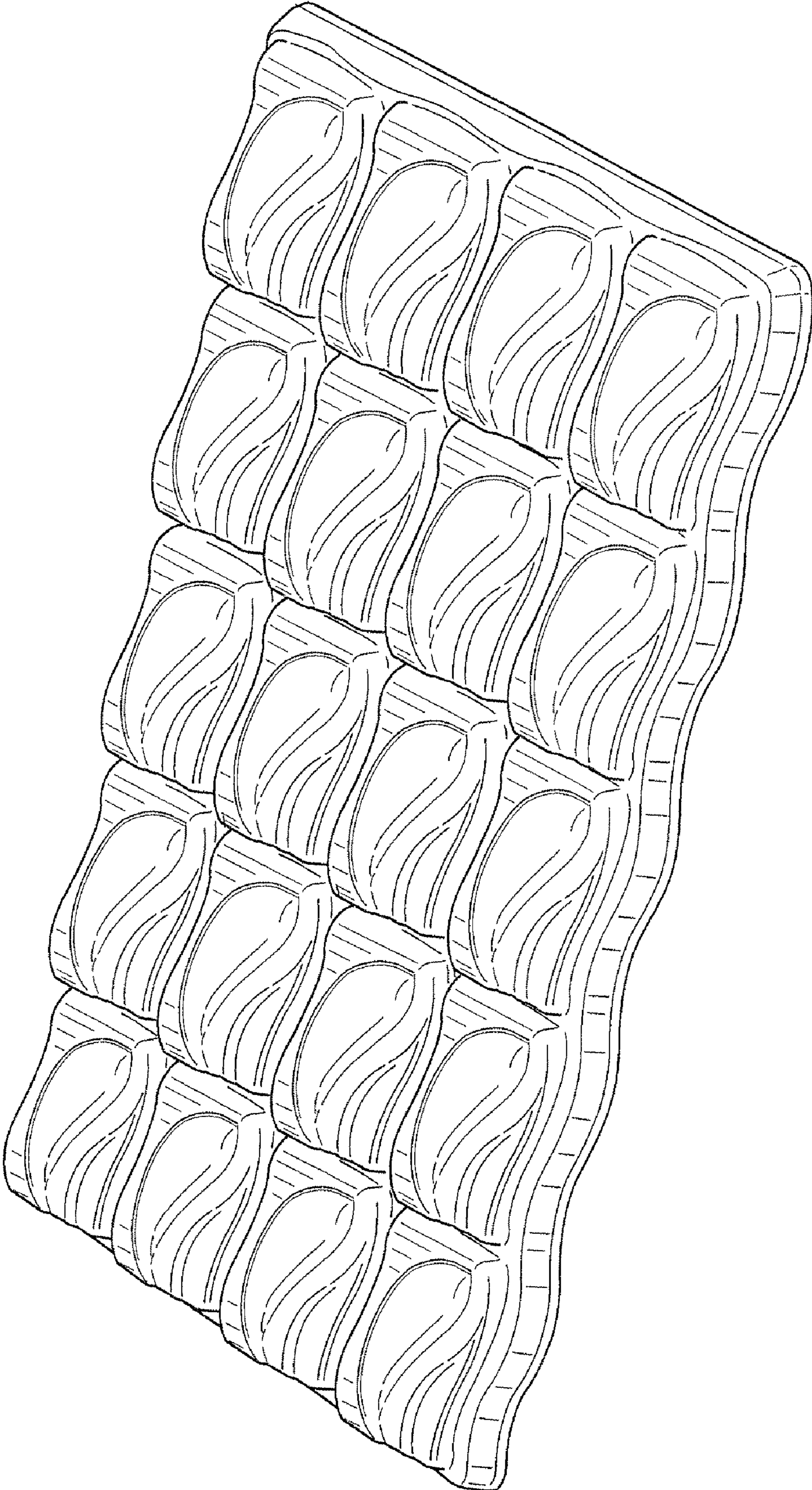

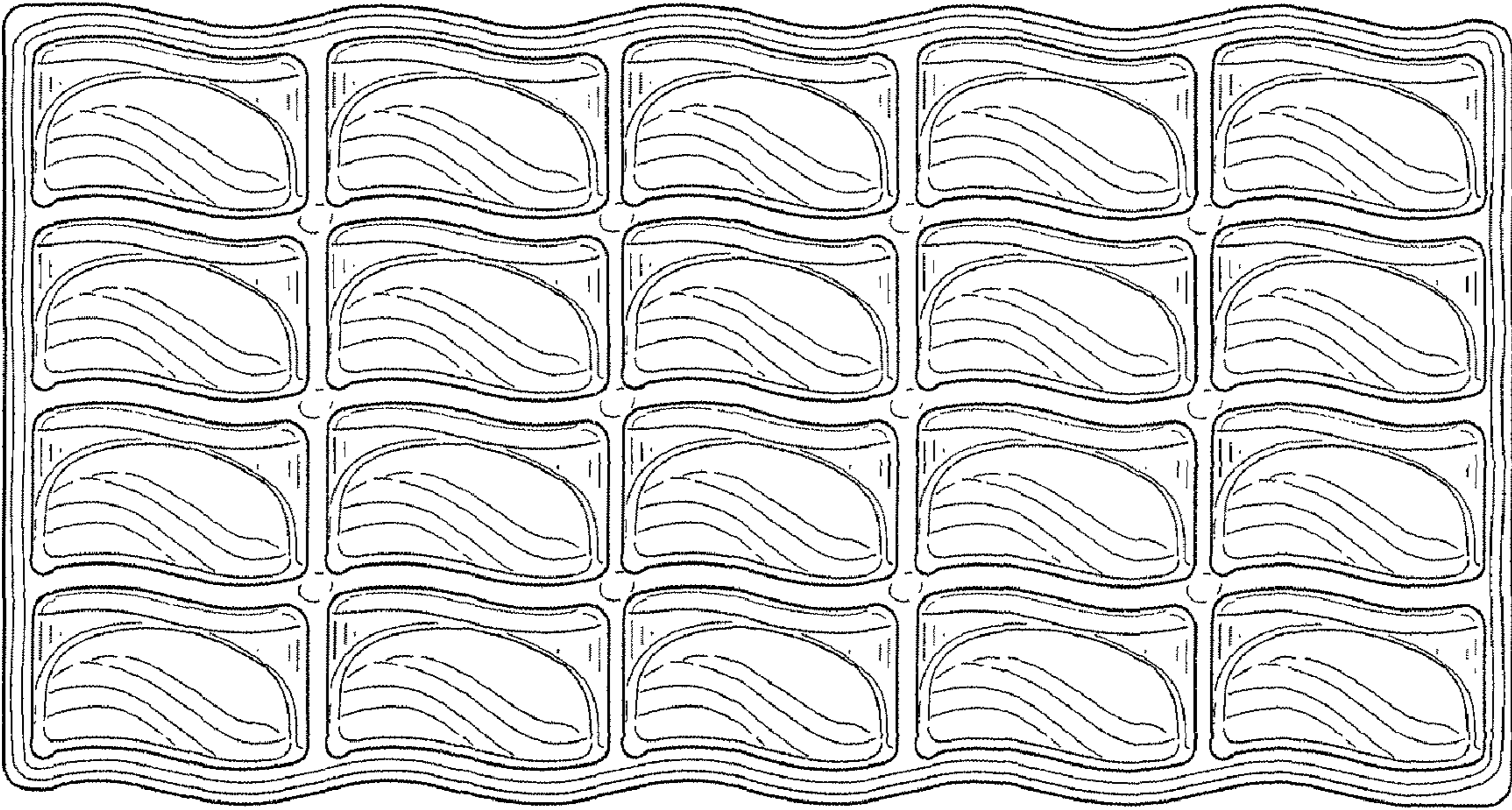

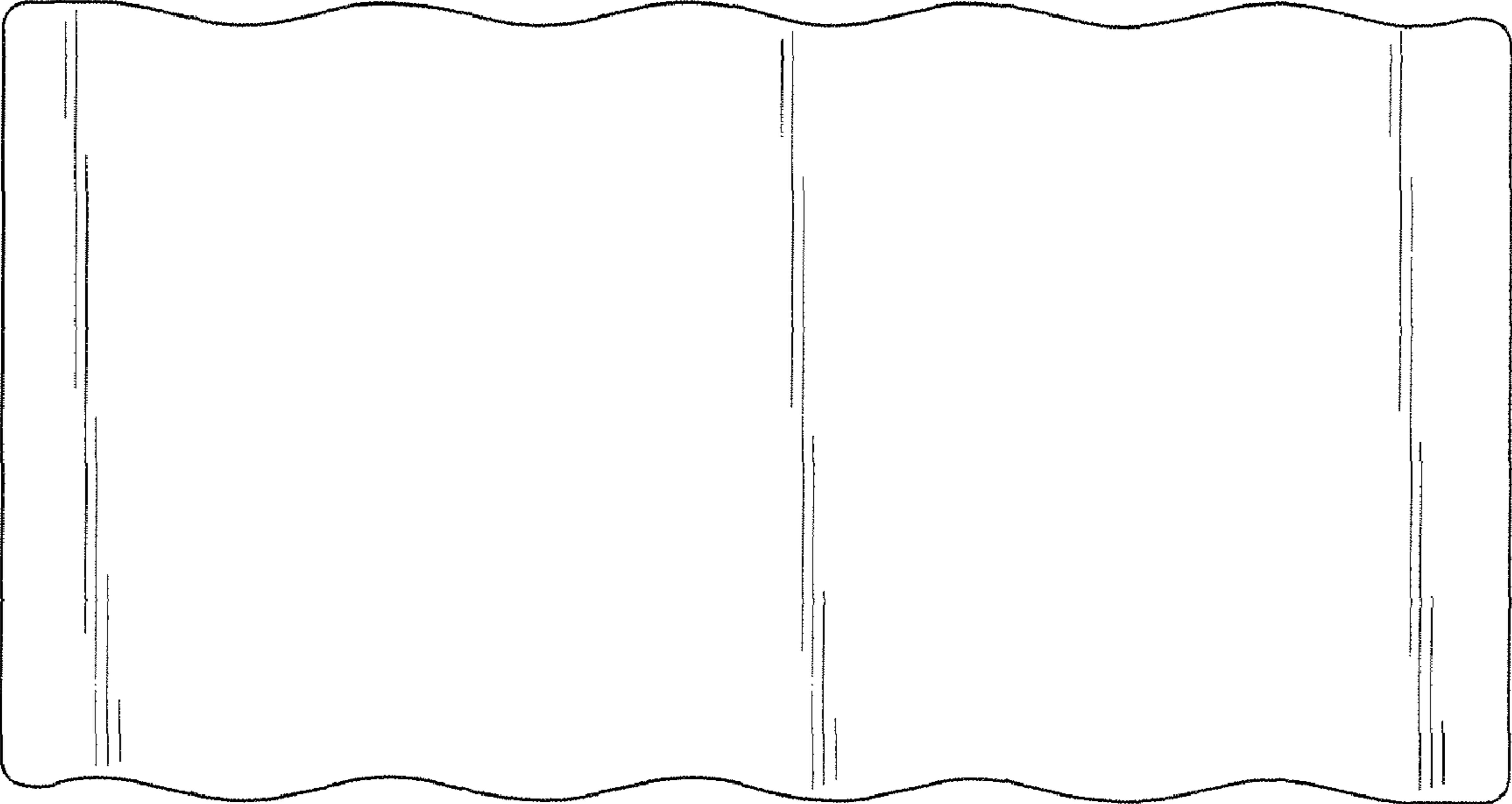

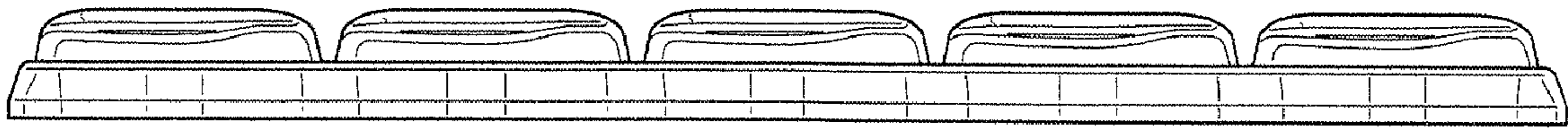

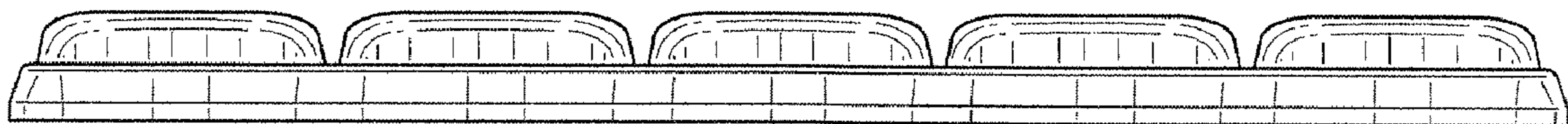

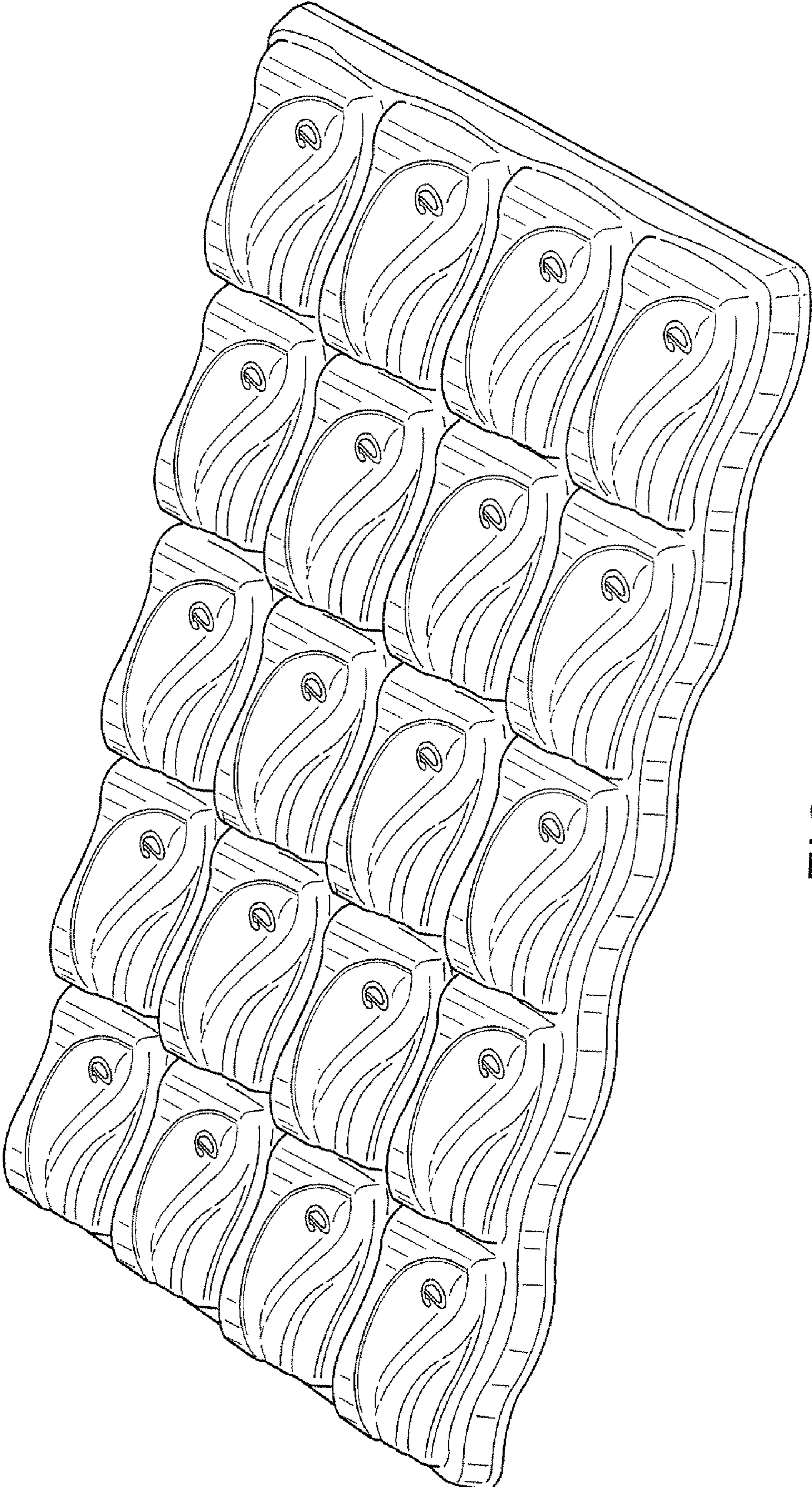

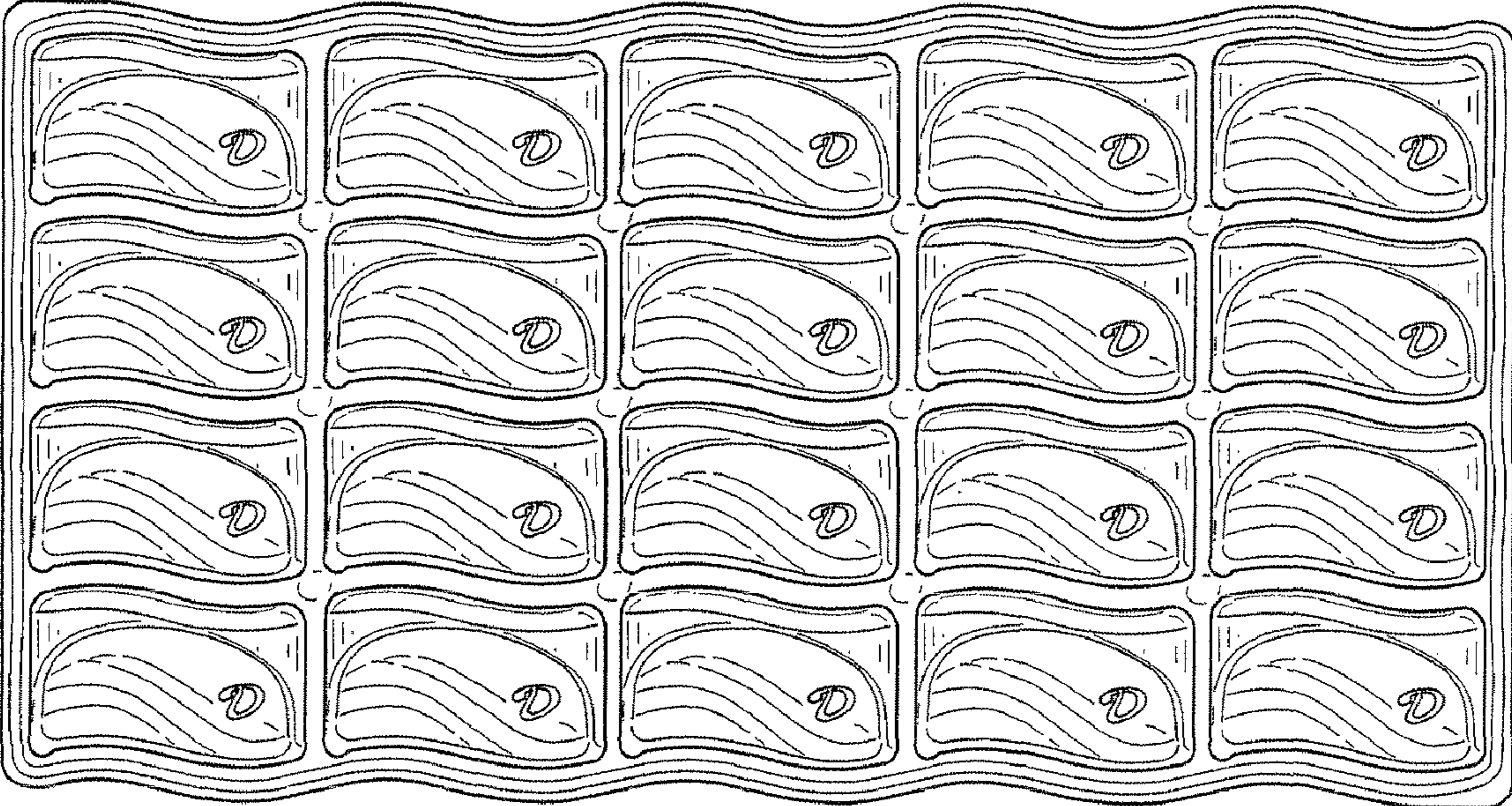
