(57) **CLAIM**

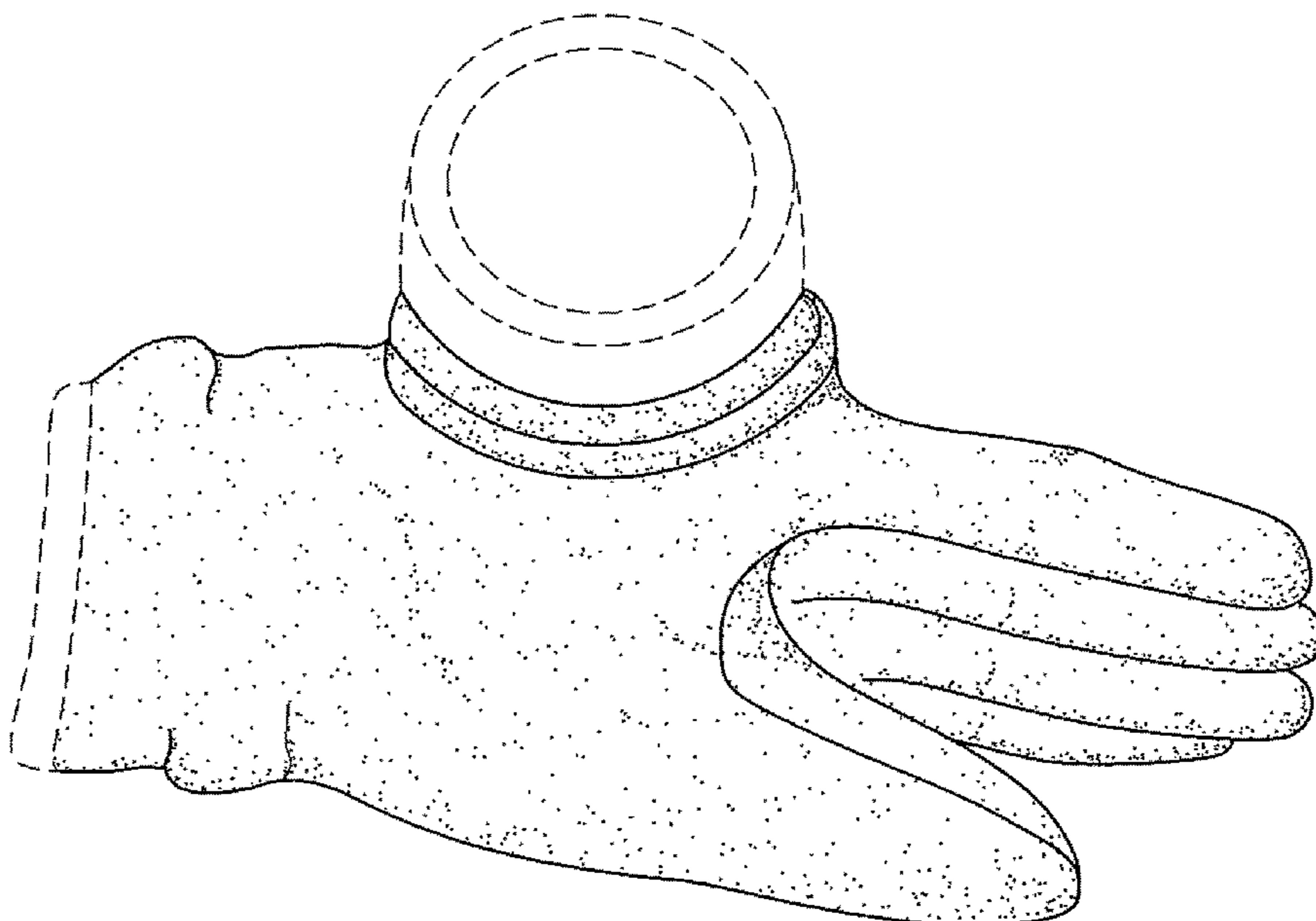
The ornamental design for a drinking glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the drinking glove; FIG. 2 is a front (palm side) view of the drinking glove; and, FIG. 3 is a back view of the drinking glove.

Applicant explicitly disclaims the left side view of the drinking glove of the present invention. The dashed lines in FIGS. 1-3 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

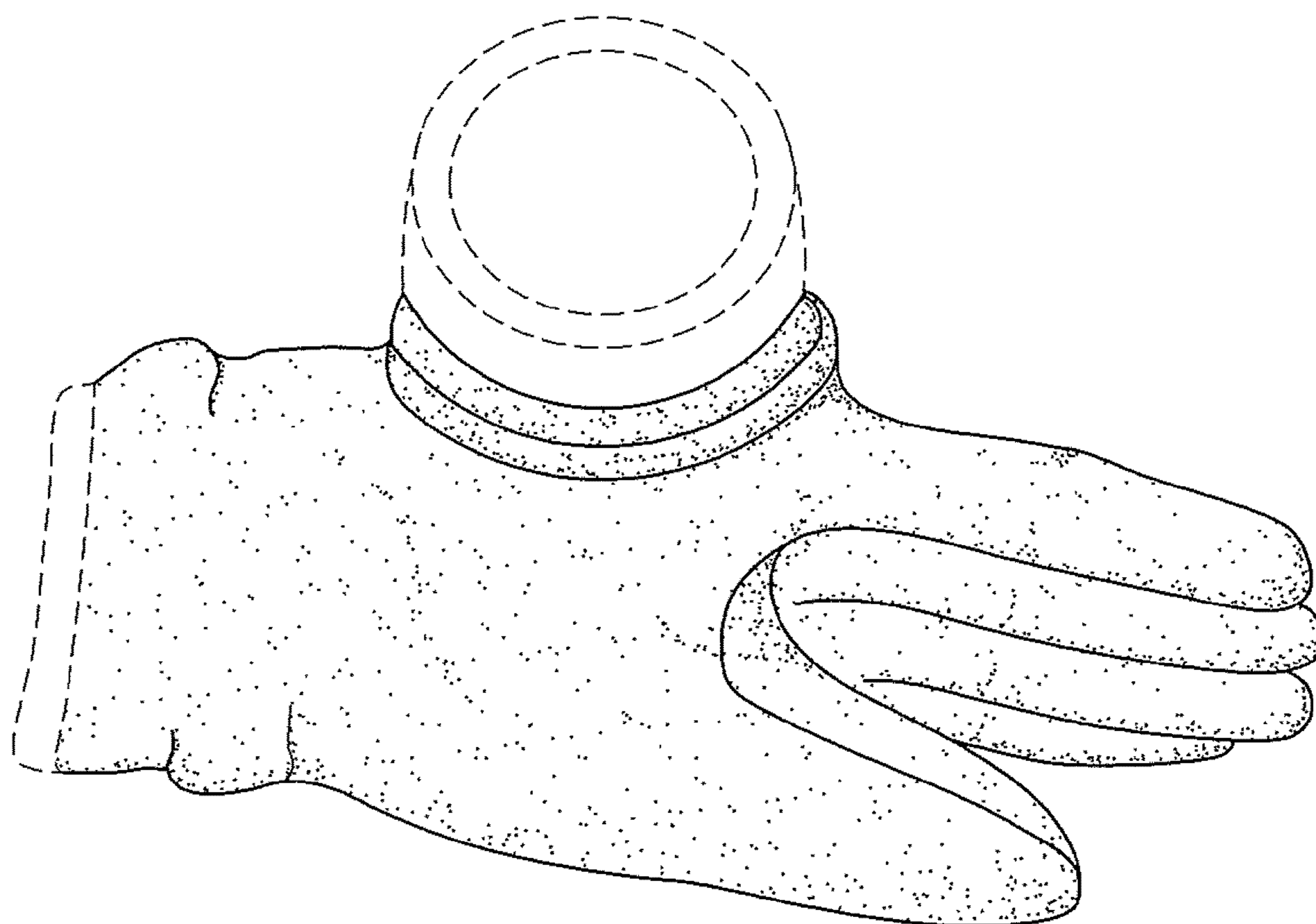

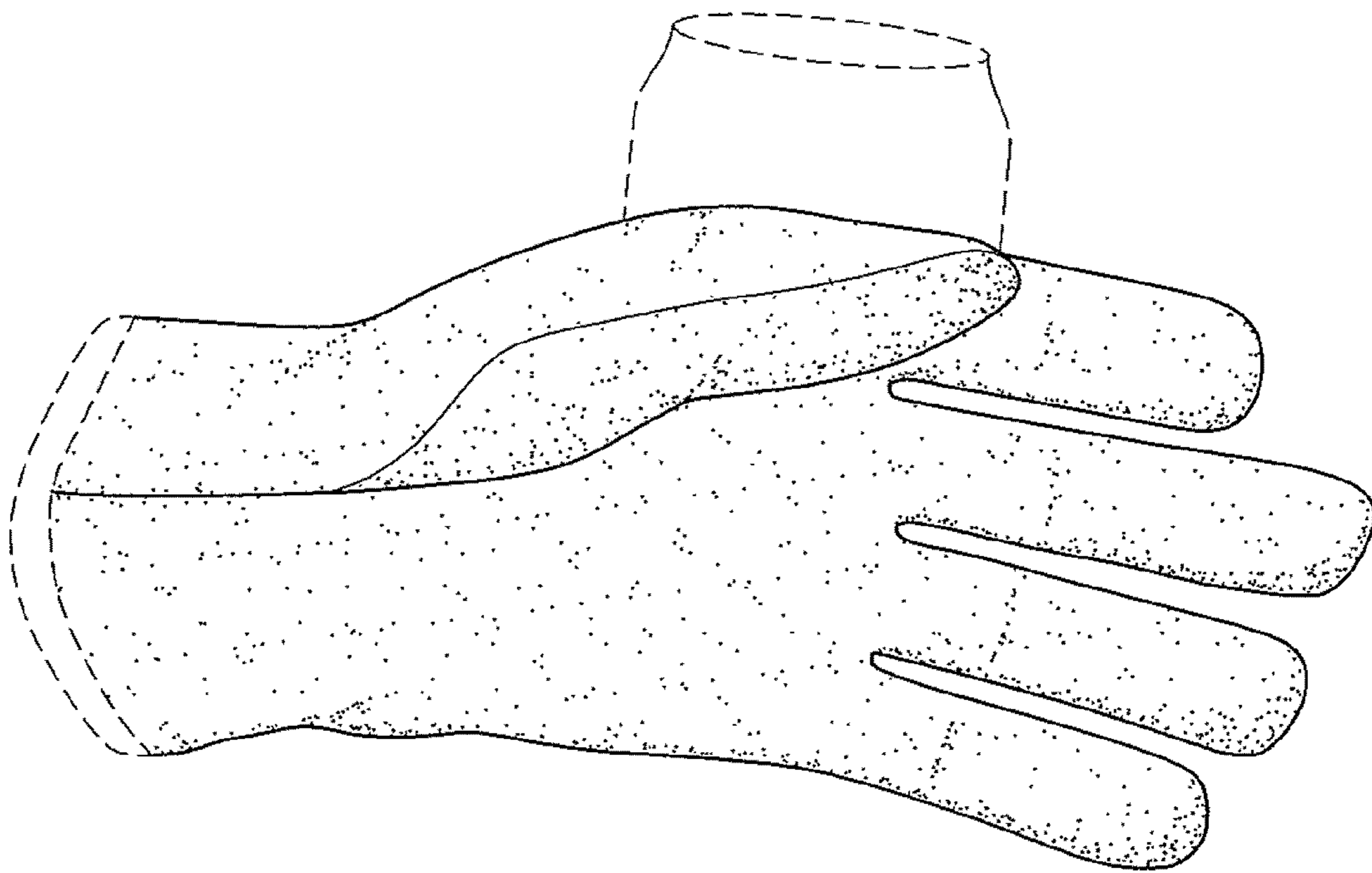

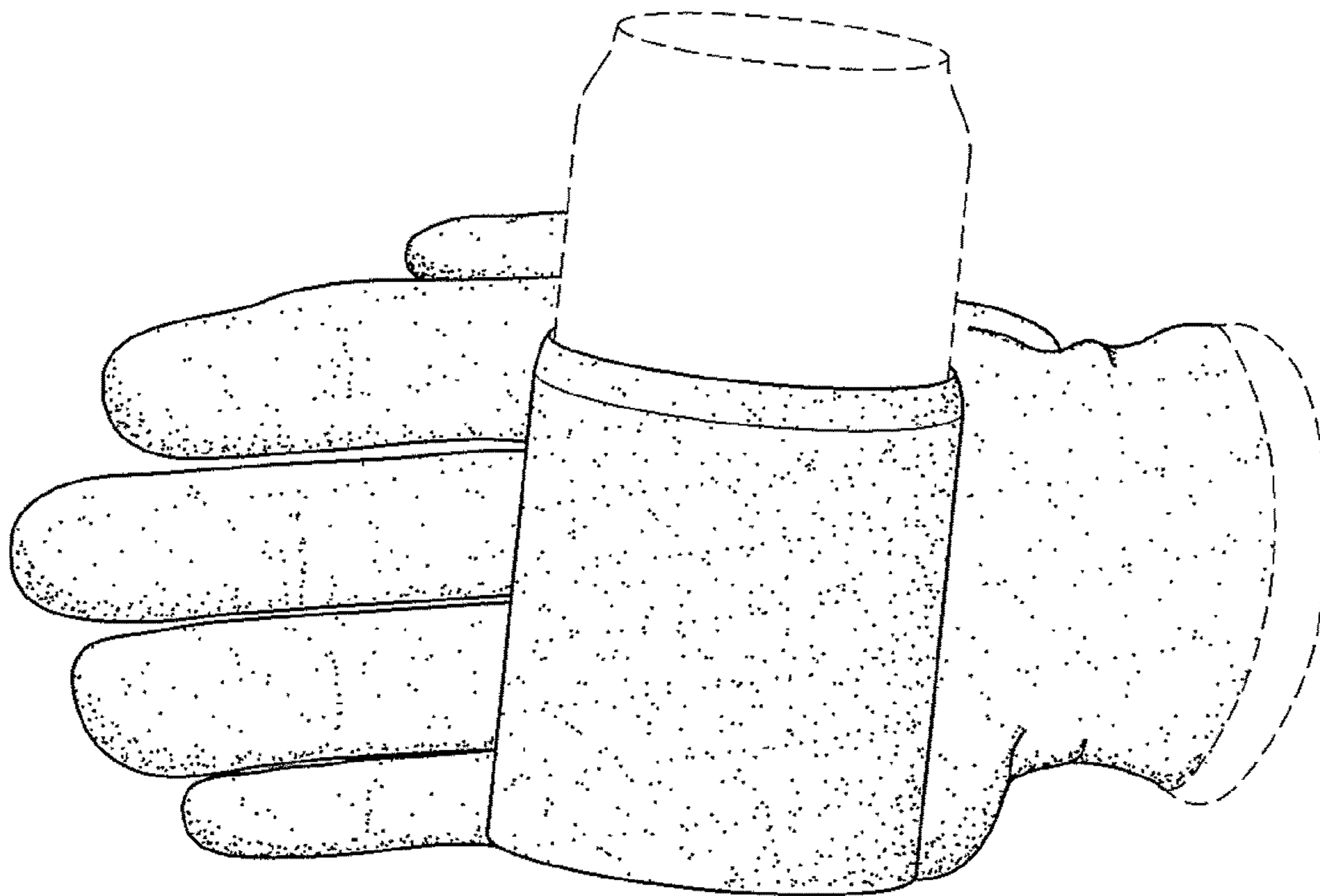
