FIG. 1 is a front view of a lady's slip with side zipper and high waist band showing my new design;

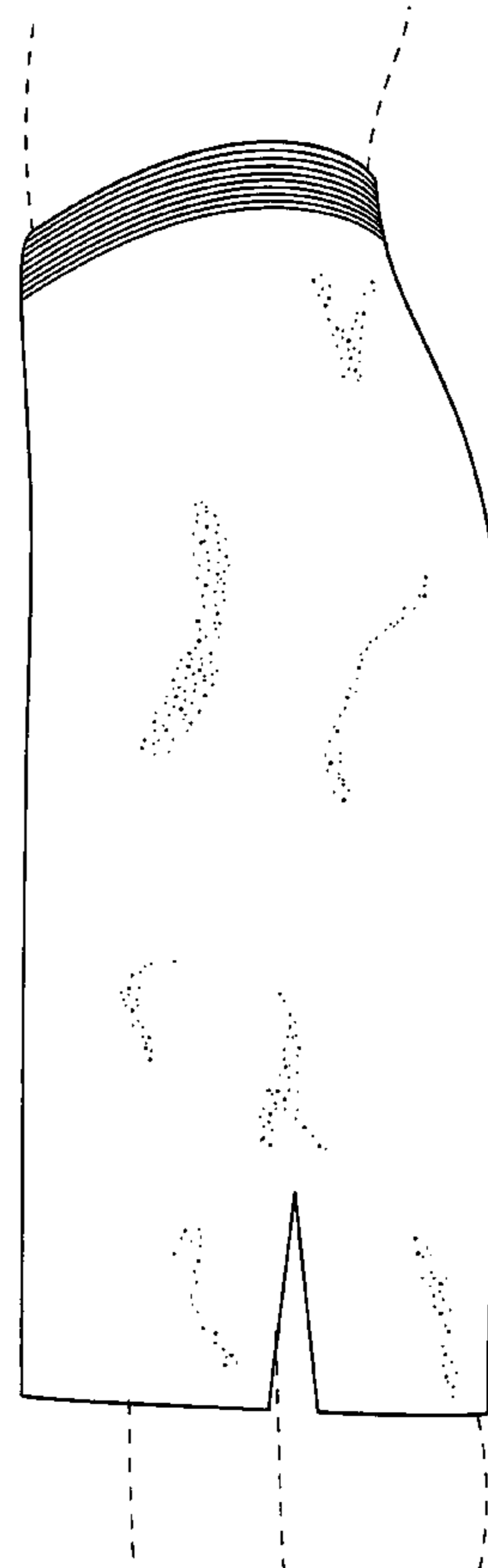
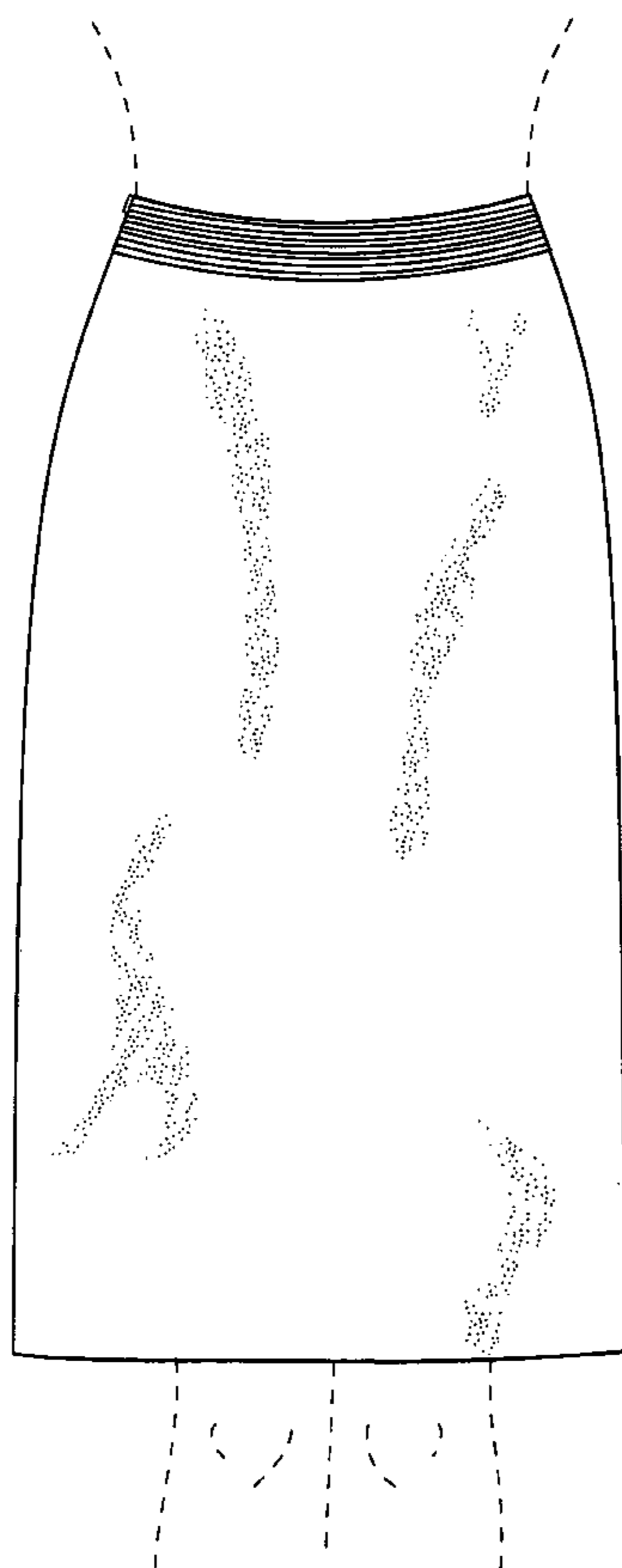
FIG. 2 is a right side view thereof;

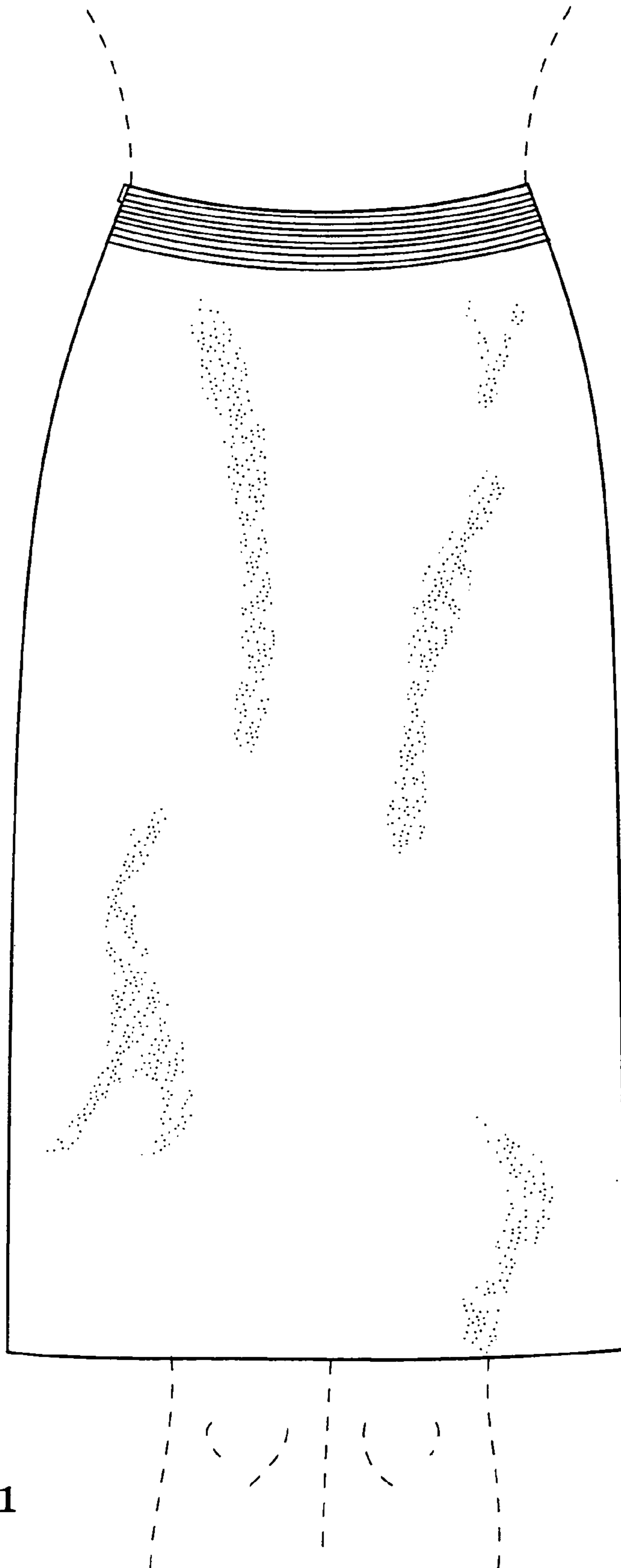

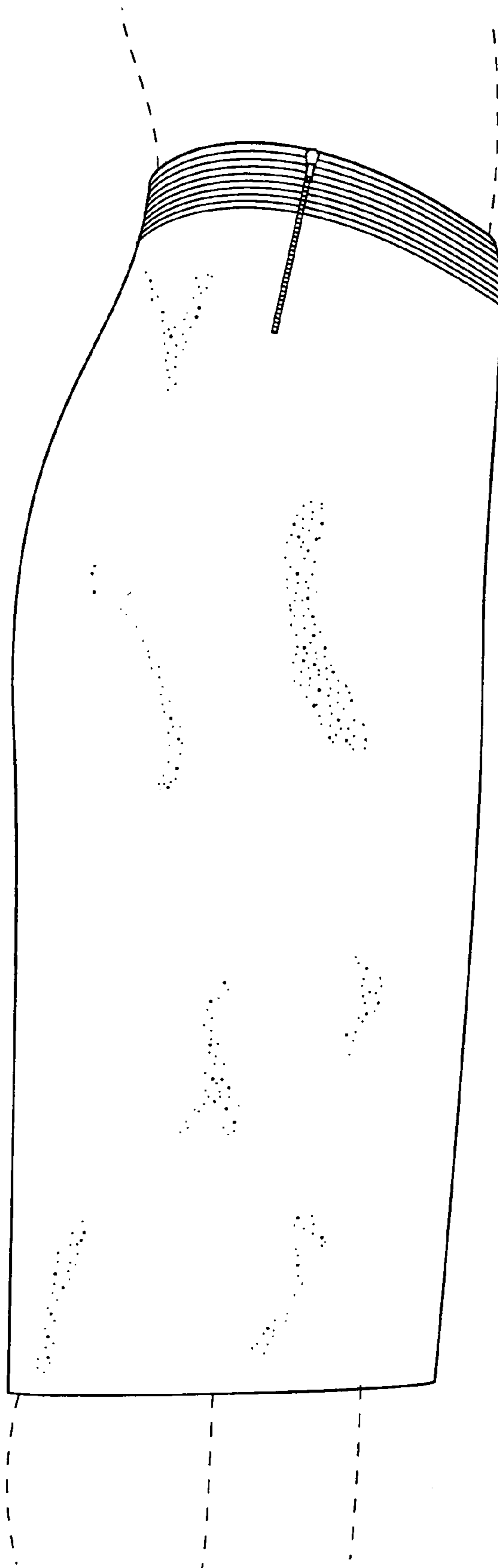

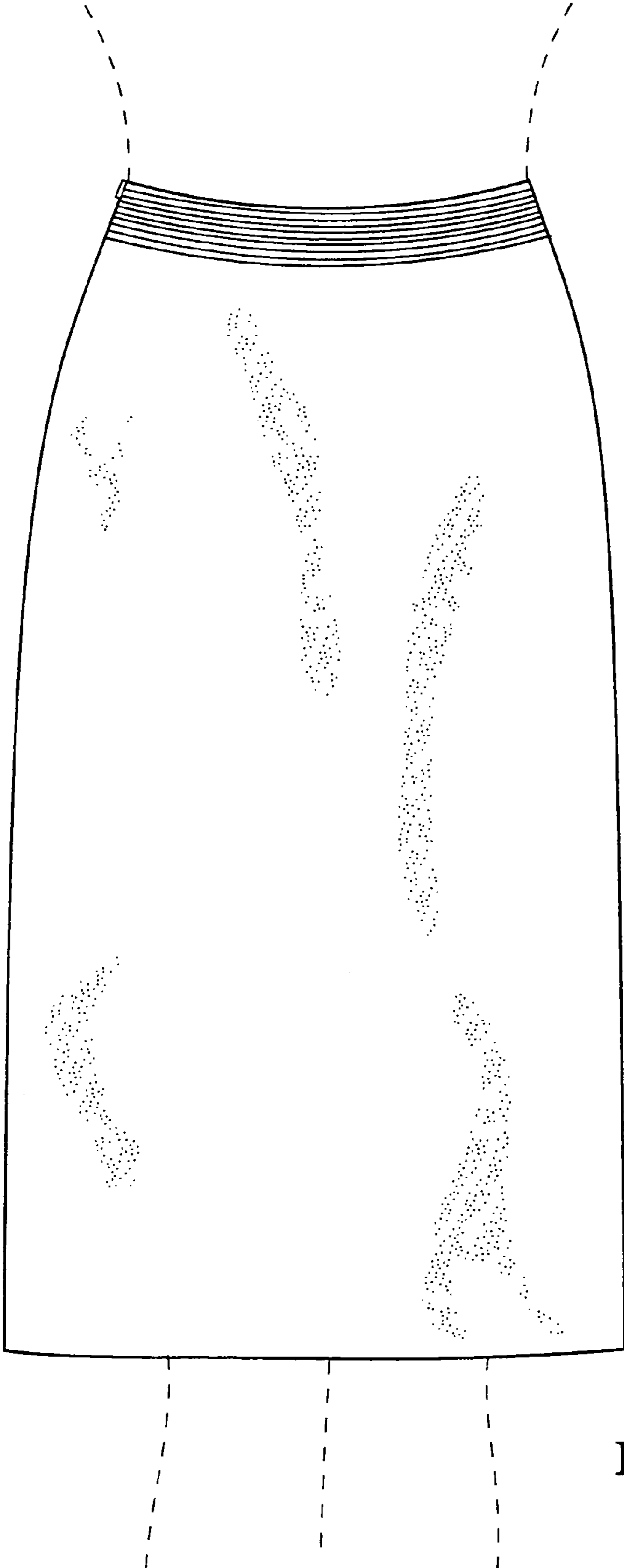

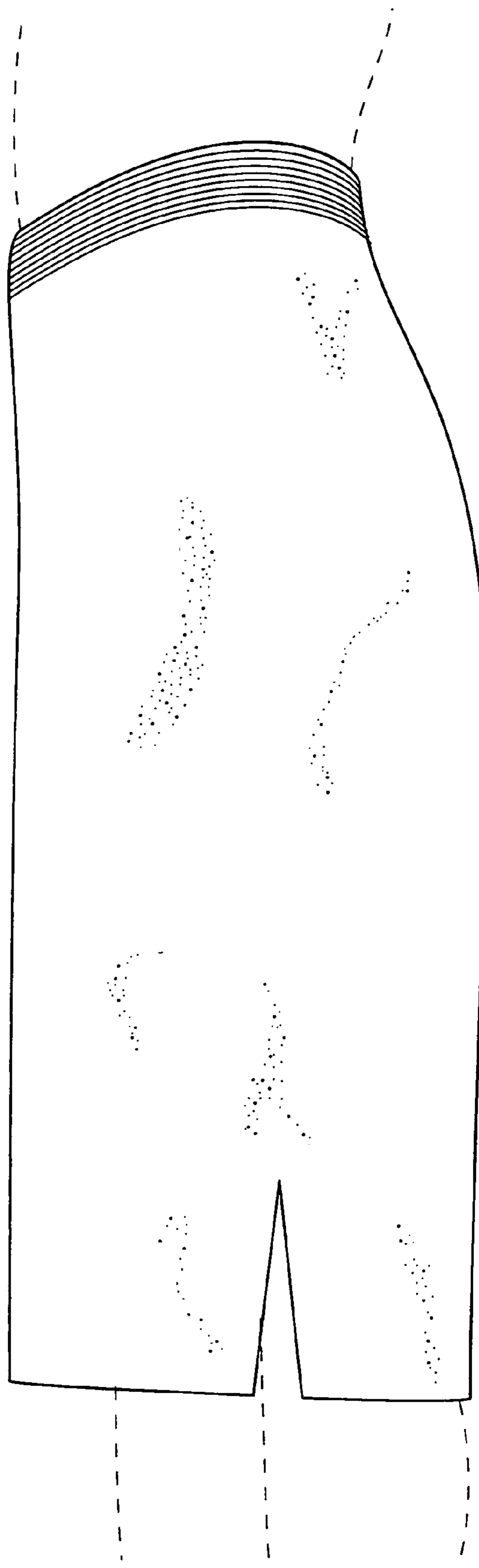
