(57) **CLAIM**

What is claimed is the ornamental design for a medical scrubs with lining, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a medical scrubs with lining, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a partial cross-sectional view thereof, taken along line 7—7 in FIG. 1;

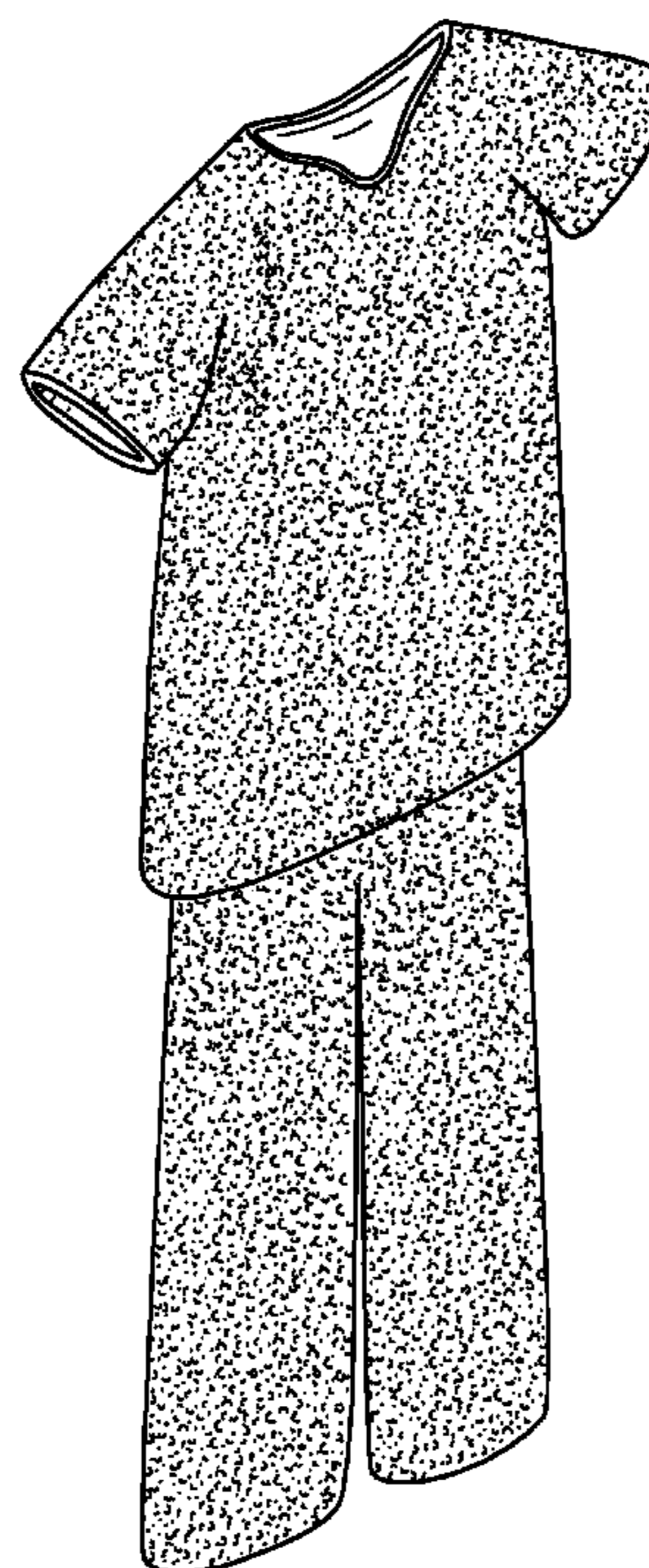
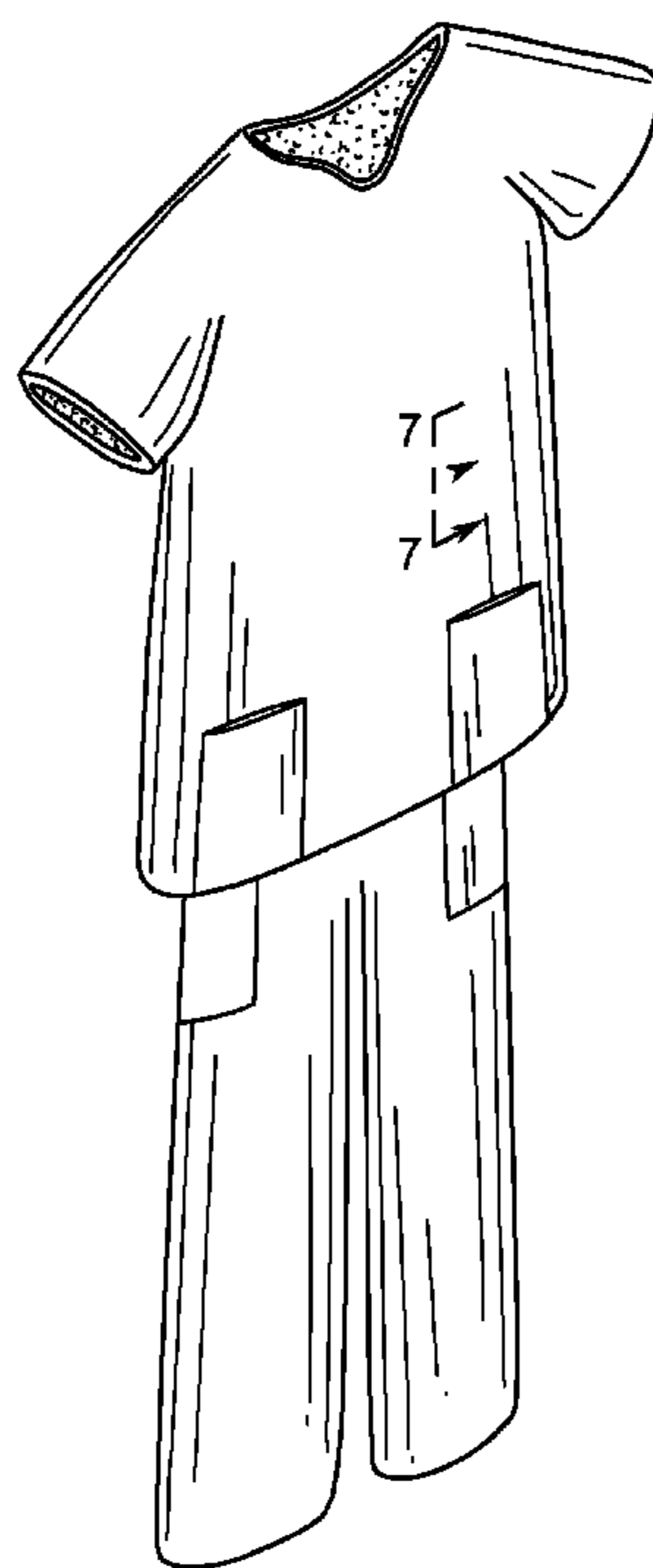
FIG. 8 is a perspective view thereof, illustrated in an inside-out configuration;

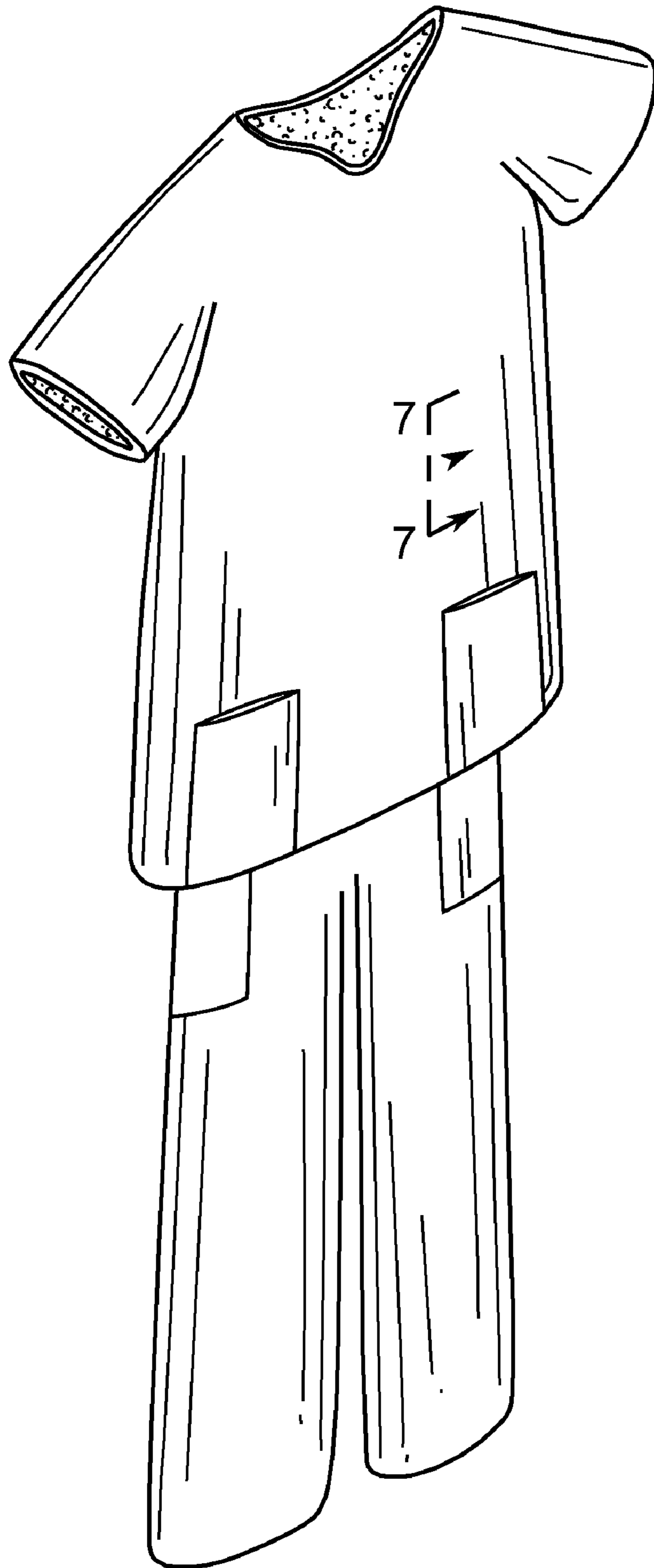

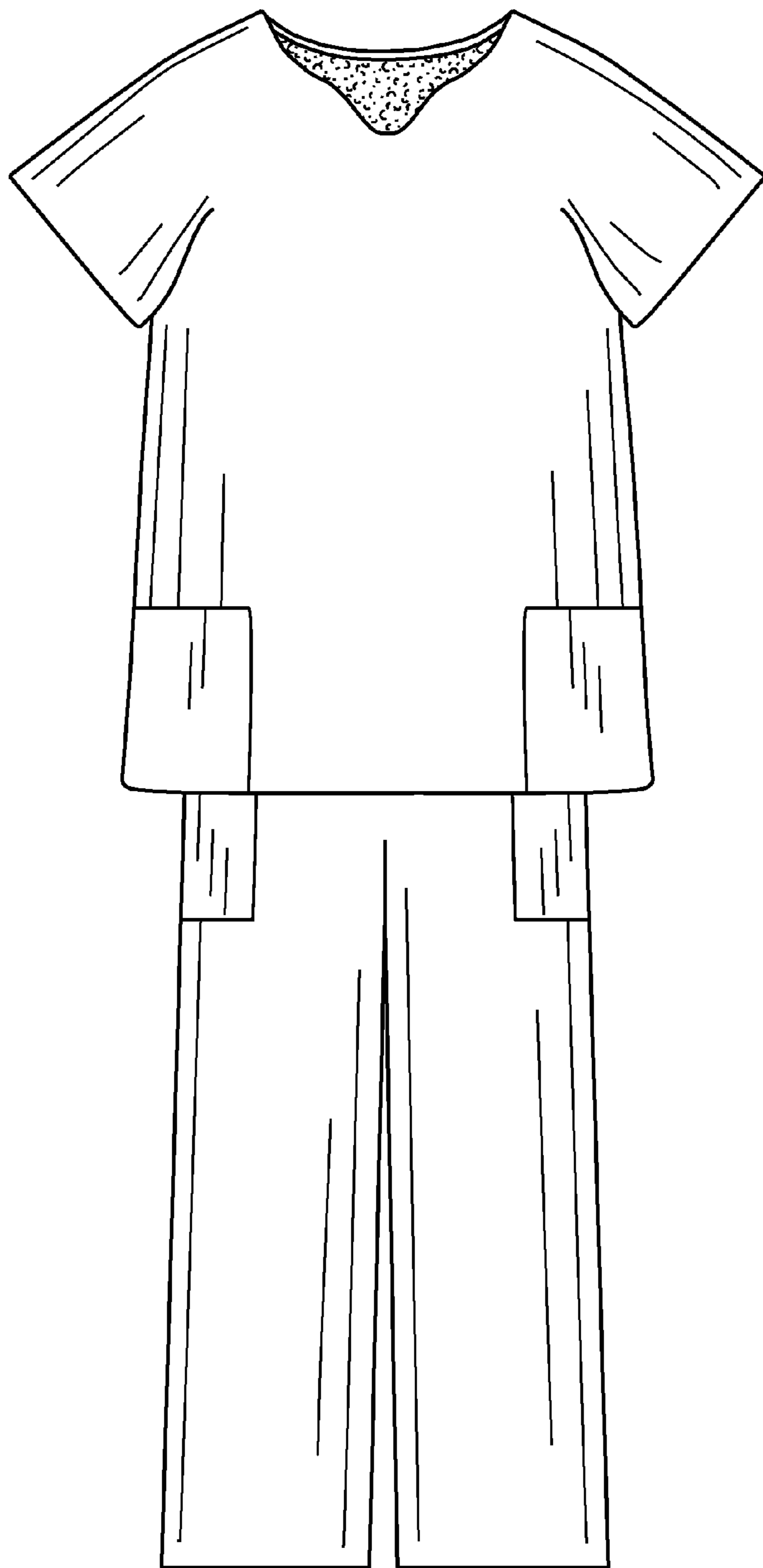

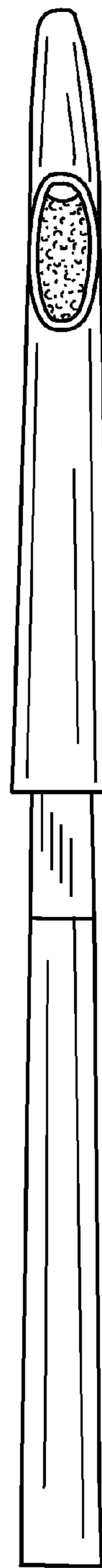

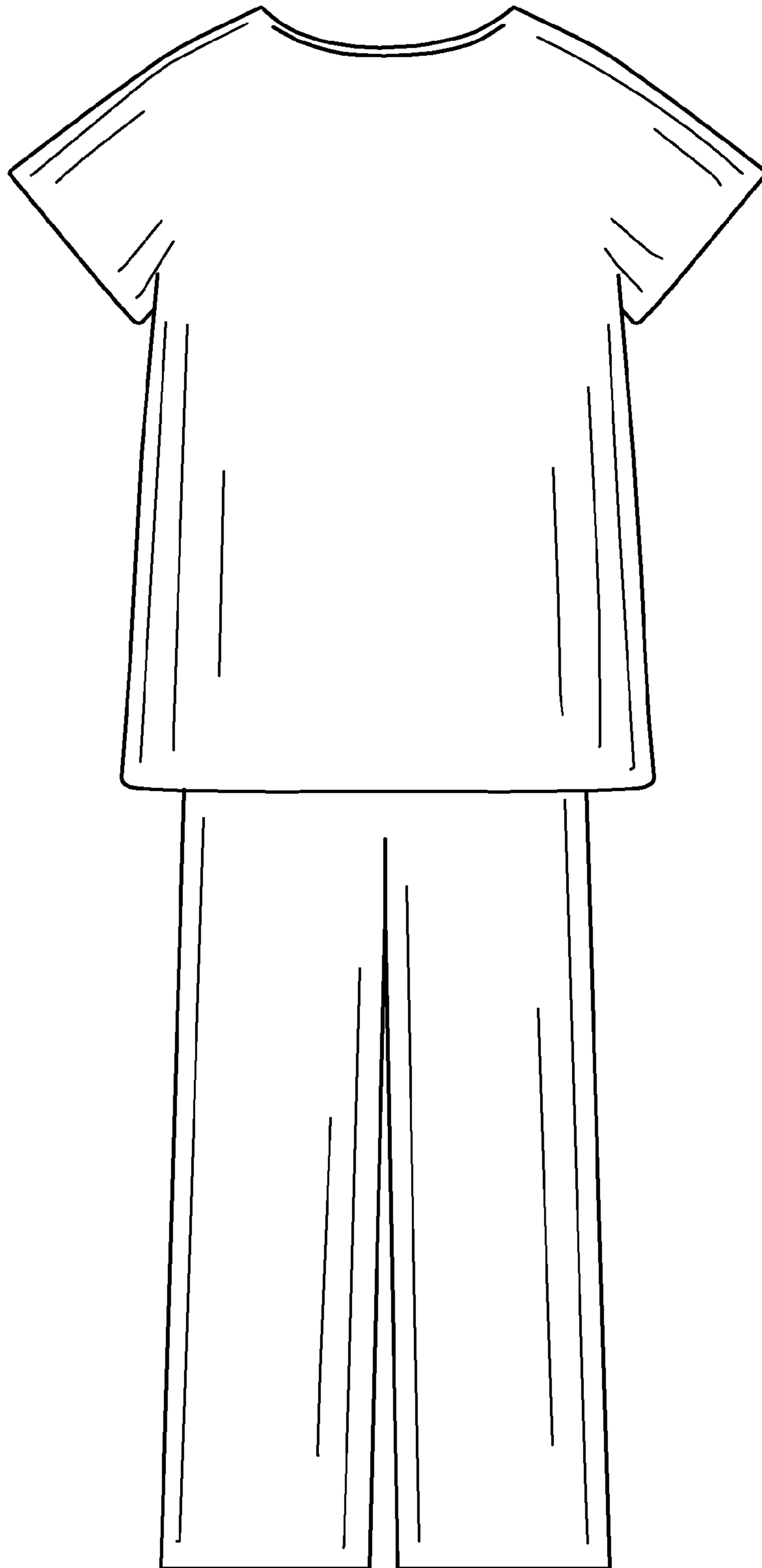

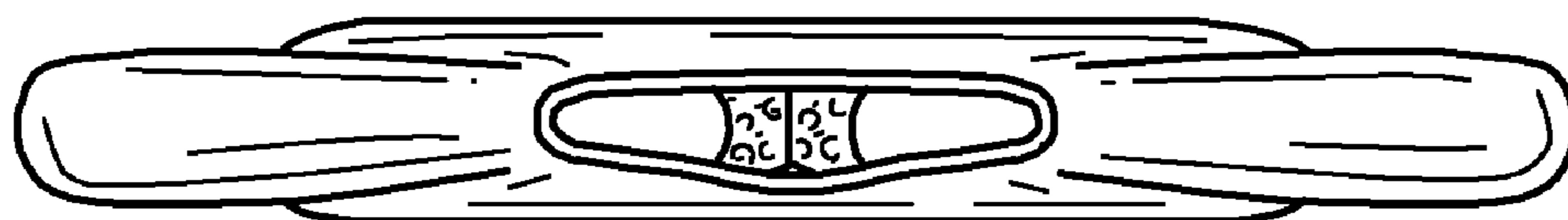

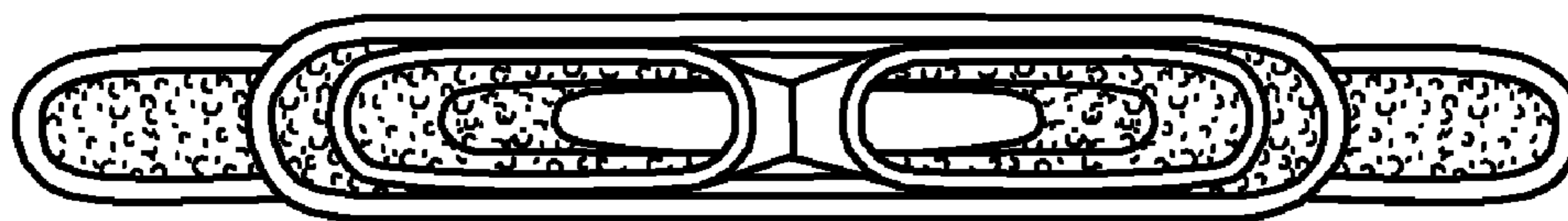

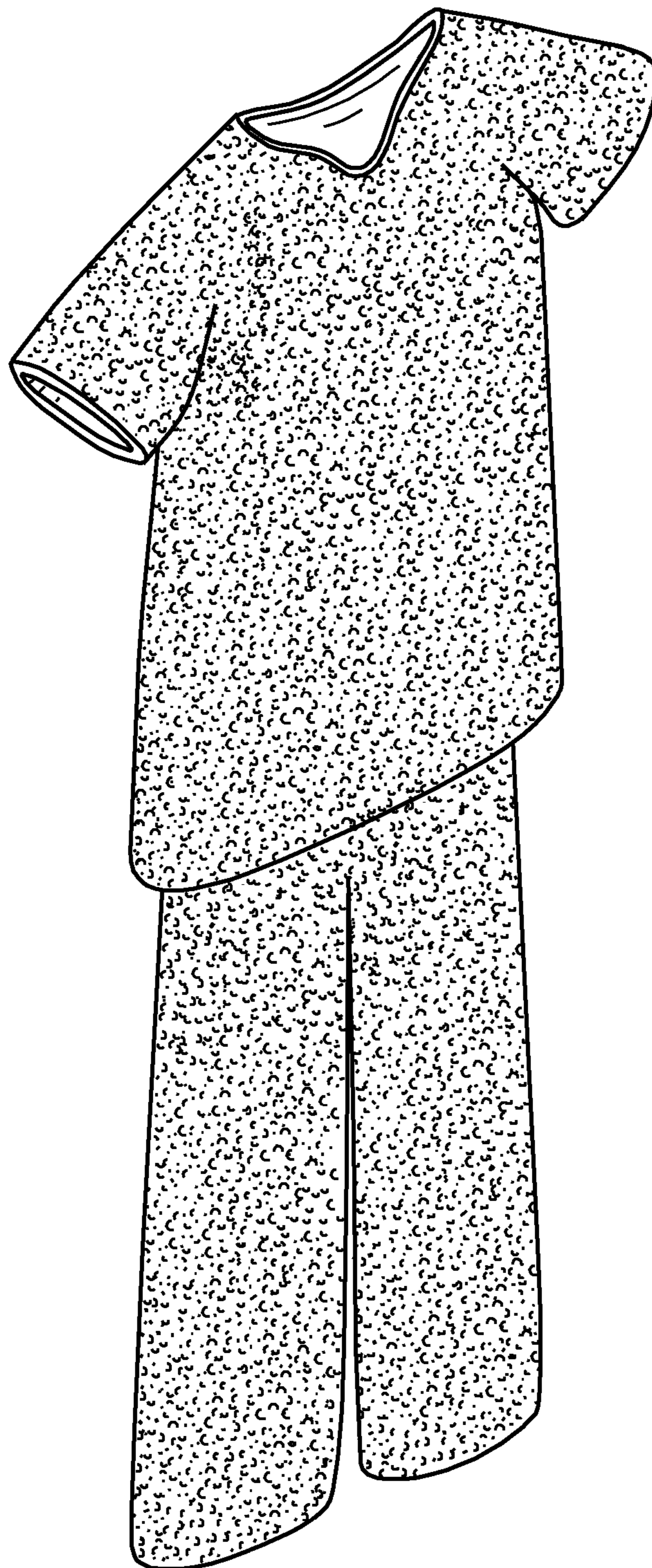

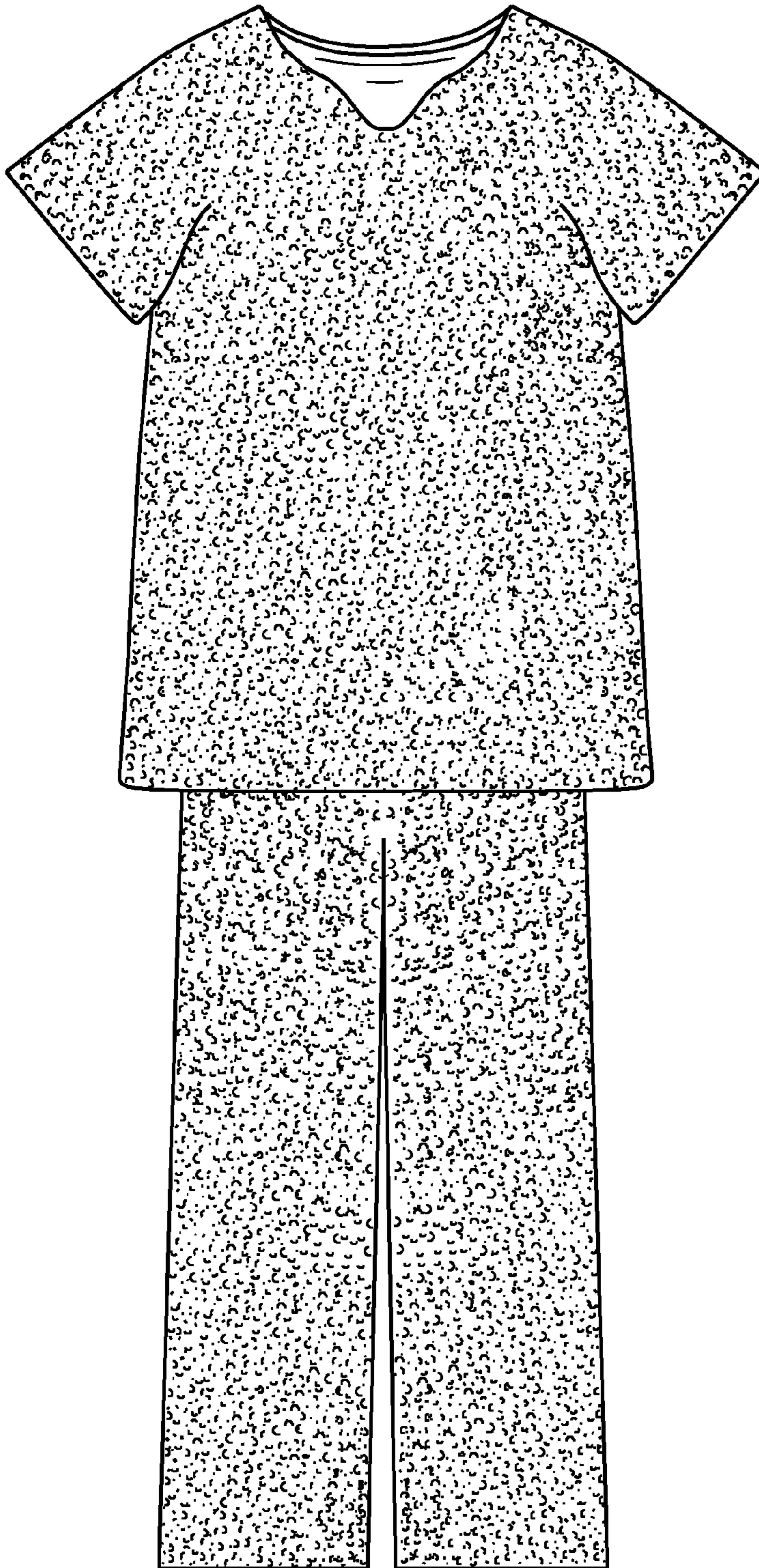

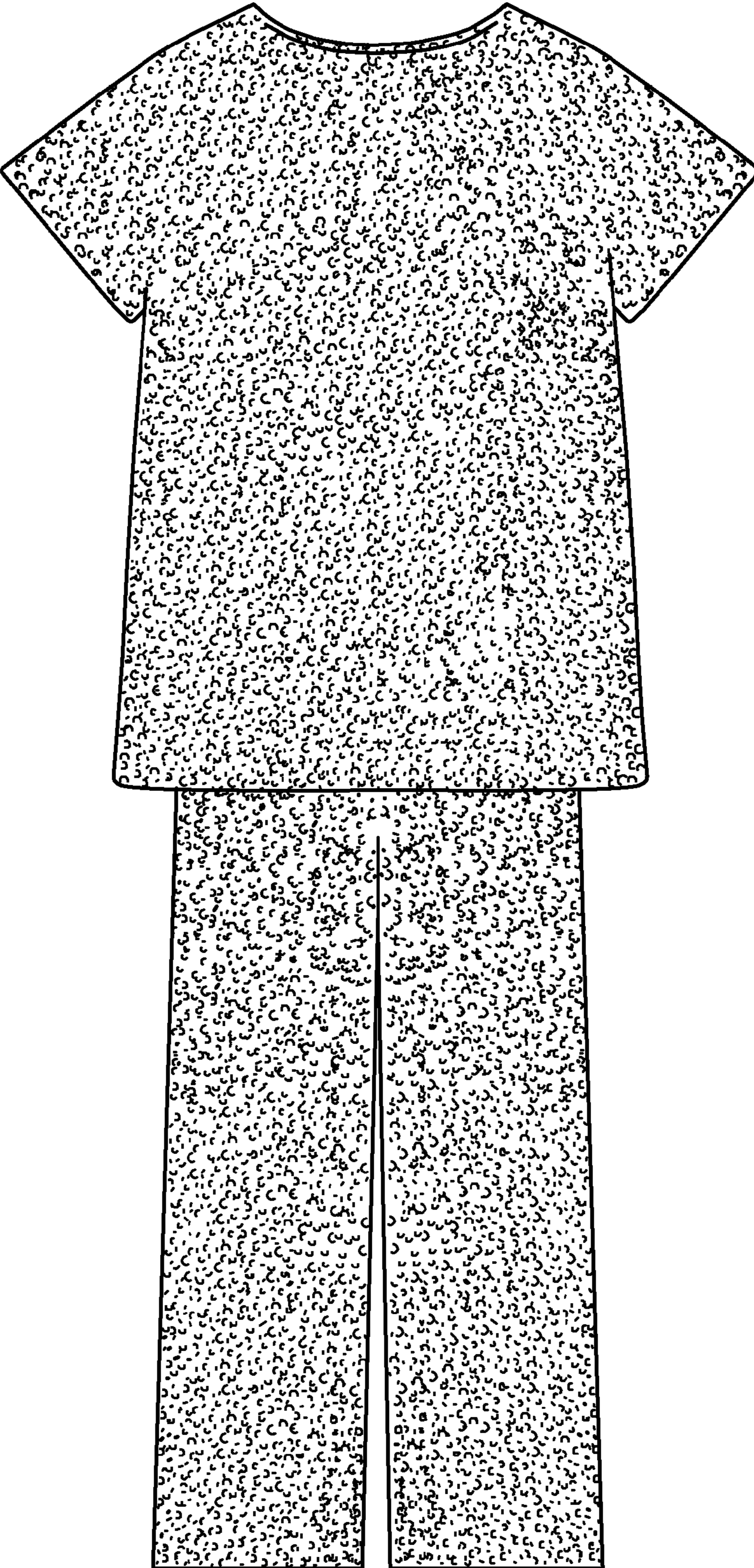
