(57) **CLAIM**

The ornamental design for a shirt with squared ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of my design for a shirt with squared ornamentation;

FIG. 2 is an enlarged, front, elevation view of a section thereof;

FIG. 3 is an enlarged, cross-sectional view thereof taken along line 3—3 of FIG. 2;

FIG. 4 is an enlarged, cross-sectional view thereof taken along line 4—4 of FIG. 2;

FIG. 5 is a front elevation view of a second embodiment of my design for a shirt with squared ornamentation;

FIG. 6 is an enlarged, front, elevation view of a section thereof;

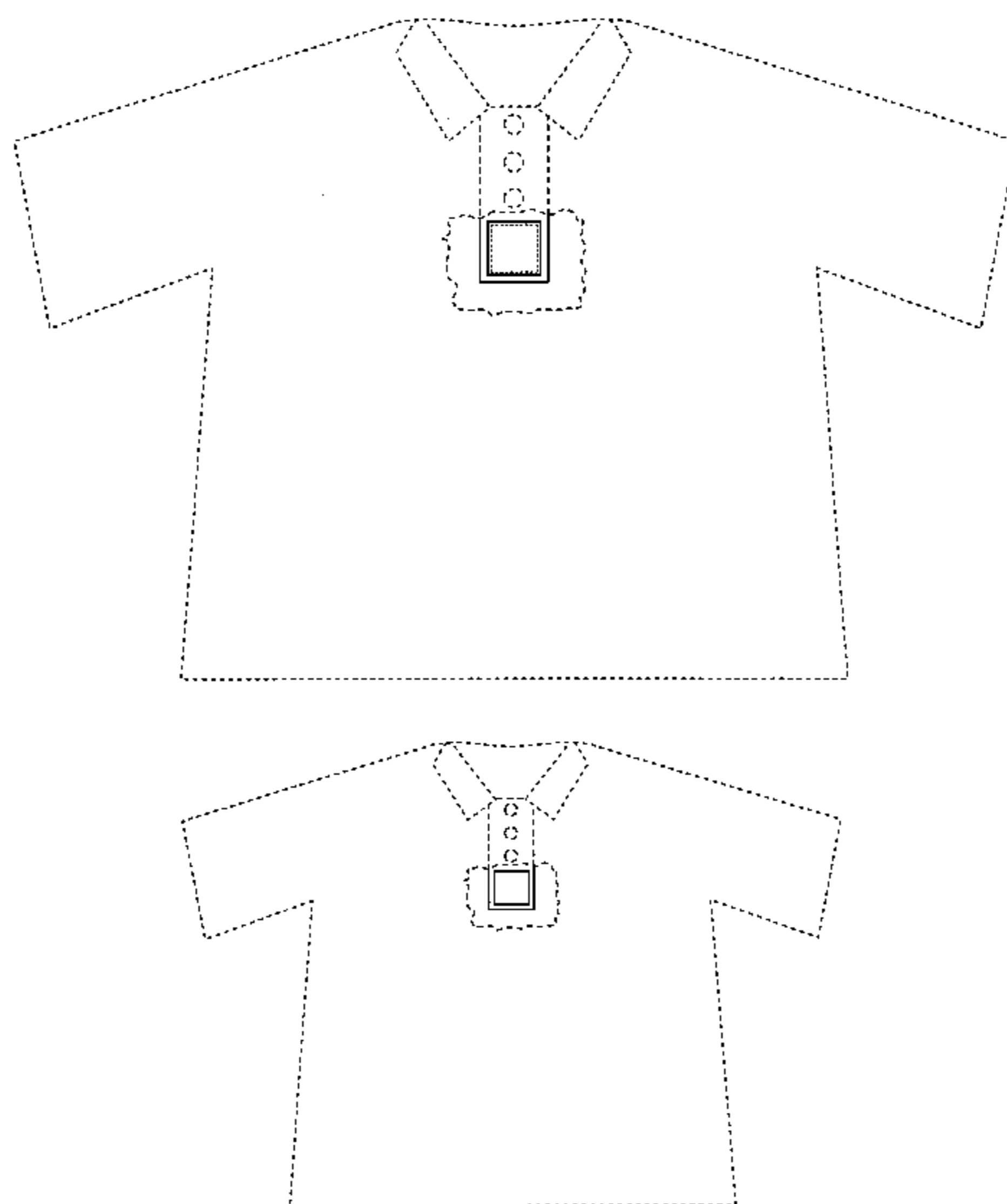
FIG. 7 is an enlarged, cross-sectional view thereof taken along line 7—7 of FIG. 6; and,

FIG. 8 is an enlarged cross-sectional view thereof taken along line 8—8 of FIG. 6.

The portions of the shirt and squared ornamentation in FIGS. 1-8 shown in dotted lines do not constitute a part of the claimed design.

The squared ornamentation, in one form, has a color substantially the same as the area of the shirt surrounding the squared ornamentation. In another form, the squared ornamentation has a different color than the area of the shirt surrounding the squared ornamentation.

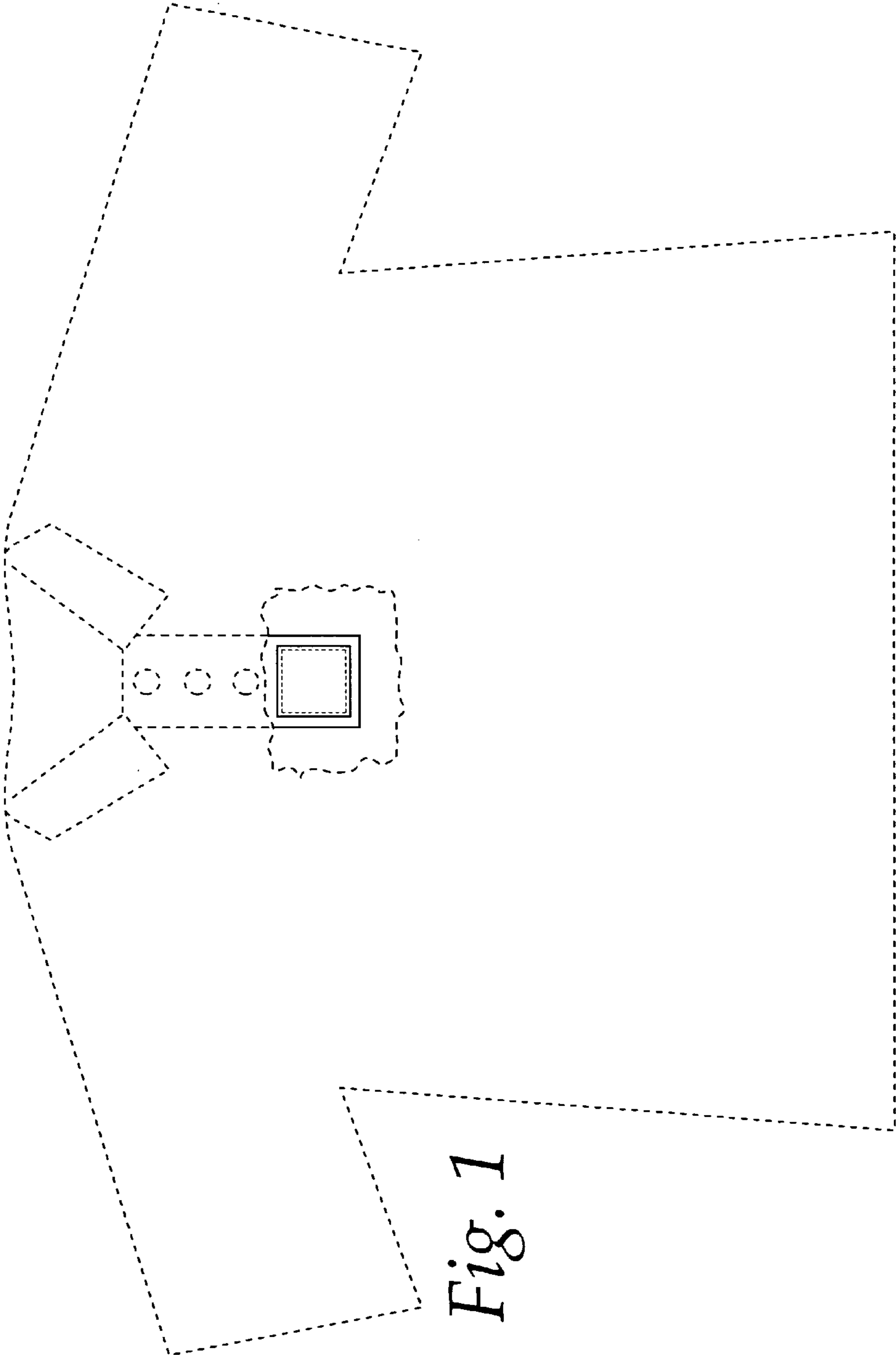
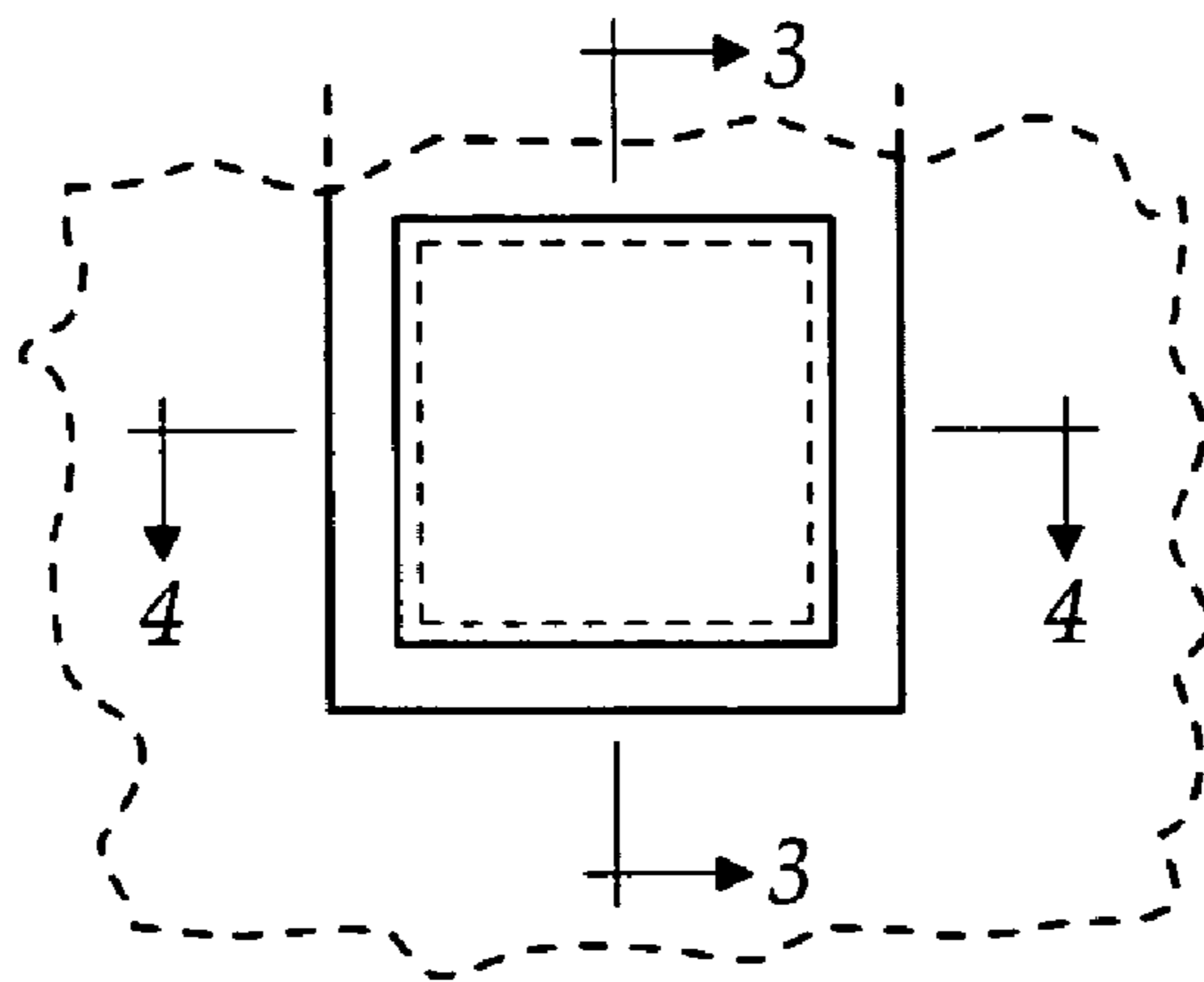

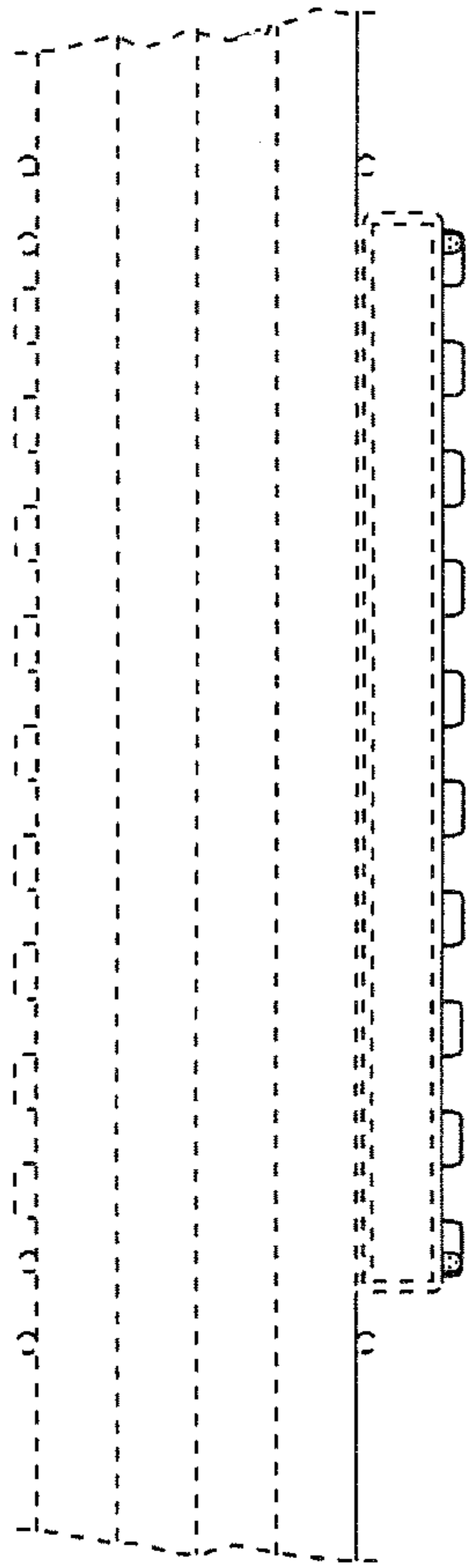

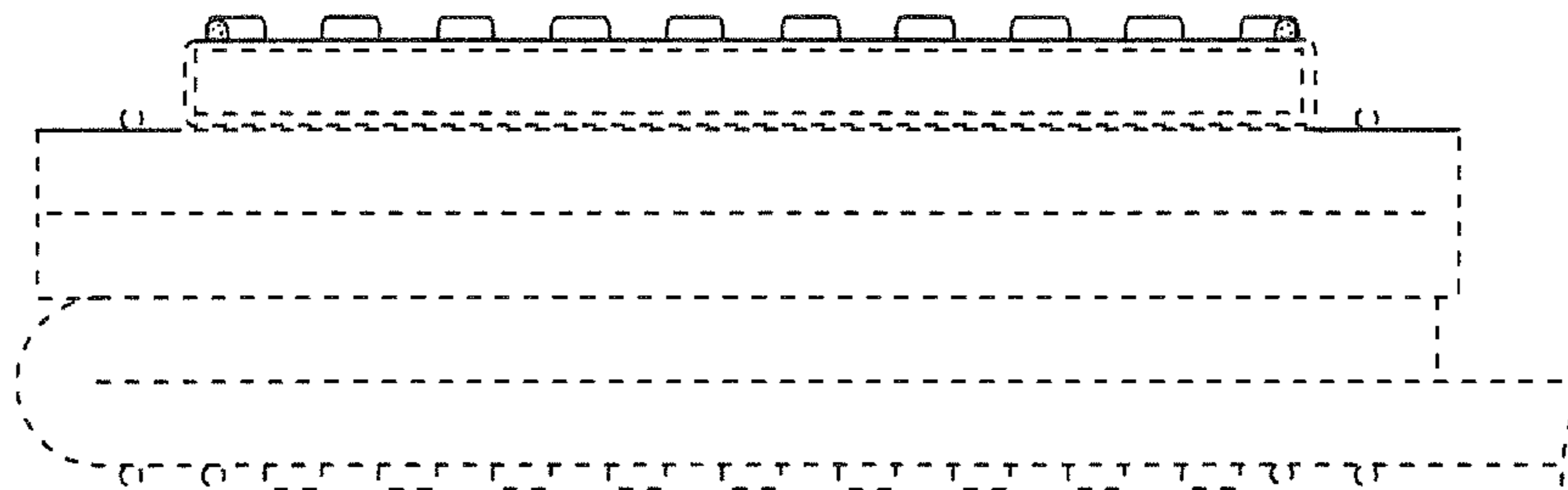

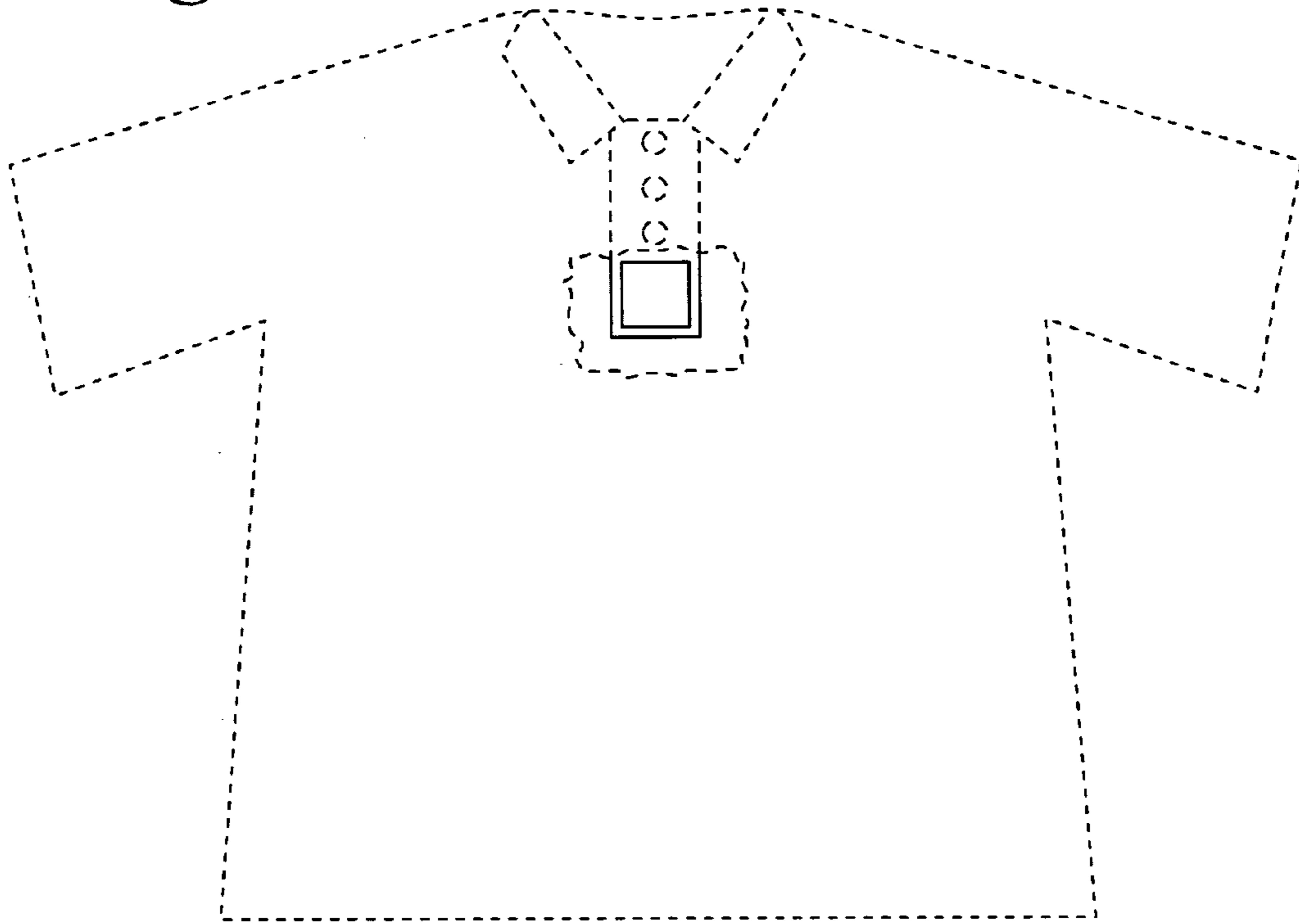
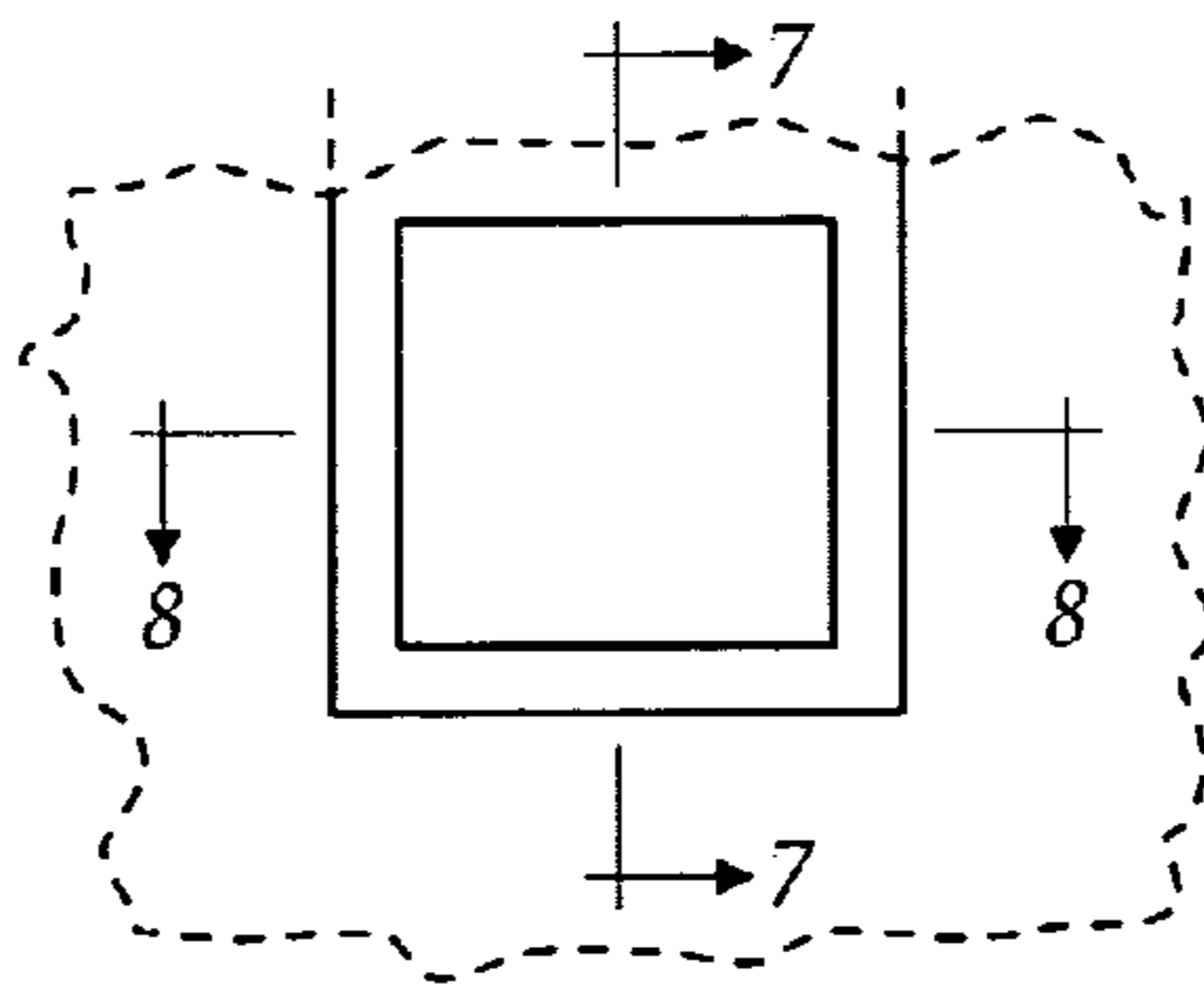

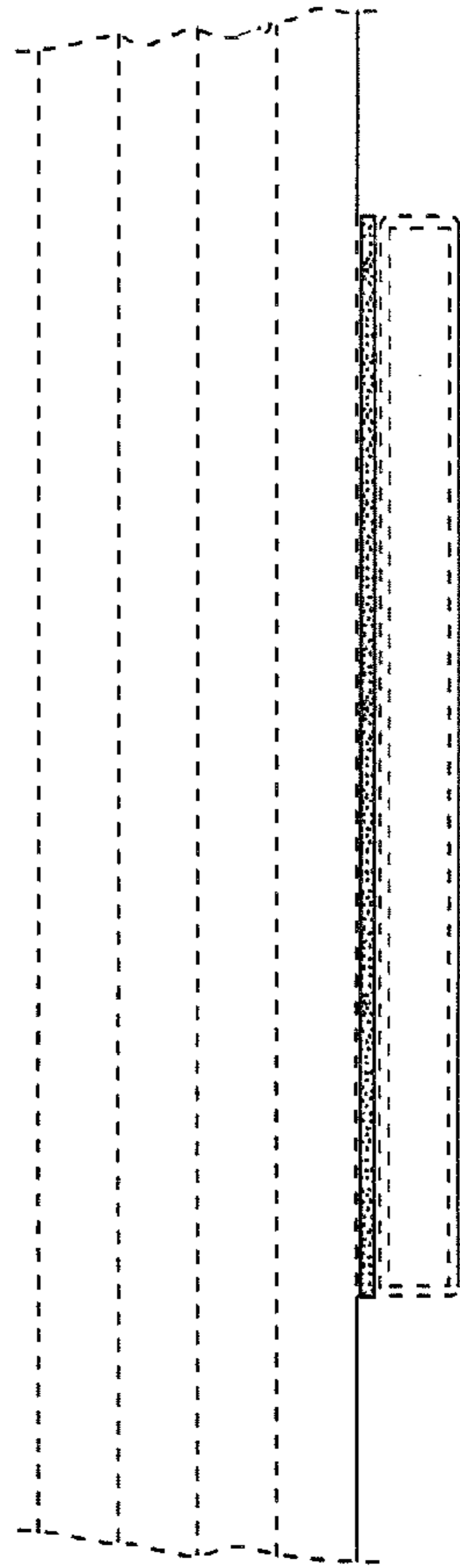
