The ornamental design for a foot stand for walking stick, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of a foot stand for walking stick showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

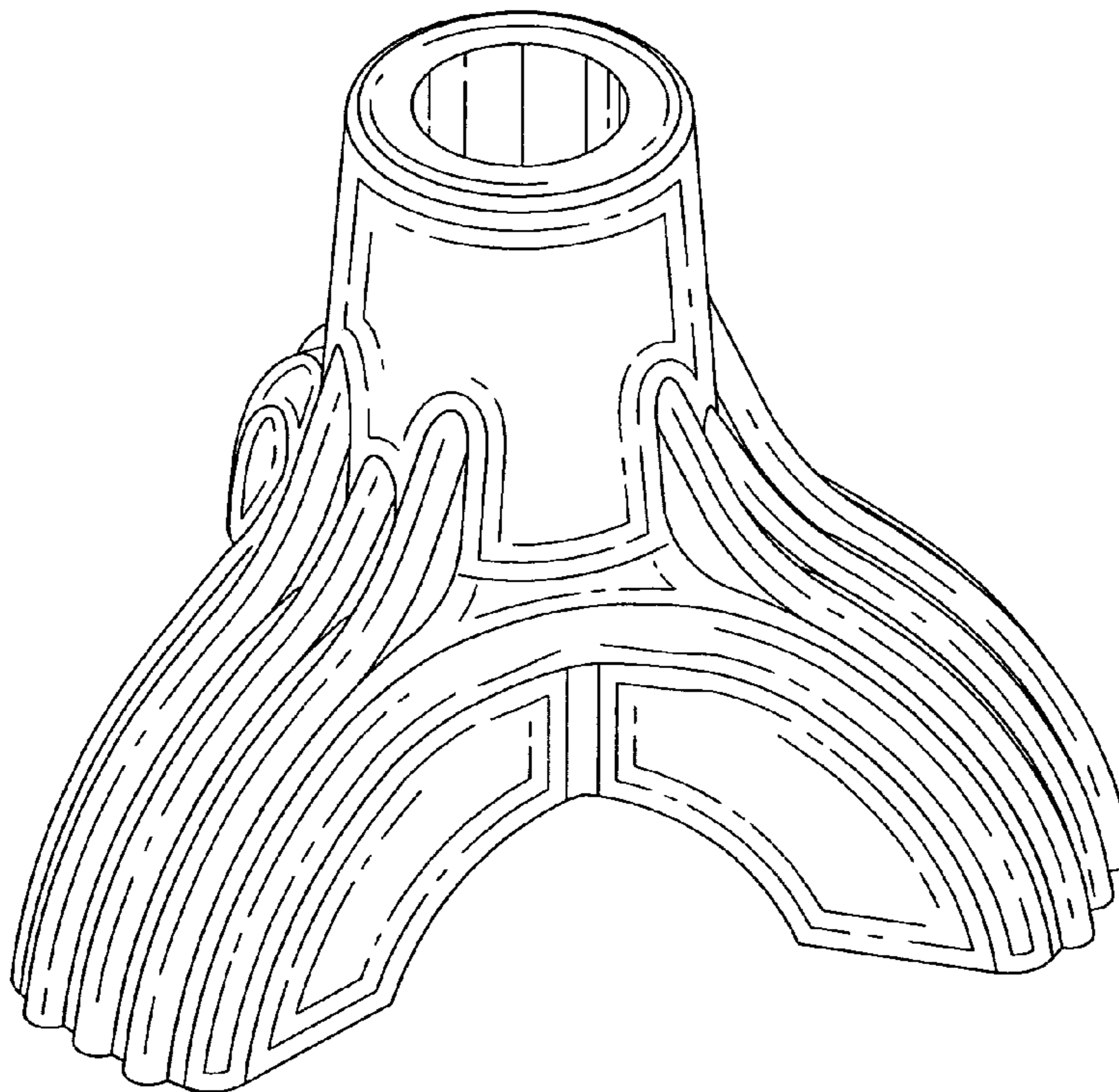
FIG. 6 is a top plan view thereof, the center circle depicted by means of broken lines being for illustrative purposes only and forming no part of the claimed design;

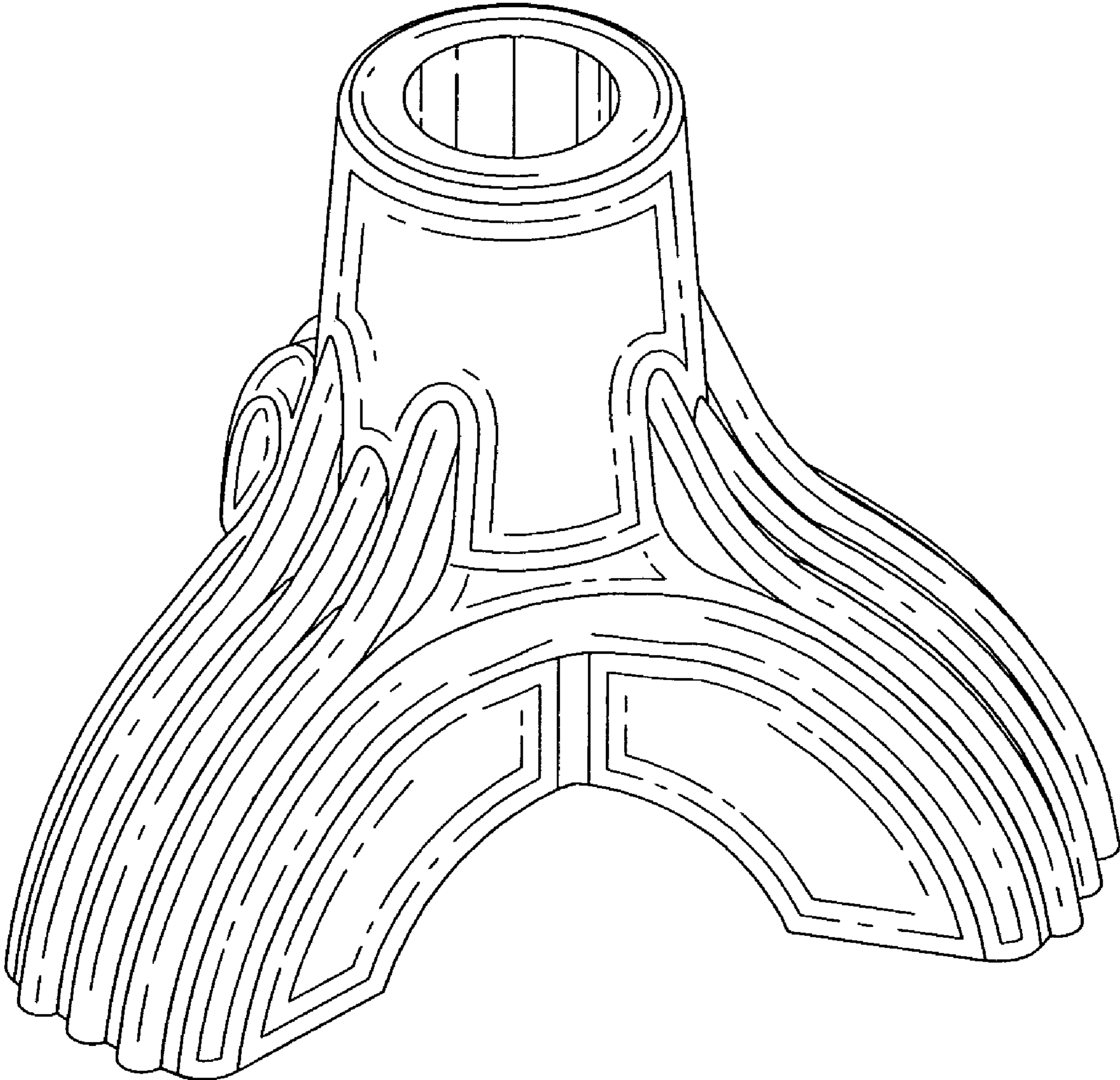

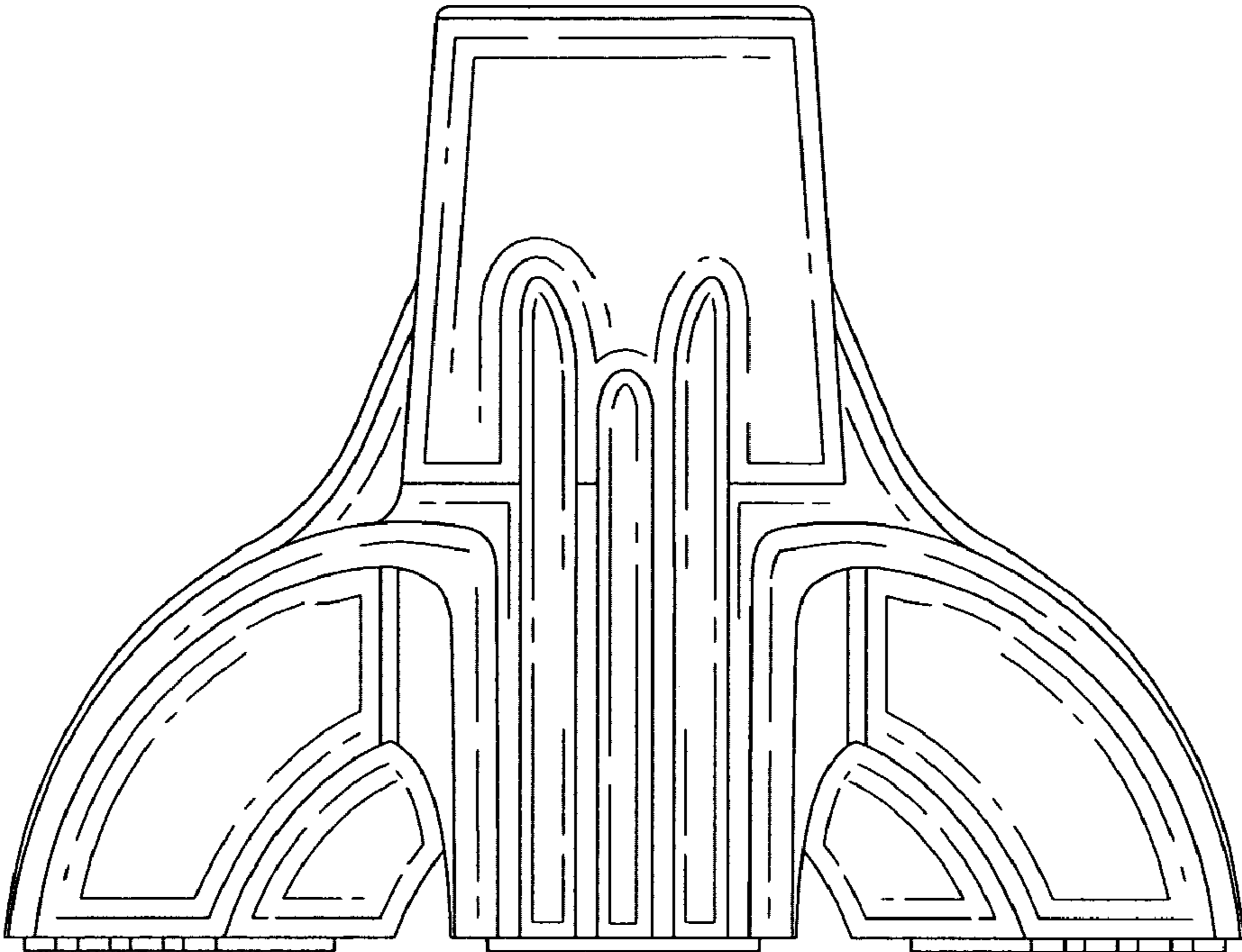

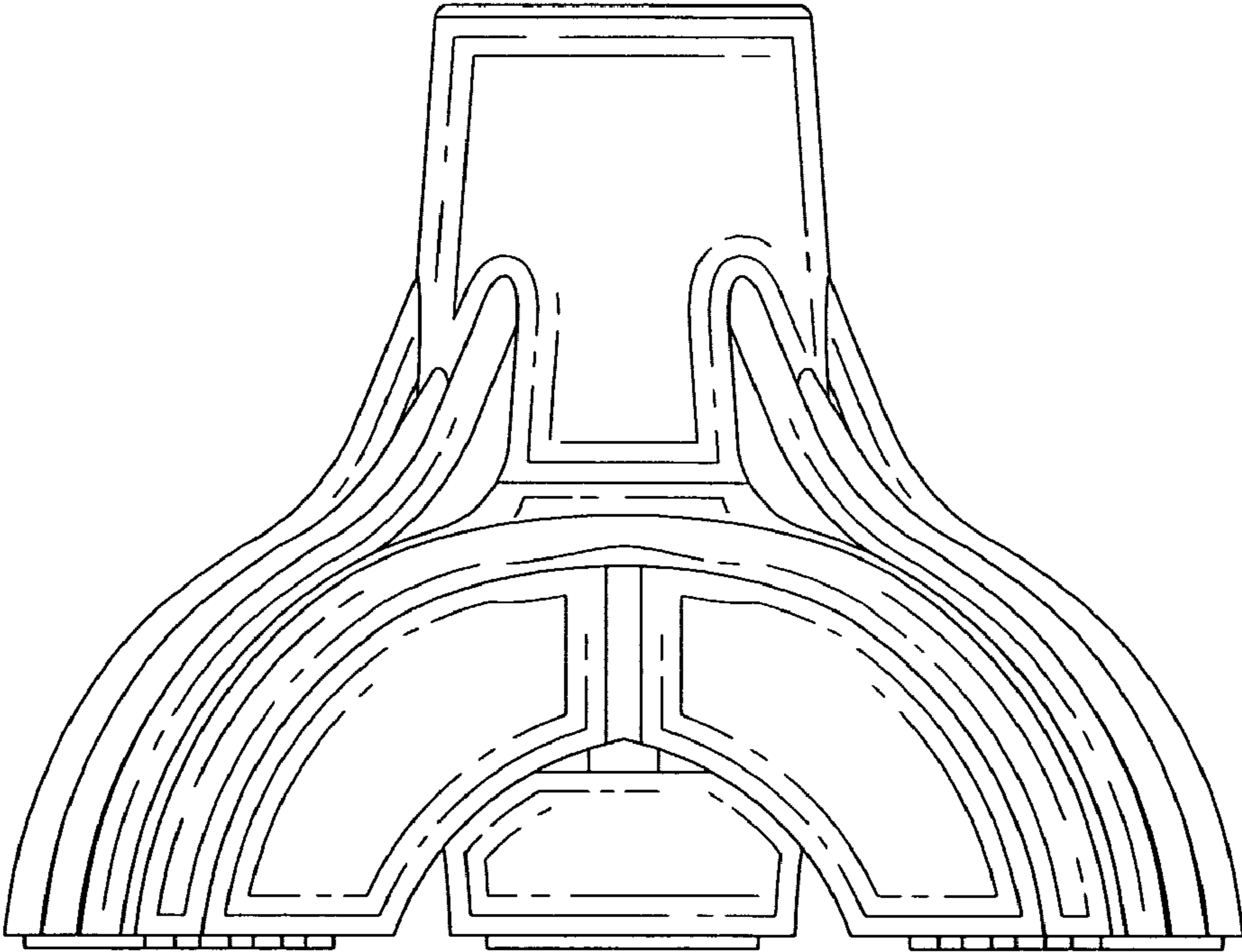

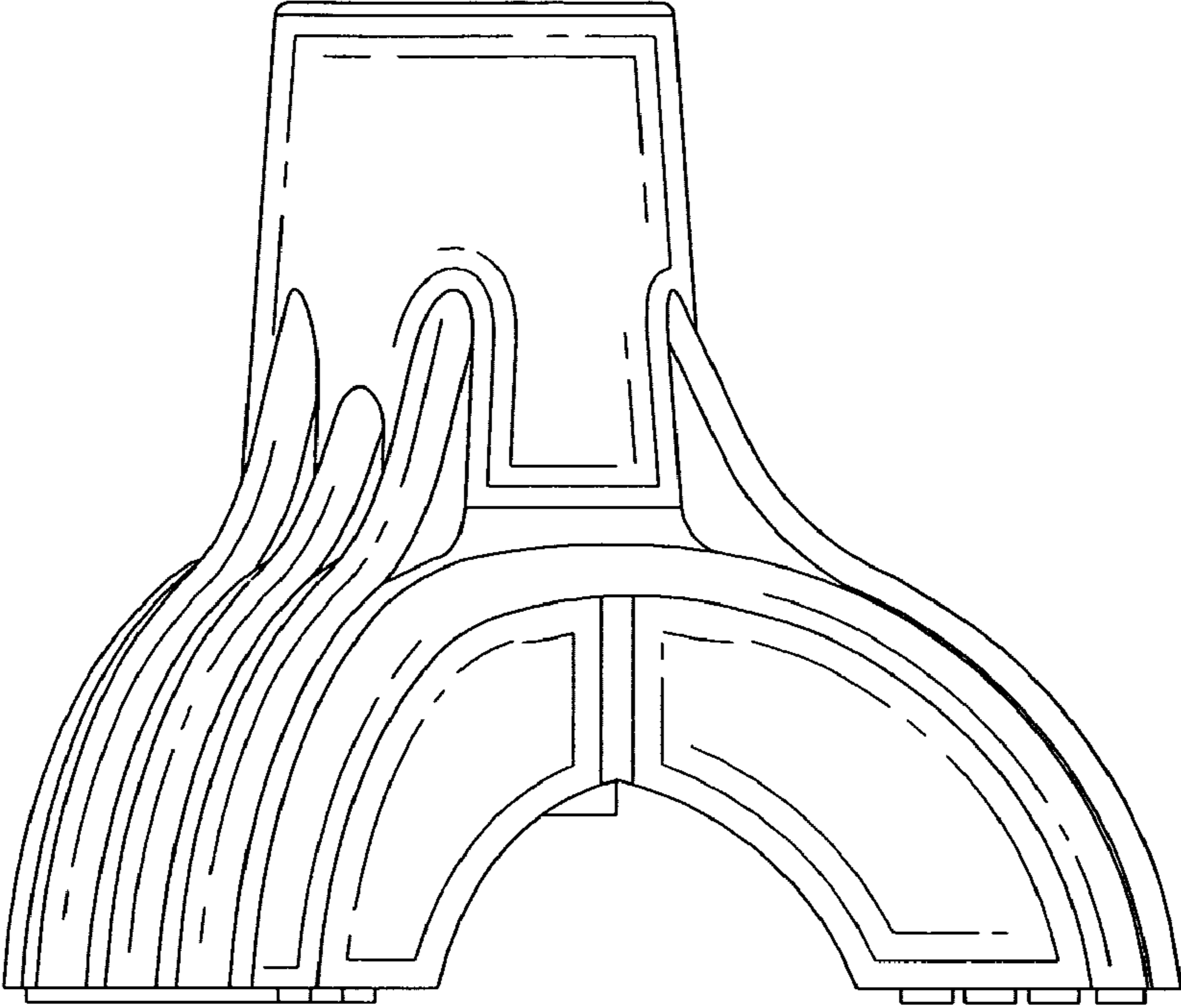

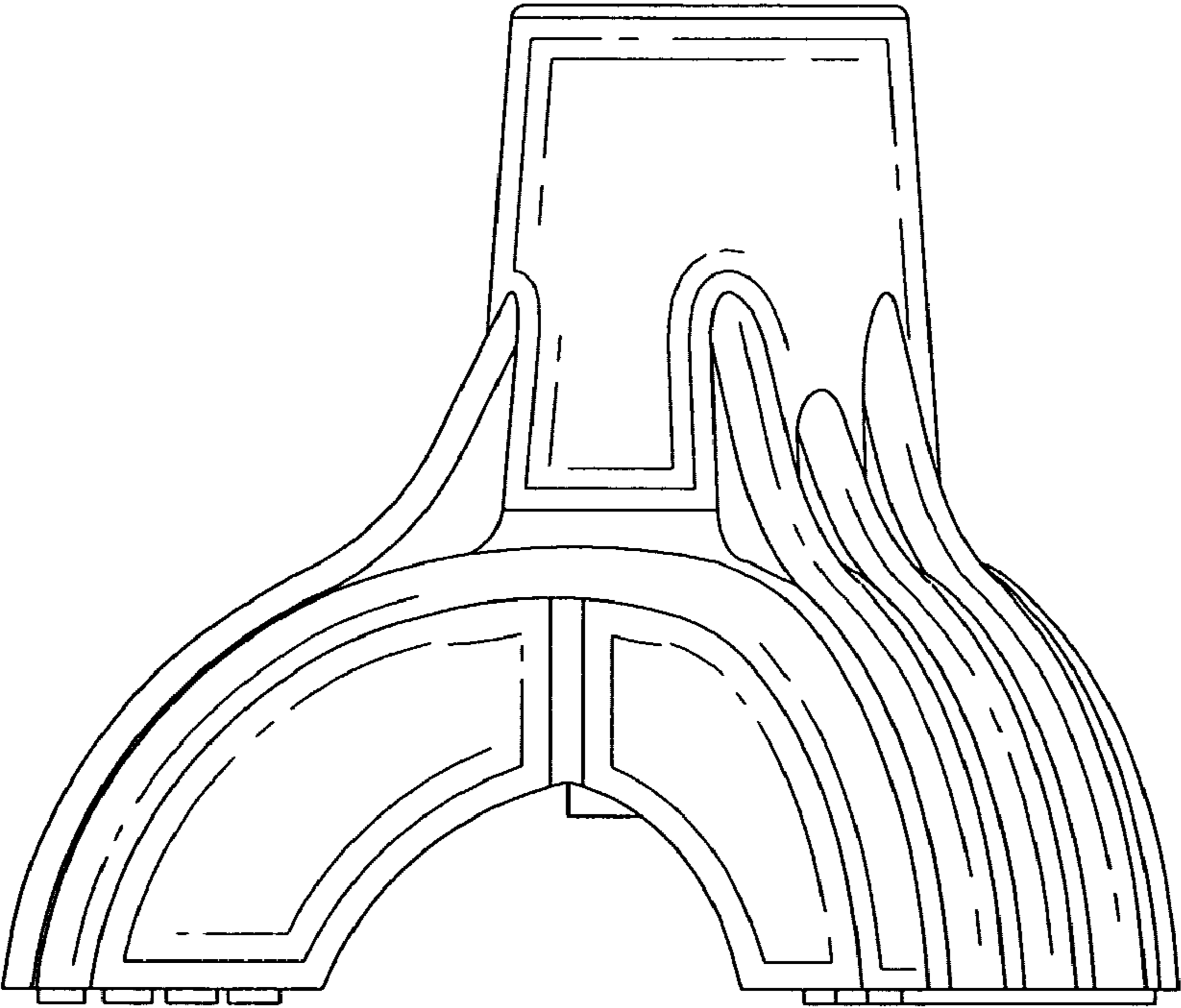

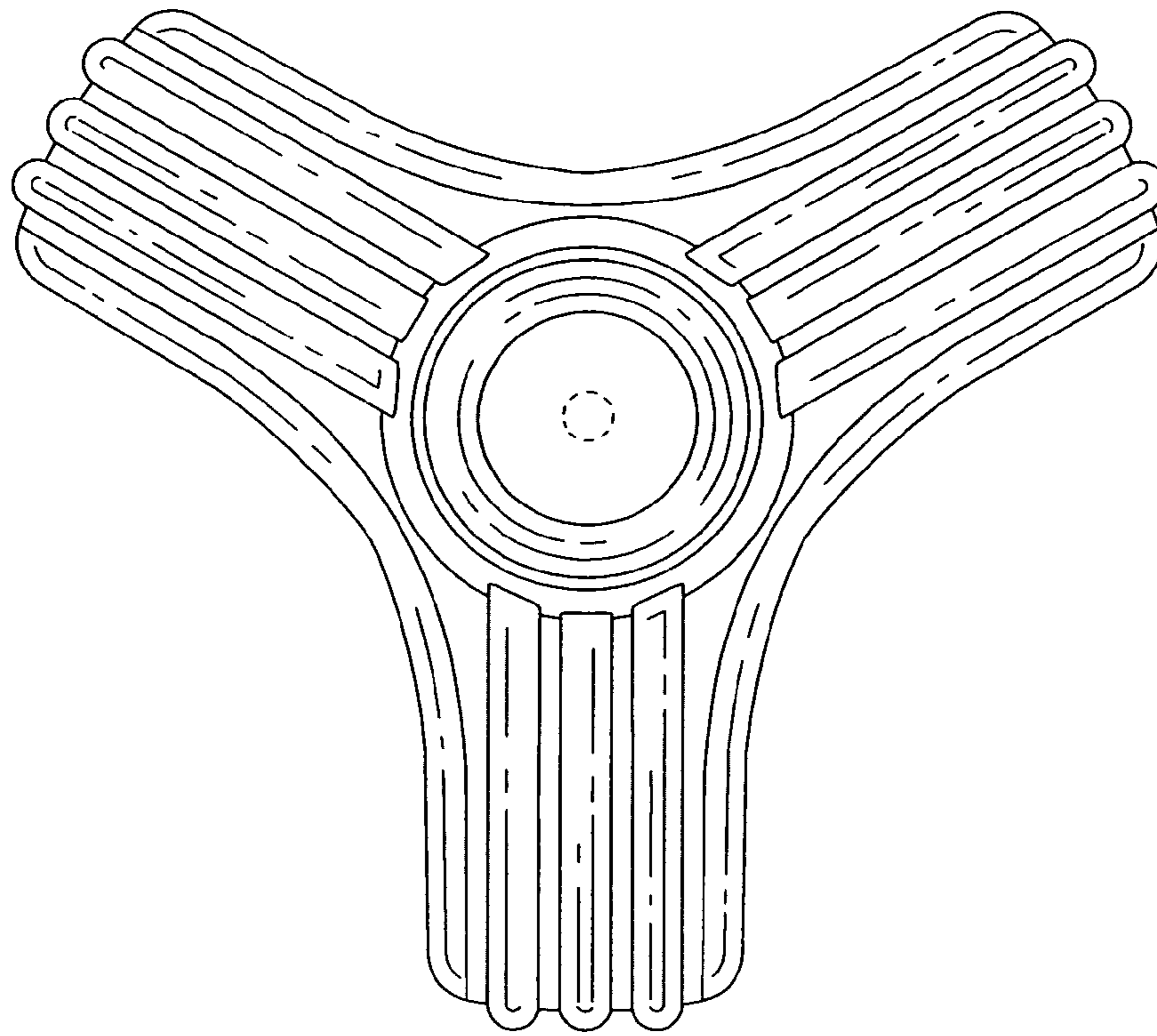

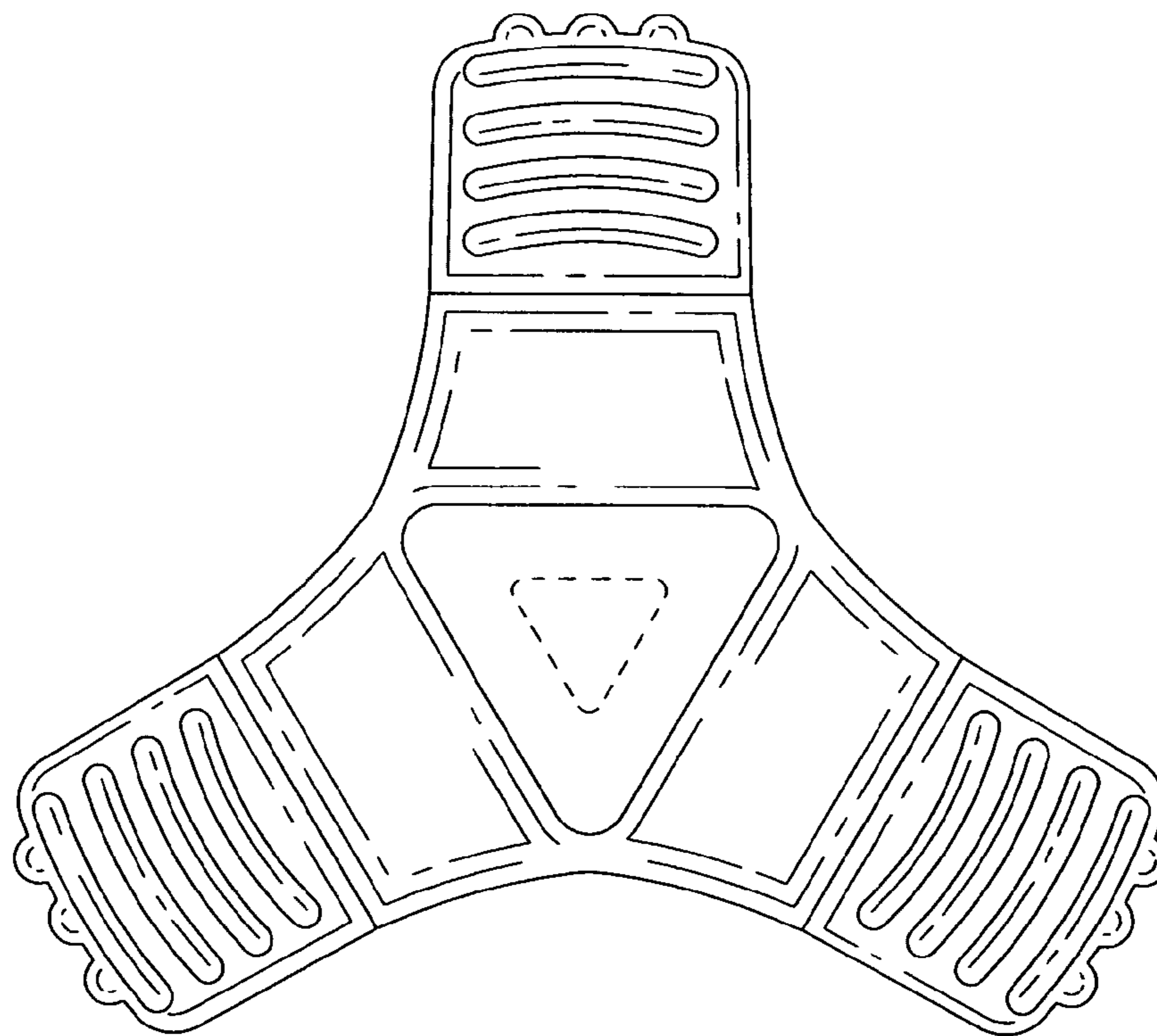

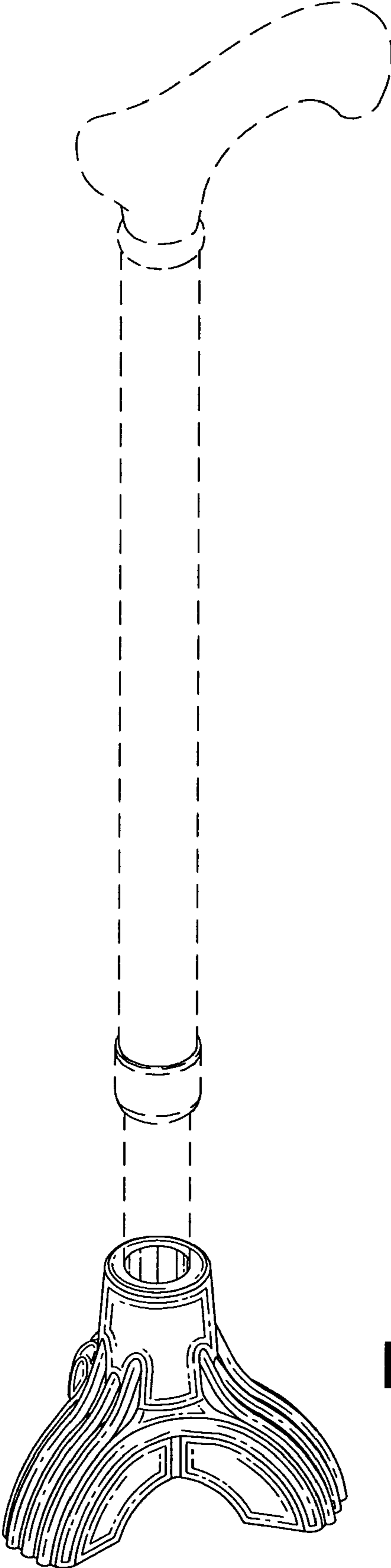

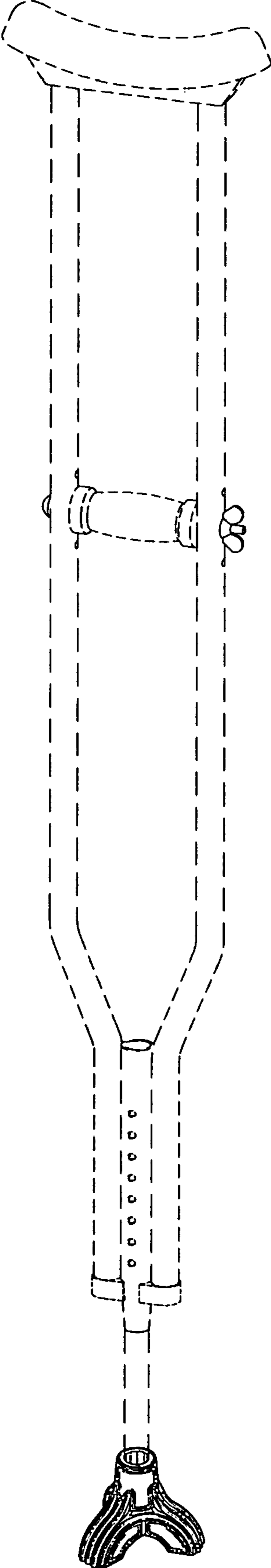
