The ornamental design for a laptop bag, as shown and
described.

DESCRIPTION

FIG. 1 is a photograph of a front side view of a laptop bag
according to the present invention;

FIG. 2 is a photograph of a left side view of the bag of FIG. 1;
FIG. 3 is a photograph of a right side view of the bag of FIG.
1;

FIG. 4 is a photograph of a top plan view of the bag of FIG. 1;
FIG. 5 is a photograph of a perspective view of the bag of FIG.
1 from above a rear side of the bag with a rear pocket in an
open position;

FIG. 6 is a photograph of a bottom plan view of the bag of
FIG. 1; and,

FIG. 7 is a photograph of a perspective view of the bag of FIG.
1 from above a front side of the bag with a front pocket in an
open position.

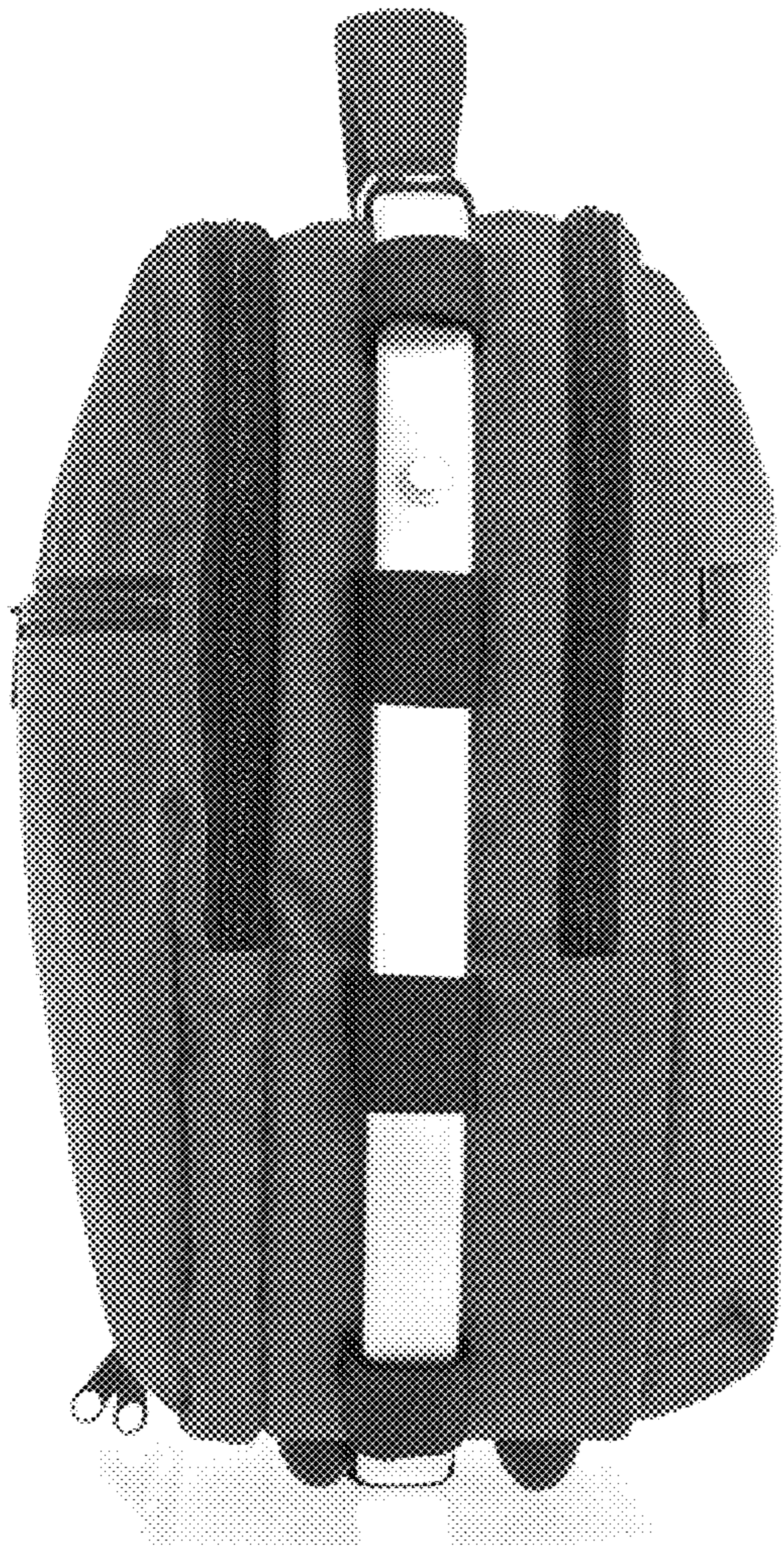

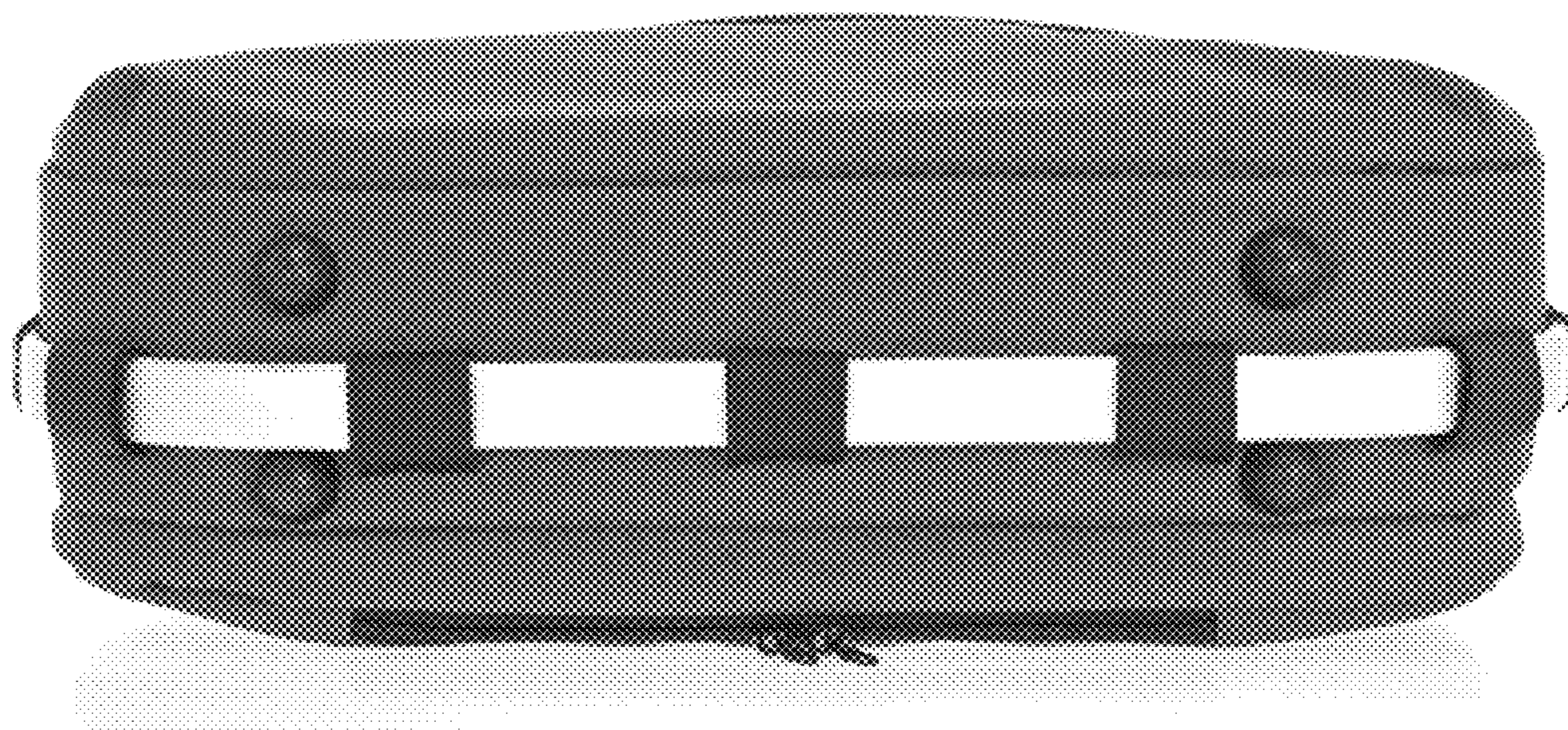
