(57) **CLAIM**

The ornamental design for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a chair from the front right side thereof, the perspective view from the front left side of the interior of the chair being a mirror image thereof;

FIG. 2 is a perspective view of a chair from the rear right side thereof, the perspective view from the rear left side interior being a mirror image thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

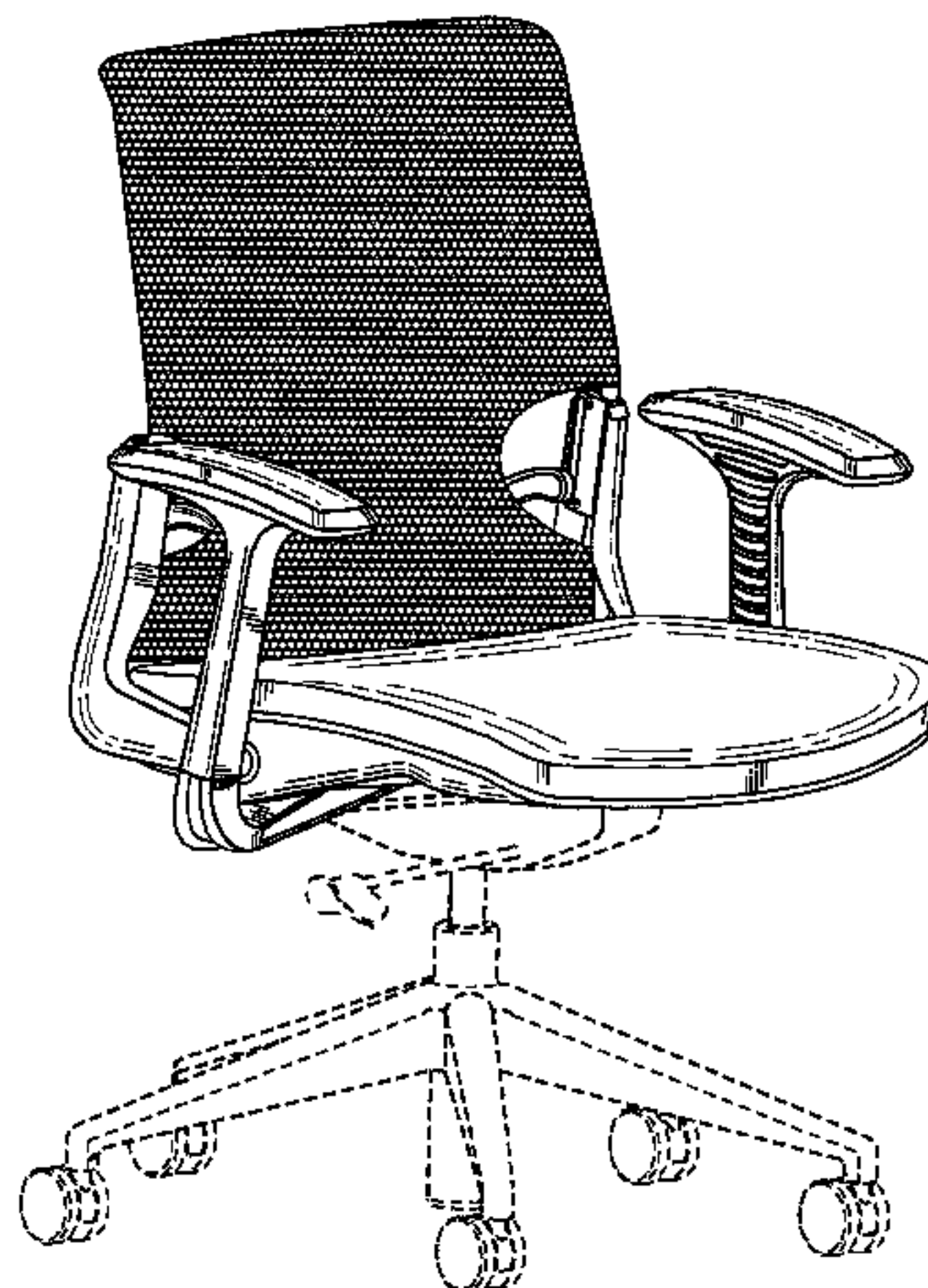
FIG. 6 is a right side view thereof; and,

FIG. 7 is a top view thereof.

The bottom view of the chair does not form part of the design.

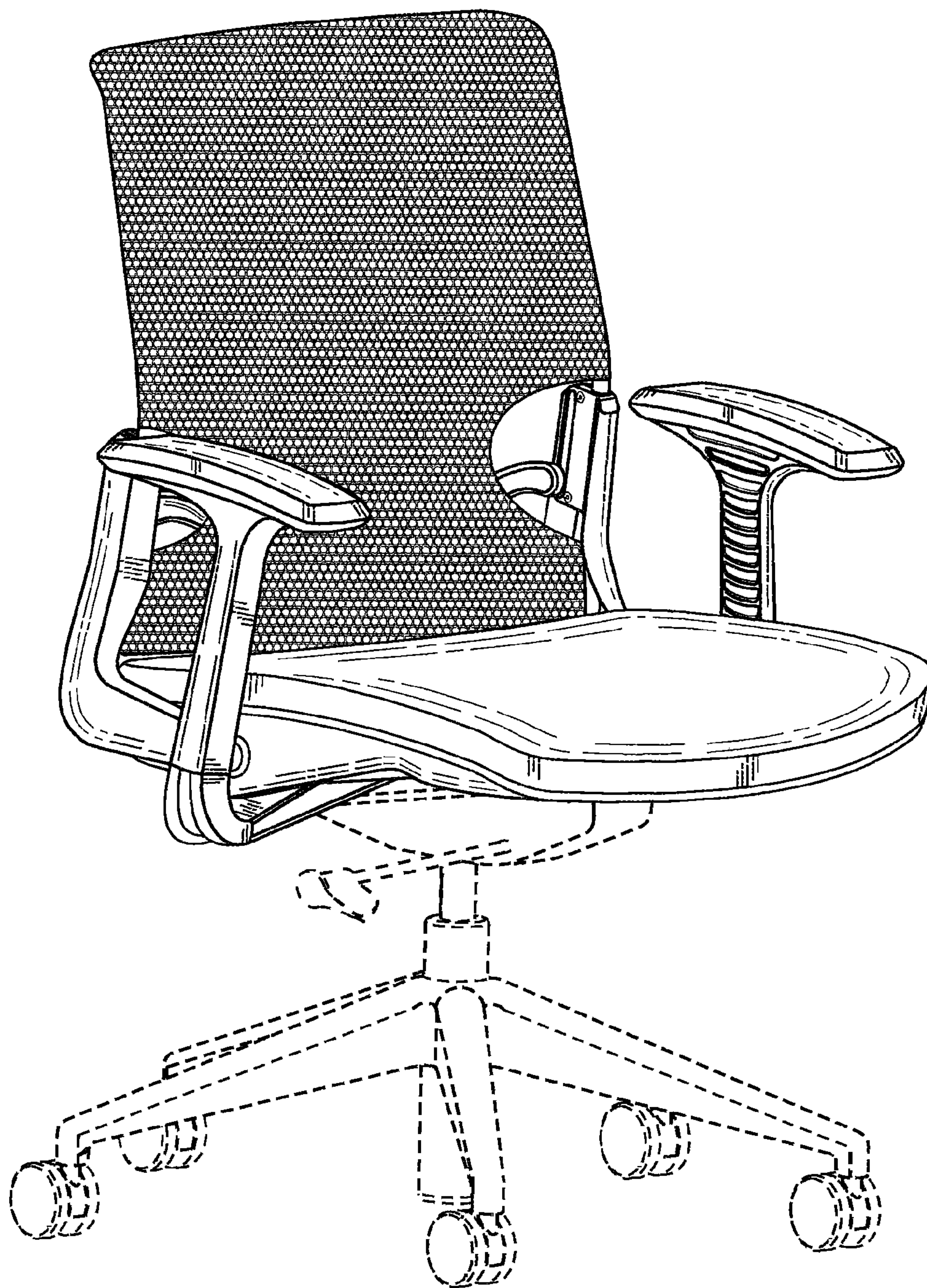

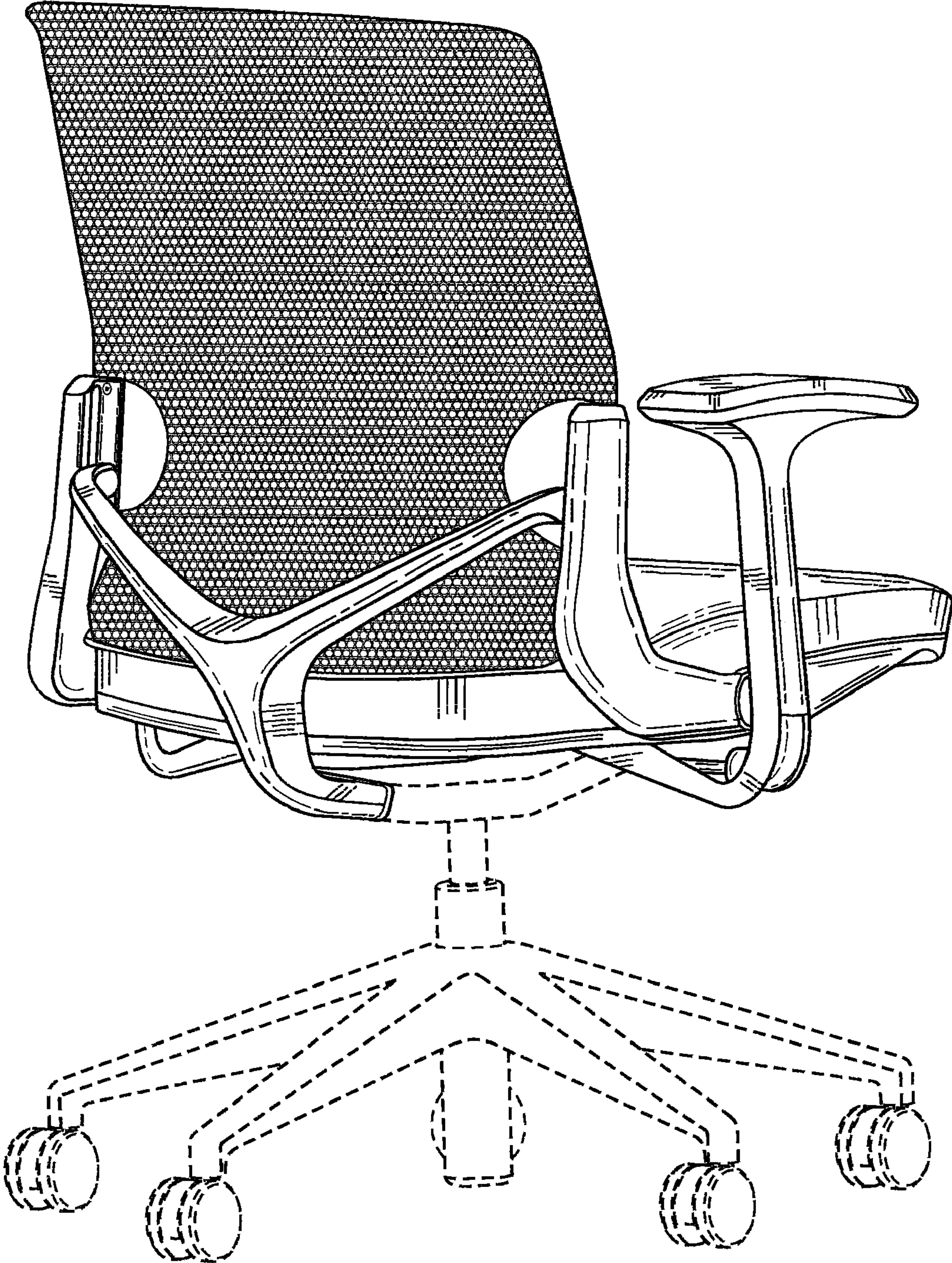

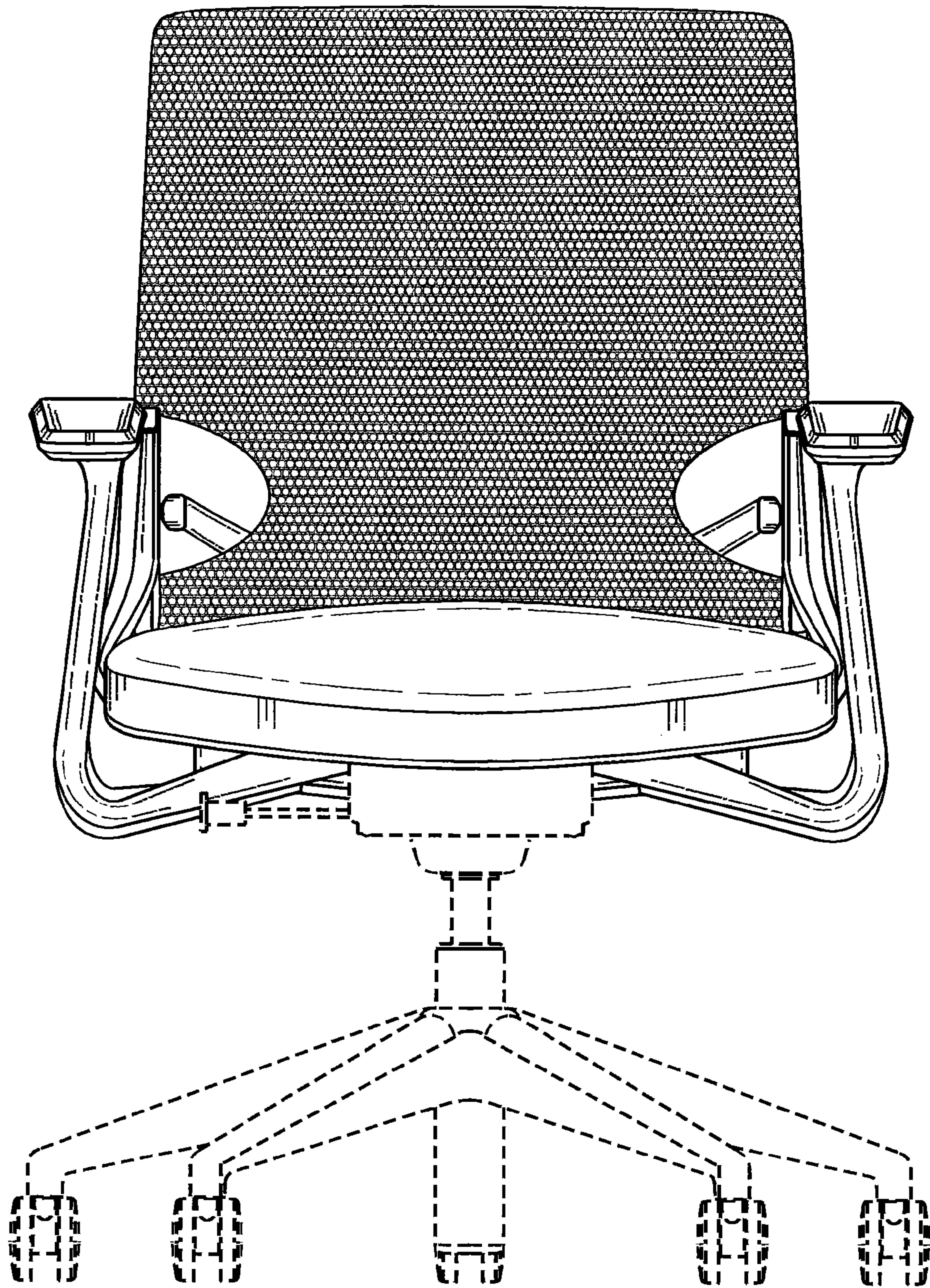

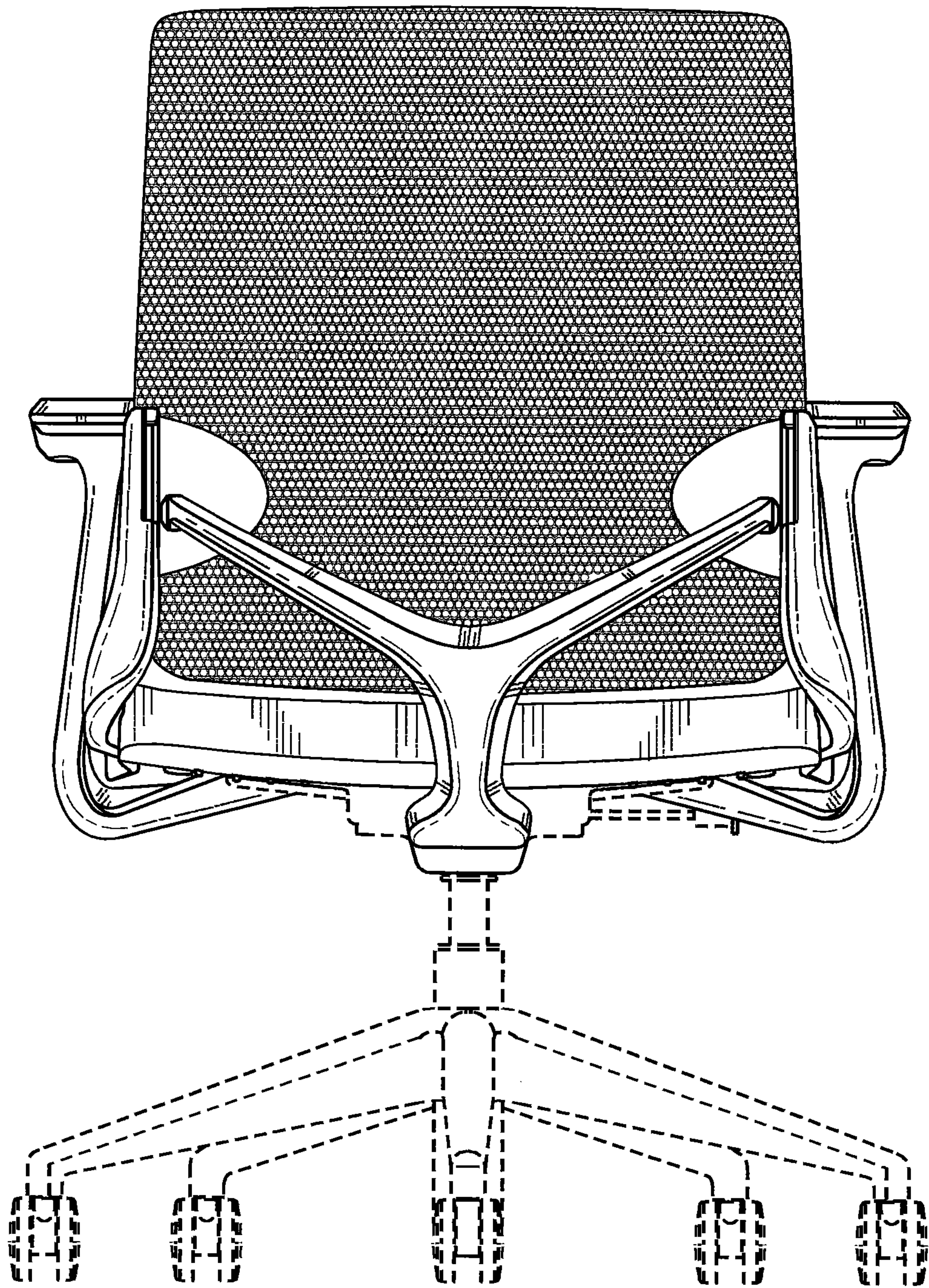

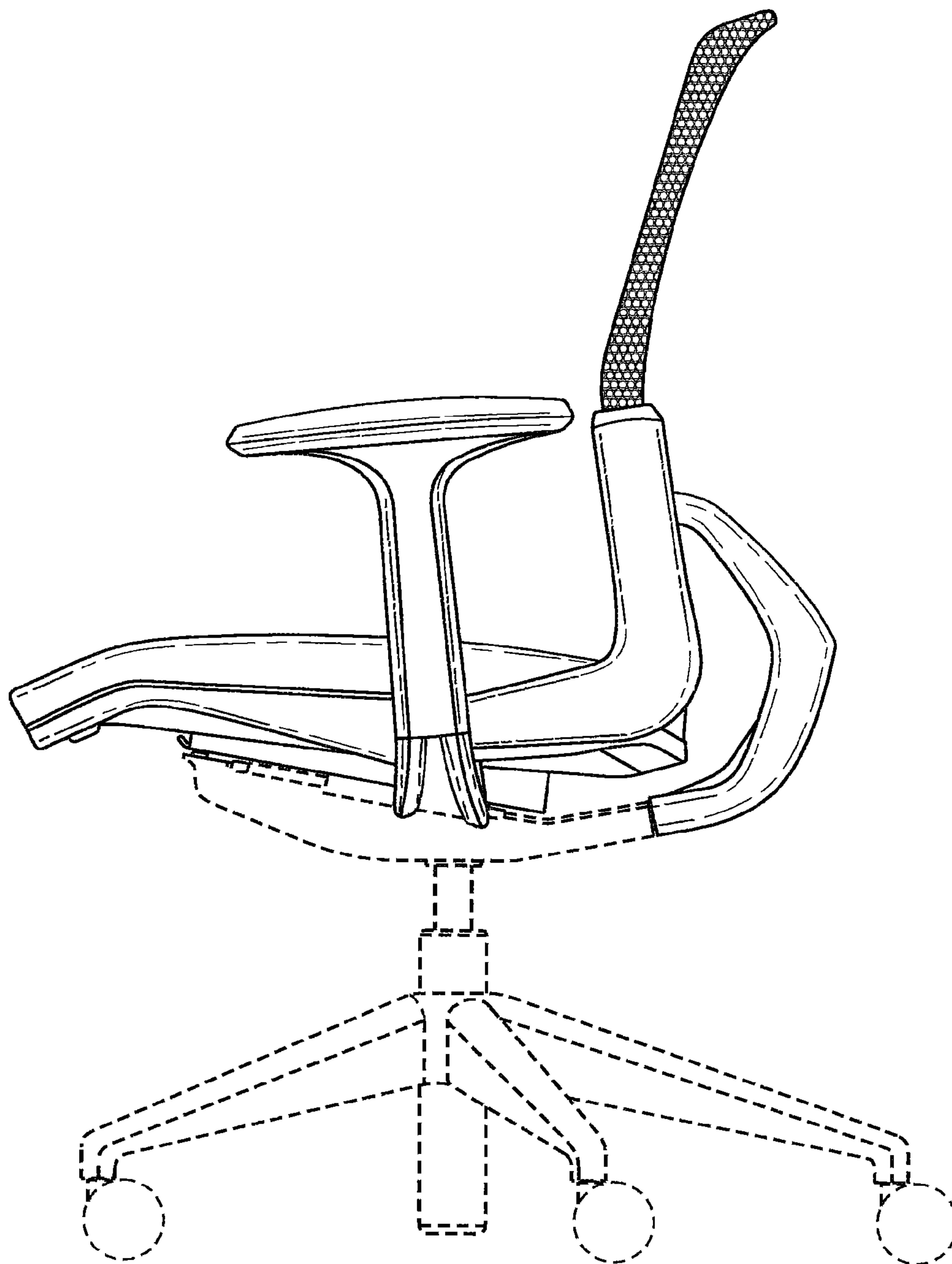

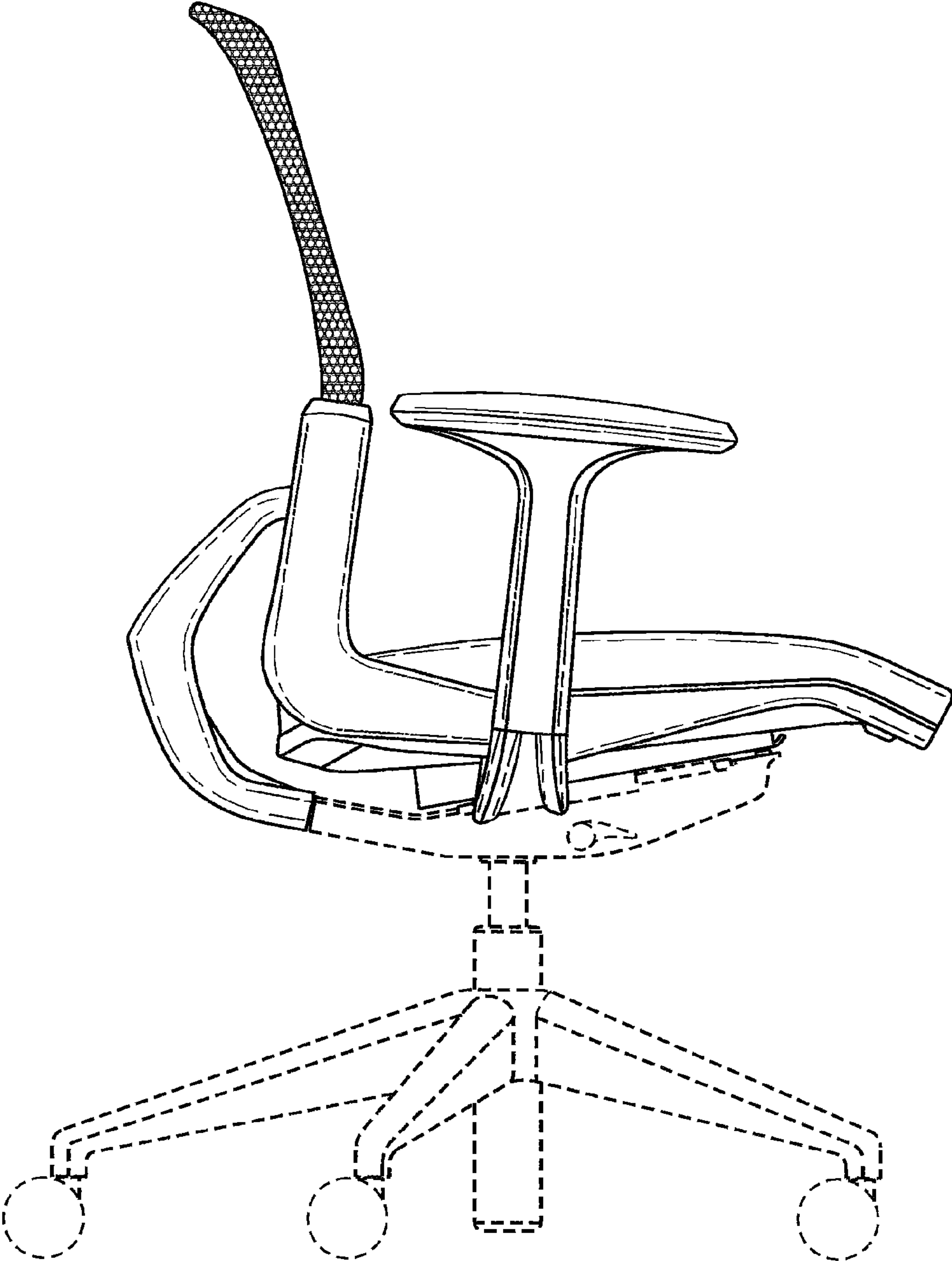

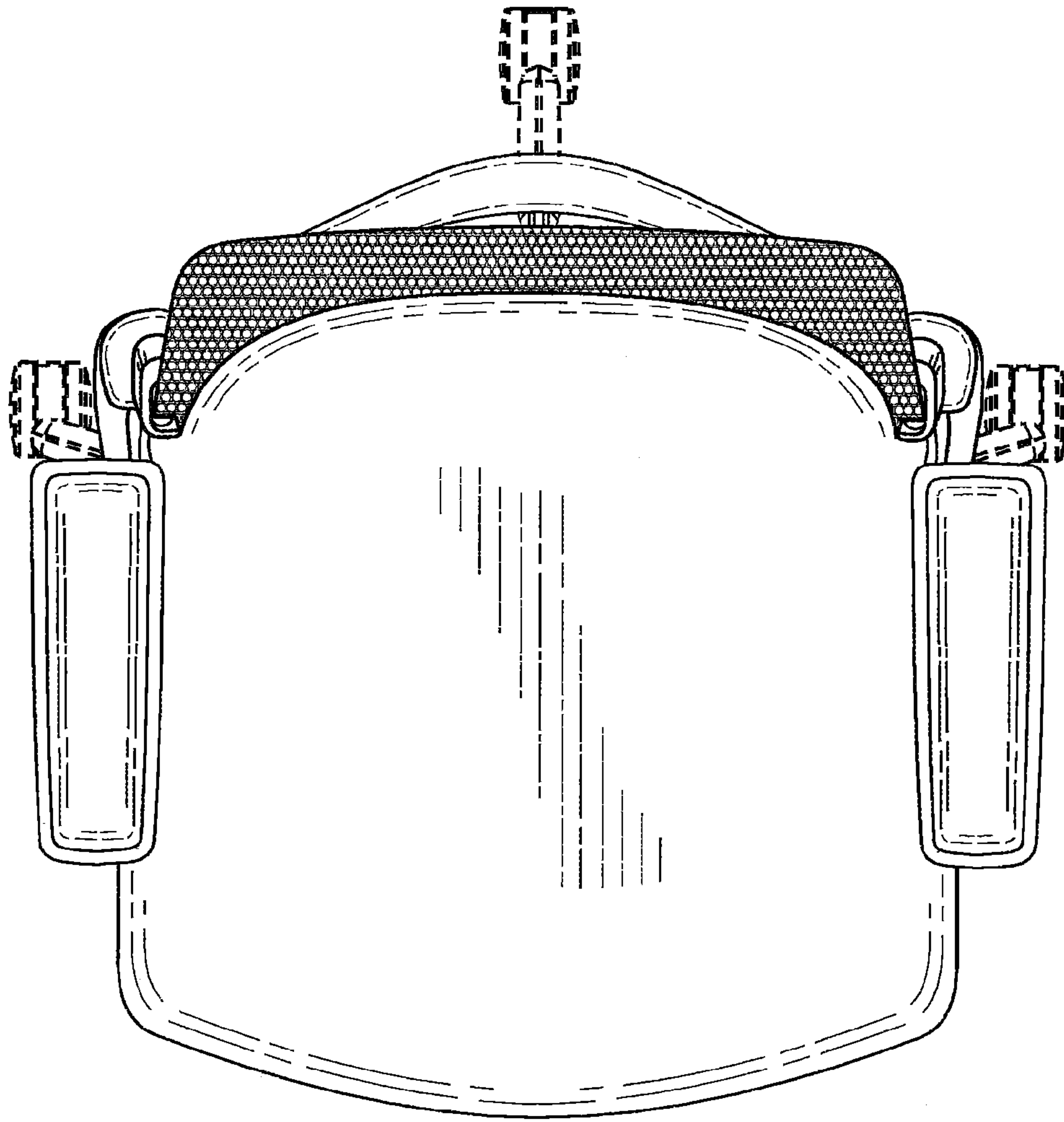
