The ornamental design for a tool handle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tool handle embodying the design of the present invention;

FIG. 2 is a left side view of the tool handle illustrated in FIG. 1;

FIG. 3 is a right side view of the tool handle illustrated in FIG. 1;

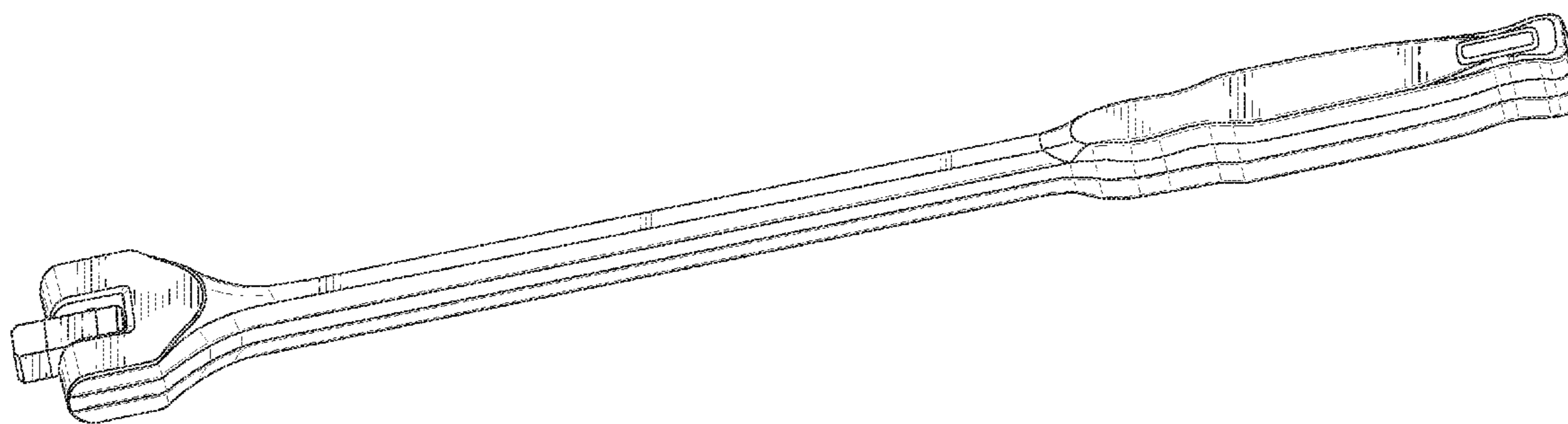
FIG. 4 is an end view of the tool handle illustrated in FIG. 1;

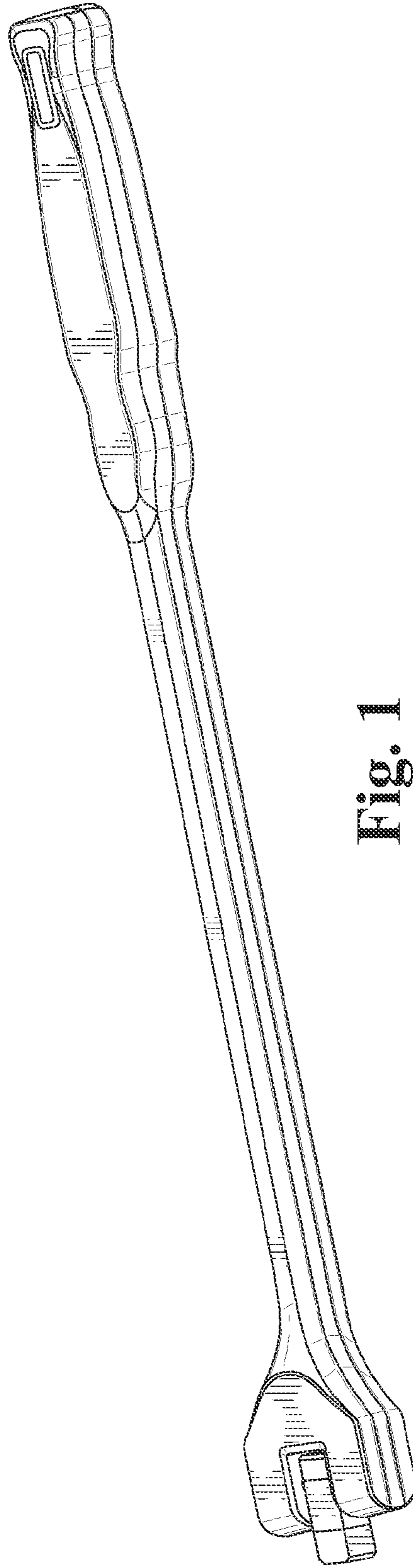

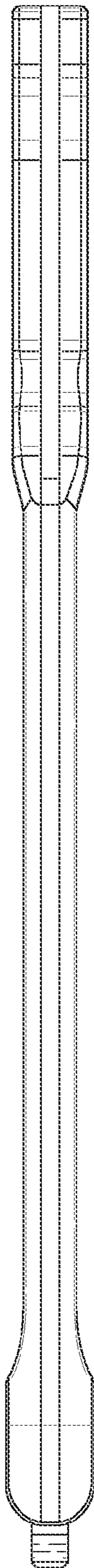

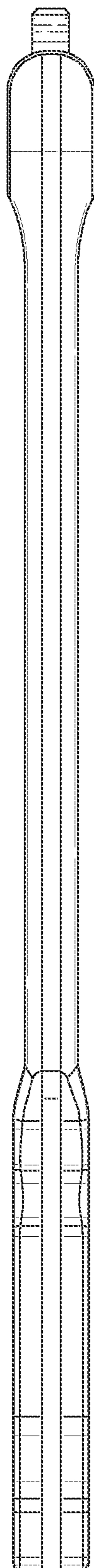

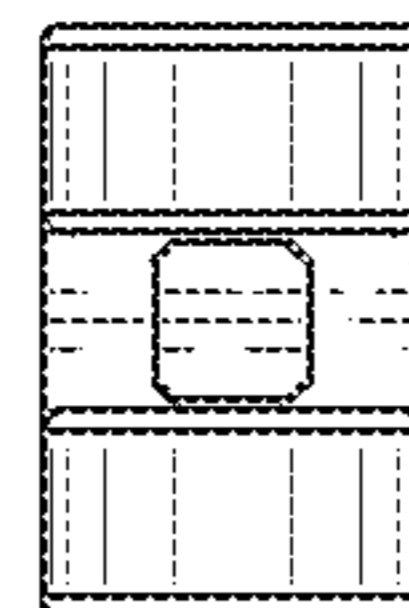

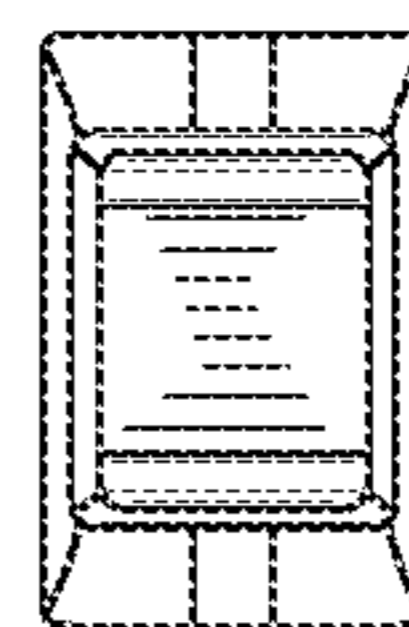

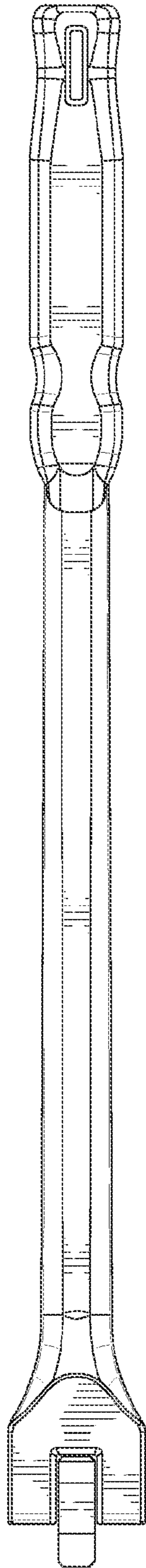

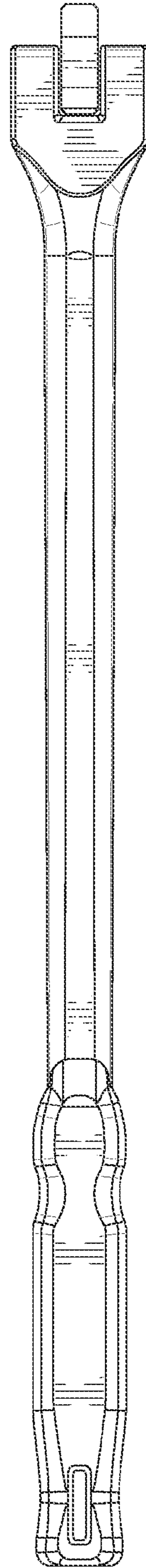
