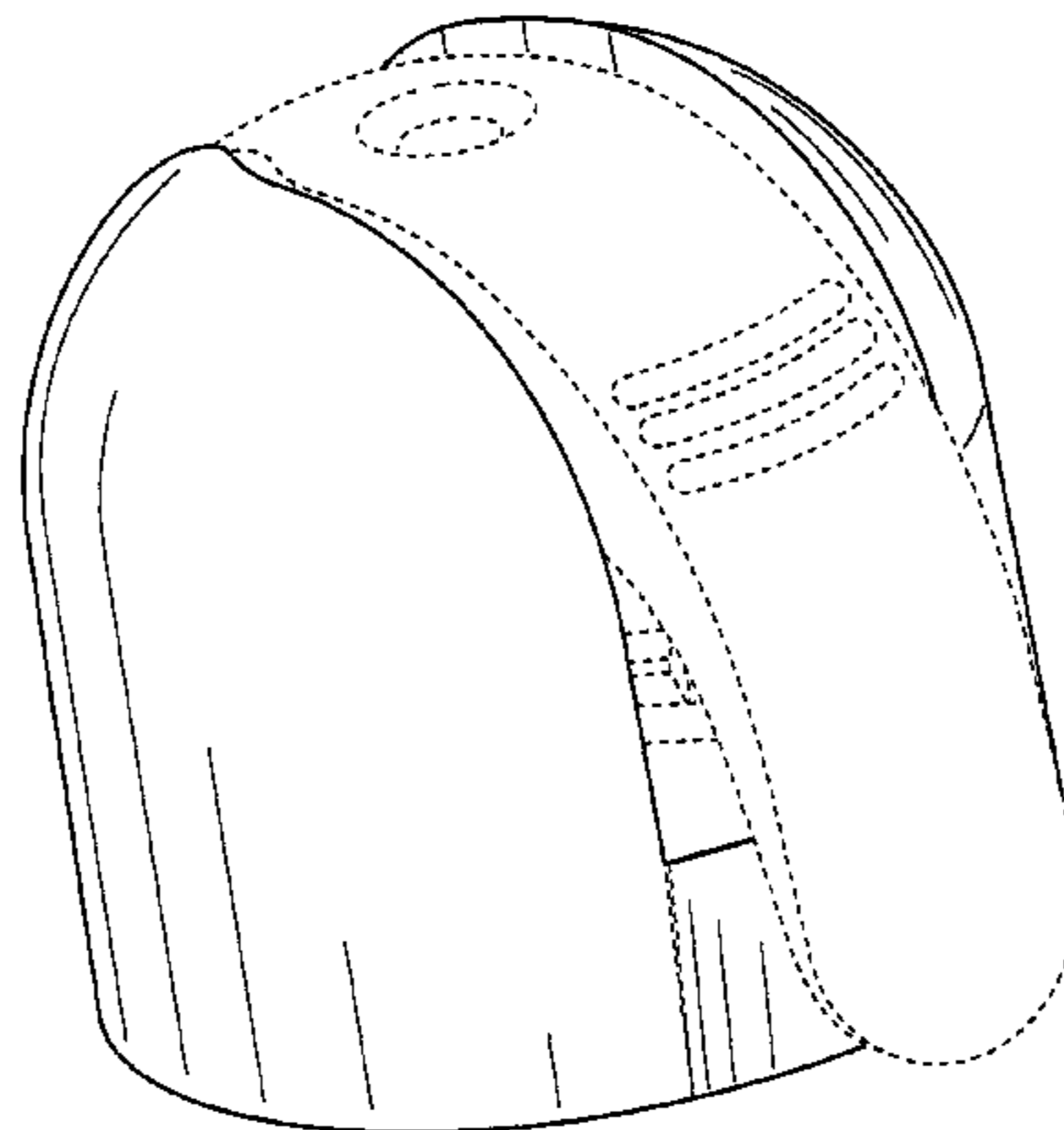

FIG. 7 is a bottom elevational view of the overcap of FIG. 1.

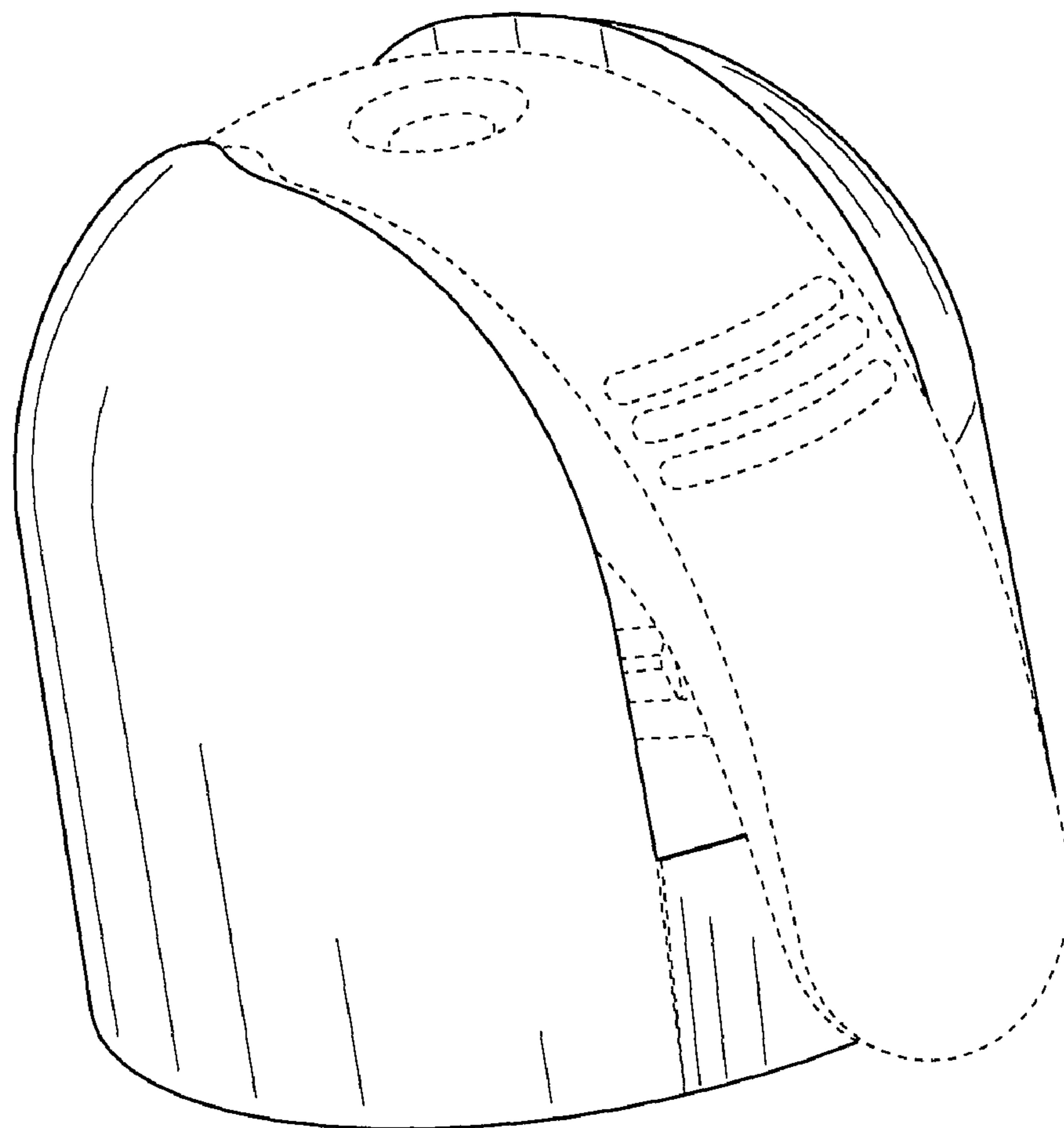

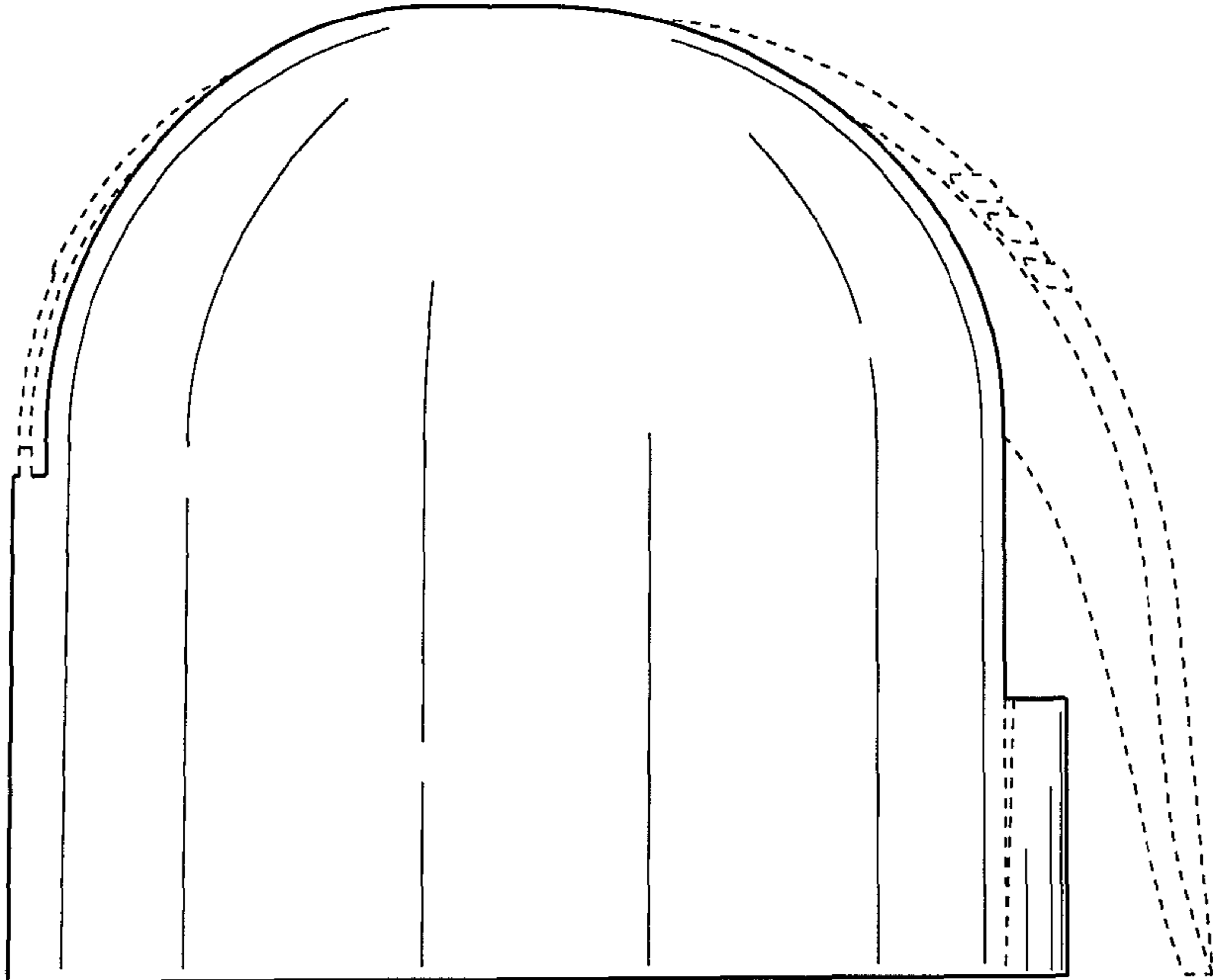

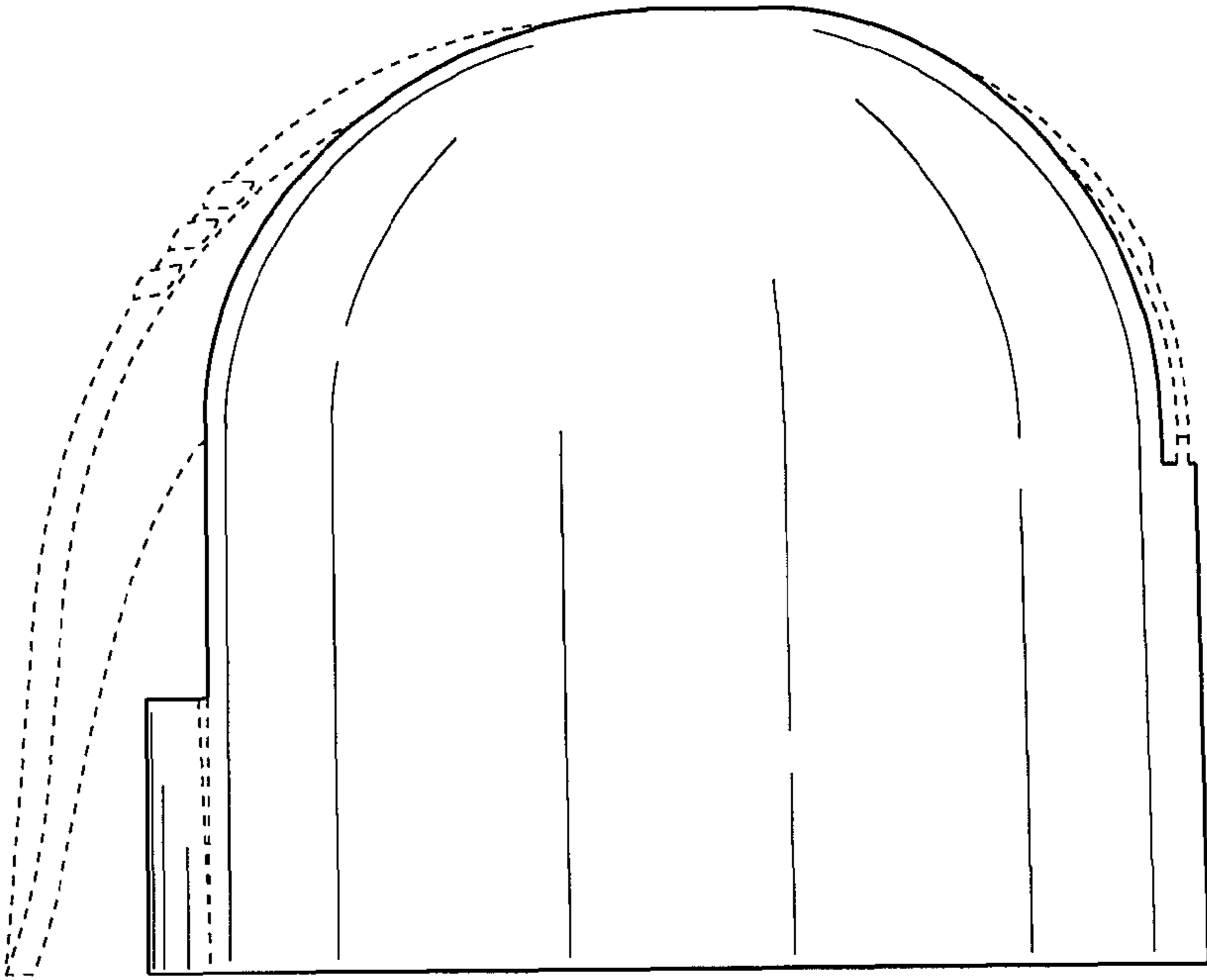

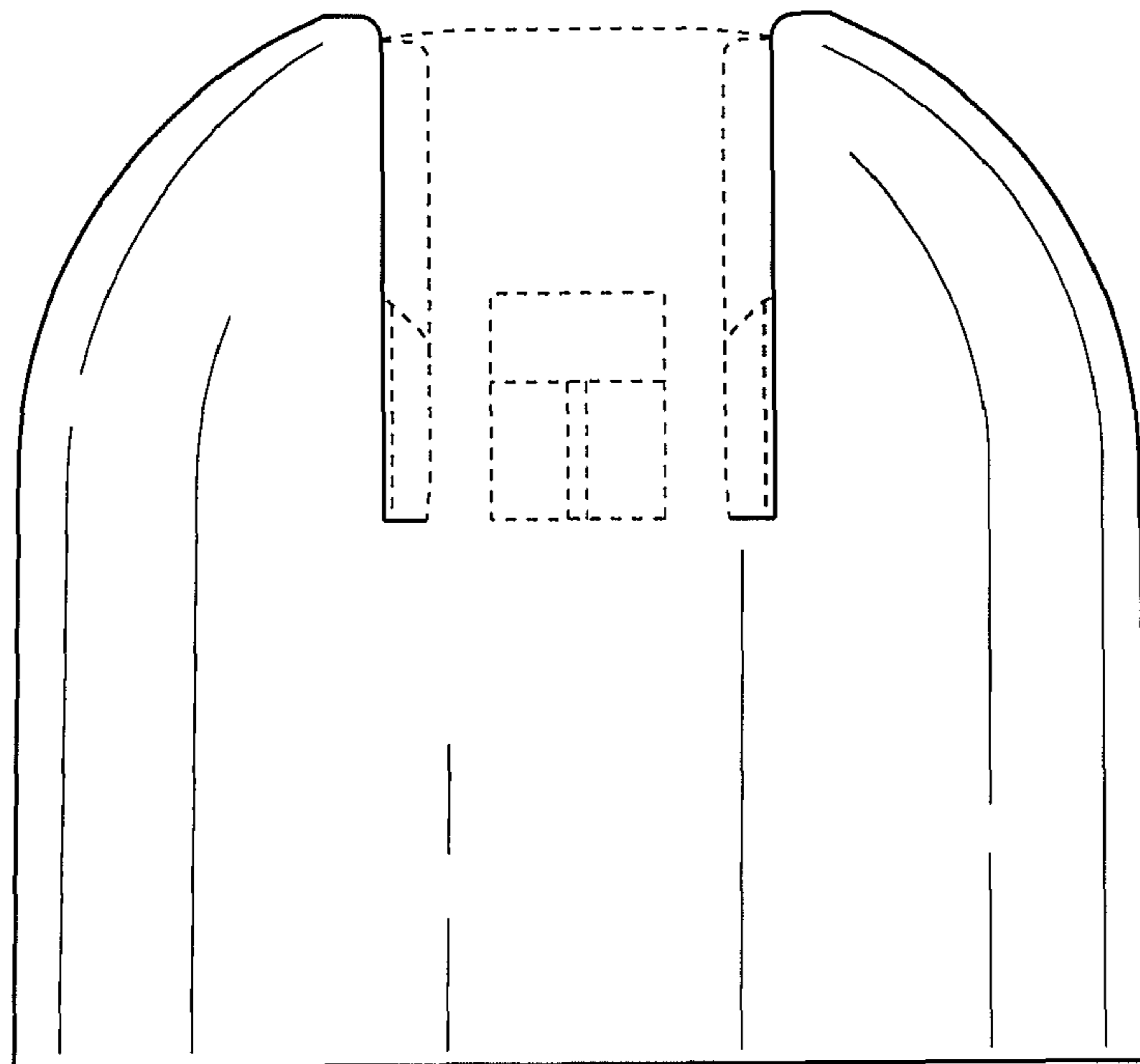

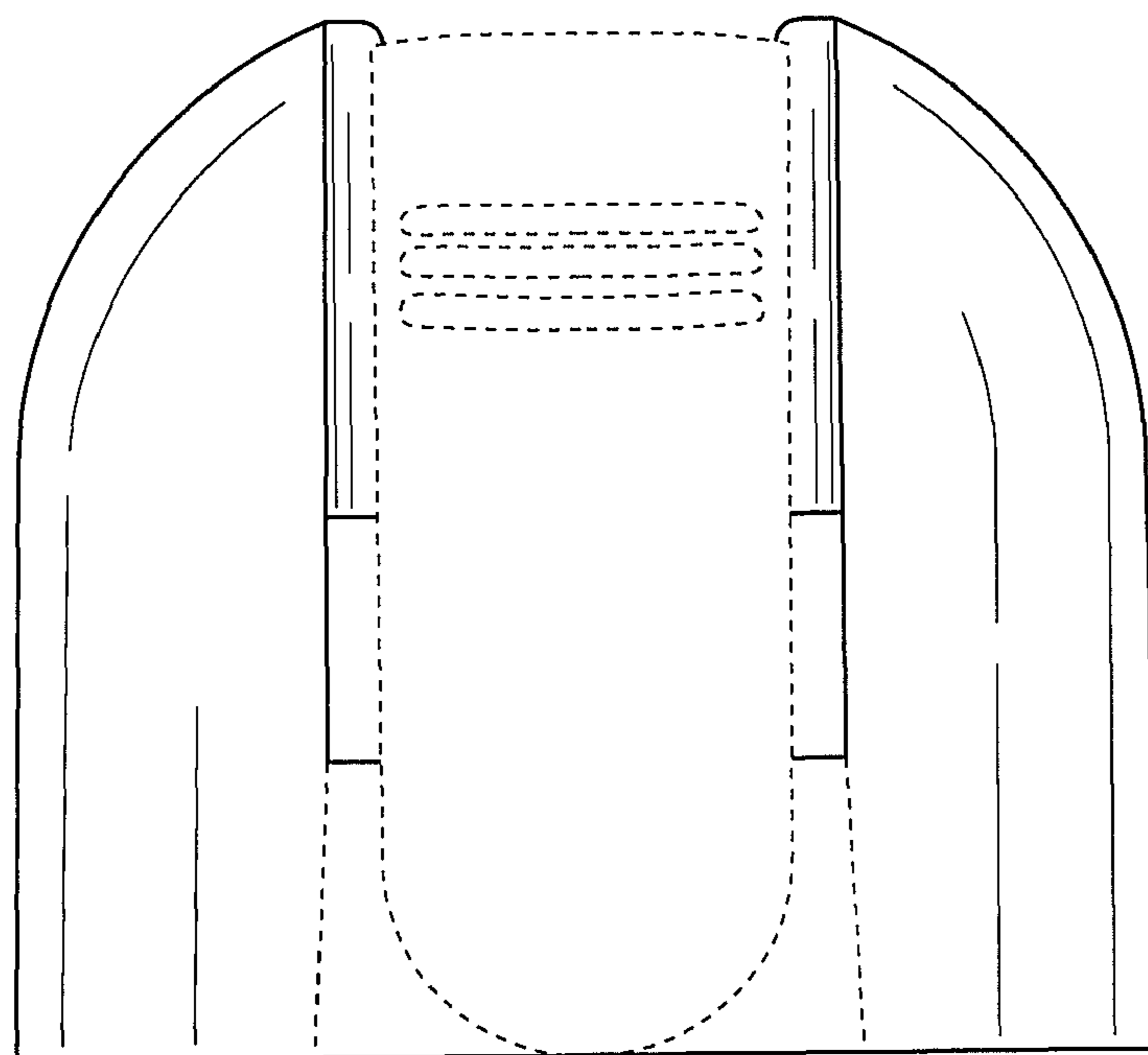

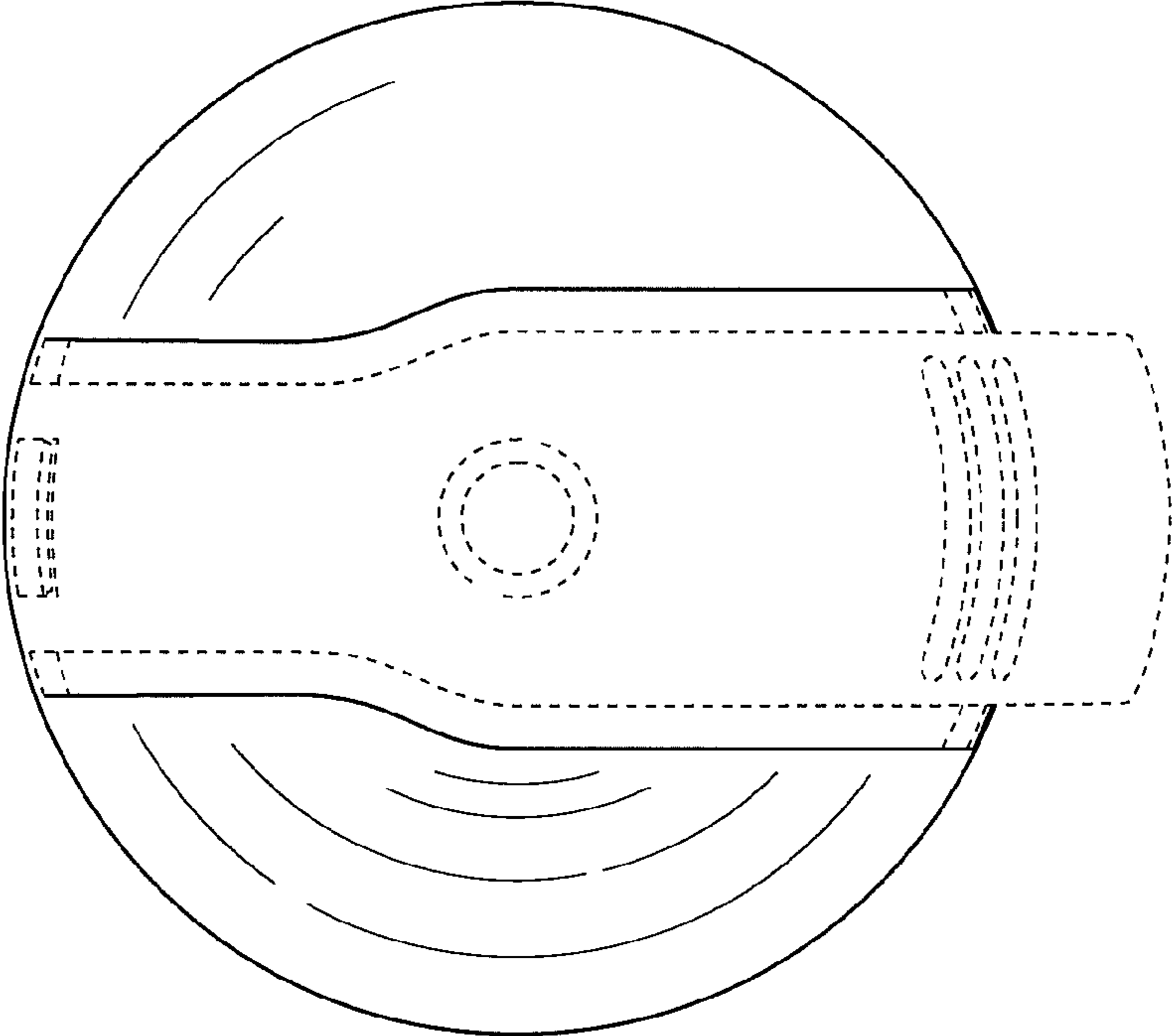

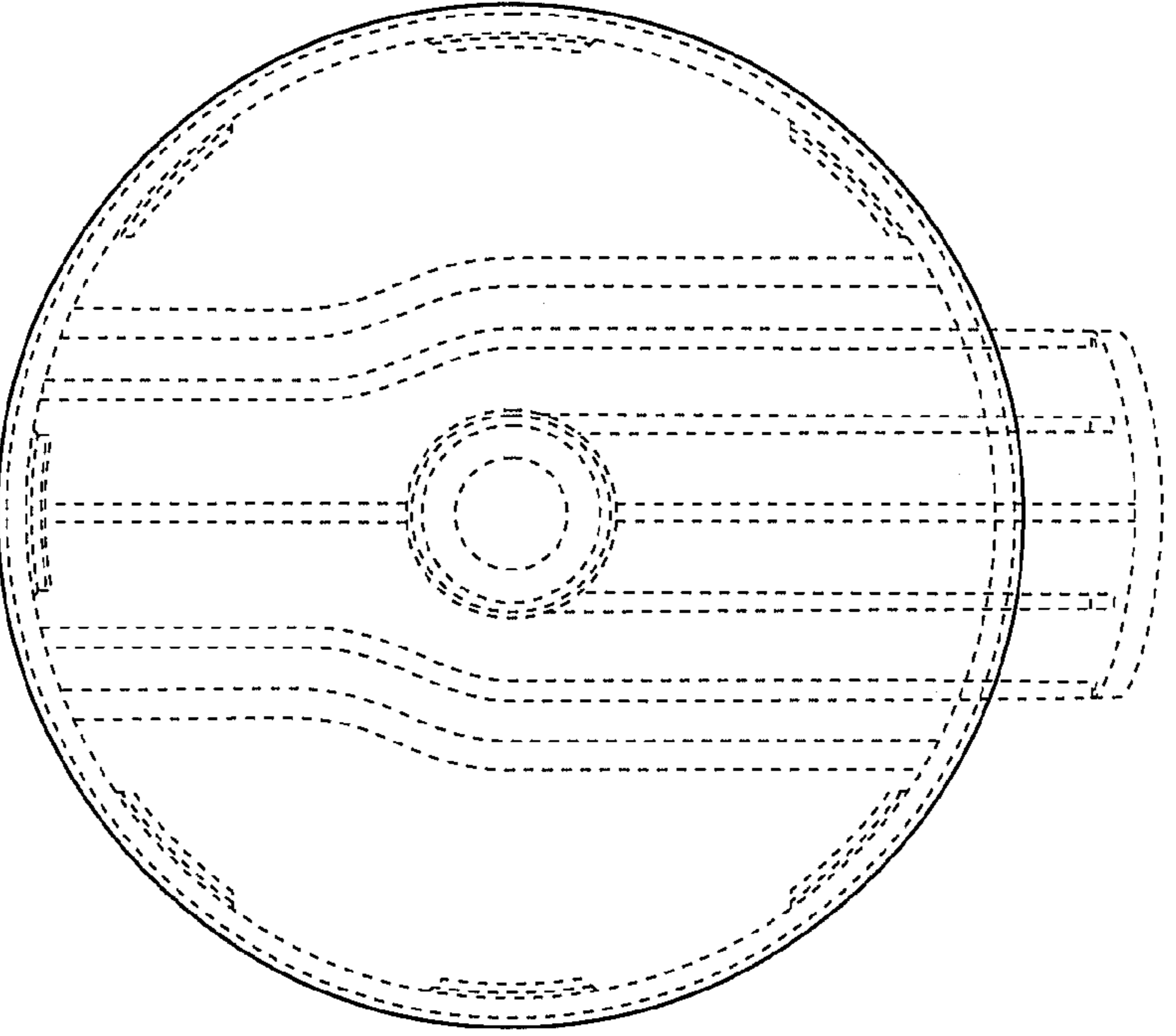
