FIG. 3 is a front view thereof.

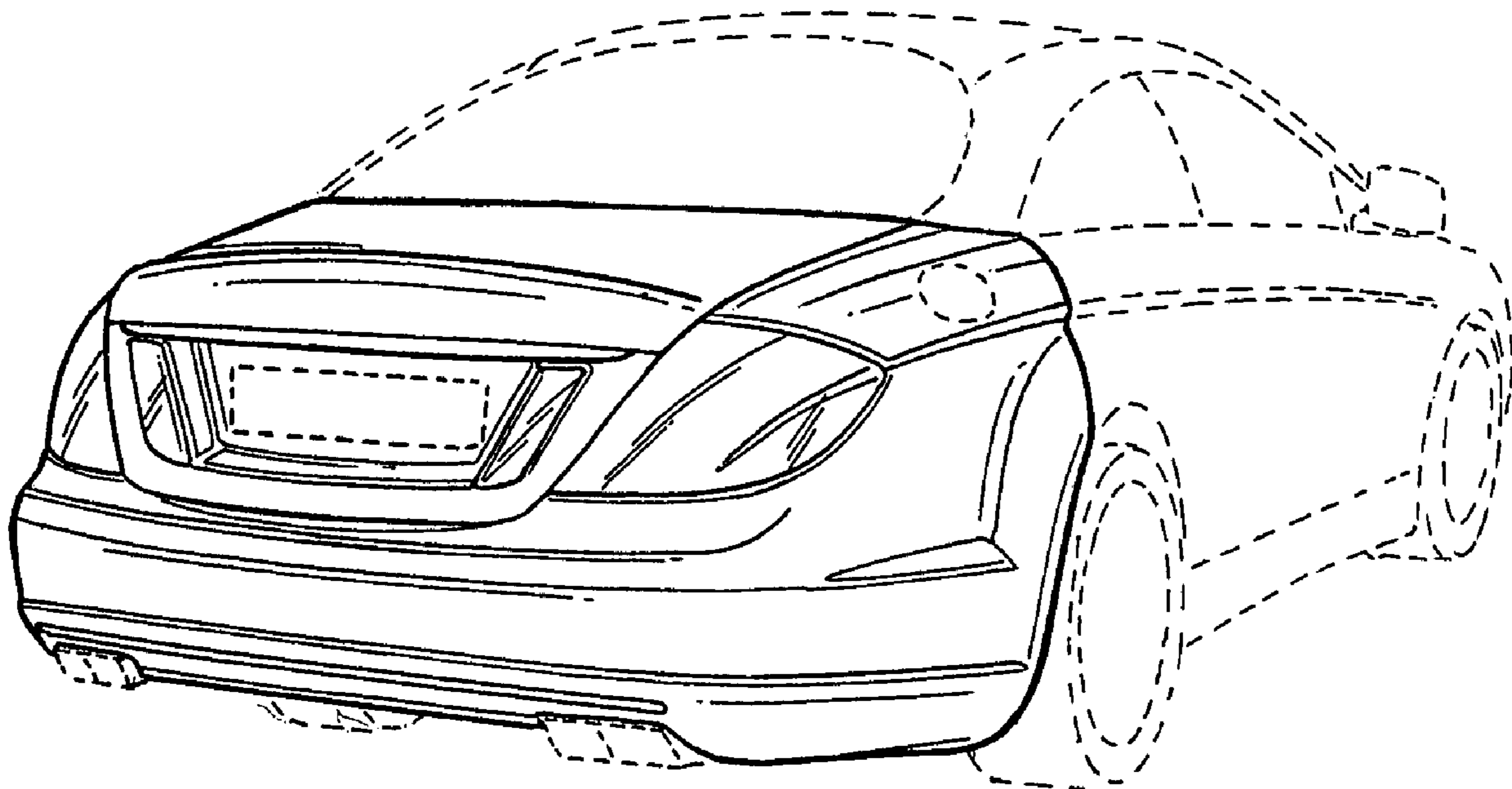
The broken line showing of the license plate, gas tank cover,

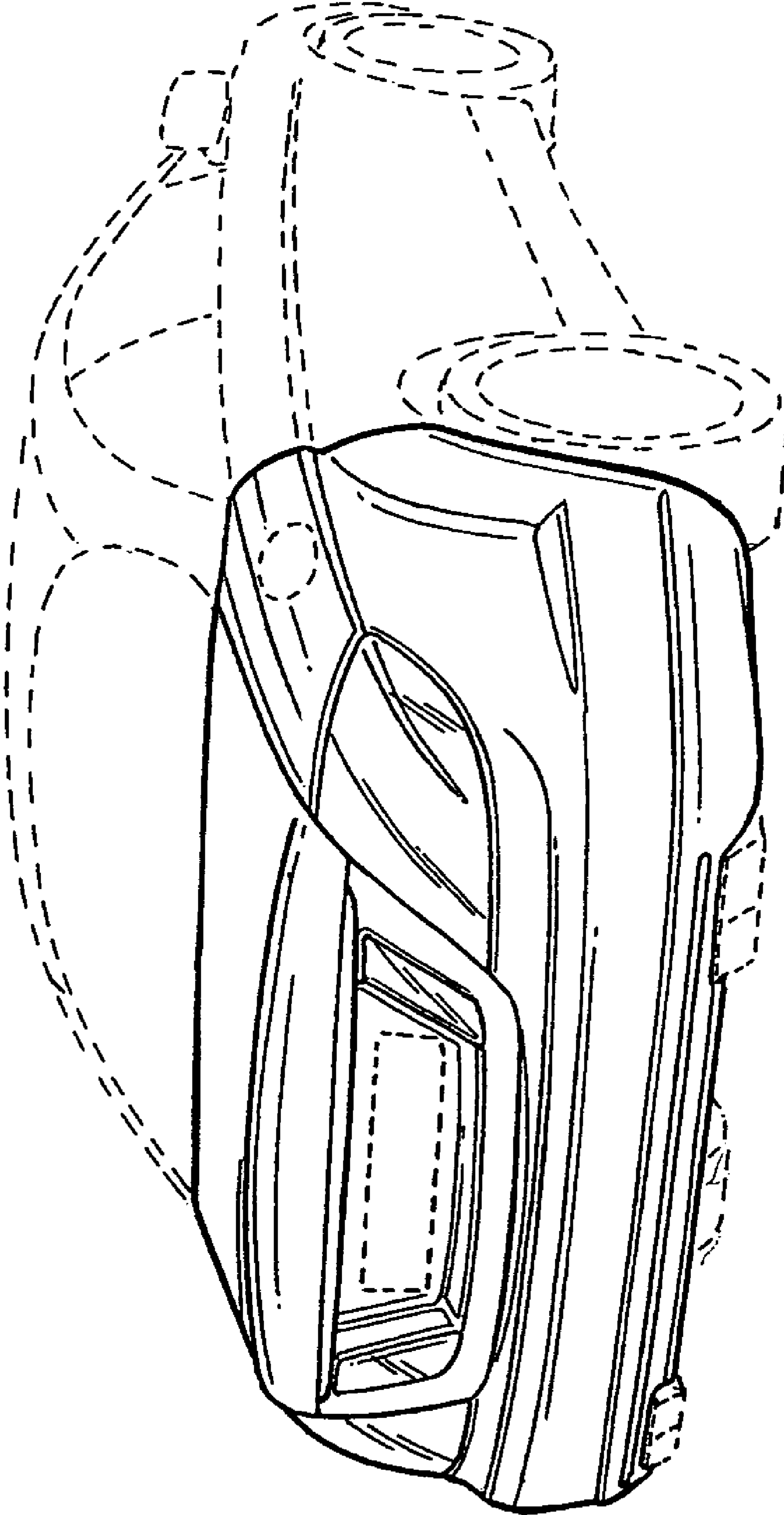

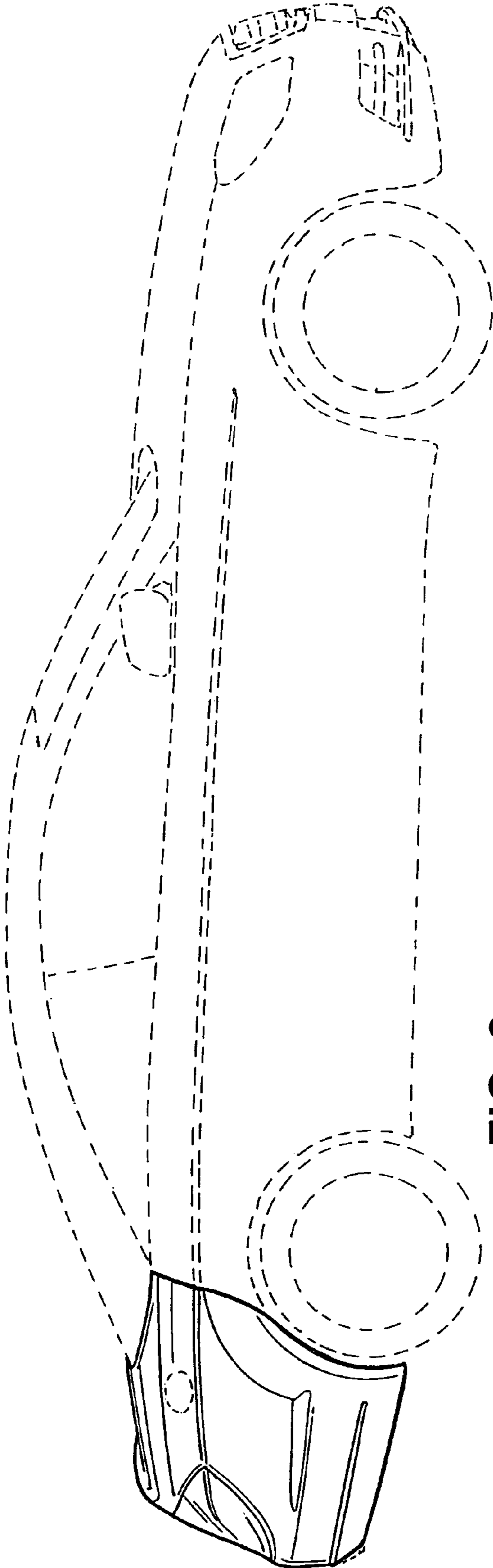

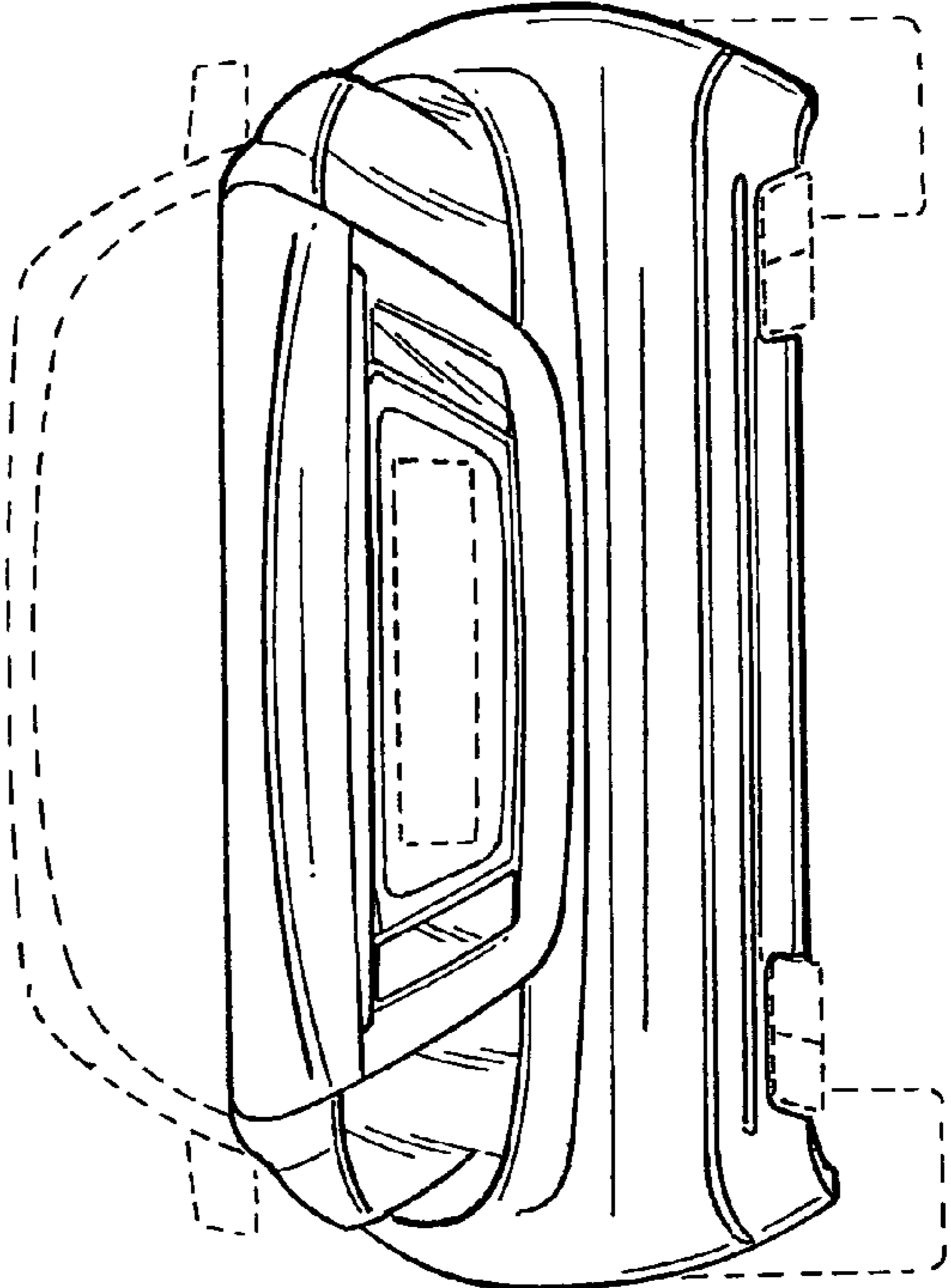
