and described.

**DESCRIPTION**

shown in FIG. 1;

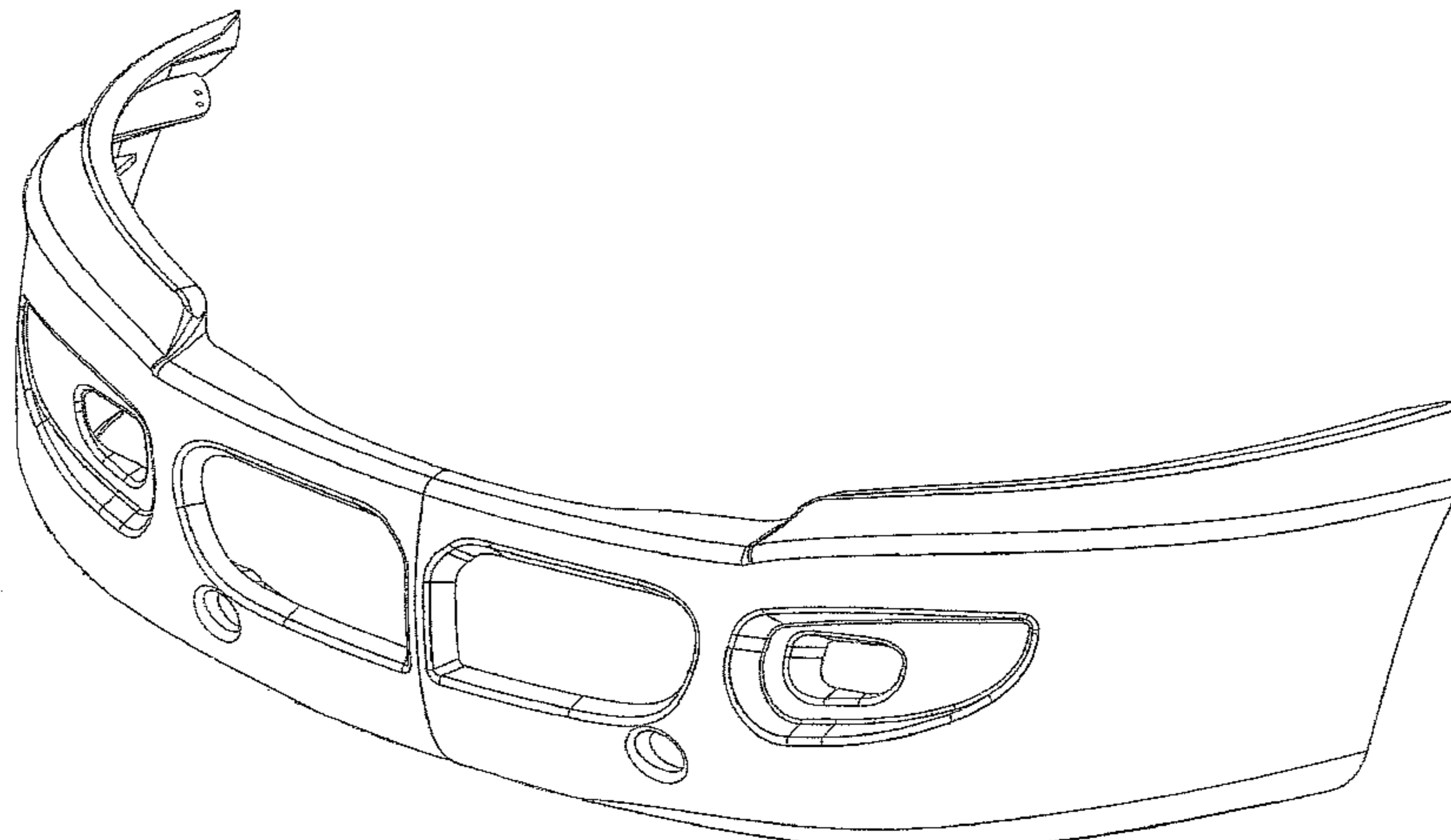
FIG. 16 is a perspective view showing the top and the front of

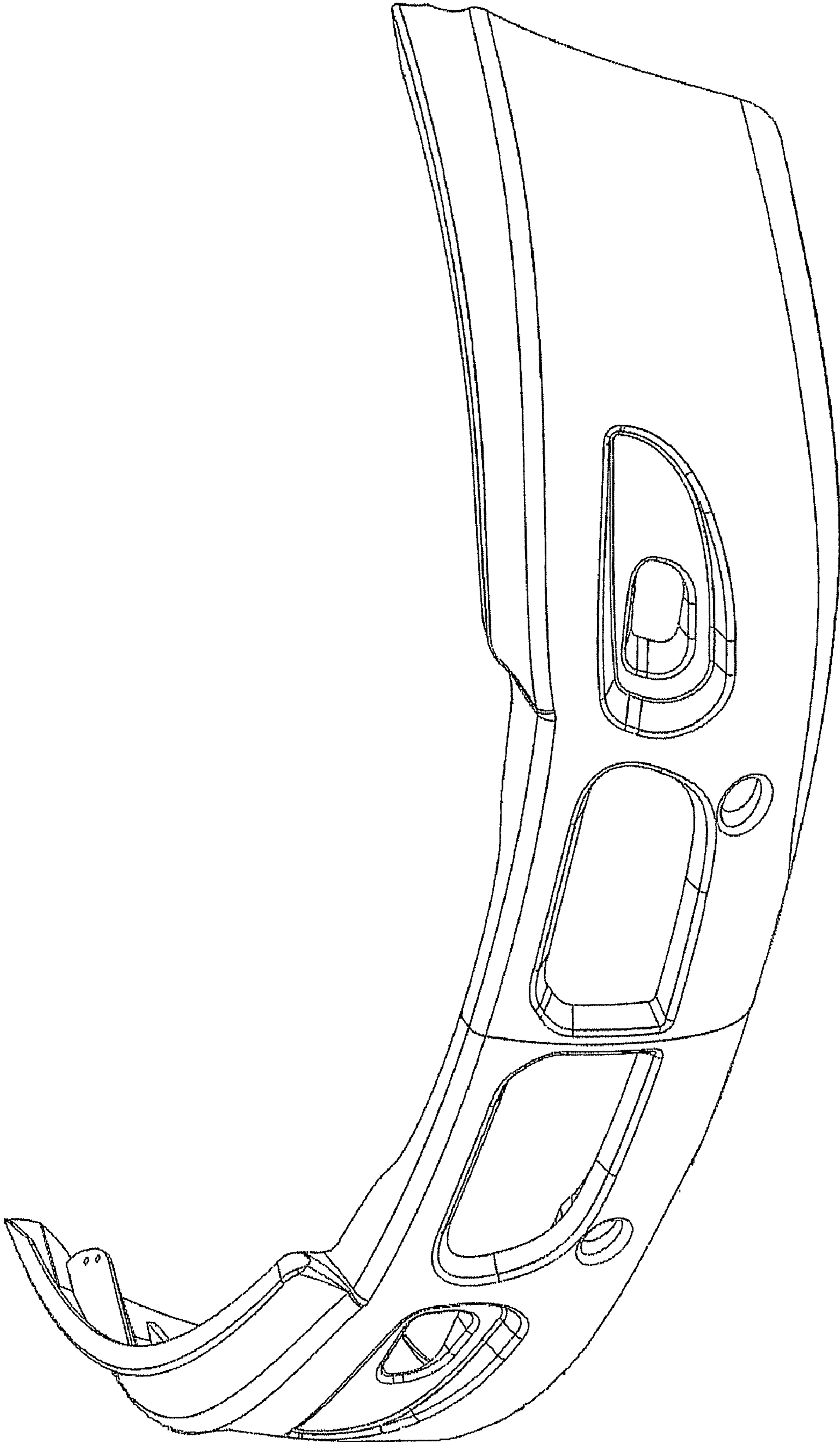

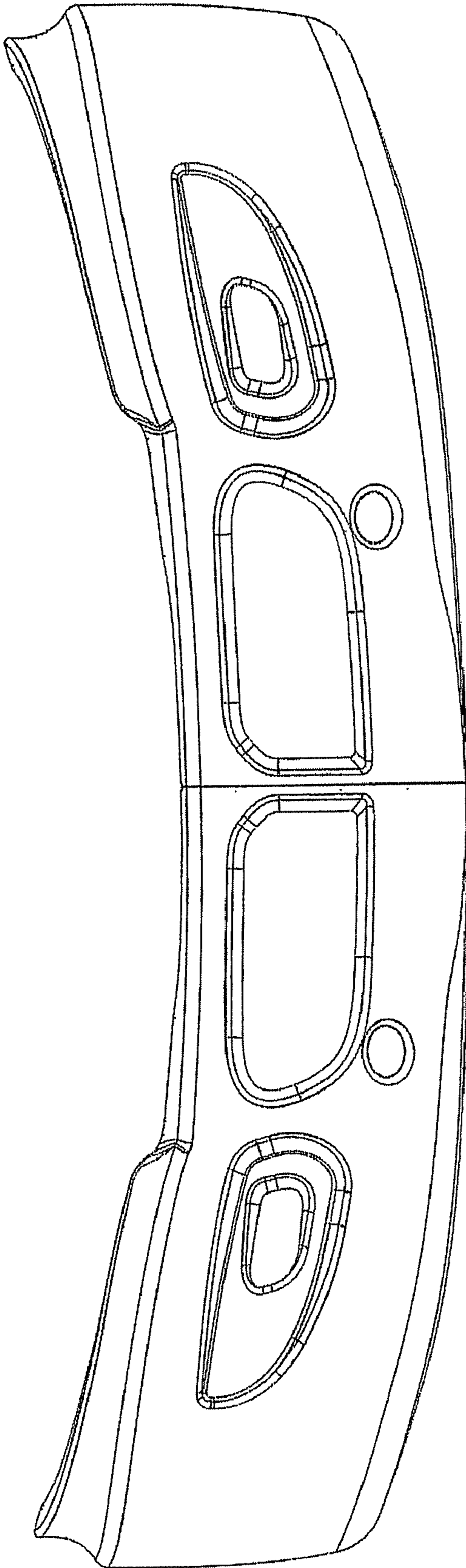

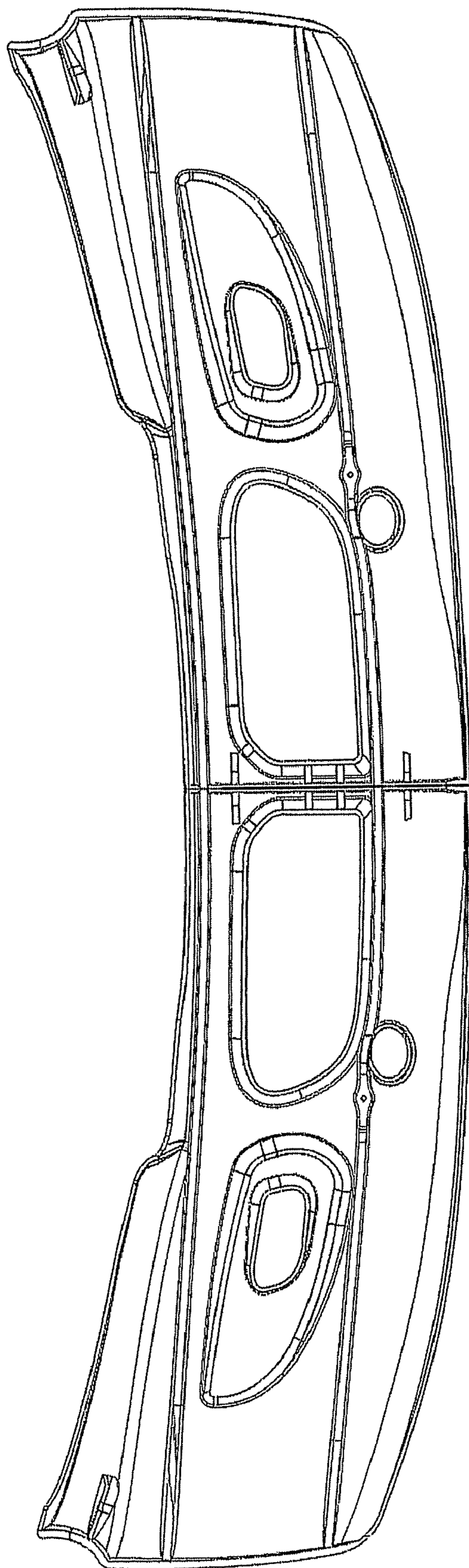

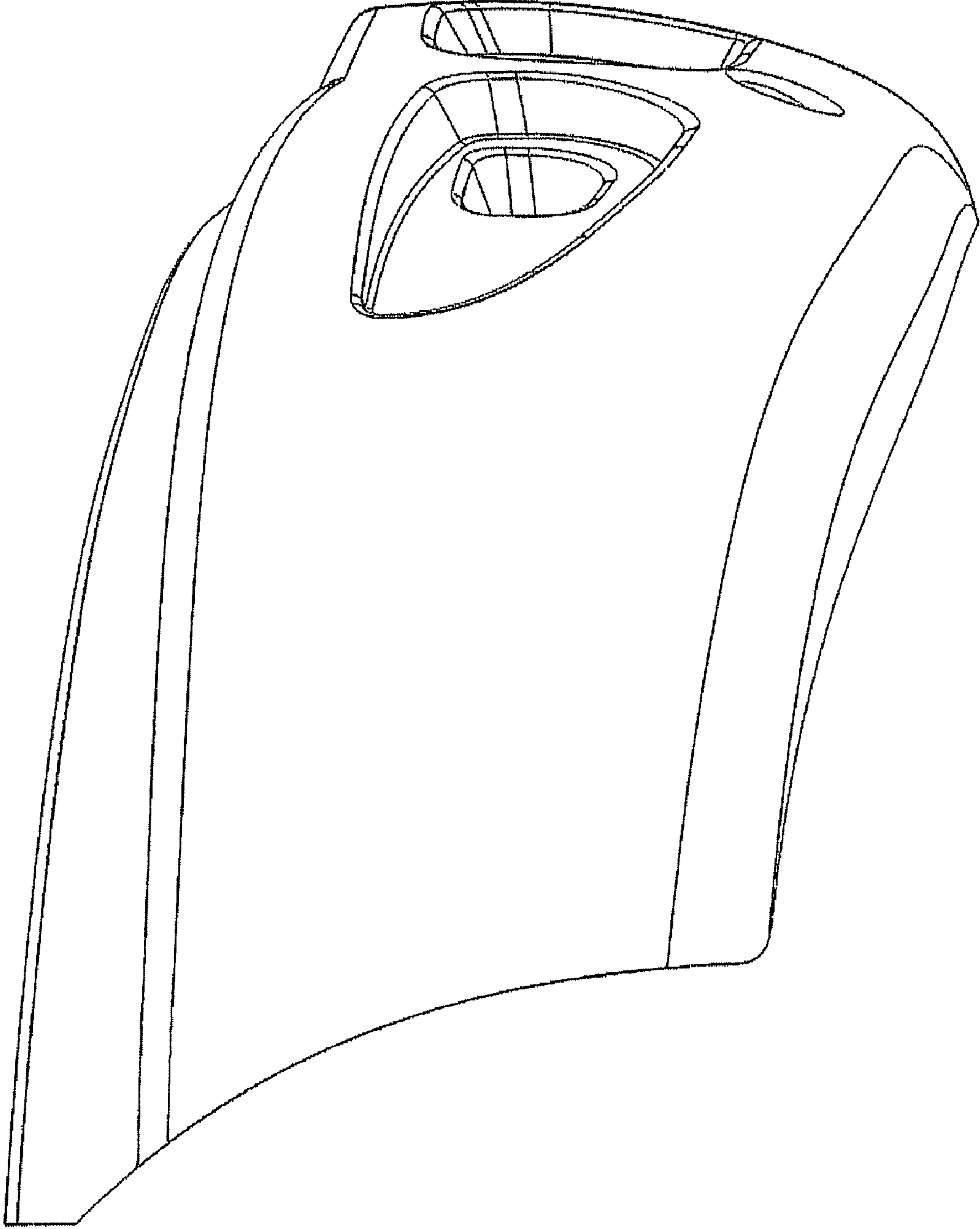

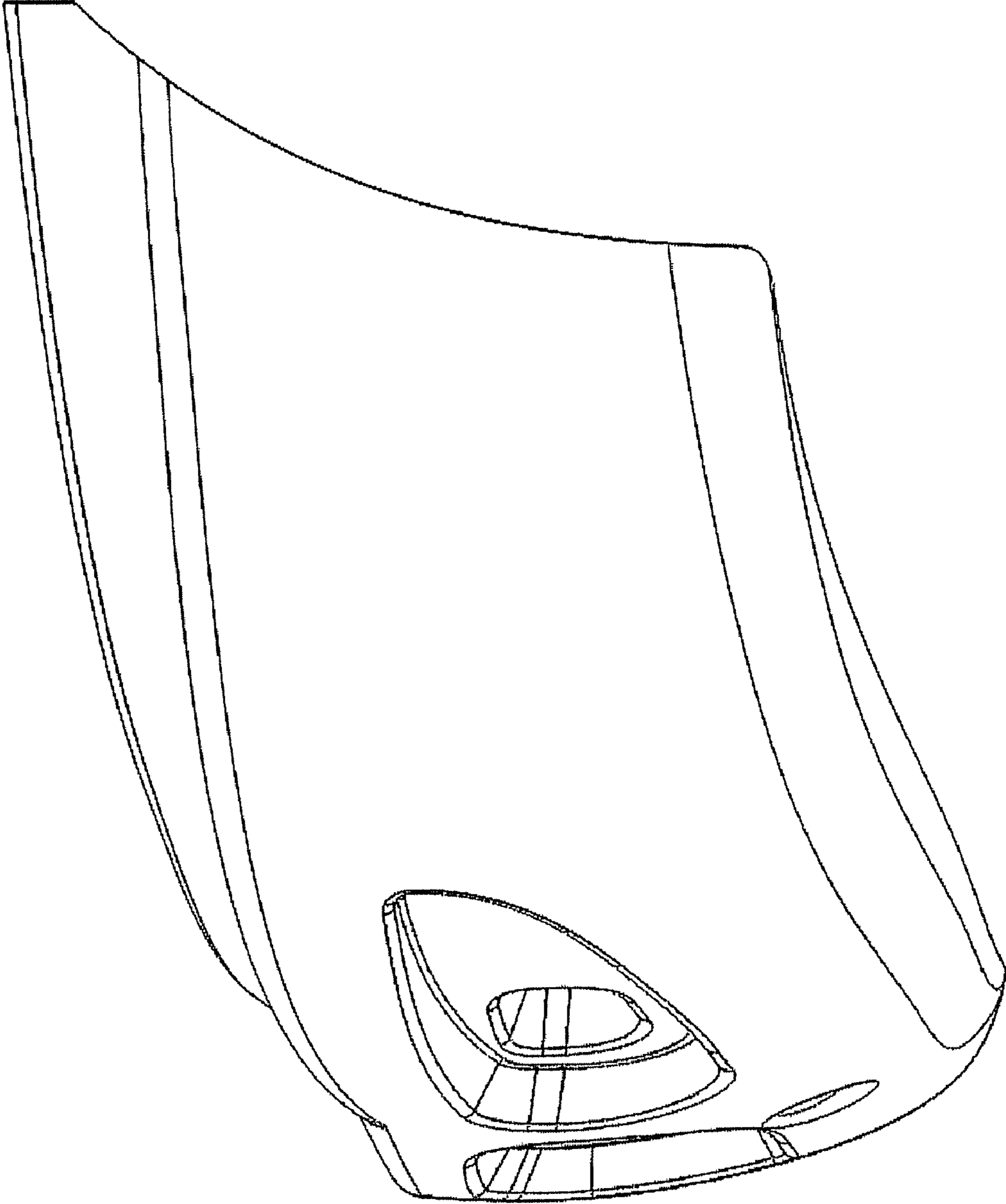

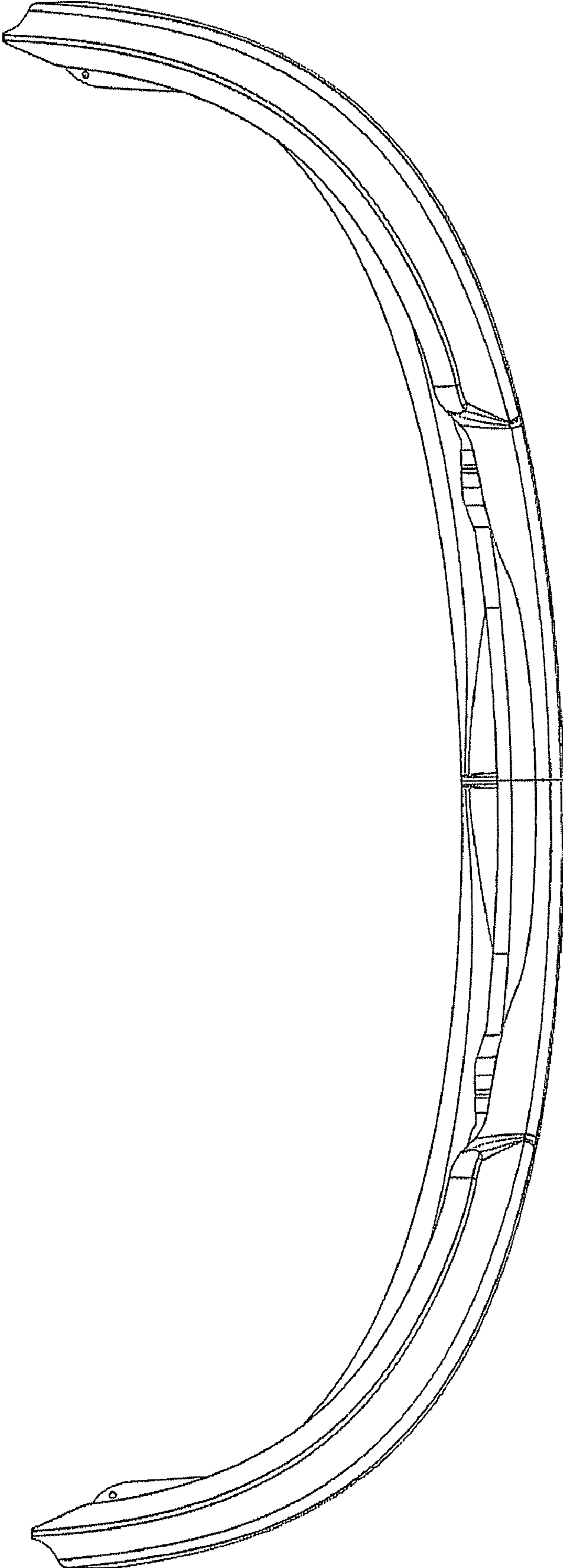

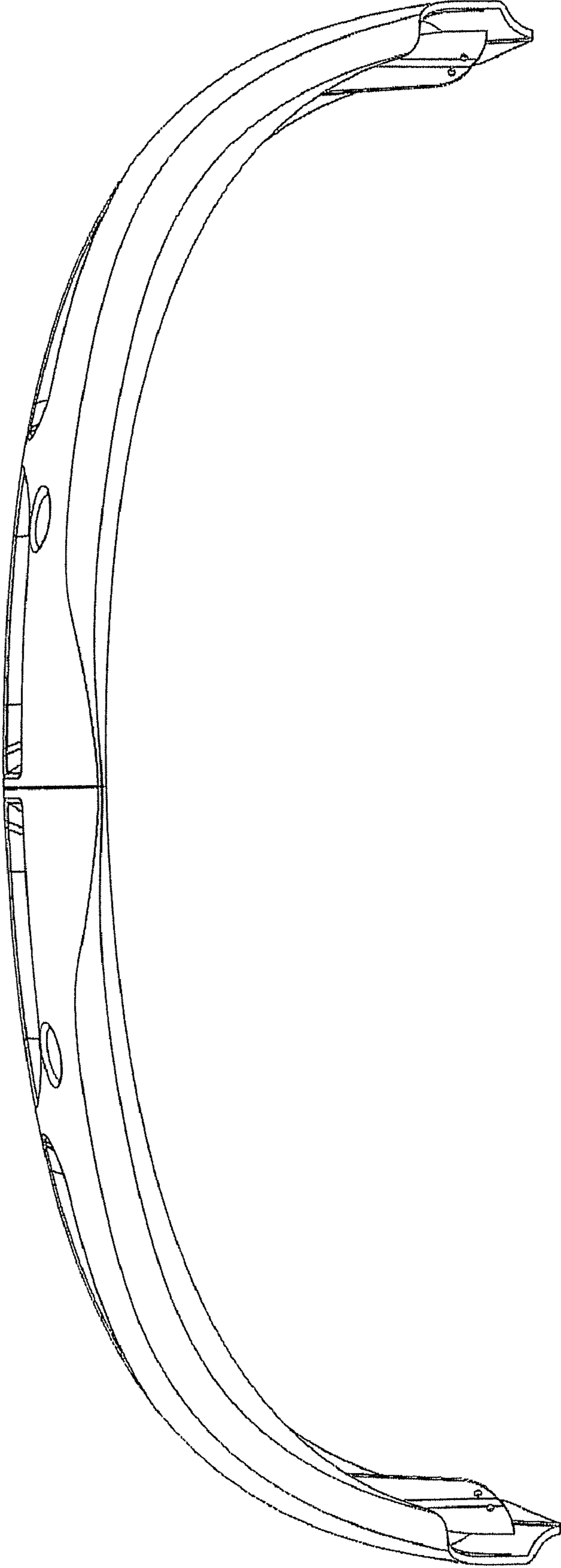

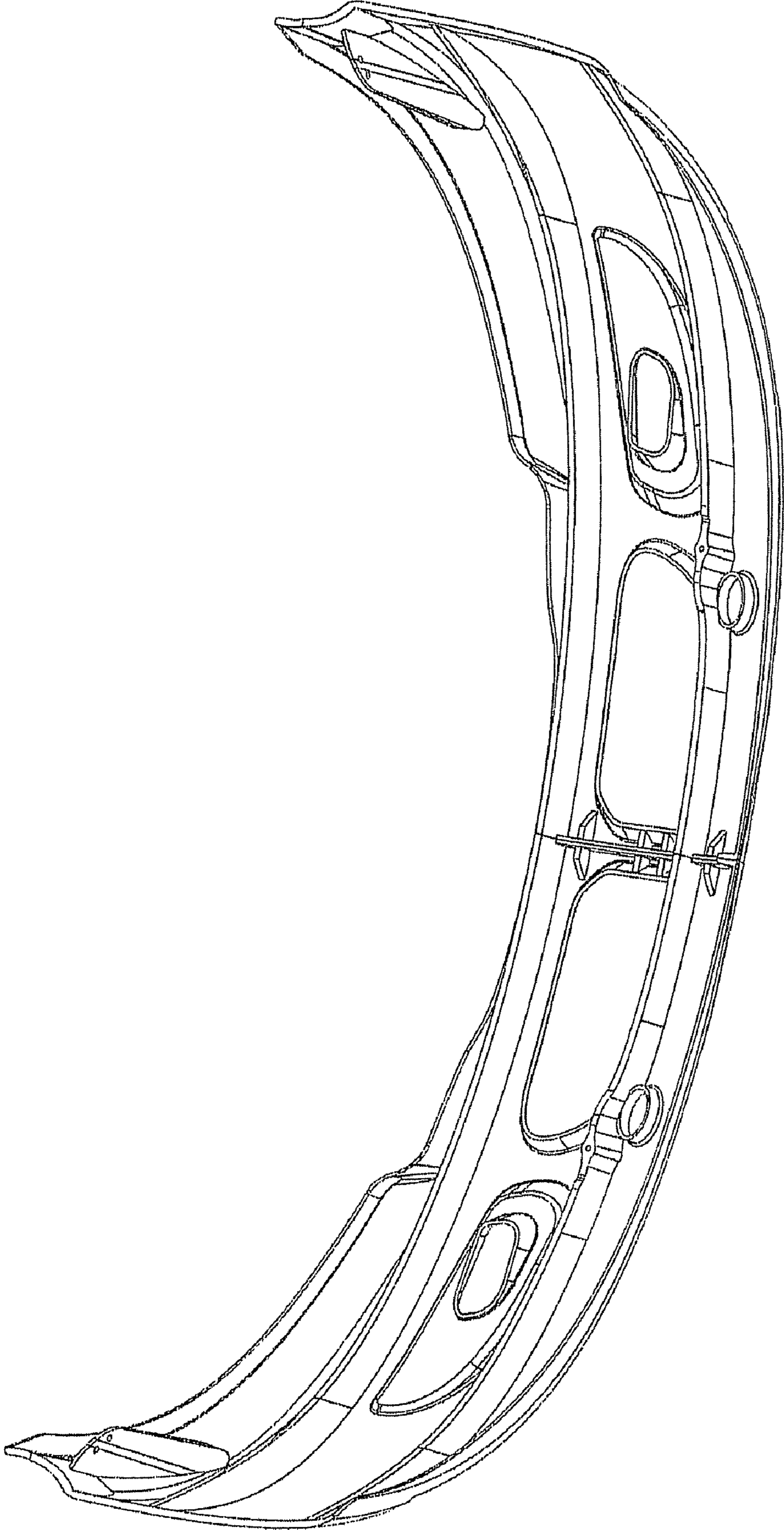

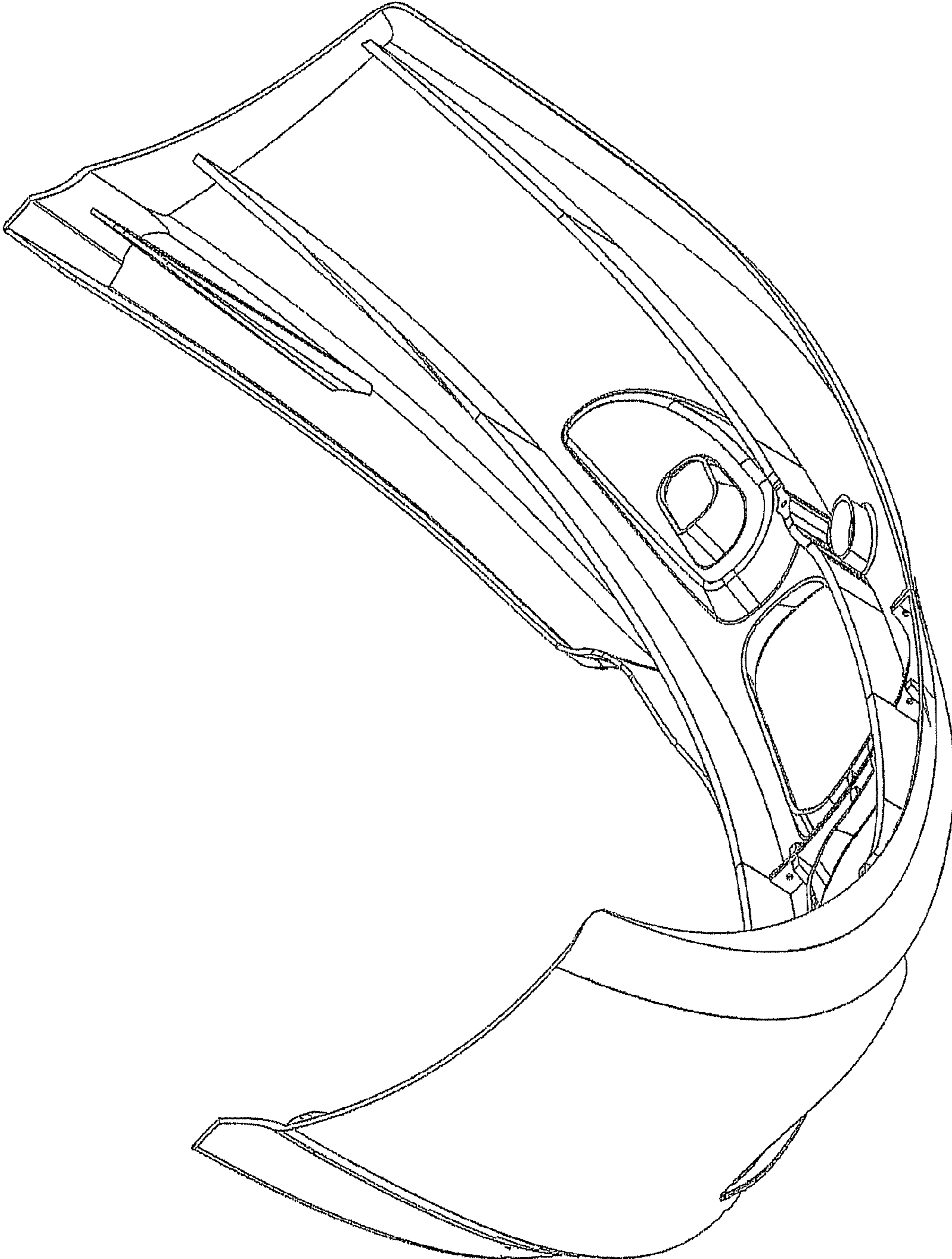

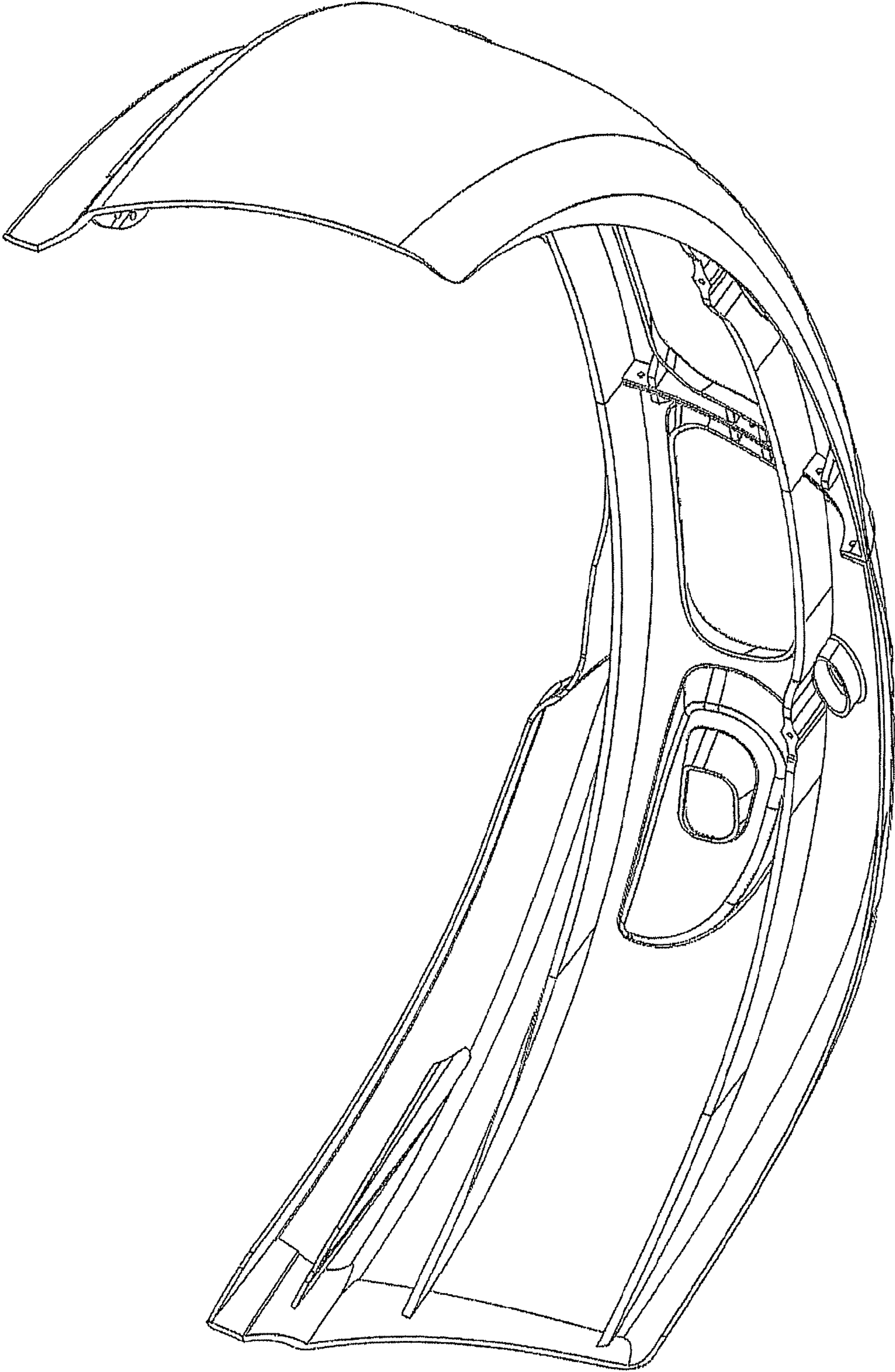

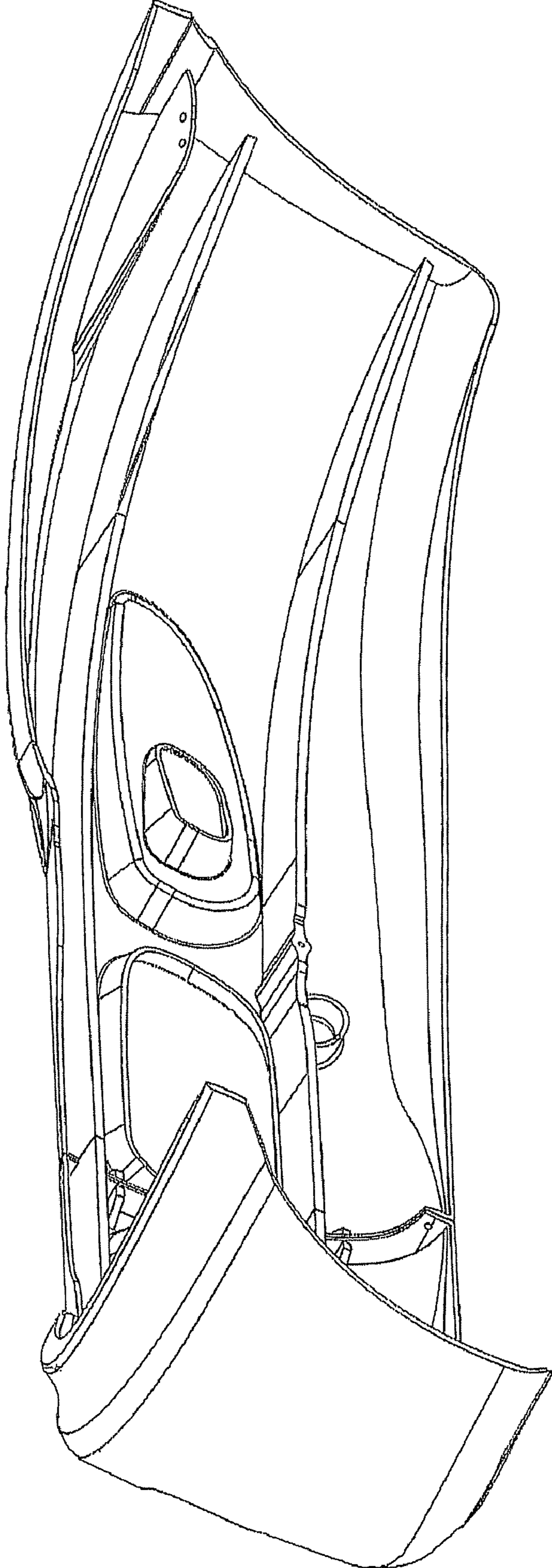

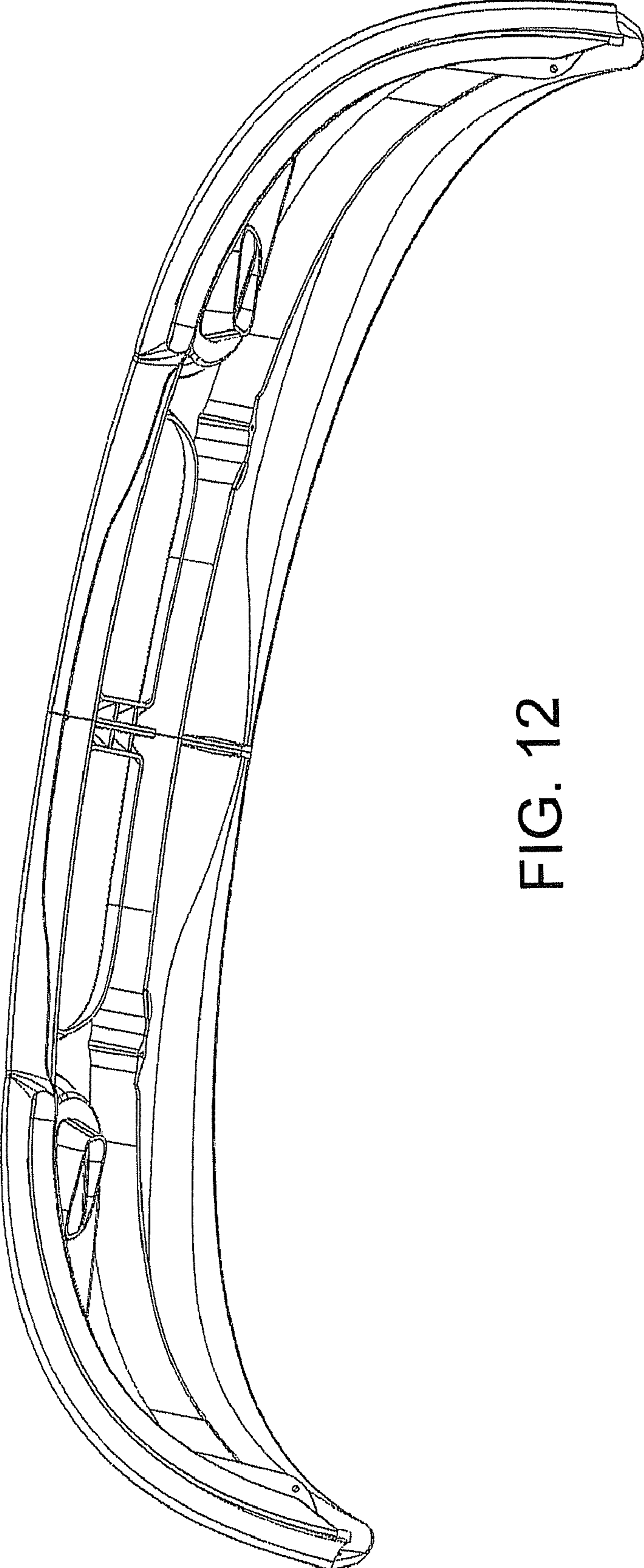

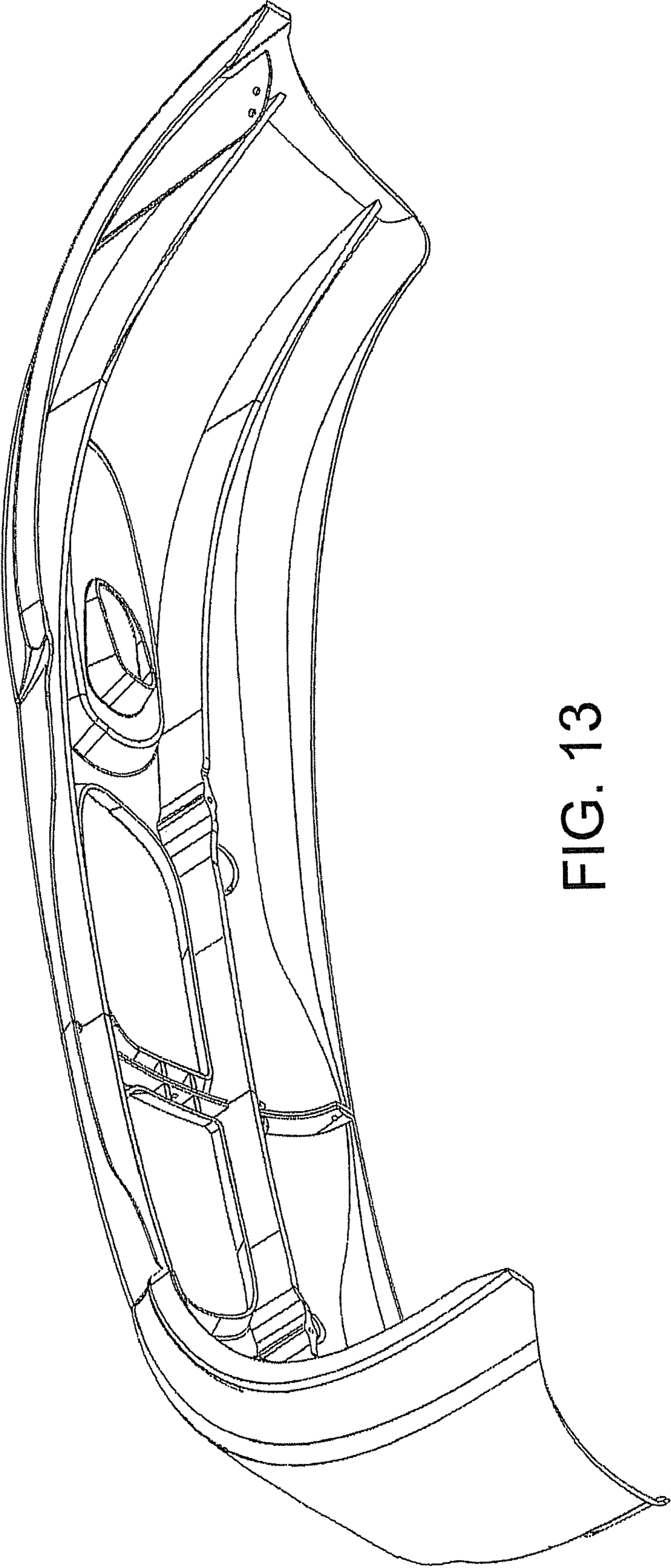

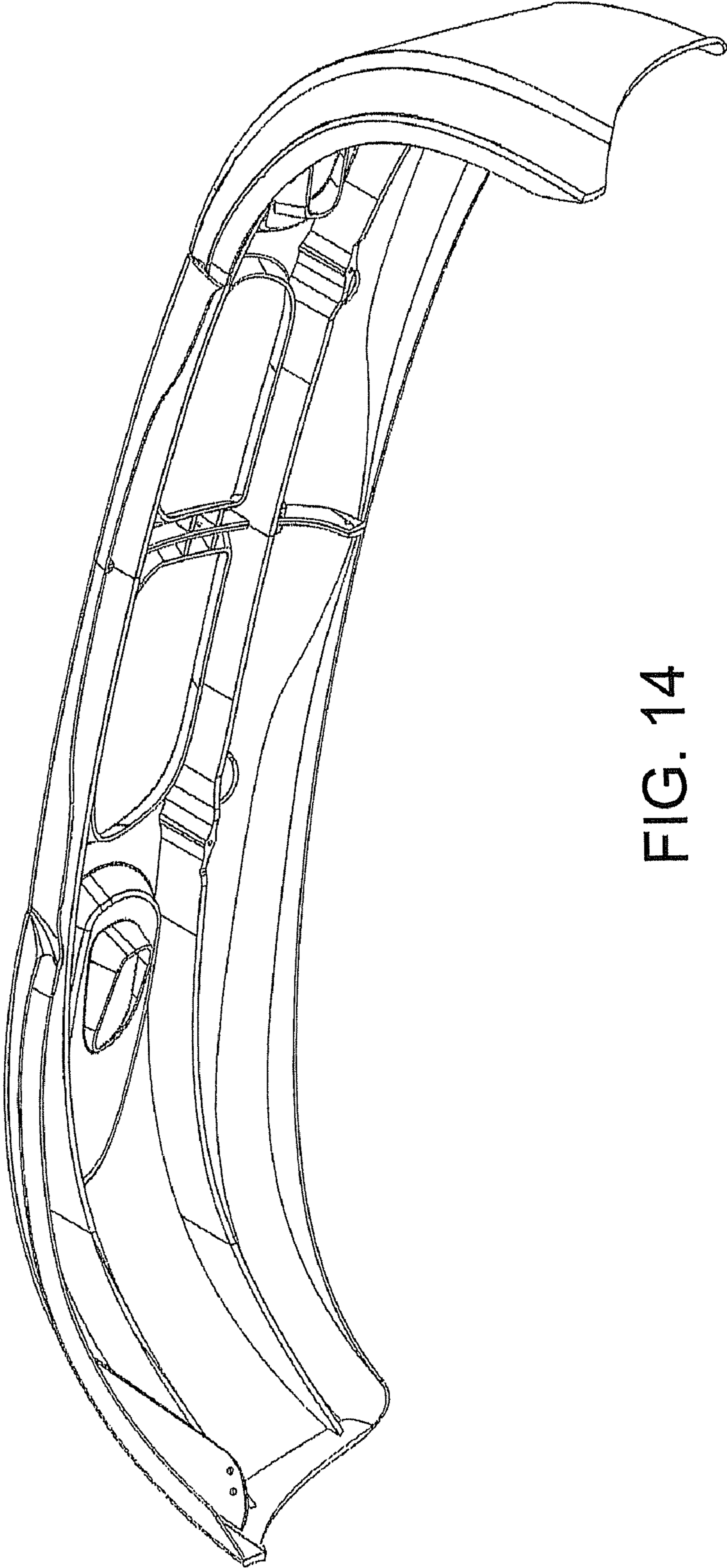

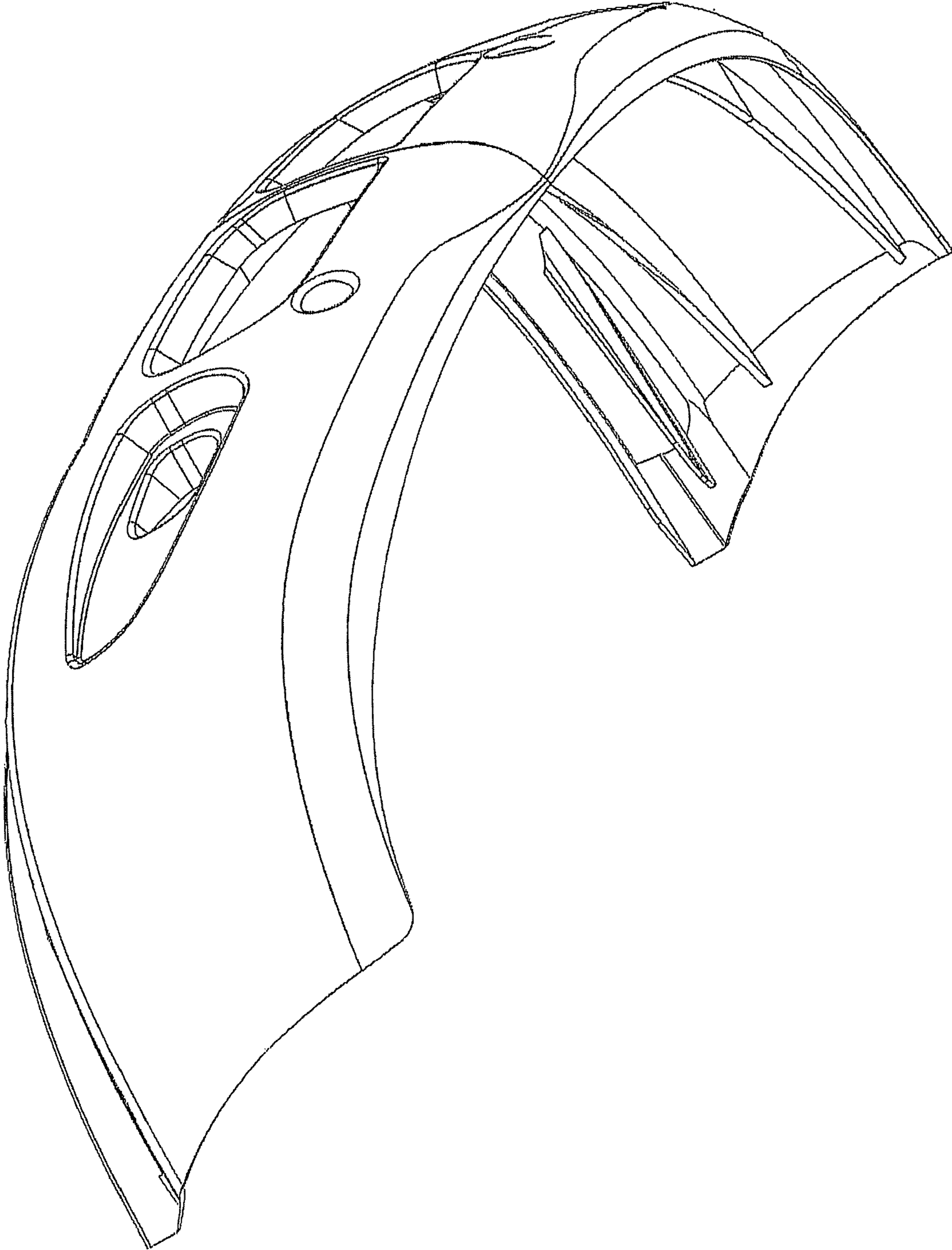

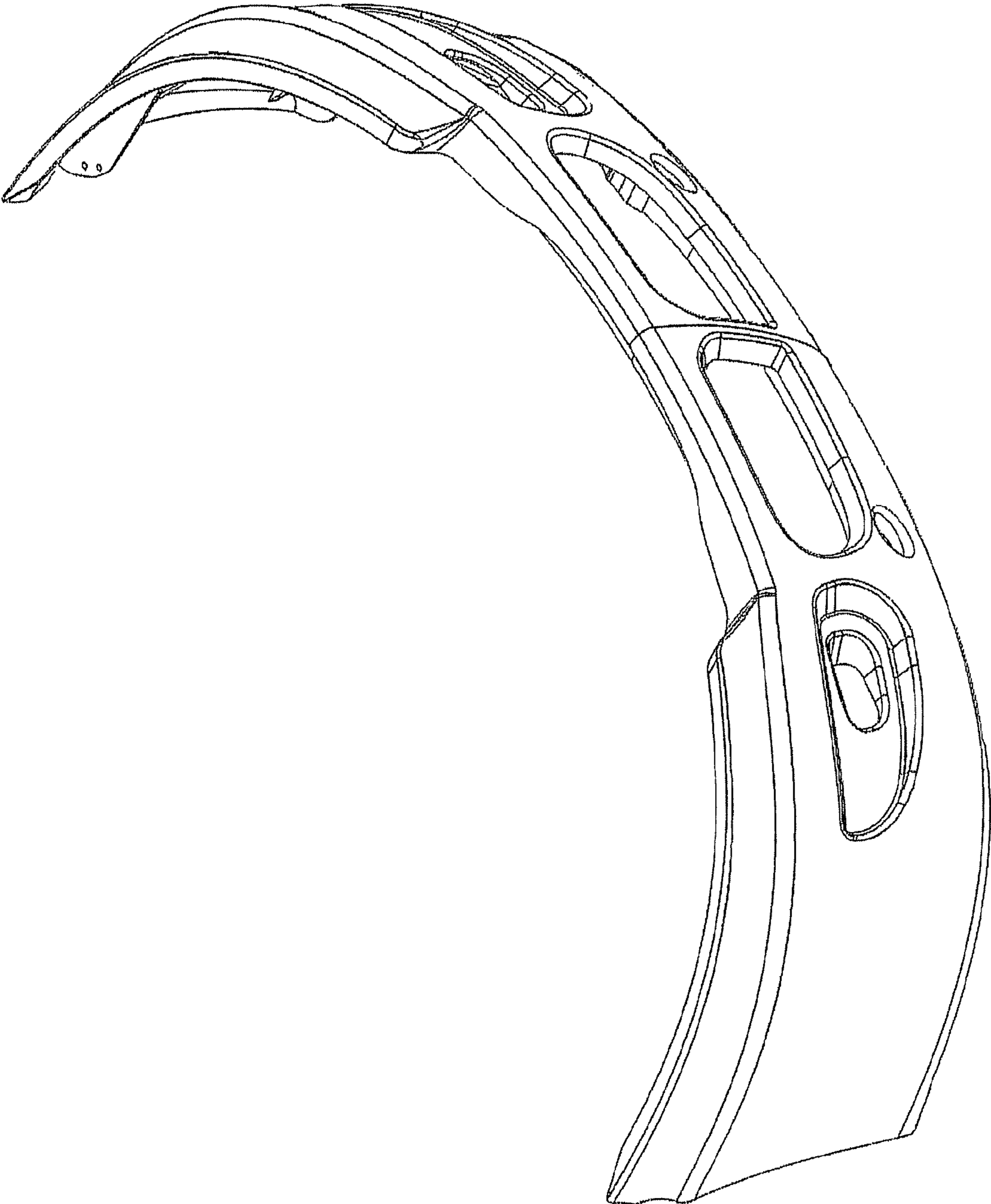

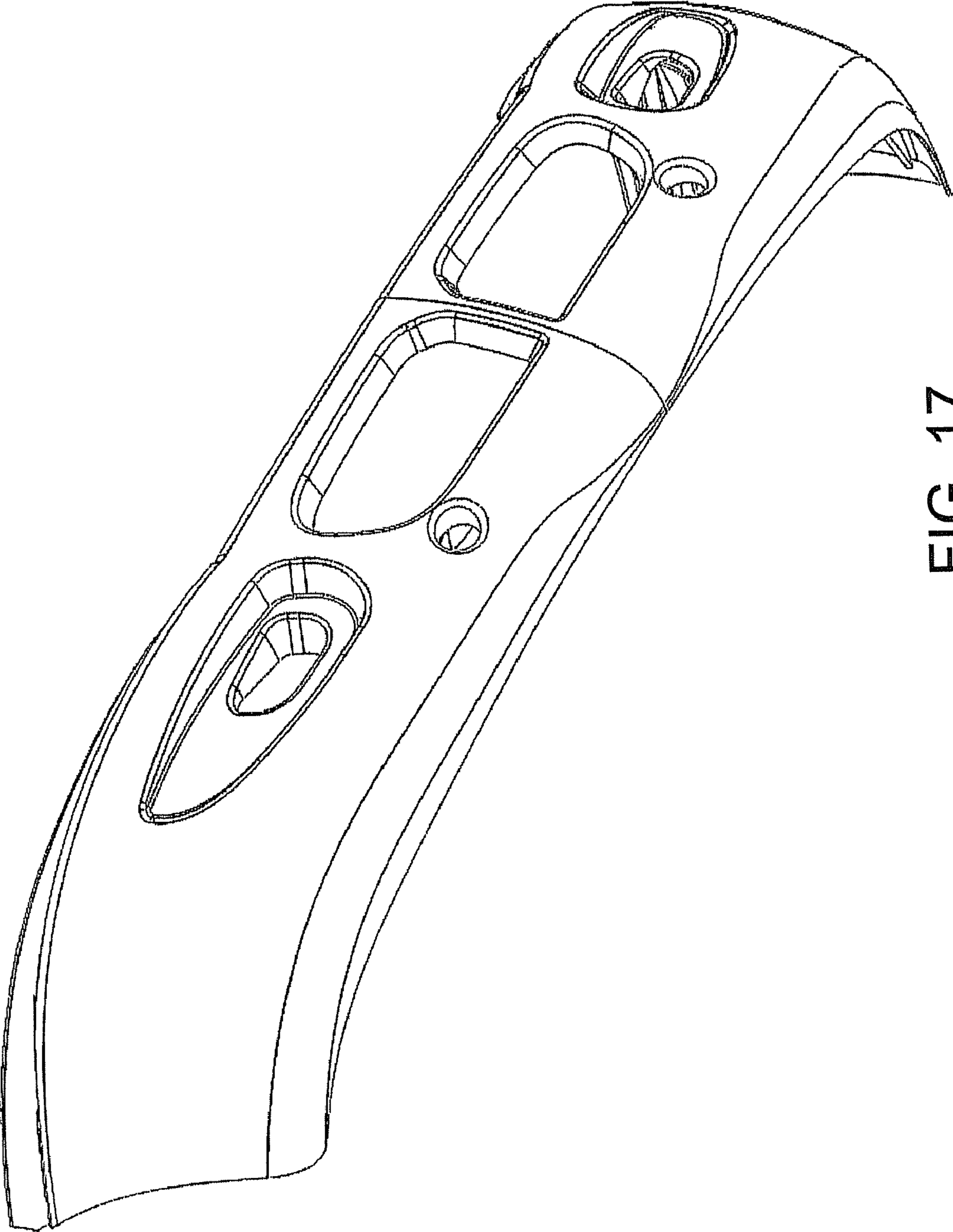

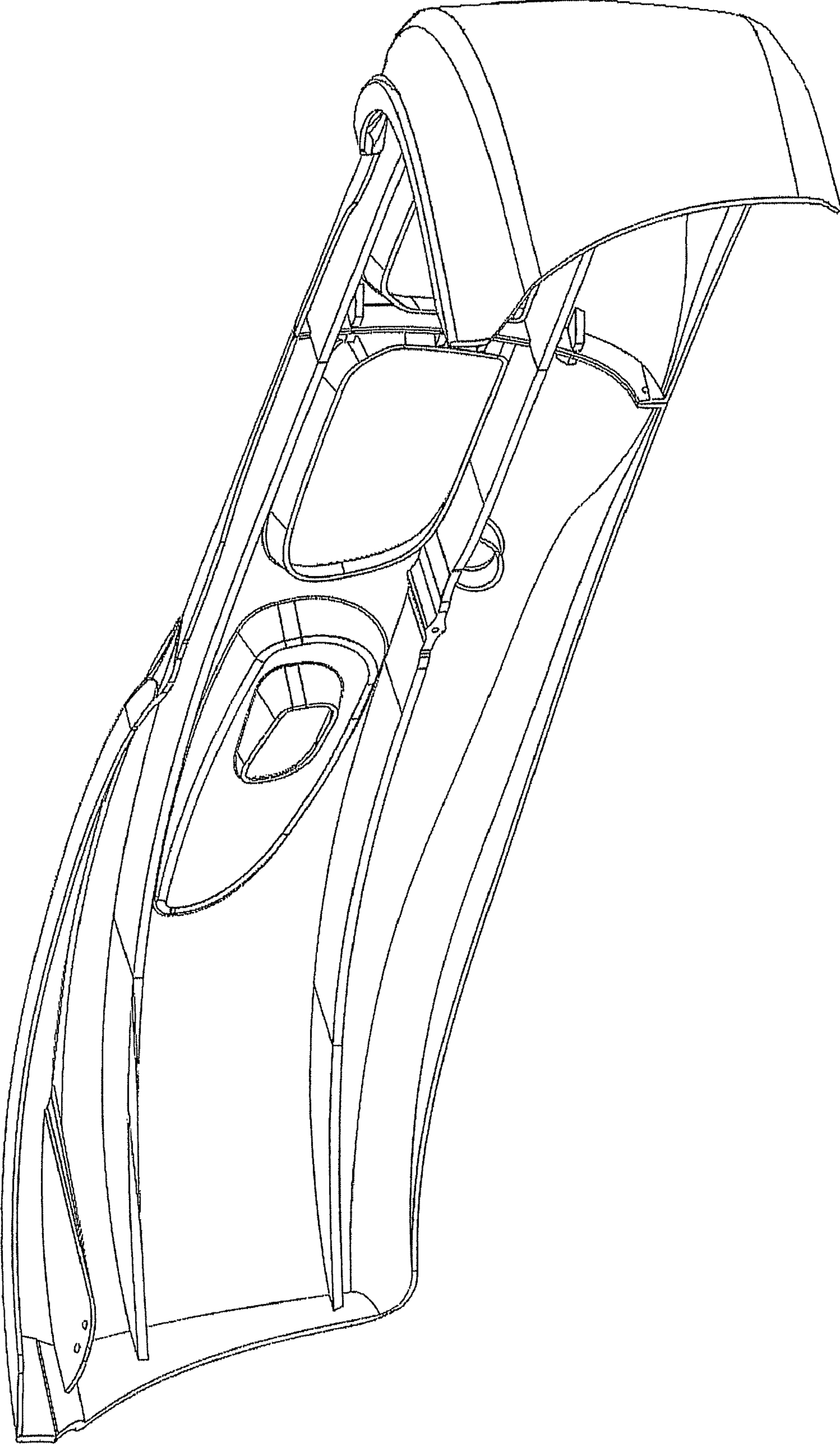
